Melded Zoning Ordinance Gets OK in Northampton

The newly elected Northampton supervisors made good on their campaign promise by voting Tuesday to repeal the 2015 Zoning Ordinance.

Board Chairman Spencer Murray, joined by Supervisors Robert Duer and Granville Hogg, voted to replace the three-month-old ordinance with the newly minted 2016 version.

Supervisors Larry LeMond and Oliver Bennett, both of whom had supported the 2015 version when it was put in place last December, stressed the need to have a clean document of 200 pages or fewer that would be easy for residents to use and that would support commercial businesses within the county, including some areas along Lankford Highway.

Referring to Lankford Highway as a linear city, Murray noted the need to try to capture some of the money that flows north and south as travelers pass through the county.

Duer said he believes the 2015 version of the ordinance was not in the best interest of the towns within the county.

Hogg, while voting to support the new 2016 Zoning Ordinance, stated that he is not happy with either the 2015 nor the 2016 version. He noted the need to guide transient traffic to commercial areas in such a way that it improves traffic safety within the county.

Murray charged the county staff to work to streamline the 2016 ordinance and to merge the appropriate portions of the 1983, 2000, and 2009 versions. By

Accomack Schools Rank Eighth in Surplus Funds

Accomack County Public Schools (ACPS) ranks 8th in the state for percentage of carryover funds for FY2015. That position was evident in a spreadsheet compiled this week by County Finance Director Mike Mason with figures taken from the state superintendent's annual report.

The division's year-end balance was \$8,756,046, nearly 16 percent of the overall budget. Now it's just over \$4 million, according to officials. A dispute between Accomack's School Board and Board of Supervisors regarding the stash is expected to culminate when a report about the funds is discussed by school officials Tuesday night and then brought to the supervisors the next evening.

The seven divisions with higher percentages are Franklin with 66.5 percent (\$11.6 million), Manassas with 31 percent (\$44.2 million), Winchester with 28.2 percent (\$15.5 million), Bland with 26.6 percent (\$2.2 million), Roanoke City with 25.9 per-

cent (\$47.6 million), Arlington with 23.6 percent (\$136.6 million) and Prince William with \$17.8 million

(\$201 million).

In Stafford County there is also a debate going on between county and school leaders. The surplus there has been reported at over \$8 million and a forensic audit is being conducted. In Mason's analysis, that school division ranks 25th with 8.6 percent carryover (\$26.2 million). Stafford's superintendent is Bruce Benson, who held that position for a few years in Accomack earlier in this decade.

"The superintendent's report makes it clear that many localities have leftover funds,

which varied, at least in FY15 from a high of 66.5 percent of balances held to total receipts to 0," County Administrator Steve Miner noted this week. He suggested schools Finance Director Beth Onley or Superintendent Chris Holland be contacted regarding the disposition of carryover money.

"Some of it is probably leftover federal money, some is probably enterprise funds from, say, the school food program, which is supported by charges to students," Miner continued. "I am sure I don't know, and equally sure they should know."

Onley responded, "The balance above the \$6.2 million represents federal funds that are required to be kept separately and used for a specific function, such as School Food Services. The

entire balance of \$6.2 million in carry-over funds are state funds."

In written correspondence, state Deputy Superintendent Kent Dickey of Finance & Operations, told Mason school divisions may use the remaining FY15 Direct Aid to Public Education Fund carryover appropriated to the school division to fund capital expenditures, if the school division chooses and the funds were appropriated in a lump sum by the locality.

Earlier, Mason said he learned in a conference telephone call that the money could be spend on anything that is considered education, including books, supplies and buildings. Onley was connected to the call. The next night when addressing the School Board, she said she called back and got information that made her believe the money could not be spent however they choose.

Supervisors were irate because they borrowed \$1.8 million at the division's request to fund a new gym and other needs at Kegotank Elementary School.

School officials have been accused of "hoarding" millions of dollars since 2010, possibly to purchase a new location for its cramped Central Office. The school division said the money was for contingencies. Onley compared it to the county's Rainy Day Fund.

County officials say the Rainy Day Fund, now at about \$10 million, is for catastrophic emergencies like a hurricane, and includes all county operations, including the schools.

Both sides have agreed that ACPS needs to spend the money in the next year or two or the state will take it back when the biennial budget cycle ends.

"Surplus state money was always recaptured by the state before the recession," said Miner. "Starting, it appears, in 2010, the General Assembly was fearful it might not make its projected revenues and started allowing schools to keep the leftover direct aid to public education funds in case they didn't."

Northampton School Division is among 17 with a zero balance at the end of FY15.

Court Postings

Accomack Grand Jury

It may have been “mutual combat” that killed Breonya Collins, a seventh-grade Nandua Middle School boy, shot to death at his Keller Pond Road home last October.

The second-degree murder charge that has held Nicholas Martinez White, 23, in Accomack Jail for the last six months, was reduced to voluntary manslaughter in Accomack Juvenile and Domestic Relations Court last Friday morning at the request of Deputy Commonwealth’s Attorney Matthew Brenner.

Judge Jack Wescoat cleared the courtroom upon Brenner’s request because of the young age of a witness to the shooting of the 13-year-old boy. A few minutes later, other witnesses were separated and several investigators also were asked to leave the courtroom.

Wescoat later found probable cause to send to an Accomack Grand Jury the manslaughter charge as well as a count of use of a sawed-off long gun in the Oct. 16 killing. The grand jury is next scheduled to convene June 6.

Records that were sent to Accomack Circuit Court stated the charge was to “commit voluntary manslaughter ... without malice, while engaged in mutual combat, upon a sudden heat or on reasonable provocation.”

Included in the items that were confiscated from the Keller home were two 12-gauge shotguns and a Winchester 12-gauge shot-shell case.

Breonya died of a gunshot wound to the head that day. While warrants give White’s address as Onancock, defense lawyer Shannon Dunham said the defendant was living at the house where the shooting occurred.

Records state White told police that both he and the boy possessed guns and that his weapon discharged.

Accomack Circuit Court

She said he raped her twice by scaring her into submission and made her feel too intimidated to flee. He told police they had consensual sex four times during the same timeframe.

Judge W. Revell Lewis III concluded there wasn’t sufficient evidence to convict Clifford E. Albritton III, 39, of Big

Pine Road near Painter. So after hearing hours of testimony Wednesday in Accomack Circuit Court, he dismissed the charges of rape and abduction. Asked by Deputy Commonwealth’s Attorney Matthew Brenner to consider lesser counts of sexual misconduct, the judge waved the request aside.

Albritton was released soon afterward. He had been held in Accomack Jail without bond since the allegations were made on Oct. 25, 2015. He did not testify.

The woman said she had a previous relationship with Albritton but had broken it off about three weeks before the incidents occurred. He left the area during that time and when he returned he wanted to talk to her. She agreed to a meeting and eventually returned to her house with him.

When they arrived, she said, he started arguing and knocked her down onto the concrete porch floor. She said her knees were bruised and her glasses flew off. Once inside the house, “he just grabbed me and started taking my clothes off. ... I struggled until I got tired ... I did not have an expectation that he was going to do that to me.”

The woman said she tried to call 9-1-1, but he “kept snatching the phone” out of her hand. In the morning, he wanted sex again and she turned him down but said he wouldn’t take “no” for an answer. After awhile, she went outside and got in her car. Albritton was right behind her. She said she managed to lock him out, but he hung on to the trunk of the car for miles as she drove.

Officers testified that Albritton called police from the side of the road and complained that he and the woman were going for a ride when she got angry and locked him out of the car. He reported that he finally let go in a turn and fell to the ground.

She drove to the sheriff’s office to get forms for a no trespassing order and then to the hospital, where she reported that she had been raped.

Erica Flugle, the sexual assault nurse who examined the woman, said she had bruises on her knees but no signs of a struggle or assault anywhere else.

“He was trying to have sex with her but she didn’t want to,” said Brenner. “He knew what it would take to overcome her will ... to fight this much stronger man, not because she became aroused. The way she told her story, maybe there

are some things left out. The commonwealth is not interested in every detail of every minute of what happened during the day, but what happened that night at her house. How many times does ‘no’ mean ‘no’? ‘Stop’ mean ‘stop’? ... What you have is her saying ‘no’ and him pushing and pushing and him not taking ‘no’ for an answer ... he finally got his way with her.”

Defense lawyer Carl Bundick argued that the woman’s timeline of events did not fit the places where witnesses saw the two that day. He also noted that the woman’s phone was never broken and was given back to her so she could have called or asked for help. He said she could have made the report to police when she was at the sheriff’s office instead of waiting to get to the hospital.

Pam Clark, 29, of Withams Road in Withams pleaded guilty to distribution of heroin on Oct. 8, 2014. A short-form presentence report was ordered. Clark was released on existing \$2,000 bond. Restitution of \$120 also was ordered. Records show she was on probation when the crime occurred.

James Winston Scott, 46, of Guard Shore Road in Bloxom pleaded guilty to distribution of heroin, occurring Dec. 11, 2014. Sentencing was deferred pending completion of a short-form presentence report. Scott was remanded to jail.

Felicia Marie Gaskill, 24, of Savageville Road in Melfa was sentenced for possession with intent to distribute between a half-ounce and five pounds of marijuana on Nov. 23, 2014, to three years in prison, with all but 45 days suspended. Work release will be permitted.

Terrell Charles Thomas, 30, of Fleming Road in New Church pleaded guilty to felony eluding that occurred Dec. 11, 2015. He is being held in Accomack Jail pending a presentence report.

Kendall Darrell Bibbins, 48, of Powhatan Trail in Melfa pleaded guilty to two counts of failing to register as a violent sex offender on May 26 and Aug. 19, 2015. A presentence report was ordered.

Northampton Circuit Court

A Machipongo man was sentenced Monday in Northampton Circuit Court to a total of seven years in prison for a drug offense, assault and battery of police officers and other charges in connection with a July 25, 2015, incident.

Thirty-five year old Antwine Jermaine Reid was sentenced for distribution of cocaine to 20 years, with 15 suspended; for two counts of assault and battery of the officers to five years on each count, with four years each suspended; for resisting arrest to a 12-month suspended sentence; and for obstruction of justice to two 12-month suspended sentences. The terms are to run consecutively.

Accomack District Court

Judge Gordon Vincent found probable cause Monday in Accomack General District Court to certify to a grand jury a charge of dredging oysters without a permit against a Maryland man.

Marine Police Officer T.K. Fitchett testified that Capt. James Milbourne Carman of Crisfield committed the crime Dec. 8, 2015, in Virginia waters of the Chesapeake Bay near the state line.

Fitchett said he was sure of this because he could clearly line up the buoy markers and see the boat, which used an orange marker as its bullseye for circling, a common practice with dredging. The marker was in Virginia waters near Saxis, the officer testified.

Fitchett went aboard the vessel and soon learned that a chart plotter on the boat also showed that the vessel had been in Virginia.

“I watched him go into Virginia waters several times,” Fitchett said. The officer was unsure how many oysters had been caught, but remembered there were some in baskets, on a table and in the dredge.

“I didn’t count ‘em,” Fitchett said. “If you gathered them all up, you might have had a bushel.” It was “more than two or three dozen.”

In another case, a malicious wounding count against Diego Ayrton Jimenez, 18, of Church Road in Onley was certified to the grand jury. The incident involves the alleged Feb. 28 wounding of a Bloxom man whose home Jimenez was visiting. According to testimony, Jimenez started swinging his knife when he was challenged about working for police. A witness said the victim and others thought the man was joking. The victim then pulled out a taser and Jimenez gashed open the man’s hand.

Defense lawyer Terry Bliss said there was no malice and that testimony did not show an intention to maim.

Deputy Commonwealth’s Attorney

Matthew Brenner argued, "When you swing a knife at somebody ... close enough to ... create that kind of cut, you obviously intended to cut them It was malicious in its nature."

Asking Vincent to set bond, Bliss said, "He has a small child and needs to take care of his family." The judge refused.

Brenner was opposed to bond. He stated that Jimenez had a couple of violent convictions as a juvenile and is in this country illegally though he has lived here all his life. "No social security number or driver's license number was given for this defendant," said Brenner.

Bliss said Jimenez has lived with his grandparents in Onley since he was 6 after being abandoned by his parents. "This is his home," she said.

Northampton District Court

James Edward Green Jr. of Chesapeake was arrested April 4 and charged with felony possession with intent to distribute marijuana, according to records filed in Northampton General District Court.

The alleged offense occurred the same day. He was arraigned Tuesday.

Exonerated Teacher Won't Return to Classroom

Pocomoke Middle School teacher William Albert Cathell Jr., who lives in Parksley, was acquitted earlier this month of charges that he sexually assaulted students. While he had been suspended pending trial, Cathell has decided not to seek re-instatement and has issued the following statement.



Cathell

"Having proven my innocence in a court of law, I have formally tendered my resignation to Worcester County Public Schools. I have decided that it is now time for me to move on to another career outside the field of public education.

"On Friday, March 18, a Worcester County Circuit Court judge threw out two cases, accounting for 12 of

the 24 charges against me. After about 90 minutes of deliberation, I was found not guilty of the other two cases and those 12 counts by a unanimous jury.

"I have lost so much that is irreplaceable. I cannot begin to convey the extent of those losses or the magnitude of devastation that being branded by these falsehoods has wrought. It will be a life-long struggle to repair the damage and rebuild my reputation and my life.

"My wife and I are extremely grateful to the parents, students, friends, family, churches, and other community members who stood by us and showed their support. Times like these reveal who your true friends are and they mean the world to us, forever having a place in our hearts.

"I implore Worcester County Public Schools and all school districts to install cameras in all classrooms for the protection of both teachers and students, and to prevent potential future incidents of false allegations.

New \$199.5 Million Orbital Contract Includes Wallops Launches

NASA has awarded its Sounding Rocket Operations Contract III to Orbital ATK, Inc., in Greenbelt, Md.

The cost-plus-fixed-fee contract, with a technical performance incentive fee, has a one-year base period and four one-year options. The total contract value, including the option periods, is approximately \$199.5 million.

Under this contract, Orbital ATK will manage and be responsible for providing all associated services and supplies for the Sounding Rockets Program, except those provided as govern-

ment-furnished property.

The contractor will conduct an estimated 18 launches per year throughout the period of performance.

The work will be performed at NASA's Wallops Flight Facility; White Sands Missile Range in White Sands, N.M.; remote launch sites, including the Poker Flat Research Range in Fairbanks, Alaska, Andoya Rocket Range in Andenes, Norway; and mobile launch sites, including Reagan Test Site in Kwajalein Atoll, Republic of the Marshall Islands, and Woomera Test Range in Woomera, Australia.

SOL Test Results Improve Status of Some Accomack Schools

Accomack County Public Schools will start the upcoming year with a "clean playing field," Sandra Drummond, the division's accountability and curriculum coordinator, recently reported to the School Board.

The "good news" is schools previously designated as priority or focus schools will be removed from that status, Drummond said. "It does not mean to get off the gas pedal ... we've got to continue."

Metompkin Elementary, where the School Board session was held, has been among the lowest performing 5 percent of Title I schools in the state. The designation remains with a school for three years.

"We are not going to be on that list," Drummond said. "More changes are coming absolutely."

Metompkin principal Karen Riner, who was transferred to the school last July from Chincoteague Elementary, said 16 teachers were replaced, a new

assistant was brought in, a new book-keeper was hired and the custodial staff has been replaced since she came on board. "It has been so exciting to be part of the transition this year."

The goal of getting students to read more went beyond expectations with "4,000 books read and counting." Riner said there was more parent involvement with more than 200 families attending various events. A program titled Positive Behavior Intervention and Support also was initiated, giving "everyone something to strive for" with good behavior being rewarded.

High-school Standards of Learning (SOLs) test scores from fall of 2015 also were discussed at the board session.

At Arcadia High School, 68 percent of students passed the English writing 11 SOL, 82 percent passed reading, 74 percent passed biology, 83 percent passed chemistry, 73 percent passed earth science, 80 percent passed Algebra I, 77 percent passed geometry, 81 percent passed Algebra II, 61 percent passed U.S. history, 62 percent passed world geography and 66 percent passed World History II.

At Nandua High, SOL passing rates were 77 percent for English writing 11, 81 percent for reading, 87 percent for biology, 75 percent in chemistry, 75 percent for earth science, 81 percent for Algebra I, 75 percent for geometry, 75 percent for Algebra II, 53 percent for U.S. history, 73 percent for world geography, 62 percent for World History II and 84 percent for World History II.

SOL passing rates at Chincoteague High were 75 percent for English writing 11, 100 percent for English writing 8, 83 percent for reading, 92 percent for biology, 90 percent for chemistry, 91 percent for earth science, 96 percent for Algebra I, 100 percent for Algebra II, 79 percent for U.S. history, 100 percent for world geography, 60 percent for World History II and 73 percent for World History I.

At Tangier, 71 percent of students passed the English Writing 11 SOL; 86 percent passed reading; 100 percent passed biology, earth science, and world geography; 80 percent passed Algebra I; and 83 percent passed Algebra II.

Northampton Begins To Whittle Budget

Northampton supervisors met for a second time this week Wednesday, in an effort to begin chipping away at the \$3 million plus deficit that must be dealt with for the FY2017 budget.

With a decrease in county assessments of over 20 percent, the board will need to adjust the taxes on real estate and if needed, tack on a few extra cents to cover the extra funding that may be needed.

County Finance Director John Andrzejewski itemized each of the budget increases, noting the largest requests were from the Emergency Medical Services Department (\$810,146) and the School System (\$391,781).

The board next reviewed requests by Sheriff David Doughty for his department, including four replacement vehicles, an additional school resources officer, a code enforcement officer, and an animal control officer. The board

discussed the sheriff's vehicle replacement schedule as well as the positions being requested. Doughty said he tries to replace vehicles when they approach 100,000 miles, which generally means replacing four units each year.

The board previously had agreed to fund two law-enforcement vehicles through the U.S. Department of Agriculture grant replacement deal brokered by County Administrator Katie Nunez. The board agreed to keep the four vehicles in the budget, but deferred a decision on the three staff positions. The county eliminated the full-time code enforcement position. Doughty has offered to include the position in his department if given an additional officer.

Supervisor Granville Hogg spoke of the need for resource officers to be in the schools and his colleagues agreed. For the moment, those positions remain in the budget.

The next budget session is slated for April 19 at 5 p.m. at which time the board will begin to review the School Board's budget requests.

Forbes Recommends Wallops for Drones

Congressman J. Randy Forbes, who represents Virginia's Fourth District, which includes parts of Norfolk and Chesapeake, as well as Franklin, Emporia, Blackstone, Short Pump and Petersburg, visited Wall, April 12th, 2016 to tour space facilities and meet with the Wallops Island Regional Alliance.

His visit coincided with the Navy's consideration of Wallops Island as the East Coast base for the MQ-4C Triton unmanned maritime surveillance aircraft, which would require the stationing of up to 400 personnel plus family members at Wallops.

"Wallops Island does important work, with tremendous potential to play an even more significant role for NASA, our national defense, the commercial space industry, and the economy of the region," Forbes said. "As a member of the House Armed Services Committee and Chairman of the Seapower subcommittee, I am particularly interested in opportunities to bring

new military missions to Wallops. With its prime location, room to grow, and experience operating unmanned systems, Wallops is an ideal place to base the Navy's new Triton aircraft, and I look forward to discussing that option with the Pentagon."

The Navy is currently considering Wallops as one of three East Coast options for permanently basing the MQ-4C Triton unmanned maritime patrol aircraft. The Triton provides real-time intelligence, surveillance, and reconnaissance capabilities in maritime and coastal regions. A decision on the permanent basing of the Triton is expected later this year.

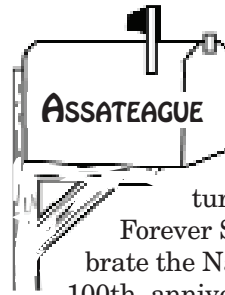

doing so, he noted the importance of eliminating the need to refer to the multiple editions, which encompass 700 pages, when an individual or business seeks to build within the county.

Earlier in the evening, County Economic and Community Development Director Kris Tucker gave a presentation on the state of the county economy. He noted that Northampton needs to increase the hireable workforce in order to attract new businesses. He also recommended that portions of Lankford Highway need to be selected for commercial development. Referring to the importance of making it easy for travelers to find such things as food, fuel, and a place to stay, he stated, "People aren't going to go exploring if they are heading for a destination."

Much of the citizens' information session focused on concerns over the county's Emergency Medical Services (EMS) system. A recent request for proposal (RFP) that was advertised by the county brought a large number of EMS workers to the session. According to several who spoke, the RFP appeared to be asking for bids by private ambulance companies to provide EMS coverage for the county.

Northampton EMS Director Hollye Carpenter expressed her concern over a lack of communication between county leaders and county employees. She noted that the county's paid EMS staff is far more qualified to meet the needs of the citizens of the county than a private ambulance service.

Greg DeYoung of Community Fire and Rescue in Exmore said the RFP was a slap in the face of EMS staffers and volunteers.

Others questioned how supervisors had met, possibly in an unadvertised meeting, to develop the RFP or had even communicated with a private EMS company prior to issuing the RFP.

In response to the numerous comments and concerns raised over the issue, LeMond stated that the board is not actively seeking to replace the county's EMS staff, but rather is seeking to have a survey conducted by an outside agency. He noted that Carpenter has asked for additional personnel to meet the needs of the coun-

ty, at a projected cost of approximately \$500,000. If approved, it would require a tax increase of 4 or 5 cents per \$100 of assessed value. (Currently, the county has 32 EMS staffers.)

According to Carpenter, the move of the local hospital from Northampton to Accomack County is expected to add a strain on the Northampton's paid and volunteer EMS services, thus the need to add more personnel. LeMond emphasized that the RFP was just a study and not an effort to replace anyone.

Murray said the real issue is to have enough EMS personnel to handle the needs of the county's population. "Not one of the companies that responded to the RFP owns an ambulance," he said. "It's a big issue and we need to do the right thing for the county."

In a related area, the board agreed to postpone a decision regarding the EMS vehicle garage proposed for the Machipongo area as well as hiring any additional EMS personnel.

Northampton Sheriff's Office Accepting Medications for Disposal

On April 30 from 10 a.m. to 2 p.m., Northampton Sheriff's Office and the Drug Enforcement Administration (DEA) will give the public its 11th opportunity in six years to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs.

Pills can be brought for disposal to Northampton Sheriff's Office in Eastville. (The DEA cannot accept liquids, needles or sharps, only pills or patches.) The service is free and anonymous, no questions asked.

Medicines that languish in home cabinets are highly susceptible to di-

version, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. In addition, Americans are now advised that their usual methods for disposing of unused medicines — flushing them down the toilet or throwing them in the trash — both pose safety and health hazards.

Police Action

One of the most common questions I am asked is in regards to child restraint laws. Hopefully, I can bring some clarity to this issue and encourage everyone to buckle up their little ones.



Every child under the age of 18 must be secured in a restraint, regardless of where they are seated in the vehicle. This article specifically addresses children under the age of 8.

I fully support the "Click it or Ticket" campaign which begins on May 18 and I have directed my troopers to aggressively enforce all seat-belt and child-restraint violations. Every parent I know would gladly lay down their lives to protect their children, and making sure they are properly restrained is the best way to ensure their safety.

Section 46.2-1095 of the Code of Virginia sets forth the requirements for child restraints. It states, "Any person who drives on the highways of Virginia any motor vehicle manufactured af-

ter January 1, 1968, shall ensure that any child, up to age eight, whom he transports therein is provided with and properly secured in a child restraint device of a type which meets the standards adopted by the United States Department of Transportation. Further, rear-facing child restraint devices shall be placed in the back seat of a vehicle. In the event the vehicle does not have a back seat, the child restraint device may be placed in the front passenger seat only if the vehicle is either not equipped with a passenger side airbag or the passenger side airbag has been deactivated."

There is no longer a weight in which a child can move from a child restraint to a seat belt. Children under age 8 MUST be in either a car seat or a booster seat. It is recommended that parents follow the manufacturer's recommendations when making the move from a car seat to a booster seat. The most important aspect in making this determination is that the seat belt should fit properly when moving into a booster seat. If the shoulder belt does not fit across the shoulder and chest, a child should remain in a car seat.

Also, it is recommended that children always be placed in the back seat of vehicles, when possible, due to the injuries that may be sustained from the air bag system. It is required that any rear-facing car seat be placed in the back seat of the vehicle, or the passenger's side air bag system deactivated. Serious injury can result when an airbag strikes a rear-facing child seat.

Once again, my office is committed to protecting our children, and on May 5, Trooper John Feryus will complete his training to become a certified child restraint technician and will be available to assist parents, grandparents and caregivers in the proper installation of child seats. Feryus may be reached by calling my office at 787-5813.

Also, Eastern Shore Rural Health has a program called "Safe Kids Eastern Shore" in place to assist parents who need financial assistance with obtaining a car seat. For more information regarding this program, contact Heather Dean at 442-4819, ext 320.

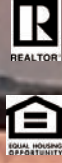

A Shot at the Masters that Defies Tradition

Apparently, we witnessed a tradition unlike any other on that April day in 2009 at Augusta National.

It was a Tuesday practice round prior to the start of the Masters when Vijay Singh came to the 16th hole with Sean O'Hair and Ken Duke. After hitting their tee shots, O'Hair stopped at the edge of the water that spans from just in front of the tee to the green. He dropped a ball and skipped it across the pond that fronts the green.

It is a practice-round tradition that the crowd urges golfers to attempt after they hit their tee shots at the 16th hole.

Singh was next, and he dropped a ball next to the pond and hit a low shot across the water. The crowd saw it skip once, twice, three times and then leap onto the green, where it made a sharp left turn and tracked toward the cup like a magnet was pulling it for the unlikely of holes-in-ones.

Since then it has been shown on YouTube thousands of times. There have been several articles about the shot and the practice round tradition that evokes questions of how it began.

But, as my golfing buddy Charlie Cameron often reminds me, we were there on the front row watching it in person the day Singh perfected the shot.

Charlie had won the golf lottery that year for four tickets to a practice round at the Masters. Carlton Leonard, my brother Steve and I joined him for a memorable trip that included some golf at famed Pinehurst on the way to Augusta.

On a windy, blustery day that must have resembled this week's weather at the Masters, we walked the course that many have called the most beautiful piece of real estate on earth.

We checked out Amen Corner, that stretch of holes 11 through 13 that

gives golfers fits. Just ask Jordan Spieth, who took a 7 on 12 to throw away the tournament last Sunday.

We eventually settled in alongside the 16th hole, a par 3 where a spectator can see the tee shot and also have a good view of where the ball lands on the green or in the drink.

A number of golfers that day had responded to the cheers of the gallery to give the skip shot a try. Those who ignored the calling were greeted with a chorus of boos.

It was the first Masters for Ken Duke, playing with Singh, and he had looked forward to honoring the tradition of the skip shot. But after watching Singh hole out, he celebrated with the group and then waved his arms, as if to say, "How do you follow that?"

He picked up his ball and walked on, the crowd giving him a reprieve for not attempting to duplicate a hole-in-one.

According to a recent article in Golfweek, it is not certain when the tradition of skipping a ball across the pond at the 16th hole began, but the early practitioners of the shot usually received a stern letter from the chairman of the club, where decorum is held in high regard. However, enough players persist-

ed in delighting the crowd with the shot that now most pros join the fun. There's even one story that Lee Trevino, so disgusted with his round one year, did it on purpose from the tee during the tournament. And he made a par.

I know watching Singh make that hole-in-one is a lasting memory for our group from that special day.

We have tried every year since to win the Masters lottery for either practice or tournament tickets. The tickets are not all that expensive, just difficult to get. If you ever have the opportunity, don't pass it up.

The Augusta National Golf Club, where the Masters is played each April, was once a nursery encompassing 356 acres. When golf legend Bobby Jones retired from championship golf in 1930, he hoped to realize his dream of building a golf course.

Upon seeing the Georgia property where a great variety of flowering plants and trees, including a long row of magnolias planted before the Civil War, remained on the grounds, Jones said. "Perfect! And to think this ground has been lying here all these years waiting for someone to come along and lay a golf course on it."

Construction on the new course began in 1931 and the course opened in December 1932. The holes are named for the various plants and trees on the property, including Pink Dogwood, Flowering Peach, Juniper, Carolina Cheery, Nandina and others from the 80,000 plants and over 350 varieties that dot the Augusta landscape.

The Masters started in 1934 as a small invitational golf tournament. It was known as the Augusta National Invitation Tournament until 1939 when the present name was adopted. It is now one of the four majors and considered by many PGA touring pros to be the most coveted title in golf.

A few friends who had been to Augusta had told me no matter how high my expectations of the course were, they would be exceeded when I saw it in person. I have watched the Masters on television since I was a young boy and have come to enjoy Sunday at the Masters more than any sporting event in the calendar year.

Flounder, Togs Top Local Fishing Report; Anglers Hoping for Better Weather

With two flounder tournaments opening up today in Wachapreague with big prize money at stake, anglers won't be pleased with the northeast winds predicted for the weekend.

Here's what Dr. Julie Ball is saying about fishing prospects.

With the Virginia cobia season threatened by restrictive regulations this year, anglers are looking for some positive news on the fishing front.

Flounder have debuted in the sea-side inlets on the Eastern Shore, where anglers are watching for optimal days to target them with strip bait and gudgeons, especially in Wachapreague and Oyster. This action will only improve as the water continues to warm.

Tautog action is still going strong, and the spring tog bite has really taken off in bay waters. And with fiddler crabs now available, it is game-on. Fiddler crabs and even blue crabs are working well on lower bay structures and wrecks. The rocks and tubes of

the artificial islands and the pilings near the high-rise section of the Chesapeake Bay Bridge-Tunnel are providing very good results.

Most anglers are catching limits of fish ranging to around 4 pounds, but some nicer tog over 6 pounds are also

in the mix. Deeper water wrecks are also producing nice tautog, with fish to 15 pounds taking offered crab in water ranging to around 70 to 100 feet. Seabass are also available on many of these deeper structures, but they are still illegal to keep.

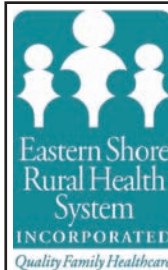

From the OutPost

I recently had the pleasure of visiting relatives in the Philadelphia area and meeting a few of their friends.

As is often the case in such situations, it didn't take long for someone to comment on my vernacular. While, as a life-long Eastern Shore resident, I don't see anything unusual about the way I speak, obviously some of those not as fortunate to live here find it slightly peculiar. Apparently, it's not only the so-called "accent," but also some of the terminology.

For example, I like to never got one

woman to understand that "like to never" is just another way of saying "almost." "Why don't you just say 'almost'?" she challenged me. "Guess I just like to never thought of it," I told her.

There is, however, one group of folks who have given a lot of thought to our local vocabulary, and for a very good reason. Seems this bunch of medical folks decided they better compile a list of Eastern Shore medical terms in order to make new clinicians aware of what they might come across.

To make it worse, I got the sugar and my glucometer has went up.

Guess I'd better call my doc. At least he understands me.

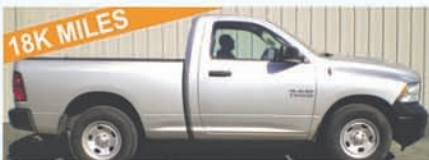
