Homicide Reported

The body of a 41-year-old Northampton man was found in a field off Davis Wharf Road near Craddockville Wednesday, Accomack Sheriff Todd Godwin reported Thursday.

The death of Eric Clifford Rhatigan of Eastville is being investigated as a homicide, the sheriff disclosed in a prepared statement.

A spokesperson for the Norfolk Medical Examiner's Office said results of an autopsy that would determine the cause of death are not expected until after press time Thursday.

Northampton OKs Budget

Northampton supervisors briefly discussed the proposed FY2017 budget and tax rates that will finance it Tuesday before approving the \$42,375,399 spending package, 4-1. Supervisor Granville Hogg voted in opposition.

The tax rate of \$0.83 per \$100 of assessed value for real estate is less than ½ cent above the equalized tax rate following the recent reassessment of property.

The budget includes all county departments, including the schools.

Hogg pressed to have the tax rate on aircraft reduced from \$3.90 to \$0.99 per \$100 of assessed value. Commissioner of the Revenue Charlene Gray explained that the county's tax rate for aircraft is based on 70 percent of a standard "blue book" estimate. A comparison of Northampton and Accomack County's tax rate on aircraft showed that it is more expensive to own one in Northampton County.

Speaking as a tax-paying citizen, Gray said she sees

Local First Responder, Saltwater Cowboy Dies in Single-Vehicle Crash

A member of two local fire departments, who was also a former Marine, died last week in a traffic crash in Stockton, Md.

Justin Lee Lewis, 26, of Snow Hill, Md., was driving north on Route 12 in a 1999 green Honda Civic in the area of Pike Lane in Worcester County at about 3 a.m. June 9 when “for unknown reasons, the vehicle left the right side of the road ... striking a tree, causing the vehicle to overturn,” according to Donna Cobb of Maryland State Police.

There were no passengers in the car. Lewis died at the scene. An investigation of the incident is continuing, Cobb said. “Contributing factors to the collision are still being determined,” she added.

Lewis was not wearing a seatbelt. His body was sent to the medical examiner’s office for autopsy.

The northbound lane of Route 12 was closed for about three hours following the crash. State police were assisted by the Worcester County Sheriff’s Office, Maryland Chief Medical Examiner’s Office and Girdletree Fire Department.

Jeremy Eggers of NASA said Lewis joined the Wallops Fire Department in 2013 following service in the Marine Corps.

Lewis was also a member of Chincoteague Volunteer Fire Department and was a Chincoteague saltwater cowboy.

Shore Backs Taylor for House Seat

The majority of Accomack and Northampton voters who cast their ballots in the Republican Primary Tuesday followed the 2nd District trend by nominating Del. Scott W. Taylor of Virginia Beach as the party’s candidate for Congress in the November General Election.

Rep. Scott Rigell is not seeking re-election.

Raised in Hebron, Md., Taylor is an entrepreneur and real-estate broker. He beat out C. Pat Cardwell IV, a lawyer who lives in Virginia Beach, and 4th District Rep. J. Randy Forbes of Chesapeake.

In Accomack County, 677 voters cast

their ballots for Taylor, while 531 went for Forbes and 57 favored Cardwell. In Northampton, 276 voted for Taylor, 227 picked Forbes and 20 cast their ballots for Cardwell.

Taylor carried Chincoteague, Atlantic, Greenbackville, Oak Hall, Accomack, Tangier, Onancock, Onley, Bobtown, Melfa, Wachapreague and Painter in Accomack, and the Cape Charles Nassawadox, Machipongo and Exmore areas in Northampton.

Forbes took Bloxom, Parksley, Saxis, Mapps ville and Rue in Accomack; the Cheriton area in Northampton; and the majority of absentee ballots in both counties.

Body Discovered in Quinby Harbor

The body of a Maryland man was found in Quinby Harbor last Saturday, according to Accomack Sheriff Todd Godwin.

Responding to a call that came in about 2 a.m. June 11, deputies and rescue personnel found the body of Roger Meeks Jr., 61, of Eldersburg, which was pulled from the water.

“Meeks had been staying with a

friend who owns property in Quinby,” Godwin said Tuesday. “At this time, there is no indication of foul play; however, a death investigation is ongoing and a final determination as to the cause of death will be made following receipt of lab examinations.”

There is very little splashing, waving, or shouting. Often help is nearby but no one knows what is happening. Drowning takes as little as 20-60 seconds.

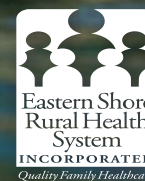

Court Postings

Northampton Sheriff's Office

More than a dozen vehicle burglaries in several areas were reported to the Northampton Sheriff's Office last week, according to Sheriff David Doughty. A variety of items were taken, mainly from unlocked cars. Entry was gained to one vehicle after a window was broken, he said.

Doughty reminded people to lock their vehicles and outbuildings and avoid leaving valuables in sight.

Citizens are asked to call the sheriff's office at 678-0458 if they see a suspicious person, vehicle, or activity or have any information regarding the recent break-ins.

Accomack Circuit Court

A Parksley man was convicted for a second time and again got a suspended sentence for a sex offense, according to records filed in Accomack Circuit Court.

Chief Judge William R. O'Brien,

who previously vacated the conviction and sentence of Richard Alexander Lewis, 26, of Mary Street, accepted a plea bargain last week that amended the charge to a non-violent offense of using a communication system to solicit a minor.

Lewis was convicted previously of having carnal knowledge of a 14-year-old girl and given a seven-year suspended sentence. The new conviction drew the same sentence.

Because the defendant is Judge W. Revell Lewis' nephew, another judge handled the proceeding. A special prosecutor, C. Andrew Rice, an assistant commonwealth's attorney in Virginia Beach, was assigned the case.

Under the first plea bargain, a charge of taking indecent liberties with a child was not prosecuted in exchange for a guilty plea to the carnal knowledge count.

Written evidence at the first trial stated that Lewis and the girl had been texting on July 17, 2015, before he took her and one of her friends for a ride and the encounter occurred. Defense lawyer Adam M. Carroll of Vir-

ginia Beach said it was consensual.

In another case involving defendant Lewis, Judge John R. Daffron Jr. gave him a three-year suspended sentence for forgery, passing a bad check, and obtaining money by false pretenses — 2014 crimes at a family business. Restitution of \$9,156 was made.

Tia Michelle Harmon, 45, of Pearl Drive in New Church was sentenced on each of two counts of forgery to two years, with all but a month suspended, to run consecutively. Restitution of \$165.75 was ordered to Jeanne or Rick Trotman of Chesapeake.

Keshawn Savage, 26, of Rantz Lane in Withams pleaded guilty to felony eluding and possession with intent to distribution between a half-ounce and five pounds of marijuana on Jan 10, 2015. A presentence report was ordered.

Northampton Circuit Court

A Cheriton man was acquitted Monday in Northampton Circuit Court of robbery, and assault and battery.

At trial, charges against Marquese Damion Washington, 23, were dismissed in connection with allegations

from Dec. 11, 2015.

In another case, Washington Javon Smith III, 24, of Cape Charles was sentenced for unlawful wounding to five years, with all but 12 months suspended.

Accomack District Court

Accomack General District Court Judge Gordon Vincent found probable cause Monday to certify to a county grand jury a felony charge of threatening to burn down the Tyson's plant in Temperanceville.

Patrick Richard Corey, 29, of Hornstown Road in Horntown is accused of the April 8 offense. According to evidence given at a preliminary hearing, Corey made the threat after a disturbance occurred in the plant's Human Resources Department and he was about to be escorted off the premises.

Defense lawyer Carl Bundick said Corey "was upset and running his mouth and making gestures. It certainly appears the language was very bad that afternoon," but there was "no intention to burn down ... Tyson's Food."

Spencer Morgan said, "In this case, it's clear what his intention was."

In another case, Morgan decided not to prosecute Corbin Kenji Drummond Jr., 36, of Smith Lane in Atlantic on a charge of threatening to burn Keith Lewis' home on Atlantic Road in Atlantic on April 20. The victim said in court records that Drummond came to his home, an argument ensued and he said he was going "to burn my trailer."

A local man was accused last week of robbing a Tasley convenience store in 2015, according to records filed in Accomack General District Court.

Vontrell Lataize Trader, 26, with addresses in Accomack and Melfa, was charged with robbery and use of a firearm at Oceanway on April 13, 2015. Trader was arrested June 9, 2016, by Deputy M.R. McCready of Accomack County Sheriff's Office (ACSO).

The charges include robbing Kenyun Wyche, a clerk at the store, and "use of a firearm in a threatening manner while committing ... robbery."

Trader is being held without bond in Accomack Jail. Investigator C.A. McPherson of ACSO investigated.

In another case, Humberto Cropper Vasquez, 20, of Lankford Highway in Temperanceville was charged with unauthorized use of a vehicle, driving on a suspended license and stopping a ve-

hicle on a road in a dangerous manner in connection with a June 10 incident. He was arrested the same day.

The vehicle belonged to Nathaniel Ross Mumford, also of Temperanceville. Vasquez is being held without bond. Senior Trooper J.N. Godwin III investigated.

A New Church man, released in April after it was determined there was not enough evidence to convict him of murdering a local resident, Monday waived extradition to Maryland, where he is wanted on charges of armed robbery and related offenses.

Jahad Arell Triggs, 21, of Chincoteague Road in New Church is accused of armed robbery, first-degree assault, use of a firearm in a violent crime and second-degree assault, according to records filed in Accomack General District Court. He is being held without bond in Accomack Jail until Maryland authorities come to retrieve him.

The court documents state that a U.S. marshal brought Triggs to the jail on June 9. The Maryland charges, which allegedly occurred Dec. 1, 2015, were then confirmed by ACSO.

Triggs was one of two suspects freed after an administrative action taken on April 15 in Accomack District Court. He was accused of murdering Robert Franklin Baytops IV of Horntown on Feb. 4.

Accomack School Board To Meet with Supervisors

It will be done secretly until it isn't. Chairman Ron Wolff of the Accomack Board of Supervisors (BOS) has been trying to get the county School Board (SB) to meet with his panel since January. Wednesday, during the sixth month of the year, he told fellow supervisors that Chairwoman Margaret Miles wants to receive some dates to choose from.

Wolff said both he and Miles agreed that the last meeting was "very unproductive. 'When you have 18 or 20 folks, things don't get said by people who don't want to say anything. Break into smaller groups where we can come up with agenda ideas,' " Wolff said Miles told him. "Which I think is a pretty fair idea. I'm sure there will be repetition of agenda

items. Then make into an agenda."

Supervisor Donald Hart suggested that Wolff, Miles, BOS Vice Chairman Robert Crockett, SB Vice Chairman Travis Thornton, Superintendent Chris Holland and County Administrator Steve Miner should get together to come up with some good topics.

The board agreed, so that is the plan. But that meeting does not have to be public since only two members from each board will attend that session.

The dates for the joint meeting will be worked out when the agenda is set. Wolff also previously complained that Holland had not come before the supervisors to make a report about county schools. He made the report Wednesday.

Judge Vincent accepted Deputy Commonwealth's Attorney Matthew Brenner motion not to prosecute because "the commonwealth's evidence is not sufficient to secure a conviction at this time." Sheriff Todd Godwin later said, "I thought we had a good case." Triggs had been held in jail for murder and use of a firearm in that crime since Feb. 11.

Meanwhile, Florida authorities are seeking to extradite a man who has been living in Accomack for about a month and was arrested here June 3. Court records state Louis Morton Jean-Francois, 28, of Liberty Lane is accused of having sex with a 14-year-old girl who was visiting relatives in Collier County, Fla., between Feb. 1 and March 31, 2015. The girl became pregnant because of the encounter, the record states.

She told Florida authorities he followed her into a bedroom where she slept during her visit and forced himself on her. The six-foot, 300-pound man threatened her not to tell or make any noise during the alleged crime, the record continues.

Jean-Francois, identified as a friend of the girl's family, told an ACSO inves-

tigator that he had sex with her one or two times. He said he didn't know how old she was. Jean-Francois is being held without bond in Accomack Jail. In Florida he had been released on \$50,000 bond.

A New Church man will be sent to Maryland to stand trial for robbery and related offenses that occurred last December.

According to records filed in both Virginia and Maryland courts, Gregory Eric Conquest Jr., 24, of Hornstown Road is accused of armed robbery, conspiracy to commit armed robbery, first-degree assault, use of a firearm in a violent crime, second-degree assault, reckless endangerment, possession of a handgun on a person and conspiracy to commit those crimes.

The offenses allegedly occurred in Somerset County on Dec. 9, 2015. Conquest was arrested in Accomack County on June 7 after Deputy T.C. Haines filed a complaint.

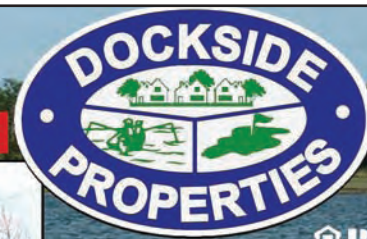

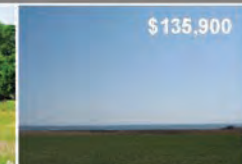

Landfill Nears Capacity as DEQ Withholds Permit

What has at least 25 more years of life, but could meet its end before the start of 2017?

The Accomack County landfill.

Public Works Director Stewart Hall says the state Department of Environmental Quality (DEQ) has dragged its feet for more than a year about issuing

a permit to expand the northern dump in Atlantic to allow a third cell to be built. The delay could cost Accomack up to \$40,000 a month.

So though the facility has enough property to continue until around 2041, and Cell 2 has been in use for approximately 13 years and is nearing the end, construction can't begin.

"We want to get it built this summer," said Hall. "We must have a liner, piping system and earth work done." The director said it's a summer job, not for spring "when it's too wet" or winter "when it's too cold."

"Trash waits for no man or woman is what I say around the shop," Hall repeated Tuesday. "Time is of the essence," were his words to the DEQ last month.

In that letter to the agency, Hall told of the permit application that was submitted in February 2015.

In March 2016, the county and its consultant, CHA Consulting Inc., met with DEQ "to review the status of the permit application. At that time, the county ... indicated the current cell at the landfill was reaching capacity. I informed my board ... that we will need to begin exporting waste as of June 1, 2016," Hall told the DEQ. That process has begun at the rate of \$1,000 per day, though refuse is not transported every day.

"The additional out-of-pocket cost is estimated at \$20,000 to \$40,000 per month, depending on the amount of waste diverted," Hall wrote to the state department.

At the current rate, cell 2 will be full by the end of 2016.

"We have prepared a schedule that will allow us to construct a new cell in 2016," he continued. "We are requesting your cooperation to meet this schedule," which "assumes the department will issue a temporary authorization to begin construction in August. Note that if we do not meet the schedule for completing the bid period in mid-July, the next County Board of Supervisors meeting would be August

17 and that would mean delaying the start of construction until September and that potentially means construction could not be completed in 2016."

"We still don't have a permit in hand, but we have to have some kind of plan," Hall said Tuesday. "It's probably a good idea to take a load or two to Hampton."

"I'm trying not to throw them under the bus," Hall said of the DEQ. "They've been asking for additional information that they never requested before. They could have moved fast design of the application process."

Asked if other places have similar problems, Hall mentioned Worcester County, Md., that is in the same situation with its state agency. "They've had one pending over a year also," said Hall. "We don't have much space ourselves," someone in that county told him when he asked about taking Accomack garbage there.

"I sent a schedule to DEQ of things we would provide," Hall said. "They did call and say they could meet that schedule." There was no written confirmation, he added. "They said between the lines that I was being an alarmist."

"We want to start it way ahead of time so there are no issues," Hall said.

The southern landfill was closed at the end of 2012 and is serving as a transfer station. "We don't bury trash there. We load it into tractor-trailers and carry it to the northern landfill to dump," said Hall.

With respect to cost, Stewart said, "We've spent \$255,410 to date, mostly on the engineering and permitting. Current estimate for the construction phase is \$3.3 million."

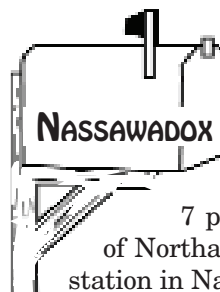

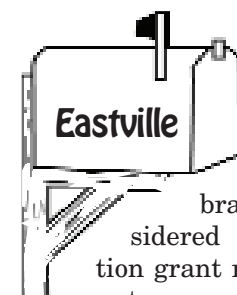
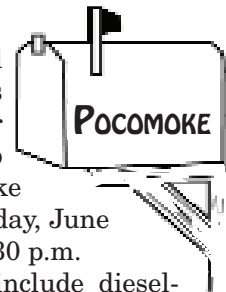
The show will include diesel- and alcohol-powered super and pro-stock tractors, two-wheel-drive trucks, four-wheel-drive diesel trucks, modified tractors, and hot farm tractors. The equipment will carry such colorful names as "John Deere Green," "Mischievous Maker" and "Radial Reactor."

A truck and tractor pull is a modern-day event that evolved from horse pulls, where farmers challenged one another to see whose horse could pull a cart or sled filled with stone the greater distance. In today's truck and tractor pulls the vehicles often make a lot

At its May meeting, the Circuit Court Records Grants Review Board of the Library of Virginia considered records preservation grant requests from circuit courts across the commonwealth.

Northampton County's project request was one of 73 grants totaling nearly \$900,000 that were approved. It amounts to \$9,868.50, including \$2,012 for professional conservation treatment of Deed Book 71 (1915-16), \$3,633 for Deed Book 29 (1824-34), \$2,780 for Deed Book 39 (1831-36), and \$1,443.50 for Superior Court Orders.

Funded through a \$1.50 fee included with the cost of recording land transactions and judgments, the Circuit Court Records Preservation Program provides resources to help preserve and make accessible permanent circuit court records.

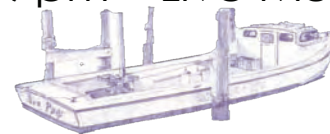

Sewage Leak at Metompkin Elementary Has Been Corrected

"We have fixed the problem," Accomack Schools Chief of Operations Mike Tolbert reported to the Board of Supervisors Wednesday regarding a sewage leak at the kindergarten playground at Metompkin Elementary School in Parksley.

"The system is getting on to about 18 years old now," he explained. "Things do wear out. We will replace them as they fail. We had a pump fail as they sometimes do. Working on one pump, we overloaded one side of the drain field. The playground was closed the same day ... the contractor was hired ... we wasted no time doing what we should have done."

The problem was first reported May 25 and was mentioned at the supervisors' session Wednesday when Supervisor Grayson Chesser asked for an explanation from Superintendent Chris Holland.

Holland said he went to investigate the issue four or five weeks ago. "They put the playground over the septic," he explained. "I went over there three times ... I went over there the other day. It was not wet at all ... I drove a car around it ... we put down mulch."

Tolbert further explained, "It's a condition of the original design. I was not involved in the original design. ... We have spoken about reserve drain fields located to the west in the field between the Town of Parksley and the building. We'll be asking for a permit to remove those drain fields to the reserve area."

"This is Murphy's Law," said Supervisor Paul Muhly. "You're going to have a failure again somewhere down the line. I would feel much more comfortable if you moved the playground."

But Tolbert said the location of the playground, just behind the school, is needed so that students can quickly get back inside the building when or if

necessary. "We would prefer to have the playground at the back door. We'd rather move the sewage," Tolbert said.

The operations chief also stated that two pumps wound up being replaced. The health department "told me we have gone well out and beyond. We've been through this exercise a few times." The playground "will not be reopened before the children are out of school." But it will be ready for the start of the next term. "We've gone a little farther. We did not have to replace that control panel," Tolbert said.

Chairman Ron Wolff received an email complaint that stated it was the third year in a row a leak occurred.

County Prepares for Arrival of Zika Virus

The Virginia Department of Health (VDH) reported 25 cases of the Zika virus to the Center for Disease Control (CDC) as of June 9. Officials on the Eastern Shore met this week about the issue to get prepared as the area is considered to be at medium risk.

A breakdown of the cases, according to the VDH shows one report in the Eastern Region. Accomack County Administrator Steve Miner told the Board of Supervisors Wednesday there is none here yet.

The CDC has issued a travel alert for people going to regions and certain countries where transmission is ongoing.

Zika, a viral disease that causes 20 percent of those infected to become sick with fever, rash, joint pain and conjunctivitis, is primarily spread to people who are bitten by infected mosquitoes.

The other 80 percent of those infected do not become

Tolbert said that wasn't true. "It has happened three times in the last 16 years," he said.

The system will be tested before the health department is called back for an inspection. Senior Environmental Health Manager Jon Richardson of the Eastern Shore Health District said the contractor also will be required to report findings, corrective actions and "an affirmation that the system has returned to normal function."

He confirmed that lime was put down to kill any bacteria that might have been present and mulch would be removed and replaced in the area.

He said an issue also was reported about two years ago, but no problem was found.

sick, the website states. "The illness is usually mild and the symptoms typically last several days to a week."

"Mosquitoes become infected by feeding on infected persons," the health department reported. "Zika virus is transmitted primarily by ... yellow fever mosquitoes and Asian tiger mosquitoes ... but sexual transmission has also been documented."

"The point is starting to talk about mosquito control," Miner told the supervisors. "The bottom line is the health director is starting to talk about using our authority. They're working on it. (Health District Director) Dr. (David) Matson asked to come to our next meeting just to share information in a public manner about the virus ... the virus isn't here yet ... so far no reported cases."

Miner said the "good news is they are working on a shot for it. Not there yet ... control of the breeding ground is very, very important."

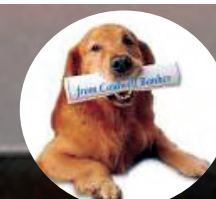

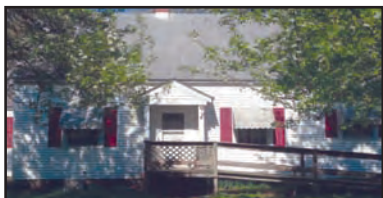

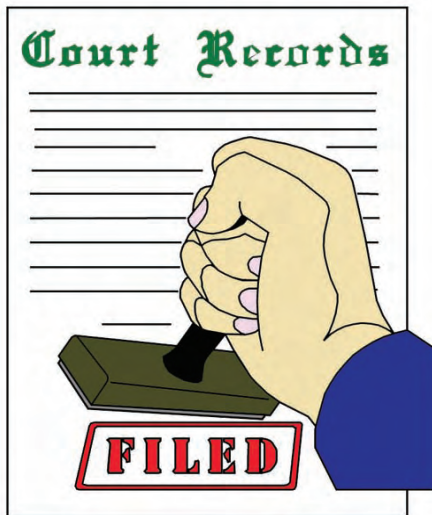

ROCKET WEEK WILL FEATURE LAUNCH OF STUDENT EXPERIMENTS

During Rocket Week from June 18-24 at Wallops Flight Facility, nearly 200 university and community college students and instructors from across the country will build and fly experiments on a NASA suborbital rocket through the RockOn! and RockSat-C programs. Another 20 high-school educators from the eastern United States will examine how to apply rocketry basics into their curriculum through the Wallops Rocket Academy for Teachers (WRATs).

The week will end with the students launching their experiments on a Terrier-Improved Orion suborbital sounding rocket at 6 a.m. June 23.

The rocket will carry 22 experiments from the RockOn! program, nine experiments from the RockSat-C program and more than 80 small cubes with experiments developed by middle-school students in 49 states as part of the Cubes in Space program, a partnership between idoodlelearning inc. and the Colorado Space Grant Consortium.

After flying to nearly 70 miles altitude, the payload will land via a parachute in the Atlantic Ocean, where it will be recovered. The participants are expected to have their experiments in hand later in the day to begin their data analysis.

“The participation in the Rocket Week programs continue to grow, showing the continued interest in NASA and science, technology, engineering and math (STEM) careers,” said Joyce Winterton, Wallops senior adviser for education and leadership development. “Working with the participants, we want to show the importance of STEM majors and the opportunities that are open to them, in particular, those in the aerospace fields.”

Conducted with the Colorado and Virginia Space Grant Consortia, RockOn! is in its ninth year, RockSat-C its eighth and WRATs is in its sixth year.

Chris Koehler, director of the Colorado Grant Consortium, said, “RockOn!/RockSat is a three-tier program

that takes students from learning to crawl, through the baby steps and then on to walking in scientific experiment development. They will advance not only their technical skill sets, but also those of working with others and becoming team leaders. These are skills that are highly sought by employers.”

In RockOn! the participants receive instruction on the basics required in building and developing a scientific payload for flight on a suborbital rocket. After learning the basics in RockOn, students may participate in RockSat-C, where they design and build an experiment for rocket flight during the school year.

WRATs works with high-school teachers to show them the basics of rocketry and how to take what they learn into the classroom. The 20 participants from Virginia, Maryland, West Virginia, New Jersey, Pennsylvania and Washington, D.C., will receive instruction on the basics of rocketry, including Newton’s Laws, electronic fun-

damentals, drag and propulsion. This instruction will be applied to hands-on learning activities, including building and launching model rockets.

“The RockOn/RockSat program provides hands-on training for students in the critical development of scientific payloads so these students are ready to enter STEM careers in government agencies and commercial fields upon graduation,” said Phil Eberspacher, chief of the NASA Sounding Rocket Program Office at Wallops. “WRATs helps the teachers show students that STEM is interesting and can be a path to exciting careers. The educators participating have shown a great dedication for working with students. We want to support them with the tools needed to reach their students and guide them to STEM careers.”

The RockOn!, RockSat and WRATs programs are supported by the NASA Sounding Rocket Program. RockOn! also is supported by NASA’s Office of Education and NASA’s National Space Grant College and Fellowship Program in partnership with the Colorado and Virginia Space Grant Consortia.

The NASA Visitor Center at Wallops will open at 5 a.m. for viewing the launch, which is predicted to only be visible in the Wallops area. If needed, the backup launch day is June 24.

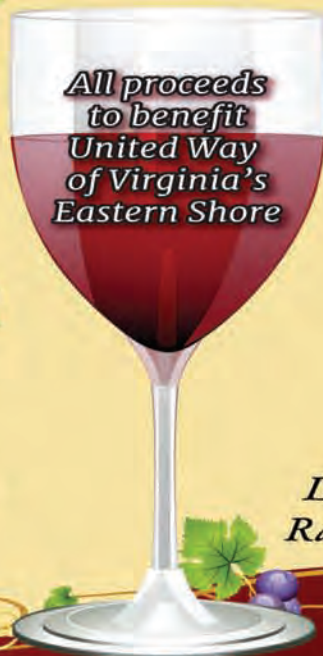

no difference between owning an aircraft or a motor vehicle, which is taxed at the same rate. Currently there are approximately eight aircraft in the county.

The supervisors welcomed a new bed and breakfast by approving the special-use permit (SUP) requested by Candace and Lee Nottingham of Smith Beach.

No one spoke in opposition to the SUP and the board voted unanimously to support the request.

A second SUP request came from Cheriton businessman Gary Wagner, who wants to expand his excavation operation near Eastville.

The operation, classified by the state as mining because it involves digging for a product, namely dirt, gravel or sand to be used in landscaping.

Hogg questioned the security of the excavated area in that there are several families living in a nearby subdivision. While there is a vegetated buffer of 200 feet between the subdivision and the excavated area, he called for a fence to be placed around the pit and area that contains water.

Wagner noted that the property has no trespassing signs around it and the vegetated area is very thick with underbrush, thus making it very difficult for someone to trek through it. He added that he has never had a problem with people venturing into the excavated area.

Supervisor Oliver Bennett agreed that a fence probably is needed, adding that at least one other property owner was required to fence an irrigation pond near a residential area.

Board Chairman Spencer Murray said he supported the SUP and did not feel that installing a fence was necessary in this case. Hogg's motion to require a fence in order to approve the SUP was defeated, 3-2, with Supervisors Murray, Larry LeMond, and Robert Duer voting against it. A second motion to allow the SUP without the requirement for a fence was approved by a 3-2 vote, with Hogg and Bennett voting against.

Murray addressed an issue that had been raised concerning the county's involvement in a bond issue that was being supported by the Joint Industrial Development Authority (JIDA). The bond is being sought by James City County to help fund an assisted living facility there. Murray explained that the JIDA's support of the bond in no way places financial obligation on Northampton County and, in fact, a small amount of interest would be forthcoming.

Broadband Authority spokesman Nick Pascaretti provided the board with an update on the status of broadband development. He noted that over 300 miles of fiber has been installed on the Eastern Shore and as a result, a

number of communities now have access to high-speed Internet.

Additionally, Pascaretti noted that the Broadband Authority has set up a number of Wi-Fi hot spots to will allow users to access the Internet without charge. Most of the hot spots are public areas such as parks and other local government properties.

Murray pressed Pascaretti to provide more data regarding when the rest of the county's residents and businesses might be able to expect coverage. Pascaretti said the authority is in negotiations with other providers in an effort to do just that. Duer also asked Pascaretti about providing Wi-Fi to the Exmore town park area.

During the citizens' comment session, Kiptopeke resident Senora Lewis urged the board to revoke an SUP issued to Royal Farms to construct a convenience store in the Kiptopeke area. Lewis contended it is not needed and would pose safety issues for children who live in nearby homes. She said she had a petition signed by 110 individuals opposed to the Royal Farms project.

Murray responded that there is no way to revoke the SUP as long as the owner complies with its stipulations.

Lewis pressed Hogg to act on the matter, to which he noted that he had opposed the SUP when it had come before the board at a previous session.

As Lewis left the podium, she turned to the board and noted that what taxpayers want appears not to count.

Kerry Allison asked the board to forgo a \$140 building fee a community sign to be erected. In particular, Allison was referring to a request by some residents of Jamesville to renew a welcome sign in there. The board discussed the matter of fees, especially for non-profit groups, and suggested that the county review the fee structure for a variety of items it controls. While no decision was reached on the fee structure, it was generally agreed that just repainting the sign did not require a building permit. A public hearing will be scheduled in the future to discuss fee structures.

A recommendation by Hogg to hire someone to provide additional zoning training to the members of the Planning Commission did not receive enough support for approval. The cost of bringing the individual to the county would have been \$850.

Retriever Tests Held Under 'Perfect' Rainy Conditions

On a day when almost any outdoor event — sporting or otherwise — would have been canceled, the North American Hunter Retrieving Association (NAHRA) held a field test at the farms of Charlie and Marlene Donnell, David Joynes, and Larry Housman and Victoria Peppler outside of Onancock one Saturday last month.

It was a day the rain began early in the morning and rarely let up, sometimes coming down in buckets. But when did you hear of a duck hunt being called off on account of the weather? The worse the weather, the better the hunt. Hunters pride themselves on standing up to horrible weather conditions. The dogs don't seem to mind either.

The field test had attracted twice the field it had last year in the inaugural event for the Eastern Shore. Many had traveled from all over the East Coast, as far north as Vermont. This year there were 120 entries, with 60 dogs



being tested under actual hunting conditions and showing the hours of work they had put in with their owners.

NAHRA's mission is the preservation of our heritage of hunting with retrievers. Members see the retriever as a conservation tool in the field.

Larry Housman is the president of Eastern Shore Retrievers Club, which hosted the test. Formed a little over a year ago, the club has 36 members who get together to work with their retrievers. They usually meet on his 70-acre farm that includes several ponds. The club has a Facebook page, and interested members can call 787-8520.

"The major difference in our field tests and other competitions is these dogs are in most cases pets in addition to being hunting dogs. Our members are the owners of the dog. At many field trials, it might be a dog trainer working the dog. My two dogs, Bry, 7, and Hank, 2, sleep in my bed, although not at the same time. They have to take turns," explains Housman.

Ryan Sayers from Old Town Retrievers in Eastville was one of the local entrants working his dogs. Sayers trains dogs for local hunters and has

been supportive of the local club. Charlie Donnell, a nearby neighbor, saw his dog Kate win her first ribbon ever.

Under the NAHRA concept, the objective is to recover the bird as quickly and efficiently as possible, to create the least amount of disturbance in the marsh and upland and to give the hunter the maximum amount of time to actually take game. Dogs are placed in five categories based on ability, not age: Beginner, Starter, Hunter, Intermediate and Senior. Dogs do not compete against one another for placements, but rather their performances are judged individually against a "standard."

Housman says the event was made

possible through the sponsorship of Weichert Realtors Mason-Davis and Accomac Title Company

In addition to Labradors, there were several golden retrievers and Chesapeake at the field trial. Dogs that were in hot pursuit of a fallen duck stopped 10 feet away from the prey on command by their owner. Blind retrieves were made through hand signals from the owner.

All of this was done through a heavy downpour. But the reward that evening was a roasted pig and sides served to the members and workers while drying out from the wet conditions that were just perfect for hunting.

Northampton Reaches State Soccer Final Before Bowing Out

Northampton matched its longest ever run in the state soccer playoffs one win short of a state title with a 6-1 loss to Riverheads Saturday in Radford, but the Jackets had much to be proud of after compiling a 19-3-1 record that included district and conference titles.

"I am extremely proud of this team," said Northampton coach John Gorman minutes after his five seniors accepted the state runner-up trophy. "We were up against a really good team and a special player today, but there were only two teams standing at the end, and we were one of them."

Northampton was no stranger to the state's final four in soccer. The Jackets lost a 4-3 title game to Manassas Park in 2012 and had reached the semi-finals five other times since Gorman arrived in 2005.

Riverheads capped a perfect 22-0 mark with Virginia Tech-bound James Kasak finishing the season with an incredible 75 goals this season, breaking his own single-season record of 57 set in 2015. The speedy Kasak recorded a hat trick in both the semi-final game, where Riverheads beat Honaker 8-1, and then again Saturday against Northampton.

Riverheads thoroughly dominated its competition this season. In one six-

game stretch this season, including the conference and regional playoffs, the Gladiators scored 55 goals to three for their opponents.

"They finished their opportunities," said Gorman. "That's what you have to do. Their defenders also do a great job of getting the ball to their forwards."

Northampton's lone goal came from Jesus Maldonado on an assist from Billy Martinez with 16:39 remaining after Riverheads took a 6-0 lead.

The halftime score was 2-0, with Kasak netting both goals for the Gladiators, the first one coming at the 21-minute mark after goalie Gabe Webb had made two saves.

Riverheads was credited with 10

shots on goal to only two for Northampton. Webb made four saves for the game.

One of Northampton's top defenders, Garrett Marsh, was injured in Friday's semi-final and unable to play in the championship game.

Jackets Win State Semi-Final

Northampton defeated two-time defending state champion Galax 3-1 Friday to advance to the state championship game.

Galax broke a scoreless time in the opening minute of the second half, but the Jackets answered with three goals, the first coming on a header from Artu-

ro Gildo off a direct kick from Mariano Gaytan at the 34-minute mark.

Jesus Maldonado then dribbled past a defender and scored from close range to give Northampton the lead with 21 minutes remaining.

The third goal came when José Palacios made a run up the middle and fed Maldonado at the 18-minute mark.

The Jacket defense limited Galax to five shots on goal. Goalie Gabe Webb made two tough first-half saves to keep Galax off the scoreboard.

Northampton will return many of its key players from this team, losing five seniors, including Gildo, Webb, Noah Leffel, Chris Montalvo and Angel Mateo-Sanchez.

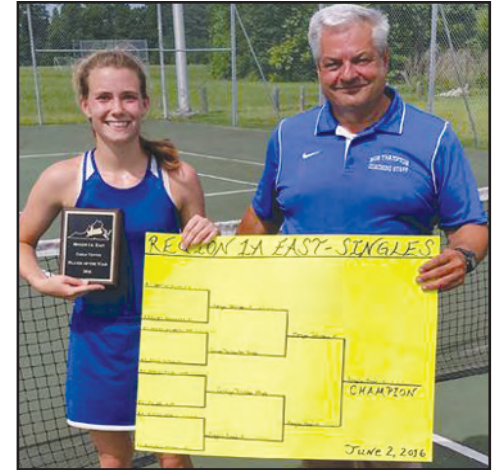

Flounder, Cobia, and Drum Provide Local Fishing Action

Ron Greaser of Don's Tackle Shop in Wachapreague says flounder fishing is still fairly good. He suggests drift or jig the 12- 25-foot ledges around channels. The old Coast Guard Station area, Millstone Creek and Green and Drawing Channels have been producing.

He reports that the inshore wrecks and reefs have produced a few sea bass and very few flounder so far.

On the bayside, cobia and black drum still have everyone's attention. Chumming, trolling and sight casting for cobia are all working.

Black drum seem the thickest around Buoy 13, Latimers Shoal and Middle Grounds. You also can find sheepshead there and around the bridge pilings of the Chesapeake Bay Bridge-Tunnel, says Greaser.

The upper ends of bayside creeks have gotten up to 80 degrees, push-

ing the rockfish out to the mouth of the creeks, where water temps drop. A few speckled trout have been taken, but luck with them has been very spotty.

Yep, I'm still waiting for that day when I step out into my yard and have to yell for someone to throw me a rope. Did I see that in a movie or a cartoon? I can't remember. Maybe, it was quicksand that Wile E. Coyote threw across the road to stop The Roadrunner. He did catch him once, you know. But what about all the times he failed? And all the ways he tried and tried. That had to be one of the most violent cartoons ever.

I guess comedy didn't come to the rescue after all. But doesn't it leave us with something to think about? Oh yeah, there was another thing I read on social media. We're coming up on high-school graduates who won't have lived through or have remembered when those planes hit the twin towers. Or the quiet, quiet skies that followed.

Accomack School System Needs Changes

Dear Editor:

It is my sincerest hope that you will publish this letter, without me having to disclose my identity, as it could have obvious harmful repercussions to my family. I am a resident of Accomack County, the spouse of an Accomack County Public Schools teacher, the parent of an ACPS student and an Accomack County taxpayer.

In the wake of recent articles regarding the surplus of funds held by the School Board, it is appalling to think that the School Board would consider utilizing those funds for self-serving purposes, namely the prospect of acquiring a building. It is extremely exasperating to know that the School Board apparently holds itself above the needs of its teachers and students.

Many would argue that the teaching profession is an easy 10-month journey and that summers more than offset the lack of adequate compensation and benefits. Stand in the shoes of any teachers committed to their profession and dedicated to providing their students the very best instructional experience, and you are likely to have worked at least 60 to 80 hours per week.

It is no wonder that Accomack County has a reten-

tion problem. Teachers are overworked, unsupported, underpaid, and often have to work second jobs to make ends met. It is disturbing that the new superintendent for ACPS advised this year's new teachers to work lucrative summer jobs on Chincoteague during their break to augment their meager salaries. Bonuses, although a nice gesture, are a taxable lump sum and do not help in the long run.

As well, it is disturbing that the superintendent believes it excessive to give every teacher \$200 for teaching supplies. The federal government permits a \$250 tax credit for teachers to offset personal money spent on teaching supplies. However, it is typical for a teacher to spend upwards of \$1,000 per year in personal money, even with generous donations of supplies from area churches and Walmart. Shouldn't the superintendent be at the forefront of a campaign to secure the compensation packages Accomack County's teachers deserve? After all, there is a surplus!

Accomack County's School Board has a health-insurance plan with Anthem that is far superior to the plan with United Healthcare for its teachers. Why does the School Board have a better plan than its employees? The only explanation offered is that teachers have significantly greater health-care needs and therefore drive the cost up.

Is it any wonder that the teachers of Accomack County have significant health-care needs? Teaching in Accomack is a challenge unlike any other professional challenge. The environment and social challenges Accomack teachers face daily from students

in poverty are exasperated by the lack of leadership and direction from the top down. There is no meaningful communication, collaboration, or teamwork. Simply shuffling administrators from one school to another in hopes of rectifying a perceived problem has not worked. Administrators who are not working to promote the needs of the teachers and their students should be released. Simply permitting inept administrators to remain within the system to preserve their Virginia Retirement System benefits is serving no one's interest but that of the inept person. Nepotism should not have a place on the Eastern Shore if we wish to be competitive with the rest of the state.

Driven by mandates to meet certain minimum pass rates for SOLs and retain accreditation, there are practices that selectively gamble on whether a student will achieve a passing mark on the SOLs. Based on this, determinations are made to devote time, attention and resources to students more likely to pass, while openly stating that time should not be wasted on those not likely to pass.

It is time the School Board treated the public schools as places of instruction instead of daycare centers for older children.

The time has arrived when the county Board of Supervisors and School Board should be divorced from one another. Never has there been a better time to entertain the notion of having an independently elected School Board that is held accountable to voters and taxpayers and not to the Board of Supervisors.
