Supervisors Focus on Dead Fish and Ag Districts

Northampton supervisors received a report on the recent menhaden spills Tuesday.

Silver Beach resident Bob Meyers provided a documentary of the two most recent spills that covered lower bayside beaches with millions of dead menhaden, leaving area residents and visitors alike disgusted by their image and smell.

Menhaden are small oily fish used for animal feed, fertilizer and a multitude of other bi-products. They serve as a primary food source for other fish and as filter feeders, help to clean the bay.

What they aren't is a fishery regulated by the Virginia Marine Resources Commission (VMRC). Instead, menhaden are regulated by the General Assembly. A number of companies gather the fish and process them, most notably for Virginia, Omega Protein, which has a processing facility on the Great Wicomico River at Reedville, directly across the bay

from the Eastern Shore.

On or around June 22 and again on July 1, dead menhaden began to wash ashore on the lower bay-side beaches and creeks. Reports began to circulate that the spill had occurred as a result of damaged nets. A cleanup crew was dispatched to the area to begin removing the dead fish.

Meyers noted that because of the way the fish are netted and compacted, they generally die during the netting process. He said the General Assembly needs to begin taking a serious look at tighter regulations of the menhaden industry in Virginia.

Board Chairman Spencer Murray stressed that he was not suggesting that the spill was intentional. He expressed concerns over the frequency of these events and how the industrial nature of the harvesting of menhaden is hurting the resources of the bay as well tourism for the county.

The board conducted two public hearing during

the evening regarding agricultural-forestal districts (AFDs) in the county.

The first, requested by Suzanne Tankard, called for the addition of 52 acres in the Wardtown area. She noted that the AFD designation makes it easier for agricultural operations to stay viable since the tax rate is lower.

Supervisor Larry LeMond noted the value of farming to the county, but stated that the lower tax rate means that those not receiving it have to pay more in taxes.

The board voted 3-2 (Supervisors Oliver Bennett and LeMond voting against) to support Tankard's request.

The second hearing was to renew the Jacobus Point AFD, which is located in the Machipongo and Church Neck area.

There were no speakers for or against the request



Death Determined Accidental Drowning

No foul play is suspected in the case of a Melfa man who was found dead Saturday, July 2, in standing water near Locustville, Sheriff Todd Godwin announced Monday, nearly nine days after the body was discovered.

Sixty-seven-year-old Webster Fitchett was found at the intersection of Locustville and Drummondtown roads. The report was made to authori-

inches of rain that fell in about three hours the previous day.

The cause of Fitchett's death was drowning, according to Donna Price of the Norfolk Medical Examiner's Office. The manner was accidental.

"Through the investigation into this incident, it is believed that on the evening of July 1, Mr. Fitchett's vehicle became disabled in flood waters, at which time he left walking to get assistance," Godwin said. Depu-

ties at nearly 9 a.m. and followed flash ties and rescue workers found the victim when they responded to the site.

Cuellar is from Texas.



Accomack Group Launches Campaign for Elected School Board

About 30 local residents met last week to kick off a campaign geared at changing the way members of the Accomack School Board are chosen. The group's preference is to have an elected panel rather than the current selection commission appointed by the circuit court judge.

The change to an elected School Board was made in Northampton several years ago after parents and other concerned citizens there circulated petitions to take the issue to a referendum. In that case, nearly 80 percent of voters favored electing members.

Accomack Supervisor Paul Muhly, was among a group that attempted to get the issue to a referendum in Accomack a couple of years ago "basically through the Republican Party."

"We started out on the wrong foot ... petitions were not worded correctly," he said. "They got that squared away" and then went in front of a grocery store to collect signatures, but were asked to leave.

Muhly said they went to another store front and had better luck, but "people signed who were not residents, were part-time residents or not registered voters (but) said or thought they were."

"There was no central area to turn in petitions," he continued.

Petitions are legal documents that must be notarized. "If not done correct-

ly, the registrar will throw it right in to be re-appointed. The only candithe trashcan," Muhly said.

Since then, some members of the election group went to Norfolk organizers, who told them about their experiences. Muhly said it took the Norfolk group four tries to get a referendum. "They keyed it to Election Day at the polls" because the people coming out from casting their ballots are registered voters, he added.

Signatures of 10 percent of Accomack's 23,000 voters are needed for the referendum. The group is aimed at getting 3,000 to ensure success.

Alan Silverman of Onancock was also an original group member. He said with 100 people split up at the polling places, "We stand a chance of doing it in one day."

The group agreed that they should get the signatures at the upcoming November General Election and then get the referendum on the ballot at the November 2017 election.

A woman in the crowd asked how she could get on the School Board now. She was told of the process of writing a letter to the selection commission and going before it at a public hearing to talk about herself. At that point, her supporters also could speak about her.

The commission will meet twice later this month to receive nominations and then select a District 7 representative. Janet Turner was a sitting member last month when she asked

to be re-appointed. The only candidate to seek the post, she was turned down without explanation. That move stirred more people to want an elected board.

A District 9 candidate, Peggy Drewer, was also turned down without any feedback. Her son, James, was at the election session to voice his dismay with the process. He complained about the School Board's "lack of transparency. Everything is swept under the rug ... who is going to be valedictorian ... what's going on in the playground ... lack of repairs ... poor communications ... nepotism."

Turner, who lives near Accomac, attended the election meeting and was informally chosen to be the group's representative. Connie Burford of Bloxom, an activist and parent, was picked as secretary and Stacy Gardner of Bloxom, a former school employee, was chosen treasurer. Muhly is a notary and will serve as such for the group. Two others said they will become notaries for the cause.

Also in attendance were Supervisors Grayson Chesser and Harris Phillips.

"If you have a big sign that says, 'Elected School Board,' they will come to you," said one woman who did not want her identity disclosed.

All the groups that previously participated are encouraged to come back and help. Those who attended last week's session were instructed to invite family, friends and acquaintances to join the quest.

Those who volunteer to work at the polls will go through training sessions, group leaders said.

Court Postings

Northampton Circuit Court

A 17-year-old Cape Charles boy being held in Eastern Shore Regional Jail (ESRJ) on charges of rape, sodomy, abduction, robbery, theft and related gun charges occurring last October was indicted this week for trying to escape from jail.

A Northampton grand jury indicted Frederick Wayne Baker of Plantation Drive Monday on counts of attempting to escape and damaging the property on Feb. 15.

"I just wanted to get out of here for a little while at least," Baker told Capt. Roger Kennedy of ESRJ. "I would have come back if they wanted me to." Baker said he took a three-hour shower to "soften up the wall" and then used a pencil and a piece of metal to scratch at the sheet rock.

"My plan was to get through there and get to another room and get to another room and then I'd make it an exit room," the boy told the officer. It was unclear from the record how much damage was done.

Kennedy gave information about the incident to the grand jury. Baker was initially held in Norfolk Detention Center. He will stand trial as an adult. The initial indictments against him involved incidents at Cape Charles Central Park.

The victim, who was riding her bicycle when she was allegedly stopped by the defendant on Oct. 2, is identified only by initials in the record.

She told Sgt. Chelsea Pfeiffer of Cape Charles Police Department that her attacker approached her and said he had a question for her. "She stopped and the male ... pointed a gun at her ... she stated that he then put his arm around her and squeezed her arm and forced her to walk to the bathroom located at the Southeast area of the park."

"Do everything I say or I will kill you," she said he told her.

The victim told police she was forced into the men's room and told to lie on the floor. Her clothes were removed "until she was completely naked" and at gunpoint she was sodomized and raped.

In another case, Khiry Akeim Six, 26, of Linhaven Circle in Pungoteague was indicted on counts of breaking into the El Ranchito convenience store in Cheriton and displaying a firearm while robbing 9-year-old Edith Palacio on Aug. 7, 2015. Co-defendant Jabias Keandre Kellam, 18, of Willis Wharf was indicted in connection with the case in May. Both are being held without bond. Six also was indicted on a count of possession of a firearm by a felon.

Information about the cases were presented to the grand jury by Investigator Tara Leckel of Northampton County Sheriff's Office (NCSO).

Matthew James Prosper, 28, of Riverside Drive Extension in Salisbury, Md., was indicted on two counts of making threats to kill his aunt and uncle on April 24, 2015. Court records state he wrote the threat in a text message to two cell phones and said he would damage their boat, house and cars. He was arrested April 28, 2016. Deputy Roger Pike of NCSO gave information to the jury.

Gregory Scott Foster, 24, of Bayside Road in Exmore was indicted on counts of attempting to break and enter a store while armed with a deadly weapon with intent to commit robbery and use of a firearm in the crime on April 13.

Deputy Danny Bell of NCSO investigated.

Sean Andrews, 43, of Seaview Road in Fairview was indicted on a count of possessing or transporting a firearm after being convicted of a violent felony. The alleged offense occurred Oct. 10, 2015. Deputy Justin Smith of NC-SO investigated.

Lenny Rock Kenner, 38, of Washington Avenue in Cape Charles was indicted on a count of possession or transportation of a firearm by a violent felon on Oct. 10, 2015.

Deputy Justin Smith of NCSO investigated.

Jason Carter Walker, 25, of Duncan Road in Petersburg, Va., was indicted on a count of possessing a firearm after being convicted of a violent felony on Sept. 12, 2015. Officer L.R. Christian of the Chesapeake Bay Bridge-Tunnel (CBBT) Police investigated.

About 100 marijuana plants valued at \$300,000 were confiscated during a raid at a Hallwood home last week, according to Accomack Sheriff Todd Godwin.

Donald Wyanne Rice, 59, of Marshall Street was charged with cultivating marijuana and possession with intent to distribute the drug, both felonies. He was arrested July 7. Unsecured bond for Rice was set at \$5,000.

Members of Eastern Shore Drug Task Force and the Virginia State Police Tactical Team served a search and seizure warrant at about 11:30 a.m. that day, the sheriff said. In addition to the plants, which were in various stages of growth, hydroponic tubs, lights, ventilation systems and electric converters were found.

The value was "based on a high-quality plant having the potential to yield a pound of high-quality marijuana valued at an average of \$3,500," said Godwin.

"Bloxom Volunteer Fire Department assisted at the scene by providing SCBA (Self-Contained Breathing Apparatus) equipment" to protect officers during the collection of evidence in relation "to air quality often found in indoor-grow operations," Godwin said. "Also assisting during the investigation were members of the GIANT

(Governor's Initiative Against Narcotic Trafficking) Task Force and the Accomack County Sheriff's Department."

Accomack Circuit Court

A county man pleaded guilty last week in Accomack Circuit Court to robbing a Painter convenience store in December 2015 and using a firearm in the crime.

Sentencing was deferred for Akeem Mason, 22, of Church Road in Accomac until a presentence report can be completed. He also was ordered to make restitution of \$39.

"I ran into the Fast Stop with a BB gun," Mason said to police. "I told the clerk to give me the money and I ran out."

In another case, Francisco Garcia Ruiz, 33, of McComas Drive in Greenbush pleaded guilty to two counts of having carnal knowledge of a girl between 13 and 15 years old. He admitted to having sex with the girl about 20 times between January and November 2015. A presentence report was ordered.

Fontae Fadle Ayres, 35, of Piggen Road in Melfa was sentenced to a total of nine years for three counts of welfare fraud involving \$2,206.48. The crimes occurred between June 1, 2013, and March 31, 2014. All but 40 days of the terms was suspended. Restitution was ordered.

Judgment was withheld for a year under First Offender Status for Steven Mark Pearce, 62, of Chincoteague. He is accused of possessing heroin on Jan. 2. A presentence report and 100 hours of community service were ordered. His driver's license also was suspended for six months.

Accomack District Court

A former member of Onley Volunteer Fire & Rescue (OFR) was looking for an "adrenal high" when he allegedly set fire to a truck last February, according to testimony in Accomack General District Court Monday.

After hearing evidence presented by Assistant Commonwealth's Attorney Spencer Morgan, Judge Gordon Vincent found probable cause to certify a count of arson to the county grand jury.

Brandon Travis Haynes, 20, of Ma-

ple Street in Onley was arrested in May and charged with arson of a 1993 Freightline tractor-trailer truck in February. The vehicle was valued in court records at \$10,000.

Haynes told police he was "bored at the station." State Police Special Agent Paul Neal said Haynes admitted to him that he had used a cigarette lighter to ignite the truck's seat.

The owner of the vehicle, Antonio Logan, who moves houses and other structures for a living, said he paid between \$15,000 and \$16,000 for the truck about 12 years ago. "I got a deal on it," Logan added. He said it would cost \$20,000 to replace it.

"The truck was in excellent condition," he said. It was located on the corner of Stonehouse and Locustville roads when the fire occurred. "The truck is beyond repair. It is just burned to a crisp," Logan said.

Haynes' lawyer argued that the charge should be dismissed because no malice was shown.

"They hadn't had a fire call for a while," the prosecutor said. Evidence "shows that he was bored or he wanted to see firemen rushing to the scene ...

destroying Logan's property; malice is ... present in this matter."

Vincent explained that malice is not used here in the ordinary person's meaning. "Doing something illegal intentionally, I think there is sufficient evidence," the judge said.

Community Services Board Acquires Iconic Building

The stately structure built by George McMath in the late '80s on Lankford Highway in Tasley will soon be filled with do-gooders.

Constructed for \$1.8 million and assessed at \$1.12 million more recently, the three-story brick structure on more than 7.5 acres was sold last month for \$400,000 to a corporation run by members of Eastern Shore Community Services Board (ESCSB).

The company, Mendisadd Inc., bought it from The Bank of Hampton Roads. Land transfer documents were filed in Accomack Circuit Court July 6.

Originally constructed to house Atlantic Publications which, at its height,

owned 32 newspapers from Delaware to South Carolina, the building was informally referred to locally as "The White House" because its Georgian-style redbrick exterior was originally whitewashed to evoke colonial days.

The building was most recently the headquarters of BaySys, which left more than five years ago.

These days, "the plan is to expand all of our services up the road," according to ESCSB Executive Director Mimi Sedjat. "We feel very lucky. The stars just aligned ... if you do good things, good things will come back to you ... provide services to the Eastern Shore that have been needed for years. I'm lucky to be a part of it."

"We are really looking at expanding services to everybody," Sedjat continued. "We want to be closer to the new hospital. A lot of the services we provide are emergency services. We wanted emergency services and crisis stabilization services closer to the new hospital."

ESCSB has 10 full-time clinicians compared to five when Sedjat came onboard two years ago.

"We're hoping that we will officially be in the building by January," she said. "I'm told I'm a little too optimistic."

The administrative offices will stay

in Nassawadox. Sedjat said she is being vague about exactly what will go on in the new structure because a license will have to be obtained. "I wish I could tell you. A licensing specialist came out and was very impressed with the building and said he would support it," she added.

In addition to general maintenance like painting, some landscaping work needs to be done. Sedjat said the building was closed up so there is also mold that must be removed. There is no plan yet for the grounds.



Exmore Works To Improve Police Relations

By Ron West

In an effort to help bring unity and a sense of community spirit, the Town of Exmore will celebrate a "First National Night Out for Northampton County" Aug. 2 from 6 to 9 p.m. at the Town Park.

Designed to strengthen community spirit by providing one night a year for neighbors to get to know each other and their law-enforcement officers better, the event heightens awareness of crime and drug prevention efforts while sending a message to the criminal element that citizens are ready to unite to keep their neighborhoods safe.

Exmore Police Chief Angelo DiMartino is asking Exmore residents to join other towns across the country in locking their doors, turning on their outside lights and spending the evening outside with neighbors and police.

"It's a big block party with an important purpose," said DiMartino. "We want the people of Exmore to get to know each other and the police officers who serve them. We also want everyone to have a good time."

The festival will include activities for children and adults, including McGruff the Crime Dog, an IDENT-A-KID fingerprinting program by Northampton Sheriff's Department, music by DJD Productions, and food trucks. For more details visit www.exmore.org

During the Town Council session, Utilities and Zoning Administrator Taylor Dukes reported that development of the new well system that will provide water for the town is on schedule.

Regarding the wastewater system, Dukes noted that representatives of the town have met with engineers to evaluate the current system. It was agreed that the town should look at the feasibility of replacing, rather than upgrading, the existing system.

Following a presentation on the state-of-the-art system, designed to support a mid-sized town such as Exmore, Town Manager Robert Duer and Dukes recommended that council strongly consider moving forward on the project. Dukes noted that if the current system is not replaced and

fails, a number of businesses would be forced to move to another town that could meet their needs.

Duer said a meeting is scheduled for July 21 at 6:30 p.m. with representatives from Rural Development and the state to lay out the costs of the project and the sewer rates that would need to be implemented should it be built. Dukes said the system would be capable of handling the needs of every property within town limits. The current system provides wastewater services for fewer than 400 properties in Exmore.

Council reviewed the possibility of imposing an excise tax on cigarettes sold in town. Duer reported that a number of communities in the state have imposed such a tax to increase revenue. He noted that one Hampton Roads city levies a \$1 fee on every pack of 20 cigarettes. The tax, as proposed for Exmore, would add 30 cents per pack or \$3 per carton of 10 packs. Eastville already has such a tax. Council agreed to move forward with the recommendation, which, if approved, could be imposed within six months. Council would need to conduct a public hearing on the tax.

Linda Spence suggested that rumble strips be installed on Lankford Highway near the traffic signals, as have been installed near T's Corner. She suggested that the strips would draw drivers' attention to the need to watch for increased traffic in the area.

DiMartino spoke of the recent shooting incident in town that had left three citizens injured and led to a fourth being fatally wounded in lower Northampton County. In a related area, Mayor Doug Greer Sr. noted the value of police officers to the town. Given recent events, Greer said council should give serious thought to providing the officers with more personal protective equipment (PPE). He asked DiMartino to provide a list of PPE gear that would provide his officers with additional protection should they be faced with a life-threatening situation. The chief indicated that he would follow through with the mayor's request.



NASA Wallops Balloon Flight Sets Duration Record

NASA's Balloon Program Office at Wallops Flight Facility successfully completed the second test flight of its Super Pressure Balloon (SPB) Saturday, July 2, setting a new flight duration record for a mid-latitude flight of a large scientific research balloon.

The mission launched May 16 from Wanaka, New Zealand, and ran a total of 46 days, 20 hours, and 19 minutes.

"We're extremely pleased with the flight time we achieved with this mission, far and away the longest mid-latitude flight of a NASA heavy-lift balloon to date," said Debbie Fairbrother, NASA's Balloon Program Office chief. "We'll continue to strive for even longer duration flight, 100 days or more, and what we learn from this year's mission will help take us there."

Having identified a safe landing area over the southern tip of Peru, balloon operators from NASA's Columbia Scientific Balloon Facility in Palestine, Texas, sent flight termination commands at 3:14 p.m. July 2. The rapidly deflating 18.8-million-cubic-foot bal-

loon then separated from the payload, which floated safely to the ground, touching down in a mountainous area. NASA coordinated with officials in Peru prior to ending the balloon mission to recover the payload and balloon.

The decision to conclude the mission came after NASA's balloon operators noted altitude variations during the last few weeks of the flight over the Pacific Ocean. The variance occurred at night and especially when flying over cold storms, with temperatures dropping as low as negative 80 degrees Celsius.

"Balloons are thermal vehicles, and some altitude variance isn't uncommon during periods of extreme cooling and heating," said Fairbrother.

Engineered to fly at 110,000 feet through the day/night cycle, at times the balloon dropped as low as 80,000 feet with the lowest drop nearing 70,000 feet when flying over a severe cold storm. However, at sunrise, the balloon always ascended back to 110,000 feet and repressurized.

"At its core, this was always a test

flight," said Fairbrother. "We're looking forward to the this next phase of analysis. We'll apply any lessons learned to future missions as we continue to eye our 100-day duration goal."

A number of "firsts" were marked by this year's SPB flight. It was the first time SPB carried a science payload, the Compton Spectrometer and Imager (COSI), during a mid-latitude flight.

Also, the balloon is the first to complete a mid-latitude circumnavigation, doing so in just 14 days, 13 hours, and 42 minutes.

And it was the first time in nearly 25 years the team operated balloons in the northern and southern hemispheres concurrently, with SPB flying in the southern hemisphere and balloon flight

operations in Palestine, Texas, known as the Balloon-borne Imaging Telescope (SuperBIT), launched June 30, which ran for just over 10 hours.

"This (SPB) mission marked the most rigorous test yet of a super pressure balloon and brings the NASA and the Orbital ATK Columbia Scientific Balloon Facility (CSBF) team even closer to setting a longer flight duration record in the future," said John Pullen, vice president and general manager, Technical Services Division of Orbital ATK's Space Systems Group. "All of these accomplishments point to future growth for NASA's scientific balloon program, which continues to offer reliable and affordable options for exploring the universe."



NASA has awarded a contract to Lagan Construction, LLC, of Woodbridge, Va., to conduct an airfield repair project at Wallops Flight Facility.

This is a firm-fixed price contract with a value of \$18,716,643.

"The Wallops airfield is a critical facility asset supporting not just NASA's Airborne Science Program and the Wallops Range, but also the Department of Defense, other governmental agencies and the commercial aerospace industry," said Bill Wrobel, Wallops Flight Facility director. "This contract continues an ongoing major repair effort for the airfield, demonstrating Wallops' future viability in support of NASA's and our partner's aviation and aeronautics operational and research needs."

The scope of the work is to provide services and materials to repair the Wallops Airfield, including demolition, site work, concrete construction, and asphalt milling and replacement.

and the board voted 4-1 (Bennett voting against) to approve the renewal of the AFD. Renewals for AFDs are good for 10 years.

Kiptopeke area resident Senora Lewis addressed the board regarding construction of a convenience store near Kiptopeke State Park. Lewis said the county needs to revoke the special-use permit issued over a decade ago since the store has not been constructed. She added that the property was zoned agricultural and as such should not be used for a commercial operation. Lewis said she wants to see an opinion on the matter by the office of the state attorney general.

The board briefly discussed a resolution regarding the issuance of a revenue bond by the Joint Industrial Development Authority for an assisted living facility in James City County. Murray and County Administrator Katie Nunez both said the bond would be a source of revenue for the county over the life of the bond. The board voted 5-0 to approve the resolution.

Murray briefly discussed the matter of the boundary adjustment for the Town of Eastville. The town has been seeking to expand its property line for several years but has met with resistance from various supervisors. The board agreed to schedule a public hearing on the town's request, after which the board will have the option to vote on the matter.



What's Going On? Sadly, We Have Been Here Before

"What happened to us in the sixties? ... How could so many bright, committed people have miscalculated so badly? We thought the center wasn't going to hold, but it has, and now we're in pieces. We're all loose change."

Twas 18 in 1969 and remember well the world was coming apart at the seams. There was a time we on the Shore felt somewhat insulated from all the violence we witnessed on the evening news.

But, alas, it is not so now. Our newspaper ran a story recently of shots being traded from vehicles riding down Route 13.

A week earlier there was a shooting spree that extended from Exmore to the lower Shore that claimed one life and injured three others.


We all want to turn on the TV and hear the news of "Peace on Earth." But it really hasn't been so since the beginning of time.



Girl, 9, Catches Record 94.6-Pound Cobia

Emma Zajdel, 9, of Ocean City, Md., set a new Maryland fishing record on June 30 with a 94.6-pound cobia caught about a mile and a half east of Assateague Island near Little Gull Shoals.

Emma and her father, Ed, were fishing with Robert Clark and Emma's best friend, Ashton Clark. They were trolling two lines, hoping to catch bluefish when one line went tight. Emma, who already had a fighting belt on, was handed the line.

Emma told a Maryland Department of Natural Resources official, "At first, we thought it was a shark, and the line was going out. I could hear the reel and the drag and I thought I could go over the side."

The battle lasted about 20 minutes. Ed said, "I kept the boat in gear and followed the fish at a 45-degree angle to keep the line tight and Emma settled. When she got the fish in, and we lifted it on board, it went ballistic. Emma and Ashton scurried to the front of the boat while Robert and I wrestled the fish into the fish box and iced it down."

They kept the fish iced overnight and

took it to the certified scale at Sunset Marina, where department fisheries biologist Steve Doctor inspected and confirmed the species and the catch. The fish measured 66.5 inches long. Emma, by the way, is 52 inches tall.

This breaks the previous 79-pound state record set by Jack Latimer in 2014.

The cobia fishery is currently closed in federal waters. This fish was caught in Maryland waters, where there are no restrictions on catching and keeping cobia.

Emma's catch could become a new International Game Fish Association Small Fry World Record for a fish caught by an angler under the age of 10. The current record is 48 pounds. Either way, the fish was put to good use. According to Emma, "It tasted very good."

Shore Fishing Report

In other locations, Chris of Chris' Bait and Tackle says the cobia bite has been good in the lower Chesapeake Bay. There also have been some spadefish and flounder around the fourth island, with flounder around the ships.

Matt Abell of Seahawk Sports Cen-

ter inPocomoke, Md., says the big story this week has been the awesome off-shore bite. Both chunking and trolling are producing a mix of yellows, blues, and mahi. The lumpy bottom has been the hot spot. Also, the railcars are producing decent flounder action, with other inshore shallow structures holding triggers and spades. On the Chesapeake, the action has been limited to occasional specks and cobia.

Ron Greaser of Don's Tackle Shop in Wachapreague says the best bet for flounder is on the reefs and inshore wrecks, with the flatties in good numbers and sizes. He says it has been slow inside, with croaker not showing yet.

Greaser adds that tuna are being caught on the 26-mile hill, 21-mile hill, and Sam's Hill and really packed on Lumpy Bottom.

Lindsey Paul at Trident Tackle in Wachapreague confirms Lumpy Botton is hot for the tuna. The best flounder bet inside is the Coast Guard Station, but overall, all action is slow inside, says Paul.
