## AFTER 11 YEARS, NUNEZ OUT IN NORTHAMPTON 'RESTRUCTURING'

Two top Northampton officials lost their jobs this week in what Chairman Spencer Murray of the county board of supervisors called a restructuring move to make government more "effective and efficient."

The supervisors voted Monday night to accept the resignation of County Administrator Katherine (Katie) H. Nunez and eliminate the position held by Economic and Community Development Director Kris Tucker. The action was unanimous and took effect immediately. Finance Director John Andrzejewski was appointed to serve as interim administrator.

"We feel like we need new management," Murray said Wednesday. The board will look nearby first for a new administrator. "I'm not a big fan of national searches. Those searches they can cost \$20,000 in fees plus expenses" like moving allowances.

"Any of the department heads can apply," he continued. "We're hoping for somebody local. They get started a

whole lot better if they're local if they have a feel for the culture here."

"We want a people-oriented manager," he said. "There's a limited number of really good people" who fit that criteria. The staff is "offering ideas" to work better for the public. "They're the closest to the process."

"I have assured certain ones that there jobs are secure," he continued. "We had to calm the waters somewhat. Even as early as this morning." Murray said he asked the workers to help figure out "better ways to process things ... restructuring doesn't always involve termination."

Nunez, who held the post for nearly 11 years, was given a severance equal to a year's pay and benefits. Her salary was more than \$121,000. Murray said her benefits were around 30 percent of her pay.

She was the only contracted employee on staff and the only worker who answered directly to the board. A contract that was amended in December 2009 made her fully vested, Mur-

ray disclosed.

Nunez did not return a reporter's telephone call that was made to her home Wednesday. Murray said he did not know what she would do for work in the future.

"She is going to land on her feet," he added. "We talked about it mostly all last week. We finalized what we were

going to say last Friday."

The administrator "reached a mutual agreement with the board," according to a prepared statement distributed after the vote. "Ms. Nunez has served ... through many changes and the board wishes to express its gratitude and extend her best wishes for

## Accomack County's Best Kept Secret 'GOES' Undetected

It's not covert, underground, hush-hush, top-secret, classified or invisible. But Operations Chief Al McMath says the U. S. Department of Commerce is busy on the Eastern Shore of Virginia, and not everyone is aware of what's happening.

Most folks who pass the entranceway to the left of Route 175 on the ride to Chincoteague think the road is just another way to get to a NASA facility. This despite a sign that clearly says otherwise.

"We're the best kept secret in Accomack," McMath said Tuesday. He's excited about the \$11.2 billion project NOAA (National Oceanic & Atmospheric Administration) is planning to blast-off in November. "We are prime for the world, the country and the atmosphere."

The GOES-R (Geostationary Operational Environmental Satellite-R Series) is a spacecraft to beat all others, the Onley man said. It will be launched by NASA on Nov. 5 from Cape Canaveral aboard an Atlas V 541 rocket. The des-

# Ballots Being Prepared in Both Counties for Nov. 8 Elections

Ballots are being prepared in both Accomack and Northampton counties for elections that will be held on Nov. 8.

Four candidates are expected to be on the ballot for president. Republican Donald Trump and Democrat Hillary Clinton are already the candidates that will vie for the top seat in the country. Jill Stein of the Green Party and Gary Johnson, a Libertarian, are still in the process of getting on the ballot. Their deadline was Thursday.

In Accomack, the hotly contested race for prosecutor should bring voters to the polls. Deputy Commonwealth's Attorney Matthew Brenner will take the spot left vacant by Gary Agar on Sept. 2. By law, he will hold that seat until Dec. 31. Brenner is running for a four-year term against Assistant Commonwealth's Attorney J. Spencer Morgan III and Carl H. Bundick, who often represents defendants in criminal cases.

Three towns will also have elections

in November.

In Bloxom, Mayor R. Scott Callander is running unopposed for re-election. There are five seeking six seats on the Bloxom Town Council. They include Thomas Wayne Beasley, Samuel H. Bloxom, Peter G. Bourbeau II, Christopher F. Kreisl and his wife, Jenny K. Kreisl.

In Melfa, Mayor Denise D. Bendick wants to retain her post. She is not opposed. Council contestants are Nancy L. Crockett, Brian B. Langley, Daniel F. Macca, David A. Peffer and James Robert Wilson. No one is running for the sixth seat.

In Painter, Mayor Connie Widgeon Campbell will run for re-election without opposition. Those seeking council seats are Barry C. Frey, Eric T. Harris, Stephen J. Hearne, Kim Randall Savage, James N. Sturgis and Thomas L. Willett.

In Nassawadox, Mayor Ed Gibb did not register to run for re-election. Two incumbents, Councilmen Claude F.

Jones and John W. Hallett Sr., want to be returned. Four newcomers are also running for council. They are Dr. Drury Stith, his wife, Patricia Stith, Terry Custis and Lisa McDonald.

In both counties, voters will help fill the 2nd District seat for the U.S. House of Representatives. Rep. Scott Rigell is not running for another term. Republican Scott W. Taylor and Democrat Shaun D. Brown will vie for the post. An Independent candidate, Dustin A. Willow filed his qualification but not petitions at press time.


Two state constitutional amendments will also be decided.

The first applies to surviving spouses of public safety workers killed in the line of duty. Under current law, General Assembly does not tax the real property (including anything owned jointly by a married couple) belonging to any veteran with a 100 service connected, permanent and total disability as determined by the U. S. Department of Veterans' Affairs, and the real es-

tate of a surviving spouse of an eligible veteran. The exemption is for the principal residency and ceases if the surviving spouse remarries. The proposal would give the same benefit to a surviving spouse of any law-enforcement officer, firefighter, search and rescue personnel or emergency medical services worker who is killed in the line of duty.

Since 1947, there has been a Right to Work Law in Virginia in which workers are not required to join a union that has an agreement with an employer. The second ballot proposal would put that provision into the Virginia constitution.

Deadline to register to vote is Oct. 17. Absentee voting will begin the last week in September. The last day to vote absentee by mail is Nov. 1. The last day to vote absentee in person is Nov. 5. Voter registration offices will be open in Accomack and Eastville on Saturday, Oct. 29 and Saturday, Nov. 5 for "in person" absentee voting.

# Search Suspended for Norfolk Man Who Vanished Sunday Near Smith Island

Rescuers searched about 360 square miles of seas near the northern end of the Chesapeake Bay Bridge-Tunnel this week to no avail.

They were looking for Maurice Alonzo Wright, Jr., 20, of Norfolk who was in the area between Smith Island and a boat he and his family and friends had anchored there. The search

began Sunday after Wright disappeared in water.

Wednesday afternoon, Laurie Nasmith of the Virginia Marine Resources Commission (VMRC) reported Wright was believed to have drowned. "At this point, we do not think it is going to be a rescue, it's going to be a recovery," she said.

"The man was wading from the beach to a pontoon boat approximately 20 feet offshore and fell underwater at about 2 p.m.," according to a Coast Guard report. "He was last seen wearing khaki shorts and no shirt. He was not wearing a life jacket."

The search continued into the night and started again the next

morning. The Coast Guard suspended its efforts Monday.

"The decision to suspend a search is never an easy one to make, and we extend our thoughts and prayers to the family and friends of the missing swimmer," said Capt. Richard Wester, commander, Sector Hampton Roads.

"The unique thing about VMRC is we are always on the water," she said. "We are always searching. We're on the water day in and day out. Our eyes are always on the look out."

Responding to the call were Coast Guard Station Cape Charles 45-foot Response Boat-Medium crew, Coast Guard Air Station Elizabeth City MH-60 Jayhawk helicopter crew, Coast Guard Cutter Cochito crew, Virginia Marine Police, Virginia Beach Fire Department, cities of Chesapeake and Norfolk, Virginia Department of Game and Inland Fisheries and Northampton County Sheriff's Department.

In October 2015, Richard Nee of Virginia Beach was lost in the same area and was never found. He was wearing a fiberglass cast on his leg and a black hoodie.

the future.”

When county offices were relocated and the new courthouse and social services buildings were constructed, Nunez was in charge. “All were brought in time and under budget,” said Murray. “Project management is one of her skills.”

Andrzejewski was not offered a pay increase. Murray said the board would consider a bonus. His salary figure was not available at press time Thursday. His predecessor, Finance Director Leslie Lewis, was paid \$96,307 in 2014.

The restructuring is more about pleasing the citizens. Murray said a “tremendous amount of input and complaining” was made about operations. “The feedback that we’re getting from the public is about timeliness” and the ineffective or incomplete responses to their needs.

“In the last five to six months ... citizens and businesses expressed frustration with their interactions with county administration departments,” Murray said. Three months ago the board started doing research.

Failings were about authority and “decisions being timely and made at the lowest possible level. Everything should not go to the board,” Murray said. “The staff should be taking care of things ... structure optimizes the work flow.”

The chairman said the process was not “streamlined and flexible.” There needed to be “standards in quality control” and “a radar screen of initiatives and projects” to be sure things are getting done. He also said that morale was down.

The last five years the board has spent hundreds of thousands of dollars on the economic position, only to find it was not a cost-effective expenditure of tax payer funds. Murray said neither Tucker nor his predecessor Charles McSwain had

a track record of new jobs.

“Companies wishing to locate in Northampton typically contact the county administrator and more often members of the board,” said Murray. “Legal and other departments are brought

into the process after the initial contact.”

Murray admitted that a board action caused some issues. “We need another person, a short term planner. It was cut last year. That caused some problems and was reauthorized” for better day-to-day management.”

“They need someone to go through those archives” for better record keeping, he continued. “We authorized a part time position for that.”

Non-refundable registration fees had already been paid so the board agreed to allow Tucker to attend two conferences.

“He will not be representing the county,” Murray said. “But he can network there. The more compassionate you are the better it is. He’s going to pay all travel, hotel and meals.”

Tucker did not get severance pay. He started in November 2015 with a salary of \$95,000. Six months later, he received a five percent increase. He left with \$99,000 annually, or a total package with benefits of \$127,000.

“One of the things we need to do better is we need to invest in management development of our staff,” Murray said. “We have money for training. Things like project management, people skills, complex problem solving. It just makes you a better employee. People need to respect and get along with each other. They need to work with each other for the citizens. These jobs are complex.”

“The board of supervisors is committed to as smooth a transition as possible and asks for the patience and understanding of the staff and public,” the prepared statement noted. “Other restructuring steps may be considered as the board moves to improve county processes and responsiveness to the many challenges ahead.”

“Input and complaining is not just a local thing,” said Murray. “People seem to be pretty upset about government everywhere. Government has got to do a better job.”

# CAPE CHARLES YACHT CENTER EXPANSION APPROVED BY TOWN COUNCIL

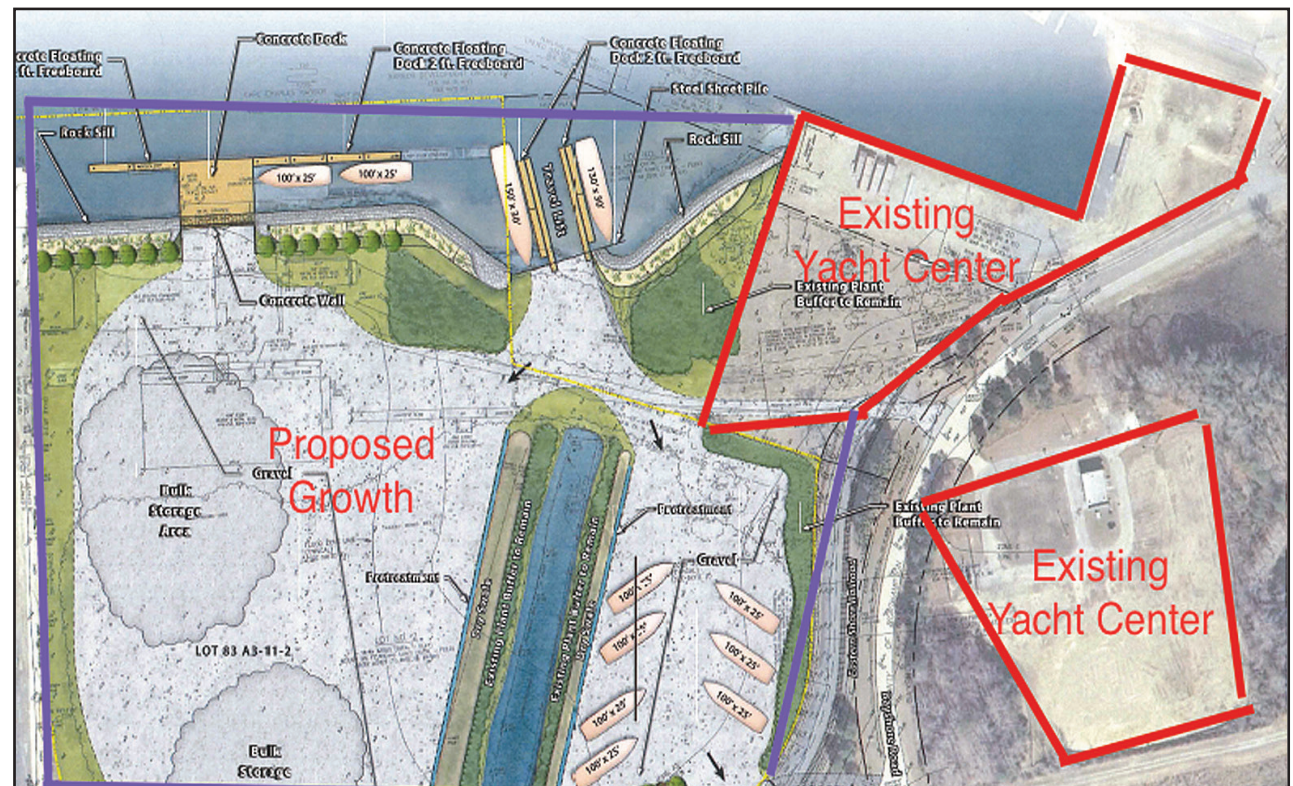

Cape Charles Yacht Center will nearly double in size under a plan approved by town council last week to expand operations on the south side of the town harbor.

Cherrystone LLC, which operates the yacht center, had applied for a zoning change and permission to develop space adjacent to its existing operations to expand the business. The center, which has been in operation for approximately three years, would provide additional onshore storage of larger vessels at the boatyard, and would add floating docks to accommodate several vessels, some as long as 130 feet. While the additional work does not include buildings higher than 50 feet, the council agreed that movable cranes higher than that height would be allowed.

Once the addition has been completed, it will extend the company's property westward to abut the Bay Shore Concrete property.

During the public input session of the evening, Bill Prickett urged the Council to designate funding to assist in funding concerts that are conducted at the Town Park. Currently the group, Friends of the Town Park, have raised funds to help offset the cost of the events.

Entrants may also pick up their cutouts and paint them at home. Judging will take place on Sept. 30th, and council members will serve as judges. 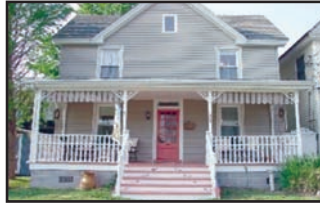

## Does Sorghum by Another Name Taste as Sweet?

What's that different-looking stuff growing in the fields on the Eastern Shore?

It's Sorghum! What? Sorghum! Excuse me?

Just call it Milo. That's another name used locally for the grain and not to be

confused with the chocolate malt drink.

The crop seems to be everywhere. Sorghum (pronounced sore-gum), is a cereal grain that grows tall like corn and is used for livestock, in

this case mostly to feed the big swine industry in Smithfield.

"It has different nutritional package to offer," said Lynn Gayle, president of the Accomack Farm Bureau. "We harvest it and get the seed with a combine just like you would soybeans or wheat or barley."

"I can tell you we're taking it to T-F Grain in Painter," Gayle added.

Bill Floyd of that grain company's Eastville office guessed there are about 4,000 acres of it locally. "There's definitely been a significant increase. It is

feed grain that is often a substitute for yellow corn that is grown on the Eastern Shore as well," he said.

In addition to being shipped to Smithfield, Floyd said the product also goes to international companies. "It's usually the lowest cost ration," he said. "There are some Asian markets that

like it because the dark red color transfers to the pork."

Floyd said 10 to 12 producers came to him and asked if he would buy it. "It's a good rotation. Some sort of grain or soybeans were in the fields before."

So why

is hay piled up to the sky across the Shore?

It's not hay. It is wheat straw used for growing mushrooms in the Chad's Ford area of Philadelphia, Pa. "The mushrooms, they are all grown under cover," said Gayle. The straw is cut when it is dry and compacted so it doesn't go bad. "They have pressure gauges on the bailers," said Gayle. "It's monitored. They have moisture monitors."

Floyd say the mushroom people are "buying it right in the fields and bailing it" there.

tinuation is a band in space known as Clark's Belt.

It is 23,000 miles above the equator and always appears at the same point in the sky to ground observers, he said, adding, "It's a really valuable real estate."

Hundreds of millions of dollars worth of equipment that looks like a mass array of stereos or DVD players are housed in a new addition at the Wallops facility waiting to take in information. The satellite is being built by Lockheed Martin, an aeronautics contractor. The ground system is being built by Harris Corporation, which according to its website has expert "abilities in tactical communications, air traffic management, environmental solutions" and more.

The satellite will undergo an extended checkout and validation phase expected to last until around June, McMath said. Another six months later, it will have gathered data that previously took 40 years to collect.

Three other GOES satellites are currently in orbit. "The old spacecraft will go away over time and we'll evolve to the new," he explained. By maintaining a position hovering over a fixed point on the Earth's surface, GOES will be able to constantly monitor atmospheric conditions in a particular portion of the Earth's atmosphere. Polar orbits will continue to gather information and are more research-like.

"Our job is to command the spacecraft and to receive the data," McMath continued. "We end up sending it to Suitland, Md." to NOAA headquarters. The images are the stuff weather services are known for. "You can see from the coast of Africa to Guam."

Three satellite tracking antennas were put up at Wallops and another three were erected in West Virginia for the project.

"We collect data via the Internet and send to Colorado where the prediction center is," McMath said. Some information can warn aircraft of a solar storm that could affect airplane communications.

McMath has been working for NOAA since 1977. He's seen spinning satellites that moved at 100 rev-

olutions per minute in space "to do a full earth picture from north to south pole," to this project that will establish a platform that will not only take a picture of the same space but will capture "individual pictures of locations at the same time."

"We want to do bigger or better things," said McMath. "Spinners were elementary." It will also be looking at the stars for navigational purposes.

McMath also explained where part of space junk comes from. The life of a satellite is normally about five years or when its fuel get to less than 10 percent. "Then they kick it up," and off the belt. "All of these things burn up before they could hit the atmosphere," he added.

The Wallops facility will get the raw data from GOES-R. "We take it and we insert the geographical lines ... and then we send it back to the spacecraft and it lands down in Suitland," said McMath. "They make products like clouds moving" for weather forecasts. "People like to see the fronts coming at them."

The equipment will also measure wind speed and temperature. "The Corps of Engineers is using our data right now for flooding and flow of rivers ... volcanoes, tsunamis ... fires in California, gulf stream ... about 800,000 messages per day," he continued.

About 65 employees work at NOAA on Wallops, or four crews for 24 hours a day, seven days a week, 365 days a year. There are 12-hour shifts, three days on and three days off. "All equipment is maintained and operated from here," McMath said. They also gather data for other countries. "Our job is to receive it and get information to who owns it."

NOAA announced that it was getting a \$250 million face lift at Wallops in 2011. At that time spending for the entire GOES-R project was budgeted at \$6 billion. Locally the project included a new power house, four new 1 megawatt generators, increase station power capacity, a 6,000-square-foot data center, site-wide duct banks and rehabilitation of the existing GOES operations area.

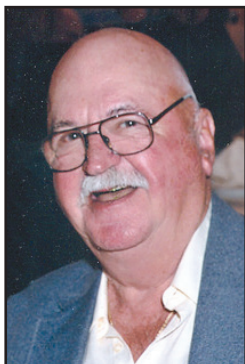

## What Parents Need To Know When Bad Weather Threatens Northampton Schools

When inclement weather causes road conditions to be hazardous, schools may open late, close early, or close for the entire day, depending upon the severity of the weather. In all situations, the primary concern is for the safety and welfare of the children.

When inclement weather is a possibility, selected transportation personnel monitor road and weather conditions in all areas of Northampton County. All available information is analyzed so a decision can be made. School delays will be communicated to TV and radio stations as well as Facebook and Twitter, generally by 6 a.m. unless changing weather conditions prevent a decision by that time. Parents and students should monitor radio and television stations whenever weather conditions threaten.

Northampton County Public Schools has contracted a message service to deliver the superintendent's prerecorded

message to all parents and staff, notifying of emergencies, late openings, early dismissals and school closings. Parents need to make sure their child's school has current working phone numbers.

Severe weather or other emergency conditions may necessitate closing school after the school day has begun. When the superintendent determines that school will be closed, radio and television stations will be notified and the division message system will begin calling parents. The notification will include the anticipated dismissal time.

Generally, all extracurricular activities (i.e., sports, activity practices, meetings, etc.) will be canceled when there is an emergency closing of schools.

Breakfast will not be served when school is delayed.

Parents should not bring students to school early when a delayed opening is in effect because school staff members also will be delayed.

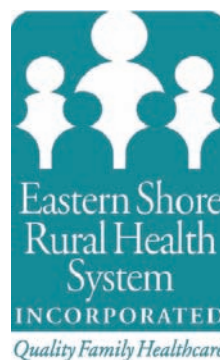

Career Connections is the area designed to help students prepare for careers and continuing education. It provides connecting links for students in pursuit of career development and related career information resources and includes:

- Career Investigation Phase I
- Career Interpretation Phase II
- Virginia Teachers for Tomorrow II (formerly Career Application Phase III).

The Family and Consumer Sciences program facilitates student progress toward a set of unifying goals in the areas of academic achievement, cultural and environmental issues, health and safety, individual and family relations, leadership and workplace ethics, and application of technology. The following courses are taught:

- Introduction to Culinary Arts
- Culinary Arts I
- Independent Living.

Marketing prepares students for careers in the marketing of goods and services. It includes buying transporting, and storing goods; promotion of goods and services; and marketing research and management. The following courses are taught:

- Fashion Marketing
- Marketing
- Principles of Business and Marketing
- Sports, Entertainment, & Recreation Marketing
- Introduction to Hospitality & Tourism.

In Automotive Technology, the first of a three-course program sequence, students learn all aspects of repair, safety, and customer service by concentrating on the four primary certified areas: brakes, steering and suspension, electrical/electronics, and engine performance. Students who successfully complete this program sequence will be prepared to take and pass the respective ASE/NATEF exam and will be prepared for postsecondary education opportunities. The following courses are taught:

- Small Engine Repair
- Automotive Technology I
- Automotive Technology II.

Building Trades prepares students to erect, install, maintain, and repair buildings and other structures, using materials such as metal, wood, stone, brick, glass, concrete and composition substances. Students focus on developing skills in core safety and the masonry, carpentry, electricity, and plumbing professions in the following courses:

- Carpentry I
- Carpentry II
- Carpentry III.

In the Welding program, students learn to use gases and electric arc processes to fabricate and weld metal parts according to diagrams, blueprints, and specifications. Students also will receive all safety-related practices and techniques, including the OSHA 10 card.

Tech Prep opportunities are also available for students who are entering the workforce and/or postsecondary education through dual enrollment with Eastern Shore Community College.

## Free/Reduced-Price Lunch Policy

Northampton Public Schools announces its policy for providing free or reduced-price meals for children served under the National School Lunch, and/or School Breakfast Programs. Each school and/or central school nutrition office has a copy of the policy, which may be reviewed by anyone.

Household size and income are used to determine eligibility for free or reduced-price meal benefits. Children from households whose income is at or below the Federal Income Eligibility Guidelines, shown in the chart below, may be eligible for either free or reduced-price meals. Children who are members of households receiving Supplemental Nutrition Assistance Program (SNAP) benefits or who receive Temporary Assistance for Needy Families (TANF) may be eligible for free meals. Children who are homeless, migrant, or runaway also may be eligible for free meals. Foster children, who are the legal responsibility of a welfare agency or court, are eligible for free meals, regardless of the income of the household where they reside. Children who are members of households participating in WIC also may be eligible for free or reduced-price meals based on the household's income.

Application forms distributed to all households include information on the availability of free or reduced-price meals for children. Applications are available at each school and at the central office. To apply for free or reduced-price meals, an application must be filled out for each household and returned to the school division. Applications may be submitted at any time during the school year.

For school officials to determine eligibility for free or reduced-price benefits in households receiving SNAP benefits or TANF, the child(ren)'s name and SNAP or TANF case number must be reported and an adult household member must sign the application. In households where a SNAP or TANF case number is not listed, including WIC households, applications must include the names of all household members, the amount and frequency of the income received by each household member, and the last four digits of the social security number of the adult household member who signs the application. If the household member does not have a social security number, the household member must indicate that a social security number is not available. The application must be signed by an adult household member in order to be approved.

Under the provisions of the free and reduced-price meal policy, Trish Bell, food service coordinator, will review applications and determine eligibility. Those dissatisfied with the ruling may wish to discuss the decision with the official on an informal basis. Those wishing to make a formal appeal for a hearing on the decision may make a request either verbally or in writing to Chris Truckner, director of operations.

If a household is not eligible now but has a change, such as a decrease in household income or an increase in household size, its residents become unemployed or qualify for SNAP or TANF, the household should contact the school for an application.

The rail cars and the CBBT are producing some really nice flounder. After a little mid-summer lull, the return of good to great floundering is very welcome. When we have been in the lower bay drumming, I’ve seen several Spanish mackerel jumping.”

## Fishing Action Changing With Season

As summer comes to a close, anglers are enjoying a few breaks from the stifling heat. And as we transition into fall, the weather patterns will encourage changes in the local fishing scene.

Cobia fishing has been good this season, and this week has been more of the same. But cobia hunters are also relishing an upswing in the number of larger fish, with several studs weighing in from 60 to 87 pounds. Fish are forming into pods and gliding along the surface in the lower bay and along the ocean front, as well as loitering around navigational buoys. Cobia season closes at the end of the month. Big schools of red drum are also providing very good opportunities for sight casters in these same areas.

Spanish mackerel action is still over the top, with plenty of big fish available. A few stray mahi are also

surprising trollers a few miles off the beach, especially when easterly winds prevail. King mackerel action has had a decent introduction this year, with a few kings pushing to around 40 pounds already boated off the Virginia coastline.

And for those anglers looking for something different, some big sharks are hitting in these same areas.

Flounder action is still good on some days and waning on others, but for those putting in the time, nice flatfish are responding from many areas in the lower bay. Most structures can produce fish for anglers working with live bait or jigs and Gulp baits. Most flatfishes are averaging to around 21 inches, with a few trophies also around. Decent flatfish also are available on most inshore and offshore wrecks for the next few months, along with trigger fish and nice black seabass.

# It's Peak Hurricane Season: Are You Prepared?

Hurricane season is June 1 through Nov. 30., and the frequency of hurricanes peaks in August and September. The Virginia Department of Emergency Management recommends taking the following measures.

## Before the Storm

During the threat of hurricane or tropical storm WATCH, monitor local radio or television stations for official emergency information and instructions. Make a plan to evacuate in case you are asked to do so.

### Interior Preparations:

- Verify that vital records such as birth certificates are in a safe storage area. If necessary, temporarily relocate records to a safe storage facility off-site.
- Inventory hurricane emergency supplies and restock if necessary.
- Clear all desk and table tops of small loose items.
- Secure first floor doorways with sandbags, duct tape or heavy plastic to protect from possible flooding.

- Disconnect all electrical appliances and equipment.
- Box or place any loose papers, books, hanging plants, etc., in desk drawers or storage cabinets.
- Close and lock all windows. Draw the blinds or drapes.
- Secure adequate cash to operate for several days.
- If you are advised to evacuate, lock the doors when you leave.

### Exterior Preparations:

- Secure your property. Install hurricane shutters over glass doors and windows or install protective material such as plywood (at least ½ inch thick). Make sure the plywood is flush against the wall and tight – gaps will allow wind to enter.
- Tie down or bring indoors any objects that might be blown around by hurricane winds (outdoor furniture, decorations, garbage cans, display racks, signs and any other loose objects that are normally left outside).
- Remove all outdoor signs, particularly those that swing or might

- cause damage during strong winds.
- Secure all items that cannot be brought inside.
- Remove antennas and loose objects from the roof.
- Keep trees and shrubs well trimmed.
- Ensure that all vehicles are serviced and fueled. Determine where they can be stored during the storm.

## During the Storm

During a hurricane or tropical storm WARNING (hurricane or tropical storm conditions are expected in 24 hours or less), listen to your battery-operated and/or hand crank radio or NOAA weather radio for instructions.

If you are not advised to evacuate, stay inside, away from windows, skylights and doors.

- Close all interior doors. Closed doors will help prevent damaging hurricane winds from entering rooms.
- Have a flashlight and extra batteries within reach. Flashlights provide the safest emergency lighting source.
- If power is lost, turn off major equipment to reduce the power surge when electricity is restored.
- Stay out of flood waters, if possible. The water might be contaminated or electrically charged. If you find yourself trapped in your vehicle in rising water, get out immediately and seek higher ground.
- Be alert for tornadoes and flooding. If you see a funnel cloud or if local authorities issue a tornado warning, take shelter underground, if possible, or in an interior room away from windows. If waters are rising quickly or local authorities issue a flood or flash flood warning, seek higher ground.

## After the Storm

After a hurricane or tropical storm, stay alert for extended rainfall and flooding, even after the hurricane or tropical storm has weakened.

- Stay away from floodwater. Drive only if absolutely necessary and avoid flooded roads and washed-out bridges.
- Do not return to your home until lo-

cal authorities say it is safe. After the hurricane and after flood waters recede, roads could be weakened and could collapse.

- Examine the exterior of the building and walls, floors, doors, staircases and windows to make sure that the building is not in danger of collapsing.
- Begin clean-up, document damages, and contact your insurance agent.
- Check for gas leaks. If you smell gas or hear a blowing or hissing noise, open a window and get everyone outside quickly. Turn off the gas, using the outside main valve if you can, and call the gas company. If you turn off the gas for any reason, it must be turned back on by a professional.
- If someone needs to be rescued, call professionals with the right equipment to help. Many people have been killed or injured trying to rescue others in flooded areas.
- Stay away from loose or downed power lines. Immediately report them to the power company, police or fire department.
- Use battery-powered lanterns or flashlights to examine buildings.
- Check for sewer and water pipe damage. If you suspect sewage lines are damaged, avoid using the toilets and call a plumber. If water pipes are damaged, contact the water company and avoid using water from the tap.
- Check refrigerated food for spoilage. If in doubt, throw it out. More information on food safety is available from the American Red Cross.
- Open doors and windows to ventilate and dry the building.
- Use the telephone only for emergency situations.

Dear Editor:

I recently moved to the Eastern Shore of Virginia for my job. I've noticed that there are a lot of complaints about the toll fees for the Chesapeake Bay Bridge-Tunnel (CBBT). Due to the overwhelming costs to travel to the Hampton Roads metropolitan area to the south, residents of the Eastern Shore take their spending power to Maryland cities such as Salisbury. Since a purchase in each state has its own sales tax, the funds received from consumer purchases isn't spread to border states based on the residency of the purchaser, it remains based off of which state had the purchase.

The Delmarva peninsula does not have many amenities found in metropolitan areas. It's often cheaper to go to Maryland and shop in Salisbury, Crisfield, Ocean City, Cambridge, Berlin, and Easton. With the peninsula county residents spending money elsewhere, it's more costs to the state of Virginia as a whole, while other states are accumulating revenue for roads and other state programs.

According to the CBBT website, the two-axle, four-wheel vehicle includes passenger cars, pickup truck, panel truck, station wagons, motorcycles, and minibus/vans with 15 or less seating capacity have an initial crossing of at least \$13 and depending on if they return across, it can range from three dollars to \$15 depending on if an E-ZPass is used. That's a total for the maximum amount of a possible \$1,360,860 for a roundtrip fare with all of the residents of the two counties at any given time.

Other states such as Rhode Island give discounts to Rhode Island residents for crossing the Newport Pell Bridge with the E-Zpass transponder registered. Although there would be a loss of revenue with Eastern Shore of Virginia residents crossing the bridge, it would generate more state sales tax with the increase of people shopping in Virginia.

One possible way to attract the county residents would be having special days that residents who show proof of Accomack or Northampton counties can either go across on a reduced rate or for free.

Another possibility would be for a resident to make a purchase of vouchers at a discount price when showing proof of residency. Another would have a similar discount table such as Rhode Island showing discounts for residents on the website.

In essence, there are price differences that have to be considered for differences between the Newport Pell Bridge and the Chesapeake Bay Bridge Tunnel. However this is still something to consider for a better discount rate than a general discount that blankets every E-Zpass regardless of the state. This not only allows prices to remain the same for E-Zpass in general, but it allows residents to have a higher discount from tourists.

If you can extend these possibilities at a board meeting or to someone who has influence on these matters, I believe there would be an increase in revenue not only with the state of Virginia but the Chesapeake Bay Bridge Tunnel as well.

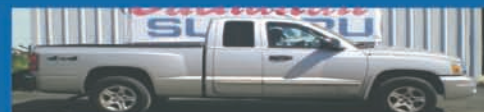

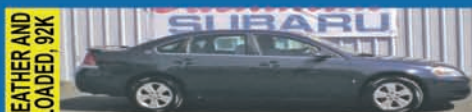
