MATTHEW LEAVES ITS MARK ON SHORE

Buckets of rain and winds in gusts of more than 40 mph wreaked havoc for about 18,000 acres of crops in Accomack County last weekend and continues to do damage as water stands in the fields this week.

“Major impacts to the more than 16,598 acres of soybeans will ... result from the excessive wind and rain,” wrote Extension Agent Theresa Long Pittman in a memo to emergency personal Tuesday. “A potential reduction in yield of 40-50 percent along with problems with the quality of the harvested bean” are anticipated. “Disease

pressure and rot from the amount of rain received over a short period of time and residual standing water will most likely occur,” she continued.

The storm deviated from the projected course causing more damage than expected, wrote Pittman. “Over an 18-hour period, we had between seven and 10 inches of rain throughout the county,” she continued. “We are waiting to see the complete impact of the storm.”

An assessment also listed 238 acres of fresh market snap beans and 927 acres of grain sorghum.

Registrars Detail Deadlines, Provide Polling Information

Voters on the Eastern Shore should prepare themselves for Election Day as several deadlines are approaching, some polling places have changed, several town elections will be held and constitutional amendments may need to be studied before the big day.

In Accomack, the board of supervisors made changes for polling places in two districts. In District 3, the polling place has moved from Arcadia High School in Oak Hall to New Church Fire & Rescue Company in New Church. The physical address there is 4264 Firehouse St., New Church. In District 7, Onancock and Onley polls have been combined and is being called Nandua Precinct. Voters can cast their ballots at Nandua Middle School at 20330 Warrior Dr. in Onley.

The rest of the polls are unchanged from the last general election and all polls will be open from 6 a.m. to 7 p.m. Tuesday, Nov. 8.

Registrar Patricia White said letters were mailed out to all registered voters

in District 3 and 7 from her office in Accomack notifying voters of the poll changes. Some letters have been returned to White “not deliverable” as addressed.

“If you live in District 3 or District 7 and have not received a letter about these polling location changes, please contact the registrar’s office” at 757-787-2935, White said. “The last day we will be able to make any changes to a voter’s record is Monday, Oct. 17,” she added. That is also the last day “before the November Election, the registrars in Virginia will be able to add any new voters.”

Four Shore towns, three in Accomack and one in Northampton, will be conducting elections.

Melfa Mayor Denise D. Bendick is seeking re-election. There are five running for six council seats. They are Nancy L. Crockett, Brian B. Langley, Daniel F. Macca, David A. Peffer and James Robert Wilson.

In Painter, Mayor Connie Widgeon Campbell is asking for another term. The six who want to fill the council

Most Eastern Shore Residents Like Their Water Right From The Tap

Water, water, everywhere and lots of drops to drink.

That's the story in Accomack and Northampton counties where 73 percent of the folks who participated in an email survey conducted recently by the Eastern Shore Post said they cook with and drink water from their kitchen faucets without hesitation.

"We have a deep well with good water," wrote Nancy Kupar-Page of Parksley.

"Yes, I cook and make beverages with water from my spigot," said Cora Bailey of Machipongo. "We have our own deep well. I don't like (the) drinking water in towns as you can taste the chemicals used for water treatment."

Alex Coleman of Wachapreague drinks his from the faucet "because it is a fresh-water well aquifer that has been drilled approximately 290 feet and the water tastes really good."

"We have good, deep, well-water with a softener in the basement and a built-in filter on (a) separate spigot for cold drinking water at the kitchen sink," said Vicki Parker of Onley.

Cherie Jester of the Atlantic area wrote, "We have a deep well and always had good-tasting water, although with some hardness. We installed a whole-house filtration system about 10 years ago to address the hardness and calcium buildup for longer life of our fixtures and faucets."

"I don't drink ... the tap water because I don't find it as refreshing as bottled water," said Denise Bowden of Chincoteague. "But, I do use tap water when cooking."

Libby Hume of Machipongo said she cooks "with water from my spigot and use it for coffee. We've had it tested and it's great. We have well water with a whole house filter and softener."

Jan Andrejco of Mink Farm Planta-

tion "cooks with unfiltered (and) drinks filtered. We are in new construction and the well water still smells. The health department report says the water is safe to drink."

Reade Bonniwell of Quinby wrote, "The water is excellent with minimal rust."

Anthony Lofaso of Onancock uses "a Brita pitcher for drinking. My wife will sometimes cook with filtered water. Cook with tap water because I figure the boiling will remove impurities."

"Yes," Patrick Belote of Onancock drinks his water. "I grew up in Onancock on a farm with a shallow well. I'm not too worried about deep wells."

Brenda Harrie of Parksley/Clam wrote, "I filter my drinking water but not for cooking since it's boiled."

Stephen J. Rulison of Occohannock Neck in Northampton said, "Taste is not bad, but it does sometimes contain sediment from the pressure tank."

Joanne Laskowski of Nelsonia likes

her well water. "It has been tested and approved for use."

Victoria Riggin-Bundick of Exmore is pleased. "Yes, no problem with my water."

But there is the 27 percent that are not so happy with their situation.

"I do not believe it is safe to consume," wrote Abra J. of Exmore.

Edean Bundick of Greenbackville doesn't cook or drink from the tap "because I live in Captain's Cove and the water taste like an over-chlorinated swimming pool! It is disgusting and we have to pay for that mess!"

Ellen Spence of Chincoteague Island said her tap water "smells and tastes bad."

Andrew Farkas of Atlantic said he "doesn't like the taste."

Richard McDowell of Pungoteague cooks with it but doesn't drink it. "Tastes yuck," he wrote.

Angie H. Crutchley of the Exmore area doesn't use it. "No, I don't. It's gross."

NORTHAMPTON SUPERVISORS BRIEFED ON JOINT INDUSTRIAL DEVELOPMENT AUTHORITY

An update on recent successes was presented to Northampton supervisors this week by Joint Industrial Development Authority (JIDA) Chairman Bill Parr.

Parr said supporting bond requests from other areas, such as Williamsburg, would bring interest from the bond in the coming years. Reaching out to other groups such as Accomack County and the Accomack-Northampton Planning District Commission will help strengthen Northampton's efforts to improve the county, he added.

JIDA is being proactive in bringing people in to help learn what to do when opportunities occur, thus making the area more receptive to businesses that might want to relocate here, Parr continued.

He praised JIDA member John Pavlik for his efforts in helping the school system develop a mentor program that would help students develop job skills. Parr noted JIDA provided financial support for Extension Service Agent Ursula Deitch's recent trip to China to promote

foreign trade for Eastern Shore agricultural products.

Vice-Chairman Larry LeMond discussed supporting efforts by other counties to gain General Assembly support regarding local authority to impose a cigarette tax. Several counties have gained this authority, which provides them with an added source of revenue. It only affects those who use tobacco products rather than the general population, Lemond said.

The board agreed to support York County's effort to eliminate the need to conduct a referendum regarding a food and beverage tax. The tax is set at 4 percent. By eliminating the need to conduct a referendum on the issue, the county could proceed faster.

The board also conducted public hearings. The first two were for special use permits submitted by Christopher and Patricia Blevins and Terrill and Rose Marie Ramsey of Kiptopeke. They want to construct a pole barn and to house up to three horses on site. At issue was the location and size of the two lots that would

be used. The 5-acre and the half-acre lots are zoned Agricultural-Rural Business. The applicants proposed to construct a horse barn on the smaller lot and use the larger one as pasture. Planning commissioners supported the applications at an earlier session but recommended the property line between the lots be abandoned. The applicants opposed this stipulation noting that if in the future they wanted to put a residence on the same lot as the barn, it would be prohibited. If the barn was constructed on the smaller lot, it become the primary structure. By code, accessory structures cannot be placed on a property without a primary structure. Following a brief discussion by the board, they agreed to both requests by insuring the permit for the barn runs with the land and the permit allowing the horses would run with the applicant.

The board also considered modifying the 2016 Zoning Ordinance approved earlier this year. While most consisted of changes that were not controversial, one proposal in Oyster created a concern for

an existing aquaculture business. The board proposed to rezone several parcels near Oyster Harbor as Working Waterfront. Doing so could adversely affect a currently allowed use of a structure on one parcel, according to the discussion.

Speaking in opposition to the proposed change, Parr noted the owner already has a permit to operate a small business on the site and would like the opportunity to use a portion of the existing structure as a residence for an employee managing daily operations. The business is open 24-7, 365 days of the year. The current uses would not be permitted in a Working Waterfront District.

The board agreed and noted the commission is seeking to make changes to permitted uses in such a district, which might eliminate the conflict.

During the citizens comment period, Janet Sturgis of Franktown reported a fight on a county school bus that resulted in some students being removed by police. Board Chairman Spencer Murray

"Evaluations are being made by C&E Farms as to the status of the fresh market snap bean crop," Pittman wrote. "Disease and scarring/quality issues are the major areas of concern for snap bean growers," she said.

"Approximately 45 percent of the 2,107 acres of grain sorghum planted in Accomack County is still unharvested in the fields," according to the report. "Sprouting/quality issues will be the number one concern of growers as harvests continue. We could see as much as 70-75 percent of the remain-

ing unharvested grain sorghum affected. As the fields dry out, evaluations will be made as to if the harvest can continue.

Any damage caused to aquaculture will require a more intense procedure as it is not something that I can observe but must rather contact multiple individuals to assess," Pittman stated. "I hope to gather this data within the next week or so."

The value of the crops was not included in the report.

Preliminary estimates of storm

damage and cleanup for state-maintained roads on the Eastern Shore totaled more than \$76,500 and further evaluations could make that figure go even higher, according to spokesperson Paul Miller of VDOT.

For the Hampton Roads region, the total is expected to "top the \$2 million dollar mark" for state roads and bridges. More than \$1 million is for Southampton County, which was the hardest hit.

Initial figures for the Shore showed \$19,100 worth of repairs and debris removal would be needed in Northampton County with \$57,439 in Accomack.

NORTHAMPTON SHERIFF'S OFFICE TAKING BACK UNWANTED PRESCRIPTION DRUGS OCTOBER 22, 2016, AT 5211 THE HORNES (NORTHAMPTON SHERIFF'S OFFICE)

On October 22, 2016, from 10 a.m. to 2 p.m., the Northampton Sheriff's Office and the Drug Enforcement Administration (DEA) will give the public its 12th opportunity in six years to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. Bring your pills for disposal to Northampton Sheriff's Office at 5211 The Hornes, Eastville, Virginia. (The DEA cannot accept liquids or needles or sharps, only pills or patches.) The service is free and anonymous, no questions asked.

Last September, Americans turned in 350 tons (over 702,000 pounds) of prescription drugs at more than 5,000 sites operated by the DEA and more than 3,800 of its state and local law-enforcement partners. When those results are combined with what was collected in its 10 previous Take Back events, DEA and its partners have taken in over 5.5 million pounds — more than 2,750 tons — of pills.

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines — flushing them down the toilet or throwing them in the trash — both pose potential safety and health hazards.

Court Postings

Accomack Circuit Court

A Maryland man pleaded guilty last week in Accomack Circuit Court to having sex with a young teenager.

Nicholas Rufus White, 21, of Salisbury, admitted to committing the crime against a 13- to 15-year-old. Two counts of carnal knowledge without force, which are felonies, were reduced to charges of sexual assault of a child, which are misdemeanors. He was given a 12-month suspended sentence for each count, to run consecutively, and two years of supervised probation. The incidents occurred between July 1 and Aug. 31, 2015.

Curtis Lee Ames Jr., 26, of Holly Ridge Drive in Melfa, was sentenced to three years in prison each for two counts of child endangerment. Two years, 10 months and 15 days of each term was suspended. The sentences were set to run concurrently.

The crimes occurred Feb. 28, 2015, along Wachapreague Road and in Pigen. A count of eluding police was not prosecuted. Cpl. E. J. Nottingham of the Accomack County Sheriff's Office wrote in the court file that Ames was going up to 90 miles an hour with two unsecured children in the car; one was four and the other was about a year old. The officer could smell alcohol and Ames admitted, "he had a few beers earlier ... he had bloodshot eyes and slurred speech." Ames was put on probation for three years.

Brandon Scott Parks, of Main Street in Melfa, pleaded guilty to two counts of selling buprenorphine, a medication used to treat opioid addiction, on Dec. 2 and 10, 2015. He was arrested in February 2016 and is scheduled for sentencing in February 2017.

Kendiah O'Jamine Divine Custis, 26, of Lankford Highway in Parksley, was sentenced to three years in prison with all but three days suspended for possession with the intent to distribute between a half-ounce and five pounds of marijuana on Jan. 29, 2015. He was put on probation for two years.

Kalvin Pairell Hodges, 20, of Seaside Road in Melfa, pleaded guilty to two counts of robbery (in connection

with incidents at Fast Stop in Painter, and Ocean Way in Tasley, and two counts of using a firearm in a felony. Judgment was withheld on the latter two charges until a presentence report could be completed. An evaluation for the youthful offender program was also discussed.

Raynell Devine Mason, 28, of Bay-side Road in Greenbush, pleaded guilty to distribution of cocaine. He was released on existing bond. A presentence report was ordered.

Accomack General District

An Accomack County Jail inmate was charged recently with malicious wounding after being seen on a facility video repeatedly beating another prisoner before knocking him unconscious, according to records filed in Accomack General District Court.

Samuel Keynia Dennis, 29, of Payne Road in Bloxom, was awaiting trial on drug offenses when he is alleged to have injured 62-year old Billy Austin. It is unclear why Austin was being held prisoner.

"I observed video from the cell block showing ... Dennis strike ... Austin with his closed fist to his face/head area several times," wrote Deputy D. T. Gladding. "Austin did attempt to defend himself ... Dennis continued to strike ... Austin, knocking him to the floor. Dennis continued to strike and kick ... Austin while (he was) on the floor. Austin got back to his feet when ... Dennis struck him several times again knocking him unconscious." Gladding said, "Austin received several stitches to his face and inside his mouth."

Dennis is being held without bond.

The court records noted the weight of evidence was "significant." The incident allegedly occurred Oct. 6.

In another case, Lawrence Walter Nalls III, 26, of Nancock Gardens Road in Onancock, was accused Monday of felony shoplifting and possession of a controlled drug. He was arrested the same day. Deputy Luke Arnold investigated.

A young Pungoteague man who was awaiting sentencing for crimes in an alcohol-related traffic crash was sentenced to seven days in jail for assault and battery in a more recent incident, a Brandon O'Neil West, 23, of Pungote-

ague Road, pleaded not guilty and was convicted of assaulting Nathan Char-nock Jr. on Aug. 5. He was given 97 days with all but seven suspended. He was ordered to be on good behavior for two years.

West pleaded no contest in Accomack Circuit Court to involuntary manslaughter and maiming in connection to a single-vehicle alcoholic-related traffic crash on Dec. 10, 2015. He also pleaded guilty to a general charge of DUI. No contest means the defendant admitted guilt because the evidence against him was overwhelming. He told police he was drinking and driving when he crashed. A breathalyzer showed he had an alcohol level of .087 percent. The legal limit is .08 percent.

West was driving a 2002 Mitsubishi Lancer just north of Perdue when he crashed. Devante Deshawn Harris, 23, of Parksley died in the accident. Another passenger, Ray Thomas Fitchett Jr., was severely injured.

The maximum sentence for the crimes is 16 years in prison and a fine of \$7,500. He is being held for sentencing in Accomack Jail.

Northampton General District

A New York woman was charged recently with possessing a drug illegally, according to records filed in Northampton General District Court.

A December preliminary hearing is scheduled for Cassandra Mosher, 35, of Glen Falls. She was arrested Sept. 17 and charged with possession of a Schedule I or II drug, which is a felony.

The complaint was filed by Officer Shelly Beasley of the Chesapeake Bay Bridge-Tunnel.

said the incident needed to be handled by the school board as the supervisors do not have the authority to intervene.

Charles Buckner of Kiptopeke was concerned about a Royal Farms convenience store that was approved for a parcel north of the entrance to Kiptopeke State Park. He urged the board to seek an opinion from the State's Attorney General's office regarding the legality of permits that allow construction of the business. Buckner said he is seeking a review by the Virginia Department of Transportation (VDOT) office in Suffolk regarding the highway entrance to the business. The board has emphasized on several occasions that the permits were approved and are viewed as legal by the county attorney, thus giving the business the right to move forward with construction.

Murray said the controversial contract between the board and former County Administrator Katie Nunez would soon end. The contract was initiated in order to complete financial issues including the county's fiscal audit, he said.

Rocket Could Launch Sunday Night if Hurricane Nicole Permits

The Antares Launch was rescheduled earlier this week for 8:03 p.m. Sunday at the Wallops Flight Facility. There will be a five-minute window.

The rocket was due to be rolled out to the Mid-Atlantic Regional Spaceport launch pad Wednesday and was scheduled to launch Friday before the latest postponement, which was made so that NASA could prepare for Hurricane Nicole, which was a Category 4 at press time, at its tracking site in Bermuda.

A rendezvous date of the S. S. Alan Poindexter Cygnus cargo logistics spacecraft with the International Space Station has not yet been determined, according to an announcement made Tuesday.

"The Antares and Cygnus team encountered and resolved a minor vehicle processing issue last weekend, together with time spend on contingency planning for Hurricane Matthew" necessitated an earlier one-day slip, officials said earlier in the week. The launch will air live on NASA Television

and the agency's website beginning at 7 p.m.

The spacecraft's trajectory takes it from Wallops and past Bermuda on its flight into orbit. The Bermuda tracking station provides downrange tracking, telemetry and flight termination support. After the storm system has passed Bermuda, the Wallops team will conduct a damage assessment, perform mission readiness testing, and bring the site back up to operational status, according to an announcement.

"The tracking station at Bermuda is required to conduct the Antares launch from Wallops," said Steven Kremer, chief of the Wallops Range and Mission Management Office. "The ability to support a launch will depend on the impact the storm has on not only our systems, but also the overall Bermuda infrastructure."

The last Antares Launch was two years ago when a mishap occurred and the rocket was exploded. Since then engine changes have occurred.

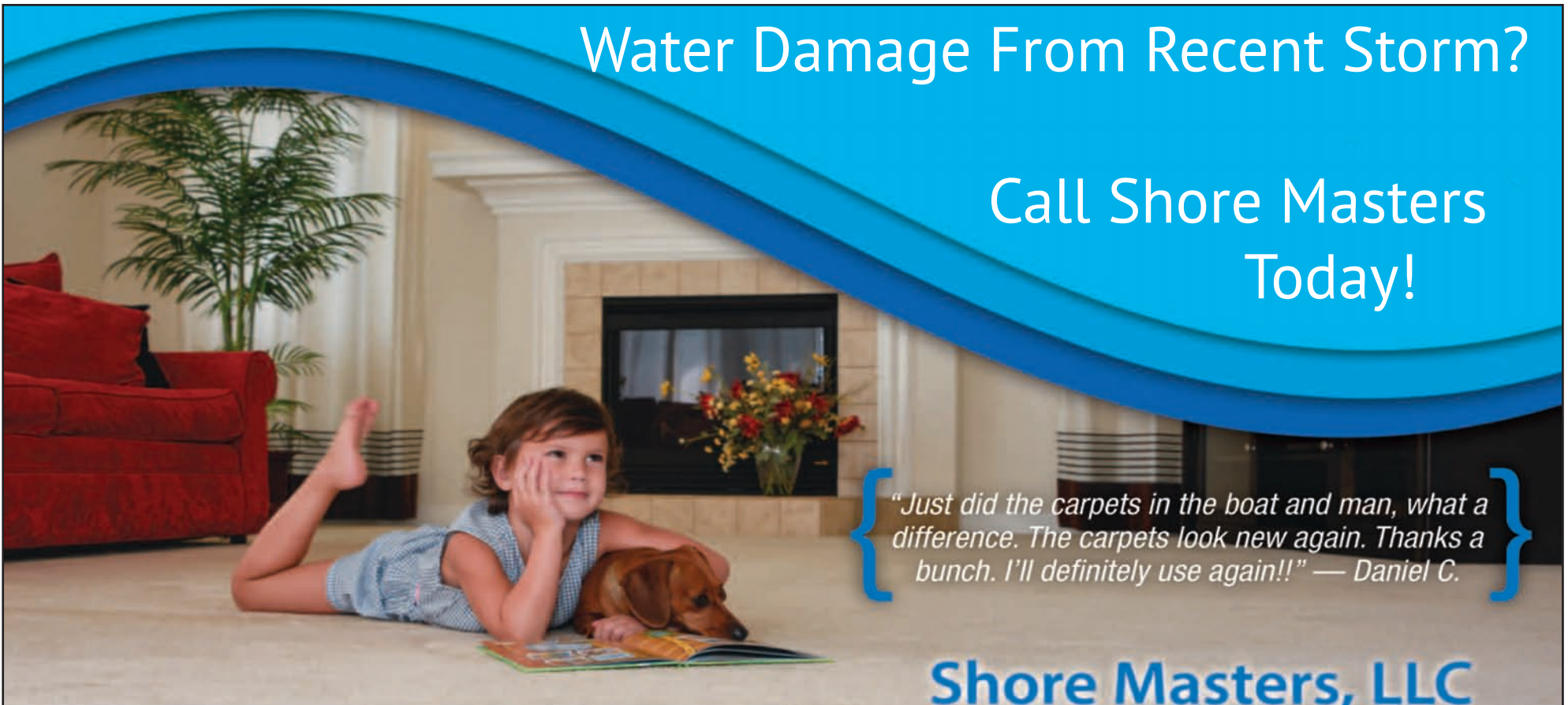

as Independents.

Democrat Shaun D. Brown and Republican Scott W. Taylor are vying for the 2nd District seat in the House of Representatives. Rep. Scott Rigell is not running for another term.

Two state constitutional amendments will also be decided.

Currently the General Assembly does not tax the real property (including anything owned jointly by a married couple) belonging to any veteran with a 100 percent service-connected, permanent and total disability as determined by the U.S. Department of Veterans' Affairs, nor the real estate of a surviving spouse of an eligible veteran. The exemption is for the principal residence and ceases if the surviving spouse remarries. The proposal would give the same benefit to a surviving spouse of any law-enforcement officer, firefighter, search and rescue personnel or emergency medical services worker who is killed in the line of duty.

Since 1947, there has been a right-to-work law in Virginia in which work-

ers are not required to join a union that has an agreement with an employer. The proposal would put that provision into the Virginia constitution.

In Accomack, voters will choose between three lawyers for commonwealth's attorney. They are Commonwealth's Attorney Matthew Brenner (who recently filled the seat of retiring Gary Agar), Assistant Commonwealth's Attorney Spencer Morgan and defense lawyer Carl Bundick.

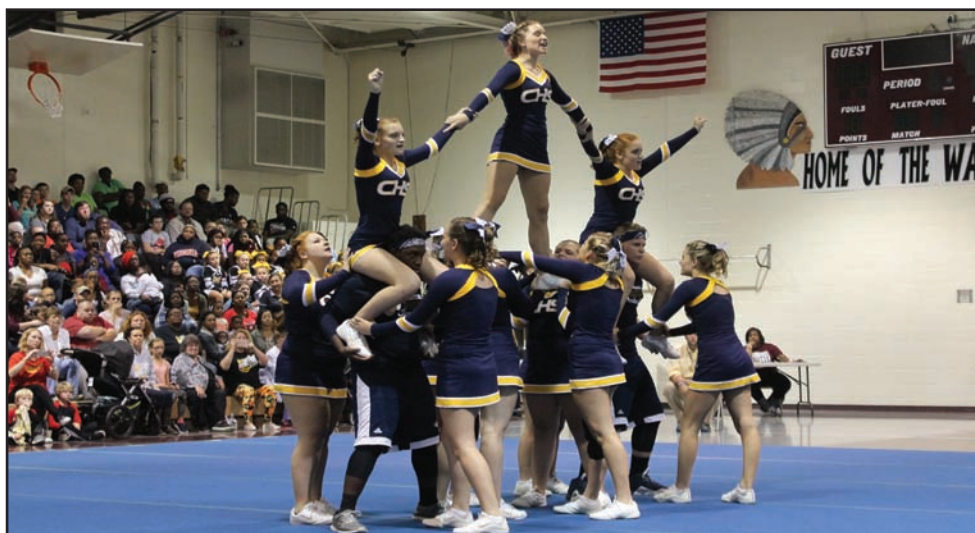
We've Got Spirit, Yes We Do

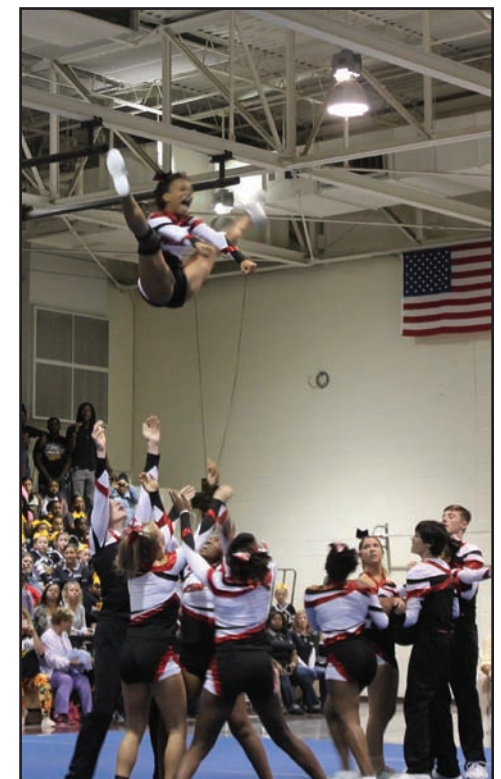

Hello everyone,

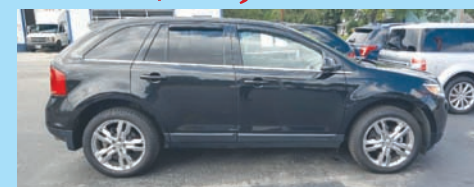

Students Milk Classroom Time for Dairy Lessons

Despite the fact that the Eastern Shore is a rural area, comparatively few individuals have had experience with obtaining their minimum daily allowance of milk and or milk by-products first-hand, or by hand.

Students from Kiptopeke Elementary School and Broadwater Academy were given an opportunity to see exactly where milk comes from, thanks to Southwest Dairy Museum, Inc., a non-profit education program funded by dairymen across the southeast and southwest. Northampton County Extension Agent Ursula Deitch and 4-H Coordinator Christina Ruszczyk-Murray hosted Tuesday's event to provide children with a better understanding of how food reaches their breakfast tables.

It was a good fit for the dairy museum, which seeks to educate the public, especially young people, about the dairy industry. The museum has mobile dairy demonstration teams that travel throughout the southern part of the nation offering up-close lessons on where and how milk and

other dairy products are produced from four-legged factories. The demonstration cows, whose only job in life is to eat, calve, and produce milk, seem to enjoy—or at least tolerate—the hundreds of bubbly kids and their endless questions.

Amanda Griffith fielded questions posed by Kiptopeke's students as Ginger, Griffith's able-bodied assistant, munched on hay. She seemed to have no modesty as she was hooked up to the milking machine and pumped a few gallons of milk into a container to the amazement of the audience.

Griffith spoke of the importance of the many products made from milk. She noted that Ginger produces about 12 gallons of milk a day and consumes about 60 pounds of food and 40 gallons of water daily.

Those who grew up on farms were expected to do daily chores, which included "shopping" for eggs (from the hen house), "obtaining" milk (from the cow), and during the winter, "pur-

chasing" pork products (directly from the four-legged source). Fast food generally referred to chasing a chicken that would later show up on the plate next to the mashed potatoes and gravy. Today, a short walk through the local grocery store can produce the same products without the inconvenience of having to deal with the care and feeding of the "live" product, leaving an un-

derstanding gap of who and what is involved in its production.

Those with an interest in taking a step back in time can attend the Northampton Agricultural County Fair on Oct. 15t from 10 a.m.- 2 p.m. at the former Northampton Middle School in Machipongo. The event offers everything from tractor driving competition to a skillet throwing event.

The Eastern Shore of Virginia Historical Society, in partnership with ES-LAND and Bay Creek, presents a reception, lecture, and book signing of "The Gentleman's Farm: Elegant Country House Living," Friday, Oct. 28, 6:30 p.m., at Mimosa Farm in Cheriton.

"The Gentleman's Farm" highlights the historic classical architecture of presidential homes, such as Mount Vernon and Monticello, and gentleman farmer homes, including the Eastern Shore of Virginia's Eyre Hall, a historic plantation home located in Northampton County owned by the Eyre family since 1668.

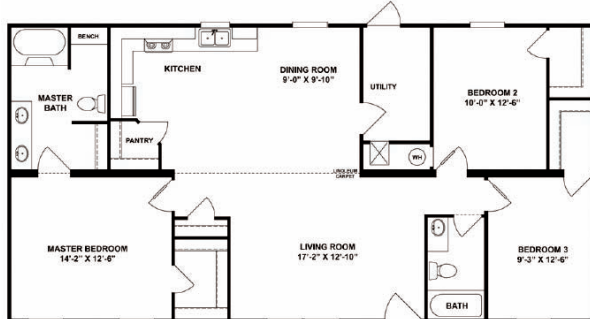

Orchestra's Time Travels Keeping Great Music Alive on the Shore

There are so many kinds of music, from chants, folk songs, dance, and nursery rhymes to gospel, rock and bluegrass to classical and jazz. Over time, what may have started as a kind of non-verbal vocalizing discovered the beauty of the human voice, created song and was extended by human ingenuity to a multiplicity of musical instruments with an unbelievable array of tones and timbres.

Not all music survives. Many kinds of music have blossomed and faded, leaving no trace. It takes active participation – by children playing hopscotch, church choirs, marching bands, jazz trios, symphony orchestras – to keep music alive. Before the advent of recording technology, another method of preserving music was made possible by an amazing innovation: a written system of musical notation.

This “killer app” greatly facilitated the growth and evolution of what we now call classical music. Starting in the 16th cen-

tury, composers could use this notation to score a complex interplay of musical lines for a variety of performers playing different musical instruments. The composer could also indicate tempo, rhythm, loudness and feel. It enabled classical music to develop into the sophisticated forms we know today, such as sonatas, concertos, symphonies and operas. Just as important, written notation allowed musicians separated by thousands of miles and hundreds of years to reproduce the music as it was originally intended to be heard.

Almost anywhere you go in the world, groups of musicians gather together to bring this music to life. One such group is Symphonicity, Virginia Beach's community orchestra. Another is the Salisbury Symphony Orchestra, a thriving organization that draws players from the local and university communities and attracts large audiences. Perhaps most surprising is the existence of another long-lived community orchestra, south of Salisbury on Virginia's rural Eastern Shore.

The Orchestra of the Eastern Shore

was started in 2001 in the town of Onancock by local music teacher Peter Dundon as a way to give his string students the experience of playing in an orchestra. From there, it began to attract more experienced amateur musicians with a repertoire that included such classical stalwarts as Mozart, Bach, Vivaldi – even Beethoven.

In 2010, Lee Jordan-Anders, a concert pianist and professor of music at Virginia Wesleyan University, took over as music director. The orchestra began to give additional concerts and updated its repertoire with Hindemith, Bartok, Britten and several contemporary composers.

Dr. Paul Kim, a conductor, violinist, composer and assistant professor of music at Old Dominion University, became music director in 2015. The orchestra now includes some woodwinds and horns in addition to strings, and performs three sets of concerts per season at two different Shore venues, as well as two December sing-alongs of Messiah excerpts featuring local vocal soloists.

As the orchestra has grown in quality

and range, so has the size and enthusiasm of its audiences. The rehearsal and performance venues are both historic Eastern Shore churches with excellent acoustics. Concerts are free but attract generous donations, and a group of Friends of the Orchestra helps to cover annual expenses. As there are no university or school string programs on the Shore from which to draw rising talent, the orchestra relies on amateur musicians from its working population, retirees and the occasional student. It provides a warm welcome to potential orchestra members of all stripes, with string players always in demand. For the coming season, the orchestra will present concerts starting in November with “From Britain to France,” followed in March by “Classical Masters,” including the Haydn Cello concerto, and an “All Baroque” concert in May.

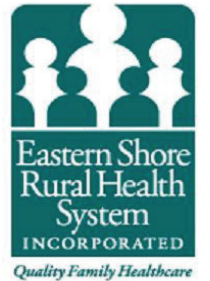

With “The Tony Sacco Experience,” 89-Year Old Musician Shares Love of Music with Cape Charles

Tony Sacco will turn 90 years old next year, but he doesn't let that stop him from sharing his love of music—with a red carpet flair.

On Friday, Oct. 21, from 6-8 p.m. at Lemon Tree Gallery and Studio in Cape Charles, the Shore legend will host what he calls the “Tony Sacco Experience” —a night of entertainment fit for royalty.

“This performance may be my last hurrah,” says Sacco, who plays the clarinet. He is dedicating the evening to his wife, Flora; they will celebrate their 68th wedding anniversary this month. Originally from Brooklyn, Sacco retired to the Shore 28 years ago, and has since devoted himself to alleviating poverty and helping children learn music.

“I bring my heart, I bring my soul, and music is...my language,” says the octogenarian, who has been known to purchase instruments and pay for music lessons for aspiring young musicians. “This is how I talk to people, whether it's jazz, whether it's classical, whether it's pop.”

Sacco's hand-selected show of a lifetime features Sherri DiMarino, who will be singing Disney and Broadway favorites. DiMarino's full-costume characters—including Ariel, Elsa, and Pocahontas—are sure to delight young audiences. Former school superintendent Dawn “Dr. Dawn” Goldstein will play a few songs on the ukulele, and Sacco will tell stories and play a broad range of tunes from surf music to blues, classical to Old Country.

Attendees are encouraged to dress up in their best royal regalia and pose for photos by photographer Leland Sharp. The free event features champagne for kings and queens and sparkling juice and tiara crafts for princes and princesses.

While Sacco and DiMarino have performed in countless community events and programs over the past few decades, Friday night will be Goldstein's debut. “I've only played for family before,” says Goldstein, who studies ukulele at ESO in Belle Haven. “I bought my ukulele because it was so pretty, and I heard it was easy. Now I've got two grandchildren, a daughter, and a daughter-in-law all playing ukulele.”

The love of music certainly is contagious. Sacco's hope is that the event at will ignite the passion in a few more souls.

“I want to bring my love here, my talent, my understanding,” says Sacco.

Book of Duck Hunting Tales Sure to Please Hunters and Non-Hunters Alike

In "Chesapeake Bay Duck Hunting Tales," C.L. Marshall intended to chronicle regional hunting adventures and misadventures. What he may not have foreseen was the near universal appeal of an individual locked in the passionate pursuit of pastime, how it shapes friendships and family life, and the bond between hunter and retriever.

Marshall acknowledges that although the idea was to write first and foremost for hunters, the book "isn't just about duck hunting. There's something in there for everybody."

A short attention span dictated the short-story format of the book, according to Marshall, whose experience reaches 40 years in the field. Each story was selected to bring a different perspective to the reader.

"I wanted each story to stand alone, to be a different experience from those before and after it," he said.

Many things have changed in his hunting career, such as clothing and gear, said Marshall, but so have his own attitudes about hunting over the years.

"It was an unintentional observation found in the editing process. Time has tamed the outlaw, age has changed perspective, but the desire is still there," he said.

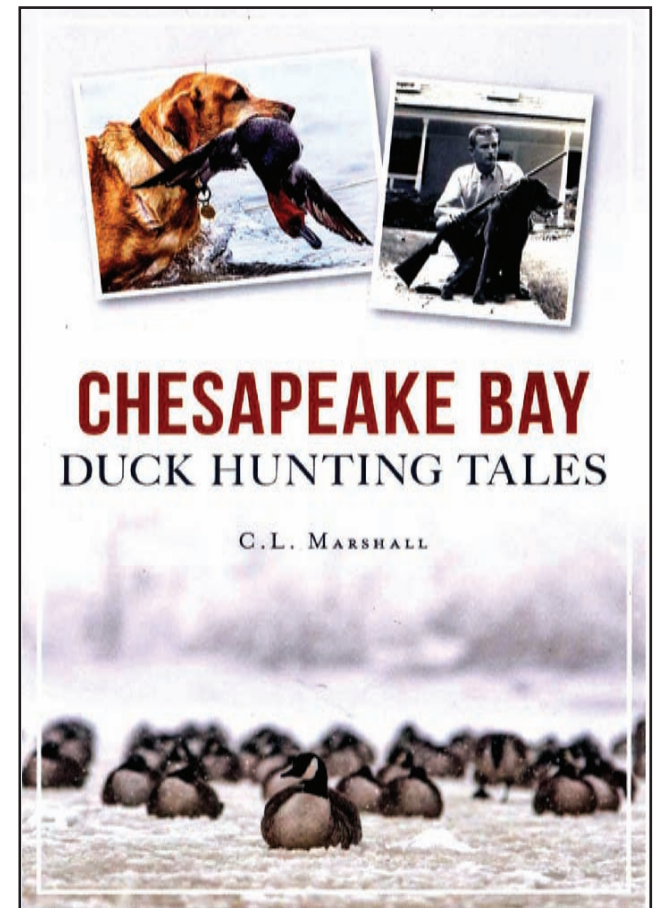
by Hallwood artist Joyce Northam help to bring the stories to life.

"Her drawings, especially the one of Jenkins Bridge, are spot-on," Marshall said of Northam's illustrations. "I've known her since I was 10 (years old) and am pleased to have her work included in this book."

Between the written word, photographs, and Northam's drawings, Marshall hopes to convey just what drives a hunter out into the punishing Chesapeake weather during duck season. Marshall falls back to a passage in "Beginnings and Endings," one of the stories in the book, to elaborate.

"Simply bearing witness to the wonders of nature that those who opt out will never experience, is reason enough to go," Marshall said. "The joy is in just being outside in the wild. These experiences will never fill the freezer, but sometimes that's all we get. Often it's enough."

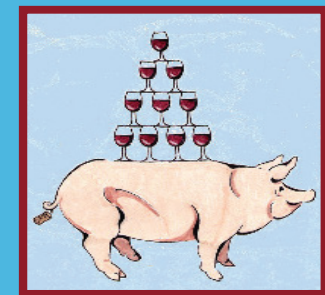

More than 200 walkers and volunteers came together to celebrate and honor the lives of those who struggle with mental illness and who were lost to suicide.

Suicide is the tenth leading cause of death in the United States. Because of this walk and the generous donations and sponsorships of our community members and local business owners, the American Foundation for Suicide Prevention raised almost \$10,000. All proceeds benefit the American Foundation for Suicide Prevention Virginia Chapter. The money helps communities, such as ours, promote walks, research and advocacy for depression and suicide.

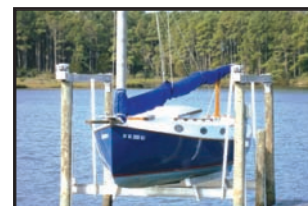
