Resident Pat Farley of Chincoteague complained to town officials this week about their failure to answer her questions regarding a closed meeting where a reorganization of workers was discussed and the plan was accepted. She said she made two requests through the Freedom of Information Act with no response. Farley contends that the mayor and council went beyond speaking about a particular personnel item and should have come out of the closed session or never met in private at all. The lack of transparency "raises more suspicions," she said.

In this case, Director of Planning Ron Marney of Chincoteague was laid off and his job was eliminated in what was explained in a prepared statement as a "reorganization."

The statement was made after three residents inquired about Marney's departure during a public participation session of the town council last month. They were told an announcement would be forthcoming and it was.

"The Town of Chincoteague recently selected to implement a reorganization within its general government division," according to Town Manager Jim West. "This organizational change shifts planning responsibilities to various members of staff and resulted in the loss of a position. The town is confident that citizens will not experience a loss in services or planning expertise with this reorganization. This reorganization was not related to any performance is-

sues or disciplinary actions," the statement noted.

Farley wants to know more. But likely there are no recordings of the closed session.

Some members of both Accomack and Northampton boards of supervisors are not only meeting in private, they are being paid to do so as part of the continuing saga of railroad business on the Eastern Shore.

There are three members from each board on the Accomack-Northampton Transportation District Commission (A-NTDC). They got there by being appointed by their respective board of supervisors and are paid \$35 a meeting for the job. Their main focuses appear to be the local railroad and Star-Transit. Reports of the latter are available for public reading.

Accomack supervisors Donald Hart, Reneta Major and Ron Wolff are on the commission. Northampton supervisors Oliver Bennett, Granville Hogg and Larry LeMond were also appointed. Steven Hennessee of the Virginia Department of Rail & Public Transportation in Richmond is also on the panel. Linda Balderon serves as an alternate. Bennett is the chairman, Hart is the vice-chairman and Major is the secretary/treasurer. Assistant to the Northampton County Administrator Janice Williams is the group's assistant

# Northampton Planning Commission Recommends Changes to Accessory Dwellings

Northampton's Planning Commission recommended Tuesday that county supervisors allow a dwelling being used as a residence while a new home is being constructed to later become an accessory dwelling unit.

In March, a Machipongo resident sought to have a single-wide mobile home where his family lives, designated as an accessory dwelling while their new home was being built. A sticking point for the supervisors was the wording of the zoning text that placed a roadblock in front of the request.

The zoning text was written based on the concept that a property owner would want to add an accessory dwelling unit on their property after their principal dwelling unit or home was in place. By ordinance definition, an accessory housing unit is limited to being no more than 50 percent of the size of the principal structure.

The size of the mobile home and the wording of the existing zoning text would have required the new home to be at least 4,000 square feet.

The commission also recommended approval of a special use permit for a dredging disposal site in Willis Wharf. The site has previously been used as a spoils site but

would need to have the berm surrounding it repaired to contain the spoils dredged from Willis Wharf harbor. The six-acre property is zoned Working Waterfront.

Stephen Marsh, of a Maryland engineering firm, said materials would likely contain silt. It would be piped from the hydraulic dredge to the spoils site. The last time the

site was used for dredged materials was around 2000.

The supervisors will hold a public hearing on the issue at their May 9 session.

The commissioners also worked on the transportation section of the Comprehensive Plan. Once the plan is completed, public hearings will be held.

# Picott-Cleveland Murder Trial Underway in Northampton County

The trial of a young man accused of attempting to maliciously wound his father and murder his cousin last summer was underway at press time Thursday in Northampton Circuit Court.

Twenty-three-year-old Alexander Hunter Picott-Cleveland asked Judge W. Revell Lewis III to decide his fate against charges of murder-

ing his first cousin, Ronald Graves, 30, of Portsmouth; and wounding his father, 58-year-old Alexander Cleveland; and two counts of using a firearm in a felony.

The incidents occurred on June 18, 2016, at 29192 Arlington Rd., in Cheapside, in front of the house where the father and son lived.

Picott-Cleveland was initially charged with attempting to kill his

father. He pleaded guilty in January to three charges of malicious wounding and related gun offenses. Mona Jones, of Treherneville, Ranquise Coston, of Exmore, and Andre Johnson, of Jamesville, were hit with gunfire at a graduation party in Exmore earlier that day.

In exchange for those guilty pleas, Commonwealth's Attorney Bruce Jones promised the wounding cases would not be considered as prior convictions or be mentioned trials for the rest of the charges.

Until Wednesday, the defendant was held in Virginia Beach City Jail due to the number of local victims and the possibility of crossing paths with a friend or relative who may also be at the Eastern Shore Regional Jail. The trial is expected to last through Friday (today).

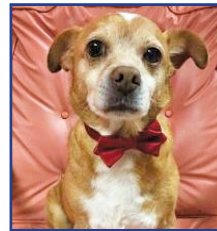

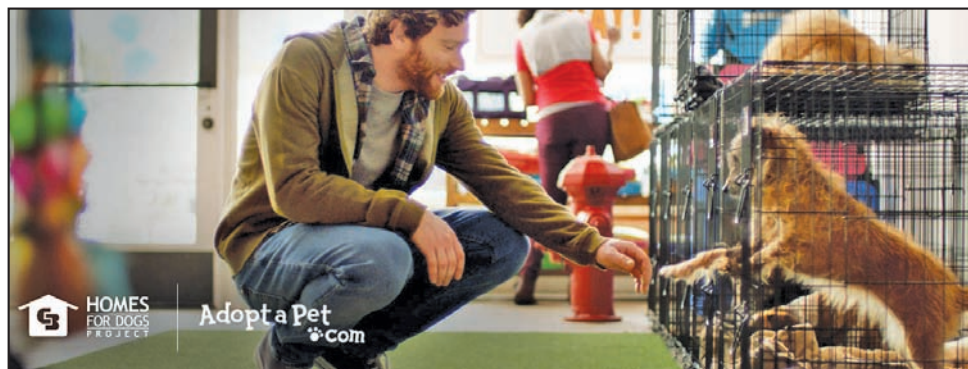
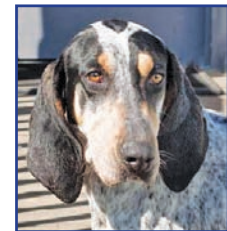

# Chincoteague Council Approves Water Bonds For Modern Meters

Safety concerns, a water bond, student participation in government, parking near the theater and a giant TV screen for pony penning viewing were among the topics discussed Monday night during a meeting of the Chincoteague's town council.

The panel approved general obliga-

tion water bonds not to exceed \$971,400 to cover the cost and installation of the most up-to-date water meters, which will avoid big problems by quickly detecting leaks. No one spoke at the public hearing.

Town drinking water is safe as lines from shallow wells on Wallops Island were cut off recently, officials reported.

## Accomack School Board to Lose Thornton

Accomack School Board Member Travis Thornton and Coach Gary Reese of Nandua High both are planning to retire from education this year.

Thornton, who has been on the school board for about 18 years told fellow members Tuesday night that he will retire effective June 30. He did not give any further explanations for the move. Thornton has served as both chairman and vice chairman since he took a seat on the panel July 1, 1999. His latest four-year term will not expire until June 30, 2019, so the School Board Selection Committee will have to appoint someone to fill his unex-

pired term.

The personnel list approved by the School Board this week included that of Reese, a health and physical education teacher. It states he will retire Sept. 1, 2017. That would be at the start of football season.

School Board Member Margaret Miles' term will expire at the end of June. It is not known if Miles will ask for another term.

In June of 2018, the terms of Vice Chairman Paul Bull and Member Camesha Handy will expire.

A referendum in November will ask voters if they want to elect school board members.

More test results regarding contaminants from firefighting foam used by NASA were being awaited. Previous results showed the water had accepted levels — parts per trillion. Mayor Arthur Leonard said if necessary the town could negotiate with NASA for water from deeper wells as a supply line is already in place.

Ed Malloy, a leader in the pickle ball league, alerted council to moisture problems at the town activity center. Four people have fallen due to wet floors, he said. "Just giving you a heads up" about the upcoming basketball tournament. "Conditions are ripe. You're going to have falls beyond belief," he said. Malloy suggested air conditioning be installed to solve the problem. "Thank you for the use of that gym," he said.

Chincoteague High students spent the day learning about local government with some playing the role of town leaders. Their suggestions included having student participation at sessions, widening the bike path on Maddox Boulevard, more cross walks, a left-turn lane at Maddox and Main in the tourist season, a four-way stop at Chicken City and Ridge roads

and handicapped parking at the library.

Councilman Gene Wayne Taylor liked the idea of student representation. The issue will be put on the next agenda along with the other suggestions.

Jon Richstein and David Landsberger of Chincoteague Island Arts Organization announced an open house for the annex facility at the theater on Friday, May 5. Concern was expressed about the elimination of parking adjacent to the facility on Mumford Street.

"We haven't asked the town for anything at all," said Landsberger. "We're asking the town for our parking spaces back."

Town Manager Jim West reported Chincoteague is considering getting a Jumbotron, also referred to as Jumbovision, or a large-screen television, typically used in stadiums and at concerts to show close up shots of the event. The idea is for visitors to get a better view during the pony swim.

Vice Mayor Denise Bowden reported a homeowner can apply to have historic status on his or her property but the state national registrar will require more rigorous restrictions that way than if the property were in a historic district.

# BUSINESSES HEAR FROM ELECTED OFFICIALS AT CHAMBERS' EGGS AND ISSUES

The state budget topped the list of issues discussed by State Sen. Lynwood Lewis last week at the annual Eastern Shore Chamber of Commerce Eggs and Issues gathering.

Medicaid, retention and pay for the state troopers, and pay raises for state employees drew attention in Richmond this year. Lewis noted pay for troopers was an issue because experienced ones were going where localities could afford them. Other state employees saw a 3 percent pay hike.

A bill Lewis supported to benefit 600 working watermen, a third of which are local residents, will allow localities to offer separate tax rates for working watermen. In addition, Lewis said interactions between waterfront homeowners and the aquaculture industry have occurred regarding who has the right to enjoy or to make use of water views.

He reported improvements and expansion for NASA/Wallops and related government operations in that area. Lewis said the largest problem looming on the horizon is healthcare.

The government funded the Broadband backbone for the Eastern Shore but localities and private companies need to develop the "last mile" to help customers in rural areas obtain access, Lewis said. Chairman Spencer Murray of the Northampton Board of Supervisors noted it is necessary to expand to the outer reaches of the county if economic development is to occur.

Del. Rob Bloxom talked about a successful bill offering a 25 percent state tax credit to repurpose old structures. The amount is in addition to the 20 percent federal credit. Bloxom also discussed a 10 percent increase in public school funding per student for divisions that have a decrease in enrollment. Northampton was among those.

Bloxom told of legislation providing \$17.3 million for construction at the Virginia Institute of Marine Science campus in Wachapreague.

Chairman Robert Crockett of the Accomack Board of Supervisors said the county is in good financial shape with a diversified economy including facilities at

Wallops, a new medical center in Onley, a thriving poultry industry and a wide range of commercial businesses.

Crockett said poultry processing facilities are the top two employers in Accomack and are number three and four at providing tax revenue. While the number

of poultry houses has increased, he said how many chickens can be processed will be determined by the plants. Once the number of birds raised by farmers reaches how many that can be processed locally, there will not be a need for additional poultry houses, he said.

## Northampton Schools Make Cuts

Northampton School District will have to cut its budget as county officials will not increase taxes to raise the \$253,000 requested beyond last year's plan.

At a school board session last week, Superintendent Eddie Lawrence noted a few things could be pared down, but the need for the additional classroom staff could not be eliminated without losing approximately \$400,000 in state aid.

The state provides funding based on a maximum class size for elementary classrooms.

The superintendent noted the importance of keeping salary and/or benefits incentives in the budget to retain teachers. Officials said Northampton Schools has one of the lowest salary scales in the mid-Atlantic region. Teachers with ties to

the Shore might be inclined to remain in the system. But others, with little or no prospect for a salary increase and take-home pay being eaten up by insurance increases, might abandon ship.

Lawrence and the school board agreed they need to seek a compromise with the board of supervisors that would hold the line on a tax increase while adjusting the budget in such a way as to prevent the loss of more teachers from the system.

In other business, Lawrence recognized Tyler Spady of Machipongo, a Northampton Middle School student, for having the top essay on the Eastern Shore in a contest sponsored by the American Legion.

## Cheriton Ponders Demolition

Cheriton's town council reviewed options last week regarding ridding the town of derelict buildings.

Mayor Joe Habel reported only one contractor responded to a request for bids to demolish an aging and deteriorating structure. The possibility of the town fire department doing a controlled burn is an issue due to the location and close proximity other structures. Habel suggested advertising again, including in Hampton Roads and in lower Maryland.

The panel is also seeking contractors willing to tackle drainage issues in two parts of town. The desire is to have drains carry water away so it doesn't flood and stand in town areas after heavy rains.

The panel and mayor discussed repaving portions of downtown sidewalks. Habel said businesses are responsible for the first four feet of sidewalk in front of their establishments. Using bricks for portions of the work instead of concrete

was discussed. No action was taken.

Habel reported portions of fencing were installed and power was provided where there was a need at the town park. A technician is sought to install the security system. Additional equipment for the playground includes a seesaw, a merry-go-round and spring toys. It was also suggested council request "Children at Play" signs from VDOT be placed near the park.

Habel also reported council will need to look at projected revenues and expenses for fiscal year 2018 due to recent changes in policy regarding using sheriff's deputies and vehicles to enforce town ordinances and traffic laws.

Council also voted unanimously for a resolution regarding the recent hazard mitigation plan.

The 2nd Annual Cheriton Fun Day is slated for June 10 at the park. Council members were asked to volunteer at the event. Baked goods will also be needed.

secretary/treasurer.

Once a supervisor is on the A-NTDC, he or she can then be appointed to the Canonie Atlantic Company's board of directors, which has meetings closed to the public on the premise that the company is a private one. There are a total of 10 members on the board. Hart said six are elected and four are from the general public but also appointed by the A-NTDC.

The members are paid \$50 a meeting. Hart, who is the executive vice president, said the commission meets quarterly but lately it has been a little more often due to a project that he would not speak about on the record. He did say that LeMond is president of Canonie and Major is secretary/treasurer.

The supervisors are required to file financial disclosure forms twice annually. According to Hart's documents, he gets paid in excess of \$5,000 for his position at Canonie. Hart said this isn't true. He explained Tuesday that he checked the box with that amount because he was trying to encompass all the paid boards he serves on for a total figure. "I didn't know where to put it," he said of those posts. "I guess I felt like

I should put it down" for getting \$50 and \$35 per meeting for those boards and money for serving on the Accomack-Northampton Planning District Commission and the Eastern Shore 9-1-1 Commission. "I just listed everything" in one figure, Hart said. None of the other supervisors listed meeting compensation on their forms.

There is a lease between Canonie Atlantic and Cassatt Management LLC, (a private for profit company owned by Dickie Foster of Virginia Beach who developed Bay Creek near Cape Charles) which does business as Bay Coast. Canonie is considered a private corporation but 100 percent of its stock is owned by the A-NTDC, a government entity.

Hart further said he understands the questions people have about the railroad workings. However, he added, the Canonie board must meet behind closed doors like any private company does so that it can do business without fear of competition finding out what it offers. "It was set up 15 or 20 years ago by the state so there would be no liabilities," Hart said.

Hogg's financial forms disclosed that he owns between \$5,001 and \$50,000

worth of stock in Norfolk Southern, a competitor of Cassett or Canonie.

Cassett does business as Bay Coast. Eight years ago, Accomack and Northampton supervisors gave about \$100,000 each to get Bay Coast's carfloat back in operation. That means the same people who vote for the spending are sitting in on a private meeting of a private company that is 100 percent owned by the public entity, A-NTDC.

Wolff, as recently as last month, pro-

vided meals for the Accomack supervisors during a meeting break. He was paid for the food from his restaurant in Atlantic. The monthly service started in January 2015 and includes an assortment of subs and chips for the nine members of the board of supervisors and a few workers who are required to attend board meetings. ## GREEK DINNER FOR SCHOLARSHIPS



## Convicted Killer Could Face New Charges

Kendrick Di'ke Duffy sat on a car window ledge and fired the gun that killed a college student in August 2009 as the vehicle's driver sped off from the Royal Farms at Fisher's Corner near Parksley.

This week, Duffy was back in Accomack General District Court for a second alleged criminal incident since serving prison time for the death of Bobby Oneal Ballard, 20, of Saxis Road in Temperanceville.

Judge Gordon Vincent found probable cause Monday to certify charges to a grand jury of disregarding a police officer's command (eluding) and possession of a firearm by a violent felon, both felonies, and a misdemeanor count of reckless driving with speeds exceeding 80 mph that occurred March 8, 2017.

Duffy, 26, of Parksley Road in Parksley, is being held without bond in Accomack Jail. In August 2014, when he was out of prison for about a year, he was accused of pointing/brandishing a firearm. The witness in that case did not show up to testify and the charge was dismissed.

At the preliminary hearing Monday on the more recent incidents, Deputy Eric Nottingham of the Accomack County Sheriff's Office (ACSO) testified Duffy was driving on Route 13 near Temperanceville at a high rate of speed. With his siren blaring and lights flashing, Nottingham said, he followed the vehicle, which turned on Hallwood Road. He said at that point Duffy was going 114 mph and eventually ran into the side of a house.

Nottingham said he saw Duffy, the only person in the vehicle, get out of the driver's side and run. The defendant reached Poulson's garage where he jumped in an occupied vehicle and was captured.

The deputy said Duffy told him he ran because he had been smoking "a blunt." Nottingham said a loaded gun was in Duffy's glove box. The defendant was not charged with possession of marijuana, although some was found, Nottingham said.

In 2010, Duffy was sentenced to 10 years in prison with four years and four months suspended for Ballard's death.

His plea came in the bargaining agreement with former Commonwealth's Attorney Gary Agar. A charge of using of a firearm in the crime was not prosecuted.

Evidence showed that men in a car with Ballard assaulted those in another car with Duffy and attempted to take the car keys to keep them from leaving the scene. Ballard was not involved in the altercation.

"Three seconds" after the car with Duffy drove away from the fight, the defendant fired and struck Ballard in the head with the bullet.

Back then, Agar said, he used the plea bargain because the shooting occurred so quickly after the assault. "Heat of passion" was involved. "Something has to be said about young people carrying guns." They should be going out and "enjoying life. Bobby Oneal Ballard was truly an innocent victim here."

"It is clear that the legal analysis is correct," Judge Glen A. Tyler said at the sentencing. "Self defense would have been difficult to prove since they were moving away ... malicious murder (was not applicable) because it was seconds later," Tyler said agreeing with Agar's description of a crime of passion.

A grand jury will meet next month in Accomack to consider the new charges.

## Man Admits to Sex Crime Involving Child

A Modest Town man pleaded guilty last week in Accomack Circuit Court to aggravated sexual battery of a child under the age of 13.

Marcos Perez-Morales, 21, of Hope Land Road, admitted to committing the offense between Sept 1 and June 30, 2016. A short-form presentence report was ordered. Perez-Morales was taken back to Accomack Jail to await sentencing. Sgt. Anthony Bright of the ACSO investigated.

Shannon Faye Wanstall, 29, of Walnut Hill Road in West Chester, Pa., pleaded guilty to assault and battery, a misdemeanor. She was initially charged with a felony, malicious maiming of Riley Bartoo on June 29, 2016. The altercation occurred at a Chincoteague bar. Wanstall was sentenced to 98 days in jail with all but eight days suspended. She was also ordered to be on good behavior for two years and pay restitution of \$320 to the Criminal In-

juries Compensation Fund.

Brittany Lynn Taylor, 21, of Winterville Road in Bloxom, pleaded guilty to a misdemeanor count of trespassing on July 19, 2016. The initial charge was burglary, which is a felony. She was sentenced to 60 days with 50 suspended. She was also ordered to pay restitution of \$250 to Allysin Mason on or before Nov. 1, 2017 and to be on good behavior for three years.

Ebony Rena Baines, 26, of Washington Street in Exmore, pleaded guilty to possessing cocaine, a felony, and a second offense of DWI within five years and driving on a revoked license, which are misdemeanors. The incidents occurred Aug. 18, 2016. A presentence report was ordered. Baines was allowed to remain free on existing bail.

Clearance William Sample, 28, of Drummondtown Road in Melfa, was sentenced to three years with all but six months suspended for a third offense of DUI in five years. He was also given suspended 30-day sentences for driving without a license and leaving the scene of an accident. He was put on good behavior for five years and probation for three years. Sample was also allowed to have work release while serving his time.

## Four Arrests Filed

Four arrests of local residents were recently filed in Accomack General District Court.

Chappell Teriz Faulcon, 30, of Bradley Court in Pocomoke City, Md., was charged with credit card larceny and stealing property worth less than \$200 belonging to Cynthia Vanvliet in connection with March 24, 2017, incidents. Secured bond was set at \$4,000. Deputy D. Gladding of the ACSO investigated.

Mildred Beatrice Mills, 57, of Runway Drive, in Melfa, was charged with embezzling more than \$200 belonging to Shore Stop, where she worked between March 7 and 9, 2017. Investigator C.A. McPherson of ACSO handled the case. Mills was arrested April 19. Unsecured bail was set at \$5,000.

Titanya Townsend, 42, of Occohanock Neck Road, in Exmore, is being held in Accomack Jail on charges, from Sussex County, Del., of reckless endangerment, disregarding police signal, possession of heroin, endangering welfare of a child, reckless driving, resisting arrest and possession of drug par-

aphernalia. She is being held without bond pending extradition with a hearing set for June 5. The incidents are allegedly to have occurred Aug. 26, 2015.

Damien Warner Howard of Chincoteague was arrested April 27 and charged with grand larceny that occurred April 23. Officer Tyler L. Greenly investigated. A June preliminary hearing was scheduled.

## Man Pleads Guilty to Wounding and Abduction

A man with addresses listed in Exmore and Delaware pleaded guilty Monday in Northampton Circuit Court to malicious wounding and abduction of a local woman.

Frederick Jerrard James, 41, most recently of Vanessa Drive in Dover, admitted to the incidents that occurred on Christmas Eve, 2015. James continues to be held in the Eastern Shore Regional Jail in Eastville.

The victim, Nehshawae Nicole James, 39, of Willis Wharf Road in Exmore, was severely injured and was caused to suffer permanent and significant physical impairment.

Records from Delaware show James has been convicted of conspiracy, burglary, robbery, delivery of illegal drugs, unlawful sexual contact and failure to register as a sex offender since 1992. A presentence report was ordered.

In another case, Jodecii Kiiwaan Purnell, 25, of Westover, Md., was sentenced to five years with all but two suspended for possession of a gun by a felon. Supervised probation was ordered for three years. The incident occurred in 2015.

Jamal D'Angelo Stratton, 22, of Jackie Drive in Cape Charles, was sentenced to four years with all but a year suspended for hit and run with more than \$1,000 worth of damage. Stratton was also fined \$100 for not having insurance when the Feb. 21, 2016, incident occurred.

and loving dog at his side.

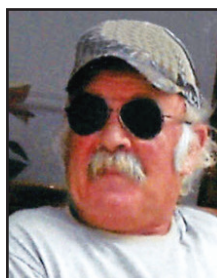

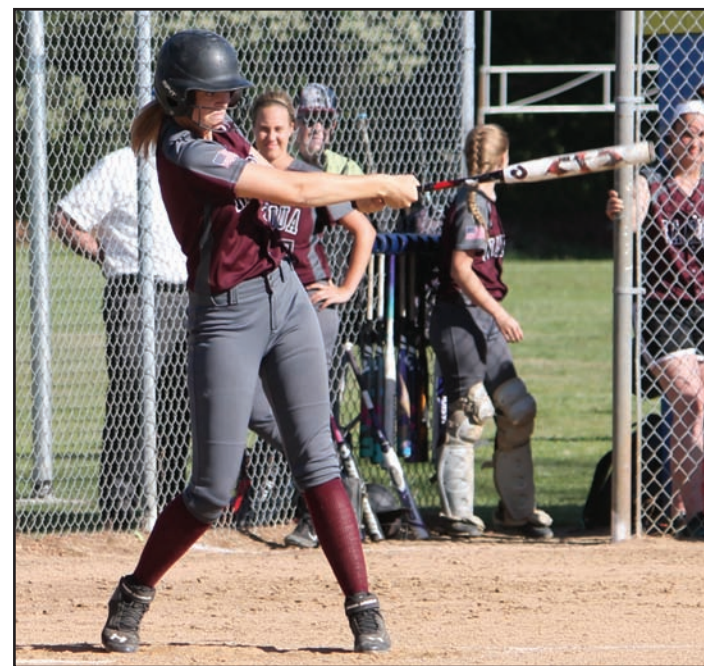

Johnson took the loss this time around for the Yellow Jackets, surrendering two hits, six runs and nine walks with seven strikeouts across just over five innings on the mound.

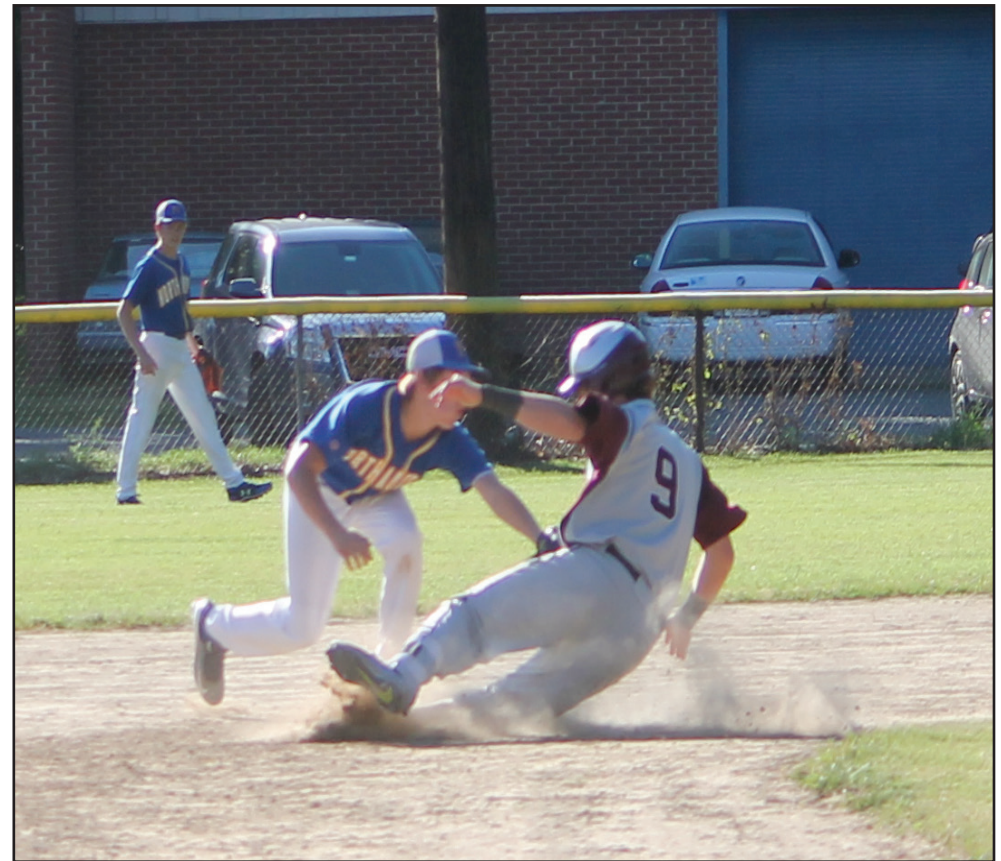
The Broadwater Vikings topped Alliance Christian Academy Monday afternoon, 22-5, in their last away contest.

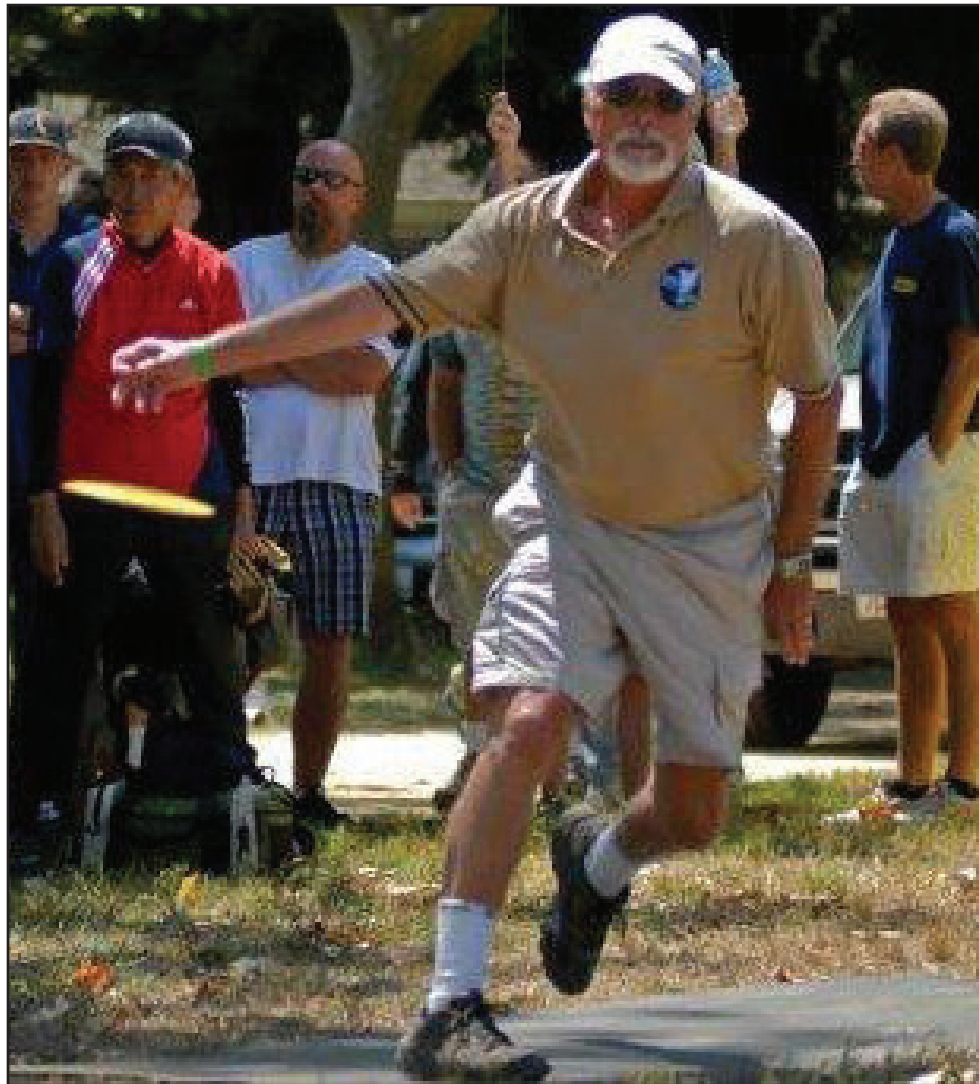

## Perdue Farms, Delmarva Shorebirds Launch '2017 Perdue Strike Out Hunger Challenge on Delmarva'

As part of a company commitment to fight hunger in local communities, Perdue Farms and the Delmarva Shorebirds announced the annual season-long "2017 Perdue Strike Out Hunger Challenge on Delmarva" in partnership with the region's three food banks.

To jumpstart the challenge, the Franklin P. and Arthur W. Perdue Foundation, the charitable arm of Perdue Farms, has issued a \$15,000 challenge grant to the Eastern Shore Branch of the Maryland Food Bank, the Food Bank of Delaware and the Eastern Shore Branch of the Foodbank of Southeastern Virginia.

### **How The 'Challenge' Works:**

Each food bank must raise the equivalent of 10,000 meals in order to claim its share of the \$10,000 challenge grant. Perdue has also committed to donating \$10 each time a Shorebirds' pitcher strikes out an opposing batter (up to \$5,000). The money will be split equally between the three food banks.

The Shorebirds plan a variety of promotions to generate interest in the Strike Out Hunger Challenge at their 70 home games.

The Shorebirds have designated the season's 11 Sunday home games as "Strike Out Hunger Sundays." If fans bring two non-perishable food items to the stadium they can receive an upper reserved ticket to that day's game for \$3. Food collected from the Sunday home games will be distributed equally among the three food banks.

In addition, food donation barrels will be located at Arthur W. Perdue Stadium, making it easy for fans to help by bringing food items to the game or just stopping by the stadium.

With spring rockfish trophy season officially underway as of May 1, local anglers are gearing up for what's to come.

Although the Shore has been hammered with wind and rain as of late, this did not hinder fishing numbers, as there have been flounder up to 24 inches reported in Wachapreague, according to Don's Tackle Shop. There have also been reports of flatfish catches up on the western part of the Bay. The best bites have been happening during the outbound tides.

It is also reported the bayside is yielding good numbers of red drum, and black drum are being pulled by sea clams over in the Quinby inlet.

Rudee and Lynnhaven inlets are giving good Speckled Trout and puppy drum bites.

As Cobia season approaches, keep

in mind that the regulations have changed to one fish per day per-person, three per vessel if three or more anglers are onboard and only one fish can be over 50 inches. Recreational permits are also required in the new Cobia regulations. Permits are also required for grouper, tilefish and trophy rockfish.

Offshore fishing is giving way mainly to tilefish as fishermen wait for seabass season to open mid-May and for Yellowfin to move in.

Tautog numbers were great off of bay structures up until the season close May 1.

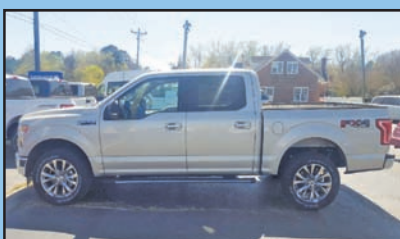

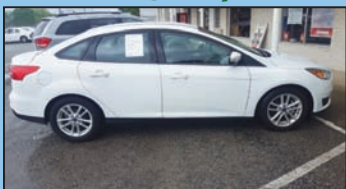

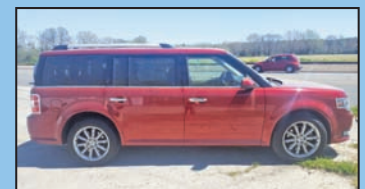

## The “Accidental Artist” is Impressive

Her passion for putting impressions on canvas is as wide as her smile. Carrie Jacobson, of Wachapreague, has held an array of jobs, but painting with a palette knife has by far made her the happiest. She calls herself the “accidental artist.”

And that joy and inspiration is contagious to those who covet her work on their walls. Jacobson is also a charitable animal lover, which doesn't hurt her appeal. She credits her success to her husband, Peter, who provided her with the confidence to quit her last regular job and pursue her dream. In his own right, he makes compelling digital and photographic images.

“I quit my journalism job to paint, and we moved from expensive, crowded Connecticut to the beautiful, uncrowded, quiet Eastern Shore,” she said. “I had finally had a vacation, and gone to the Outer Banks to paint,” she explained. “I didn't want to go back to work and was noodling my way home, up Route 13 ... Painter was in the rear-

view mirror. I took the first right I came to, drove to the end of the road and found myself in Wachapreague. Honestly, it felt like I was coming home. I set up and painted, spent the night at the hotel, heard all about Guy Wilkins and how much I'd like Wachapreague. I went home and told Peter about it, and he came down here and put an offer on a house I'd never even seen.”

She started with dog painting, which makes sense since the Jacobsons have half a dozen rescue pups. Eleven years later she still paints “portraits of people's dogs,” she said. “It's great! Right now, I'm doing a big project, 101 Dogs, where I'm painting, yes, 101 dog portraits. I give some money from each portrait to a dog-related group, including the Eastern Shore Humane Society.”

She is also motivated from “anything and everything. The light shimmering on the soft tassels of the fields of wheat growing around here ... The way a house sits on a hillside, next to a small pond, perfectly situated, perfectly peaceful. The roiling clouds of a storm rolling across an

open prairie, darkening the yellow grass, casting purple shadows from the trees.”

Jacobson doesn't really have an all-time favorite subject. “I'm painting a lot of flowers right now. I love our country, and am crazy about painting landscapes that make my heart sing. And I've recently started a series of paintings of famous artists. Whatever I'm painting at the moment is usually my favorite.”

For a quarter of a century she worked as a reporter, copy editor, page designer and executive editor at various newspapers across the country. “I wrote about rock and punk music in Boston in the late 70s and early 80s,” she continued. “Around the same time, I wrote resumes for people. I waitressed, worked as a secretary, got my stockbroker's license and worked as a broker's assistant. I've taught school, taught workshops, worked as a gardener, a cook, a ski instructor, a pottery teacher, a journalist and now, a painter.”

Her mother died in July 2006. “Her death broke me,” she said. “Months and months went by, and I simply could not recover, could not get my stride back.” In

November of the same year, she got the idea to make a painting of their dogs to give to her husband for Christmas. “I was looking for anything that would help me cope, that would bring me back. From the first stroke of the brush on the canvas, I knew that I'd found what I was supposed to do. I loved it.”

At a plein air event in New York, when she was still painting with a brush, “I found myself painting every beam, every girder, every light and dark part of that bridge, each ripple in the river below, and by the time the session finished, I had a painting that I'd painted the life right out of.” It was then that she watched a demonstration with a palette knife.

“If I was going to paint, it was not going to be like this,” Jacobson said of the brush. “So I went out and got some palette knives, and began a journey of discovery that I like to say also freed me from the tyranny of detail.

“Here, life is quiet, and sweet, and cheap,” she said. “The sky is big, the wind is strong, and the landscapes are broad

and inviting. This life is a gift, and I've never understood it more clearly than I have since gambling everything, leaving the corporate world, and doing what I love.

"I love my art! I love my paintings, I love painting itself, I love the whole thing," she said. Now that her Dad is retired he is drawing and painting too. "I go visit him and his wife in Arizona in the winters, and we've had the chance to paint together, which has been just wonderful."

The wild west is not that far for Jacobson. In addition to shows in Virginia,

Maryland and Delaware, Jacobson has brought her work to Pennsylvania, New York, Connecticut, Rhode Island, Massachusetts, North Carolina, South Carolina, Tennessee, Florida, Indiana, Ohio, Michigan, Minnesota, Nebraska, New Mexico, Arizona, California, Texas and Maine.

"I was born on the Navajo reservation in Arizona, and spent a couple weeks painting near Fort Defiance and Ganado, on the reservation." Her most recent painting adventure took her to Montana and Wyoming. She makes between 150 to 200 paintings a year and has been producing at that rate for at least six years.

## CAPITAL LETTERS

The 2017 reconvened or "Veto Session" of the Virginia Senate ended at approximately 8:30 p.m., Wednesday, April 5, having been gavelled into session at noon by Lt. Governor Ralph Northam. This one-day session of the Virginia General Assembly, which is required by our state constitution, occurs every year approximately six weeks after the adjournment of the regular Session of the General Assembly. The purpose of the reconvened session is to consider vetoes by the governor and amendments by the governor to various pieces of legislation, includ-

ing the budget, by the governor.

Gov. Terry McAuliffe vetoed 40 pieces of legislation and offered amendments to 71 more. The total number of vetoes by Gov. McAuliffe over his term in office is 111, which is a record for the Commonwealth of Virginia. It is also a record that none of his vetoes have been overridden. To override a veto requires a two-thirds majority by both chambers of the legislature. Some of the legislation which he vetoed included the Coal Tax Credit, Concealed Weapon Permits for Domestic Violence Victims and the "Tebow Bill," allowing home-schooled students to participate in public school athletic programs. Most of the vetoes were taken up in a single block vote, while others were pulled out by their patrons for individual consideration.

I agreed with the governor on some vetoes and disagreed on others — the Concealed Weapons Permits for Domestic Violence Victims being one example of a veto on which I disagreed with the governor.

The General Assembly will be out of session until January 2018 unless events in Washington require a special session. Any dramatic changes on the healthcare front at the federal level would make it very likely that a special session would be required. McAuliffe could, of course, call a special session on his own in regard to healthcare issues and has indicated that he is considering that option.

My legislation allowing localities to create working waterfront development zones within their zoning ordinances, should be a useful tool

here on the Shore and throughout the 6th District. Also, my legislation, which allow localities to establish a separate category of personal tax to give a break to commercial watermen, has advanced.

In addition, I will likely be putting together a stakeholder group on the issue of conflicts between landowners and the aquaculture industry which has flared in the assembly recently. My work on the Recurrent Flooding Subcommittee will also continue throughout the summer and fall.

I have been holding my annual post-session town halls across the district and will finish with Mathews County on May 15. I am glad to see the interest folks have in their state government.

# Health Matters **Stormy Weather Preparation**

**W**arm, humid conditions during the spring and summer are perfect for thunderstorms. Thunderstorms have the potential to be life-threatening. Lightning continues to be one of the top storm-related inju-

ries in the United States. Know what to do during thunderstorms. It can greatly increase your safety and the safety of those around you.

Thunderstorms produce heavy rain for a brief period, anywhere from 30 minutes to an hour. These storms have the ability to produce dangerous winds, hail, and lightning. They can cause flash

flooding in rivers and streams, dry gulches, and in low-lying areas. If you hear the sound of thunder, then you are in danger from lightning.

### Stay Safe Outdoors

- Be aware of the weather forecast. Sign up for weather alerts on your mobile device.

- Pay attention to changing weather conditions, darkening skies, flashes of lightning, or increasing winds. If you are outdoors and hear the sound of thunder, don't wait for the rain to begin, go indoors immediately. Lightning can strike as far as 10 miles away from where it is raining. Many people struck by lightning are not in the area where rain is occurring. Small, open shelters in parks and athletic fields do not protect people from lightning.

If you cannot seek shelter indoors:

- avoid going near water,
- stay away from tall trees, and
- do not seek shelter near metal objects such as fences or bleachers.

**If a person is struck by lightning, call 911 immediately.**

### Stay Safe Indoors

- Seeking shelter indoors during a thunderstorm is the best protection from lightning. While inside stay away from windows and refrain from running water.

**Lightning can follow conductors such as:**

- Electrical wiring,
- Plumbing and
- Telephone lines.

**Stay inside for at least 30 minutes after the last thunder clap.**

**Protect your pets by bringing them inside the home or garage during thunderstorms.**
