## Family in 1999 Murder Wants Justice

The widow, children and grandchildren lost their patriarch, Charles Andrew Finney, when he was gunned down outside the Cape Charles Shore Stop in 1999, and they are still waiting for closure.

Last week's story about the man who was convicted of Finney's murder and his petition to get the case overturned, brought back unfinished feelings for the family.

"I want real justice," Velma Beamon Finney, the victim's wife, said Sunday. "I want the person who pulled the trigger, doing time. I want the people who were with him, doing time."

"The whole family is very upset," she continued. "When they had court, no one got in touch with me at all. I was living in Virginia. They claimed they did not know how to get in touch."

Finney, 48, was not simply the 25-year veteran Suffolk truck driver who was passing through the area on a run. He was born and raised in nearby Stockton, Md. It was his home place, his wife said. "He has two sons and two daughters still on the Eastern Shore."

"He was also a minister and helped people in all states that his truck

would drive through," she said. "He would bring people home ... when possible, feed and clothe them. He was also a skilled mechanic. And whenever he saw someone broke down he would stop and help if he could. He was featured on the 700 Club after his death, because he had stopped and helped a lady whose car had broken down on the side of the road."

He regularly went to the Cape Charles Shore Stop for more than 15 years, she said. "We were married in 1980. I had three children for him and two sons that he raised as his own. My youngest son was one-month-old when I married him. While riding with him on the truck I watched him feed the homeless under the bridge in Philadelphia. He was always giving his time to help others. Her stepdaughter, Terrell Finney-Crosby of New Church, had the same story. She was six months pregnant when he was killed. The next day she said she went to Northampton to find out what was going on. "They took my name and address and phone number and put me on a list that I would be notified. I never was," she said.

"We're reliving this all over again. We want justice for our father. My dad

was the type of person he would help anybody. If you needed something he would help you. For things to go the way they did, it is just awful ... It seems like at the time they were more

concerned about the drug charges. And for the people who were with him, they should have gotten charged also. We gonna fight this until the end," Finney-

## New Water Source on Tap for Chincoteague

Chincoteague's Town Council voted Monday to spend \$28,000 for an exploratory well, engineering and related testing that could provide drinking water to the island in the future.

The officials also discussed selling the former public works building on Cropper Street to the Chincoteague Volun-

teer Fire Department (CVFD), which uses it to store equipment and house emergency workers. In the end, the officials agreed to seek an appraisal for the property. The company has a 40-year lease for the structure at \$10 a year.

In addition, council debated changing the process for higher density projects on the island. A public hearing on

that topic is scheduled for next month.

"These people out here are screaming every day," said Vice Mayor Denise Bowden regarding the latter subject. "They want to give their opinion. You've got to give these people some input on what's going on in their neighborhood. The people who are going to build these

# Exmore Proposes Ruth Wise Road in Memory of Late Community Leader

Town Manager Robert Duer told the Exmore Town Council he would like Sojourner Truth Road to be renamed Ruth Wise Road, in honor of the local community activist who died in July.

Wise passed less than a week after being recognized at the New Road Community Development Group's 25th anniversary celebration. The event featured the unveiling of a new sign renaming the New Road Community Square as Ruth Rogers Wise Community Park and Garden, in her honor. Wise worked with the community development group since it was founded to provide water and sewage for 90 Exmore area homes.

Utility Director Taylor Dukes said the town's water and sewage systems need updating. The wastewater treatment plant's drip dispersal field must be relocated, due to general "failure," unrelated to the system's age. The drip dispersal field works like a home

septic system's drain field, Dukes explained. The drip dispersal system is similar to an irrigation line so water released stays in the ground. The site for the new drip dispersal field has not been determined, as the town was unable to secure its initial location of choice.

Exmore's current water supply originates from two wells, is pumped into a 200,000 gallon, above-ground holding tank, and is chlorine-treated. A water quality inspection found high levels of iron and manganese. To correct this issue, the town plans to implement a greensand water filtration system, which will go to bid in September. Two eight-inch pipes were installed in 2014 for use with the water filtration system. The town council agreed Monday to pay \$12,500 for an easement for a 1,000-foot right-of-way to install a pipe for disposing backwash from the filtration system. Backwashing is a method of cleaning water filters

by reversing water flow.

The council, Duer and marketing consultant Clarice MacGarvey all commended police chief Angelo DiMartino for his recent efforts to improve safety and community relations in Exmore. Duer stated that the new drop-off bin for disposal of expired or unused medications, located just inside the entryway of the town hall, is already "75 percent full." DiMartino introduced the new medication disposal bin in mid-July. He also designated an internet purchase exchange location outside the town hall, next to the police station, for buyers and sellers to safely complete online business transactions under 24-hour video surveillance. The location is marked by a green "Meet-Up Spot" sign.

DiMartino was credited with organizing Exmore's second annual National Night Out, held in the town park last week, which was deemed a big success by town personnel, with

200 or more attendees. He pointed out that director of public works, Mike Johnson, was responsible for acquiring the vendors for the event, and also assisted in cleanup the next day. The block party-style event was part of a nationwide effort to improve community relations and reduce crime.

DiMartino acquired a grant to purchase a new, four-camera surveillance system, which will supplement the three existing cameras at the town hall; two in the lobby and one outside.

The council also appointed two new members to the town planning commission, Chase Sturgis and Ernest Fields Jr.

Duer stated that with no turnover in two years, the town staff has completed projects in a more timely and efficient manner.

# County Up to Its Neck in Controversy over Hacksneck Boat Ramp

Local watermen, residents and officials are at odds over who can use access Hacksneck by boat.

"A public right-of-way exists and has existed for decades upon decades at Hacksneck Landing," County Administrator Mike Mason said Wednesday. "This landing is utilized by commercial fisherman, the Department of Game and Inland Fisheries and recreation seekers alike. Recently, an individual has attempted to block the public's use of the landing. The county has and will continue to defend the public's right to use this landing. The county has pending litigation associated with this matter so this is all I am prepared to say at this time," Mason added.

Tucker Mayhew Terry, 38, of Exmore, owns the building where Nandua Seafood's crab house is located at the landing. The business is owned by Clinton Pitts and Franky Bennett and employs 15 to 20 people.

Terry has been posting signs and running people off what he believes

is his turf. He was not at the seafood company Wednesday when a reporter attempted to reach him for comment. He owns a minnow business on the left side of the road. The crab house is on the right.

Terry was accused in papers filed in Accomack General District Court of assault and battery of waterman Matthew Forbes May, on Aug. 1.

"He pushed my boat out into the water where I couldn't get to the boat," May wrote in a warrant. "As I tried to stop him, he grab(bed) my shirt and pushed me away. Then as he was walking away, he said, 'I will f---ing kill you.' Then I asked Billy Bowen for a ride out to my boat. To which he said, 'I'm not getting in the middle of this.' He then gave my employee, Visente Alaniz, a ride to my boat. We then left the boat ramp."

"Mr. Terry has owned that property for years," Supervisor Donald Hart said Wednesday. "All of a sudden a couple of months ago," he put down "crush and run and blocked the ramp ... his-

torically it has been used for over 100 years" by waterman and their forefathers. "The VDOT right of way goes over to the water. The county is writing him letters ... we tried to talk to him."

Hart said County Attorney Celia Berge is dealing with an attorney "across the bay" over the issue. Terry "put up two poles and he put a chain

up," said Hart. "But the county took it down. We're just trying to find out why he's doing it. He says it's his private ramp and no one else can use it. It's listed on all the maps and everything as a public ramp."

Hart said Terry also notified Pitts and Bennett that they will have to move their business by the end of the year.

## Suspect in Salisbury Murder Arrested in Horntown

The seventh suspect in the murder of a Salisbury, Md. man was arrested in Horntown last week without incident.

Brandon Keith Yarns, 21, of Marshall Street in Salisbury, waived extradition from Virginia clearing the way for him to be returned for trial, according to records filed in Accomack General District Court. Yarns is being held in Accomack Jail without bond. He was arrested Aug. 2 and charged with first and second degree murder, two counts

of conspiracy to commit murder, assault and reckless endangerment.

Yarns could face life without parole if convicted of the July 30 death of Tavin Tyrue Molock, 32, of Washington Street. Molock was found stabbed to death on Bethel Street, also in Salisbury. Two other suspects Eddie Smith and Hammond Taylor identified Yarns as being in the group that attacked Molock.

Deputy B. K. Misener of the Accomack County Sheriff's Office was involved in the investigation.

# County Health Care Dominates Top Northampton Supervisors Agenda

"Thirty million Americans don't live within one hour of trauma care," Spencer Murray stated Tuesday, emphasizing that Northampton County is not the only rural area in the nation with issues obtaining urgent and emergency health care. "Northampton County needs an urgent care center," the board chairman asserted.

The county supervisors meeting opened with a news video about Richard, Ga., and how the low-income, rural area was affected by the local hospital's closing. The nearest hospital is now 45 minutes away, EMS is flooded with over 1200 calls per year, and ambulances have become "mobile emergency rooms." Local doctors are so overwhelmed that one woman said she had to call an ambulance to be treated for the flu.

"With so many rural hospitals closing across the nation, the Eastern Shore is fortunate to have a hospital of the caliber of Riverside, in Onley," Murray said.

Since Riverside Shore Memorial Hospital relocated from Nassawadox in February, Northampton County EMS staffing needs have already increased, with an accompanying "expanded cost," Murray stated.

Murray said he spoke with Eastern Shore Rural Health System CEO Nancy Stern about forming an ESRHS urgent care center. The Department of Health and Human Services would not prevent it. Such a project would likely require a three-to-five year plan.

Supervisor Granville Hogg added, "The public needs to be better educated on how to use the county's public transportation system," StarTransit, when traveling to local medical facilities for routine care.

Director of Finance John Andrzejewski presented a budget amendment for fiscal year 2018 for \$58,600 to purchase a prison transport vehicle and maintenance truck. The money will be withdrawn from the jail's phone commission account, with a current balance of

\$160,000. Supervisor Larry LeMond questioned why the sheriff's department is not using any of these funds to offset its costs, and board member Oliver Bennett asked why the money couldn't be used to purchase security cameras for the county. Deputy County Administrator Janice Williams explained that the funds were intended to directly benefit the jail and its prisoners; Andrzejewski stated that these were not general funds. Murray said these are not taxpayer funds, and invited the sheriff to attend the board's next work session to further educate them on the matter.

Andrzejewski also presented amendments to the school budget for fiscal year 2018, including over \$5,000 in grant funds from the Northampton County Education Foundation for four-week Pre-K summer camps at both Occohannock and Kiptopeke elementary schools. The Virginia Tiered System of Supports awarded the school system \$19,000 in grant funds to continue the Positive Behavioral Interventions and Supports program.

School Superintendent Eddie Lawrence reported there were no permanent suspensions or expulsions from the school system last year.

Andrzejewski said Northampton was "safely in the black" for fiscal year 2017. Murray announced that there were no county tax increases for two years in a row.

Bayview residents pay a flat fee of \$54 per month for water. Director of Public Works Chris Thomas said the average Bayview household should use 3,000-4,000 gallons of water per month, but some are using ten times that or more. He attributed the excess water usage primarily to faulty toilet flush valves, causing the toilets to run constantly. A recent inspection of Bayview units identified 30 of 72 toilets with the fault. The board is considering an alternative billing system for Bayview's water supply, based partially or fully on usage, providing incentive for residents to ensure their water-using appliances are in good working order.

The board approved repairs to Route 617 in Bayford, with a spending cap of \$40,000.

# CHESAPEAKE COWBOYS WRANGLE BOATS FOR \$20,000 IN CASH PRIZES

The brutal, August sun beat on the crowd above, but it still wasn't as hot as the engine of the boat as it careened towards the slip formed by two rows of piles. It came in strong and turned hard, coming to nearly a complete halt before backing swiftly into the slip, the captain darting back and forth across the deck, hurriedly tossing the ropes over each of the four corner piles marked with orange tape before drifting out of reach.

Approximately 1,500 spectators watched the Chesapeake Cowboys boat docking contest at The Oyster Farm at King's Creek in Cape Charles on Sunday, part of Shuck 'n' Suck 2017. Chesapeake Cowboys organizer and MC, Erik "Flea" Emely, said, "the event was incredible for their second year at that location ... the atmosphere couldn't get any better."

The Chesapeake Cowboys wowed spectators even when they finished with high times or didn't finish at all. Many cowboys literally made a big splash as they leapt to rope the last pile, in a last-ditch effort to beat the shortest recorded time. Some successfully roped the fourth pile before hitting water, while others

succeeded in belly-flopping before the entertained crowd, which hooted and hollered at the cowboys' aquatic exhibitions.

New this year was the women's division, a team competition with boat captains maneuvering the vessels while female partners, usually spouses, "roped" the piles with hula hoops.

Competitors placed in four categories - small, medium, large, and wood boats. Times were recorded from the moment the horn sounded to the moment the final pile was roped. Finishes counted only if all four piles were roped completely around. Competitors who missed or did not completely rope a pile were designated "Did Not Finish."

### Accomack Grand Jury Indictments Handed Down

Two county women were indicted Monday by an Accomack Grand Jury on counts of committing violent crimes in separate incidents this year.

Bertisha Rose Johnson, 52, of Onancock, was indicted on counts of robbery, abduction, use of a firearm, eluding and assault and battery of an officer in connection with an incident at St. Peter's Catholic Church in Onley on May 24, 2017.

Yashica Tonya Hope, 37, of Chester Street in Mappsville, was serving a 12-month jail term after being convicted in March of assaulting Kegotank Elementary School's principal. Hope was indicted for assaulting a deputy while in police custody on June 11, 2017.

Sheriff Todd Godwin said Hope, who was pregnant when she was convicted of the altercation involving Principal Jennifer Annis last November, assaulted the deputy after refusing to get out of a squad car when being taken for a doctor's appointment. She has since had the baby, who is in foster care, Godwin said. Deputy E. Thornton, the assault victim, gave information to the grand jury in that case.

Hope slapped Annis in the face, grabbed her by her hair and threw her in the floor against the filing cabinets in the school's office.

In Johnson's case, preliminary hearing testimony showed she had a cocaine relapse earlier this year and was desperate to get cash so she could return money to her son's debit account before he realized she'd spent it on drugs. She's been convicted of crimes 23 times before.

Johnson went to the church dressed in black, complete with a matching ski mask and a pistol that she later used to beat Joanne Boyko, the business manager at the church, the victim testified. Johnson tied up Boyko after getting less than \$50.

Boyko testified Johnson pulled out a gun that was wrapped in a blue grocery store bag and demanded money. At some point Boyko managed to get free from the ties that bound her hands. When Johnson got close enough, she said, "I lunged at her hand and grabbed it (the

gun). The two struggled and she "continuously hit me in the head with the gun." Boyko said she started screaming and the suspect fled.

"I think she might have hit me at least five times," the church worker said. "She didn't talk, she just kept on hitting me."

In another case, Brandy T. Fiddemon, 37, and her husband, Robert Lee Fiddemon, 52, both of Neal Parker Road in Withams, were indicted on counts of stealing food from Oak Hall Pizza Hut on May 27, 2017. Sgt. Bobby Taylor of ACSO investigated.

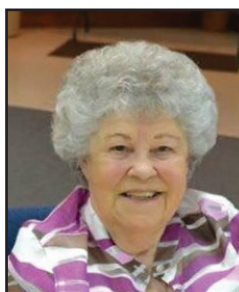

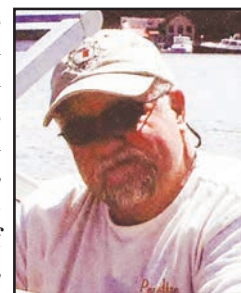

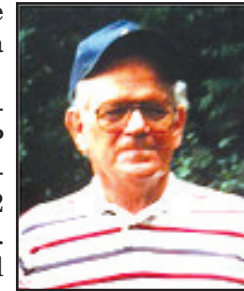

# 92nd Annual Pony Auction Shatters Record

Every year, the Chincoteague ponies make their aquatic trek from Assateague Island to Chincoteague for the annual auction, which takes place Thursday mornings during Pony Penning week. Held at the carnival grounds, the proceeds benefit the Chincoteague Volunteer Fire Company, which manages and oversees the well-being of the beloved, historic herd.

The auction serves as population control, and draws thousands from across the country since its inception in 1925. Made famous by Marguerite Henry's "Misty of Chincoteague," the event gives the four-legged island natives an opportunity to spread their roots, while keeping the wild herd's numbers from becoming too large.

This year, the 92nd bidding race tallied a record-breaking \$209,900 in sales, shattering the previous record of \$179,700 that was set roughly 10 years ago, according to Chincoteague vice mayor and fire company member Denise Bowden.

The first of the 62 foals to be presented for auction was a 3-month-old palomino colt with striking white stockings and a star, which sold for \$4,200.

A 4-month-old buckskin and white pinto colt was the first buyback pony. It went to the Chincoteague Legacy Group, with a winning bid of \$8,400.

This year, the auction consisted of 10 buyback ponies; two colts and eight fillies, chosen by the fire company to replenish the herd. The ten made the swim back with the rest of the herd to Assateague, where they will remain. Winning bidders do, however, get naming rights.

Also among the ponies were what the announcer referred to as "fall pick-ups"; those foals that are only weeks old, and are too young to be weaned from their mothers. They will also return to Assateague with the herd until the set fall pick-up date of Oct. 14.

A little 1-month-old palomino and white filly would mark the first fall-pick up to be presented to the crowd.

The second buyback of the day, a six-week-old filly, benefitted the Kiwanis Club and sold for \$7,100.

A buyback palomino filly sold to the Chincoteague Legacy Group, marking the highest sale of the day at \$15,000.

The Feather Fund aided Alyssa Jastram of Ridgley, Md., and Kensington Nelson of Monterey, Ca., in fulfilling their dreams of owning their own Chincoteague ponies.

Jastram was the highest bidder on a chestnut and white pinto filly out of CJ Sammin', who she has named Alyssa's Blissful Dream, known as Dreamer in the barn.

Nelson won a bay and white pinto colt out of Cody Two Socks, which she named Copper's High Tide, or Bongo, for short.

One of the most memorable, "awe" moments of the day was when five-year-old Austyn Mae Manning won a 3-month-old liver chestnut filly by Riptide and Lyra's Vega. Cheers – and tears – erupted throughout the crowd when it was announced that Manning was the winning bidder. She made her way to the booth to set-

tle up, escorted by her father, clutching a Mason jar filled with money she had been saving over the last year in order to buy her very own Chincoteague Pony.

Manning's father, Adrian, explained that his daughter saved a combination of mostly pennies, giving her a total of \$50 to put towards a pony.

She named her Sandy, formally known as Fleck of Island Sand. Sandy will not have to travel far, as the family resides in Zuni, Va., and also own another Chincoteague pony named Salty.

Sometimes, people come to watch the auction without the intention of purchasing a pony; however, there are instances when a special one comes along that causes an unplanned buy, which is the case for Alyvia Davis' family from New Hampshire.

Davis, who states they own two horses and a pony, were vacationing on the Island for the week, and could not resist the opportunity to get a Chincoteague pony. Davis rides horses in local 4-H shows, and is now the proud owner of a chestnut

and white filly.

Another family from Indiana bought their first auction pony, a 3.5-month-old chestnut and white pinto filly, to add to their barn.

Each buyer got a bag full of horse-related items and coupons for their new pony, and foals were able to be hauled home beginning July 28, in approved trailers.

Just before 11:30 a.m. the last pony of the morning, a 3-month old filly, also a buyback, sold for \$9,000.

The lowest price recorded was \$1,100, with the average of \$3,400 a foal – an increase of \$741 – to last year's average of \$2,659 over 57 ponies sold.

The Chincoteague Legacy Group holds the highest bid record at \$25,000, which was recorded last year on their buyback pony.

The competition, which brought together over 190 athletes from across the globe, was a full format champion-

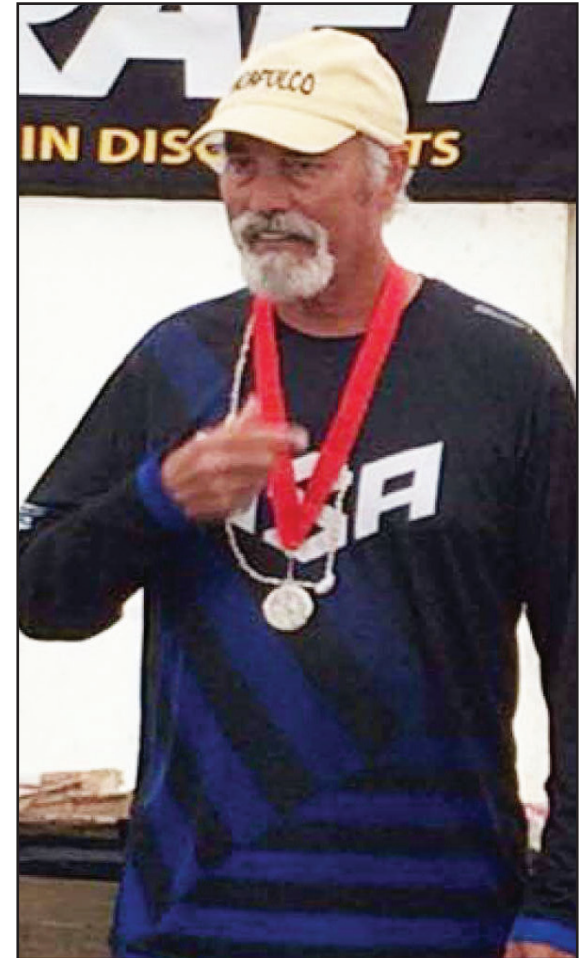
ship event, consisting of Accuracy, Discathon, Disc Golf, Distance, DDC, Freestyle and Self Caught Flight.

# Fishing from the Shore

The catches were on the small side in the Onancock Volunteer Fire Department Croaker Classic, but the participants had a whale of a good time and the event benefitted a worthy organization. Mason Horner captured the top spot as well as the largest croaker caught by a youth. Other winners included Joey Boole (2nd Place), Chad Parks (3rd place/Top First Responder), Brittany Parks (Top Female), Sterling Valentine (Top Non-Croaker) and Brenda Payne (Smallest Croaker).

Brisk winds last weekend, which undoubtedly affected the croaker tournament results, kept most of the vessels inside the creek, and monsoon-like weather in the early part of this week combined to put a damper on most folks' fishing plans. Look for improved angling results once the weather stabilizes.

Just to our north, the 44th Annual White Marlin Tournament is being held this week, with Friday, Aug. 11, the last day of fishing. The tournament attracted a field of 353 boats and the \$4.6 million dollars in payout money, making it the largest amount of money ever awarded in a fishing tournament. The largest white marlin could earn the angler a paycheck worth \$2 million dollars or more! Off-shore fishing up to this week off Delmarva has not been great, but a fleet that big will have the range to find the fish if they are out there. The awards ceremony will be held on Saturday, Aug. 12.

**Wachapreague** – Vessels making the run south to the Norfolk Canyon found marlin fishing to be on the slow side, but hungry hammerhead sharks were very aggressively hitting slow trolled live tinker (chub) mackerel. Most boats gave up on the trolling and ended up deep dropping for blue line tilefish and black sea bass. Captain Lindsay Paul, of Trident Tackle, reported that the action inshore of the canyons was also on the slow side. One boat trolled from the 830 line all the way to the Lumps without a single knockdown. A few king mackerel and

false albacore were caught from 20 fathoms inshore to the Hills. Inside the inlet, a few flounder are still being taken, but the overwhelming majority are throwbacks. Anglers wanting a serious shot at a keeper flatfish are having to run out to the wrecks and railcars near #10.

**Chincoteague** – The offshore fishing up at the Washington Canyon was somewhat better than down in the Norfolk, with some white marlin releases and dolphin (mahi-mahi) action being found around the lobster balls. Donna Rae, at Captain Bob's Marina, reported that the blackfish (tautog) fishing has improved over the offshore wrecks, with triggerfish and spadefish coming from the Blackfish Banks. Inside the inlet, action for keeper-sized fish remains disappointingly slow. Croaker are few in number and most of the flounder are well below the legal size limit. Kingfish and sharks remain the only steady catches.

**Lower Shore** – Mark, at Chris' Bait & Tackle, reported that a few croakers were coming from the area around Marker 262 at Wise Point. Anglers fishing from the pier at Kiptopeke State Park were finding a mixed bag of croakers, sand mullet (whiting) and hand-sized spot. Red drum releases are being made around the Chesapeake Bay Bridge-Tunnel during the evenings. A few cobia are still being caught by anglers sight casting in the waters between the bridge tunnel and buoy 36. Tautog catches have come from over the tubes and spadefish continue to be found around the rock islands. Sharks were described as being "everywhere!"

**Upper Bay** – Matt Abel, at Seahawk Sports Center, reported that red drum were being caught and released from the southern bay all the way up to Pocomoke Sound. There have been some cobia catches as well by anglers targeting the big reds. Bottom fishermen have been finding mostly kingfish, with a few spot and small croakers. Large sheepshead are still a possibility at the target ships

for those anglers willing to risk their vessel and personal safety among the sharp remains of the rusted hulls.

Crosby said.

“We still grieve,” she posted on Facebook. “We still hurt. And the worse thing is we were denied our rights as a family. Our father meant just as much to us. He was just not an average black truck driver. And for his life to be taken by man instead of God is unacceptable.”

On May 18, 1999, he made his last trip to the Shore, making the usual stop for a snack. He was leaving the parking lot when he was shot in the chest during an attempted robbery by three men. His wife says she heard a girl was also involved in the incident. “They claimed she was a senator’s daughter or somebody’s daughter. Name was Valerie, something like that,” she said.

Finney collapsed in front of the store. His wife says he died in the arms of an officer who lived nearby. But she doesn’t know who that was. Not only did the family lose their loved one, the major breadwinner was gone and with him went “houses and everything.”

“When I found out, I was at work” in Virginia Beach, Velma Finney said. “My sister called me from Georgia.”

“The blood is still in front of the store,” his youngest daughter, Lashavay Zanta Finney, said in the background during a telephone interview with her mother. “It left a mark on the ground,” she said.

“I could have gotten off” work to go to the trial, said the widow. “After I contacted the court, the investigator called” and told her the verdict. “It’s been 18 years,” she said. “Come May, next year, it will be 19. We’re still trying to adjust.” She urged people on Facebook to “write statements so I can carry them to court when the time comes.”

Jerell Damon Smallwood was 20 when the murder occurred. During a police search for drugs he was linked to the death. Smallwood was convicted in Northampton Circuit Court in 2001. In accordance with a jury’s recommendation, he was sentenced to life for capital murder, 10 years for attempted robbery and three years each for two counts of use of a firearm. He pleaded guilty to cocaine distribution and got

40 years for that. All the terms were set to run consecutively.

His former best friend has recanted damning testimony he made about Smallwood at the trial. Charges were dropped against two others at that time. There was no mention of a girl in the court files.

Smallwood has asked the state supreme court to reconsider the case because Cornell Sheron Evans, 36, of Virginia Beach, formerly of Fairview, says he told the lies at the trial to get a leaner sentence for his own unrelated crimes. Evans claims he was coerced into giving the testimony by (now retired) Judge Glen A. Tyler, who at first sentenced him to nine years in prison for two counts of selling cocaine. Evans said Tyler told him he had 30 days to think about what he knew about the murder if he wanted the term to be reconsidered. Evans said he testified as was suggested. Court records show Tyler later re-sentenced him to five years and then suspended the term with the condition that Evans successfully complete a drug rehab program.

Tyler denied the allegations of misconduct. Evan’s case was never transcribed and is more than 10 years old so files weren’t kept. Smallwood also says Commonwealth’s Attorney Bruce Jones did not disclose information to the jury regarding possible consideration that might be given to felons who testified against him.

Senior Assistant Attorney General Virginia B. Theisen asked the supreme court to dismiss Smallwood’s petition. Tyler “properly considered Smallwood’s other serious criminal acts in fashioning the sentence for the drug crimes,” she wrote. Other drug-related sentences cannot be compared since the history of each defendant may “factor into the sentence he receives.”

“Criminal sentencing decisions are among the most difficult judgment calls trial judges face,” Theisen wrote. “The sometimes conflicting ... goals involved in such decisions defy precise measurements. Because this task is so difficult, it must rest heavily on judges closest to the facts of the case — those hearing and seeing the witnesses, tak-

ing into account their verbal and non-verbal communications and placing all of it in the context of the entire case.”

She also argued that while Evans’ affidavit regarding his testimony is dated July 14, 2016, the date that Evans actually told Smallwood of his lies “would be the pertinent date for purposes of the statute of limitations.”

Theisen noted that a week before the trial, Jones stated in discovery that Evans “may be called” to testify. “The prosecutor stated that although Evans had been sentenced for his most recent drug distribution conviction, he may hope that cooperation ... might result in a reduced sentence.” In addition, she said, Jones told the court, “Some of the commonwealth witnesses have been convicted of crimes and some of them ... are hoping that by cooperating ... somehow their circumstances will be helped.”

Smallwood told authorities he was in New York visiting his grandmother and father when the crimes occurred. He was listed as homeless and was linked to the murder after a search warrant was made at a trailer where authorities said he was living. No one at the trial testified to seeing him in New York.

Defense lawyer Bryan Jones says in the petition that a letter from 2005 from Dwight E. Adams, director of the FBI Lab, addressed to ... Bruce D. Jones ... cites a 2004 report issued by the National Academy of Science. “The letter states ‘the FBI has elected to no longer conduct bullet lead examinations’ because of ‘the inability of scientists or manufacturers to definitely evaluate the significance of an association between bullets made in the course of a bullet lead examination.’” The defense states “the practice significantly debunk(s) the commonwealth’s scientific evidence.”

The other suspects were Vernon (Rochette) Leroy Smith, then 21, of Cheriton, and Demarco (Macho) Antwan Spady, then 22, of Cape Charles. When Smallwood’s trial began, Bruce Jones told the Post the charges against the two had been dropped. Frederick (Frank) Washington, one of the witnesses listed, reported that Spady said Smith “actually shot the victim.”

Spady pleaded guilty to possession of cocaine and marijuana in 2000. There were no convictions for Smith in

Northampton Circuit Court.

Rochelle Myrick knew Smallwood and said she saw him on Bayview Corner with a gun on the day Finney was shot, Theisen noted. She also “heard Smallwood, while in the company of Demarco Spady, talk about robbing and killing somebody. Tekesha Benton likewise saw Smallwood on the corner by Snake’s pool room and she noticed that he was carrying a gun.” Theisen said Benton recalled a conversation about a robbery.

Victor Damont Taylor saw Smallwood at the convenience store on the day of the murder with two others. Washington said he saw Smallwood that day too. He had a gun and was with Spady. “He was going to the Shore Stop to ‘stick up’ a truck driver,” Theisen wrote Washington said.

Lonnie Wiggins noticed Smallwood, Smith and Spady walk past him toward the Shore Stop about 20 minutes before the crime occurred, the senior attorney general stated. Katie Lewis said she saw Smallwood there. Veronica Finley “selected Smallwood’s photograph from a photo array prepared by police as one of the men she saw running from the Shore Stop after she heard gunfire.”

“After the murder, Smallwood told David Washington ... he killed the truck driver. In the Portsmouth jail, Smallwood admitted to Antwan Uptegrow that he had shot the truck driver, but claimed the gun had fired accidentally,” Theisen wrote. “In the Northampton County Jail, he threatened to do to Ricky McMillan what he had done to the ‘guy at the Shore Stop.’”

This week Bryan Jones responded to Theisen’s comments in a 36-page filing. In summary, he said, his client’s constitutional rights were violated and that, new “evidence confirms that the trial court coerced Evans into testifying.” He wrote, “The prosecution’s questionable tactics extended beyond Evans. They extended to every witness who was paraded into court with incredible stories of how petitioner was supposedly involved in the crime ... petitioner has addressed each witness and demonstrated that the one thing they had in common is that they each had something to gain, and indeed, they benefited in one way or another from their testimonies.”

big things .... It takes corporations ... These people here that have worked all their lives ... have every right to say, 'hey, I have an issue with that.'

Planning Chairman Ray Rosenberger reminded the officials the island "is not a planned community. All things lead to confrontation," he said. "Give people the opportunity to express their concerns."

Councilman Jim Frese was opposed to changing the rights of landowners. "When I see all these changes here ... Holy Mackerel! That's what we do with the comprehensive plan ... Look at the pages in this thing."

Councilman Gene Wayne Taylor discussed grandfathered rights and giving owners a chance to decide what to do with their property before their rights change.

"This does not mean that Joe ... cannot build a hotel," Bowden said as an example. "He's going to be held more accountable as to how it's going to be done. It's a win/win for the landowners."

Taylor said if he were backing a project he would withhold his funds "because I don't know what you're going to do tomorrow ... Can I trust something by right?" he asked.

Concerning the public works building, CVFD President Willis Dize wrote, "Our plans are to continue to use the building for storage of our fire apparatus. At the completion of our new fire house, all of our equipment will be under one roof once more." He said the building "shall be sold with the existing fire house and possibly torn down for parking."

Supervisor Billy Joe Tarr, also a CVFD member, said, at first, the company spent \$100,000 renovating the building, which has a big crack going up the wall where the sun shines through. "Not sure there are any renovations that can be done to the building" to save it now, he said.

Taylor said the lease would change the value of the building. Councilman Ben Ellis was concerned how citizens would feel if the fire company sold it for more than they paid.

"Everybody knows how I feel, I'm pro-fire company," said Bowden, who is a department member. "It's still going to go back to the people we're protecting ... sometimes the fire company is taken for granted." She wondered what would happen if there was no fire company. "You people out there are going to be paying taxes like you've never paid before."

Councilwoman Ellen Richardson, a for-

mer member of the fire department's ladies' auxiliary, did not agree. She said the fire company has not met its obligations in the lease by not putting in a sloped floor, installing new bathroom and partitions, installing separate heat and air conditioning for areas, painting, insulating the ceiling, patching a hole in the second floor. "Leasee should maintain in a clear orderly and safe condition," she said.

The town gives the fire department \$700,000 a year for EMS and other costs, Richardson continued. "There's not another town that supports its fire company like the town of Chincoteague ... People (in CVFD) say they (the town) don't do nothing for us, it's all right here," Richardson said the town budget.

"The fire company utilizes that very well," Frese said of the money. "No question about it. We cannot ignore the fact that that property ... belongs to the people ... we have to be very careful ... sometimes you have to say things that don't make you a favorite ... honesty comes first. That's taxpayers money in one form or another ... we cannot rush into it. It cannot be an emotional. Its not us against them. That's a lot of money, multiply that by ten years and that's \$7 million."

Mayor Arthur Leonard wanted an ap-

praisal that would take everything into consideration. "We're straddling on some debate here ... over expenditures ... the fire company does more things than just fight fires, ambulance and that stuff ... it's the community center ... it's the heartbeat ... through everything there's always been the Chincoteague Vol. Fire Company ... It's us. All of us. When we start bickering about who does what, when, where, I think we're slapping ourselves in the face ... stay focused. Look at the building. Go from there."

Reports on pony penning indicated having an earlier swim this year made things run smoother. Town Manager Jim West said there were 100 people (town workers and volunteers) involved with handling the shuttles, parking and crowd management. "Very impressive," he added. "All thanks go to Karen" Hipple, finance director for Chincoteague, "for basically planning it. Nobody whines and complains even though we have stories afterwards," West joked. "The jumbotron was pretty successful this year," he added. "Hopefully, we can continue that program next year."

"I can't say enough about how well pony penning went this year in regard to working with town," said Bowden. "Nothing but compliments ... you guys did a fantastic job. I appreciate it very much."

# Coast Guard Rescues Two

Coast Guard Station Cape Charles rescued two men Saturday, Aug. 5, after their boat capsized.

Watchstanders on duty at Coast Guard Sector Hampton Roads in Portsmouth were notified around 2 p.m. that a 14-foot sailboat carrying two people had taken on water and run aground near the Cape Charles Coastal Habitat Natural Area Preserve.

The sailors, a 70-year-old man and his 34-year-old son, had already re-launched their boat when Cape Charles Coast Guard personnel were en route to the scene in their 29-foot, small-crew response boat.

The sailboat capsized, and the two men, who were both wearing life jackets, were tossed into the water.

The Coast Guard arrived on the scene and rescued the men. The crew transported them and towed their sailboat to the Cape

Charles marina, arriving at 3:10 p.m.

Petty Officer 2nd Class Christofer Brown, coxswain for the case, stated, "Weather conditions can change unpredictably on the water ... It's important to wear your life jackets at all times and stay prepared for the unexpected, as these gentlemen were."

The same day, the Coast Guard assisted five people after their boat ran aground on Parramore Island.

We don't want anyone to take rocks that may be part of a natural barrier from the bay or ocean so buying them is a safe bet and they are relatively inexpensive."

"I'm not sure how many I have painted and hidden," Bell continued. "It's in the hundreds. I've gone through about

120 pounds of rocks so far. My two kids are painting. My daughter who will be 3 tomorrow (Wednesday) paints herself more than the rock but she has fun doing it. My 7-year-old, William, he is my hider/seeker. Sneaking and hiding them is his favorite part."

"Basically, you paint and hide rocks around the community to spread happiness, joy, inspiration, and fun," Bell posted on the site. "When you find a rock, take a pic of it and post it on Facebook with the hash tag #ESVARocks or in this group and either keep the rock or better yet, hide it in another spot for someone else to find!"

"Do not go in someone's yard and place rocks unless you have their permission first ... Rocks should be hidden in public places. If you want to give a certain person a clue just for them, that's great. Some people will not care if you hide them on their steps ... please, get permission first and DO NOT post pictures of any houses/yards."

"Also, be VERY careful about going out at night. We don't want to cause a problem for local law enforcement with reports of suspicious activity around businesses," Bell wrote. "We do not want to cause any problems and have any

negative thoughts against our group."

As for my co-workers, they seem to have all found their marbles ... I mean rocks. Bell was aware of them too. "I have seen quite a few that Troy (Justis, our ad manager) has found! I love seeing everyone participating. It's so cool. It gets William off his tablet and out of in front of the TV for a while, which is great!"
