CHINCOTEAGUE UNDECIDED ON GIVING PROPERTY TO FIRE COMPANY

SPIRITED DISCUSSION ON FIRE COMPANY FUNDING ENSUES

It started with a request for Chincoteague to give a building to its volunteer fire company last month and a debate regarding more than \$700,000 that two council members say the town spends on Emergency Medical Services (EMS) every year.

Fire Chief Harry Thornton took the floor at Tuesday's town council meeting to continue the conversation saying emergency services on the island are funded with 1 percent of the transient occupancy tax, so the tourists are paying the bill, not local taxpayers.

But Councilman Jim Frese said that is not the way it works. All taxes are put into the general fund by law and then council allocates money in the budget, he said.

Thornton disagreed. It was set up in 1989 or 1990, not to be a burden to the people. He said it was either the occupancy tax or the meals tax that was supposed to fund paid EMTs.

"The (emergency) calls were not being answered so the town stepped up to pay," said Councilwoman Ellen Richardson.

"The local people were not creating the problem for the ambulance," said Thornton. "The visitation was creating the need."

"Somewhere along the line somebody dropped the ball," Richardson said. "There's been a lot of balls that have been dropped."

"Thank God we haven't had to ask the town for a whole lot," Thornton said, adding, the fire company recently spent \$500,000 to purchase a new fire truck so residents would have lower insurance rates.

But while they disagreed, they were cordial. And support for the fire company was apparent. No decision was made regarding the request for council to sell property the fire company leases for \$10 a year. It uses the former public works building on Cropper Street to store equipment and house emergency workers. Fire officials reported in August the building is in dire need of repairs. Richardson said the lease requires the fire company maintain the structure.

Last month, town officials agreed to seek an appraisal before considering a gift or sale of the property.

"We're not ready to tackle the questions you're asking," Mayor Arthur Leonard said at Tuesday's session. "We don't have that property assessed. We can't be getting ahead of ourselves ... those figures were probably spat out to make a point ... not to be factual ... we could probably do an interior audit ... don't want to make a mountain out of a molehill ... we're dealing with a piece of property that the town hasn't ... used and we're making it into the Taj Mahal."

"I'm just talking about EMS," said Thornton. "I don't even care about Cropper Street."

But Leonard reminded Thornton,

"The facts and figures were brought up because of the request."

Richardson said it should be noted that billing money from the ambulance service does not come back to the town. She and Frese both said they got the figures from the town budget.

"The insurance money is what purchased a \$250,000 ambulance," Thornton answered, daring them to take over such purchases.

"I know there have been long, hard fought battles ... over EMS ... the fire company," said Leonard. "I don't want to see this digress into something where

IRMA'S FATE IS FICKLE, SO MAKE PLANS NOW

The track is uncertain, but authorities suggest residents in Accomack and Northampton counties begin storm preparation in case the Eastern Shore gets hit or otherwise affected by Hurricane Irma.

That includes assembling emergency kits and securing outdoor items like lawn furniture, grills, garbage cans, toys and garden tools that can fly in strong winds. Inside, turn the refrigerator and freezer to their coldest settings. Store

drinking water in clean jugs and bottles. Store valuables and personal papers in a waterproof container on the highest level of your home.

An emergency kit should include at least a gallon of bottled water per person per day for three days; canned or packaged food for three days; blankets/sleeping bags; a first aid kit; a non-electric can opener; toiletries; essential medicines; special items for infant, elderly or disabled family members; a battery-operat-

ed portable radio; flashlights; extra batteries; a corded telephone; cash and credit cards; pet supplies; and sturdy shoes.

Also consider filling your vehicle with gas in case you need to leave. Learn your evacuation routes and have a plan for where you can stay. If you aren't in an evacuation area, get supplies in case you are flooded or there are blocked roads. Make a family emergency communication plan. If you have pets, you will need a hurricane plan for them as well.

Northampton Finance Director Reportedly Offered Position in Alabama

Northampton County Finance Director John Andrzejewski may be leaving his position to become the chief financial officer for Decatur, Ala., a city of approximately 55,000 residents, or about 4.5 times the population of Northampton.

According to a report on decaturndaily.com, Andrzejewski interviewed for the position last Thursday, Aug. 31, and the Decatur city council decided at its Tuesday work session to make him an offer. He was one of three candidates on the council's short list, narrowed from 27 total applicants for a position which has remained unfilled since 2009, when the city's previous CFO was fired.

Though Andrzejewski has no previous municipal experience, Decatur city council voted for him 3-1 based on his leadership skills, members said. Prior to his last two years as finance director in Northampton County, Andrzejewski spent 22 years working in

finance at the Department of Homeland Security, for FEMA (Federal Emergency Management Agency) and ICE (Immigration and Customs Enforcement).

Andrzejewski has a bachelor's degree in management/economics from the U.S. Coast Guard Academy, a master's degree in financial management

from the Naval Postgraduate School, and a certificate in contract management and administration from the University of Virginia.

He requested a minimum salary of \$90,000, less than the \$97,920 he reported making annually in Northampton County.

Andrzejewski did not answer or

return any phone calls to comment on the job offer. Northampton County Administrator Charles Kolakowski said he was "not aware" of any plans by Andrzejewski to relocate to Decatur. Northampton County Deputy Administrator Janice Williams said she would not comment on the matter.

To Avoid Speeding Tickets, Know the Law

There are two types of speeders – those who wantonly whiz past the warning signs, and the well-meaning, who unwittingly wind up with tickets. Ignorance of the law is no excuse, and neither is blaming speed traps, so here are some tips to help otherwise law-abiding citizens stay out of trouble on the road.

Research suggests that motorists make dozens of driving decisions for every mile they travel. Reacting immediately to information on road signs generally helps drivers make better decisions behind the wheel, when every second counts. However, drivers should temper their reaction when observing a road sign indicating a raised speed limit.

Speed limit signs “shall be located at the points of change from one speed limit to another,” according to Section 2B.13 of the Manual on Uniform Traffic Control Devices, an official document from the Federal Highway Ad-

ministration of the United States Department of Transportation, concerning traffic signs, signals, and road surface markings.

The statement suggests that speed limits change at the exact location of the signs, not when the sign becomes visible. Northampton County Sheriff David Doughty agreed a speed limit “starts where the sign is.”

Do not begin accelerating when approaching an increased speed limit zone if doing so causes you to exceed the current speed limit. A driver traveling in a 35 mph zone who sees a sign ahead indicating a 55 mph zone may not begin accelerating beyond 35 mph until reaching or passing the sign.

When approaching a reduced speed zone, brake if necessary to achieve the new speed limit before reaching the sign. Doughty warns in Cape Charles, for example, the speed limit “goes from 55 down to 25 ... you could let off the gas and not be to the limit in time.”

Though speed limit enforcement is “up to the individual officer, at their discretion,” Doughty said, he is “not aware of anything in the (Virginia) code for a grace period ... where you can accelerate up to the (oncoming) speed limit.”

Virginia enforces speed limits on an absolute basis, as does 75 percent of the United States. A driver is in violation when exceeding the speed limit by as little as one mile per hour. A violation for such an offense may be issued at the discretion of law enforcement.

Some states, like Texas, enforce speed limits on a presumptive or “prema facie” basis. A driver who receives a speeding violation in Texas may argue in court that his speed was safe based on conditions like traffic flow and weather, and the judge may dismiss his ticket. No such provision exists in Virginia law.

Drivers traveling sections of roads

with fluctuating speed limits should be particularly vigilant, as any Virginia motorist exceeding the speed limit by 20 mph or more is automatically charged with reckless driving. The law also states that any person driving “at a speed or in a manner so as to endanger the life, limb, or property of any person shall be guilty of reckless driving ... irrespective of the maximum speeds permitted by law.” A police officer can charge a motorist with reckless driving if he deems the driver's speed or actions as dangerous, regardless of the posted speed limit.

When no speed limit is posted, statutory speed limits are effective, established by state legislators based on road type and land use area. Virginia statutory speed limits are 25 mph for business and residential areas and 55 mph for secondary roads.

Doughty advises, “Observe whatever the speed limit is ... try to manage your speed according to what the signs are.”

Riverside's Closing Rehab Center Rated 4 out of 5 Stars by Medicare

Riverside Shore Rehabilitation Center, also known as the Parksley nursing home, got an above average overall rating on the medicare.gov website with 4 out of 5 stars. It got average ratings or 3 stars for staffing and quality measures when it was assessed in December 2016.

The facility, which has the legal name of Shore Lifecare Inc., is owned by Riverside Health Systems, and is slated to close in October because the age and condition of the nursing home, erected in 1967, "leaves us open to risk of potential emergency evacuation in the future," according to Riverside administrators.

The December report was the most recent one regarding the Riverside facility that has been released to the public. A survey that was done in July 2017 cited the nursing home for not putting enough signs out warning residents to refrain from drinking water from sinks and fountains. The well pump was replaced and testing had not, at that time, shown the water was safe for consumption. At press time, that report had not been completed. It will not become public information un-

til it is.

The December survey noted 5 deficiencies compared to the Virginia average of 8.9 and the national 7.3 average. The report included a deficiency for "Quality Care" that was listed as 3 on a scale of 1 to 4 and titled, "actual harm."

There were 2 deficiencies for resident rights. "Inspectors determined that the nursing home failed to keep each resident's personal and medical records private and confidential" (rated 2 for causing minimal harm or potential for actual harm) and failed to "allow residents to easily view the results of the nursing home's most recent survey," (rated 1 for potential for minimal harm.)

There was 1 environmental deficiency (rated 2 for causing minimal harm or potential for actual harm) listed because the facility "failed to have a program that investigates, controls and keeps infection from spreading."

"Inspectors determined that the nursing home failed to safely provide drugs and other similar products available, which are needed every day and in emergencies, by a licensed pharmacist." That

was rated 2.

No resident assessment, nutrition and dietary, or administration deficiencies were found during that visit.

Staffing got an overall rating of 4 stars, which is above average. The average number of residents was 103 compared to 96.9 for the state and 85.6 for the country. The total number of licensed nurse staff hours per resident per day was 1 hour and 39 minutes compared to 1 hour and 52 minutes for the state and 1 hour and 41 minutes nationally. Registered nurse (RN) hours per resident per day was 46 minutes, the same as the state average. The national average was 50. They were rated 4 stars or above average.

LPN/LVN hours per resident per day was an average of 53 minutes at the Riverside facility compared to 1 hour and 5 minutes for the state and 51 minutes nationally. Certified Nursing Assistant hours per resident per day was an average of 1 hour and 57 minutes compared to 2 hours and 16 minutes for the state and 2 hours and 27 minutes nationally. Physical therapy staff hours per resident per day was an average of 3 minutes for


the local facility, 7 minutes for the state and 6 minutes nationally.

"RNs are licensed healthcare professionals who are responsible for the coordination, management and overall delivery of care to the residents," the assessment stated. "Some nursing home residents who are sicker than others may require a greater level of care, and nursing homes that have more RN staff may be better able to meet the needs of those residents."

The quality of residential care was listed as above average or 4 stars and involved two categories, short-stay and long-stay residents.

Of the short stay, 74.2 percent "improved in their ability to move around on their own" at the Parksley facility compared to 68 percent for the state and 65.5 percent nationally. The percentage who were re-hospitalized after a nursing home admission was 21.3 at Parksley, 21 for the state and 21.1 nationally. More than 18 percent at Parksley "had an outpatient emergency department visit" compared to nearly 12 percent of the state and national nursing home residents. More

residents “were successfully discharged to the community” compared to 60.3 percent statewide and 57 percent nationally. The percentage of short-stay residents who report moderate to severe pain was 7.5 percent at Parksley compared to nearly 15 percent statewide and nationally. The percentage with “pressure ulcers that are new or worsened” was 2.3 percent at Parksley and 1 percent statewide and nationally.

More than 93 percent of the Parksley residents, who needed it, got a flu shot for the current flu season, compared to 82.3 percent statewide and 80.2 percent nationally. Nearly 90 percent got a pneumonia vaccine compared to 84.6 percent statewide and 82.5 percent nationally. Those who newly got an antipsychotic medication were 2.8 percent in Parksley compared to 1.8 percent statewide and 2 percent nationally.

For long stay residents, there were 1.4 percent at Parksley “experiencing one or more falls with major injury” compared to 3.5 percent for state and 3.4 percent for national. Riverside had .9 percent with a urinary tract infection compared to 4.6 percent for the state and 4 percent nationally. Residents “who report moderate to severe pain” were 1.3 percent at Parksley compared to 7.2 percent in Virginia

and 6.3 percent nationally.

“High risk residents with pressure ulcers” were 11.2 percent for Parksley, 6 percent for Virginia and 5.7 percent for the country. The percentage of “low-risk residents who lose control of their bowels or bladder” is 35.5 percent for Parksley, 53.3 percent for Virginia and 47.4 for the U. S. In Parksley, 1.2 percent of resident have/had a catheter inserted and left in their bladder, while 1.6 percent were reported statewide and 2.2 percent nationally.

None of the long-stay residents at Parksley were physically restrained, while .5 percent were statewide and nationally. Those whose “ability to move independently worsened” were 19.1 percent in Parksley, 20.6 percent statewide and 18.3 percent nationally.

Residents who need help with daily activities were 22.5 percent in Parksley, 16.3 percent statewide and 15.1 percent nationally. The percentage of residents who lose too much weight were 11.8 percent at Parksley, 7.6 percent statewide and 7.1 percent nationally.

None of the residents at Parksley showed symptoms of depression while 2.7 percent statewide and 5.1 percent nationally did. Those who got anti-anxiety or hypnotic medication was 23.4 percent for Parksley and

statewide and 23.1 percent for nationally. Nearly 98 percent got a flu shot for the current season at Parksley. The state showed 94.6 percent while the national average was 94.7 percent. All of the Parksley residents had pneumonia shots while 93.6 percent got them statewide and 93.9 was the national figure. The percentage of residents who got antipsychotic medication was 17.7 percent at Parksley, 15.8 percent for Virginia and 16.1 percent in U. S. facilities.

The Riverside home did not receive any fines in the last three years or have any payment denials by Medicare during that period.

In the past three years, there were six complaints and facility reported incidents, all of which were reported as affecting “few residents.”

There was an obvious mistake in the dates of the first listing. It stated that the facility “failed to provide necessary care and services to maintain the highest well being of each resident” when it was inspected on Dec. 1, 2016, and that the issue was corrected Oct. 5, 2016. It was listed as a Level 3 with “actual harm.”

The nursing home also “failed” on that date “to safely provide drugs and other similar products, ... which are needed every day and in emergencies, by a licensed pharmacist.” That was listed as a Level 2

issue and was corrected on Jan. 6, 2017.

On Oct. 9, 2014, the facility “failed to give or get specialized rehabilitative services per patients assessment or plan of care”; “failed to make sure each resident receives an accurate assessment by a qualified health professional”; “failed to develop a complete care plan that meets all of a resident's needs, with timetables and actions that can be measured”; and “failed to reasonably accommodate the needs and preferences of each resident.” All were listed as Level 2 infractions that were corrected on Nov. 21, 2014.

Riverside announced in August it would close the facility in October. A task force set up by the county was to have met this week, but according to County Administrator Mike Mason, the meeting was canceled “pending the outcome of discussions between Riverside and county officials which [are] ongoing at this time.”

The corporation status of Riverside Hermitage Inc. was renewed Aug. 31, 2017. It was formed the previous August when Riverside and the private Onancock home, Hermitage of the Eastern Shore, were talking because Riverside wanted to close the Parksley facility and Hermitage needed to up its resident numbers. The mix would have required Medicaid coverage and was put on hold.

Man Accused In PNC Plot Pleads Guilty to Assault and Battery of Officer

A Norfolk man will not stand trial for the 2016 attempted capital murder of Accomack Deputy Eric Nottingham and related firearms offenses in accordance with a bargain that was struck last week with Commonwealth's Attorney Spencer Morgan.

Instead, Lamont Perry, 23, of Marshall Avenue, pleaded guilty to assault and battery of Nottingham and felony eluding. Morgan made no promises for sentencing. Perry is being held in Accomack Jail pending completion of a presentence report. In addition to the murder charge, the defendant was initially accused of using a firearm in a felony, discharging a firearm from a vehicle and shooting at an occupied police car.

Deandre Breshon Ayers, 28, of Hanson Avenue, in Norfolk, previously of Painter, was indicted for the same offenses and a count of possession of a firearm and is awaiting trial

after being convicted of a felony within the last 10 years.

Maryland officers were investigating a robbery at the PNC Bank in Pocomoke at about 2 p.m. on Sept. 26, 2016. Authorities said three people threatened to blow up the bank, but did not display weapons or explosive devices to tellers. Afterward, they were seen running toward the 6th Street Car Wash and getting into a silver Chevy Malibu with a Virginia tag. Nottingham got the alert and saw the vehicle near Temperanceville. He followed and when it ran a stop sign, he attempted to pull the car over.

"The vehicle was acting like it was stopping," Nottingham said. It rolled to about five to 10 mph "and then floored it and went up to 80 to 90 mph." The deputy said the car suddenly jammed on the brakes. That's when he saw an arm come out of the driver's window with a gun pointed towards him.

"It started popping off," he said. "I heard metal clanking around. I just heard a whole bunch of shots." Nottingham put the squad car in reverse and the Malibu took off again. The deputy tried to chase it but his car quit running. "Three bullets struck my vehicle, one of them hit the transmission cord," he continued.

Man Who Likely Swallowed Drugs To Avoid Charges Sentenced

A Lynchburg man who likely swallowed illegal drugs so he wouldn't get caught with them in 2016 and then "began throwing up a foamy white substance" after arrest, was sentenced to a total of 22 years with all but two years and seven months was suspended for a variety of offenses.

Kerry Dewitt Martin, 26, of Early Street, was given a 12-month suspended sentence each for having a concealed weapon and possessing marijuana. For possession of a firearm by a felon, he was sentenced to five years with all but a year suspended. He was given five years with all but four months suspended and five years with all but three months suspended for the two counts of possession of a Schedule I or II drug. Martin was also sentenced to five years with all but a year suspended for possession of a firearm while in possession of a Schedule I or II drug.

Rontari Malik Warren, 23, of Diamond Road in Birdsnest, pleaded guilty to two counts of credit card theft

and three counts of credit card fraud in connection with February 2017 incidents. The case was continued until a presentence report could be made.

No Bail for New Church Man

A young New Church man is being held without bail in the county jail after being charged with several felonies, according to records filed in Accomack General District Court.

Timothy Vanhart, 20, of Taylor Farm Road, is accused of knowingly possessing or transporting a firearm by a felon convicted in the last 10 years on Aug. 25; and stealing property valued at more than \$200 belonging to Herman Chesser and burglary on Aug. 16 and 18. Deputy M. R. McCready of the Accomack County Sheriff's Office (ACSO) investigated. Vanhart was arrested on Sept. 3.

In another case, Vincent Lavette Stoudmire, 18, with addresses of Logan Road in Onley, and Bethel Church Road in Bloxom, was charged with robbing a pizza delivery worker of cash and food at gunpoint on June 18. He is being held in Accomack Jail without bond. Investigator C.A. McPherson of ACSO handled the case.

we're pitting us against the volunteer fire company ... they save us money in the long run. We'll go back and look at facts and figures and everything else," he said.

"Taxpayers need to know where the money is coming from," said Vice Mayor Denise Bowden, who is also a fire department member. "I don't feel like this is any kind of grudge match."

"About six years ago, my husband started having a lot of problems," islander Peggy Thomas reported when speaking during the public participation portion of the session. The rescue squad came many times. "I never received a bill from them at all." Three weeks ago she said, she needed assistance. "Dial 9-1-1 (and) here they come ... this island better stick with that fire company ... property on Cropper Street — Give it to them. Let them have it," Thomas said.

Another woman said she and a neighbor would purchase the property after the fire company finishes its new fire house if "that is ever an alternative. I don't believe it ever was a part of the two parcels (owned by her and the neighbor). Both are zoned as commercial. It would help to have additional parking for us. If the property does become a parking lot (public) we ask that there is a very secure fence" to keep people out of her yard.

"I want the fire company to know as long as I have breath in my body, you have my support," Council Gene Taylor said. "I sincerely pray that storm, (Hurricane Irma) doesn't hurt anybody." All the volunteer firefighters will be the ones helping islanders if the hurricane comes, he reminded attendees. "We're a recreational community now," Taylor continued. "You can't do that as a volunteer system ... Our town has grown ... We have stepped up. We're all stretched thin. But, if we continue to work together, it still works."

"No doubt about it, we support the fire company," said Frese. But, he said there is also a need to take an "unbiased look at our situations in everything. It may be that we're asking too much of the volunteers. We may have to go into a part volunteer system. It's overwhelming. I commend them. I couldn't do it ... fire and EMS minutes are critical. We have to come up with something that isn't

going to kill our volunteers." However, he also stated, "We've got to get the facts on the table. This is what is in our books ... in excess of \$700,000" for EMS. "The age of the volunteer fire company keeps going up ... I do not think personally that we are going to forever be able to rely on volunteers ... prepare for the future... it was not meant to be a fight. It was just a statement of facts ... we want to make sure we are doing our due diligence."

Nancy Payne of Circle Drive had suggestions for plans to spend a \$1.5 million grant to improve Maddox Boulevard for pedestrians and bicyclists. A public hearing is scheduled for 5 p.m., Sept. 20, but Payne will not be able to attend.

"I suggest you remove all street parking on Maddox Boulevard," she said. "No need to park on the street ... all have parking spaces who live there ... by doing this, less congestion and safer for all ... Change the traffic pattern," she continued. For that Payne suggested making Maddox a one way street with Ocean Boulevard going the other way. "You need to spread this traffic out. It's very inexpensive ... making it more pleasant on that street."

Bowden reported for the parks and recreation committee. She said they will continue to discuss the possibility of a town pool as a joint venture with the YMCA but the cost of \$2 million is an issue. No decision has been made about a dog park. Bowden said that will also continue to be discussed at a meeting at 5 p.m., Sept. 12.

In the end, Leonard said, "Congratulations to all the Chincoteaguers! We made it. After Labor Day we can go back to being ourselves. Be a friendly little town again. It's amazing how after one day the streets revert back to what we're used to. We're happy to see them come and we're happy to see them go."

The New GI Bill

Last month, President Trump signed into law the Harry W. Colmery Veterans Educational Assistance Act, also known as the “Forever GI Bill,” which is the first change to the GI Bill since the introduction of the Post 9/11 GI Bill. The GI Bill was named after WWI Veteran and American Legion National Commander (1936-1937) Harry Walter Colmery. Colmery is remembered for writing the blueprint of the GI Bill on hotel stationery that would later be adopted as the GI Bill of Rights, which has enabled hundreds of millions of veterans to earn college degrees since its inception. According to the Department of Veterans Affairs (VA), several of the new changes will go in to effect immediately, while others will go shortly after. Here are some of the more important provisions now in effect.

sions now in effect.

A major change is the elimination of the 15-year utilization time period. Under the Post-9/11 GI Bill, veterans had up to 15 years to take advantage of their education benefits. Under the new signed bill, those veterans who left active duty on or after Jan. 1, 2013, are no longer bound to a finite period to use their benefit, hence, the “Forever GI Bill.”

Another important piece is that reservists who were eligible under the Reserve Educational Assistance Program (REAP) and lost their eligibility due to congressional repeal of the program will have that service credited toward the Post-9/11 GI Bill program.

Work-study opportunities for veterans in the past had to be approved every few years. Under the new GI Bill certain work-study positions are permanently authorized.

The VetSuccess on Campus pro-

gram has been around for several years, and now it will be available to students across the country. The program provides on-campus vocational rehabilitation and employment service support to transitional service members and veterans with their transition from military to higher education followed by support and assistance needed to pursue their educational and employment goals.

Another change is the addition of provision of information on priority enrollment for veterans in certain courses of education. The VA will help veterans to identify schools that offer them priority enrollment which allows veterans to enroll in courses earlier than other students attending the school.

Lastly, under the new GI Bill, eligible veterans or dependents are authorized to

use the Post-9/11 GI Bill to pursue accredited independent study programs at career and technical colleges or vocational schools.

It's important to note that many of the changes improve or expand education benefits for veterans, service members, Families and Survivors moving forward. However, limitations set in place under the Post 9/11 GI Bill prior to August 2017 are still in effect. It is recommended that if you are entitled to VA education benefits and you are approaching your 15-year mark, to contact the VA to verify how much time you have left. 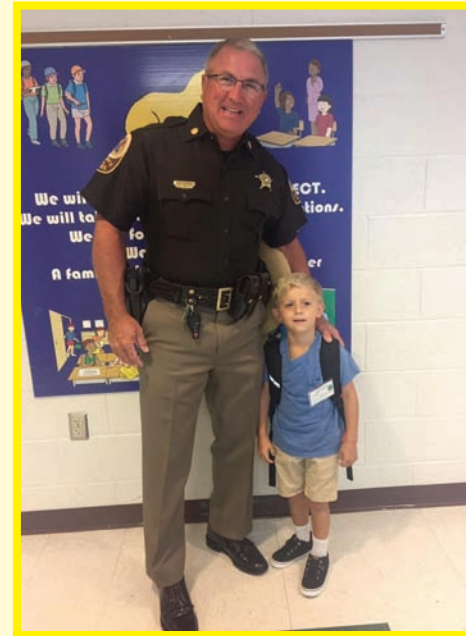


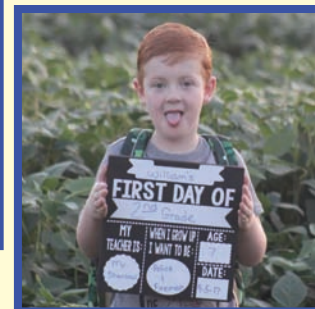

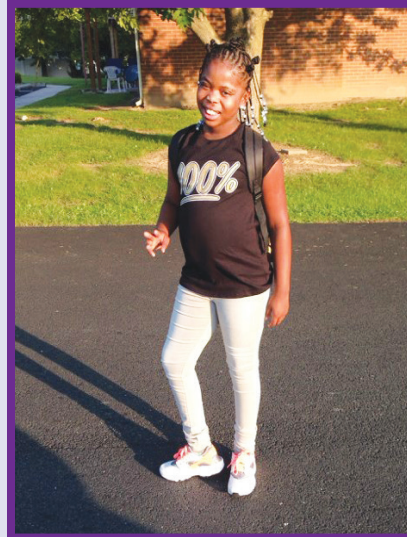

School Daze: Post Readers Gaze Into the Past

When Accomack and Northampton kids went back to classes Tuesday, Eastern Shore grown-ups fondly reminisced about their long ago school days and former lives and how things were a lot different for them.

Nearly 60 percent said today's youth have it easier. About 15 percent said it's harder these days for children and the rest struggled between the two responses.

"Are you kidding me?" Bruce MacMaster Jr. of Onley responded to an email survey conducted this week by the Eastern Shore Post. "Early 40s, even in South America, where I grew up, the war effort was perceived. We had to manufacture our own baseballs and bats (and) that's just for starters. Homework was supervised ... Mom's network of spies was better than any CIA or NSA would ever dream of. We were prohibited from going swimming. Mom would taste our hair ... for salt ... if positive you would get at least a spanking. We had weekly report cards. One or two points less than perfect and your weekend was doomed. School schedule was from 7 a.m. to 4 p.m. with two hours for lunch. Saturdays were report card day from 7 a.m. to 11 a.m. (and) Sundays, Mass with the school, from 7 a.m. to 11 a.m. Like I said, 'Are you kidding me?'"

Richard McDowell, of Pungoteague, called today's youth "damn snowflakes." He further made his point by saying, he "mostly" looked forward to going back to school to get a break. "Dad kept me working in summer."

About 85 percent of the survey participants were excited to go back to school. They were either self-proclaimed "nerds," who just loved it, or social butterflies, who only cared about seeing their friends.

MacMaster was among the other 15 percent. "No," he replied. "I wanted to work."

The best loved subjects in school were also among the most dreaded. English rated the favorite of about 35 percent with math in second place with nearly 30 percent. But for worst, math and history tied with 31 percent each.

McDowell said his worst was algebra. "But in USAF tech school at 30, when it had applications to do a job, I aced it."

Artima Taylor-Thornton, of Accomac reported the best thing she did this summer was go on vacation to Ocean City, Md. "We were able to take the children to the fire truck parade. We also went to the boardwalk and took the children to different museums in Ocean City." She agreed kids have it "much easier" today then when she was a student.

Amy Eckard, of Temperanceville, said kids have it both harder and easier. "Easier because a lot is handed to them. Many don't really work for what they want, although some do. Harder because of technology. They have to deal with online bullying and misinformation."

Bill Payne, of Cape Charles, told about his summer trip to Atlanta for Rotary's International Convention. "Two fellow Rotarians and I drove there and back. We met with over 50,000 Rotarians from over 100 countries. It was the Rotary Foundation's 100th anniversary."

"It seems nothing is easier for this generation's youngsters," said Payne. "It is harder to get a good education and then buy a home." He looked forward to going to school. "I knew I needed an education."

Jane Silveria, of Florida, a Chincoteague native, traveled during the summer. "I went to Devil's Tower, Wyoming, and visited the Badlands, Custer State Park and Mount Rushmore in South Dakota. There is a lot of beautiful country out there."

She says kids have it harder today.

"Stress is way too much for such young and tender minds," Silveria stated.

"I think, in a way, they have it easier because they have so many aids to help them with their studies — computers, calculators, etc.," wrote Shirley Christian, of Melfa. "Half the time, they don't even have to think. However, I don't

think they enjoy being kids as we did during our childhood. We actually got outside, ran around, played."

She looked forward to going to school. "Got to get back with all our friends," Christian said. Her best subjects were math and spelling. "I really didn't have a worst, but, I didn't care for history."

Krystle Bono, of Machipongo, went to Oklahoma City this summer so her daughter, Isabella, could compete in Youth Nationals, horseback riding.

She says kids have it easier these days. "There are so many places that are willing to hire seasonal kids looking for summer work ... I loved school up until I started getting a lot of homework and tests, haha! ... My worst was math. I was terrible, but somehow always got in the advanced level classes, so it was always my least favorite subject."

Evan Clements, of Onancock, said he "enjoyed sitting on our porches and in our gazebo watching the sunrises, the sounds of the birds, enjoying morning coffee, and watching the many humming birds and geese flying over" this summer. He "mostly stayed home as home is our vacation spot."

Kids have it neither harder nor easier, Clements said. "It is just different and too many do not appreciate what life is all about ... I was not a very good student until after dealing with cancer

in my sophomore year in high school. I survived and my outlook changed dramatically, loving school then and went on to nursing school and a plus-20 year career! I loved history, science classes, and geometry. I hated algebra and Latin, but benefited with Latin when I got to nursing school."

Judy Brunk, of Jamesville, said the best thing she did this summer was "just the usual enjoying every day life on the Shore." Brunk said kids have it "a lot easier but not as much freedom and childhood enjoyment as my generation."

She was ready to go back to class "because I loved school and books and learning. Art and English were best. A class called Modern Problems was worst mostly because of the teacher. She was the one that made me realize that even teachers could be unfair and wrong at times. They don't always treat all students equally. You always remember your best teacher as well as your worst."

Denise Bowden, of Chincoteague, spent time with her mother this summer who visited during Pony Penning. She didn't venture far this year — "too busy working."

Kids today have it "Too easy. Some seem to get everything handed to them and they expect it!"

"Yes and no," Bowden said about liking school. "Playing sports in high school made me like school more. My best were History and English and my worst were Math and Science. Sorry Mr. Jeffries!"

The best thing Angie H. Crutchley, of Exmore, did this summer was "get to see my nieces and nephews a couple of times," she said. "Yesssss!" she looked forward to the first day of classes. "I was a dorky nerd and I loved school! I just wanted my name to be first on any given list! ... English was best and any form of math was worst."

Regarding kids today, Crutchley said, "I've heard every generation since I've been alive say the kids these days have it easier. I don't want to be a cliché. I would instead say that their lives are different. That may or may not affect ease of life."

EMPLOYEE OF THE MONTH AFTER 50 YEARS

Bailey's Bait and Tackle Shop in Cape Charles recently made a playful announcement in church: Lola Bailey had been made "Employee of the Month," the first time she had received that honor since starting with the business 50 years ago. Since Lola and her husband Emmett had founded the business, everyone had a chuckle, but it caused everyone to think about how Cape Charles has changed over the last 50 years. Today, there are only a handful of family-owned businesses left.

In the late 1960s, the couple had an idea for a small business that would provide the local fisherman with what was missing in Cape Charles — a fishing tackle and bait shop. Emmett was originally from Richmond, but married and moved to Cape Charles in 1955, just when the town was winding down from

the loss of the Chesapeake Bay Ferries and ultimately, the Pennsylvania Railroad. He loved to fish, and spent many hours black drum and cobia fishing with his buddies. Bailey saw a need for quality fishing equipment, fresh bait and good service, and he also thought he might offer other sporting equipment, like bats and balls, but the more he thought about it and discussed it, he realized that the real need was for fishing equipment.

By 1967, he decided to get serious about it and started carrying a small amount of stock, selling it from the front porch of their house on Mason Avenue. By the early 1970s, he had added an addition to the house, just to house his ever-growing inventory and customers.

Once the word got around (and this was before the internet), fishermen from all over the country were coming to Bailey's Bait and Tackle Shop. Sports writers

from Washington, Richmond, Baltimore and other cities would call to get the "fishing report." Charter captains would stop in frequently since the tackle shop was an official weighing station for the Virginia Salt Water Fishing Tournament.

It was not unusual to hear a knock at the door at 10 or 11 p.m. with someone who had just come in and had caught the "big one" to be weighed.

Emmett and Lola would drag out of bed to accommodate them, knowing how important that fish was to that person. Sometimes traffic on Mason Avenue would be backed up waiting for fishermen to get their fish off their boats and drag them up to be weighed. Black drum especially were plentiful during this time, weighing 50-75 lbs. each. There were just as many spectators as there were fishermen.

In 1987, Emmett and Lola decided to

semi-retire and close the business. There was still a demand for tackle and bait, so their daughter and her husband took over the business. Marie and Donnie Brady moved the shop downtown to its current location on Mason Avenue and kept the business going. Emmett and Lola continued to help out until Emmett's death in 2011. Lola still works, waiting on customers and giving information.

With the addition of Jeb Brady, who is the grandson of Emmett and Lola, his wife Marie and great-grandson Seth Johnson filling in during the summer, it is a family business with four generations working together. Unbelievably, there are still customers who come in and ask for Mr. Bailey, and describe how they came to the shop when it was in its original location. Bailey's Bait and Tackle has become a Cape Charles institution.

Fishing from the Shore

It's starting to sound like a broken record, but the weather, specifically the winds and rain, has played havoc with both the anglers' access to the productive fishing areas as well as the anglers' success once they get there. Unfortunately, next week's weather is not looking too sporty either as all eyes are focused on the potential effects presented by Hurricane Irma. Based on some of the storm's projected path scenarios, fishing may be the least of most people's worries.

Hopefully, the weather will settle down in time for next week's scheduled 27th Annual Onancock Bay Challenge Fishing Tournament on Sept. 16. Eight different bay species will be eligible for first- and second-place catches in both adult and youth divisions. For more information, log on to www.esanglersclub.org or call 757-709-8697.

Here's what's been biting this week.

Lower Shore – Chris' Bait and Tackle weighed in two large flounder on Monday, the largest exceeding eight pounds. Both fish were caught along the Chesapeake Bay Bridge-Tunnel. Chris also reported that a sizable population of sea mullet, aka kingfish, and whiting remain off Kiptopeke, where a late push of the croaker run has also been occurring. Catches (and releases) of large red drum have continued to be made in between the blows over the Inner Middle and Nautilus Shoals. As predicted, the cobia run has slowed substantially, but a few fish were caught last weekend and into the early part of this week. Spadefish are still hanging over the fourth island tube and around the rock island, but their time here will be limited before they begin their migration east and south. Expect the triggerfish to stay here a few weeks after the spades leave.

Upper Chesapeake Bay – The run of speckled trout has been a little bit of a disappointment over the last week after what looked to be a good start to the early autumn run. The inconsistent and unset-

tled weather may be the culprit responsible for the fish's lockjaw. Fortunately, the appearance of bluefish in the 14- to 22-inch class as well as a decent population of rockfish are providing steady action in the bayside shallows. The bluefish have been a bane to the serious speckled trout angler, but to others any action is better than no action at all. Some of the bluefish have approached three pounds and most of the rockfish have started exceeding 18 inches.

Chincoteague – Flounder fishing inside the inlet has slowed down to a trickle and what flounder being caught are not meeting the 17-inch minimum. Undersized black sea bass, affectionately known as "black wills," have become the consumer of most baits intended for flounder. Small snapper bluefish have provided most anglers with their best chance of catching and taking home a legal-sized fish. For keeper flounder, the offshore wrecks have been the only reliable source. Limit catches came from the rail cars on Labor Day. A few gray trout have also been encountered on the near-shore wrecks and have been a welcome by-catch. There is a one fish per person limit for gray trout. One fishery that has not been affected by the weather has been the inshore shark fishery and local fishing guides are keeping their out-of-state clients happy with picture-worthy shark catches. Surf anglers are finding spot, small bluefish, sharks and rays, while the offshore wrecks are still holding keeper black sea bass.

Wachapreague – Like the inshore fishery of Chincoteague to the north, the flounder fishing inside the Wachapreague Inlet can be described as poor at best, with the overwhelming portion of the flounder caught not meeting the minimum size limit for a keeper fish. Offshore fishing has been more productive with charter vessels finding a few yellowfin tuna and lots of false albacore trolling in the vicinity of Sam's Hill.

Bill Hall was the first Eastern Shore resident to achieve Virginia Salt Water Master Angler Status. He has been named Virginia Saltwater Angler of the Year and Virginia Saltwater Release Angler of the Year. Bill is an I.G.F.A. International Committee Representative and a long-

time member of the Virginia Saltwater Fishing Tournament Committee. He is the Virginia Recreation Fishing representative on the ASMFC Striped Bass Management Panel and is a past recipient of the CCA-VA Virginia Outdoor Writer Conservation Leadership Award.

A Weekend of Contrasts

Saturday will be a day of contrasts, with a 9/11 Tribute in the morning to honor and memorialize the best of human nature, and a Plein Air Art Show in the evening to showcase the best of Mother Nature.

Sept. 9 begins with the tribute sponsored by the Navy's Morale, Welfare and Recreation program, at the KOA campground (formerly Maddox Family Campground) on Chincoteague.

"9/11 means a lot to me because I lost a lot of brothers and sisters that day," said Program Director Nicholas Hewitt, "and I personally love my country and all the people in it." Hewitt is a disabled veteran who served in the U.S. Marine Corps.

The free event is intended to be a way for parents to teach children about 9/11. For instance, the "almost 1K" will be signed with a timeline so parents can help children understand how the day of 9/11 unfolded, and so the family can together experience "a renewed sense of the sacrifice some have made for our freedom," Hewitt said.

An 8 a.m. opening ceremony and benediction kicks off the event. The "Almost 1K" Walk/Run at 9:11 a.m. will consist of a 2,996-foot course (representing one foot for everyone lost on 9/11/01). Kanjam and cornhole tournaments, and other family competitions and activities start at 11 a.m. (Kanjam is a frisbee-like game where discs are tossed at a large can target.) Awards and the closing ceremony are slated for 1 p.m., along with a bottle rocket launch by Virginia Space Academy. Kids who want to build their own rockets are asked to bring two empty two-liter soda bottles.

Food trucks will be on-site and the Tiki Bar Band will provide entertainment. Free T-shirts will be given to the first 200 event participants. But Hewitt hopes that's not all they will leave with.

"When people walk away from this event, my sincerest hope is that they have a renewed sense of how great our country is and a deeper sense of what it means to be an American."

The 9/11 tribute will wrap up in plenty of time to re-group for the Chincoteague Cultural Alliance's 14th Annual Plein Air Show, Reception, and Sale from 6 to 9 p.m. at Christ United Methodist Church Social Hall. The works of 54 artists, some nationally known, will be featured outdoors on Chincoteague and Assateague Islands earlier in the week. Admission, parking and refreshments are free.

Linda Epstein, one of the participating artists, has been drawing and painting since her childhood in Cape Cod, Mass. Her works have been exhibited in galleries and art shows since the mid-1990s. Eleven years ago, Epstein moved to the Eastern Shore and three years ago she opened her studio gallery, Bad Ponies, on Cleveland Street on Chincoteague.

Painting "en plein air," French for "outside," is something she especially enjoys. "So much of it is about the light," she said. "You have to paint quickly before the light changes." She likes occasions like CCA's annual Plein Air Event because it is "a focused time where you have to deal with whatever the weather throws at you." In bad weather, Epstein has painted from the front seat of her car, capturing the scene in between swipes of the windshield wipers, and on nicer days she has painted from a kayak.

The Sept. 9 show will include artists from 10 states and the District of Columbia.

Co-coordinator Nancy West reminds art enthusiasts that "our Plein Air Show is so popular that art lovers line up to be first inside when we unlock the doors. To get the best selection of artworks available for sale, come early."

The Chincoteague Police Department's 13th Annual Poker Run for Kids will also be held Saturday. Proceeds will go toward the food bank, fuel assistance, pharmacy, athletics, scholarships and more. Registration and the first card will be available between 9 and 11 a.m. at Royal Farms on Wallops Is-

land with the last bike leaving at noon. Between 9:30 and noon, the second card can be picked up at Fins Ale House & Raw Bar in Berlin, Md.
