# A Conversation With Governor-Elect and Shore Native Ralph Northam

For Ralph Northam, the Sunday following the election was one of the most enjoyable days he has experienced in a long time.

Just off from a year of campaigning which culminated in his election as Virginia's next governor, Northam spent the day knocking around on his boyhood farm on Onancock Creek,

tinkering with two antique cars and visiting his 93-year-old father, now at the Hermitage in Onancock. He also checked out oyster grounds he owns with his brother Tom, a local attorney, who lives on the family farm. The two brothers restored a 1953 Oldsmobile when they were both teenagers.

Of that recent Sunday, Northam said from his Richmond office, "It was

a relaxing day that I had been looking forward to for a long time. I hope to get back to the Shore more often now that the election is over."

Northam says his Eastern Shore roots remain strong and he's proud to be only the second person from the Eastern Shore elected governor of Virginia. "In my office hangs a portrait of Henry Wise," says Northam.

"He was the first Eastern Shoreman to be elected governor of Virginia. I never dreamed when I learned that fact in school that I would be the second Eastern Shoreman to hold this office."

The road to the governor's office had some unusual twists for the 58-year-old, the second of two sons born to Wescott and Nancy Northam, but

# Norfolk Man Who Left on Raft Saturday Found in Machipongo Sunday

A good Samaritan from Machipongo made the call Sunday alerting authorities that a missing Norfolk man was found alive after he disappeared Saturday evening in a raft on the Chesapeake Bay.

The survivor, Wesley Schoonmaker, donned a full wetsuit, and planned Saturday, Nov. 18, to test out a new oar by paddling his blue and yellow raft into the Chesapeake Bay near Willoughby Spit in Norfolk. The Norfolk Police Department notified the Coast Guard at about 5 p.m. the 49-year-old man had gone missing.

Watchstanders in Portsmouth at the Sector Hampton Roads Command Center issued an urgent marine information broadcast and initiated search efforts that would take 33 hours and cover 1.438 miles.

The Coast Guard launched 45-foot, medium-crew response boats from Portsmouth and Little Creek stations. with the Cutter Mako diverting to join the search. Crews aboard an MH-60 Jayhawk helicopter and a C-130 Hercules aircraft were launched from the Elizabeth City, N.C., air station. Virginia Ma-

rine Police and other agencies searched throughout Saturday night into Sunday morning. Coast Guard stations Mitford Haven and Cape Charles also assisted.

Schoonmaker landed his raft on a Machipongo beach Sunday and walked into the backyard of a local resident, who called 911. Eastern Shore 911 dis-

patch and the Accomack County sheriff notified the Coast Guard that Schoonmaker had been found. He said his raft had been blown away from shore immediately after launching it. Schoonmaker drifted north all night until reaching Machipongo. He was found windburned, but in stable condition, and local EMS transported him to Riverside Shore Memorial Hospital in Onley.

Coast Guard Lt. j.g. Bradley Milliken, command duty officer at Sector Hampton Roads Command Center, said, "We appreciate the team effort from different agencies and stations during the search" for Schoonmaker. "We're glad he's okay."

### Saltwater Cowboy Wesley "Old Dad" **Bloxom Dies**

A saltwater cowboy, who for 57 years helped guide the famous herd of wild Chincoteague ponies across the slack waters of the Assateague Channel and up the streets to the carnival grounds during the volunteer fire company's Pony Penning every July, died Nov. 16, to the dismay of fellow firefighters, residents and visitors of the event.

"You all know him, Wesley (Old Dad) Bloxom, as one of our famous saltwater cowboys and have probably never seen him in dress uniform," said Chincoteague Vice Mayor Denise Bowden, a spokesperson for the fire company.

He "was one of a kind, a true cowboy

and a faithful member," she continued. "He passed on the love he had of the fire company and Pony Penning to his son, John Wesley Bloxom, who will carry on the traditions his father taught him."

"Wesley will be missed, everywhere," Bowden said. "On the dock during swim day, at the corral during roundups, at AJ's with his friends, at Don's on Sunday having chicken and dumplings. His spirit will live on in those who will carry the torch forward. Ride on cowboy, ride on."

The native of Chincoteague was 78 years old. Condolences came in for his family from across the country. A full obituary is on page 10.

friendly performances feature a wide range of music genres, including swing, jazz, blues, gospel, folk, country, rock, and disco. This summer's concerts were held outdoors at Central Park and indoors at the historic Palace Theatre.

Reportedly, 3,000 people attended the free Harbor for the Arts events, which served as a marketing tool for local real estate agents, and bed and breakfast and other business owners.

The cost of this year's Harbor for the Arts was around \$30,000. Combining \$5,000 in donations collected at the events, and grant funds Arts Enter received to put on the concert series, the organization broke even on the project.

Harbor for the Arts faces an uphill financial battle in 2018. To secure the return of this year's most popular bands, and to add new, high-caliber artists to next year's lineup, the event will cost about \$2,000 more. Arts Enter expects \$12,000 less in grants next year. The organization asked the town to give \$10,000 to Harbor for the Arts 2018, more than three times the \$3,000 it received in 2017.

Renata Sheppard, who runs another arts non-profit in Cape Charles, Experimental Film Virginia, asked the town for \$10,000 for that project when she met with council in September. She had asked for the same amount last year, and received \$5,000. Sheppard reported to council in September that visiting artists working on this summer's experimental films had spent \$30,000 in town on housing.

Carol Evans, of the Eastern Shore of Virginia Tourism Commission, said the number of visitors at the welcome center off the Chesapeake Bay Bridge-Tunnel has risen 20 percent. She guessed the increase was related to the closing of the gift shop, restaurant, and public fishing pier on the CBBT, due to construction of the new parallel tunnel.

### **Main Street**

Cape Charles bears the distinction of being the only town on the Eastern Shore participating in Virginia Main Street, a program of the Virginia Department of Housing and Community Development. The Main Street program offers services and assistance to towns revitalizing their historic commercial districts, allowing them to preserve their history while growing their community and economy.

Tammy Holloway, vice-chairman of

Cape Charles' community enhancement program, spoke about her recent experience at a "Virginia Main Street Regional Rev Up" conference in Ashland, Va. The town is applying for a Commercial District Affiliate grant in the maximum amount available, \$7,000. The application is due Dec. 1, and if approved, the grant will help pay for the services of a branding consultant, at between \$8,000 and \$20,000.

A request for proposal (RFP) will be prepared to seek the right consultant for the job. Council mentioned that developing Main Street communities generally follow a "template," and Holloway suggested, "I'm not sure we're a template kind of a place." She would like to see Cape Charles "break out of the box" among Main Street communities.

Holloway asked Mayor George Proto when council would address establishing a new non-profit for the Main Street project; he said it would likely happen in January.

Main Street affiliates may have the future opportunity to participate in the competitive application process to become Designated Virginia Main Street Communities. There are currently 25, which the Virginia DHCD promotes to potential visitors in its Virginia Main Street Travel Guide.

# Bi-County Planning District Commission Weighs In on Northampton Plan

The coexistence of residential, commercial, and roadway developments with land, coastlines, and water has long been a priority of many Eastern Shore residents. As the draft of Northampton's comprehensive plan continues to be developed by the county planning commission, citizens and stakeholders have cited a lack of plans supporting this priority.

In its own commentary, the Accomack-Northampton Planning District Commission said many of these plans have been created, but are not referenced in Northampton's draft comprehensive plan.

Citizens and stakeholders want to limit further commercialization of Route 13, in part to protect the Shore's sole source aquifer, the Columbia Yorktown-Eastover aquifer system. A report on hypothetical industrial withdrawal in Northampton County prepared by the Eastern Shore of Virginia Groundwater Committee confirms the Shore's "spine recharge area," where the fresh groundwater supply is most plentiful, "roughly coincides" with Route 13.

The A-NPDC's Groundwater Supply

Protection and Management Plan for the Eastern Shore and Northampton County Water Supply Plan detail plans to monitor groundwater use and manage existing and future land use. Land use management is necessary as more buildings and pavement create more "impermeable land cover," preventing rainfall from percolating the soil to recharge the aquifer, and creating more runoff and possible contamination. These plans, say the organization, should be referenced in the comprehensive plan's section on groundwater resources.

The Water Quality Implementation Plan for the Gulf, Barlow, Mattawoman, Jacobus, and Hungar Creeks and the Department of Environmental Quality's water quality information webpage both offer strategies for reducing waterway pollutants at the county, locality, and residential levels, and should be linked to the comprehensive plan in its section on water resources.

One issue that affects both Shore residents' quality of life and water quality in the Chesapeake Bay watershed is a lack of indoor plumbing, which may directly impact hundreds of people. The report, Indoor Plumbing Needs on the

Eastern Shore of Virginia, supported by the National Fish and Wildlife Foundation, should be referenced in the comprehensive plan's discussion of substandard housing. The study states over nine percent of occupied homes on the Shore lack complete indoor plumbing. "Hot spots," clusters of homes known or suspected to lack indoor plumbing, are targeted for needs assessment, and the study discusses funding options for assistance.

Socio-Economic Impacts of Conserved Land on Virginia's Eastern Shore, prepared for Virginia's Coastal Zone Management Program and Department of Environmental Quality (DEQ), should also be referenced. The document describes how land conservation positively affects the Shore's economy. In Northampton County, every dollar spent on public services supporting land conservation easements generates \$1.15 in revenue, the study conveys.

A-NPDC notes that references to the Hazard Mitigation Plan, Transportation Infrastructure Inundation Vulnerability Assessment, and Coastal Resilience tool are missing from the comprehensive plan's section on sea-level rise, but are included in the transportation section.


The HMP identifies hazards and community preparedness to safeguard its citizens and protect its structures, having a total replacement value of \$1.575 billion. Northampton is primarily at risk for coastal and stormwater flooding, with an elevation ranging from zero to 40 feet above sea level, and only 207 square miles of land surface area among the county's 795 square miles. The TIIVA assesses the Shore's risk of sea-level rise eventually causing daily inundation of roadways. The Coastal Resilience tool is used to model various scenarios of sea-level rise and storm surge.


A-NPDC is one of 21 planning district commissions in the state, which were established in 1968 by Virginia law through the Regional Cooperation Act. The A-NPDC supports local and regional planning and community development efforts. Each PDC has goals unique to the region it serves. A-NPDC's mission on the Eastern Shore of Virginia includes, but is not limited to, improving housing, protecting its waters under guidance of the ESVA Groundwater Committee, and expanding broadband through the ESVA Broadband Authority.

# Readers Share Thanksgiving and Leftover Favorites

Whether you're sitting around eating leftovers, holding your belly from the big meal or shopping the Black Friday sales until you drop, that long Thanksgiving weekend is a winner.

The Eastern Shore Post's office is celebrating by closing Wednesday through Sunday. Yippee! But, we'll be ready to go back to work on Monday, Nov. 27, because the separation anxiety will be killing us. And we'll have food comparisons to make and stories to tell each other.

An email survey taken by the Post this week showed some eager eaters waiting in the wings across Accomack and Northampton counties. The favorite foods of participants were turkey, stuffing and the long awaited pumpkin pie.

And if you're thinking it's too late to try these on your holiday table, remember, Christmas is just around the corner.

Sally Tuttle, of Wachapreague said the holiday would not be complete without her favorite, apple pie. She shared the recipe below:

### Mom's Apple Pie

(the late Sarah Metcalf's recipe) Preheat oven to 425 degrees.

Peel and slice roughly six cups of Macintosh apples.

3/4 cup of sugar

2 to 3 tablespoons flour

½ teaspoon cinnamon

1/8 teaspoon salt

1 tablespoon lemon juice

Combine all dry ingredients well. Mix in apples and lemon juice. Pile mixture in pie crust. Put two tablespoons of butter, cut into bits, on top. Cover with pastry shell and seal edges. Make two vents, sprinkle with cinnamon sugar, place on cookie sheet and bake for 30 minutes. Turn down the oven to 350 degrees and continue baking for between 30 and 40 minutes.

Another of her favorites is sweet potato biscuits. Ron West, of Machipongo, made his late mother's recipe for the Northampton County Fair this year, and it took first place. "I'm pretty sure she would be pleased to have other folks make use of it," he said.

### Eastern Shore of Virginia Sweet Potato Biscuits

(from Charlotte West, who passed

away in 2004)

2 cups of sweet potatoes

3/4 teaspoon of salt

34 cup of sugar

2/3 cup of shortening

3 cups of flour

6 teaspoons of baking powder

Wash, dry and pierce sweet potatoes before baking on a ungreased cookie sheet at about 400 degrees until soft in center. Peel them while still warm.

Work the first four ingredients together. Don't use a mixer but be sure to get all of the shortening blended in.

Sift together flour and baking powder and mix, a little at a time, with potato mixture. Be sure to get the flour well mixed with the potatoes. Once this is mixed, it will resemble regular bread dough but may be a bit sticky.

Flour a counter top or other surface and empty the potato dough on it. Using a floured rolling pin, roll out dough until it's about ½- to ¾-inch thick. A light dusting of flour on the dough will make it easier to roll out. Also, try rolling out half the dough at a time.

Cut the biscuits with a water glass, biscuit cutter, or doughnut cutter. Some folks even use a small clean tin can.

Bake for about 12 minutes, checking to make sure bottoms are not burning.

Like Tuttle, Windy Grace Mason, of Pastoria, chooses the apples. She makes her great grandmother's apple dumplings for her children and grandchildren on Thanksgiving. Mason did not share that recipe. Her favorite pies are coconut custard or sweet potato pie with coconut.

"I learned to make homemade turkey pot pie from my ex-mother-in-law," said Mason. Those cooking instructions were provided, as follows.

### **Turkey Pot Pie**


(from the kitchen of Shirley Willams) Leftover turkey and broth Vegetables

Salt and pepper Cornstarch

Mix first two ingredients. Add salt and pepper to taste and cornstarch to thicken. Pour into a pie shell (top pastry optional) or just add to a baking

# Pair of Crimes Under Investigation

# County Files Motion in Right of Way Dispute

The Accomack Board of Supervisors asked the county circuit court to agree last week that there is a public right of way at the end of Route 759 at Hack's Neck where local watermen and others have launched their vessels since at least the 1940s and to compel Tucker Mayhew Terry, of Nassawadox, to "remove any and all blockage materials" from the area.

County Attorney Celia Burge filed the motion for declaratory judgement Nov. 15 against Nandua Selects LLC and managing member, Terry, of Whitehead Lane. On April 8, 1941, county supervisors passed a resolution regarding the landing, which was accepted as an addition to the Virginia Department of Transportation secondary system on April 8, 1941. Terry "has blocked access at the public landing at Hack's Neck on several occasions by putting aggregate piles on said landing and by putting up poles and chains across the public landing," the motion states. "An actual controversy exists with an antagonist assertion and denial of right between the parties and that it is appropriate for this court to take jurisdiction of this matter to resolve said actual controversy" according to law.

The county also contends that it did not at any time abandon or discontinue the use of the public landing or right of way.

Terry, 38, acquired the property from Eagle Sound Estates LLC on Oct. 29, 2013, for \$235,000.

A month ago, an assault and batter charge was alleged by a Hack's Neck waterman and dismissed because Matthew Forbes May, of Hack's Neck Road, pushed Terry before he was assaulted.

May said Terry was between him and his boat on Aug. 1, and had cast the vessel into the waters near what Accomack officials have deemed a public boat ramp. May contended he was just trying to keep the boat ashore.

Terry told the district court judge there is no public right of way. "The county is trying to cut a deal." He denied threatening May. Despite that claim, Vincent granted May a protective order against Terry. During the proceeding, May said he had been back to the landing three times since the incident occurred. In order to get a protective order, continued fear must be shown. "We don't have a problem with people using the boat ramp," he said, then adding, "It's not really a boat ramp."

Accomack supervisors have met several times in closed sessions to discuss the right of way. County workers have also removed the poles and a chain Terry had put across the entrance to the landing to keep out the public.

The motion is one side of the story. Terry will have a chance to respond before a ruling is made. He has declined to comment.

# Employee Acquitted in Embezzlement Case

A Melfa woman was acquitted last week in Accomack Circuit Court when there was a lack of evidence to convict her of embezzling more than \$200 from Shore Stop.

Mildred Beatrice Mills, 57, of Runway Drive, was indicted with the crime, alleged to have occurred between March 7 and 9, 2017.

In another case, Thomas Roosevelt Bunting, 33, of Daugherty Road in Accomac, pleaded no contest to possessing a firearm by a felon on Sept. 16, 2016. A count of carrying a concealed weapon was not prosecuted.

A charge of possession of a controlled substance was continued for a year for Cornelius Lenwood Townsend, 62, with addresses of Kenilworth Drive, in Hampton, and Savage Town Road, in Painter. The incident occurred Nov. 8, 2016.

# Man Charged With Burning Motorcycle

A motorcycle parked at a Chincoteague motel was set on fire last week and a man has been charged with arson and destruction of property in connection with the incident, according to records filed in Accomack General District Court.

Randy Lee Jack, 37, with addresses on Chincoteague and Jacksonville,

Fla., is being held in Accomack Jail without bond. The motorcycle belonged to Robert J. Kelly and was valued at more than \$1,000. The incident occurred Nov. 15, at Marina Bay Motel.

"I observed a 2001 motorcycle, laying on its side, on fire," Officer Tyler Marks, of Chincoteague Police Department, wrote in the file. Jack sent a text message stating he was going to kill the victim. A video of Jack arriving and leaving the scene as the motorcycle was smoking, was also obtained.

In another case, Alexis Tazewell, 21, of Woodland Parks in Parksley, was charged with assault and battery of Marks, which is a felony. Tazewell was also charged with disorderly conduct on Nov. 18. Unsecured bail was set at \$1,000. Deputy J. Rose investigated.



## Rufa Red Knot Shore Birds' Decline Mirrors Erosion of Barrier Islands

A threatened shorebird, the rufa red knot, has experienced an 80 percent population decline since 1980, when there were about 60,000 of the subspecies. There are approximately 10,000 of this migratory bird left. Red knots are imperiled by the erosion of Eastern Shore barrier islands, where they often stop in spring to rest and feed along their 9,300-mile journey from South America to their breeding grounds in the Arctic tundra.

Of the six subspecies of red knots, the rufa is the only one which is threatened under the U.S. Endangered Species Act, the second-most serious status after endangered.

This member of the sandpiper family has a grey-feathered breast throughout the winter, which turns a reddish hue in the spring in time for breeding, giving the red knot its name.

Erin Heller, a third-year doctoral student at Virginia Tech studying wildlife science, shared her research with a full house at the Barrier Island Center on Nov. 17.

Red knots, once abundant in New Jersey and on Long Island, began to decline in the late 1800s when they were a frequent choice of "pothunters," who kill for food, not for sport.

When red knots continued to decrease

in the 20th and 21st centuries, researchers like Heller wondered if there was a connection to the decrease of horseshoe crabs. whose eggs are the red knot's primary food source at the Delaware Bay, the shorebird's other preferred stopover during migration.

Historically, horseshoe crabs were used as bait for catching eels and conchs. The medical industry also uses the crab's copper-based blue blood to detect bacterial endotoxins; catching, bleeding, and returning them to their habitat interferes with their breeding cycle.

When red knots stop over at Virginia's barrier islands, they eat mostly coquina clams and blue mussels. Red knots can find coquina clams in the sand of higher islands at mid-tide, and blue mussels on the peat banks of lower islands at low tide. Their long, black bills easily crush through shells, and they move from one island to another between tides to make the most of mealtime.

Since blue mussels are found on the lower, less stable islands, and 99 percent of the Virginia coastline is at high risk for erosion, and the number of storms per year has been climbing since the 1800s, a large portion of the red knot's stopover food supply is threatened.

There is much wildlife scientists still don't know about red knots and

how the rufa red knot became threatened, but modern technology has helped Heller and her peers learn a lot about the red-breasted shorebird.

They used LIDAR (light detection and ranging) imagery to study how geomorphological factors like changes in temperature and currents have affected the barrier islands. Thirteen islands were studied, from Assateague to Fisherman's Island at the bridgetunnel. Higher islands like Hog Island have experienced some positive change, but lower islands like Myrtle Island, where red knots find blue mussels, have suffered negative changes.

Researchers checked the levels of isotope 18 in different parts of the blue mussels the red knots eat, and determined the mussels originate in Virginia or northward, the opposite of what they originally predicted. The shifting of blue mussels northward raises further concerns about the red knot's migratory food supply.

The red knot's decline may also be related to a decreased population of lemmings in the Arctic, where both creatures breed. Lemmings breed in burrows they dig in the snow. Warmer Arctic tempera-

tures due to climate change mean heavier, more compacted snow, making burrowing difficult for lemmings, the preferred prey of the arctic fox. When there are no lemmings, the arctic fox eats the eggs of the ground-nesting red knot.

Journeying three times the distance of a more famous migrator, the monarch butterfly, by the time the red knot is 10 years old, it will have traveled the distance of the earth to the moon.

Heller and her peers will continue to research how climate change and other factors affect the survival of this threatened shorebird who crosses astounding distances to perpetuate its species.

# Accomack Schools Prepared for New Graduation, Testing Requirements

The Virginia Department of Education released new graduation and accreditation requirements last week. The changes are intended to "encourage continuous improvement" and close "achievement gaps between student groups," according to a release from the department.

In practical terms, students will need to pass fewer assessment to earn their diplomas. Academic achievement in English, mathematics, science and history are emphasized, along with developing critical thinking, creative thinking, communication, collaboration and citizenship skills.

The new diploma requirements would take effect with students entering the ninth grade next fall (class of 2022).

For school accreditation, schools would be rated as "accredited" or "accredited with conditions" based on performance on multiple school quality indicators. New indicators would include progress made by students toward proficiency in English and mathematics,

achievement gaps in both subjects, absenteeism and dropout rates. Schools that fail to implement state-required improvement plans could be rated as "accreditation denied."

Accomack County Public Schools officials called the changes "exciting."

"It's where we really should be," said Assistant Superintendent of Instruction Rhonda Hall. "It gives every child a chance. If they show growth, they can pass." That's because in addition to a target score, students are also counted as passing if they demonstrated growth.

Superintendent Chris Holland said the changes were expected and the division has been preparing. "We've already had meetings with the principals," he said. "The only major SOL changes are math, and we're on top of that," added Secondary Coordinator Karen Taylor.

Earlier in the week, the board met at Metompkin, a school where changes could help push it into accredited status.

Parent Luz Maria Caballero told the board, in Spanish, how happy she is with the school where her children attend kindergarten and fifth grade. Vice Principal Teresa Ibarra translated. "There is always someone who answers in English when I call or visit. … They are very attentive when I come to visit my children's classrooms."

Fourth grade teacher Christine Labore said she ignored others and listened to her heart when choosing to teach at Metompkin. "It takes great teachers, great staff, and great leadership, and Metompkin has it all," she said. Fourth grade students shared their Pumpkins for Puerto Rico project, which was featured in the Eastern Shore Post Oct. 27 edition.

Professor Robin Rich-Coates, advisor for Phi Beta Kappa honor society at Eastern Shore Community College, and Crystal Routine, a community educator also from the college, asked for permission to talk to high school students about human trafficking.

The honor society made the issue its "honors in action" topic for the year. Members found adolescents are at risk and want to get high school



students talking about human trafficking, give them signs to look for, situations where they can be exploited, and resources available. The board approved their request.

Fishing from
the Shore

Last weekend's strong westerly winds, which swung from the northwest to south southwest curtailed most, if not all, of the angling activity on this side of the Chesapeake Bay. Small craft and gale warnings prevented all but the most foolhardy souls (and one seriously foolhardy person on a raft), from venturing beyond the mouths of the most protected creeks from the entrance of the bay, all the way up the western side of the Eastern Shore.

Rough waters also prevented any attempts at offshore fishing for tautog and black sea bass.

Despite the gale force winds, beach anglers fishing from the Eastern Shore barrier islands experienced some of the best puppy drum action in several years, with double digit catches reported off some islands.

A three-day surf fishing tournament based out of a Chincoteague Island tackle shop attracted a record number of participants and despite the unpleasant weather conditions, produced a wide variety of fish numbers and species.

Lower Shore — Excellent puppy drum fishing was reported from the southern barrier islands, especially Cobb and Smith islands. One successful angler commented that at times, he and his group of anglers were hooking fish on almost every single cast. Chris, at Chris' Bait & Tackle, said that they were busy setting out tackle and gear for their annual Black Friday sale when I called, and reported due to the weather, angling activity was minimal, at best, with only a couple of small flounder releases being reported from the pier at the Kiptopeke State Park.

The shop had received a delivery of live eels, just in time for the 22nd Annual Kiptopeke Rockfish Riot Fishing Tournament, which will run from Nov. 24 through Dec. 3, with the proceeds benefitting the Eastern Shore Coalition Against Domestic Violence. Wachapreague – No boats ventured offshore over the weekend, but anglers fishing the beaches on Cedar and Metompkin Islands found a few puppy drum and undersized rockfish as well as lots of drifting seaweed in the surf.

Chincoteague - The Captain Steve's Bait & Tackle Annual Surf Fishing tournament attracted a field of almost 100 anglers representing six states and D.C. The field produced a variety of catches including striped bass, red drum, black drum, speckled trout, bluefish, and even a 21.5-inch flounder. Chincoteague's Robert Nickell took first place in the striped bass category with a 12-12 rockfish. Second place went to 10-year-old Hunter Holtzman, of Hagerstown, Md., with a 12-06 striper. The largest red drum in the event was brought in by local, Bill Hill, and weighed in at 8-12, while Chris Tensbusch, of Georgetown, Del., took second place with a redfish weighing 7-11. All red drum were required to meet the state regulation slot limit of a minimum 18 inches to no more than 26 inches to qualify for the tournament. The largest bluefish award in the tournament was won by John McWilliams, of Salisbury. Outside of the activity in the surf, the only recent action out of Chincoteague were catches of schoolie-sized rockfish in the Chincoteague Bay and some tautog action around the bridge pilings along the causeway. Captain Steve's now has live eels and breakaway bobbers and planers for the serious rock fisherman.

Upper Shore – Captain Matt Abell, at the SeaHawk Sports Center, reported when anglers were able to get out, good numbers of rockfish were encountered off Smith and Tangier islands. Abell added the keeper to throwback ratio of fish was improving. Fish to 28 inches were landed by anglers jigging along the reef, the Puppy Hole and over structure in Tangier Sound. Smaller schoolies were being found under schools of working birds, however the bird activity has been in-

consistent, with numerous feeding flocks found on some days and little to no bird action at all the next.

And finally, I have sort of gotten used to the occasional person who tells me they actually read this fishing news and enjoy it, but one reader recently really took me by surprise. Thanks to the Internet, the Eastern Shore Post is available to almost anyone in the world who has access to a computer, with the possible exception of North Korea and that leads us to Oliver Jarvis. Oliver is a resident of London, England, who tells me that, despite not understanding some of the techniques and terminology in this column, he looks forward to the report and reads it every week. Who would have thought it, Fishing from the Shore is now enjoyed by at least one person all the way "across the pond!" Thank you, Mr. Jarvis, for your readership.

Bill Hall was the first Eastern Shore resident to achieve Virginia Salt Water Master Angler Status. He has been named Virginia Saltwater Angler of the Year and Virginia Saltwater Release Angler of the Year. Bill is an I.G.F.A. International Committee Representative and a longtime member of the Virginia Saltwater Fishing Tournament Committee. He is the Virginia Recreation Fishing representative on the ASMFC Striped Bass Management Panel and is a past recipient of the CCA-VA Virginia Outdoor Writer Conservation Leadership Award.



### CHICKEN HOUSE BUILDER CHARGED

A Northampton man, who is building chicken houses in Accomack County, was charged with two misdemeanor offenses and was served with two summonses in connection with the construction, according to records filed in Accomack General District Court.

Mohammad Chattha, 59, of Cheriton, was charged with failure to comply with the state code and a chapter of the state water control law. The summonses involved allegations of violating a county ordinance.

Accomack Director of Environmental Programs Chris Guvernator stated in the court records that on Aug. 15, 2017, "I observed that a land disturbance was being performed outside of the approved limits of construction as shown on the

approved erosion and sediment control plan. On Sept. 29, 2017, I observed that the lack of proper erosion and sediment control practices was posing an imminent danger of causing harmful erosion and poses a threat of causing sediment deposition in waters within the watershed of the commonwealth."

A letter requiring modification of the chicken houses was sent Aug. 18. Another letter requiring plan modification was sent Sept. 18, when a third letter requiring the installation of proper erosion and sediment control measures was also sent.

A notice of violation was also sent Oct. 3. It stated "non-approved land disturbing activity within Accomack County without the approval from the director of planning" had occurred.



# Quilts of Valor Warm the Hearts, Honor Spirit of Veterans

With winter rapidly approaching, the need to stay warm is often foremost on the minds of those of us who tend to get a little chilled when the temperature falls as rapidly as the brown leaves that are filling the yard. There are few things that warm the body as nicely as a comfortable quilt and maybe a cup of hot chocolate.

In years gone by, wives, mothers, daughters, and neighbors would often gather for a "quilting bee," which offered the opportunity to turn bits and odd scraps of fabric into beautiful quilts. They were often passed down from one generation to another. Today, quilt guild members can frequently be found gathered in their modern version of "quilting bees."

Across our nation, some of these guilds have found a new reason to create quilts: not only to help warm chilled bodies but also, more importantly, to warm the hearts of those individuals who have stepped up to defend our country. These quilts are referred to as "Quilts of Valor."

The Quilts of Valor Foundation is a national organization founded in 2003 by then-Blue Star mom Catherine Roberts. For those not familiar with the term "Blue Star," it refers to families with a family member who currently

or has served in the military. "Gold Star" refers to those families that have had a family member who has paid the ultimate sacrifice by laying down their life in the defense of our nation.

Roberts' son was deployed in Iraq as a gunner atop a Humvee, a position that made him vulnerable to injury. She envisioned her son sitting on the side of his bunk struggling with the demons of war at 2 a.m., and then comforted as he was wrapped in a quilt to help ward off despair and bring healing. From this vision, the Quilts of Valor Foundation was founded.

Today, dozens of guilds across the nation piece together quilts and present them to service members and veterans who have been touched by war, as a way to help them heal from the trauma that they may have experienced. Since its inception, guilders have sewn and presented 171,441 Quilts of Valor.

The Eastern Shore Quilt Guild became a part of this process over the past few years and this month presented five Quilts of Valor. Once a recipient is recommended to a guild, the members work to handcraft a unique quilt. Les Page, of Virginia Beach, sews the backing to the quilts at no charge. When complete, the quilt is presented to the veteran in a small ceremony.

This year, the local guild selected veterans who represented four of the five military branches. Those receiving quilts spanned World War II to the post-9/11 conflicts. The horrors of warfare know no bounds and can touch someone regardless of the decade in which they served.

### Rex Ingram

The guild's first quilt was presented to Rex Ingram, of Nassawadox. Ingram enlisted in the U.S. Navy near the close of World War II. He trained as a medical corpsman and later was attached to the U.S. Marines during the Korean Conflict. Ingram found himself shoulder-to-shoulder with Marine riflemen, often providing medical aid to wounded troops while crawling through the muddy and frozen terrain, the worst of which was located in a little-known piece of land referred to as Chosin Reservoir. In that battle, 30,000 U.N. Forces were surrounded and attacked by 120,000 Chinese troops.

Following his Naval career, Ingram became an educator and later an administrator with Northampton County Public Schools. It was during this period that he chose to join the U.S. Coast Guard Auxiliary and begin his third career. Having worn three uniforms for his nation (Navy, Marine, and Coast Guard), he has more

than earned the right to be called a veteran and deserving of a Quilt of Valor.

### Tom Gleason

The second of the five went to Tom Gleason, a teacher at Arcadia High School. After graduating from the Virginia Military Institute (VMI) in Lexington, he joined the U.S. Marine Corps and obtained the rank of Captain. Captain Gleason completed three back-to-back combat deployments in Ramadi, Iraq and lost no Marines under his command. Later he was assigned to the Wounded Warriors Unit at Camp Pendleton, Calif.

Following his active duty time with the Marines, he attended Florida Institute of Technology (FIT) where he completed his Masters degree in Engineering and Computer Systems. NASA has given him and two of his students the honor of designing some components for a satellite that will be launched in the spring of 2018.

### Virginia Schneider

The third quilt was presented to Virginia Schneider. a nurse and member of the Air National Guard who was deployed on multiple occasions throughout the world. As a flight nurse, she treated wounded troops and helped evacuate them from war zones in the

Middle East to medical facilities in the U. S. Desert Storm, Desert Shield, and Noble Eagle are but a few of the operations that Col. Schneider took part in. In commenting on her 27½-year career with the Air National Guard, Col. Schneider noted one of her proudest achievements was to have the opportunity to lead her unit as its commander prior to her retirement.

### Marvin Nuttall

The fourth quilt presented went to Melfa resident Marvin Nuttall who served in the U.S. Air Force during the early stages of the Cold War. Nuttall was assigned to the Strategic Air Command (SAC), tasked with being ready at a moment's notice to deploy nuclear weapons anywhere in the world. As a member of SAC, Nuttall found himself as part of the ground crew for what was then one of the most lethal weapons systems in the nation's arsenal, the B-47. The long-range six-engine jet was capable of striking where needed, when needed. The ground crews, along with their support equipment, would be deployed to for-

ward bases in order to keep the bombers flying. Following his service with the U.S. Air Force, Nuttall returned to the Eastern Shore and was a successful insurance salesman.

### Roy Wallace

The fifth and final Quilt of Valor presented by the guild went to Wachapreague resident Roy Wallace. Wallace followed his father's footsteps and served in the U.S. Coast Guard in the field of Aids to Navigation. After leaving the Coast Guard, Wallace had a successful

career with the U.S. Government Accounting Office in Washington, D.C.

Upon retirement from federal service, he moved back home to Wachapreague and decided to once again don the uniform of the U.S. Coast Guard, this time as a member of the Coast Guard Auxiliary. Wallace progressed up the ranks to become the commander of the Fifth Coast Guard District-Southern Region Auxiliary, with the one-star rank of Commodore. As such, Commodore Wallace led more than 3,000 active members of the Coast Guard Auxiliary for two years.



### ~ Governor-Elect Northam ~ (Continued From Front)

he credits his Eastern Shore upbringing for his work ethic and willingness to take on a challenge.

"I always worked hard growing up," says the governor-elect. "I was only in the sixth grade when my brother and I were working on Floyd Nock's farm. I can remember being in a loft on a hot summer day pitching hay out the window when I thought, 'I had better start working harder at school because I don't want to do this the rest of my life."

But that wasn't the hardest job he ever had. "I was a mate for both Capt. Ray Parker and Capt. Bobby Turner," recalls Northam. "I would get up at four in the morning to get to Wachapreague and have everything ready on the boat. I don't think either one paid me more than \$10 a day, so your income was based on the tips you received from the fishing party. It was a great lesson in understanding human nature. Every day there would be six different people, and sometimes they left without so much as a thank you, and other days they would be very generous.

Before I could go home, I would have to take care of the fish and clean the boat. Both Capt. Ray and Bobby were very particular about their boat, too. They always checked it out before leaving. When I got home about 7:30 that night, all I wanted to do was go to bed because it was the same thing the next day. One summer I did not have a day off for six weeks. I remember praying for rain or a windy day

The summer between his senior year of Onancock High School, where he graduated second in 1977, and his freshman year at Virginia Military Institute, Northam ferried workers to Tangier Island for Randy Eller, who had the contract to work on the island's airport. One day he was walking across the island to order lunch for the crew when he walked into the island's new gymnasium. "There was a group of younger boys playing basketball, and I asked them if they had ever seen anyone dunk a basketball," Northam remembers. "They said no, so I took off my sunglasses and hat and dunked on my first try." An athletic 6-foot, 1-inch former Onancock baseball and basketball player, he recalls, "Everyone wanted to be the one to give me my hat and sunglasses back. So, today, I claim to be the first person to dunk a basketball on Tangier," he laughs. "I do know I hit over .600 my senior year in baseball. My coach, William Skinner, was also my math teacher."

Northam also recalls another teacher, Dennis Custis, helped him win election as attorney general of the Model General Assembly while in high school. "I had to give a speech in front of about 600 students when he asked me what I was going to say. I told him I was just going to explain where I was from. He said, 'I don't think that will work,' and then spent about 20 minutes going over a speech. I won the election, and I tell him to this day that he's my speech writer."

Northam, who was president of Beta Club his senior year of high school, says he can recall by name every teacher he had, beginning at South Accomack Elementary School, then Mary N. Smith Middle School before he attended Onancock High School. He says he is proud of his public school education, which continued at VMI, where he was elected president of the honor court for his senior year, and at Eastern Virginia Medical School, where he earned his medical degree in 1984 and eventually became a pediatric neurologist.

But Northam says his parents were the biggest influences on him growing up. His father instilled a great work ethic, having been born on a seaside farm near Modest Town on the Eastern Shore and losing his father at the age of 14. The senior Northam served in World War II, became an Accomack attorney and was elected commonwealth's attorney before being appointed a circuit court judge.

Northam said his mother, who died in 2009, showed him the value of service. Mrs. Northam was a nurse and worked one shift a week in addition to serving Hospice. "She was the reason I entered medicine. For 19 years I have been the volunteer medical director for a children's hospice. It is very difficult dealing with children facing such dire circumstances, but I am comforted knowing the parents place that trust in me. And when I think I am having a bad day, I think of those children and their parents."

He honored both parents by spending eight years in the Army, continuing his medical education and treating troops wounded in Operation Desert Storm. "I was in Germany, where they evacuated casualties from the war zone," says Northam. "We saw the sickest of the sick. It was very intense but also very gratifying when you felt you made a difference in a soldier's life. I have the utmost respect for veterans because of the sacrifices I saw soldiers making during that time."

He met his wife, Pam, in Texas while completing a pediatric residency. She was a longtime elementary schoolteacher before working for a conservation organization. They have two children, Wes, 29, a William & Mary graduate who is now in his fourth year of a seven-year residency in neurosurgery at the University of North Carolina, and Aubrey, 26, a University of Virginia graduate who is a web developer.

Married for 32 years, Northam says when he asked his wife to marry him, neither one would have thought he would ever enter politics, much less be the governor of Virginia.

He says he made his decision to enter politics when he found as a doctor he was spending more time navigating the paperwork for insurance claims and other bureaucratic processes than he was with his patients. "I was complaining about it one day when a colleague told me if I didn't like it, go do something about it. I went home that night and thought about it and said, 'I think I will do something about it.' When I told my wife I was going to run for political office, she thought I had lost my mind. But she has been extremely supportive, and I couldn't have done this without her being onboard."

Gaining the Democratic nomination, Northam, a resident of Norfolk, chal-

lenged the incumbent, Sen. Nick Rerras in 2007 in the Virginia 6th Senate district and won with 54 percent of the vote. He was re-elected in 2011 with almost 57 percent of the vote.

Right from the beginning, Northam worked both sides of the aisle in the Senate. He put together a coalition to get a smoking ban in restaurants. There were even reports Northam would be switching to the Republican party; he says those predictions were overstated. However, he agrees that the Eastern Shore has a history of legislators who are regarded as bipartisan. "Robert Bloxom had a remarkable career in the House and was widely respected by both Republicans and Democrats," Northam says, "I have always tried to listen and work with both parties."

Shortly after his re-election for the Senate in 2011, Northam was persuaded

Senate in 2011, Northam was persuaded by Gov. Terry McAuliffe to join his ticket as a candidate for lieutenant governor. Reluctant at first, Northam agreed and easily won the election after a tough fight to gain the Democratic nomination. He is the only Eastern Shore native to serve as lieutenant governor.

When Attorney General Mark Herring decided not to seek the governor's chair, it cleared the way for Northam to run for governor. He fought off a surprise challenge for the nomination from Tom Perriello that sapped his campaign funds and forced him to work harder and earlier than expected. But the competitor in him was up to the challenge.

Northam retains the same athletic physique he had in high school and greatly values the benefits of exercise. "I've always said the body will rust out before it wears out," he says.

Not long ago, Northam was thrown into a FitBit competition with several other legislators and their spouses. The competition was to last 53 days with the winner being the person who logged the most miles. "I got up every morning and ran six miles, and then that night you could check online what the other competitors had done that day, and often I would go back out and run again. When it was over, I won by over 100 miles. People often think I am laid-back, but I can be very competitive when I want to accomplish something," says Northam.

And run he has for the past year, campaigning for governor against Republican

candidate Ed Gillespie, winning the race by a larger than expected nine percent.

Asked if it annoved him when indepth political stories in major newspapers published during the campaign invariably mentioned his "Eastern Shore drawl" or some other reference to his manner of speech, Northam says "No, it didn't bother me. I am proud to be from the Eastern Shore. I am who I am. And however I sound, it must play pretty well in northern Virginia, because both in the primary for the lieutenant governor and in the governor's race. I beat two candidates in their backyard pretty decisively."

Asked what he would say to Eastern Shore voters who did not vote for him — 53.8 percent in Accomack County and 42.4 percent in Northampton — Northam repeats what he said in his victory speech on election night: "Whether you voted for me or not, we are all Virginians.' I hope to earn their confidence and support. We need to end the divisiveness and bring unity to Virginia."

Northam feels Eastern Shore citizens soon will learn that having a governor from their region of the state will have benefits. "I want a cleaner Chesapeake Bay, as I think most Eastern Shoremen do, particularly those who make their living on the water," he says. "I understand the importance of agriculture and aquaculture to our economy and what it takes for farmers and watermen to be successful."

Even on gun control, a hot-button is-

sue on the Eastern Shore, Northam has an understanding of the issue based on his youth. "I grew up hunting ducks and geese on the Eastern Shore. Although I am not a hunter today, I own guns and enjoy skeet shooting. I am a firm believer in the Second Amendment. However, in the light of all the tragic killings we've seen, including the one at Virginia Tech, and the fact that over 900 people die each year in Virginia from shootings, more than on our highways, I am for responsible gun ownership. I look forward to a discussion on that topic."

Another discussion Northam is likely to hear from some of his Eastern Shore constituents concerns statues that commemorate Civil War leaders. Following the chaos that exploded in Charlottesville in August, resulting in the deaths of two state policemen and a 32-yearold woman who was killed when police say a white nationalist from Ohio intentionally drove his car into a group of people. Northam said if a statue created that type of controversy and violence, then it should be removed and put in a museum. However, he has also said he would leave that decision to the localities where the statues exist and repeated that thought last week.

Northam, who founded a pediatric practice with four other doctors that has grown to more than 200 physicians with different pediatric specialities, took a leave of absence from his practice in November of 2016 to run for office. He will now take an additional four vears' leave of absence to serve as governor, but he is not ready to leave medicine forever.

With Virginia the only state in the nation where a governor cannot succeed himself, he knows this is a oneand-done deal. "I am thankful I've been here four years as lieutenant governor and six years before that in the Senate. I have a lot of staff in place and other contacts to help me to hit the ground running."

But he doesn't see any pursuit of further political office, only a return to his roots and serving people through healing. "I tell Nancy Stern at Rural Health whenever I see her to keep an office open for me because when this is done, I am coming home to the Eastern Shore. Pam loves the Shore like I do, and that is where we eventually want to be."

# New Life for Historic Miles Hancock Carving Workshop

A revered decoy carver's workshop is relocated to the Island Museum to teach about carving and culture

Last week, the workshop belonging to the late carver Miles Hancock was moved to the Museum of Chincoteague Island, thanks to a \$30,000 grant from the Eastern Shore of Virginia Community Foundation.

Hancock's workshop is situated just outside the museum's front doors. Visitors to the museum will be able to walk into and explore the workshop where they'll see many of Hancock's possessions, including the chair where he sat while carving. A permanent exhibit will illustrate the many sides of Miles Hancock (1887-1974): decoy carver, terrapin farmer, hunting guide and actor.

The workshop has been donated to the museum by the Beitzel family. Craig Beitzel stated, "We wanted to share the workshop with others, not just keep it to ourselves." The museum expressed gratitude to the Beitzel family for being good stewards of the workshop while it was under their ownership. Much of the interior of the building remains exactly as it was when Hancock was using it.

"Visitors to the workshop will really get a sense of who Miles Hancock was," said museum executive director Maria Grenchik. "He was known as a sort of 'jack of all trades' and everyone who interacted with him remembers his entrepreneurial talents but also his genuine kindness towards others."

After receiving several bids for the project design and completion, island contractor Drew Jorgensen

was selected to oversee the project. Jorgensen's plan includes stabilizing the historic structure, moving it to the museum in several sections, and restoring the workshop once it is onsite.

Grenchik stated, "While Miles Hancock is the primary focus of this workshop restoration, we are really preserving and presenting information about the entire community of Chincoteague decoy carvers. This craft is an important part of Chincoteague history and culture which we don't want to lose."

The museum hopes to host decoy carving demonstrations and talks near the workshop so visitors get the full sense of the time and talent that goes into decoy carving.



Shirley Christian, of Melfa, picked sweet potatoes for her top Thanksgiving food, "But, turkey salad is good too," she wrote. Christian shops online for Black Friday and bought her first present in September for her companion. She shared her favorite dessert as follows:

#### Lemon Lush

(From the Kitchen of Shirley Christian) 1 1/2 cup flour

1 1/2 cup butter/margarine, softened

1 16-oz. container Cool Whip

1/2 cup chopped walnuts (plus extra for top)

1 (5 oz or 2 3.4 oz ) boxes instant Lemon Pudding & Pie Filling

1 (8 oz) cream cheese, softened

1 cup 10X sugar

Mix together the flour, butter and 1/2 cup of chopped nuts for a pie crust. Pat into a 13 X 9 pan. Bake at 350 degrees for 20 minutes. Remove from oven and cool completely.

Mix together cream cheese, sugar and 1 cup Cool Whip. Pour over cooled crust.

Prepare Lemon Pudding as per directions on box and pour over cream cheese layer. Completely cover lemon layer with remaining Cool Whip, then sprinkle chopped nuts over Cool Whip. Refrigerate.

NOTE: This could be made with any flavor pudding. Lemon is just the most popular.

Christian also shared an apple pie recipe, complete with pastry crust. The pie recipe, she said, is a bit different, "in that it has a nut layer at the bottom. I guess you could do it without that layer, but I like nuts, so I always use it."

#### Blue Ribbon Apple Pie Never Fail Pie Crust

3 cups plain, all-purpose flour

1 teaspoon salt

1<sup>1</sup>/<sub>4</sub> cups shortening

1 beaten egg

1/3 cup COLD water

1 tablespoon white vinegar

Cut flour and salt with shortening. Combine remaining ingredients and stir into shortening mix. Let stand a few minutes. Roll on floured board. Yields four 9-inch shells.

#### Walnut layer

3/4 cup ground walnuts

2 tablespoons brown sugar

2 tablespoons of a lightly beaten egg

1 tablespoons butter, melted

1 tablespoons milk

½ teaspoon lemon juice

Preheat oven to 375 degrees. On a lightly floured surface, roll one half of pastry dough to circle 1/8-inch thick; transfer to a 9-inch pie plate. Trim pastry even with the rim.

In a small bowl, mix nut layer ingredients until blended. Spread onto bottom of pastry shell. Refrigerate while preparing filling.

#### **Filling**

6 cups sliced, peeled tart apples (4-5 medium)

2 teaspoons lemon juice

1/2 teaspoon vanilla extract

3/4 cups sugar

3 tablespoons flour

11/4 teaspoon ground cinnamon

1/4 teaspoon ground nutmeg

1/8 teaspoon salt

3 tablespoons butter, cubed

For filling, in a large bowl, toss apples with lemon juice and vanilla. In a small bowl, mix sugar, flour, cinnamon, nutmeg and salt; add to apple mixture and 1/4 teaspoon vanilla extract; toss to coat.

Pour filling over walnut layer; dot with butter. Roll remaining pastry dough to a 1/8- thick circle. Place over filling.

Trim, seal and flute edge. Brush top with milk; sprinkle with sugar.

Cut slits in pastry.

Place pie on a baking sheet. Bake 55-65 minutes or until crust is golden brown and filling is bubbly. Cover edge loosely with foil during the last 10 minutes if needed to prevent overbrowning. Remove foil. Cool on a wire rack

NOTE: Always watch the pies, and especially about half-way through, make a cover from foil and a cover it, so as not to have a burnt outer edge.

#### **Topping**

1 teaspoon milk

2 teaspoons sugar

Drizzle pie with topping.

Connie Morrison, of Onancock, says her favorite Christmas food is her grandmother's burnt caramel cake. That is also her favorite leftover. She shared that recipe last fall.

She also likes Mama Stamberg's Pepto-Bismal-pink cranberry relish, which Susan Stamberg in known for sneaking into a pre-Thanksgiving NPR broadcast each year. "Sounds awful, tastes wonderful, is easy to make, and has horseradish, which give it bonus points in my book," she said.

# Mama Stamberg's Cranberry Relish (from npr.org)

2 cups whole raw cranberries, washed

1 small onion

34 cup sour cream

½ cup sugar

2 tablespoons prepared horseradish

Grind together the raw berries and onion in a food processor. Mix in the remaining ingredients. Put in a plastic container and freeze.

Thanksgiving morning, remove from freezer and place in refrigerator to thaw. The relish will be thick and shocking pink, with little ice slivers.

Jolynn Perry, of Bloxom, picked traditional Smith Island cake for her favorite Thanksgiving dessert. She also really likes turkey and creates turkey burritos with her leftovers. Perry was kind enough to include her recipe in her response.

#### **Turkey Burritos**


Preheat oven to 300 degrees. Heat oil in large nonstick skillet over medium-high heat. Add onions and bell peppers; sauté until tender and golden, about 15 minutes. Add turkey, salsa, and cumin; stir until heated through, about 5 minutes. Stir in cheese and cilantro; season generously with salt and pepper. Remove from heat; cover to keep warm.

Working with one tortilla at a time, heat tortilla in dry skillet over medium-high heat until warm, softened, and browned in spots, about 30 seconds per side. Place tortilla on work surface. Spoon 1 cup warm turkey mixture along center of tortilla; fold sides in over filling, then roll up tortilla to enclose filling. Place burrito seam side down on baking sheet, and place in oven to keep warm. Repeat with remaining tortillas and filling.

This week I came across a newspaper feature touting a tutorial for the production of an entire Thanksgiving feast in just eight hours.

It doesn't seem like much of an accomplishment to me.

"You don't have to cook Thanksgiving in one day, on four burners and in one oven. But you can," read the tag line.

You bet I can. Most of us can, and do, every year.

Maybe some New York Times readers have multiple days to prepare for Thanksgiving, or fancy kitchens with more than four burners or more than one oven. I'll wager most of us on the Shore do not.

There was a time when I cooked my bread and biscuits for my dressing ahead of time, but nowadays I'm not too proud to purchase bagged cubes. I learned that from my mother-in-law.

In fact, I learned a lot from her. At a time when I made everything from scratch, including cooking and canning my own pasta sauce from the backyard garden, we went to her house for dinner. There was a store-bought frozen lasagna in the oven, a bag of salad waiting to be dressed, and pre-made garlic bread on the pan to be toasted at the last minute.

It was a revelation.

We talked, wandered outside through the hard-won blooms of her flower gardens — according to her, snatched from the jaws of voracious deer — and virtually none of the time was spent cooking. Clean up was a breeze. We did not exhaust ourselves for a brief meal, but instead relished our short time together.

It is a lesson I carry today: Do the things that matter, when they matter. Sometimes I'm up for making a big production; but when I'm not, I give myself permission to not feel guilty about it — a piece-of-mind gift from my mother-in-law.

It's not an indictment of those who enjoy being in the kitchen and producing a meal together, or who have grand kitchens. I covet a well-equipped creative space, and if someone is going to cook a top-shelf dinner, I would not decline their invitation.

I grew up in a household where cooking and eating were central to everything we did. Our parents were avant-garde cooks, regularly preparing international meals from their Time-Life cookbook series. My dad made us master the use of chopsticks because it was the only proper way to eat Chinese food, even at home.

We also learned many Southern specialties. His mother was from a very large family and made Brunswick stew in a cast iron cauldron over an open fire. I have her recipe, which, among other things, calls for a dozen squirrels. My brother and I plan to make Brunswick stew in the same way this winter (probably without squir-

rels, although we have been known to eat them at our house). I'll make photos and print both the original recipe and the one we follow.

Soon, my siblings and I will scatter my father's ashes, a sacred act fulfilling the last leg of his earthly journey. Then we will gather at the same restaurant where we clung to each other the anguished night before removing him from life support eight months ago. Completion and closure, with food once again easing us through a life passage. Of course, we know it isn't the food, but the strength we draw from one another in the rituals built around food, that sustains us. And so it is with Thanksgiving.

As we gather together to ask the Lord's blessing, I know when I place the dressing made from store-bought croutons on our Thanksgiving table, alongside the rest of the meal made in one day on our 25-year-old, four-burner, one-oven range, we are no less blessed than anyone else — nor are we more so. But my gratitude is boundless, especially for family — for those I have lost, those still living, for family I have chosen and those who have chosen me.

# Data Error Don't Invalidate Comp Plan Analysis

Dear Editor:

Thank you for your continued coverage of the comprehensive plan review, it is important for all our citizens to be engaged in this vital process. I would also like to thank you for pointing out that for two of the figures from one of the sources cited in my analysis in Shoreline, I had transposed the numbers with those on the next line of one of the census reports. I regret this, and I apologize for any confusion caused. Unfortunately, by focusing on these two numbers to the exclusion of the broader, well-sourced analysis, I fear you left your readers with the false impression that my conclusions were incorrect. I welcome this opportunity to demonstrate that the correction of these two pieces of data confirms that my analysis remains robust and the conclusions remain valid.

The corrected figures prove false the planning commission's claim of a dramatic increase in poverty for Northampton County. The correct 2015 poverty rate is 20.5 percent, as you reported, and the 2009 poverty rate from the same source (Census Bureau's SAIPE) is 20.6 percent. This confirms my conclusion that poverty has been flat rather than the dramatic increase cited in the draft comprehensive plan.

The planning commission's claim of a 33 percent increase was actually in reference to the 2007 poverty rate – also false, as the 2007 poverty rate was 20.8 percent. During the same period 2009-2015, the median income increased from \$34,501 to \$37,515,

a 9 percent increase. While your article confirmed my finding that the planning commission had correctly quoted the alternative figures from the Census Bureau's American Community Survey (ACS), it failed to include that the Census Bureau itself cautions against using this data for communities smaller than 65,000, instead referring users to the SAIPE.

I apologize that the distraction of the transposed numbers led you to miss the forest for the trees. Not only do the corrected numbers confirm my conclusion on the planning commission's use of inflated poverty figures, but the following four additional conclusions of my analysis —which are based on other data sources—remain robust and valid.

- The nearly 40 percent decline in Northampton County's unemployment rate is largely ignored by the draft comprehensive plan;
- Tourism growth and its contribution to our economy and employment is disregarded in the draft;
- Current and relevant public input has not been permitted; and
- The planning commissions predictions on population decline are already disproven.

In short, as stated previously, the draft Compre-
