Shore Crime Down 11 Percent, Murders and Manslaughters Down 56 Percent

Reports of crimes were down by about 11 percent on the Eastern Shore in 2017 compared to the previous year and the number of murders or willful manslaughters dropped by 56 percent, according to an annual report released last week and compiled by the Uniform Crime Reporting Section of the state police.

County and state police investigated a total of 1,181 crimes in 2017 compared to 1,323 incidents in 2016.

Last year, the Accomack County Sheriff's Office (ACSO) investigated 843 incidents, compared to 944 criminal cases in 2016. That is about a hundred fewer incidents.

The Northampton County Sheriff's Office (NCSO) investigated 156 incidents in 2017 compared to 192 in 2016 or 36 fewer crimes.

State police officers in Accomack handled 143 incidents in 2017 compared to 132 in 2016, about eight percent more cases. In Northampton, the state police handled 55 cases in 2016 compared to 39 cases last year or nearly 30 percent fewer.

A breakdown showed three murders or non-negligent manslaughters were reported in Accomack in 2017. There was a kidnapping, seven forcible rapes, 11 other forcible sex offenses, eight robberies, 22 aggravated assaults, 327 simple assault/intimidations, five arsons,

106 burglaries, 215 larcenies, 18 vehicle thefts, 21 counterfeiting or forgery cases, 39 frauds, eight embezzlements, four stolen property cases, 152 destruction/damage/vandalism cases, 111 drug/narcotic offenses, a non-forcible sex offense, two pornography cases, and 24 weapon law violations.

In Northampton, there were one murder or non-negligent manslaughter, three kidnappings, three forcible sex offenses, two robberies, seven aggravated assaults, 53 simple assaults/intimidations, 17 burglaries, 38 larcenies, two vehicle thefts, six counterfeiting/forgeries, 26 frauds, an embezzlement, a stolen property, 17 destruction/damage/vandalism, 29 drug/

narcotic offenses, a pornography case, and four weapon law violations.

Cape Charles Police handled 29 reports that included a forcible sex offense, an aggravated assault, five simple assault/intimidations, 10 larcenies, two frauds, six stolen properties, two destruction/damage/vandalism cases, and two drug/narcotic cases.

Chincoteague Police handled 98 criminal reports including a kidnapping, two forcible rapes, another forcible sex offense, a robbery, an aggravated assault, 18 simple assault/intimidations, an arson, nine burglaries, 31 larcenies, two vehicle thefts, two counterfeiting/forgeries, five frauds, an embezzlement, 12 destruction/damage/vandalism cases, 24 drug/narcotic offenses, and a pornography case.

Exmore Police Department handled 50 incidents including a forcible rape, an aggravated assault, seven simple assault/intimidations, two burglaries, 24 larcenies, four frauds, a stolen property, eight destruction/damage/vandalism cases, seven drug/narcotic offenses, and three weapon law violations.

Onancock Police Department handled 79 criminal reports including a forcible rape, seven aggravated assaults, 14 simple assault/intimidations, three burglaries, 18 larcenies, two vehicle thefts, 27 destruction/damage/vandalism cases, eight drug/narcotic offenses, a prostitution case, and three weapon law violations.

Onley Police Department handled 39 criminal cases with a kidnapping, a robbery, an aggravated assault, seven simple assault/intimidations, a burglary, 20 larcenies, a counterfeiting/forgery, two frauds, a stolen property, five destruction/damage/vandalism

Cape Charles Homeowner Seeks Remedy for 300,000-Gallon Water Leak

A couple who lives part time in Cape Charles requested a credit for the bill of nearly \$5,700 they received after their home was flooded with about 300,000 gallons of water in January while they were away and the town's public utilities department failed to notify them after an employee noticed the leak and the town shut off the water.

Jeff and Jennifer Dawson, of Davidsonville, Md. (between Annapolis, Md. and Washington, D.C.), learned of the water damage on Valentine's Day when Jeff Dawson stopped by to check on their Cape Charles home. A water pipe had frozen and burst earlier that winter, causing an extensive leak and subsequent water damage before public utilities shut off the water around the first week of January.

"It's really a tragic loss," Jeff Dawson said of the damage to his home in an April 18 letter to interim town manager, Bob Panek.

"Cape Charles is my home and

I do hope to be a full time resident within the next few years," despite extensive repairs needed at the Monroe Avenue property, Dawson wrote on May 7.

According to Dawson, when he visited the Cape Charles residence on Feb. 14, he was greeted by moisture and mold all over the walls and furniture, including couches and mattresses, and more than two feet of standing water in the basement. All the door and shutter hinges were rusted. Additionally, the sump pump, which could not keep up with the leak, had overheated and failed.

Moreover, the water shutoff in the Dawson home caused the furnace to stop working, and most of the radiator pipes froze and cracked, extending the damage throughout the home.

Dawson said his homeowner's insurance doesn't cover mold damage and he had to pay \$8,000 out-of-pocket to repair it. He also plans to convert the residence to electric-based heat so the home can be win-

terized and the thermostat can be controlled remotely.

According to Cape Charles' town code, following a leak, a resident's monthly sewer bill may be reduced to a 12-month average. According to town records, almost \$3,400 may be credited to the sewer portion of the Dawsons' \$5,700 utilities bill, leaving them with a balance of nearly \$2,300.

Because much of the damage to the home could have been prevented if Dawson had been notified immediately of the leak and water shutoff, he deemed the \$2,300 balance due on the utilities bill unfair.

According to Dawson's letter, when he confronted Cape Charles Director of Public Works and Utilities, David Fauber, about why he was not notified of the water shutoff, Fauber said the town worker who turned off the water neglected to inform the utility billing clerk at the town office, who would have contacted Dawson.

Fauber later clarified that on the

day the Dawsons' water was turned off, the town office was closed.

Fauber neither confirmed nor denied whether the public works employee attempted to leave a note on Dawson's door regarding the water shutoff.

At the town council meeting on May 17, Panek said, "There's no ... requirement from the law that the notification be made, but it is our policy to do so. That was a very busy time of the year with leaks and cutoffs and that was just one that fell through the crack."

Town council members passed a motion to award the Dawsons a credit on their water bill to be calculated similarly to the credit they received on their sewer bill.

The U.S. Geological Survey estimates the average person uses between 80 and 100 gallons per day. By that estimate, the 300,000 gallons of water that leaked into and flooded the Dawson home is about the same amount of water used by a family of four in two years.

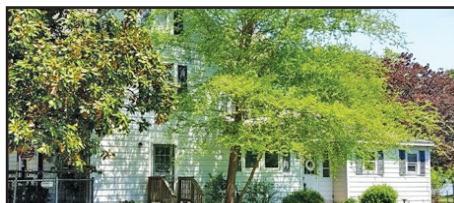

Northampton Budget Will Boost Deputy Salaries \$5,000 Annually

Northampton's budget for fiscal year 2019 is not yet final, but it's "firm and balanced," Spencer Murray, chairman of the board of supervisors, said at the May 29 public hearing.

The \$46 million budget is supported primarily by local taxes. Real estate taxes account for more than half of all county revenue, or 53 percent. Real estate and property taxes combined are nearly two-thirds of all county revenue, or 66 percent.

The budget provides a 2 percent raise for county employees, and Northampton's contribution to each employee's health insurance plan will increase from \$583 to \$700 per month to compensate for a 24 percent cost increase.

Supervisors also made good on their pledge to prioritize the financial well-being of farmers, sheriff's deputies, and teachers.

The farm equipment tax was decreased from \$1.43 to \$1.20 per \$100 of assessed value. All other tax rates will remain the same, including the real estate tax rate of 83 cents per \$100 of assessed

value and the personal property tax rate of \$3.90 per \$100 of assessed value.

Sheriff's deputies will receive salary increases of \$5,000 each. Correctional officers at the jail will receive salary increases of \$3,000 each.

There is a 2.5 percent increase in the school budget, which includes all school employee salaries, from teachers to bus drivers, the cost of the operation and maintenance of all school buildings, transportation of students to and from school, and other expenses.

No one openly objected to the proposed budget during the public comment period, with the exception of Northampton schools superintendent Eddie Lawrence and several members of the school board: Chairman William Oakley, Randy Parks, and Nancy Proto. A Cheriton citizen made a brief statement in solidarity with the school board.

The school board had requested a county funding increase of about 5.5 percent for improvements including a 4 percent raise for teachers, higher pay for classified employees who don't

make a living wage, and additional personnel such as an attendance officer and in-school suspension monitor.

It was the first time the school board asked supervisors for more than \$9 million for their budget. Northampton schools received around \$8.6 million from the county last year, contributing to total expenses of about \$21.7 million.

Education accounts for 29 percent of county spending, second only to public safety at 32 percent.

Former supervisor Granville Hogg shared some concerns during the public comment period, including the cost of ongoing maintenance needs at the high school in light of the fact that there will be no "significant drop" in county debt until 2026.

School debt is below \$3 million, or less than 15 percent of the county's total debt of about \$20 million.

Hogg pointed out that supervisors made no contribution to the county's capital reserve fund this year.

However, the county's undesignated fund balance, which Murray equated

to an "emergency account," stands at 22 percent of expenditures, though the minimum required is 10 percent.

The county is also in good standing regarding its debt, which should be less than 12 percent of expenditures and is currently a little more than 7 percent.

Hogg echoed Supervisor Robert Duer's concerns that revenue from fines and forfeitures are projected to be 20 percent or \$127,000 higher than last year. Hogg said there is a "hefty reliance on the motoring public" and wondered if the projected revenue is attainable, especially since Cheriton now has its own police force to take advantage of the "cash cow."

Hogg is also interested in transient occupancy tax revenue, which is projected at \$375,000 for FY 2019, and he advocated for another public beach to attract more visitors.

"We invite people to come here to spend money, by gosh, I want to give them a place to spend it."

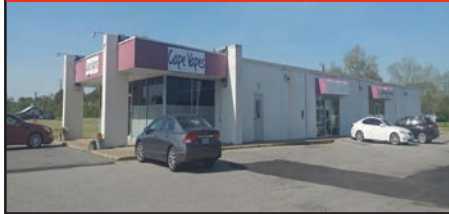

cases, a drug/narcotic case, and a weapon law violation.

Parksley Police Department handled nine cases including four simple assault/intimidations, a burglary, two larcenies, a destruction/damage/vandalism, and a drug/narcotic case.

In Accomack, a total of 723 adults were arrested. They included four adults for murder, four for kidnapping, one for a forcible sex offense, one for robbery, nine for aggravated assault, 90 for simple assault/intimidation, one for arson, 14 for burglary, 40 for larceny, four for motor vehicle theft, eight for counterfeiting/forgery, 10 for fraud, five for embezzlement, three for stolen property, seven for vandalism, 117 for drug narcotic offenses, one for pornography, and nine for weapon violations. There were also two arrests for writing bad checks, six for disorderly conduct, 99 for DUI, 88 for drunkenness, 4 for non-forcible family offenses, six for liquor law violations, nine for trespassing, and 181 other violations that are not traffic related.

There were also 14 juveniles arrested in

Accomack with one being for larceny, four for drug/narcotics, three for curfew/ loitering/vagrancy, one for DUI, four for liquor law violations, and one for trespassing.

There were 341 adults arrested in Northampton in 2017. Those included three for kidnapping, one for robbery, seven for aggravated assault, 50 for simple assault/intimidation, one for burglary, 18 for larceny, two for counterfeiting/forgery, eight for fraud, 10 for stolen property, three for vandalism, 45 for drug/narcotic offenses, and three for weapon law violations.

There were 15 juveniles arrested in Northampton in 2017 including six for simple assault/ intimidation, one for larceny, one for vehicle theft, one for stolen property, five for drug/narcotic offenses, and one for other offenses not including traffic crimes.

"Crimes Against the Person" occurred once every four minutes, 56 seconds, in Virginia, in 2017. There were 85,710 "Crimes Against Society," or one every six minutes, eight seconds, statewide.

There were 455 murders or non-negligent manslaughters in the state in 2017; 1,585 abductions; 5,736 forcible sex offenses; 98,610 assaults; 147 non-forcible sex offenses; 4,320 robberies; 809 arsons; 18,396 burglaries; 125,068 larcenies; 9,947 vehicle thefts; 6,951 counterfeiting or forgery offenses; 35,230 frauds; 2,789 embezzlements; 1,542 property thefts; 55,110 property destructions or vandalisms; 27 bribes; 70,974 drug offenses; 1,545 pornography or obscene material offenses; 57 gambling offenses; 754 prostitutions; and 12,380 weapons law violations reported.

There are 57 sworn officers working for the Accomack County Sheriff's Office. Of those, 48 were men or more than 84 percent. Eleven civilians work for Sheriff Todd Godwin. All 10 of the sworn officers who work for the Chincoteague Police Department are men. There are also four civilian employees in the CPD. Onancock Police Department has five officers with one being female. Five men are in the Onley Police Department. Parksley has three sworn officers including a woman. There is one officer, male, in the Tangier Island Police Department.

There are 67 sworn officers in the Northampton County Sheriff's Office employed by Sheriff David Doughty. That includes 49 men or more than 73 percent. Doughty also has 17 civilian workers. There are six male officers each in the Cape Charles and Exmore police departments and no women.

Two New Candidates Ask to Be Appointed to District 4 School Board Seat

In the second attempt by the Accomack School Board Selection Commission to fill the District 4 school board seat recently vacated by Margaret Miles, two people put their names forward for consideration: Gary Reese and Worth Saunders. Both brought supporters to speak on their behalf.

Reese, a former athletic administrator at Nandua High School, said if he was appointed he would “listen not only to my district, but to other districts in the county,” and would be open to considering changes “as long as those changes will improve the school system.” He has lived on the Shore 37 years and described himself as a team player, eager to help, with experience in accounting, and with educational connections across the state from his work in athletics.

There to speak on his behalf were former Nandua Principal Dennis Custis, current Nandua Principal George Parker, Nandua teacher Carla Savage-Wells, Chincoteague Principal Harold Holmes, and Tom Wilson of Parksley.

Reese is a resident of Parksley and taught there four years before switching to Nandua 32 years ago.

“I think you did well in holding off and not bringing on someone with a personal agenda,” Wilson told the commission. Burford was the only candidate under consideration for District 4 at the commission’s May 15 meeting but was passed over and the post was re-advertised. No reason was given by the commission for declining to appoint her.

Burford was reached at home for comment. “To make things better for the teachers and students in Accomack County: That’s always been my agenda,” said Burford. “It’s what you’re supposed to do as a school board member — make sure students get the best quality education possible.”

Of Reese, Wilson said, “Gary’s got great integrity,” and painted him as a willing volunteer.

Custis described Reese as someone of “tireless dedication,” and Parker said he “lends credibility to the Eastern Shore.” Holmes said Reese’s children attended Accomack schools and

will bring a balanced view because he understands parents’ perspectives, and Savage-Wells said Reese and his family are models of decorum and good character. Reese is a graduate of Longwood University and retired from the Accomack County Public Schools in 2017.

Worth Saunders graduated from Nandua High School in 1987. He earned a Bachelor of Science in finance from Virginia Tech, holds a Master of Physical Therapy degree from Old Dominion University, and a Doctor of Physical Therapy from Virginia Commonwealth University. He is co-owner of a local physical therapy business.

He said his private sector experience has made him aware of the need to stay relevant. “There are other options in education,” said Saunders. “I’d like to do what I can to keep Accomack County as a school of choice.” He told the commission he stands ready to help and getting up to speed on his new responsibilities would be his first order of business if appointed. He would also like to help find ways to reduce healthcare costs to employees.

Saunders asked whether being on the school board would pose a conflict for his wife’s employment at Accawmacke Elementary. Commission Chairwoman Jodie Greene said it would not pose a conflict “as long as she has an existing contract with the county.”

Jane Duer, John Roache, and sitting board member Paul Bull spoke in favor of Saunders. Bull and school board member Camesha Handy were reappointed May 15.

Duer said Saunders has “a strong moral compass” and his opinions are informed and reasoned. Roache said Saunders strives for right decisions, “balanced by data for support.”

Bull pointed out only two school board members have children in schools. (Members with school-age children are Bull and District 1 member Jesse Speidel.) “That kind of groundtruthing is an important commodity,” he said.

The commission meets again Tuesday, June 5, at 3 p.m. to consider the candidates and to possibly make a selection. It faces a June 30 deadline to make an appointment.

Man Convicted in '09 Killing of College Student Ordered Back to Prison

Kendrick Di'ke Duffy, who was convicted of manslaughter in the shooting death of a local college student in 2009, was ordered last week in Accomack Circuit Court to serve nearly two more years in prison for the crime.

The time came from his original sentence and was given because Duffy, 26, of Parksley Road in Parksley, violated probation when he eluded police with reckless speeds of up to 114 mph in March 2017. The incident ended with Duffy hitting a house and then abandoning the car and continuing to flee.

Judge W. Revell Lewis III said the term would conclude Duffy's punishment in the death of Bobby Oneal Ballard, 20, a college junior who lived on Saxis Road in Temperanceville.

In the 2017 incident, Lewis sentenced Duffy to 12 months in jail, with half suspended, for misdemeanor reckless driving. He got five years with four suspended for felony eluding. He was also ordered to be on probation for five years and good behavior for 10 years. In addition, Duffy was ordered to pay restitution of \$1,740 by 2025. The defendant has been in jail since the 2017 incident occurred. The sentences were set to run consecutively.

Deputy Eric Nottingham of the Accomack County Sheriff's Office said he saw Duffy driving on Route 13 near Temperanceville at a high rate of speed on March 8, 2017. With his siren blaring and lights flashing, Nottingham said, he followed the vehicle, which turned onto Hallwood Road. After Duffy's car struck a house, Nottingham saw Duffy, the only person in the vehicle, get out of the driver's side and run. The defendant reached Poulson's garage where he jumped into an occupied vehicle and was captured.

Defense lawyer Tom Northam offered no excuse for the incident. Duffy apologized for his actions and asked for leniency as he was trying to now set an example for his daughter who was born while he was in jail.

Commonwealth's Attorney Spencer Morgan complained Duffy acted with dis-

regard to other people's safety. He mentioned the defendant fled from the officer because he didn't want to get caught smoking marijuana.

In August 2015, when Duffy was out of prison for about a year, he was accused of brandishing a firearm. The witness, in that case, did not show up to testify and the charge was dismissed the following December.

In another case, Dorian Antione Noncent, 18, of Matthews Street in Mappsville, pleaded guilty to maliciously shooting at an occupied vehicle on Nov. 21, 2017. He was denied bond and was returned to Accomack Jail to await sentencing.

According to evidence, there was a feud between two families in the Mappsville Trailer Park where Noncent lived. Defense lawyer Carl Bundick said his client's family has been beaten and terrorized by members of the other family who have gang affiliations. "While an inappropriate response, his grandmother is able to testify about what is going on in that community," Bundick offered. "The young man made a bad choice that will affect him for the rest of his life."

Noncent was walking his dog when a vehicle was leaving the park and almost hit the animal. Noncent shot at the vehicle but denied doing so. Deputies later searched his home and found ammunition and a firearm.

A mental health evaluation was ordered.

Billy Deeon Harmon, 32, of Raymond Townsend Road in Horntown, was sentenced to 20 years in prison for distributing heroin on Sept. 15, 2016. Ten years of the term was suspended. A charge of distribution of cocaine, in connection with an incident that occurred Oct. 26, 2016, was not prosecuted. After he is released, Harmon will be on supervised probation for 10 years.

Brandon Mulder, 25, of Ferdinand Street in Scranton, Pa., was sentenced to three years each for two counts of assault and battery of Officer Tyler Marks of Chincoteague Police Department on July 11, 2017. Marks was punched, kicked, head-butted and spit upon. All but seven months of the terms was suspended.

Kayla Mercy Justice, of Quinby, was given a three-year suspended sentence for distribution of heroin as an accommodation, which means giving the drug to someone without the expectation of profit. She was convicted of the offense in December.

Wesley Thomas Wilson, 39, of Parks-

ley was sentenced to three years each for credit card larceny, credit card fraud, and possession of crack in June 2017. All but three months each was suspended for the credit card offenses and all but a month was suspended for the drug charge. The terms were set to run consecutively. Wilson was ordered to be on probation for two years and good behavior for five years.

James Ernest Logan, 34, of Woodland Park in Accomack, was sentenced to five years with all but a year suspended for burglary and five years with all but 10 months suspended for grand larceny. He was also given the mandatory two years for possession of a firearm by a felony. The terms were set to run consecutively. The crimes occurred in 2016.

Logan was recently charged with robbing another of a phone by means of violence, malicious wounding and use of a firearm in a felony in connection with March 2018 incidents.

Two Face Drug Charges

Two men were charged recently with possessing illegal drugs.

Israel Juan Francisco, of Accomack, was charged with possession of a Schedule I or II drug, which is a felony, according to records filed in Accomack General District Court. The offense occurred May 25. Francisco was arrested the next day. A preliminary hearing is scheduled for June 20.

Printince Alvin Wiggins, of Cape Charles, was accused of possession of a Schedule I or II drug. The drug charge was made in connection with a May 20 incident. He was arrested May 21.

Bond Denied for Another Accused in Murder-for-Hire Scheme

A Parksley man who is accused of conspiring to commit capital murder and other crimes in connection with a murder-for-hire scheme was denied bail in Accomack Circuit Court last week.

Judge W. Revell Lewis III denied bond for Keenan Jibrel "Lo" Berry, 26, of Jermaine Lane. The defendant was returned to the Eastern Shore Regional Jail in Eastville where he has been held since he was indicted in April. A grand jury indicted him on counts of conspiracy to commit capital murder, conspiracy to commit capital murder by a prisoner, and obstruction of justice. The crimes occurred between Aug. 11 and Nov. 10, 2017.

During the hearing, there was a ques-

tion of whether Berry fell under the automatic presumption that no bond should be offered. Defense lawyer Patrick Robbins argued that while the law states there is a presumption in first-degree and second-degree murder cases, it does not specifically state that is the case in a conspiracy to commit capital murder. Judge Lewis agreed.

"We are simply asking for the court to set a reasonable bond," said Robbins. He contended that another defendant, who was indicted on more charges in connection with the allegations, was allowed out. "It still has to be proved. It's contested," the lawyer said. "Most of the other defendants are 16 counts, or 12 ... He has positive attributes. He at least has a part-time job with a lady who trusts him."

The employer is Delores Sartor, a local health counselor, who has known him for about a year and testified Berry has done home improvement jobs for her and other work. "He's just a blessing," she said. "He's trustworthy," Sartor said. She goes to the home of Berry and his girlfriend several times a week. "The kids love him. He's outside with the kids playing basketball ... He's at home with her."

Commonwealth's Attorney Spencer Morgan said evidence will show Berry talked to an inmate at Accomack Jail "communicating about a murder-for-hire plot. You all put the master plan together." Morgan said Berry was convicted of grand theft auto and gang participation with juveniles in 2012 while the other person who was charged and is free on bond "has no prior record."

Berry "has proven himself in the past to be a danger to the community," said Morgan.

Lewis reminded Berry that he was on probation when the allegations occurred. "You have a right to appeal this decision."

Berry shook his head while being escorted out of the room.

Health Matters **Meniere's disease**

Meniere's disease is a disorder of the inner ear that causes episodes in which a person feels as if one's spinning (vertigo); has fluctuating hearing loss with a progressive, ultimately permanent loss of hearing; ringing in the ear (tinnitus); and sometimes a

feeling of fullness or pressure in the ear. In most cases, Meniere's disease affects only one ear.

Meniere's disease can occur at any age, but it usually starts between the ages of 20 and 50. It's considered a chronic condition, but various treatments can help relieve symptoms and minimize the long-term impact on one's life.

Symptoms

Signs and symptoms of Meniere's disease include:

Recurring episodes of vertigo—a spinning sensation that starts and stops spontaneously. Episodes of vertigo occur without warning and usually last 20 minutes to several hours, but not more than 24 hours. Severe vertigo can cause nausea and vomiting.

Hearing loss in Meniere's disease may come and go, particularly early on. Eventually, most people have some permanent hearing loss.

Ringing in the ear (tinnitus) is the perception of a ringing, buzzing, roaring,

whistling or hissing sound in the ear.

People with Meniere's disease often feel fullness in the ear, pressure in the affected ears (aural fullness) or on the side of the head.

After an episode, signs and symptoms improve and might disappear entirely. Episodes can occur weeks to years apart.

When to see a doctor

See your doctor if you have signs or symptoms of Meniere's disease. Because any one of them can result from other illnesses, it's important to get an accurate diagnosis as soon as possible.

Causes

The cause of Meniere's disease isn't understood. One popular theory is that Meniere's disease appears to be the result of the abnormal amount of fluid (endolymph) in the inner ear. This often shows on autopsies, but it's not clear that it causes the episodes.

Factors that affect the fluid, which might contribute to Meniere's disease, include:

- Improper fluid drainage, perhaps because of a blockage or anatomic abnormality

- Abnormal immune response
- Allergies
- Viral infection
- Genetic predisposition
- Head trauma
- Migraines

Because no single cause has been identified, it's likely that Meniere's disease results from a combination of factors.

Complications

The unpredictable episodes of vertigo and the prospect of permanent hearing loss can be the most difficult problems of Meniere's disease. The disease can interrupt life and cause fatigue, emotional stress, depression, and anxiety.

Vertigo can cause you loss of balance, increasing risk of falls and accidents while driving or operating heavy machinery.

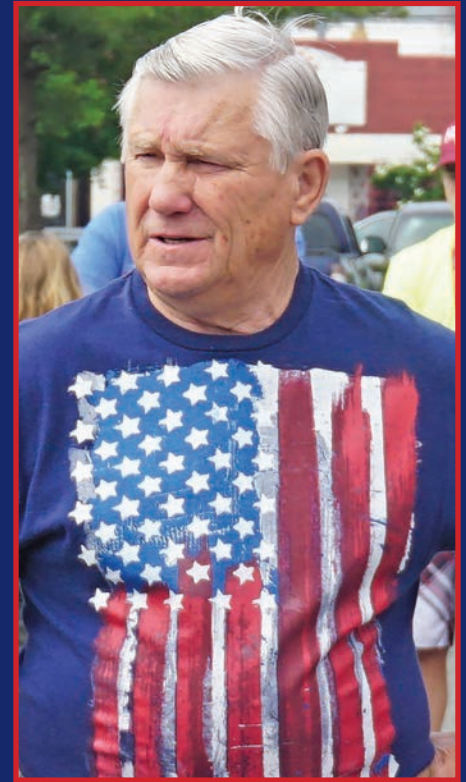

Kings Dominion Rules for Kids and Schools

Last month, both Accomack and Northampton county school boards completed a long, complex task that is required annually and is often taken for granted by teachers, students, and parents – approving the calendar for the next school year.

During the discussion that inevitably ensues about what teachers or parents want included on the school calendar, Northampton schools Superintendent Eddie Lawrence said the most important priority “really should be what’s best for instruction.”

But there are also legal considerations school boards must make when organizing school calendars.

Virginia law prevents school districts from beginning the school year before Labor Day unless they can prove “good cause” to do so and receive a waiver from the state board of education.

The legislation, which has been on the books since 1986, was named the Kings Dominion law, after the Richmond-area amusement park that supported the original bill due to millions

of dollars of revenue generated by traditional Labor Day weekend travel and activities.

A district can receive a waiver if schools were closed an average of eight days per year during any five of the previous 10 years due to inclement weather, power outages, or other emergency situations.

A waiver can be given if a special instructional program requires a pre-Labor Day opening date.

A school district also qualifies for a waiver if it is conducting instructional programs in partnership with a district that already qualifies for one, or if it is entirely surrounded by a neighboring school district that opens before Labor Day.

Of Virginia’s 132 school districts, 85 have waivers, often related to inclement weather.

In January, the Virginia House of Delegates voted 76 to 22 in favor of a bill allowing school districts to begin the instructional year any time, provided they authorize a five-day weekend for Labor Day. The House also vot-

ed 75 to 24 for a bill that would give local school boards complete authority over school calendars and the Labor Day holiday.

A Senate committee combined the bills and voted 9 to 6 to continue the matter until next year, so for now, the Kings Dominion law remains in effect.

Virginia public school students are required to receive 180 days or 990 hours of instruction every year, not including lunch or recess. That is an average of 5.5 hours of instruction per day.

Lawrence said that in Northampton public schools, there is an extra half-hour built into every school day that is often viewed as “bank time.”

School board member Randy Parks suggested using the bank time to let school out early for the year, because most students become disengaged after the Standards of Learning tests are administered. Lawrence deemed this suggestion impractical, since many students are re-tested until the last day of school.

In another matter, it was determined that the Kiptopeke Elementa-

ry School parking lot is badly deteriorated, in spite of being fairly new, because it was constructed with faulty aggregate. The contractor who did the original work has agreed to redo the parking lot at no cost to Northampton schools, Lawrence said.

Plans to shore up the Northampton High School auditorium are still in the works for this summer, causing Lawrence to decline the use of the facility by several outside groups. One group was granted permission to use the building on a first-come, first-served basis, Lawrence noted.

It’s also the time of year for teachers and staff to be recognized.

Helene Doughty, of the Northampton County Education Foundation, announced the foundation’s annual Teacher Recognition Banquet will be held Thursday, June 7, 6:30 p.m., at Franktown United Methodist Church.

Lawrence announced that Chief Financial Officer Brook Thomas has been selected as the next president of the Virginia Association of School Business Officials.

Free Fishing Days Established June 1-3

If you've always wanted to try fishing, now is your chance! You may fish without a license again this year during the first weekend in June. Take advantage of the free fishing days, June 1-3, and enjoy the great outdoors with your family and friends without having to spend money for a fishing license.

No fishing license of any kind will be required for recreational rod and reel fishing during free fishing days, and facilities use permits will also not be required during these dates.

To increase angling opportunities, Virginia Department of Game and Inland Fisheries (DGIF) has removed the restriction to

fishing designated stocked trout waters. This will open over 2,900 miles of trout streams, in addition to numerous ponds, small lakes, and reservoirs. Virginia's diversified trout habitat offers a wide range of trout fishing prospects. All fishing regulations including size, season, catch limits, and gear restrictions will remain in effect.

"Fishing offers a person, no matter their age, race, fitness ability or income level, the chance to connect with nature and to learn how to become better stewards of our natural resources," said Bob Duncan, executive director of the DGIF, which manages the states freshwater fishing. "In this fast paced society fishing is also a great way of 'casting' your troubles away and relieving stress."

The 2018 Freshwater Fishing and Boating Regulations can be found on the DGIF website at dgif.virginia.gov/fishing/regulations/

Printed regulations are also available at most major outdoor retailers throughout the state that sell hunting and fishing licenses. In addition, the Marine Resources Commission's website, <http://mrc.virginia.gov> has extensive information on Virginia's recreational fishing size, season, and creel limits.

DGIF's Virginia Angler Recognition Program is a fun way to recognize a trophy freshwater catch. For more information on that program, visit dgif.virginia.gov/fishing/varp/

On average, anglers measure up over 6,000 trophy size fish annually. Since 1963, when the program began, over a quarter-million trophy fish awards have been issued.

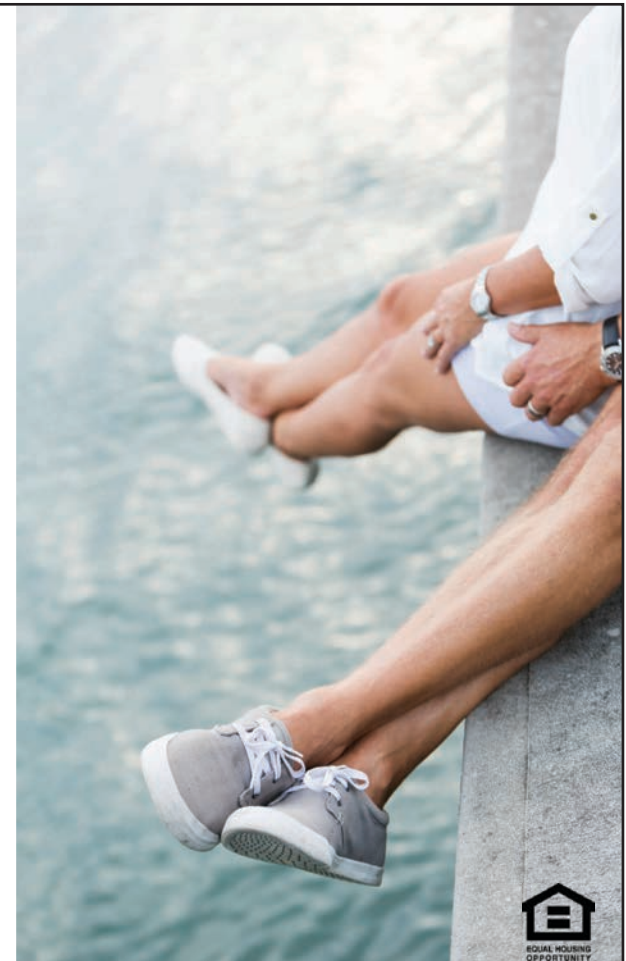

Fishing from the Shore

For the second week in a row, the fishing remains more consistent than the weather. Croakers have made an early appearance on the seaside, and cobia have begun to take the place of black drum in the lower Chesapeake Bay. Spanish mackerel have showed up in the ocean waters just off the Virginia Capes.

Lower Shore – Chris Snooks at Chris' Bait & Tackle reports that flounder fishing has improved in the ditch off the refuge, with flatfish as big as eight pounds reported. Red drum fishing remains very good off Fisherman's Island, where black drum also remain. Cobia and large sharks have begun to show up, with shark releases as long as 8 feet, registered for citations. Sheepshead catches are still coming from the Chesapeake Bay Bridge-Tunnel. Catches of sea mullet have been made from the pier at the Kiptopeke State Park. Croaker catches have come from the waters out of Oyster.

Jeb Brady at Bailey's Bait & Tackle reports that they have enjoyed a good run of black drum and a few fish still remain. Drum anglers are starting to see increasing numbers of cobia bycatches, especially off Nautilus Shoal and around the Bridge-Tunnel. Flounder catches were being made out of Oyster, and sand mullet were being caught off Guy's Point.

Wachapreague – Captain Lindsay Paul at Trident Tackle reports that black drum catches are still being made out of Willis Wharf and Quinby. The shop registered a red drum release citation for Sam Sellard. Flounder fishing out of Wachapreague was described as "hit or miss," but croakers have shown up along with sand mullet. Reports of yellowfin tuna catches have come from the Poor Man's Canyon, but

planned trips out of the port were scuttled due to high winds.

Chincoteague – Peter Vasilou at Captain Steve's Bait & Tackle reports that the black drum and strip-er bite off the beach remains steady. Kingfish (whiting), puffers, and toothy sharks are also being caught in the surf. In Chincoteague Bay, the flounder population has spread out, with catches coming from Queen Sound as well as in the Chincoteague Channel.

Assateague Channel continues to be a favorite destination for a lot of the flounder seekers. Offshore, the black sea bass bite has been good over the wrecks. Reports of yellowfin and bluefin tuna have come from the canyon waters.

Donna Rae at Captain Bob's Marina reports that flounder fishing has been "spotty" with a lot of undersized fish. Anglers have been averaging a couple of keepers out of every dozen or so fish caught. A lot of captains are fishing in Chincoteague Bay, especially in the deep hole in front of the high school. Undersized gray trout, as well as bluefish, have shown up in Chincoteague Channel. Rae said that the surf is still producing catches of black drum, but the number of fish is declining, while the number of striped bass is increasing. Croaker and kingfish have shown up in the inlet near buoys #11 and 12. Yellowfin up to almost 70 pounds have been reported from the Poor Man's Canyon.

Upper Shore – Captain Matt Abell of the Sea Hawk Sports Center reports that fishing has been good considering the recent weather that we have had. He said flounder fishing on the seaside remains "okay," as the fish have moved up on the flats with the best action occurring during the last of the flood through the first

of the ebb tide. Red drum catches are still coming from the surf and some of the reds have met the slot limit.

On the bayside, speckled trout fishing has been slowly on the upswing, with fresh baits outcatching lures. The same holds true for rockfish. Red drum catches have been coming from the waters of Pocomoke Sound all the way up to South Marsh Island. Sheepshead catches from the waters off Chincoteague all the way down to the Chesapeake Bay Bridge-Tunnel have recently been brought into the shop.

Bill Hall was the first Eastern Shore resident to achieve Virginia

Salt Water Master Angler Status. He has been named Virginia Saltwater Angler of the Year and Virginia Saltwater Release Angler of the Year. Bill is an I.G.F.A. International Committee Representative and a longtime member of the Virginia Saltwater Fishing Tournament Committee. He is the Virginia Recreation Fishing representative on the ASMFC Striped Bass Management Panel and is a past recipient of the CCA-VA Virginia Outdoor Writer Conservation Leadership Award.

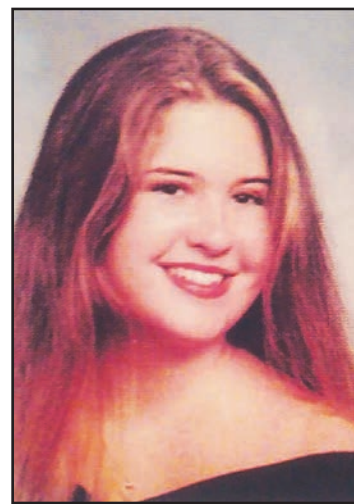

Commission Overlooks Women

Dear Editor:

Let's talk about the oppression of women by the Accomack County School Board Selection Commission. The last three qualified females who have put their names in for consideration for the Accomack County School Board (Harrison, Turner and myself) were denied seats on the board by the commission, making way for what is likely to be a 67 percent (6-3) male dominated school board. The average reported by the National School Board Association recent survey is 54 percent with males having the slight advantage.

Male members of the current school board have helped recruit their male friends and in some cases even brought in their fellow board members to speak on behalf of their chosen candidates. This puts anyone who competes against them at a huge disadvantage. Sitting school board members should not be free to choose who they want to work with in a club-like

mentality. This is clearly not advantageous for the employees or the students of this county.

Until recently, there was a 55 percent (5-4) male majority on the school board. I have watched as female employees of Accomack County Schools have been repeatedly overlooked for positions for which they were well qualified. The positions were filled by male applicants. In one case, the employee held the interim position, was passed over, and was then demoted. In other instances, positions were merely filled by male employees without benefit of advertisement. They called this "reorganization of the central office."

The Shore is filled with intelligent men and women who should be given equal consideration for advancement in their chosen fields. We cannot continue to attract and retain high quality educators of both sexes if we do not treat all employees fairly.
