Cape Charles Residents Express Concerns About Proposed Coal Ship Anchorage

The U.S. Coast Guard has a new proposal to formally establish an anchorage three miles from Cape Charles and to locate another anchorage near the Chesapeake Bay Bridge-Tunnel, six miles from Fisherman Island, but will it appease Eastern Shore citizens after a similar proposal two years ago failed to gain public support?

The Coast Guard held two public meetings on July 10 at the Cape Charles Civic Center, headed by Capt. Kevin Carroll, the new commander of Coast Guard Sector Hampton Roads, whose area of responsibility includes the Port of Virginia.

Carroll explained to a full house of Cape Charles area residents and leaders why their view of the Chesapeake Bay had become so cluttered with ships over the past year or two and why it is necessary to specify the location and boundary of the Cape Charles anchorage, which is currently unregulated.

Coast Guard anchorages A and B, belonging to the Navy and located near Thimble Shoals Channel, once welcomed commercial vessels. That practice ended and drove ship traffic toward Cape Charles, where residents now often see more than two dozen vessels lined up in the bay at once.

Though some are container vessels, most are ships that transport coal – a high-quality coal used to make steel – after it arrives by the railroad from West Virginia.

That's another reason why there are more ships in the lower Chesapeake – there has been more demand for West Virginia coal since a mine in Queensland, Australia, was flooded, bringing long-term devastation to the coal industry Down Under.

Cape Charles anchorage must be regulated to create order and prevent accidents, Carroll said. He likened the current anchorage to an unmarked parking lot. Regulating the anchorage will be "safer for everybody."

Anchorage Q, which serves vessels that are quarantined, will be moved near Fisherman Island. The new

Northampton High School Parents Say County Can't Afford Not to Build

More than a dozen parents and grandparents of current and former Northampton students and other concerned citizens told county supervisors Tuesday night that "we can't afford it" is "not acceptable" as an answer to the structural issues at Northampton High School that require the facility to be heavily renovated or replaced.

The majority of supervisors are insisting on the cheaper option of heavily renovating the building even though structural engineering firm Speight, Marshall & Francis stated renovation would cost more than 60 percent of the price to rebuild and therefore would be cost prohibitive.

Supervisor Robert Duer spoke for himself and Su-

New Church Chemical Company Closure Leaves 16 Without Work

The 13.5-acre KmX Chemical Corporation in New Church was closed in late June due to “poor business conditions for recycled chemical,” CEO Hubert Fleming told the Eastern Shore Post this week.

“The plant has been placed in care and maintenance with the objective of selling to a strategy owner who will re-start and operate,” Fleming said in responding to an email query. “There were 16 full-time employees who lost their jobs. Several have been hired back on contract to keep the plant in care and maintenance. However, there are no ongoing operations.”

The term “care and maintenance” is defined by www.dictionary.com as “the state of a building, ship, machinery ... that is not in current use

although it is kept in good condition to enable it to be quickly brought into service if there is demand.”

Fleming stated, “With regard to stored chemicals, all operating permits, including environmental permits, will be maintained. There is minimal chemical inventory at the plant, and the plant facilities will be continuously monitored.”

The solvent reclamation facility advertised on its website as adhering “to the highest standards for permitting, compliance, environmental protection, product quality, and safety and traceability. We are committed to continual process improvement, quality assurance, product safety and quality control.”

A notice sent to Accomack County regarding the company’s plan to close was dated June 15. “Because of

a continuing poor business climate for our products, New Church operations will cease with all operations and activity, as of end of day June 29, 2018. KmX and our investors did not take this decision lightly. We value the relationships we have developed with all of our customers and vendors and recognize that this decision has an impact and hope that we can help minimize that as we work through this process in the coming days.”

KMX Chemicals purchased the plant in 2004. In 2015, the company vowed to invest \$2.075 million to expand its facility and ramp up production. It began development of specialty membranes for separation and recovery of valuable chemicals and water treatment in 2005. A \$40,000 grant from the Commonwealth’s Opportunity Fund to as-

sist with the project was awarded. The company was also eligible to receive state benefits from the Virginia Enterprise Zone Program, administered by the Virginia Department of Housing and Community Development.

“KmX notified DEQ on June 27, that they would be closing on June 29,” DEQ Deputy Regional Director Janet Weyland said Thursday. “KmX has an air permit, an industrial storm water permit, and although they do not have a waste permit, as a waste generator, there are regulatory requirements that they will need to follow,” she continued. “We will be monitoring them through inspection and reporting to ensure that they are complying with their permits and all regulatory requirements.”

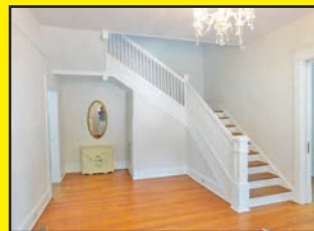

Cape Charles anchorage will become Anchorage R.

The current anchorage is 2.5 miles from the town. The new anchorage will be three nautical miles away.

Carroll admitted to the audience, "It's probably not as far as you want it," but any farther, and the anchorage would be in the York Spit Channel. To avoid collisions, ships do not anchor in navigable channels.

The anchorage must be located in naturally deep waters, due to the Virginia Marine Resource Commission's limited funds for dredging, Carroll said.

The proposed anchorage location boasts 50-foot depths. The waters near Kiptopeke are too shallow to locate an anchorage, he added.

One benefit of the new anchorage location is that it would allow local boaters access in and out of Cherrystone Inlet.

But locals were more concerned with the environmental consequences.

David Kabler, a real estate agent, said because of the amount of coal washing up on the beach, the Eastern Shore would have to change its motto from, "You'll Love Our Nature," to, "You'll Love Our Coal Ships."

Northampton Supervisor John Coker said he was "scared to death" because the town of Cape Charles and Northampton County were assuming "all the risk" and gaining "no benefit" from the anchorage. No ships will be docking at Cape Charles harbor to do business in town because of the proposal.

Ken Dufty pointed out that the Coast Guard had proceeded with its proposal

without preparing an Environmental Impact Statement as required by the National Environmental Policy Act.

Northampton Planning Commissioner Janet Sturgis frowned and stared down Carroll as she contended that ships were discharging effluent, or treated sewage, into the Chesapeake Bay.

Chlorine, often used to treat sewage, can kill shellfish like oysters and clams that play a huge role in the Shore's aquaculture industry.

Carroll stated that by law, when ships are three miles off the Chesapeake Bay boundary line, the valves that would release sewage must stay locked.

It was not until late in the meeting, nearly an hour past its scheduled end time, that Carroll openly admitted the Chesapeake Bay is not a no-discharge zone and ships are permitted to discharge treated sewage.

Jay Ford said his organization, the Chesapeake Bay Foundation, requested the Virginia Department of Environmental Quality petition the Environmental Protection Agency to make the Bay a no-discharge zone.

Already aware of the issue, Coker had drafted a resolution he presented to his fellow Northampton supervisors later that evening, requesting, among other considerations, that "a 'No-Discharge Zone' be designated at any proposed anchorage site in the Chesapeake Bay and that the USCG be notified by the Commonwealth to enforce the no-discharge zone."

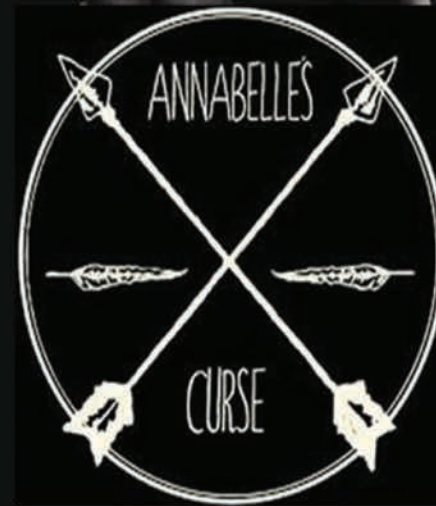
Supervisors planned to send the resolution to Gov. Ralph Northam and other state politicians. It passed unanimously.

supervisor Oliver Bennett, saying, “not 100 percent” of supervisors are against the idea of building a new school.

But a continual source of contention for all supervisors is the more than \$40 million price tag that could accompany a new high school.

A funding analysis, presented by financial consulting firm Davenport & Company for supervisors on June 25, assumed a new high school would

cost \$40.5 million.

Northampton schools Chief Financial Officer Brook Thomas used data from the Virginia Department of Education to estimate that the school would cost nearly \$40.7 million, or about \$44 million including engineering costs and a contingency.

During their July 10 meeting, supervisors repeatedly mentioned they did not want to “shackle” or “hand-cuff” Northampton to a 20-year debt commitment that would result in the county paying \$40 million for a high school plus more than \$30 million in interest over the life of the loan.

Chairman Spencer Murray dubbed himself and his colleagues “mean old supervisors who must not care about education.”

Supervisor David Fauber asked the school board about funding a new facility: “Your budget is as big as ours, can you finance it on your own?”

Helene Doughty, a Northampton County Education Foundation board member and parent of two Northampton students, one graduate and one 10th grader, was the

first citizen to speak about the financial dilemma.

“You may retort with the fact that the county does not have the financial capacity to absorb the cost of the school. Do you have the financial capacity to absorb the cost associated with a structure failure and the injuries and/or death ... that may be the result of an accident?”

“Do you have the financial capacity to absorb the cost associated with the casualties due to the lack of shelter for Northampton County citizens following an emergency situation?”

“The county has had the financial capacity to build a new court complex, a regional jail, but will not invest in education, therefore the future of its citizens,” Doughty stated.

Lynn Bowen, whose daughter is a Northampton student, said she was thinking about the Latin phrase, “in loco parentis,” referring to the legal obligation of an organization to assume parental responsibility for children in its care, and she believes Northampton’s 702 middle and high school students “are of greater import

than the ... 25 to 40 million dollars it would cost to build a new school.”

Leslie James, a 16-year Northampton teacher and parent of three current and former Northampton students, is also concerned about safety conditions at the high school. She described her experience there during an in-service training event on Aug. 23, 2011, when an earthquake occurred and she “witnessed the outside wall of that cafeteria wiggle like a worm.”

“Those were adults in that room at that time. ... Imagine if it had been children and something worse had happened.”

If the county had the foresight to start saving for a new school 20 years ago, Tuesday night’s meeting may not have been necessary, James continued.

“Too bad the emphasis was put on the atmosphere of the elected officials and the incarcerated of our county rather than the atmosphere for the education of our children,” she said.

Other speakers also indicated they sensed a disconnect between Northampton supervisors and the school board and its supporters.

Michelle Surran said, "It's very much an 'us versus them' kind of feeling. ... Our frustration is, we hear, 'No, you're not getting \$45 million, period.' We're not hearing, 'No, you're not getting \$45 million, but here's what we can do.'"

Heather Colson's hands and voice trembled as she described how "terrified" she was for her daughter, a rising seventh grader, to attend the middle and high school.

Then Supervisor John Coker interjected what he termed a "civics lesson."

"The maintenance of the schools ... it's not our responsibility," he said.

A female audience member muttered, "I can't listen to this," and walked out of the room.

Murray attempted to close the citizens information period, but the Rev. Kelvin Jones stood up to address Coker.

"To say that it ain't your problem ... basically, you're saying what matters to us doesn't matter to you," Jones said.

When Coker denied the accusation, Jones continued, "Your whole posture,

your whole demeanor, says to us ... you don't want to hear what we have to say. ... Presentation is everything."

Coker blamed the school board for "sitting on" \$2.5 million in capital funds instead of repairing the high school and said supervisors have never withheld funds to fix anything in Northampton schools within the past five years.

According to Thomas' estimate, performing all necessary repairs to the high school's interior and exterior walls and replacing the roof would cost \$23.2 million.

School board member Jo Ann Molera gave supervisors more food for thought, questioning whether the walls of the school would be able to support the weight of a new peaked roof in place of the existing flat roof.

She also explained the school board had held back on pursuing extensive repairs at the high school because the previous county administration had led the school board to believe a five-year plan was in the works to replace the building.

Northampton schools Director of

Operations Chris Truckner added, "I want to make these repairs, but I also don't want to waste the taxpayers' money if we know ... you can't renovate something that's deteriorated to that magnitude."

Murray said, "I've been wrestling with this problem for about 10 years."

But within the past eight years, the cost of roof replacement alone has risen 34 percent, Thomas said.

Northampton citizen Ann Hess asked what it would take to start a five-year plan. Murray informed her that supervisors had agreed with the recommendation of Northampton schools Superintendent Eddie Lawrence to form a committee of school board members, supervisors, citizens, and others to work through all possible options and create a staging plan for fully repairing or rebuilding the

high school.

"Any idea is a good idea," Murray said.

Hess believes there are "creative ways we can do this without taxing a lot of people who don't have tax money," and she asked, "How much money can you pour into a building that's falling down?"

Murray admitted the building is aged, but not "falling down," though Truckner had shown a photo of the exterior wall where a loose brick had been removed to prevent it from falling. A cement block has also fallen out of the interior wall of the high school music room.

Lawrence also suggested supervisors hire an independent structural engineer to give them a second opinion on the condition of high school and whether or not it is repairable.

Northampton Grand Jury Indicts 13

The New York City man who led police on a high-speed chase across both the Chesapeake Bay Bridge-Tunnel (CBBT) and the Hampton Roads Bridge-Tunnel (HRBT) last February was indicted Monday by a Northampton Grand Jury on a felony count of eluding officers.

The pursuit started around 2:30 p.m. Friday, Feb. 23, on Lankford Highway, after Chief Marc Marshall of the Cheriton Police Department clocked Patrick Nilo Gil, 46, of Union Turnpike, driving his silver Mercedes SUV in the town going 87 mph in a 55 mph zone.

Seventeen misdemeanor counts including reckless driving, reckless driving by speed, aggressive driving, not having a driver's license, having a fictitious registration, and passing on the right were also certified to the grand jury last week. They will be heard by the court when the felony charge is tried.

In Virginia Beach General District Court, a preliminary hearing is scheduled on July 20 for charges against Gil that include malicious wounding of two officers in connection with the chase.

"While driving across the CBBT the suspect driver attempted to hit a CBBT police officer who was out of his vehicle on the bridge," a Virginia Beach Police Department (VBPD) release stated. "Near the end of the bridge in the 4400 block of Northampton Boulevard," VBPD "officers were attempting to deploy stop sticks to stop the vehicle. This attempt failed and the driver continued ... driving recklessly at a high rate of speed." The race finally stopped with a crash involving seven other vehicles in the tunnel.

Gil is being held without bond in the Virginia Beach City Jail. A bail determination sheet stated he was unemployed when the incidents occurred. His prior convictions include robbery, burglary, and felony possession of stolen goods.

In another case, Nicholas Wilson, 24, of Larkfield Lane in Charlotte, N.C., was indicted on a count of abduction that occurred April 27 at Sunset

Beach Resort.

Deputy Montego Johnson of the Northampton County Sheriff's Office (NCSO) was dispatched to the resort for a domestic complaint. In the warrant, Johnson wrote, "Manager Jerry Tims saw Wilson hit (victim, Kaylon) Miller twice and pull her back into the room and (he) would not let her leave ... Also, I was advised that he took her cell phone and would not give it back to her."

Court records stated he was "very apologetic" when he was brought before the magistrate.

Jermaine Lasharn Edwards, 36, of Colorado Street in Gadsden, Ala., was indicted on a count of possession of cocaine. Master Police Officer M.D. Smith of CBBT Police Department investigated.

Weston Curlett, 43, of Paddock Road in Smyrna, Del., was indicted on a count of possessing heroin on Feb. 28. Deputy Christopher Forbes of NCSO investigated.

Dwayne Lamont Sample, 19, of Madison Avenue in Exmore, was indicted on a count of stealing a vehicle belonging to Bryan McCracken on April 19 and stealing more than \$200 that belonged to Wydell Walker on May 5. Officer Tom Lunch of the Cape Charles Police Department investigated the vehicle theft. Sgt. Jason Campbell of the Exmore Police Department handled the latter case. Sample is being held in the Eastern Shore Regional Jail (ESRJ).

Printice Wiggins, 60, of Cape Charles, was indicted on a count of possessing cocaine on May 20. Deputy William Lewis of the NCSO investigated.

Marcos Nunez, 29, with addresses on Leigh Street in Portsmouth, Va., and Jason Drive in Elizabeth City, N.C., was indicted on a count of possession with intent to distribute between a half-ounce and five pounds of marijuana on May 4. Carrol Baker Jr., 32, of Lee Street in Exmore, was charged with obtaining by false pretenses a 2004 Ford Explorer belonging to Second Chance Auto Sale on June 30. He was arrested July 6. Unsecured bond was set at \$1,000. Deputy K. McGregor of the Accomack County Sheriff's Office (ACSO) investigated.

Kyle Raftery, 25, of Richmond Avenue in Onley, was charged with felony DUI and consuming alcohol while driving on a public road. Records show Raftery was convicted of two prior offenses of DUI in the last five years. A test of the suspect showed .15 grams

A Pungoteague man who shot a trespasser on his property in 2015 was given a suspended sentence in Accomack Circuit Court last week.

Christopher William Floyd, 57, was sentenced to three years with all but the four days he served in jail suspended for unlawful wounding. He pleaded no contest to the crime in 2016. Floyd was put on supervised probation for five years and ordered to do 50 hours of community service.

The probation department will determine if he needs anger management sessions, said Judge Glen Tyler. The judge added he was glad to see the defendant comprehends the "severity of his actions."

The victim was Louis E. Lilliston of Greenbush. Floyd was initially charged with malicious wounding, use of a firearm, and misdemeanor reckless handling of a firearm. Floyd agreed to make restitution for medical care and damage to Lilliston's truck. He had paid \$2,000 of the approximately \$6,000 bill when the sentence was given.

Shane Lee Williams, 18, of Painter, was sentenced to a total of eight years for six counts of assault and battery of police officers, which occurred when Williams was 17. Half the time was suspended on the condition that he comply with a youthful offender program.

According to testimony, Williams has been in the Norfolk Detention

GROUP RAISES AWARENESS ABOUT PERILS OF SEISMIC BLASTING

Reports on the devastating impact of major oil spills are well-known, from the Exxon Valdez spill in 1989 to the Deepwater Horizon spill 21 years later, but even the method used to find oil can be dangerous to marine life.

Local efforts by an international organization for ocean conservation, Oceana, are helping drive the movement against offshore drilling in Virginia by creating public awareness of the risks it poses not only to Eastern Shore citizens but also to marine life in the surrounding waters of the Atlantic Ocean and Chesapeake Bay.

It's called seismic airgun blasting, and it uses pressurized air blasts to create sound waves that penetrate through the water to the ocean floor — where oil deposits are hidden — and echo back to the surface.

These airgun blasts generate some of the loudest noises in the ocean after military explosive testing. A ship tows an array of 12 to 48

airguns at once, blasting every 10 to 12 seconds for several days, weeks, or months. They can be heard underwater up to 2,500 miles away — the same distance as a flight from New York to Los Angeles.

The blasting can damage the hearing of some fish and elevates stress hormone levels in others, impeding their survival. It elicits varying levels of alarm response in fish, affecting their speed, schooling patterns, and position within the water column.

As a result, catch rates are reduced by 40 to 80 percent for fish like rockfish, blue whiting, haddock, and Atlantic cod.

Seismic blasting can negatively impact the development of shellfish and cause physical injury or even death.

It also affects whales, who rely on sound for communication, navigation, and feeding. Seismic blasting can interfere with whale communications and impair their hearing. It also elevates whale stress hormones,

leading to a compromised immune system and behavioral changes.

Seismic blasting has led to reduced or silenced whale calls, disrupting communication between females and their young or potential mates.

Sea turtles will erratically swim away from blasting and can become entangled in survey equipment.

Since President Trump signed an executive order in April 2017 to expand offshore drilling and the Department of the Interior reversed a Jan. 2017 decision to deny seismic blasting permits, Oceana is concerned that the issuance of these permits is imminent.

Approval of the blasting permits could result in overlapping survey areas and increased impact on marine life.

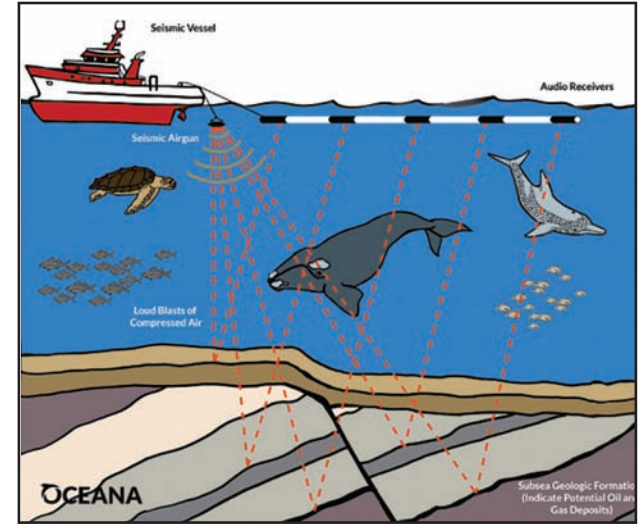

The Bureau of Ocean Energy Management is the permitting agency for seismic airgun blasting. The National Marine Fisheries Service also would have to approve Incidental Harassment Authorizations before blasting could begin.

In the event the permits are approved, Oceana recommends action to mitigate the impact to marine life, such as third-party observation of whales, dolphins, and sea turtles and stopping blast activity when those animals are present.

Seismic airgun blasting is also discouraged during the calving or nesting seasons of threatened or endangered species of marine mammals, sea turtles, and fish.

As a greener, more economically beneficial means of energy production using offshore resources, Oceana recommends offshore wind instead of offshore drilling.

Offshore wind would create 1.5 times more Virginia jobs than off-

shore drilling, which would create no jobs on the Eastern Shore.

Offshore drilling would threaten about 91,000 Virginia jobs, 95 percent of which belong to the tourism and recreation industry that contributes about \$5 billion to the state's gross domestic product. More than 3,000 miles of Virginia coastline are also at stake.

"Offshore wind produces clean and renewable power that helps cut carbon pollution and does not run the risk of a catastrophic oil spill that could threaten fishing, tourism and recreation," Oceana's promotional materials state.

"When oil and gas run out, so do the jobs, but Virginia will never run out of wind."

Center for the last 14 months.

In another case, Victor Manuel Scott, 28, of Wayne Drive in Bloxom, pleaded guilty to hit-and-run and driving without a license in connection with incidents that occurred at the intersection of Lankford Highway and Gargatha Landing Road on Jan.10. Sentencing guidelines and evaluation for a rehabilitation program were ordered.

Brandon Scott Parks of Melfa was sentenced to five years in prison each for two counts of distribution of Buprenorphine, an opioid, with all time suspended on the condition he completes a rehabilitation program. He was remanded to jail "for his own protection. He just can't resist" taking drugs, Judge Tyler said. Restitution of \$185 was ordered.

Tyrell Roshawn Northan of Onancock was sentenced to five years in prison with all suspended for distribution of cocaine with the condition that he complete a rehab program. The offense occurred in October 2016. He has al-

ready served 15 months in jail and said he had a lot of time to think about the changes he needs to make in his life.

Gesner Elta Duverny, of North Miami, was extradited from Florida to face charges of arson with intent to defraud and fraudulently obtaining more than \$200 from State Farm Insurance Company in May 2013. He was granted a secured bond of \$15,000 last week.

Making the Most of the Hot Summer Days

In an email survey conducted this week by the Eastern Shore Post, the top choice for ice pops was grape at 29 percent, ice cream was mint chocolate chip at 18 percent, vegetables was squash at more than 35 percent, and the beach was Assateague about 31 percent. Nearly 28 percent of participants said the best way to cool off is to stay inside where it's air-conditioned.

Priscilla Fluhart of Painter went with the top choice of grape for ice pops. But her favorite vegetable was a hands-down "corn on the cob. I can remember the smell of hot corn on a lazy summer day in my grandparents' kitchen in Quinby."

Her ice cream pick — "It's a toss of up between coffee and mint chocolate chip," she wrote.

Fluhart picked Cape Charles Beach as her favorite. "I like it because you can lay lazily in the water without the waves pushing you everywhere." For fishing, "My fond memories of going on the water with my church family and fishing" are from Harborton.

She also disclosed that the secret to great ice tea is to "brew it slowly." Badminton is her favorite sport. "It requires little skill but it's a lot of fun."

Don Amadeo of Tasley picked "the blue ones" for his ice pop pick and

vanilla bean for ice cream. He makes "a mean squash and cheese bake. They serve it "on a toasted bun with grilled pineapple rings, bacon and an islands-inspired homemade BBQ sauce. It knocks your taste buds for a delicious loop!" Amadeo said.

Nancy Kubar-Page of Parkley said her favorite beach is on Metompkin Island. She wouldn't divulge where she goes fishing but she gave away the secret to great iced tea. "I like to use at least one small bag of Constant Comment to give it a little zing and to add just a hint of sugar."

Amy Eckard of Temperanceville didn't mind telling her favorite fishing spot. "Ray's Shanty," she wrote. Her favorite way to stay cool is also her choice of the best summer sport — swimming in the ocean at Assateague.

Anthony LoFaso of Onancock's secret for iced tea is to "sun brew it with oranges and lemons." His favorite summer sport is baseball. When outside working, he said to keep cool he puts a wet rag on his neck and shoulders.

Meriwether Payne of Locustville said Dawson's Shoal has the best beach and Parramore Reef has the top fishing.

Yvonne LaChapelle of Greenbush said the bourbon caramel crunch

ice cream from Island Creamery on Chincoteague is the best. She likes peach cobbler and lying on the beach with a book too.

Chesterfield's Harlye Turner led off the seventh with a single, but was thrown out while attempting to steal second by Shore catcher, Konkel. Travis then struck out the next two batters to give Shore an exciting win, finishing the game with 10 strikeouts and no walks during her time on the bump.

Shore's next game later that day was against the host, Honaker, who had a morning bye. Honaker's pitcher threw a one-hit shutout and led the District 11 team to a 14-0 win.

Shore scored two more in the bottom of the fifth, and Konkel found her way home on a base hit, followed by a double to the fence by Travis. Parks drove her in with a base hit to left.

The afternoon game would be a rematch with Chesterfield to decide who would advance to the championship round against Honaker. The Travis-Doherty matchup proved much the same as Game 1, with each pitcher dominating for four innings. Chesterfield scored three runs in the top of the fifth to take the lead. Shore answered with two runs in the bottom of the sixth.

The District 11 Honaker team was undefeated in both the district and state competitions, and will advance to Regionals in Salisbury, N.C.

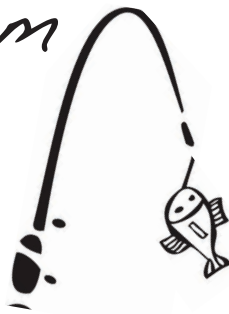

Fishing from the Shore

Just as the offshore fishing action heats up, along comes the unusually early formation of a tropical storm off the coast of the Carolinas, sending strong winds up the coast and putting a halt to most of last weekend's fishing activities. The winds should start to calm down during the week and hopefully things will have settled down in time for this weekend. Until then, enjoy this weather shortened report.

Lower Shore – Chris Snook of Chris' Bait & Tackle was quick to report that “not much happened” over the weekend. Most of those that attempted to venture out returned quickly with their tails between their legs. Just prior to the winds, the fourth island of the Chesapeake Bay Bridge-Tunnel produced some large spadefish. Spadefish were also caught around the Plantation Light. Flounder fishing along the bridge was described as “hit-or-miss” with some boats doing decent, while others were shut out. Cobia were still being cooperative during the day and red drum were biting during the evenings. Sharks were hitting both day and night. Small croaker were still biting out of Oyster.

Jeb Brady of Bailey's Bait & Tackle echoed the spadefishing action at the fourth Island and Plantation Light before the blow, describing it as “being on fire.” Cobia seemed more abundant on the surface, much to the delight of sight casters. The pier at Cape Charles was producing sand mullet and a few spot.

Wachapreague – Captain Lindsay Paul of Trident Tackle reported prior to it “blowing a gale,” he found a pair of gaffer dolphin along the 20-fathom line. The marlin bite was also strong with both blue and white marlin releases registered. However, tuna were noticeably absent in the offshore catches. Flounder limits were coming from some of the wrecks, but fishing was slow and vessels were taking most of the day in doing so. Inshore anglers were finding a few small flounder, but the keeper ratio was not good. Paul is hoping the storm stirs fishing activity up for the better.

Chincoteague – Jimmy Vasilou of Captain Steve's Bait & Tackle said the wrecks off Chincoteague have been hot, with his captains limiting out on flounder in 3-of-3 trips last week. Jigs, such as 2- to 3-ounce Pop-eyes with long strips of squid were the top producing baits. Some spadefish and triggerfish were also among the catches. Further offshore, catches of dolphin (mahi mahi) were reported near the Washington Canyon, and an 83-pound yellowfin was caught at the Parking Lot. In the surf, kingfish/whiting and spot were hitting

bloodworm baits. Inside the inlet, flounder catches were reported in Curtis Merritt Harbor, while croaker catches were coming from the waters off Memorial and Robert Reed Parks. Shark action was described as good with one boat landing approximately 40 over a period of a couple of days.

Donna Rae of Captain Bob's Marina reported that flounder fishing remains constant in Chincoteague Channel and on both sides of Queen Sound. Only about one out of every 10 flounder is a keeper, and there are plenty of bait stealers around in the form of undersized black sea bass, pufferfish, and the occasional bluefish. Croaker and kingfish catches were being made closer to the inlet. Sharks, whether wanted or unwanted, are providing the most action for anglers. Larger flounder are coming from the inshore ocean structures, as well as mostly undersized black sea bass. The offshore wrecks were producing keeper-sized sea bass. Rae claimed that there had been a steady yellowfin tuna bite at the Washington Canyon and on the east side of the Parking Lot. Anglers have also returned with catches of dolphin.

Upper Shore – Captain Matt Abell of the Sea Hawk Sports Center reported that due to the recent weather, there was not much fishing to talk about. Before the winds, there had been a decent flounder bite in Metompkin Inlet. He described the fishing over the railcars as just “O.K.” Offshore, there have been some marlin releases but very few tuna, and the tuna that were found were very deep. The Parking Lot had produced mostly false albacore and dolphin, with sea bass being pulled from the Parking Lot wreck. On the Chesapeake Bay side, bluefish were hanging around the ships off Tangier Island, while striped bass and white perch were in the mouths of the southern Maryland rivers.

Bill Hall was the first Eastern Shore resident to achieve Virginia Salt Water Master Angler Status. He has been named Virginia Saltwater Angler of the Year and Virginia Saltwater Release Angler of the Year. Bill is an I.G.F.A. International Committee Representative and a longtime member of the Virginia Saltwater Fishing Tournament Committee. He is the Virginia Recreation Fishing representative on the ASMFC Striped Bass Management Panel and is a past recipient of the CCA-VA Virginia Outdoor Writer Conservation Leadership Award.

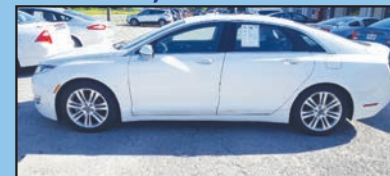

The big Broadway musical "Kiss Me, Kate" is coming to the small North Street Playhouse stage this month and those involved couldn't be more excited.

"This is the heart of musical theater," said Cat Yudain, who plays the dual role of Lois Lane/Bianca.

When it came to choosing this year's show, associate producer Mary Stiegelbauer said Playhouse artistic director Terry Bliss gave her a short list from which to choose. Stiegelbauer needed a show with a large ensemble to sustain the internship program. "That was the big criteria," she said, and "Kiss Me, Kate" filled the bill.

"This is a fun show. Your guys are playing actors who are doing shows. Everything is going wrong, and the audience is in on the joke," she said. "Because it's Cole Porter there is a lot of music and big dance numbers. It's classic Broadway."

The musical brought a new element to the North Street stage: moving set pieces.

"Every time I come to this theater something new and wonderful has changed for the better," said featured dancer Jimmy Wencel. He plays Flynt/Gremio.

Wencel has made many appearances on the Playhouse stage, most recently as Chip in "The 25th Annual Putnam County Spelling Bee" and as Benny in "Rent. "To do a very classic piece of musical theater is a no-brainer. You do it!"

It's also a no-brainer for fellow North Street Playhouse alumni Yudain, Jimmy Lee Brooks III, and Will X Stanley. This group forms a core company, members of which may shift with ease among acting,

dancing, directing or choreography. "This team gels really well," said Stiegelbauer, who is also a member of the group and is based at the theater. "Doing this is hard enough, so when you meet people who speak your language, you tend to want to keep them around."

Yudain echoes that sentiment. "I love the feel of a company. The more you work together with people, the tighter your work becomes."

That familiarity works to Brooks' advantage as choreographer, allowing him to arrive with an outline in mind, adjusting to the stage as they go. "It's easier once the actors are there on the stage," he said.

Even though the musical is familiar and might carry audience expectations, "I try to steer clear of what's expected so I can put my own stamp on it," he said. Brooks also has an acting role as Paul.

It will be a modern touch to a musical that was written in 1948, winning the industry's first Tony Award for best musical. "It was a time when people were coming back from war," said director Will X Stanley. "People wanted to go out and spend three hours watching shows." In the original score, three different songs had three encores. He has been tapering the show to suit a modern audience while maintaining the integrity of the musical. "Pacing the play has been a challenge — the biggest challenge."

It may be the biggest production challenge, but Stiegelbauer had a huge pre-production job wading through 400 online auditions to find professional actors to round out the cast. After she weeded out incomplete or otherwise unacceptable applications, she, Stanley, Brooks,

and Bliss made the selections through a collaborative process.

Hayward M Scott was one of those selected. "I didn't expect this type of company with this level of commitment," he said. He plays Man 2, a gangster, and although he hails from Los Angeles, the area is not completely foreign to him: his mother lives in Rehoboth Beach, Del., and he once came to the Eastern Shore of Virginia to make photographs.

"I love that they encourage theatre arts" with the intern program, now in its third year. The Nandua High School interns told Scott their school does not offer drama classes or club. "I cannot imagine a high school without theater arts," he said. "These kids are so committed. They want to learn."

He is equally impressed with his professional colleagues. "They put together a really nice group," adding that it's a relief there are "no divas."

Caitlin McKechney may not be a diva, but she portrays one, filling the part of Lilli Vanessi/Katherine. The actor lives in New York but was raised in Lake Bluff, Ill., a town that reminds her of Onancock. "I played Kate right out of high school and knew I wanted to play the role again now that I'm a little older. It's suited for someone with classic chops," said the operatically trained singer.

Sharing real-world experience about living as a professional performer with interns is behind her desire to mentor young actors. "I had no idea what that life looked like," she said. Paired with that tough lesson is "the joy of creating a character and creating a great musical." She tries to balance the two, but believes she owes an honest assessment to her young protégés. "I've lived all over the United States and I'm so grateful, but it comes with a price."

She said it's common for visiting actors in small theaters to stay with local families. The "Kiss Me, Kate" professionals are being housed with hosts in the community. It's one way that the area shows its support for the theater and the actors.

"Everyone has been so nice and hospitable," said Scott. He has been on a quest for the area's best crab cake and has received many recommendations and has eaten many fine crab cakes as a result.

Ultimately, it's all about the show, which opens July 19 for eight performances. (See details in the ad on Page 13.) "Rent" and last summer's "Young Frankenstein" both sold out their eight-show runs, so North Street Playhouse encourages early ticket purchases. Educational Opportunities for Military Survivors, Veterans, and Dependents

As career fields become more technical, so does the training. The cost of attending college is steadily increasing, causing a spike in student debt. In Virginia, some residents may qualify for college tuition. Under the Virginia Mil-

itary Survivors and Dependents Education Program (VMSDEP), eligible military and veteran recipients can receive educational assistance, for a total of 48 months of tuition and fees, to spouses and children of military service members killed, missing in action, taken prisoner, or veterans who became at least 90-percent disabled as a result of military service in an armed conflict. This program was formerly called Virginia War Orphans Education Program.

NOTE: A veteran's 90-100 percent disability must have been directly caused by the veteran's involvement in: 1) military operations against terrorism; 2) a peacekeeping mission; 3) a terrorist act; 4) an armed conflict subsequent to Dec. 6, 1941. The service connected disability cannot have incurred during active duty that coincides with, but was not the direct result of, one of the listed events/missions.

To be eligible for assistance under VMSDEP, an applicant must meet eligibility requirements. If the qualifications are met for the VMSDEP program, an approval letter will be mailed to your home and a copy will be sent to your school. Your institution's business office and financial aid office will bill the state

for financial aid purposes.

VMSDEP applications are submitted online; the paper application is no longer available. Visit <https://vmsdep.dvs.virginia.gov/Application/Login/Login.aspx> to apply.

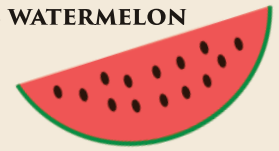

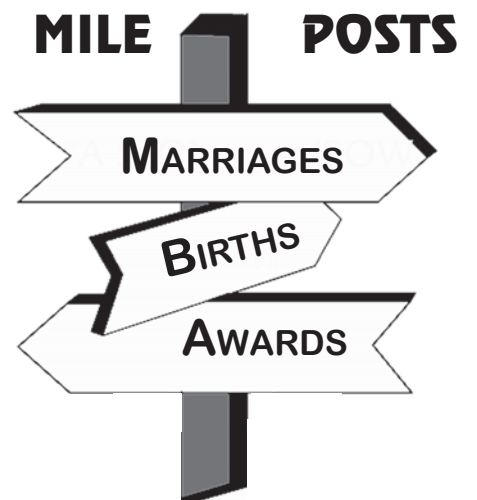

Agricultural Best Management Practices Cost-share Sign-up

Farmers and landowners may receive financial assistance for planting a winter cover crop under the Virginia Agricultural Best Management Practice (BMP) Cost-share Program administered by the Eastern Shore Soil and Water Conservation District. The cost share is an incentive to offset a portion of the establishment costs for a practice that reduces erosion and the leaching of nutrients to groundwater. **Sign-up is July 16 through Aug. 17.** Several different programs for fall cover crops are offered.

Due to new program changes, Nutrient Management Planning funding is no longer available for acres that have previously received funding within the last 18 months. However, there is a VA State Tax Credit available for soil testing in support of a Nutrient Management Plan. Current Nutrient Management Plans written by a certified VA Nutrient Management Planner are still required prior to receiving cost share for any approved bmp. Please see District Staff for more information.

For those practices that are unfunded yet still planted to DCR's specifications, VA Tax Credits will be an option. If interested in VA tax credits, sign-up will be taken for those as well.

To apply for either of the practices, farmers or landowners should contact the district with a list of FSA Farm, Tract, Field numbers and acres they wish to enroll by Aug. 17.

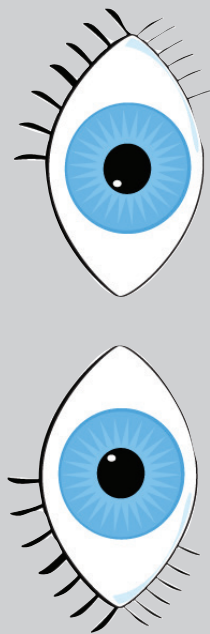



Sec. 24-1 Definitions

Antenna means any apparatus designed for telephonic, data, radio, or television communications through the sending and/or receiving of radio frequency waves. Tower means any structure that is designed and constructed primarily for the purpose of supporting one or more antennas, including self-supporting lattice towers, guy towers, or monopole towers. App Uses Words To Find Locations

What3words is a company, an app, and a geocoding system that allows you to locate any 1-meter-square section on earth by typing in that square's three-word designation. It doesn't seem possible, but the company uses an algorithm to map out the entire earth into these roughly 10-foot squares — 57 trillion of them. And each with its own three-word designation.

What3words is not a navigation system. It won't map out how to get from one square to another. But in situations where a location does not have a precise street address, the app can be invaluable. If the Post's editor, Connie Morrison, wanted something delivered to the back of the Post's building, she would have to give cumbersome directions about how to get behind the 4 Corner Plaza and then how to identify which back of the building was the Post's. But if the delivery service had the what3words app, Connie could just say, "Make the delivery at wings.stupidly.vitamin," and the delivery person could see the exact spot to make the delivery.

What3words CEO and founder Chris Sheldrick formerly worked in the music industry, helping to set up gigs all over the world. Because some of these music sites were at places without addresses, Sheldrick tried to use longitude and latitude to pinpoint where equipment had to be delivered. But longitude/latitude use multiple digits that can be difficult to enter correctly. The what3words app assigns an easily remembered three-word designation to longitude/latitude locations.

Using the app or the company's website, you can locate the 10-foot-square patch you want identified and the app will supply the three words. Or you can enter a three-word combination that you already know, and the app will take you to that square. The map shows either streets or a satellite view. If you're in a crowded plaza in Venice or on a miles-long beach in South Africa or at our own Savage Neck Dunes and you want a companion to find you, you can locate yourself, get your three-word designation, and send it to that companion. But keeping friends together or getting deliveries to the Post are not the most significant applications for what-

3words. The app can be used for everything from mail delivery to car navigation. For disaster relief, the advantages in pinpointing where aid is needed will be significant.

What3words is operating in 26 languages and has partnerships with a variety of companies and countries. Mercedes, for example, has invested in what3words and is building the technology into its cars. You won't have to remember a street address. Instead, just say the right three words and the Benz's voice-recognition software will take you there. In Mongolia, you can put the three words on an envelope, and the postal system will deliver it—a large advantage in a country that is not fully mapped with addresses.

And when drones start making Amazon deliveries, you can tell Alexa three words and the drone will deliver your package to the front door, back door, behind the garage, or whatever 10-foot square you designate. Just be careful not to pick the 10-foot square on the top of that old maple tree in your backyard.

One time I invented a farm gate that closed automatically with the help of a concrete block and a length of rope, but the ingenuity of what3words surpasses even that. The three-word designations are permanent and therefore unaffected by new buildings, road construction that leads to renaming streets, or any other development that would cause changes to addresses. What3words uses some 40,000 English words that are reviewed for length, distinctiveness, spelling, and pronunciation. Also, dirty words get sorted out, so you can't find a place at poop.in.pants. But you can find plop.into.pans, which let's face it could happen in an emergency. Plop.into.pans takes you to Alice Springs, the third largest town in Australia's Northern Territory. Those Australians, crikey!

Areas of greater population get shorter words (easier for more people) while sparsely populated areas get jawbreakers like lattes.unmitigated.emotionalism (somewhere in the Antarctic). Also, three-word designations that are similar and can potentially be entered incorrectly are geographically separated so you can readily tell that you've entered the wrong three words.

For example, Front Street in Nome, Alaska, can be found by going to di-

gested.hamster.splat. If you're looking for Front Street but mix up your wee little rodents and enter digested.gerbil.splat, you'll be sent to Leningrad and will realize something's wrong.

The White House is a large complex so what3words offers many designations to choose from, one of which is just.trash.shiny. That's what3words, not my three words.

I don't exactly live on Lonely Street but I'm close: loners.wrist.dusts. That's my front porch. The curb in front of my house is located at steers.primary.progressive. The garden in my backyard is at sofa.attends.progressive.

I'm still searching the 10-foot squares on my property for more gallant combinations. Somewhere in my backyard is croak.toast.shortwave. Meh. In my driveway, you'll find crusts.tacky.dines, which is right outside the kitchen win-

dow so I'll give that one a pass.

A ten-foot square in front of the Post's building can be found at logs.laptop.deleted, which sounds either vaguely newsroomy or like a spy agency. If I've found the right building from the satellite view, I think the desk I use at the Post is in the output.whipped.resembles square, and I identify with two out of three of those words. Angie, a coworker, sits in placidly.blame.twisted — a trifecta.

You can't acquire a vanity three-word designation. (I tried for brilliant.funny.beloved, and the app sent me to Ceduna, South Australia.) But if you go to <https://what3words.com/> you can find three words that have been designated as your address or at least your one little 10-foot square on earth, out of 57 trillion of them. Brace yourself, however, because you might end up with something like squish.worms.today (Deltana, Alaska) or worse.

New Environmental Resources Available

Dear Editor:

The Eastern Shore Public Library has two new books in circulation that should be of great interest to all of us on the Shore.

The first is "Environmental Management of Animal Feeding Operations (CAFOS)."

The "location of manure storage should consider the proximity to water bodies, flood plains, and other locally sensitive areas. ... When improper disposal of animal wastes occurs ground water can become contaminated." The book includes pre-construction strategies that might create fewer impacts on water, soil, and air as well as the need to consider local citizens who are reluctant neighbors. "Concentrated" seems to be the operative word here.

The second is "Land Subsidence Mitigation."

With knowledge of the history of the Eastern Shore aquifers, the Chesapeake Bay "crater investigation suggests that it is necessary to be *especially conservative of groundwater use* (emphasis added) in the area" USGS 2016. The book deals with sea level rise, salt water intrusion and our sinking land (subsidence)."

You can go online at Amazon Books and read the first part of each of these books.

Attention: Anyone on the Shore who

has had two or more wells drilled on their property in the last 50 years should contact his or her representative on the county board of supervisors and give the location or locations, the reason for the redrills (e.g., ran dry, polluted, salt water intrusion) the aquifers used, etc. This is important information and you are a valuable resource.

"Eating Animals," a new documentary movie produced and narrated by Natalie Portman is in movie theaters now. Check online with the Naro Expanded Cinema in Norfolk or with a video streaming service to see this movie.

It mentions that the CAFO movement (confining chickens in barns) was actually started by a woman on Delmarva! The movie looks at factory farming and its negative impact on public health and the environment, as well as the exploration of possible solutions. Pollution of our air, soil, and water is often a trade-off for the acceptance of cheap, fast-grown food, which uses antibiotics and hormones. The movie spotlights the farmers who still practice more humane methods of raising animals for food and highlights the impact the industrial poultry megabarns have on families who live near them.

Be vigilant, get informed and let's hear every voice. Our land, our water, and our air are at risk. This is an important issue for all citizens of the Eastern Shore of Virginia.

Posted at Sea Level

This past weekend came with lots of memories, ones that began 50 years ago on July 6, when my mother and my stepfather were married. Two days later, the newlyweds, and my older brother and I, moved from Long Island, N.Y., to Painter, Virginia, to start an exciting new life in this faraway place.

Nineteen hundred and sixty-eight was one of the most turbulent years of the 20th century. Both civil rights leader Martin Luther King Jr. and Sen. Robert F. Kennedy of New York, brother of the late President John F. Kennedy and a former attorney general, were assassinated. One of the largest military campaigns of the Vietnam War occurred. Peace demonstrations and war protests were happening across the country. Riots broke out.

It was an extraordinary season in the baseball world and "Hey Jude," by the Beatles, was the hottest single record.

Before that, yes, I went to a Beatles movie and screamed with delight when George Harrison appeared, and, yes, the music was on vinyl and, yes, I watched the news every night with Walter Cronkite, even though I was nine years old and, yes, we talked about current events and what happened in our lives every night at the dinner table and we all sat there until everyone was finished including Mom,

who was the slowest eater on earth.

The summer of 1968 was the shortest one I can remember as a kid. I had been cheated out of vacation time because school let out in New York in late June and started at Belle Haven School (now ESO) in August. I can remember the timeline because of where I lived. There was BESVA (before the Eastern Shore of Virginia) and AESVA (after).

The area was a different place back then. The only store at 4 Corner Plaza was the Acme Market, where Panzotti's and Don Valerio's now do business. The rest was a field. There was no McDonald's, no Wendy's, no Chinese restaurants, no Italian restaurants, and the other shopping center in Onley hadn't been built yet. There were hardly any traffic lights and lots of migrant labor camps.

Exmore was a busy place. Stores closed at noon on Wednesdays and were crazy busy on Saturdays. It was hard to find a parking space. If you wanted to send something to Norfolk in hurry, it could go on the Trailways or Greyhound bus. Peebles was the department store in the now vacant yellow brick building on the corner of Main Street and Willis Wharf Road in Exmore. And there were more laundromats.

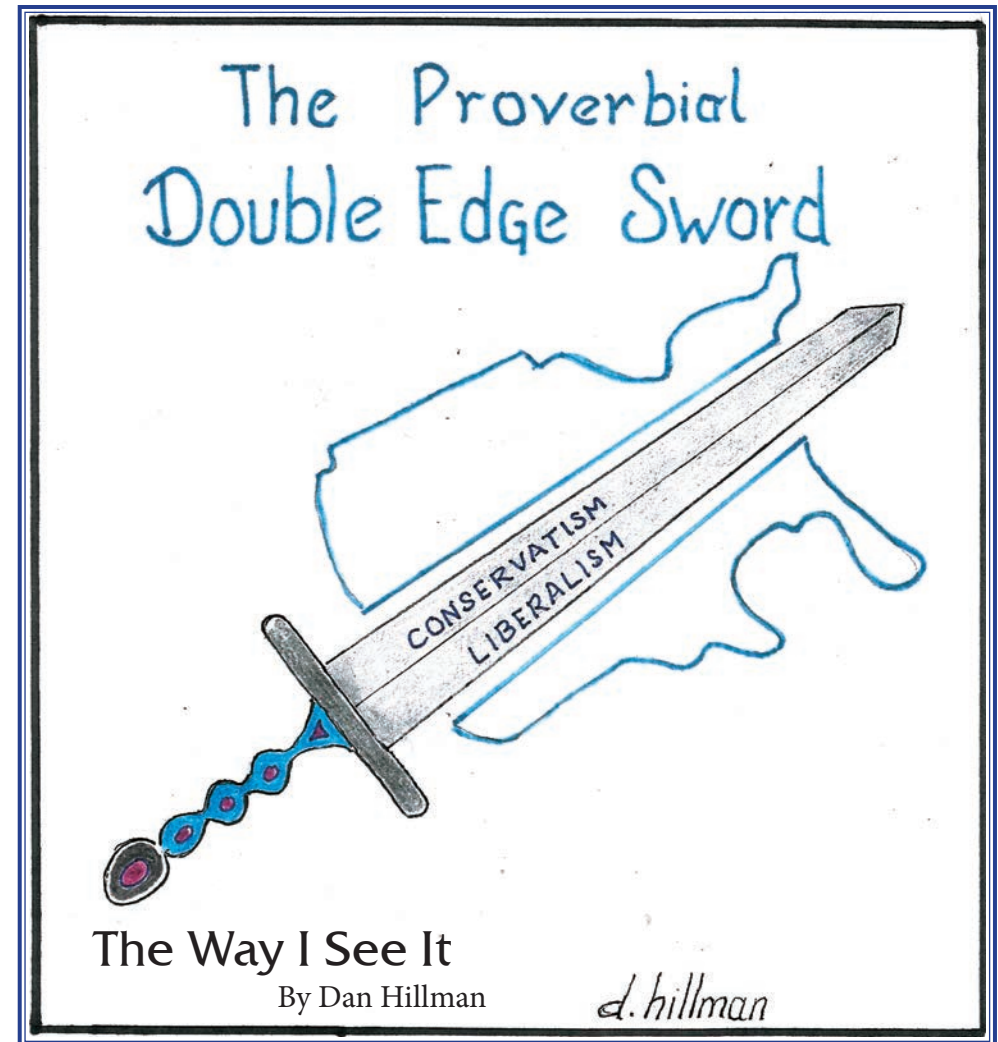
The speed limit on the Route 13, be-

fore it was named Lankford Highway, was 60 mph. There were no convenience centers or green boxes, the dump beyond the experiment station sufficed.

The fields were rich in vegetables. Homecoming football games between Central and Onancock high schools were played on Thanksgiving. It was actually so long ago that Donald Hart was not yet

on the Accomack County Board of Supervisors and Gov. Ralph Northam was probably a rising third or fourth grader.

Be Aware of GMO Food Labeling

Dear Editor:

For their families' sake, readers should consider this shortened version of comments I sent to the Agricultural Marketing Service. All should be aware that if the current GMO food labeling being considered is passed, it might prevent them from knowing what is in their food.

Dear AMS:

Your stated mission is "to ensure the quality and availability of wholesome food for consumers across the country." Soon you will be deciding on the labeling of GMO products, which currently favors GMO purveyors, not consumers.

The smiley face logo effects a positive impression, likely resulting in the consumer purchasing before questioning. It appears as a ruse to fool purchasers, especially with its similarity to the European organic food logo. Also, how many consumers know what "BE" or "GE"

means? "BE" connotes a positive impression, and "GE" is better known for electronics than a GMO advisory. Avoidance of "GMO" seems more than coincidental.

QR and UPC codes are effectively hurdles to the consumer. Who has the time and/or electronic hardware to decipher what they tell about a food product as they rush through food shopping after a long day? Everyone should know at a glance if their food contains GMO ingredients (including corn, soy, sugar, canola oil, etc.). Simplify and clarify, not confuse and obfuscate. Replace the smiley face, codes and confusing letters, with a simple logo that does not generate emotional responses and present hurdles. Allow consumers to intelligently decide what to feed their families.

This final comment was personal to each AMS Board member: As a human being, is your integrity important to you? Do you go to bed at night feeling you did good, that you did not help perpetrate deceit on your fellow Americans? Please think about that and act accordingly when

asked to make the upcoming decision. Refuse to be a corporate zombie.
