Holiday Crashes Claim 2 Lives

Two Accomack County residents were killed in separate crashes over the Christmas weekend, according to Sgt. Michelle Cotten of the Virginia State Police.

The first accident occurred early Christmas morning. Cotten said Leonardo Lopez, 27, of Onley was driving north on Lankford Highway in a 1994 Ford Mustang just before 5 a.m. Lopez was north of Route 176 in Parksley when he ran off the road and was ejected from the vehicle, according to Cotten. He died at the scene.

Cotten said the passenger, Edwar-do M. Ramirez, 20, also of Onley, was taken to Riverside Shore Memorial Hospital in Nassawadox with life-threatening injuries.

The sergeant said alcohol was involved and no seat belts were worn.

The second accident involved three vehicles and occurred at 1:50 a.m. Dec. 26 on Lankford Highway nearly a half-mile south of Route 648, north of Onley.

Cotten said Wanda Sue Taylor, 47, of Nelsonia was driving a 2003 Ford Taurus north in a south-bound lane. Going south at the same time was a 2002 Ford Mustang and a 2009 Peterbilt tractor-trailer.

The driver of the Mustang, Jer-rone Kieren-Trent Sloan, 19, of New Castle, Del., "saw the car (driven by Taylor) and attempted to make a lane change." He sideswiped the tractor-trailer that was driving be-side him, and the "Taurus hit him head-on," said Cotten.

It is unknown if alcohol was a fac-tor in the incident. Taylor was not wearing a seat belt and was trapped in the vehicle. She died at the scene.

Cotten said Sloan was seriously injured and was taken to the Nas-sawadox hospital. The driver of the truck, Wesley Hunter, 51, of Clemen-ton, N.J., was not hurt.

Death of One Woman, Disappearance of Another Believed To Be Result of Boating Accident

One woman was found dead on a beach in Northampton County and another is still missing, according to authorities who believe the two may have been in a boating accident.

At about 4 p.m. on Dec. 22, the body of Robin Lamb, 56, of Robin Lamb Homes of Onancock was recovered from Vaucluse Shores near the mouth of Westerhouse Creek. The following day, before her identity was verified, the Northampton Sheriff's Department released a prepared announcement that described her as a female over the age of 40 with pierced ears. "A fish-fighting chair was located in the water" in the same area, the document added.

A Christmas Eve announcement from the Northampton Sheriff's Department identifying Lamb as the victim, reported, "It is believed that Ms. Lamb may have been the victim of a boating accident. Search efforts are underway by the Virginia Marine Resources Commission, U.S. Coast Guard

and the Northampton County Sheriff's Office to locate the vessel and any other occupants that may have been aboard."

On Tuesday (Dec. 29), Accomack Sheriff Larry Giddens said in a prepared release that at close to 1 p.m. Dec. 23, a report was made to his office "of two missing persons who were transporting a boat from Onancock to Colonial Beach," on the Western Shore of Virginia.

Daria Finn, 55, of New Jersey "was last seen in the company of the Lamb victim and has not been located at this time," said Giddens. "The missing persons were both entered into the National Crime Information Center and the Virginia Criminal Information Network."

"We've gotten tales when they (Lamb and Finn) were supposed to leave from their dock at Deep Creek," Marine Police Capt. Randy Widgeon of the Virginia Marine Resources Commission (VMRC)

"When my oldest daughter was learning to count, she would count, 'twenty-eight, twenty-nine, twenty-TEN!' " said Jann Schott, an Arizona resident, formerly of Belle Haven. "Then she'd giggle like crazy because I'd say, 'noooo, not twenty-ten, it's THIRTY THIRTY THIRTY!' She'd be sitting in her car seat while we were riding along and just grinning like crazy

because she knew she was needling her mama!"

"Of course, now that she's in her early 20s, she doesn't find that story amusing," Schott said. "So out of respect for her, we'll be calling it two-thousand-ten. Party-Pooper!"

"Absolutely futuristic," said John Mann of Onley. "Maybe the title should be, '2010 Accomack Supervisor Odyssey, how they drove the county into bankruptcy.' "

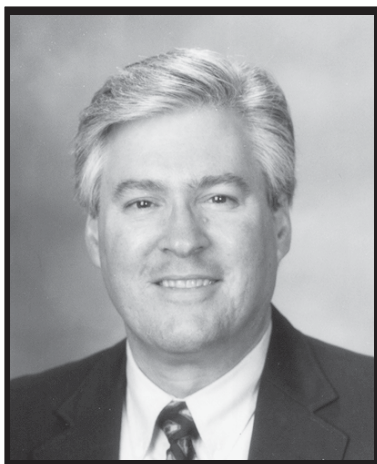

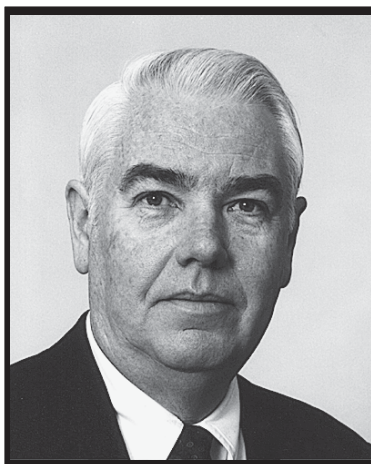

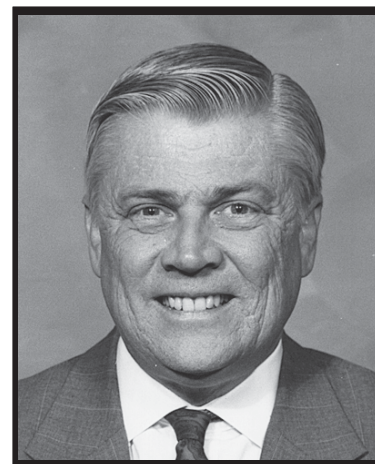

The business was "the hub for this part of the county for all races and all churches," Jo Hearne said

who did deep knee bends as he smiled for the crowds. Santa was taken out of his retirement box last week and put back to work.

"You think you won't pull it out again," said Hearne. "But, I really had to ... I have 5- and 6-year-old grandchildren. You know they need to see this. They think he's hilarious."

She and her daughter, Kate Hearne Ayres, being the elves that they are, decided to surprise all the good little boys and girls not only by bringing Santa Claus back, but also by decorating the store window with packages wrapped with the paper and ribbons from those old days. They dedicated the scene to Hearne's parents.

Santa will continue his gig through Sunday night (Jan. 3).

"Jo Hearne called and said my birthday present was in Bundick's store window," said Susan Willett Beasley. "She had set up the Santa Claus that goes up and down that we grew up with as kids. He was

built in 1957 which means he is 52, just like me."

Beasley's birthday is Dec. 23 and she had dropped the hint to Hearne of what she wanted on numerous occasions.

"Her suggestion is what prompted us to make the big move," said Hearne, who also got "harassed about it" by Painter resident Clark Gladden. He apparently hadn't seen Santa in a while.

"I thought maybe this was a good time," said Hearne. When she mentioned it to her daughter, the local teacher revealed that she'd been thinking the same thing. "We got babysitters" and went to work, Hearne added.

Bundick's store closed in 1978. Santa had a brief stint in the dress shop that Hearne later owned at Four Corner Plaza. "He's so noisy that in the small Onley store, he was too loud for the customers."

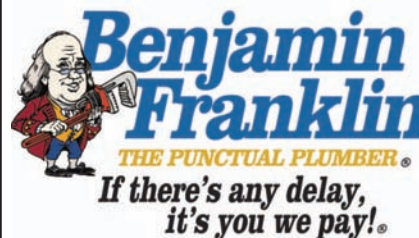

Cape Charles Councilman Files Court Action Charging Defamation

Cape Charles Councilman John W. Burdiss filed a complaint in Northampton Circuit Court last month against four town residents, claiming that they defamed his reputation by circulating petitions and attempting to have him removed from the council by alleging that he acted improperly.

He is asking for \$600,000 in damages and that a petition asking for his removal be expunged from court records. Burdiss wants half the award in compensatory and half in punitive damages.

The complaint was made against town Wetlands Board member Scott R. Walker Jr. of Washington Street, town Planning Commissioner Joan L. Natali of Blue Heaven Road, former town Planning Commissioner Karen Jolly Davis of Randolph Avenue and Lenora Mitchell Fields of Tazewell Avenue.

Burdiss, an attorney who joined the council in July 2006, charges in the court document that the four “formulated and carried out a plan” to have him removed because his decisions and actions “displeased” them. He said they were motivated by “personal spite, ill-will and malice.”

When they filed a petition in the court, he said, the action adversely affected his job as a lawyer because it claimed that he was unfit “to perform and/or a want of integrity in the discharge of the duties (as) councilman ... and as an attorney and expert witness.”

The lawsuit says that the four discussed their plans at Joe Vaccaro Appreciation Day in January 2009. He said that that month the four also attended a Town Council meeting where he alleges “Natali, Fields and Davis” spoke and made negative comments about him. “Defendant Davis’ comments were written and attached to the minutes for that meeting and were later attached and made part of the ‘defamatory materials’ the defendants circulated to the residents of Cape Charles and others as petitions,” the lawsuit continues.

It says that Natali, Walker and Fields distributed the petitions, which listed reasons why Burgiss should be recalled. All four “repeatedly, openly and notoriously published the recall petitions despite their knowledge” that they “contained numerous false and defamatory statements,” Burdiss charges.

His complaint says the false statements in the petition include: that Burdiss attempted to use his post’s influence in the outcome of a traffic summons in (Northampton) General District Court, although he had not yet taken office when the hearing was held in June 2006; that Burdiss and his wife (Cela Berge, an attorney and former town manager) obtained improper information from then Chief of Police David Eder; and that Burdiss held illegal meetings.

The councilman complains that these petitions irreparably harmed his professional and business reputation. He says when the group filed the petition in Northampton Circuit Court, they failed to do so properly and the documents “failed to assert any proper cause for removal.”

Burdiss says he has a right to “uninterrupted enjoyment of his reputation” in accordance with rulings of “the Supreme Court of Virginia which has held that certain words or statements can be defamatory as a matter of law.”

Fields answers the suit, saying she “had no motivation to harm Burdiss in any way” and “was not involved in formulating and carrying out a plan to have Burdiss recalled as a member of the town council” or in a plan “that resulted in the publication of defamatory falsehoods to residents of Cape Charles and others.”

As a supporter of Vaccaro, she admits she attended the appreciation day event, “but did not discuss plans with anyone to recall Burdiss nor to defame his reputation.” Fields says she did not make derogatory remarks about Burdiss at the January Town Council meeting and did not assemble any materials for distribution.

Fields says she “signed a petition at the request of Natali and agreed to circulate a petition on January 24, 2009 at the request of Natali.” Fields also admits she obtained 25 signatures on one petition “and started another which was left at Sullivan’s Office Supply for Natali to pick up.”

Mayor Dora Sullivan owns the office supply business. Fields says she she “had no knowledge as to what happened to that petition” nor “that the attachments to the recall petitions were false and defamatory, and believed the statements to be accurate.”

Fields also states in her answer that she believed Burdiss used his influence in the outcome of a court case and in obtaining information from Eder and that Burdiss held an illegal meeting. She says she made no false statements against him and claims that the misfiled petition caused no harm to Burdiss and that the recording of the document was performed by office personnel in the court.

Walker filed an objection to Burdiss’ complaint. He says the lawyer “failed to join all necessary parties to this lawsuit. As such this court cannot render a valid judgment ... neither Northampton County, the clerk of Northampton County, nor any other person with the authority to remove items from the Northampton County records is a party to this suit.”

In addition, Walker says Burdiss did not name the exact words spoken or written and “failed to specify all of the alleged defamatory statements ... which is necessary to correctly plead a viable cause of action.”

Davis admits, in her answer, to attending the appreciation event “as did about two hundred other persons. She denies discussing plans to recall Burdiss or to ‘defame his reputation’ at that event or any other time.”

She also admits to criticizing him at the January 2009 Town Council meeting regarding his participation “in votes and discussion

of projects before the council for companies which were represented by his wife ... her criticism was accurate as the county attorney had come to the same conclusion that Burdiss had a conflict of interest. She also criticized two other members ... Stephen Bennett and Bruce Evans ... Davis had not been asked by anyone nor given permission, not ahead of time, that her statement would be used by others and attached to the list of complaints.”

Davis says the first time she saw that her speech was attached to the petition was at Sullivan’s business where she “immediately protested.” Her answer says she was told it was a matter of public record. “She never agreed for it to be a part of those actions and does not know who did.”

Davis also says she did not initiate, distribute or file the recall petitions. She says she has no knowledge regarding the court action alleged in Burdiss’ complaint. Davis denies publishing any statements or claims regarding illegal meetings and asks that all claims against her be dismissed “on the basis that his complaints against her were frivolous and unwarranted with no factual basis, but only based upon a guess and false assumption on his part.”

Natali asks that the case be dismissed as the complaint fails to state a cause of action under Virginia law. She says there were insufficient facts and that Burdiss fails to set forth “any statements or conduct on the part of Natali that exhibited a reckless disregard for the truth.”

Correction

Based on faulty information provided to the Eastern Shore Post, last week’s edition incorrectly reported the charge for which David Loder, 48, of Accomac was convicted. In fact, Loder pleaded guilty to giving a false statement on a firearms application. He was given a 30-day suspended sentence.

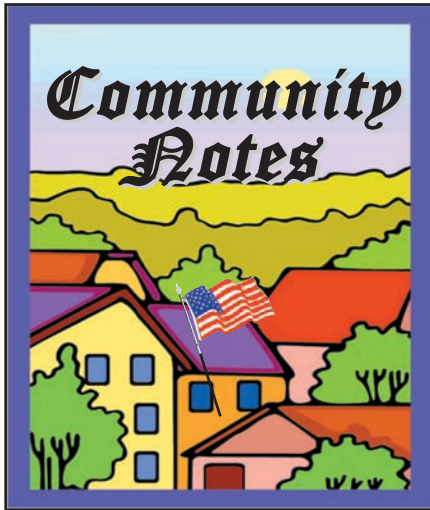

Exmore Dog Must Be Destroyed

General District Court Judge Gordon Vincent presided Monday over a trial to determine the disposition of a dog that attacked an Exmore woman during the week of Thanksgiving.

Martin Burgess testified that he and his wife, Mary, were walking near their home in Exmore on Nov. 22 when a large American bulldog lunged at her. The dog bit Mary Burgess about the face, knocking her down on the road, resulting in severe injuries to her head. Martin Burgess said he was able to get between the dog and his wife, thus preventing it from causing additional harm to her. Burgess testified that Laura Jenrette, who also lives at the residence where the dog was kept, came outside and was able to remove the dog from the scene.

Burgess was transported to Riverside Shore Memorial Hospital, where she was treated. She faces the prospect of additional surgery to repair the damage suffered in the attack.

Aaron Ross, who owns the dog, was in Tidewater working at the time of the attack and returned to the Shore upon being notified. Northampton County Animal Control took possession of the animal and impounded it, pending the outcome of the trial.

Ross testified that the animal was normally kept inside his residence and that when outside, it was tethered to a line attached between two trees. Testimony provided during the trial indicated that the dog had broken the line and attacked Burgess as she walked on the street.

A number of area residents testified that the dog had a history of lunging at them when they were in nearby yards or as they walked in the area. Most indicated that if it were not for the line tethering the dog to the tree, they too would have been in danger of being attacked.

Family and friends of Ross stated that the dog was not a danger to anyone and that it had not shown any vicious tendencies prior to the event in November. Ross stated that if returned to him, the dog would be cared for by his mother who currently resides in Chesapeake.

In his closing statement, Commonwealth's Attorney Bruce Jones claimed that the dog poses a threat not only to the community of Exto which it might be moved. Jones said that by definition, an animal can be designated as vicious or dangerous if it inflicts multiple bites or causes injuries that could be classified as permanent or result in disfigurement.

Defense attorney Marsha Carter argued that the attack did not meet the criteria defined as dangerous or vicious and that the dog should be returned to its owner. Carter cited the number of witnesses who indicated that they had been around the animal on numerous occasions and that it had not shown any dangerous tendencies.

Judge Vincent ruled that the dog's attack on Burgess met the definition of a dangerous animal and ruled that the animal should be destroyed. Ross has 10 days to appeal the decision while the dog remains under the custody of Northampton County Animal Control.

Trooper Johnson Awarded Carnegie Medal



Virginia State Police Trooper Kurt J. Johnson is among the 23 individuals from throughout the United States and Canada to be named as a recipient of the esteemed Carnegie Medal. The Carnegie Hero Fund Commission gives the medal to those who risk their lives to an extraordinary degree while saving or attempting to save the lives of others.

Trooper Johnson was nominated for this recognition based on his valiant acts performed in the line of duty earlier this year. In a press release, the commission selected Johnson for his extraordinary actions, as follows:

“Kurt James Johnson saved Destineé N. Davis in Pastoria, Virginia, February 6, 2009. Destineé, 3, was a passenger in a car that, at night, left the highway, overturned onto its roof, and caught fire. Her mother escaped the wreckage with two other children. On routine patrol nearby, Johnson, 43, state police trooper, responded to the scene on seeing flames there. Alerted by her mother that Destineé remained in the vehicle, Johnson used his fire extinguisher against flames that issued from the vehicle’s exposed underside and engine area. With flames persisting, being fed by leaking gasoline, Johnson then opened the rear door on the passenger side of the vehicle. Although the passenger compartment was filled with dense smoke

that precluded visibility, he crawled inside and maneuvered to the front. Finding Destineé under the dashboard, he grasped her by her jacket and hugged her to himself. He maneuvered back to the opened door and exited the car. Flames spread throughout the vehicle. Destineé was hospitalized for treatment of her injuries, and she recovered. Johnson also required hospital treatment, for smoke inhalation, and he too recovered.”

“Our troopers commit acts of heroism on a daily basis across the Commonwealth,” said Colonel W. Steven Flaherty, Virginia State Police superintendent. “But, in Trooper Johnson’s case, he clearly went above and beyond the call of duty and is most deserving of this prestigious recognition. Virginia should

be proud and privileged to have a trooper of Kurt Johnson’s caliber on patrol protecting its residents.”

The heroes announced Dec. 22 bring to 9,327 the total number of awards since the Pittsburgh-based fund’s inception in 1904. Commission President Mark Laskow stated that each of the awardees or their next of kin will also receive a financial grant.

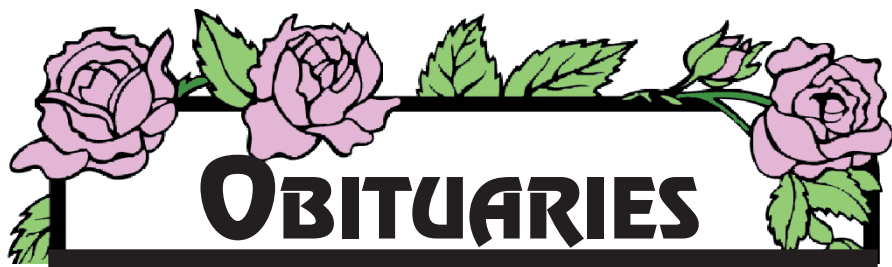

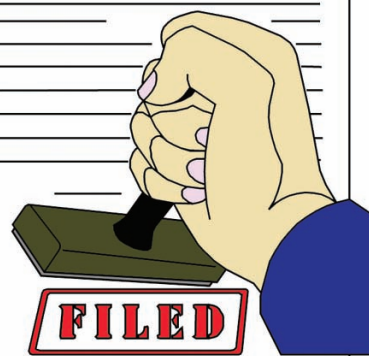

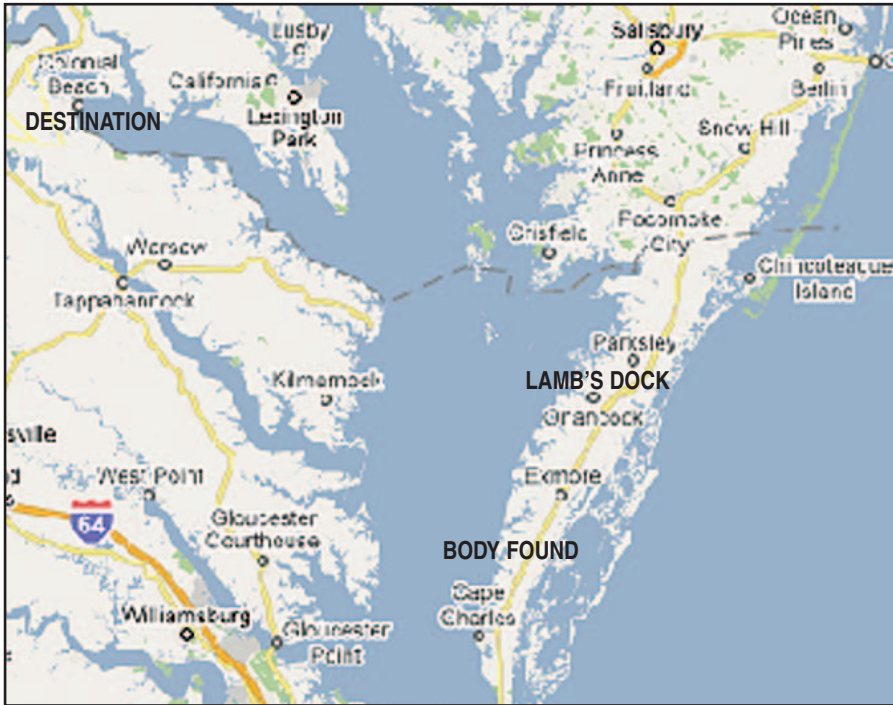

said Tuesday. "No one actually saw the boat leave," he added of Lamb's 31-foot Chris-Craft. "She had the boat for a few years. ... We haven't found the boat. Some debris that is consistent with that boat" has been found. "We can't confirm" that it is part of Lamb's boat.

Widgeon said that the investigation disclosed that the two women were to cast off on Dec. 15. "That day that we think they left was pretty nice. It got real ugly the next day," he said.

"We don't know for sure" if Finn was on the boat, Widgeon continued. "She doesn't seem to be available. She was supposed to be on the boat. I think they did live together ... they were good friends."

He said a Subaru Outback belonging to Lamb was found parked at Colonial Beach.

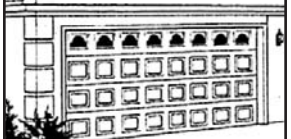

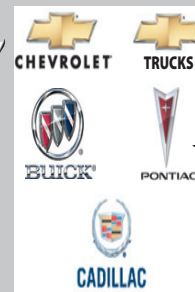
