## Shore Reaches Out to Haiti

Following the recent earthquake that demolished much of Haiti and left approximately 150,000 dead and 600,000 homeless, Americans have responded with an abundance of fund-raising efforts. Locally the outreach has equalled that of the big cities, perhaps not in dollar signs but certainly in heart and quick reaction.

The Saturday before the earthquake, Chincoteague resident and Florida "snowbird" Leigh Lawrence landed in Port-au-Prince to meet up with Harvest International Missions group.

"My impression of Port-au-Prince was that it was very similar to Kolkata, India. Haiti is the poorest country in the western hemisphere," said Lawrence, a retired builder and philanthropist from the Shore.

On the Sunday before the quake, Lawrence and 18 other volunteers connected in the city of Cayes, the third largest city in Haiti, about 50 miles from Port-au-Prince. There they participated in a church service at a local mission for "yard children," mostly ages 8 and under.

"'Yard children' is the name given to children born, then barely weened from their mothers before literally being left to their own de-

vices on the street. You have to understand that it's completely based on the economic state of the area. ... There is nothing else to do, and with a lack of birth control there is an over-abundance of yard children," explained Lawrence. "There were 1200 kids with us that day. They were the most polite and appreciative children you've ever seen. They sat orderly on the outside benches during the service. Everyone appeared extremely happy to see us."

An 8-year-old boy led everyone in prayer soon after the puppet show and before the mission fed all 1200 children rice and beans.

"They typically only get two hot meals a week. The average Haitian only eats one meal a day. One U.S. dollar is worth eight Haitian dollars. I brought a lot of quarters with me. I liked to take pictures of the young kids and would give them a quarter each time," Lawrence said.

When the quake hit, Lawrence and three others were in a masonry building by the waterfront.

"It shook, rattled and rolled. We ran out of the building yelling 'Earthquake!' Trucks were rocking six to eight inches off their tracks," said Lawrence. "It felt like eight or ten minutes. We later felt several of

the aftershocks in our beds. No one from our team was hurt. We were soon evacuated to higher ground by the Resident Missionary."

During the following days, Lawrence's mission emphasis switched gears. He was initially there to help with the construction, having had years of building experience on the Shore. But after one more day of mission work, his help was needed in the medical arena. He became a medical support aide to doctors and nurses who were overwhelmed with the patients from the quake.

The devastation in Port-au-Prince was massive. "People were pouring out of Port-au-Prince at a rate of 25,000 people an hour," said Lawrence.

"By Thursday, bodies were being put into mass graves, black and white, local and from afar. It was horrible, and they weren't taking time to identify the bodies in most cases. They had to worry about disease and the smell became almost unbearable," he continued.

The International Red Cross and U.N. told Lawrence and his companions that they would be stuck in Haiti for no less than two weeks.

But they caught a break. E-

mails were sent out to owners of small, single-engine planes that could maneuver more easily on the smaller runways, asking if they could fly in supplies.

"A man named Ken from Iowa got the e-mail on Friday afternoon, and was in Haiti by Saturday afternoon," recalled Lawrence. "Big planes were hauling the majority of supplies to Nassau, and small planes like Ken's would pick up loads and haul them to Haiti." The small-plane pilots would take three or four people out of Haiti with each trip. So Lawrence left his luggage behind — clothes to be divided among the refugees — and was on one of the last plane rides out.

They stopped in the Bahamas where Lawrence continued his efforts to help by loading planes with supplies. He finally caught a ride into Miami, close to Florida City, where he spends much of the year.

This was the fifth international mission for Lawrence, who said he volunteers primarily to help people. He also loves the adventure.

Pastor Bobby Carroll Huether of Pungoteague Community Church had bought his ticket in December to arrive in Haiti on Jan. 20 to

# Innovative Planning Session Offers Food for Thought

The conclusion was the same but getting there was a lot more fun. About 175 Accomack County elected and appointed officials, department heads and workers, other local agency representatives, ministers and concerned citizens participated Tuesday evening in a “World Café” style forum where topics were discussed in groups of five.

There was catered finger food to the tune of \$1,500 provided by taxpayers. Money for that and the unspecified cost of a facilitator, plus the room and furniture rental came from a “future search budget” of \$20,000 given to County Administrator Steve Miner last year by the Board of Supervisors and earmarked for community involvement.

The session was filmed, praised and every 20 minutes or so stopped so participants could get up and move to a new seat and talk some more. It was sometimes hard to hear above the chatter.

“Thank the Board of Supervisors,” Miner told the crowd at the start. “They took a chance on this meeting.”

“Everyone in this room really cares about Accomack County,” said Dr. Linda Thomas-Glover, president of Eastern Shore Community College, where the meeting took place. “Sitting with people they may not know ... that’s where conversations start.”

After about three hours, self-appointed hosts from each table reported the findings. The majority of the players were

over 40 and many were retired. It was agreed that the next session needed to be a younger crowd, perhaps brought over from the school's main building.

The consensus was that Accomack is slowpaced, peaceful and relatively safe, and filled with natural unique beauty and history. It is a great place to enjoy and raise a family. People are polite, accepting and "not in your face." There's fresh produce and seafood, good fishing and hunting. Everyone knows everyone. Neighbors watch out for neighbors.

"People really care about people," someone said. "There is always something to do if you want to do it," another added. "There's always deer in the freezer and green in the winter." "People who move here can be a big fish in a small pond." Residents can feel "a spiritual awakening (from) being on the Shore." "Age doesn't matter, you can go to a bar and hang out with someone 65 ... or 21."

But the negatives came in full force too. Lack of jobs, low pay, old-boy network, dwindling congregations, animal cruelty, small businesses in need of protection, limited housing, and a wide difference between rich and poor were listed. Education and public transportation should be supported. A four-year college is needed and more focus should be on skills and less on standard test scores in public schools. More trade people are needed to provide services.

Among the comments: "There's a sense of apathy and lack of motivation among some people." "We have issues with our low-income people; they need help." "Lack of middle-class opportunities." "Losing family farms to corporate farms that don't love the land as much." "Everyone wants change but no one wants to change."

# Candidates for GOP Congressional Nomination Hold Debate, But Agree on Most Issues

From the outset, the GOP Candidates Debate held at Little Italy in Nassawadox last Thursday, it was evident that the six candidates for U.S. Congress from the Second District stood as one on most of the issues presented to them.

District GOP Chairman Gary Byler prefaced the debate by noting that any of the six candidates would make an outstanding choice for the Republican congressional ticket in the Nov. 2 general election. The Republican Party will select one of the six candidates to carry the party banner against Congressman Glynn Nye, who unseated Republican Thelma Drake in the 2008 congressional election.

Each of the six GOP candidates has served in the U.S. military. Bert Mizusawa, a graduate of West Point and combat veteran, retired as a brigadier general. Kenny Golden served as a surface warfare officer and Ben Loyola flew combat missions as a bombardier navigator aboard A-6 Intruders. Both retired with the rank of captain. Ed Maulbeck and Scott Taylor served as Navy SEALs, while Scott Rigell served as a sergeant in the U. S. Marine Corps Reserve.

The candidates responded to four questions posed by former Virginia House Delegate George McMath, who served as moderator for the event. On the question of improving the economy and job opportunities, all of the candidates pressed for the need to curtail federal spending and reduce the national debt. Taylor suggested that new jobs could be created by expanding the Virginia Spaceport at Wallops as well as through the growth of off-shore oil production. Loyola's plan would call for a hiring freeze at the federal level to save money, as well as lowering taxes. Stated Loyola, "States with lower taxes have a history of lower unemployment and lower crime rates." Golden likewise supported federal spending cuts and pointed out that the "Cash for Clunkers" program was a financial disaster. Mizusawa suggested that reducing federal spending and lowering the national debt could improve the economic condition of the nation. Maulbeck echoed the other candidates in urging a cut in federal spending to maintain a balanced budget. Rigell maintained that his experience in the business world places him in a position to help with the economy. He also pressed for reducing taxes

and cutting federal spending while reducing interference with small businesses.



When quizzed on America's dependence on foreign oil, all of the candidates expressed support for oil drilling off the coast of Virginia. Also supported by the candidates were alternative energy sources, including nuclear power facilities, solar energy, and wind turbines.

All six candidates noted the need to keep healthcare issues in the hands of healthcare professionals. Maulbeck argued that cutting health coverage would be a mistake and that once cut, it would be difficult to replace.

The final question of the evening centered around the growing threat to Israel posed by the development of nuclear weapons by Iran. Iran has a history of threatening to destroy Israel and recently has been exploring the possibility of developing long-range missiles that could reach Israel. All of the candidates stated that the proliferation of nuclear weapons by the nations surrounding Israel is not acceptable.

The Accomack Republican Party will be hosting a forum of all of the Republican candidates Tuesday, Feb. 9, in Onley.

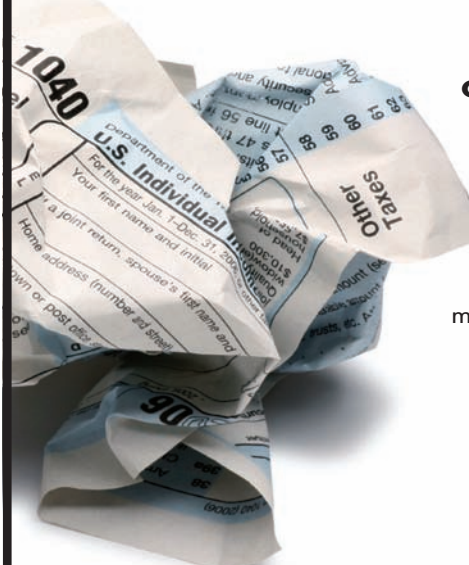

## Accomack Circuit Court

# Supervisors Receive County Financial Update

At its work session Tuesday, the Northampton County Board of Supervisors heard from the accounting firm of Davenport and Co. with regards to the county debt service.

Courtney Rogers of Davenport stated that after reviewing the projected income vs. outstanding debt, the county is financially stable. He pointed out that Northampton County had taken on a variety of capital improvement programs over the past several years and without any other major projects on the horizon, once the debt has been paid down, the county should be in reasonable financial condition.

Northampton County still owes in excess of \$40,000,000 on projects that have either been completed or are in the planning stage.

In other business, Mike Lemkuler, speaking for the Virginia Economic Development Partnership, discussed a variety of state incentive programs, including the Governor's Opportunity

Fund, the jobs investment program, enterprise zones and tax credits. No action was taken following the presentation.

The board reviewed its 2010 goals, which include completing the county's solid waste disposal

program of constructing the remaining convenience centers in Eastville and Cheapside; relocating the Health Department to the former middle school; and combining certain services of the school system and the county.

# CAPITAL LETTERS

**W**e have just completed the first full week of the 2010 General Assembly session, and we certainly have hit the ground running.

The process of submitting amendment requests for the state budget has ended, and now the difficult work of determining budget priorities will begin. In the coming days, more and more legislation will also come

to the floor from committees for votes by the full House and Senate. With so many issues being discussed, I greatly appreciate all of the feedback I receive from your letters and phone calls.

Three important bills I am working on have been referred to Senate committees for further action. The first, SB189, repeals the sunset date on space flight immunity legislation passed by the General Assembly in 2007. This ensures Virginia's place as a strong competitor in commercial space flight development, and is a very important piece of legislation to help create jobs around Wallops Island. The second, SB 193, creates stricter rules for eliminating fraud

from our Medicaid system, and will hopefully be an important cost-saving measure. The third, SB 173, which I am co-patroning with Sen. Creigh Deeds, establishes a seven-member bipartisan redistricting commission. If passed, this legislation would go a long way toward making elections in Virginia more competitive, and eliminating gerrymandering.

**T**he first full week of the Virginia General Assembly began with Gov. Bob McDonnell's State of the Commonwealth address on Monday

evening. It was a lengthy address, well-delivered and with an optimistic tone. It followed what was a very good inaugural address the previous Saturday on the portico of the Capitol. His remarks indicated what many of us have been discussing for some weeks now, that this extreme fiscal crisis may well result in a meaningful and useful discussion about the role and function of government in our commonwealth. It will force us to think in new ways about how we approach core services of government and also the state's relationship with localities.

The governor, in his State of the Commonwealth address, mentioned the exciting things at the Mid-Atlantic Regional Spaceport (MARS) and also reaffirmed his commitment to a \$1.3 million budget appropriation for the Spaceport. Clearly, he recognizes the value of the activity there, not only to the Shore but to the commonwealth as a whole. I look forward to working with him as we find ways to advance and expand the MARS' competitiveness to ensure its position as one of the premier points of entry for commercial space flight.

Last Friday marked the deadline for requesting drafts of legislation from Legislative Services. Friday, Jan. 22, was the deadline by which all legislation had to be filed. I have filed approximately 15 pieces of legislation and am a co-patron on several others. I will discuss some specific legislation in one of my later reports.

Last Friday I signed on to a letter to U.S. Attorney General Eric Holder regarding the transfer of convicted murderer Jens Soering back to his native Germany under a recommendation to the U.S. State Department made by then-Gov. Tim Kaine in the final days of his administration. Mr. Soering was involved in a very brutal murder of an elderly Bedford, Va., couple more than 20 years ago. He is serving a

life term and his girlfriend, and accomplice, is also serving a lengthy prison term. It is highly unlikely that the German authorities will hold him for any significant time beyond two years after his transfer. This is entirely inappropriate, and I joined several other legislators in sending this letter to Attorney General Holder.

The work of the Assembly has begun in earnest with the usual round of 7 a.m. sub-committee meetings and lengthening floor sessions. I still look forward to visiting with Eastern Shore folks as they make their way to Richmond to see how their state government works.

The most important thing that the legislature does is construct a budget and in this dire fiscal situation, the budget that emerges over the next six weeks will be even more important. There is a host of issues in addition to the budget that will affect the entire commonwealth and the Eastern Shore. Please don't hesitate to share your thoughts or ideas.

scout a local church in Petite Riviere and meet with local community leaders to plan mission trips for members of his church.

About a year ago, Huether was visited by Pastor Walas Renolte, a preacher from Haiti who had come to America to make money to send home in order for his community to build the Petite Riviere Community Church and a free school.

Huether and his congregation had worked with local Haitians, many of whom were brought here by "taskmasters." Taskmasters promise Haitians high-paying jobs and a place to live. Once the Haitians get to the U.S. the taskmasters set up a job. However, they, in turn, charge the workers \$100 per week for a crowded spot to lay their head, \$50 per day for transportation to and from work, and excessive fees for meals.

"This is not a new phenomenon. It has been happening on the Shore to some, not all, migrant camps. They get caught in a cycle and it's difficult to get out. That's

where we come in," said Huether, who estimates about 250 Haitians currently live on the Shore.

"Pastor Walas Renolte told us that God had sent him to our church. He was very loyal and helped our church in every way possible. And now I see why God sent him to us. Even though the Atlantic Ocean separates us, we both believe that the church should help out in the community as much as possible," he explained.

Late last summer, Pungoteague Community Church began developing a plan to help. First, Huether was to go and scout the area to see what resources were available and make sure everything he was told was legitimate. Unfortunately, the earthquake squelched those plans for the time being. He plans to visit Haiti next month.

"We want to show the people of Petite Riviere how to make a living from their island's natural resources," said Huether. "We have people in our church willing to teach them how to make pottery or use shells and stones for jewelry and then how to export it to other countries."

The Pungoteague church is working with Hope Charities out of Portsmouth to get basic supplies to the survivors. There are five 40,000-pound containers filled with supplies waiting to be shipped. There is also a 40-foot container filled with dental supplies. Huether and Hope Charities are trying to raise the \$20,000 needed to ship them. There are

volunteers in Haiti waiting to distribute the supplies, assured Huether. Donations can be sent to Haiti Relief, c/o Pungoteague Community Church, P.O. Box 3, Pungoteague, VA 23422

Perdue is one of the largest employers of Haitian-Americans on the Shore. A total of nearly 800 employees in their plants in Accomac, Salisbury, Md., and Georgetown and Milford, Del., have ties to Haiti. The Accomac plant has approximately 200 Haitian-American employees.

"Our first and foremost priority was trying to connect them to their families. Our Human Resources people provided those folks with a variety of resources, computers and phones, to try and contact their loved ones on the island."

"There were certainly some devastating stories and not all good news. Our story mirrors that of the world's: there were some joyful reunions ... and some not."

Grief counselors have been brought in by Perdue to help those struggling with the losses. Perdue is also hoping to raise over \$100,000 by pledging up to \$50,000 in matching funds. The program, "Help HERE: Perdue's Haiti Earthquake Relief Effort," will run through the end of March and funds will be split evenly with the Red Cross and Salvation Army International Disaster Relief Fund.

The Boy Scouts of Troop 314 in Exmore are also conducting a tent drive through the end of February to help provide shelter for those

who have lost their homes.

Scoutmaster Terry G. Spence was watching the news after the devastating quake and noticed scads of people lying in the streets with dust, dirt, and chaos all around.

"As a Boy Scout leader, people often give me a lot of extra tents and many we can't use," said Dr. Spence, a dentist in Exmore. "I decided to contact other troops and see what we could gather for the refugees."

The supplies aren't the only gift that the Troop 314 will be sending. "My daughter goes to Shore Christian Academy and the kids of the school are writing encouraging messages that we will stick in the sleeping bags. We just want to let them know that someone cares."

The Scouts are asking anyone who has new or gently used tents, tarps, clean sleeping bags, or folding camping chairs to bring them by Feb. 28 to one of the following drop-off points: the Chesapeake Bay Bridge Tunnel Administration office; Spence and Spence Dental Office, Exmore; A&N Pregnancy Center, Belle Haven; Bloxom Auto Supply, Mappsville; VA Dept. of Forestry, Accomac; Commonwealth's Attorney Office, Accomac; and Dr. Barney Selph's Dental Office in Cape Charles. Donations may be sent to Dr. Terry G. Spence, Scout Master, P.O. Box 819, Exmore, VA 23350. Be sure to write "For Haiti" on the check and make it out to Troop 314.

"This is about doing the right thing," said Dr. Spence. "We could be in the same situation some day. The people are poor and have lost everything. This may not be everything, but it is something."

### Taxpayers Warned of Loss of State Funding

Dear Editor:

I wrote to Accomack County taxpayers to inform them of state budget issues impacting us at the local level. As you may know, stated revenues make up a significant portion of our local budget, typically for things that the state has mandated or which it has historically funded.

Accomack County's budget must be balanced each year. We cannot spend more than we receive in revenue, so cuts in state revenue have a direct impact on our local budget, either in increased local funding to make up for state cuts, or in reduction of services. State revenues have been cut in our local budget by approximately \$1.6 million in the last three years. This year, we have been told there are more cuts, some of them larger than any before. Gov. Tim Kaine's proposed budget contained \$3.4 million in cuts to our local government and would have eliminated all personal property taxes, replacing them with a 1 percent income tax. The General Assembly has already removed the proposal for a new tax, so our new governor faces a gigantic funding gap statewide on top of the cuts already proposed. In our county alone, this would equal another \$3 million in unfunded state revenue (this is the state share of the car tax reimbursement).

The largest cuts we know of affect the schools, to the tune of \$2.7 million. The entire Accomack school budget is approximately \$45 million, so this represents a cut of nearly 6 percent. And there are planned cuts of an additional \$880,000 for the offices of the sheriff, com-

missioner of the revenue, commonwealth's attorney, treasurer and clerk of court. Of particular note, the state funds sheriff's deputy positions on a ratio of one deputy for every 1,500 population. The state will now pay for only one deputy for every 2,000 population. This will reduce our number of deputies unless we pay for them at the county level.

Some of these revenue reductions can be accommodated through service elimination, while other costs cannot be avoided. The board will do all it can to reduce the impact on local taxpayers, but it will be difficult without cuts in service, increased taxes, or both.
