## Supervisors Want Details on School Spending

Before they raise taxes to help offset cuts in state school funding, Accomack supervisors want more information from the county public-school system about plans to eliminate jobs.

"I need additional information," Supervisor Wanda Thornton told the rest of the panel Wednesday night. She said Superintendent W. Richard Bull "needs to share with us the formula they plan to use. I don't know if it's administrators, teachers, aides ... bus drivers" who are going to the unemployment line. "You have to have more information than we've got."

Thornton wanted County Administrator Steve Miner to seek out the details.

"We didn't cut the School Board" budget, the island district supervisor continued. She contends the supervisors need all the facts "to make a rational decision."

Thornton was referring to the proposed 4-cent hike in

## Two Local Men Face Federal Conspiracy Drug Charges

Two Northampton County men were accused last week in U.S. District Court in Norfolk of conspiracy to distribute large quantities — five kilos or more of cocaine and 50 grams or more of crack — and marijuana on the Eastern Shore.

Many of the court records have been sealed. However, affidavits supporting arrest warrants for the men spelled out crimes allegedly going back as far as 2002. Both were convicted of felonies in the 1990s, according to the documents.

A federal agent said seven witnesses (identified only by numbers) are ready to testify against Harry (Kojack) Byrd West and Terrance (T) Durell Price. Price allegedly confessed on a video and audio recording and then recanted. "He waived his rights in writing," the records state.

West, 35, owns AA Auto in Cheriton and is accused of using his business as a front for drug activities. He was convicted of two counts of distribution of cocaine in August 1997 in Northampton Circuit Court.

Scott Wade of the Eastern Shore Drug Task Force said Monday that recent charges stem from an investigation made by the task force, which is comprised of representatives of Acco-

mack and Northampton Sheriff's departments, the Virginia State Police and the federal Drug Enforcement Administration (DEA).

Price, 40, also known as Howard Reid, was described as West's "Right Hand Man." He was charged on March 22 with possession of marijuana and driving on a suspended license, according to Northampton General District Court records. The alleged offenses occurred on March 19.

Wade said a camera was confiscated from Price and included pictures of the "secret" task force office in Exmore. According to the court documents, the photos were part of a plan of retaliation. Price is being held in Eastern Shore Regional Jail without bond.

On March 23 he was charged with possession of cocaine with intent to distribute (second offense) on July 15, 2009. His address was listed as Birdsnest, but Wade said Price lives in Machipongo.

Wade said he was unsure where West is being detained.

In a Norfolk court record, DEA Agent Jack H. Faddis Jr. said, "Facts supporting probable cause" include "cooperating witnesses who are familiar with the West Drug Trafficking Organization." He said they "report that West some-

times travels to southern Florida, North Carolina and Delaware to purchase" the drugs and then delivers "kilogram, half-kilogram, multiple ounce or smaller quantities of cocaine and marijuana to mid-level dealers and users. West

## Man Killed in Crash

A Belle Haven man was the second person to die in a fatal traffic accident on the Eastern Shore in 2010.

Angel Antonio Gutierrez, 32, was driving a 1996 Honda Accord south on Lankford Highway at about 3:30 a.m. Sunday, according to Sgt. Michelle Cotten of the Virginia State Police, who reported that Gutierrez was about 0.4 mile south of Route 620 in Painter when he "ran off the road to the right, struck a ditchbank and overturned several times, partially ejecting the victim."

Cotten said the driver died at the scene. There were no passengers. Gutierrez was not wearing a seat belt. The sergeant said it is unknown if alcohol was a factor in the accident.

Trooper R.C. Brown is investigating.

# Department Heads Comment on Proposed Layoffs

Accomack Information Technology Director Reed Ennis has written to County Administrator Steve Miner to defend his job. His memo and messages from six other department heads were distributed Wednesday to county supervisors who did not discuss them.

The department heads had been asked to predict how proposed budget cuts would affect their operations.

Ennis' position was created last year after he was removed as director of finance. He has worked for Accomack for about 30 years and with salary and benefits makes about \$115,000 annually. Cuts to the proposed fiscal 2010-11 budget will leave Ennis and about 15 others unemployed.

"The county assessor states that this position (Ennis) was a 'key player' in accomplishing the re-assessment and accomplishing it on time," wrote Ennis.

He also said thousands of dollars were saved in printing and

postage by arranging for Mail-Movers to receive assessment notices electronically. "This was never done electronically by the county before," Ennis wrote. "The improved accuracy and postage savings ... were significant" and "will be used for tax bill mailings in the future to continue the savings."

Ennis further wrote that he is needed to complete the county's con-

version of new assessment software.

And he noted that while funding for a new Web site was retained in the budget, "the position that built the current site and has managed it is being eliminated. The county lacks any other expertise other than copying data to the server." As far as computers and the network are concerned, Ennis wrote, "The system is at risk with only

one person knowledgeable about the system remaining."

Replacing the drive in a main-frame computer with a more reliable model saved about \$7,000. "We are now exploring adding the sheriff's office to our email system ... the cost savings over time ... will be significant," Ennis wrote.

## Offshore Drilling Becomes Real Possibility

President Barack Obama announced this week that the U.S. Department of Interior has approved moving forward on a plan to allow oil and gas exploration and production 50 miles off Virginia's coast.

State representatives are rallying the cause. Locally, the National Aeronautics and Space Administration (NASA), the Navy and the National Oceanic and Atmospheric Administration (NOAA) are opposed because it would likely interfere with their missions.

Accomack Supervisor Phil McCaleb, a member of a state ad hoc committee on drilling, said Wednesday night that he was surprised at the announcement. The rigs would be in the line of fire for rocket and weather satellites, raising liability issues, he said.

Still, McCaleb added, it would bring business to

the area "since 90 percent of the servicing is done by helicopter." Melfa airport would be handy, he said.

Congressman Glenn Nye said offshore oil drilling would create jobs for Virginia and help reduce America's dependence on foreign oil. He has joined seven other state representatives to introduce a bill requiring at least half of the revenue to be returned to Virginia.

The Department of Interior's Minerals Management Service (MMS) has estimated that Virginia's Outer Continental Shelf (OCS) has 130 million barrels of recoverable oil and 1.14 trillion cubic feet of recoverable natural gas.

U.S. Sen. Jim Webb said he "strongly supports a revenue-sharing arrangement for" Virginia and plans to introduce legislation to ensure a share of profits.

U.S. Sen. Mark R. Warner also supports the cause.

# Court & Police Postings

## Accomack Criminal Court

A Melfa man was convicted of robbery and related charges Monday in Accomack Circuit Court, according to Commonwealth's Attorney Gary R. Agar.

A presentence report was ordered for Rory Tomlin, 18. He was found guilty of robbery, use of a firearm in a felony and maliciously shooting at an occupied vehicle.

Presentence reports also were ordered for Cody Hutton, 18, of Accomac, convicted of unauthorized use of a vehicle; and Anthony Johnson, 31, of Atlantic and Justin Scarborough, 23, of Painter, both convicted of distribution of cocaine.

Leeshawn Davis, 21, of Accomac was sentenced for possession of marijuana with the intent to distribute it to four years in prison, with all but three months suspended.

Anthony Duffy, 33, of Onley was sentenced for distribution of cocaine to 10 years, with all but a year and 11 months suspended. Restitution was ordered.

Ellin Early-McFord, 42, of Snow Hill, Md., was sentenced to 12 months with nine suspended for a misdemeanor count of leaving the scene of an accident.

Markiece Harmon, 24, of Parkley was sentenced for burglary and grand larceny to 10 years, with all but one suspended. Restitution was ordered.

Melissa Kellam, 30, of Onley was given a three-year suspended sentence for possession with intent to distribute marijuana. Community service was ordered.

Andrew McDonald Jr., 33, of Chincoteague was sentenced to

three years each for eluding police and a third offense of assault on a family member. All but two years, three months was suspended.

## Accomack Sheriff's Office

A Painter man is listed in stable condition after being shot Saturday at Chesapeake Square Plaza in Onley, according to Accomack Sheriff Larry Giddens.

At about 5:30 p.m. that day, the sheriff's office was alerted to the incident. An investigation revealed "multiple gunshots were fired by suspects traveling within the plaza and resulted in vandalism to a store," Giddens said. "One of the parties involved in the crime was injured during the incident."

Deleon Fitchett, 26, of Painter was taken by personal vehicle to the Wine Rack convenience store in Onley, where he was transported by ambulance to the local hospital, the sheriff said. Fitchett was later transferred to another medical facility.

"The suspects fled the scene by vehicle prior to deputies' arrival," Giddens added. "Two vehicles believed to have been involved in the crime have been confiscated by the Accomack County Sheriff's Office."

Giddens said "there were many innocent bystanders" at the shopping plaza at the time of the shooting. His department is seeking any witnesses to the crime. "Any available information regarding this crime may not only assist in the apprehension of suspects, but may help eliminate any future incidents of this nature," the sheriff explained.

To report information concern-

ing this crime, call the department 787-1131 or 824-5666.

Virginia State Police, and Onley and Onancock police departments assisted with the investigation.

Police are looking for three people suspected of robbing a Greenbush store at gunpoint last Thursday night, according to Sheriff Larry Giddens.

At about 9:20 p.m., the sheriff's department received a report about the incident at La Oaxaqueña Mexican Store on Greenbush Road.

"Further investigation revealed the two black males and one black female entered the store and robbed the clerk at gunpoint," Giddens said. "The spouse and three children of the store clerk were also victims of this crime. Taken from the store was an undetermined amount of money and the suspects fled the scene on foot prior to the deputies' arrival. No one was injured."

One of the male suspects was also described as being about 6 feet tall and of slim build. The other was said to be about 5 feet, 9 inches tall and of slim build. The female was described as about 5

feet, 2 inches tall and of slim build.

Police also are looking for a New Church man charged with robbery and use of a firearm in a felony in connection with an incident that occurred on Germaine Lane in Parksley last month.

The sheriff identified the suspect as Keeshawn Terrell Kellam, 21, of Bayside Road. He is described as a black male, about 5 feet, 8 inches tall and weighing 150 pounds. Kellam was entered into the Virginia Criminal Information Network and the National Crime Information Center as a wanted person.

The incident was reported to the sheriff's office at about 8:35 p.m. March 11. Giddens said an investigation found that three black males entered the home and robbed the owner at gunpoint. An undisclosed amount of money was taken before the suspects fled prior to deputies' arrival.

# Would Accomack Tax Hike Be Justified?

The majority of Accomack landowners who answered a recent Eastern Shore Post e-mail survey said they do not want real-estate tax rates to go up by 4 cents per \$100 valuation as proposed by county supervisors.

Others favor the proposed increases to raise money for education, which has suffered major cuts in state revenue.

A public hearing on the county's proposed 2010-11 fiscal budget and the corresponding tax rates will likely bring out even more opinions. The session is slated for 7 p.m. Monday at Metompkin Elementary School.

"I do not agree with the raise," wrote Maria R. Seibert of Wachapreague. "The School Board Office could reduce (the) budget by cutting costs (cars, including gas and upkeep) phones and high salaries. The ... supervisors do not need to receive premium health care and ... should have to pay for their families same as teachers.

What they say and do are two different stories ... just look at track record." She suggested that school division administrators take 10 percent salary cuts.

"Yes, my job is threatened" due to the economy, Seibert said. "However, loss of job and higher taxes just does not make sense."

Christine Waldenmaier of Onancock wrote in favor of a tax hike. "We have to get some money somehow," she said, "and this is probably going to be ... the first way that we can raise the necessary funds to replace what the state has withheld ... for our schools and community services."

"The schools will still need to lose some personnel even after the proposed tax increase," she continued. "I would like to see some of the high-paid personnel in school administration either be encouraged to retire or relieved of their positions, as opposed to more instructors, bus drivers, teachers' aides losing their jobs. Accomack County is one of the lowest sup-

porters of schools in ... Virginia. It's not like we are already overtaxed. The schools are at the breaking point now. They've already been cut down to the minimum. These planned cuts will have a definite and distinct impact on our students and their instructors."

"The very first thing prospective businesses ask when they consider relocating here is, 'How is the school system?'" wrote Maureen Dooley of Melfa. "This 4 cents is a down payment on the future of the Shore. The education system needs us. I will pay this tax." Dooley said her employment hasn't been affected by the recession yet. "My job is grant funded," she wrote. "If the economy continues to decline and federal budgets are cut the ripples might reach me."

"Hate to see a tax increase, but sometimes it has to be done," wrote Jon C. Poulson of Melfa. "Just don't want it to fund government 'Fat' or 'Waste.' Adequately funding public education is well-spent dollars." Poulson said he would oppose the

"layoff (of) necessary and good employees and teachers."

Karen Simpson of Quinby said she "completely disagrees" with a tax increase.

"I am surprised they feel so secure in their positions that they don't feel they can be voted out by the outraged public. Comparing how low our tax rate is ... to how high it is elsewhere is nonsensical. The conditions are extremely different as are the family economics. People cannot stand raising any costs. We are just trying to hold on to our jobs and our homes. Why are the supervisors trying their best to make it that much harder?"

"The 4 cent hike affects thousands of people who have no children in the system," she added. "Citizens should not be paying for the medical insurance of the supervisors — particularly any family members." Simpson wants to know why vacant county buildings are not being used or put up for sale "instead of wasting rent dollars."

Rev. Claire Hunkins of Oak Hall favors the tax proposal. "I think Accomack schools are at a critical needs level already. Our children, who are our future, cannot afford to be diminished by lowering the quality of education any further. Maintaining the education system is ... critical ... if the county desires to attract new business and new families to maintain its vitality. No group or business or person is free of the effects of the current economics. As churches ... we too have felt the pinch in our own budget and have worked to tighten our belts as good stewards."

Ann Stubbs of Chincoteague wrote, "I am not too happy. With the economy as it is (taxes) should be lowered." She said in Virginia Beach the rates were decreased twice, "the last time by 12.5 percent." She complained about the assessments too. "I would bet a lot of people would be glad to sell the supervisors theirs for what the supervisors think they are worth."

"I am certainly not against education but they need to cut back," wrote Stubbs. "There are too many people in the system. When I went to school, we had two maintenance people, no nurse, no guidance coun-

selor and no police. The school secretary handled injuries. We had upper school patrol boys that wore badges and were in the halls and on each bus. If the government hadn't taken away discipline we would not have the mess in schools going on."

Bob Justis of Germantown, Md., who owns property in Accomack, supports the tax increase for better education.

"We don't want even one more cent taken out of our pockets," wrote Lynn and Don Gillingham of Onancock. "The schools need to tighten their belts just as the rest of us are having to do. We are both retired with fixed incomes and simply cannot afford another tax increase for any reason ... Medicare benefits are going to be cut, is anyone going to pick up the slack for the seniors? No. So we will be expected to make up the difference out of our own pockets."

Terry Ewell of Bloxom also wants Accomack to "tighten its belt just as the rest of us have had to do

and continue to do." Ewell suggested that existing functions be "reviewed and reorganized. ... Utilize departments' internal expertise for projects instead of hiring expensive consultants. Cross-train county employees ... cut travel expenditures for conferences, meetings, and seminars."

"Ensure supplies for all county organizations are ordered from vendors offering the lowest prices," Ewell continued. "Seek competitive bids for animal control, school bus service, operation of a county motor pool, combined janitorial services for all county departments. Eliminate the county attorney and his legal assistant."

Micaela Barnhill of Greenbackville supports the tax increase. "It will cost me an extra \$4.66 a month. ... I can surely live with that if it will help the schools ... education is the key to remedying social problems."

Lois and John Cooper of Pungoteague wrote, "It's about time" taxes went up. "Had this been done incrementally in the past 20 years or more, we would not be in this fix today. There was no responsible

planning done by the old guard."

Hal Koenig of Exmore owns real estate in Accomack. "Taxes on undeveloped land are way too high already, especially considering the precipitous decline in values since the last reassessment," he said. "Our assessment tripled."

He wonders if officials can find money elsewhere in the budget. "Have some independent, knowledgeable people examine the county's entire budget, including the school budget, for cost savings."

Maria Paccioretti of Atlantic wrote, "For some this will seem insignificant. I could not support increasing the real-estate tax because I believe that the last assessment was poorly done. Many elderly and folks on fixed income will be adversely affected."

She said using money for education is necessary because "of the deep cuts to education in the state budget, but I would like to see specifics as to how the money will be allocated."

"I have always favored 'user taxes' and will be helping to get a meals tax on the ballot through referendum ... continuing to in-

crease taxes on real estate and personal property is unacceptable to me," Paccioretti wrote. "We need to think more creatively."

Bobby Carroll Huether of Pungoteague wrote, "In the economic hardships we now face, the last thing we need is more of a financial burden on the people. That is just what real-estate tax does. If you own property, there is no way around it. If I don't want to pay sales tax, I just won't buy where I feel the tax is too high. ... The county needs to live within its means. Free money from outside the county may not always be there and we need to understand not to rely on it."

"I have no problem paying for public education," Huether said. "Maybe some of the upper management's pay and benefits need to be reduced. I know the schools themselves are struggling. ... We as a community have to be more involved with the support of the education system of our county because Richmond can't help us like they used to."

John Hickman of Chincoteague wrote, "Cutting taxes and cutting

Public Safety Director Jason Loftus broke down the \$128,000 in revenue cut from local volunteer fire and rescue companies in his letter. The totals include \$4,000 to Oak Hall; \$6,000 each to New Church, Painter and Tangier; \$8,000 each to Tasley and Atlantic; and \$10,000 each to Greenbackville, Chincoteague, Saxis, Bloxom, Parksley, Onancock, Melfa, Onley and Wachapreague.

He also wrote that his emergency management coordinator's position, which was eliminated, is mandated by the state. Noted Loftus, "Work would have to be contracted out (including) the emergency operations plan and local capability assessment report. Federal compliance with the National Incident Management System (NIMS) would cease. The action would certainly jeopardize any future federal grant funds to Accomack ... all planning and practice activities for disaster management would stop. Only minimal support could be provided to the CERT program and

the amateur radio program."

Maintenance, periodic inspection of the emergency center and equipment, and many preparedness seminars would also not be possible.

Attempting to pass the duties to another existing position within his department would not be cost effective or efficient "given the man hours the duties of this position demand," Loftus wrote. "The result will be the loss of a critical component that addresses the safety of the residents of Accomack County and puts them at risk."

Planning Director Jim McGowan asked the board to consider "partial restoration of the proposed cuts" to his department. "I realize that we must all do our part, but eliminating two positions in a department of six will be devastating."

McGowan cited several programs which had suffered significantly before he and his staff were hired. "These and other shortcomings were not due to the lack of staff effort, but simply due to the lack of staff," he wrote.

Noting how far his department has come, McGowan said, "We have worked hundred of uncompensated

hours to build our capacity, motivated by the accomplishments made possible by the leadership of you and the board that provided the goal of better planning and the staff resources to accomplish it. With the proposed budget cuts, we will have to partially return to the level of service that existed when I started working for Accomack."

Public Works Director Stewart Hall wrote, "This is not an appeal, per se, but rather my own ideas on what our services might look like should all the proposed cuts be approved."

"These reductions will most likely result in every other day service at some of our buildings," Hall wrote. "I recommend that our court buildings and social services building continue to receive daily service." Hall said a contract with the latter department reimburses the expense. "As for the court buildings, they have high traffic and every day custodial service also helps with security."

He suggested that buildings with reduced cleaning "still maintain restrooms on a daily basis. Additionally, I suggest that we reach out to all employees to make an effort to police

their own work areas and notify (a) supervisor of special events in advance. Common area trash receptacles for non-recyclable items versus a receptacle at every workstation might also be worth considering."

Hall said the \$32,655 airport secretary is needed since that employee manages the customer billing and inquiries.

Hall said \$85,000 worth of cuts to the Parks and Recreation Department would likely mean a problem with mowing grass.

Chairman Michael Tolbert of the county Airport Commission wrote that measures are being taken to meet budget cuts.

Still, the impact of the lost secretary "will fall to the airport manager diminishing the time available to research other revenue generating and grant funding opportunities," Tolbert wrote. "Deposits to the treasurer and billing may be delayed due to an increased workload. Overtime will be incurred to cover duties" and there will "be a loss of internal control with one person handling all financial transactions."

Commissioner of the Revenue Leslie Savage pleaded for her employee who has worked for the county for 12 years. She "works hours over and beyond what is required of her. ... We are implementing a new tax program ... with a semi-annual billing cycle ... along with our other duties. ... We have taken the responsibility for the vehicle license fee (which replaces the county stickers)."

If the meals tax passes, Savage said, her office also would implement that program. "With the additional duties ... it will be extremely difficult for four people to do their jobs efficiently."

the county's real-estate rate that is going to public hearing Monday night. Three cents of the increase is intended to go for county schools; the other penny is for school debt.

Chairwoman Laura Belle Gordy wouldn't allow any motions on the subject Wednesday, noting that the meeting was called specifically to discuss Walmart sign changes. Before the meeting started, Gordy said they wouldn't stray from the agenda because Supervisor Steve Mallette was absent.

Still, Supervisor Jack Gray (a former School Board member and long-time school administrator) voiced his agreement with Thornton.

Supervisor Sandy Hart Mears also wants Miner to come back with a report "on the history of what the board (of supervisors) has spent" on the school system so the public will know they support public education.

"We all support the schools, Madam Chairwoman," Thornton said. "We also support the public."

Miner said he included the state superintendent's annual report in papers that were handed out to the

supervisors. That information, obtained from the state Department of Education Web site, is a review of the 2008 fiscal year. It tells "where we stand relative to a number of issues," Miner said.

Supervisor Grayson Chesson clarified later, "We just appropriate money to the School Board. They are the ones who decide how to spend it."

On the Walmart issue, the supervisors voted 7-1 to modify a conditional-use permit that designates the color of signs the company would use in its Onley store. Initially, it planned on using blue,

but the company logo has changed to "toast medium brown."

Thornton wanted to allow Walmart to make such changes in the future with the permission of the zoning administrator. She said, "A lot of people are laughing at us" because they offered public hearings on the issue. "I don't want the people laughing anymore."

County Attorney Mark Taylor left wording in the modification that forces Walmart to come back whenever they want a change. "Walmart can live happily with it either way," he said. Mears was the only one to agree with the attorney.



the size of government are all people think about anymore. But they fail to realize that it takes money to run the county and provide the services we are all accustomed to

having and we simply can't cut anymore."

He favors a tax increase for schools. "We have just about the lowest paid teachers in Virginia and we lose good teachers all the time to Maryland and to other private jobs. Our kids and schools are too important to neglect any longer.

Rhet Tignor of Hacks Neck wrote, "I hate to see our taxes going up. But the General Assembly and the governor seem intent on cutting education and health care while giving more to business ... we may have no other choice."

Chincoteague Councilman Jim Frese said he is "angry" about the

proposed increase. "Most of ... the supervisors line their pockets with their health insurance while laying off hard-working and loyal employees." He complained about overspending by funding the county legal department, wasting \$1,000,000 on the 2008 reassessment. He doubts the county's intent to use the money for schools and contends the people should impeach certain members or "vote them out."

also sends associates to make deliveries for him, including Price," Faddis said.

Those accusations include West allegedly selling 13.2 grams of crack cocaine for \$600 in the Bayview area on June 10, 2009. This transaction was "monitored and recorded by a digit audio/video recording device," the agent said. On July 15, 2009, "under the direction and control of agents," 37.7 grams was allegedly sold by West and Price for \$1,800," he continued.

Faddis told the court he has a witness who allegedly "observed West and Price cooking powder cocaine into crack cocaine at West's auto shop."

One witness said his or her arrest in 2007 stemmed from cocaine that was supplied by West who allegedly delivered the drugs in a Range Rover or a Mercedes Benz and met people at his mother's house in Kiptopeke to finish a deal started at the car wash in Cheriton.

According to the affidavit, Price was convicted in 2000 in Pasquotank County District Court in North Carolina of the misdemeanor of eluding arrest; was found guilty in 1992 in Elizabeth City, N.C., of resisting, obstructing and delaying an officer; and was convicted in 1993 in Pasquotank Superior Court of possession of a controlled substance.

The papers also state that West "has no legitimate employment, yet is known to possess assets and cash indicative of substantial unexplained wealth ... it is believed that female members of this group ... provide support and assistance ... by registering vehicles in their name for West and by laundering money in exchange for monetary support."

### POISONOUS PLANTS

#### Poison Ivy

• Eastern poison ivy is typically a hairy, ropelike vine with three shiny green (or red in the fall) leaves budding from one small stem

• Western poison ivy is typically a low shrub with three leaves that

does not form a climbing vine

- Poison ivy may have yellow or green flowers and white to green-yellow or amber berries

#### Poison Oak

- Typically, a shrub with leaves of three, similar to poison ivy
- Pacific poison oak may be vine-like
- May have yellow or green flowers and clusters of green-yellow or white berries





### Poison Sumac

• Woody shrub that has stems that contain 7-13 leaves arranged in pairs. May have glossy, pale yellow, or cream-colored berries

### EXPOSURE

- Direct contact with the plant
- Indirect contact, such as touching tools, livestock, or clothing that have urushiol on them
- Inhalation of particles containing urushiol from burning plants

### SYMPTOMS

- Red rash within a few days of contact
- Bumps, patches, streaking, or weeping blisters (blister fluids are not contagious)
- Swelling
- Itching

### PREVENTION

• Wear long sleeves, long pants, boots, and gloves. Wash exposed clothing separately in hot water with detergent.

• Barrier skin creams, such as a lotion containing bentoquatum, may offer some protection. Barrier creams should be washed off and re-applied twice a day.

• After use, clean tools with rubbing alcohol (isopropanol or isopropyl alcohol) or soap and lots of water. Urushiol can remain active on the surface of objects for up to five years. Wear disposable gloves during this process.

• Do not burn plants that may be poison ivy, poison oak, or poison sumac.


