## Runway Run-In

Accomack officials are looking for a money tree. Instead, their inability to come up with funds to build a taxiway from Wallops Research Park to NASA's airport runway has caused them to lose grant money — \$700,000 worth.

Wednesday night, Accomack supervisors voted 5-2-1 to spend \$21,500 for a study aimed at advising the best way to finance the project, which could cost \$8 million. They also agreed to meet in a closed session with BaySys Technologies and Garrett Companies — two businesses that wish to locate in the park — to determine if they can help.

BaySys reportedly told officials it is "prepared to pay a significant portion of the cost." The Tasley company needs to get started on building a \$25 million hangar it needs for a project set for 2011. BaySys is now using a NASA hangar and a large leased tent.

Supervisors Grayson Chesser and Sandy Hart Mears were opposed to authorizing the study. Vice Chairman Donald Hart was absent and Supervisor Phil McCaleb, an insurance broker who does business with BaySys, abstained.

County Administrator Steve Miner said Accomack would likely need to finance between \$3 million and \$5 million. Borrowing the funds could run up \$200,000 a year in debt service.

## STAR Transit Shows Increased Ridership Under New Management

About 18 percent more one-way trips were taken on STAR Transit in March compared to the same month in 2009. President Mark McGregor of Virginia Regional Transit (VRT) told Accomack supervisors the number of journeys taken in April, the second month under new management, rose by 21 percent or to 3,800.

Still, McGregor threatened to cut services back by 50 percent if county officials didn't come up with nearly \$33,000 to help finance the Eastern Shore's public bus system. Services would have been reduced by a total of 25 percent in the two-county area.

The supervisors voted 6-2 to use contingency funds to foot the bill.

The money represents 32 percent of the cost. State and federal funds match the remaining 68 percent.

"We need to just get through the year," McGregor said. He explained that while \$60,200 in local money is needed in the current fiscal year to run the buses, the county only budgeted \$29,000 for the cause.

The Accomack-Northampton Transportation District Commission hired the VRT to study and restructure the system after running into financial problems last year. That agency has a one- to three-year contract to get the bus system back on track.

Managers eliminated low-usage runs and increased the number of trips on routes used more frequently. The goal was to get more

people to use the system. Changes were based on an efficiency study and a rider survey. The VRT also decreased fares.

Chairwoman Laura Belle Gordy and Supervisor Wanda Thornton were opposed to funding the system. Vice Chairman Donald Hart was absent due to illness in his family. The other supervisors agreed to increase the budget.

McGregor said the system is an essential component for economic development. "The previous manager was not a good fiscal steward," he added. Supervisors suggested the transit look for contributions from major employers like Perdue.

"We operate the service," said McGregor. "We're really not

fundraisers."

"I didn't vote for this because there is no service north of Park-sley," said Thornton. She said the cost to continue a route though the northern part of Accomack would cost the county \$6,845, or \$36.15 an hour.

"When ridership is up, service will be restored" to those areas, said Supervisor Ron Wolff.

"It was a demand/response service," said McGregor. "We want to restart that service ... we'll be able to have a track record and show you results."

On another matter, the supervisors also hope they can save taxpayer money by sharing the school system's public notification

# More Information Filed About Murder Suspect

Documents filed in Accomack General District Court Tuesday offer a different name for the accused killer of Johnny Strand. The record also states that Fernando S. Carbillo, 23, of Dreamland #1 in Accomac confessed to the crime.

Police initially identified the man as Fernando Carrillo Sanchez. A preliminary hearing is set for 11 a.m. Aug. 6, 2010. Carbillo is charged with second-degree murder and is being held without bond.

A checklist for bond signed by Magistrate Jimmy Rowley states that "a firearm was not used in the offense." Sheriff Larry Giddens and the Medical Examiner's Office have refused to disclose the cause of Strand's death.

The body of the Onley Pizza Hut manager was found at his home at around 2.30 p.m. May 1. Relatives went to the Pine Ridge Drive residence near Melfa to check on him after he failed to show up for work. A police report said he suffered multiple injuries.

According to the checklist, Carbillo has lived in the area for two years, has no family here and no education, and worked for a local painting company.

Garrett Dunham, an Eastville lawyer, was appointed on May 5 by Judge John W. Wescoat to represent the defendant.

Carbillo is 5 feet, 8 inches tall and weighs 130 pounds. Sgt. Anthony Bright of the Sheriff's Office swore out a warrant for his arrest. It was issued on May 5.

Strand was slain just a few days shy of his 50th birthday. Giddens said the suspect was not a stranger to the victim who worked Friday night, April 30, but didn't show up at the business the following day.

Giddens said investigators focused on finding Strand's vehicle, a black 1998 Ford Expedition, which was recovered at Dreamland #1.

"The cause of death is a very, very vital part of the investigation," the sheriff said. Of Strand, he added, "Everyone liked him. He was a good person."

Membership of a [facebook.com](http://facebook.com) memorial site for Strand has climbed to 1,719. Strand was also well-known for his singing abili-

ties. Virginia State Police and the Virginia Marine Resources Commission assisted the Sheriff's Office in this case.

## Accomack SOL Writing Scores Improve

A higher percentage of Accomack Public School students who took writing Standards of Learning (SOL) tests passed this year, according to preliminary scores.

Assistant Superintendent Jessie Duncil told the School Board Tuesday night the results proved "very hopeful" for overall English results. "Overall very good scores," she said.

"Very nice," said Chairman Al McMath. "We're proud of all our students."

Duncil said the tests were given to students in grades 5, 8 and 11.

At Accawmacke Elementary School, 91 percent of fifth graders passed, compared to 81 percent last year. Chincoteague Elementary School fifth graders went from 88 to 90 percent, while 80 percent of Kegotank Elementary School

students passed compared to 71 percent last year. At Metompink Elementary School, the figure jumped from 78 to 89 percent. At Pungoteague Elementary School, 92 percent of fifth graders passed, compared to 82 percent in 2009.

Tangier Combined School was up 11 percent. Eighty-six percent of fifth-grade students passed the test, compared with 75 percent last year.

More eighth graders at Arcadia Middle School (90 percent) passed the SOLs, compared to 84 percent in 2009. At Chincoteague Combined School, 84 percent of eighth graders passed, a 1-percent increase over last year. Nandua Middle School had 91 percent of the students pass, compared to 88 percent last year, and 86 percent of Tangier students passed the test this year, compared to 100 percent in 2009. Duncil said the 14 percent decrease equals one student.

Second-semester scores only were tallied for the 11th graders. Arcadia High School students went from 87 to 88 percent, while Chincoteague High School students went from 95 to 93 percent and Nandua High School results went from 88 to 85 percent. Tangier Combined School, where one or two 11th graders failed the test last year (or 80 percent passed), showed a 100 percent passing grade.

In other business Tuesday, the School Board also unanimously approved its fiscal 2010-11 budget of \$41,228,604.

Efforts to get federal recovery money or other grants were “unsuccessful,” he said. “The runway isn’t public, so FAA (Federal Aviation Administration) money isn’t available.” The \$700,000 Community Development Block grant the county received from the state for water and sewage infrastructure was withdrawn because county workers were unable to show an ability to get the taxiway built.

“We are then at a crossroads and a decision point,” Miner said. “Does the board continue to aspire to see the taxiway finished? If we stop now, it appears highly likely that BaySys will be forced to leave us at some point.” Miner said 450 current and future jobs could be lost.

The study would provide a gross benefits analysis, a financing plan and an independent risk assessment. Miner said the inability to raise the funds “does not reflect on the worthiness of the project.” He still has hope for the difficult feat of persuading NASA to make a portion of the runway public.

“We don’t have to fund all now, but need a plan,” said Miner. “We will continue to look at another federal program (Rural Development Services)” and hope some recovery money earmarked for other projects will be unused.

Wallops Research Park Manager Amy Bull said the Federal Economic Development Authority remains interested in the project. But

“they require a dollar-for-dollar match” and the county “must be able to demonstrate they are bona fide,” she said.

Supervisor Steve Mallette favored meeting with the companies prior to funding the study. The late Accomack Economic Development Director Larry “Forbes was very effective in lining up people ... we’ve got some other partners we need to bring to the table,” said Mallette.

Supervisor Wanda Thornton favored doing the study first. “We have no guidance right now. We need our ammunition which this is going to give us” before discussing the issues with the private companies, she said.

Supervisor Ron Wolff suggested lobbyists be hired to help raise federal funds. But that was nixed when it was reported that the cost could be \$12,000 a month.

“Everybody’s enthused. Nobody wants to put up any money,” said Chesser, who called the idea “wishful thinking. If we’re going to do this, we might as well figure we’re going to have to do it on our own.” He said the public wouldn’t want to spend tax money on it. “I’m not going to support it.”

Mears was also concerned about spending. “Are we looking at a tax increase next year?” she asked.

“That’s why I want a study,” said Miner. “You have to believe there will be a return on your investment.”

system. County Department of Public Safety Director Jason Loftus will investigate the possibility.

He said it would otherwise cost about \$1,800 per month to send 14,000 text messages and e-mails to local residents. Landlines could be included in the alert for another \$7,600 for the first 1,000 calls and 30 cents for each call thereafter. The plan would allow residents to sign up for the program. Loftus didn’t expect an overflow of landline participants since many are deciding to eliminate landline use. Loftus said the system could be used for evacuations, weather notification or as it was used several years ago — for Chincoteague Causeway closures.

Lotus also said election district alerts could be sent.

“I’m afraid election district notification would be abused by politicians,” said Supervisor Steve Mallette.

Loftus said notifications could be limited to emergencies. “Currently, there is no system in place,” he said.

“It is a wonderful tool,” added Thornton. “When that causeway is flooded, everyone on the island gets called. It does work wonderfully,” but is costly.

“We could piggy-back” on the county school system, said Supervisor Sandra Hart Mears. “It could be worth looking into.”

# Accomack Planner Can Stay, But AFDs Might Go

It was all in a night's work. Accomack supervisors agreed to retain a land-use planner Wednesday night. They also heard about an alleged illegal secret vote taken by the Accomack Planning Commission and pondered the need for agricultural and forestal districts.

Chairman Phil Hickman of the Planning Commission asked the supervisors to consider using money set aside annually for travel and fees for commissioners — between \$6,000 and \$7,500 — to help keep the planner employed with the county.

"We voted by secret ballot," he said of the unanimous poll to give up the money.

"Was the county attorney there when you took a secret ballot?" asked Supervisor Wanda Thornton, noting that private votes were not permitted.

County Attorney Mark Taylor said he did not attend the session.

"It had to be unanimous," said Hickman. "I did not want anyone to feel any pressure. If that's wrong, I'm sorry." He said grant money could be used for the remainder of the planner's salary.

Planning Director James McGowan said he's applied for a \$37,750 Department of Environment Quality grant that he expects to receive because the application passed the first hurdle.

The supervisors appropriated \$9,000 on top of that to save the position. Only Supervisor Wanda Thornton was opposed. Vice Chairman Donald Hart was absent.

At first, McGowan had recommended elimination of the Agricul-

tural and Forestal District (AFD) program. He said it would be impossible to perform a four-year review and renewal for the 22 districts because two workers were cut from his department due to budget restraints. The districts include 1,465 parcels.

"The elimination of the land-use planner and erosion and sediment control inspector positions is a 33 percent cut to the Department of Planning staff, and a 40 percent cut in the five staff members that I supervise," said McGowan. "With the loss of these two positions, we cannot maintain the AFD program. The program requires an intensive two-year staff effort every four years, including staffing of the AFD Advisory Committee and funding for mailing materials, postage and public hearing ads." In addition, he said \$3,000 would be needed for supplies and about \$2,700 for advertising public hearings.

"Regarding staff costs, I estimate an average of approximately 40 hours of staff time per AFD for the review and renewal process," McGowan said, adding that that equals 480 hours to do the 12 districts up for renewal this year. He based it on \$25 an hour, including benefits. "We are not allowed to charge application fees for renewal; we can't recoup any of the costs."

"If you break down everything in your office like that, you'd need 50 people," complained Thornton.

McGowan said the review includes preparing maps, advising the committee, reviewing the information, asking questions and conducting meetings with the applicants, writing and sending let-

ters and scheduling and conducting public hearings.

Thornton questioned the need for the districts since land-use taxation can be gained without it. "It costs a lot of money with no benefit."

Supervisor Steve Mallette said he served on the committee and that before the last review (2006-08), the "program was in shambles. It's a bureaucratic intense program."

McGowan said the districts "provide eminent domain protection and allow the county to better manage development. ... I think many farmers would want to keep the program."

Thornton also complained about getting the funds for the planner through a grant. "It's defeating your purpose ... it all boils down to the same thing. You will have to divert workers to do a job for grant money."

"I'm writing grants to save my staff," said McGowan.

County Administrator Steve Miner said this grant is a worthy cause. It's "not just make-work grants. Sea-level rise is real. People who have money at stake are starting to pay attention. These products ... add value or we wouldn't be applying."

Supervisor Grayson Chesser said he is generally suspicious of grants. "But sea-level rise is a lot more important than ag districts. I'm all for it."

In the end, the supervisors voted to allow McGowan to start work on reviewing the first district. In the meantime they will be asking for opinions on the need for them.

The supervisors also took no action to save the job of a worker in the office of Commissioner of the

Revenue Leslie Savage. She asked the board to put up about \$36,000 since the state recently withdrew funds for the position.

"With the implementation of the new ... program, we're going to be busy straight through," said Savage. "We're busy all the time."

The matter was delayed until Finance Director Mike Mason can report back to the board regarding money that was budgeted for Extension workers who retired.

Economic Development Authority Chairman John LeCato reported that his panel is "looking hard" at ways to entice businesses to the area.

Thornton reported that 7,326 pounds of hazardous waste were collected on Chincoteague at a recent Earth Day event. She said more than 100 people participated.

The supervisors also amended the county zoning ordinance, which was changed in an emergency action last month. The fee schedule for Planned Unit Development was increased to \$2,200, plus \$40 per acres or fraction thereof.

## Northampton Circuit Court Criminal Cases

Seven people pleaded guilty to charges Monday in Northampton Circuit Court, according to Commonwealth's Attorney Bruce Jones. They were:

## Broadband Infrastructure Completed on Shore

Mid-Atlantic Broadband Cooperative, in cooperation with Eastern Shore of Virginia Broadband Authority, has completed construction of a 144-strand fiber-optic backbone cable across the Chesapeake Bay Bridge-Tunnel.

Near the Maryland State line, the Eastern Shore of Virginia Broadband Authority network connects with Maryland Broadband Cooperative, providing continuing connectivity northward.

With construction completed, Mid-Atlantic Broadband Cooperative has passed the title to the network assets to Eastern Shore of Virginia Broadband Authority for operation of the route.

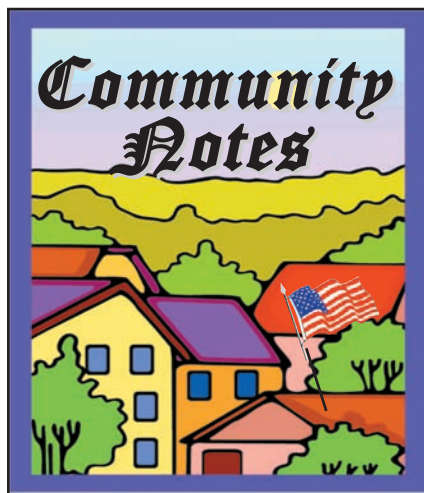

## Cape Charles Harbor Improvements Detailed

Cape Charles Harbormaster Smitty Dize and Town Manager Heather Arcos announced at Thursday's Town Council meeting that the town will receive a \$447,000 Harbor Improvement Grant.

Noting that he had hoped to receive \$100,000 from the \$1 million pool in the competitive grant, Dize was nonetheless pleased with the notification. The harbor improvement plan calls for renovations to the existing piers, as well as additional floating piers and an inner harbor floating breakwater.

Dize reported that the first phase of the outer harbor breakwater is well underway and is expected to be completed by mid-June. The breakwater will consist of five 400-foot sections and extend just west of the channel leading into the harbor. As funding becomes available, the additional phases of the breakwater will be added. Once completed, the breakwater will protect the harbor from wind-driven waves from the southwest, west and northwest.

Town Consultant Bob Panek updated Town Council on the progress being made on the new wastewater plant. He noted that the excavation work for the structure has been completed and that concrete work for the post aeration facility and bio-reactor tanks is underway. The facility is slated to be complete and operational sometime in 2011 at a cost of \$19.4 million. Just under \$15 million in grant funding has been awarded to the town for the facility.

A public hearing will be held re-

garding the possible zero-interest \$5.4 million loan that will be needed to cover the rest of the projected cost. Panek stated that a wastewater reuse agreement was being discussed with Bay Creek whereby a portion of the treated water could be used for irrigation at the golf course.

In a related area, Panek fielded questions regarding the proposed regional wastewater system and Public Service Authority (PSA) and its relation to the new wastewater facility. Cheriton, Cape Charles, Nassawadox, and Exmore are in the early stages of setting up a PSA with the county. Should the PSA come to fruition, it is anticipated that the Cape Charles facility also would be able to service Cheriton and nearby county areas.

Several Town Council members expressed concern over their limited authority with respect to the operations and fee structure of the system once the PSA is operational.

There will be a joint meeting of the towns and county Board of Supervisors on June 21 at the former middle school in Machipongo to vote on the resolution adopting the revised PSA articles of incorporation.

Town Planner Tom Bonadeo and Jeb Brady presented an update on the progress being made with Central Park and the trail project. Sidewalks, trees, lighting, and a fountain will showcase the redeveloped park and gazebo.

Public Works Director Dave Fauber reported that work on the water tower is nearing completion. Fauber said the tank would be drained and the interior painted in the fall after the tourist season.

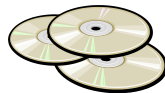

In Accomack, State Police investigated one murder, one forcible rape, one robbery, one aggravated assault, nine simple assault/intimidations, one extortion/blackmail, three burglaries, 15 larcenies, one counterfeiting/forgery, 18 frauds, two destruction/damage/vandalisms, 90 drug offenses and eight weapons law violations.


