## \$13.6 Million Owed to Accomack

A summary of a 480-page delinquent tax report that was discussed by Accomack supervisors and other officials in a closed meeting last week shows a total of nearly \$13.6 million worth of past-due real-estate taxes and personal-property taxes since 1981.

The reason for the hour-long private meeting was listed as "probable litigation." According to the section of the state law that was listed on the agenda, the term means "litigation that has been specifically threatened" and that "the public body or its legal counsel has a reasonable basis to believe will be commenced." The law forbids "the closure of a meeting merely because an attorney representing the public body is in attendance or is consulted on a matter."

Asked about litigation, County Administrator Steve Miner answered, "There is currently no pending or threatened legal action against the county in relation to the delinquent taxes. There is the potential for legal action by the county ... against those who owe taxes or others." He would not identify the "others."

The report summary was the only portion of the document released to the Eastern Shore Post by press time Thursday. Miner said in an e-mail that he wanted to wait until Finance Director Mike Mason returns from out of town (sometime next week) to release the entire document. He said at a copying charge of 25 cents per page, it would cost about \$120 to purchase a copy of the report and none were available at that time. He was hoping to make CDs of it and charge \$20 but first wanted to make sure the information was in a format that could not be altered.

"Once a digital file is out, it's out," wrote Miner. "If I release it to anyone without securing it, and someone comes back and makes a claim saying I was careless, I want to say I gave out only a

protected file."

A breakdown of the bills shows more than \$9,342,100 in delinquent personal-property taxes over the past 30 years, with less than half (nearly \$4.6 million) still collectible. Officials say the county cannot collect delinquent personal-property taxes that are more than 5 years old.

Back real-estate taxes can be collected for 20 years. The summary showed a total of more than \$4,251,700 in delinquent real-estate taxes since 1981. Of that, more than \$4.2 million still can be collected, while about \$50,255 of the debt is over two decades old.

The figures include penalty and interest. The summary did not disclose how much could not be collected because of bankruptcies. The complete report reportedly lists individual debtors.

At the May 18 closed session, the supervisors were given copies of the summary to look at while Miner referred to a copy of the whole report (which is several inches thick) that he controlled, according to sources who asked to remain anonymous. The majority of the copies were taken back from the supervisors at some point either during the session or just after it.

Mason compiled the information at the request of Miner from data provided by Treasurer Dana Bundick's office. Bundick, who has been treasurer for 16 years, stood outside the closed door during the meeting. Mason was outside for a portion of the session and then said he was going home before leaving town on business.

In a prepared statement released late Wednesday, Miner confirmed that the report came from data maintained by Bundick's office.

"The treasurer is by law the person responsible for the billing and collection of taxes – delinquent or otherwise - and is responsible for keeping the data up to date," Miner wrote. "The treasurer is therefore the best source of information

## Accomack Treasurer Responds

Collections of delinquent 2009 and 2010 Accomack tax notices have been delayed and Treasurer Dana Bundick said Thursday it is not her fault.

"I have been held back numerous, numerous times and the people need to know that," she said.

"The law requires that a delinquent notice be sent before I can begin any collection action," Bundick explained. "At the request of the (Accomack) Finance Department, I have not been able to send delinquent notices for 2009 and 2010." She said she was asked to delay "because of all the phone calls and additional work it would cause the Office of the Commissioner of Revenue."

"If I sent the delinquent notices,

the Commissioner's office would not be able to finish their work in order to get the tax bills out on time," Bundick said. "Each year I remind the Finance Department I need to send these notices before I can begin any new collection action. I have been promised that they will work with me in July to get the delinquent notices out. Then I will be able to do my job."

"With the exception of the year my computer system crashed, I have always provided the Board of Supervisors with the delinquent tax report," the treasurer continued. She said when she presents the report every August, "the Board has directed me to keep the report in my office. With the exception of that one year, I have always complied with the law."



# Northampton OKs Budget; No Tax Hike Necessary

The Northampton Board of Supervisors formally adopted a \$43.7 million budget for the coming year this week. It will not require a tax increase.

The supervisors had discussed how to handle unspent appropriations from the current school operating fund. County Administrator Katie Nunez said the money would be returned to the county's General Fund, but in recent years, that money had been returned to the school system to support its capital improvement plan (CIP).

Supervisor Richard Tankard wanted to insure that the unused year-end funds be used only for the CIP and not to fund other areas of the school budget. Supervisor Sam Long Jr. suggested

that the school system have some flexibility in how it uses the undesignated funds given the unstable fuel prices in recent months. Tankard noted that he is still discouraged that the county funds the school system at a higher rate than the minimum rate set by the state. He also noted that he is disappointed by the high cost for the county regarding the operation of Eastern Shore Regional Jail in Eastville.

The board also conducted a public hearing for proposed changes to lot sizes, coverage and setbacks for waterfront villages.

At question was a request to reduce shoreline setbacks and lot widths for the waterfront villages of Willis Wharf and Oyster. The request was forwarded by attorney Cela Burge, who represents aquafarmers in Willis Wharf. The proposal involved a minimum shoreline width of 250 feet and setbacks, including one of 110 feet from the shoreline. Burge said many parcels in Willis Wharf are irregular in size

and shape and pointed out that aquafarming industry must be located adjacent to the shoreline to use seawater for the growth of shellfish.

Following a brief discussion by the supervisors, the amendment was approved. The change reduces the minimum shoreline setback to 0 feet and minimum shoreline width to 60 feet. It applies only to water-dependent facilities such as docks, boat ramps, intake and outfall structures for power

plants, water and sewage treatment plants, storm sewers, marinas, fisheries, and aquafarming facilities.

A public hearing was conducted regarding a grant for \$1,369,334 from the Federal Emergency Management Agency (through the Virginia Office of Emergency Management) to upgrade communications systems for emergency services. Following the hearing, the supervisors approved the budget amendment.

# DYCE YOUTUBE VIDEO HAS EXMORE ALL 'RAPPED' UP

The 26-year-old spits explicit lyrics that sometimes detail the story of his life. But the rapper goes by a name that means the plural of die and there were times in his past when Arkiece "Dyce" Davis of Exmore wished for his own demise.

His future is a whole lot brighter these days.

Some of his words are for entertainment," he said this week. The rest are his reality. "I plan on bringing a trophy back here. I plan on being a legend," Davis added.

He's been making a living with gigs in Baltimore, Georgia, New York, D.C., Norfolk, Virginia Beach and Philly and recording mixed tapes by "rapping to someone else's beat." Davis wants and intends to do more. He used to work with Job Corps.

His subjects range from money, drugs, sex, family and friends to prison, race and gambling. He used to have a problem with the latter and says that's how he got the nickname. He favors the tag because it has many uses.

Davis doesn't want to forget those whose lives have taken a wrong turn — peers and family in prison — many of whom he said got more time than they deserved. He's glad things that could have happened to him didn't.

"I'm trying to put the Shore on the map," Davis said. "Get the old music back into it. How the music used to be. Poetry. I'm telling my life. I'm not trying to influence people to do wrong. I'm trying to set an example."

"Basically, the only thing I'm missing is my own beat," he said, adding

that he's working with others to get that so he can make an album. Virginia Style Records, LLC, a Severn, Md., company, is backing him. Founded by two women who grew up in the same Eastern Shore of Virginia town, the independent record label is owned and operated by best friends Camisha Davis (his cousin) and founder Markena "MT" Townsend, another artist.

The connection for Dyce Davis is paramount. He and his brother, Millie, also have branched out to establish their own label, Block of the Sinnaz.

Davis' childhood lacked the usual advantages. He remembers living on Row Lane in the New Road area with 15 other children and his grandmother in a house that had no plumbing, no central heat and no running water.

"It was good times but at the same time, we went through hell," Davis recalled. "If you really, really knew me and knew where I came from, you'd say I came a long, long way."

Davis said they got water by toting gallon jugs filled with a hand pump at the neighbor's house. "Even though I was young, I could see what was going on," he said.

Noting that he wasn't old enough to work and help out, Davis said, "I had to just sit back and wait." His memories include playing out in the yard near overflowing sewage and being embarrassed at school when he put his coat in the closet with those of other students and the fumes of kerosene "would ruin everybody else's clothes."

"There were many times I wanted to die," he says in his favorite song, "Why

Me?" The rhyme is the style he wants to continue. "I'm an entertainer," Davis said. "I have to give people what they want right now." After he makes it, he'll be able to do more of what he wants. A video is planned for "Why Me?" on July 4. His aunt will portray his grandmother (the late Dorothy Davis) and his nephews will fill in for him and his generation of cousins.

The poverty stifled Davis when he was younger. "I came from nothing so I'm more appreciative" now, he said. "At Row Lane ... I saw the crack houses and the people who were around the area. ... If I was more comfortable at my house, I would have been more comfortable to do things at school," including playing sports.

He felt frustration. "I looked at myself wanting to be somebody. What can I do?" Davis asked himself.

The rapper regrets not finishing high school and wants better for his two sons. "I love them to death," he said. "I'm happy with who I am, but I would have made a lot of different choices ... this is the thing, you live and you learn ... make it better." Davis said he's "thankful. I've gotten a chance to do this and talk about it."

Wearing his trademark star-studded earrings and a variety of baseball caps, the rapper has been busy. He said he's written more than 100 songs. He has a video on [www.youtube.com](http://www.youtube.com) titled "E.S.T.," with nearly 6,000 views since February.

"MT is pushing me. She's like really, really pushing me," he said of the rapper who is in the video with him and his brother.

And while Davis pointed out many of the things that were included in the film, he doesn't want to be judged totally by it. Still, he said, "That song was Exmore, period."

Set on Virginia Street, a crowd (of people who are his family or those he considers family) gather, crossing their arms in the air in an X for Exmore. They include the owner of a local boxing and fitness training gym; Bunny Wise, son-in-law of Ruth Wise, who helped get better conditions for the residents; and a town officer, who rides by in a patrol car and shakes his finger at the group. Davis said the police officer was not paid to perform as some have insinuated.

The video also bashes a retired judge and the county's prosecutor. Davis said he doesn't hate anyone and he understands they have jobs to do, but he insists they lack compassion.

In the background is a building where the body of a 19-year-old man was found hanging by the neck in 2002. Davis said the death wasn't investigated enough. The crowd, including children, sway to the music in front of the home of "Fat Man," the only resident still without plumbing. "He didn't want to leave," Davis explained.

Dorothy Davis was living when her grandson wrote his first song and she liked it. "The buzz you get from older people — when they ask me for a CD — it just makes you want to keep" going, he said.

The late Rapper Tupac Amaru Shakur is Davis' idol. "They see the negative side of him and (at) the same time he was a very powerful person."

## Onancock Proposes \$2.6M Budget

Former Mayor Shirley Zamora urged Onancock Town Council Monday night to be conservative when adopting the fiscal 2011-12 budget of more than \$2.6 million.

The proposal included a 2-cent increase in the real-estate tax rate and a deficit of \$117,302 in sewer expenses, which is proposed to be covered by reserves. The officials are expected to act on the proposal in June.

“Put aside money for the future to keep” Onancock “out of obligation,” Zamora said at a public hearing. “Keep the sewer contingency fund intact” and if necessary, “slowly raise the rates.”

She voiced concern about the possible adverse effect a new Laundromat in Onley will have on the one in Onancock. Without this large water consumer, Zamora warned, “the rest of the citizens will have to kick in” more funds.

“In tight times like these,” she advised, “look hard” at town salaries.

In other business, Council debated whether a hotdog stand can legally conduct business on a zoned lot. Town Manager

Sandy Manter explained that the zoning ordinance does not have a provision for the cart. Town Attorney Dave Rowan agreed.

But Wayne Bal, the owner, said that for three years he has bought an Onancock business license and has built up his clientele. “I came here to resolve it before it goes any further,” he said. “I’m not going to shut down and lose business.”

Bal sets his cart up on a hardware supply store’s lot. He said that previously he did business on sidewalks. He contended, “My cart is a zone.”

Manter said the ordinance would need to be amended to allow the use. “I’m getting calls from folks who don’t like this ... restaurants in town,” she said.

“You’re locked into the zoning ordinance,” said Rowan. “It’s up to the council to enforce it.” He said Bal “can operate for 30 days while he appeals.”

Councilman Travis Bradley suggested the issue be sent to the Planning Commission, where public opinion could be sought.

Mayor Bruce Paone said, “we can rescind the license if we issued it in error.”

regarding the report and its meaning.”

While the Finance Department previously raised the issue of delinquent accounts, Miner’s request allowed Mason to produce a more compact document, the prepared release states.

A breakdown by year shows delinquent personal property taxes as \$55 for 1981, \$65 for 1982, \$665 for 1983, \$1,670 for 1984, \$3,497 for 1985, \$8,138 for 1986, \$12,926 for 1987, \$18,260 for 1988, \$34,652 for 1989, \$46,694 for 1990, \$54,547 for 1991, \$56,316 for 1992, \$68,901 for 1993, \$91,095 for 1994, \$137,528 for 1995, \$207,187 for 1996, \$281,900 for 1997, \$285,836 for 1998, \$408,451 for 1999, \$461,606 for 2000, \$467,409 for 2001, \$481,413 for 2002, \$528,237 for 2003, \$515,556 for 2004, \$595,072 for 2005, \$632,438 for 2006, \$680,614 for 2007, \$744,242 for 2008, \$975,652 for 2009, \$1,541,475 for 2010. In the last equation, \$120,847 was listed as a license fee.

A breakdown of the real-estate delinquencies by year was \$3,653 for 1981, \$492 for 1982, \$485 for 1983, \$1,857 for 1984, \$2,269 for 1985, \$3,127 for 1986,

\$5,632 for 1987, \$7,584 for 1988, \$9,588 for 1989, \$15,563 for 1990, \$15,240 for 1991, \$18,817 for 1992, \$19,957 for 1993, \$20,959 for 1994, \$20,555 for 1995, \$27,365 for 1996, \$34,016 for 1997, \$35,896 for 1998, \$38,148 for 1999, \$44,338 for 2000, \$56,328 for 2001, \$65,257 for 2002, \$80,471 for 2003, \$95,689 for 2004, \$124,433 for 2005, \$197,226 for 2006, \$276,256 for 2007, \$506,989 for 2008, \$935,605 for 2009 and \$1,587,913 for 2010.

Wesley Edwards of Belle Haven (who says he will run for the District 9 supervisor’s seat in November but has yet to formally announce) told the supervisors earlier this month that he couldn’t find “a county that has a worse collection rate in ... Virginia than Accomack.”

He said another county with “the same amount of tax income” has “\$1 million in delinquent real estate taxes ... (and) \$1.5 million in delinquent personal property taxes.” Edwards said while Accomack writes off \$500,000 a year in personal-property taxes, this unnamed county writes off \$100,000 a year.

# Police & Court Postings

## Accomack Circuit Court

Charges against two men were dismissed in Accomack Circuit Court last week, according to court records.

Tony T. Weeks Jr., 20, of Dingley's Mill Road in Melfa pleaded not guilty to receiving a stolen Honda 400 EX Sport 4-wheeler on May 22, 2009. Jason Bryan Crockett, 21, of Main Ridge Road on Tangier Island was charged with illegally possessing oxycodone on Aug. 1, 2009. The court dismissed both charges.

### Northampton County Sheriff's Office Joins Click It or Ticket

To Crack Down on Seat Belt Use in an Effort to Increase Use

Northampton County Sheriff's Office will join local and national law enforcement officers and highway safety advocates all across Virginia and the country for the 2011 national *Click It or Ticket* seat belt enforcement mobilization.

During the mobilization, law enforcement throughout the Commonwealth will be cracking down on motorists who fail to obey all traffic laws — including seat belt and child safety seat belt use — both day and night.

Virginia has seen steady decline in traffic related fatalities; however, preliminary data for 2010 indicates that there were a total of 740 fatalities, of those, 314 were not restrained at the time of the crash.

Pickup truck occupants have been proven to be less likely to buckle up than any other class of vehicle. In a 2010 Seat Belt Observational Survey conducted by Old Dominion University, the average seat belt use rate of pickup truck occupants was 71.4 percent as compared to the state use rate of 80.5 percent.

"We need to continue to make the case that seat belts really do work," said Sheriff David Doughty. "We will do that by hitting the roads and enforcing all traffic laws 24/7, no excuses, no warnings, and we will be paying particular attention to seat belt use."
