First Degree Murder Conviction for Man Who Stabbed Hospital Employee

Before stabbing his former girlfriend 46 times last November, Winston Leroy Burton prepared for the murder by putting on surgical sleeves to protect himself from the blood that would later leave a trail as he repeatedly struck her with a cheap knife that eventually broke.

Testimony at his trial in Northampton Circuit Court this week also disclosed that the 58-year-old Cheriton man waited in the parking lot of Riverside Shore Memorial Hospital in Nassawadox, where Shelli Crockett worked, and started "butchering" her before she even got out of her car.

Her screams were heard by a coworker who was also arriving at the facility.

"I thought he was hitting her," Amanda Butler

said. "I walked towards where what was going on. He pulled her out of the car. He had her in the headlock. I got a little bit closer and realized he wasn't just punching her. I got close enough to see blood splatter. He was dragging her over by the dumpsters ... her face was up against the fence. He was repeatedly stabbing her. I could see the wounds and there was blood everywhere ... I was five or six inches from the back of his head. I screamed for him to get off of her. Anything to get him to stop ... finally he stood up."

"F--- it. Call the cops," she recounted hearing him say. "I watched him walk away far enough so he would not come back at me," she continued. She then tried to comfort her friend. "You couldn't see what color her skin was. She was alive and trying to speak to me," Butler testified as she wiped the tears from her face.

Three rows of family and friends, including Crockett's parents and the father of her daughter, also showed signs of distress at the testimony. Many were

Board Votes to Dissolve Onley Fire and Rescue

Accomack supervisors unanimously agreed Wednesday to dissolve Onley Volunteer Fire & Rescue (OVF&R), effective immediately. The company was also directed to liquidate its assets.

Other nearby units will take up the slack as they have been doing for months and new response boundary lines will be drawn up by the county fire/rescue commission to officially incorporate the district.

Earlier in the session, Mayor Jack Pierson of Onley, who said he was not speaking in his official capacity, suggested a group be put together to interview the Onley station's roster. "Give them 60 to 90 days to prove if they can run it," he said. "It should be a fair decision, because it's a big decision."

"I think this is the only thing that can be done," Vice Chairwoman Laura Belle Gordy, who represents the Onley area, said. "I hope that someday we will have a good fire company again."

"In the 70s, Onley cried out for the need for fire and rescue," said Royal Governor, president of the company. "Why deprive them now?" he asked. This could turn into a legal matter, "If not cleaned up the right way," he continued, explaining the company's

ambulance "had a blown motor" but the engine was replaced. Governor said on June 25, 2017, a new ambulance was purchased. On June 8, they were notified that their OMD (Operational Medical Director) resigned effective July 8.

"Other stations have poor statistics and yet are rewarded with county staffing," Governor continued. "Are those other companies ... going to be held to the

wearing purple clothing or ribbons to show domestic violence awareness.

Another worker saw the disturbance and went to get help. When he returned with reinforcements, he saw Burton driving away. Earlier, he asked Burton to move his car because it was parked in an illegal spot. He said the defendant was cordial and drove away from the hospital.

In addition to the eye-witnesses who identified Burton, five others, including his daughter, said he confessed his guilt to them within minutes of the killing, and there was a slew of scientific evidence to back up the charge.

Even so, Burton pleaded not guilty and asked for a trial by jury, which turned into a formality as those who watched the case unfold wondered why he bothered. After two days, the jury took less than 40 minutes to pick a leader, sift through the legal instructions and bring back a guilty verdict. In addition to the first-degree murder charge, the panel found him guilty of three or more subsequent violent crimes, which by law calls for a mandatory life sentence.

"You can't give him what he deserves," said Commonwealth's Attorney Bruce Jones. "But you can convict him of what he did ... give him as much justice as you can give him," the prosecutor said before the deliberations began. The recommendation for sentencing was already decided but the jury had to go through the process. "The General Assembly has done your thinking for you," Jones told the jurors.

"You can't give Mr. Burton what he deserves," he repeated. "But you can give him a down payment on it."

The statute does not allow a circuit court judge to suspend any of the time. Murder without the third-strike provision calls for 20 years to life. Jones chose not to prosecute an abduction charge, which was also initially brought under the multiple-crime clause. It was a result of Burton dragging Crockett from one location to another.

Defense lawyer Carl Bundick contended no one saw a weapon. He fought the murder allegation with every motion possible, but Judge W. Revell Lewis III would have none of it. Bundick complained that the jury was not made up of Burton's peers because there were only two blacks on it despite that the local African American population is more than 36 percent

of the total population. Many jurors were excused from serving after saying they read about the case and did not think they could be impartial. Others knew officers involved in the investigation or someone else connected to the case.

Lewis explained that the prospective jury list is made up of registered voters and those with driver's licenses. "The pool has been readily available for some time," the judge added.

"We did not know the makeup of the jury" until the lawyers made their strikes, Bundick argued.

Burton wanted to be sentenced immediately. Lewis ordered a short form presentence report and continued the case.

Prior to trial, Bundick asked for a change of venue, suppression of evidence and a psychological evaluation. During the preceding, he motioned to strike evidence claiming there was no proof of premeditation.

Neither of the lawyers removed a juror who said her brother was murdered.

Dr. Elizabeth Kinnison, an assistant chief medical examiner, said the cause of death was multiple stab wounds. There were 20 such injuries on the neck and head and 16 defensive wounds on Crockett's hands. Probably the most significant injury, the pathologist said, was to her right cheek. The wound "went through her tongue, to the back of the throat and injured her jugular vein."

Lead investigator Lt. Michelle Hallette of the Northampton County Sheriff's Office supervised and took photos of the crime scene, observed blood being drawn from Burton for comparisons and collected and sent evidence to the lab. Investigator Tara Leckel was involved in a search of the area and spotted the red knife handle, which was discarded in the bottom of a ditch. Investigator Terry Thomas got search warrants and arranged for evidence to be taken from cell phones. He also interviewed Burton.

After killing Crockett, Burton drove himself to the Eastern Shore Regional Jail in Eastville. On the way, he called a friend and his daughter to tell them about the stabbing. He told his daughter he did it because "he blacked out and snapped." His daughter said she didn't notice anything unusual about his speech. "It was just the regular tone," she said.

His blood showed no signs of alcohol or drug use. And psychological evaluation found him sane and competent to stand trial.

Deputies Kyle Martin and Matt Taylor and Sgt. Carl Allums testified Burton told them about the stabbing after he arrived at the jail. Burton injured his hand during the crime, was bleeding and wanted help. Court records also stated he told them he was hearing voices.

Samuel Boggs, of Accomac, went to church with Crockett and her family. She was "just a sister in the church, that's all. Just a friend," he said. But Burton thought he was Crockett's new boyfriend and call Boggs several times leaving voice and text messages in what the prosecutor called "a frenzy of anger and rage."

Burton has a long history of violence. He once jumped out of a second story window in Accomack Circuit Court after a jury recommended a lengthy sentence. Records filed in both Eastern Shore counties show convictions beginning when he was a juvenile in 1976 and was found guilty of burglary and grand larceny. That same year, he was also convicted of possession of stolen property. A charge of malicious wounding was made but not prosecuted in 1977. The reason was not specified.

In 1980, when Burton was 21, he was sentenced to five years in prison with all

but 12 months suspended for maliciously shooting a farm laborer whom he said was accidentally pushed into him at a local nightspot. He pleaded guilty.

Soon afterwards, Burton was back in court for stabbing his teenage wife. "She was going to take the child and run away and I wasn't going to ... see her and the child no more," he told a deputy.

He was given six years in prison. The four years that was suspended from the first case was revoked but set to run concurrently. His ex-wife was there Wednesday to say Burton wounded her.

At a trial in 1993, a jury found him guilty of armed burglary, malicious wounding and use of a firearm. The jury recommended 27 years in prison. A judge suspended five years of the term. Records show he arrived at the victim's home, a woman with whom he had previously lived for several years. It was dark and he was uninvited. He was a felon carrying a gun, the record said.

That woman also testified Wednesday that he was convicted of wounding her.

Sometime between then and 2005 he was paroled. At 47, he was gathering his belongings from yet another woman's house and didn't realize her adult son was inside. He injured that man and was sentenced to 20 years with 15 suspended.

He was a free man when he killed Crockett, evidence also showed.

Experimental Films Premiere Lights Up The Silver Screen

The motto of Cape Charles' arts movement, "Small town, big art," came alive on the big screen - suspended by a crane - at the Cape Charles Yacht Center last Saturday night. The yacht center hosted the 2017 premiere of the fifth annual Experimental Film Virginia project. It was the culmination of a two-week artists' residency in Cape Charles, with dozens of global and local artists cooperating to create 15 short experimental films.

Each film ran approximately three to five minutes. Like many works of fine art displayed in museums, most of the brief films sought to evoke an emotion, inspire an idea, or capture a single moment rather than tell a whole story. Some films focused on stimulating a single sense. The most resounding emotional impact of "Backwater" was not the images of people on the beach trying to fit into white rubber boots, but the sounds - of water, wind and sand.

Frequently, a film's title was withheld until the end credits, perhaps to prevent

preconceptions and preserve the purity of the audience's experience. This produced an "a-ha" moment for viewers at the end of several films. One beautiful and haunting piece featured a blacked-out scene of a lone man mopping a concrete floor, embraced by a woman who mysteriously appeared and disappeared throughout the scene. After they were both shown lying deathly still on the floor, staring into the pooled water, the title was revealed: "Echo and Narcissus."

Many of the films reflected on the theme of loss or death. "When You Leave" surreally approximated a funeral in which the deceased herself was depicted among the mourning souls tortured by her demise. "Vola" captured the wistful memories of a dangerously driven young dancer who lost the use of her legs in a rehearsal accident after arguing with her partner. "Where You Belong" was a tear-jerker about an elderly man reminded of the lost love of his youth after his grandchildren discover an old photo.

The comedic standout of the night

was "Revenge of Shucky," by director Marcus Holman, in which a serial-killer oyster picks off unsuspecting boy-friends at Cape Charles Beach. A reporter attended filming of the pseudo horror flick, with the working title, "Aww, Shucks."

Watching from behind the scenes was insightful. The artistic process was fluid - to an outsider it would have appeared that decisions were made at the last minute. Just moments before filming, two directors discussed changing the script.

Filming was often entertaining, sometimes repetitive. It became clear why it usually takes months to film a 90-minute feature - it took two hours to film one scene that lasted about 30 seconds on-screen. Dozens of takes were filmed, not because any actor was a "diva" or failed to follow the director's instructions, but to capture each scene from every possible angle. One small, handheld video camera was used during the filming session.

Filming on location had drawbacks that were unknown to the audience. "Revenge of Shucky" was partially shot in a local

pub during regular business hours. Several times, patrons entering the establishment unintentionally interrupted filming - some embarrassed, some bemused.

Neither the set nor the costumes

were pristine. The audience sees what the camera sees, so the cast and crew don't care what's outside the view of the lens. When a child actor's costume didn't close in the back, it was simply fixed with masking tape. One might have imagined a pair of Mary Janes on her feet to complement her frilly dress, but she wore flip flops.

Savannah Lunger, who played the little girl in the pub scene, became associated with Experimental Film Virginia through the Palace Theatre, where she worked with dancer instructor Amy Watkins, a teacher at Pungoteague Elementary School.

Practically anyone involved in the Palace Theatre knows the Sheppard family, who helped revive the theater and continually support Experimental Film Virginia. The two-week workshop is truly a global community effort; news about the project spreads largely by word of mouth, and practically every participant knows Renata Sheppard or knows someone who knows Sheppard, who started the non-profit which now funds the project.

Some EFV participants, like Savannah, are Cape Charles locals, and some are from abroad, like Kamilla Skjaeret, the

film's producer. Skjaeret is originally from Norway, and has been in the U.S. for five years. Her fiancé is a filmmaker who knew an EFV sponsor who knew Sheppard.

same standard?"

"We have a new leadership due to the resignation" of former Chief Allen Nicholson, who gave up the fight to keep the station open.

"New applications are coming in by the day. We have plans to reorganize as we move forward," said Governor. "We have done more in the last two weeks than the last few months." He believes the high black membership at the station is part of the reason for the dissolution. The threat also made it harder to get a new OMD, he said.

Governor asked for the issue to be deferred for at least a year. "We're moving to higher ground," he continued, adding, he met with the county to offer them heavy rescue, drivable equipment that is like a giant tool box on wheels and has been being used by the

company since March.

"It is clear to me that the company is already dissolved" because they have no EMS, no fire apparatus and no OMD, said Chairman Robert Crockett.

"I think it's important to stress that the recommendation to dissolve came from a committee of OVF&R's peers," said County Administrator Mike Mason. "It was apparent from the board's discussion ... that the decision to dissolve was based on the company's inability to provide services. The board's action to dissolve the company essentially takes away its corporate purpose. Final disposition of the company's assets is the responsibility of the company since it is a separate legal entity."

Mason encourages the company board of directors to seek legal counsel.

"I want to emphasize that the board's decision does not degrade the level of fire and EMS services in Accomack County," Mason said. "For months now,

EMS transport and fire suppression services in OVF&R's coverage area have been provided by a combination of neighboring volunteer companies without incident and within the response time parameters approved by Accomack County. Onancock Volunteer Fire and Rescue has handled most of OVF&R's calls. It is located only two miles away."

The 911 commission has already been alerted not to dispatch them but they weren't doing so anyway, Mason added.

Also among the reasons cited for closing the station were: a member was convicted in 2014 of embezzling money from the company, there was another conviction of a member who set a truck ablaze in 2016, and a former chief's report said the company would close in early 2017.

The hospital's move to Onley earlier this year also has an impact on the need for service in the area.

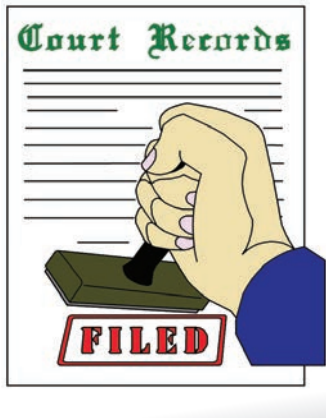

Grand Jury Indictments

Man Who Robbed 9-Year-Old Sentenced

A Pungoteague man who robbed a nine-

year-old girl at the El Ranchito convenience store in Cheriton in 2015, was sentenced to 49 years in prison for four crimes Monday in Northampton Circuit Court. All but seven years of the terms were suspended.

Khiry Akeim Six, 27, of Linhaven Circle, was given 20 years with 17 years suspended for burglary, 25 years with 22 suspended for robbery, three years for use of a firearm in a felony and a year for possession of a firearm by a violent felon. He was ordered to be on supervised probation for 10 years upon release from prison.

In another case, a Vietnam War veteran, Joseph Washington Burton, 67, of Cobb Station Road in Cape Charles, pleaded guilty to unlawful wounding. Burton admitted to police that he struck the victim, Daryl Taylor, also of Cape Charles, in the head with a hammer on Jan. 3, 2017. Burton was indicted on a count of malicious wounding, which is a more serious felony charge.

Barry Simpson, 54, of Exmore, was sentenced to three years with all but four months suspended for felony eluding and 12 months with all but four months suspended for reckless driving. Both were in connection with Jan. 15, 2016, incidents. Supervised probation was ordered for two years.

Darrell Jones, 26, of Virginia Beach, pleaded guilty to possession with intent to distribute more than a half ounce but less than five pounds of marijuana on Nov. 4, 2016. A presentence report was ordered.

Carlos B. Cardoza, 44, of Nasswadox, was sentenced to 10 years each for possession with intent to distribute OxyContin and Vicodin to run concurrently with seven years suspended. He was put on probation for five years and good behavior for 10. The crimes occurred in September 2015.

"I regret the poor choices that I've made," Cardoza told the judge.

"Your life has been a mess with the drugs," Judge W. Revell Lewis replied. "I hope you are able to get your life together after that time."

Kenneth Bowen, 58, of Belle Haven, was sentenced to 30 days in jail for petty larceny, a misdemeanor. He was initially charged with felony theft.

Kevin Da'Auyan Clark, 21, of Cheapside Drive in Cape Charles, pleaded guilty to felony larceny from a person in connection with an April 2, 2017, incident. He was initially charged with robbery. A count of use of a firearm in a felony was not prosecuted.

Court records show Deputy Walter Marks of the Northampton County Sheriff's Office responded to the incident in the parking lot of Yuk Yuk & Joe's Restaurant

in Eastville. Daveon Ayers, of Exmore, told Marks, the defendant "got into his vehicle on the passenger side ... pointed a handgun at him and said, 'Yeah I'm sticking you up.'"

After Ayers gave him \$100, the gunman went back to his own vehicle and left the parking lot. Another witness corroborated Ayers' story. The file stated the victim identified Clark by a photograph.

Jarvis D'Von Scarborough, 27, of Keller Pond Road in Painter, was sentenced to 10 years in prison with all but three years suspended for possession with intent to distribute cocaine in August 2015. Indefinite supervised probation was ordered. He got the same sentence in June in Accomack, also for cocaine distribution.

Tyrhee Henderson, 20, of Exmore, pleaded guilty to five credit card crimes in connection with incidents that occurred in February 2017. A presentence report was ordered.

Tourist Charged

Two local people and a tourist were accused of committing felonies in Accomack General District Court this week.

Brandon Scott Mulder, 24, of Ferdinand Street of Scranton, Pa., was staying at a local inn on Chincoteague. The Chincoteague Police Department was called to the establishment to investigate a disturbance. Mulder was charged with two counts of assault and battery of Pfc. Tyler Marks, possessing a controlled substance, obstructing a police officer from performing his duties, and resisting arrest. The incidents were alleged to have occurred on July 11 and involving Marks being punched, kicked, head butted and spit upon.

Michael Trent Stevens, 58, of Gladding Road in Mears, was charged with hit and run in an incident in which more than \$1,000 worth of property damage was reported, two counts of reckless driving, DUI and refusal to take a sobriety test.

According to the court records, Stevens was driving a 1992 Ford F-150 work truck on July 14, 2017, and struck a 2008 Chevy Equinox northbound on Route 13. He later crashed again on Dogwood Drive, where he was apprehended. Trooper A. J. Rohnke investigated.

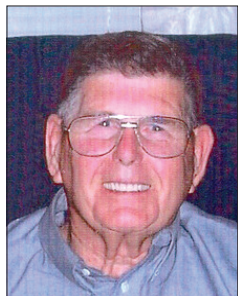

Group Seeks Recommendations for Former Machipongo Middle School

Nearly a decade after the former Northampton Middle School on Young Street in Machipongo closed its doors to students, most of the building remains unused.

Members of the Northampton County Department of Parks and Recreation Advisory Board are developing a business plan for repurposing the former school as a community center.

A public meeting was held on July 13 at Indiantown Park to allow citizens the opportunity to share their ideas about reuse of the building, and to invite community stakeholders to volunteer their input regarding the business plan.

The business plan is part of a feasibility study to be presented before the Northampton County Board of Supervisors, who must approve any reuse of the property.

The meeting was preceded by an online survey answered by 22 local respondents. An overwhelming majority, 59 percent, are age 60 or older. The rest are be-

tween the ages of 18 and 59. Respondents live varying distances from the former middle school, as many as 30 miles away or further. A slight majority live between 6 and 10 miles of the building.

There was no consensus among those surveyed about which activity they would most likely choose if available at the Young Street location. The choices were: Art shows or theater productions, business or office space use, community cookouts or fundraisers, conference center use, Eastern Shore Community College satellite campus use, community farming or gardening, local history museum presentations, and swimming lessons or lifeguard training. All activities scored a 3 or 4 on a scale of 1-5, with "1" meaning respondents are "unlikely" to participate and "5" meaning respondents are "very likely" to participate.

Four out of five respondents who submitted optional comments would like the former school building to be repurposed as a community kitchen. One commenter stated, "I... hear repeatedly about the

need for a commercial kitchen that baker/chef entrepreneurs could use to create foods to sell at the [Onancock Farmers] market!" One person requested an arts and crafts learning center for all ages.

When asked if they were interested in using the space for current or future businesses, over 80 percent of survey takers answered, "No."

Caroline Bott, who prepared the survey, acknowledged that "most of the ideas [for repurposing the former school] aren't revenue-generating ideas," which may be a concern for the core group of stakeholders which is looking for a project that will at-

tract grant funding. Bott works for the Accomack-Northampton Planning District Commission, which is not directly involved in the project at its current stage. Bott was asked to facilitate apart from her position at A-NPDC.

Deciding how to repurpose the former middle school building is not the only hurdle to overcome before the space can be reused. Bott suggested that committee members working on the business plan may also have concerns about the presence of mold, asbestos, or other structural issues that would need to be addressed before reopening the building.

Corrections and Clarifications

Truancy Trumps Strategic Plan at Northampton School Board

Northampton County Public Schools' Comprehensive Plan for 2016-2021 was intended as the main point of discussion at the school board's July 13 meeting, but its public hearing was postponed until Sept. 28 due to lack of advanced public notice.

The board allowed public comment on the comprehensive plan from the only citizen in attendance, Paul Grossman of Cape Charles.

Grossman, who doesn't have children in the system, wanted to offer his review from a business standpoint. He said the plan, as written, is "not passable in the corporate world." Grossman commended the comprehensive plan committee for their efforts, calling the plan a "good starting point," but urged them to "try again."

Grossman cited the lack of projected completion dates for the 48 strategies and tasks. Evidence for achieving goals and objectives must be more "specific, measurable, and attainable," he said.

The plan can be found in PDF format by visiting www.ncpsk12.com and enter-

ing "comprehensive plan" in the search box at the top right corner of the page.

Northampton County has been hit with a double whammy on the number of students attending its public schools. Over the past 15 years, average daily membership has decreased by nearly a third. The comprehensive plan attributes this decline to "limited opportunities for competitive employment within Northampton County, public perception of the quality of educational programs, and increasing availability of faith-based and other private educational institutions." Additionally, absenteeism and truancy continue to be a problem, with an average daily attendance of 92-94 percent of enrollment.

Chairman William Oakley announced the school board's interest in hiring a part-time attendance officer, a position which was once budgeted but never filled. The board wants the attendance officer to be bilingual and to conduct home visits. The attendance officer would cooperate with the families of chronically absent

and truant students, whom the board referred to as a "transient population" who constantly "come and go," whose parents and grandparents also struggled in school.

Superintendent Eddie Lawrence said a student who is absent from school 15 days per year from first through twelfth grades will have missed a whole year of instruction by the time they graduate. Reducing absenteeism would positively affect student academic achievement, decreasing retention rates while increasing promotion and graduation rates, the board said. Retaining fewer students would decrease class sizes and require fewer teachers - saving money for the county, suggested Lawrence.

Oakley said principals will receive a list of chronically truant and absent students at the August principals' meeting. Board members agreed there are a variety of reasons some students are chronically truant or absent, and that the conversation between school representatives and parents or guardians to address the

problem is specific to each family.

Having an attendance officer will enable this conversation to happen earlier in the intervention process. Currently, Northampton school personnel notify a parent or guardian via "robo call" the first day a student is absent. After the fifth absence, a letter is sent home "informing of the absences and explaining the consequences of continued truancy." When eight absences occur, a parent conference is scheduled.

Board member Shannon Dunham would like the attendance officer to foster personal relationships with students, gaining their trust and allowing them to "open up" about issues that may attribute to their truancy. She asserted that kids can be "incentivized" to attend school regularly.

"I thought as a district we were going to look at more prevention" of student absenteeism and truancy, said Board member Nancy Proto. The board is considering reinstating the part time attendance position in the school budget; no action was taken at the July 13 meeting.

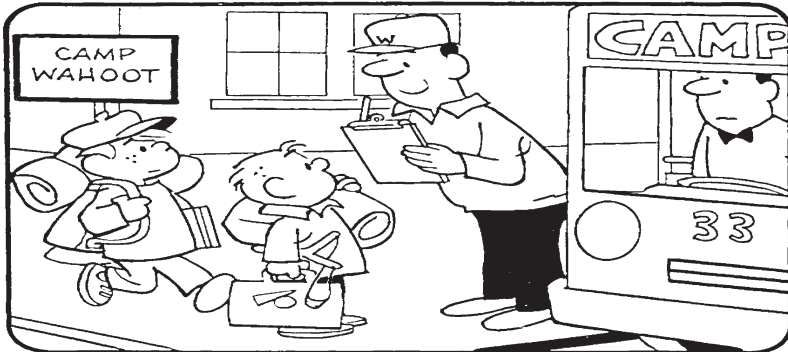

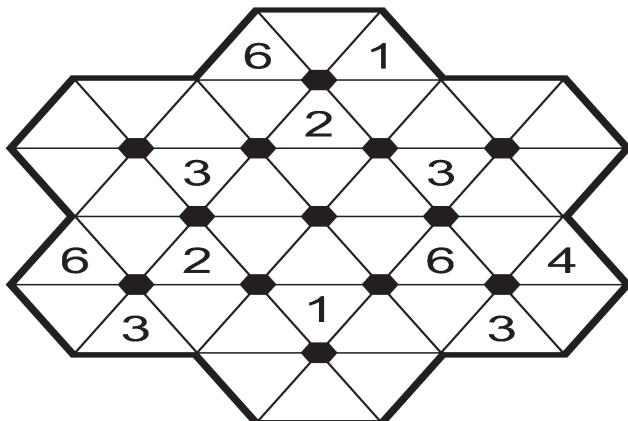

tory. The girls suffered a 20-0 shutout to McLean of District 4, July 15, and then a 7-6 loss to Warwick of District 7, July 16.

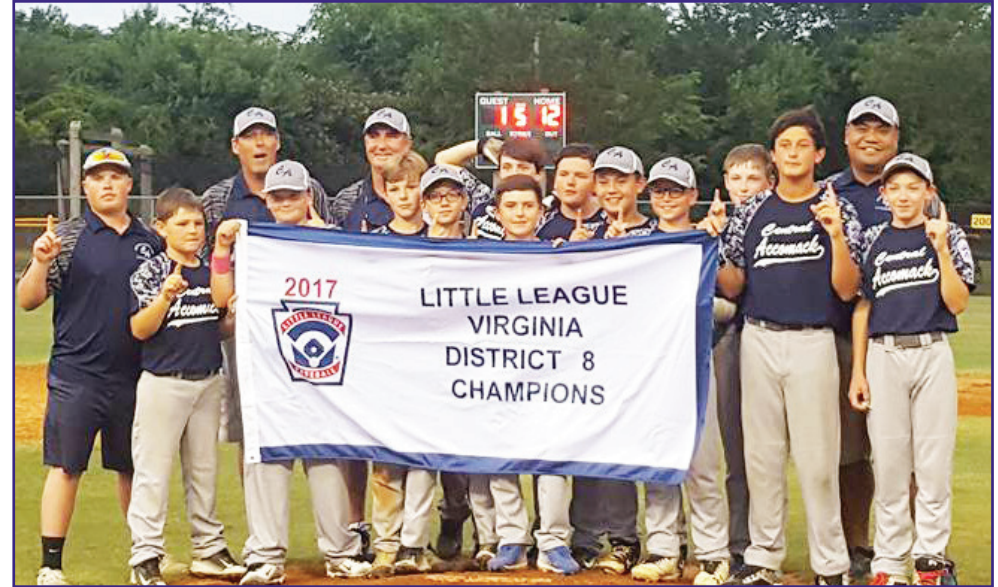
The Central Accomack major boys claimed the District 8 championship

Fishing from the Shore

The biggest change along the local fishing front over the last week has been the unexpected arrival of decent numbers of medium sized spot in the upper bay off Onancock. These are not the large “yellow-bellies” that you would expect to see in the late summer/early autumn, but the majority of these fish are keeper size. Target these tasty panfish along the channel edges while drifting, using small hooks adorned with bloodworm, Fish-bites, or the soft claw portions of a peeler crab.

Croakers, among the smallest members of the drum family, are still well below the numbers and sizes expected for this time of year on both sides of the Eastern Shore. Let’s hope that there is a surge in the population of these tasty bottom fish prior to the first Saturday in August. That’s when the Onancock Volunteer Fire Company will be hosting its first Croaker Tournament from the Onancock Town Wharf. Prizes will be awarded to the three largest croakers, the top croaker catch by a youth and the top croaker catch by a female angler. In addition, there will be a category for any active fire, EMS, and/or police personnel. There will also be an award for the largest “non-croaker” catch. All proceeds from the event will benefit the fire company. The event is scheduled for Aug. 5. For more information, contact Adam James at 757-710-2731.

Chincoteague – Donna Rae, of Captain Bob’s Marina, reported that flounder were still a “chore” to be found with the throwback to keeper ratios being 13-1 inside the Chincoteague Channel, and down to 6-1 north of the American Legion building. There were some flounder, undersized black sea bass, and small bluefish landed from the town pier. A few legal-sized flounder and small croakers came from the Assateague Channel near Memorial Park and the Tom’s Cove Fishing Pier.

Good catches of kingfish (whiting) were coming from buoys 10-14. Bottom water temperatures as low as 48 degrees were still being reported by divers on Blackfish Banks, hampering the offshore flounder fishing there. Expect limit catches to once again become the norm as the water turns over. Black sea bass can still be found along the wrecks and spadefish are swarming above the thermocline. Better seabass catches are coming from the wreck near the Parking Lot and out at the Marine Electric. A few cobia have been seen along the 2TL buoy at Turner’s Lump. Offshore, a few bluefin tuna and small yellowfin were reported beyond 20 fathoms.

Jimmy, at Captain Steve’s Bait & Tackle, reported that anglers targeting flounder in the surf, jigging with 1 to 1.5 ounce bucktails were having success, with one pair landing five keepers. Orange mylar rigs produced flounder to 22-inches in length. A variety of sharks and rays dominated most of the surf action.

Wachapreague – Captain Lindsay Paul, at Trident Tackle, reported that a few yellowfin tuna, some below the minimum size limit, were hitting in the Washington Canyon. A little closer to the beach, gaffer dolphin (mahi mahi) were being caught along the 20 Fathom line. Inside the inlet, Captain Paul said that action was “nothing hot and heavy,” but a few flounder were caught, mostly throwbacks. I witnessed the same thing inside Metompkin Inlet, as keeper-sized fish were few and far between. A few nicer class of flounder were coming from around the wrecks, as a six-pounder was brought in over the weekend. Similar reports were coming from Gargatha, with one party on Monday catching over 30 flounder without finding a single keeper. The trip was salvaged by a nice bycatch of kingfish which hit silversides. Don’s

Tackle echoed the slim pickings for in-shore flounder, but said that some nicer fish were caught out around the No. 10 rail cars. He said that the wrecks are covered with small spadefish and triggerfish.

Lower Shore – Mark, at Chris’ Bait & Tackle, reported that the run of cobia was still occurring in the lower Chesapeake Bay, with the best action occurring from the Inner Middle Grounds up to Buoy No. 36. Flounder catches were coming from along the pilings of the Chesapeake Bay Bridge-Tunnel and under the highrise section. Sea mullet (whiting) were hitting along Latimer Shoals with croakers in the 6-10” class hitting on the seaside.

Upper Bay – I fished out of Onancock on Monday, finding lots of undersized rockfish in the shallows along with a plethora of stingrays. The rockfish were hitting curlytail grubs and peeler crab baits, while the stingrays feasted on peeler crab. Drifting along the channel edges produced a mixed bag of kingfish, hand-sized spot, and

small croakers. Dylan Donnelly landed an estimated ten pound sheepshead while fishing at the Target Ships. Earlier in the day Donnelly and William Bailey found speckled trout and small rockfish along the marshy islands of Pocomoke Sound.

Bill Hall was the first Eastern Shore resident to achieve Virginia Salt Water Master Angler Status. He has been named Virginia Saltwater Angler of the Year and Virginia Saltwater Release Angler of the Year. Bill is an I.G.F.A. International Committee Representative and a longtime member of the Virginia Saltwater Fishing Tournament Committee. He is the Virginia Recreation Fishing representative on the ASMFC Striped Bass Management Panel and is a past recipient of the CCA-VA Virginia Outdoor Writer Conservation Leadership Award.

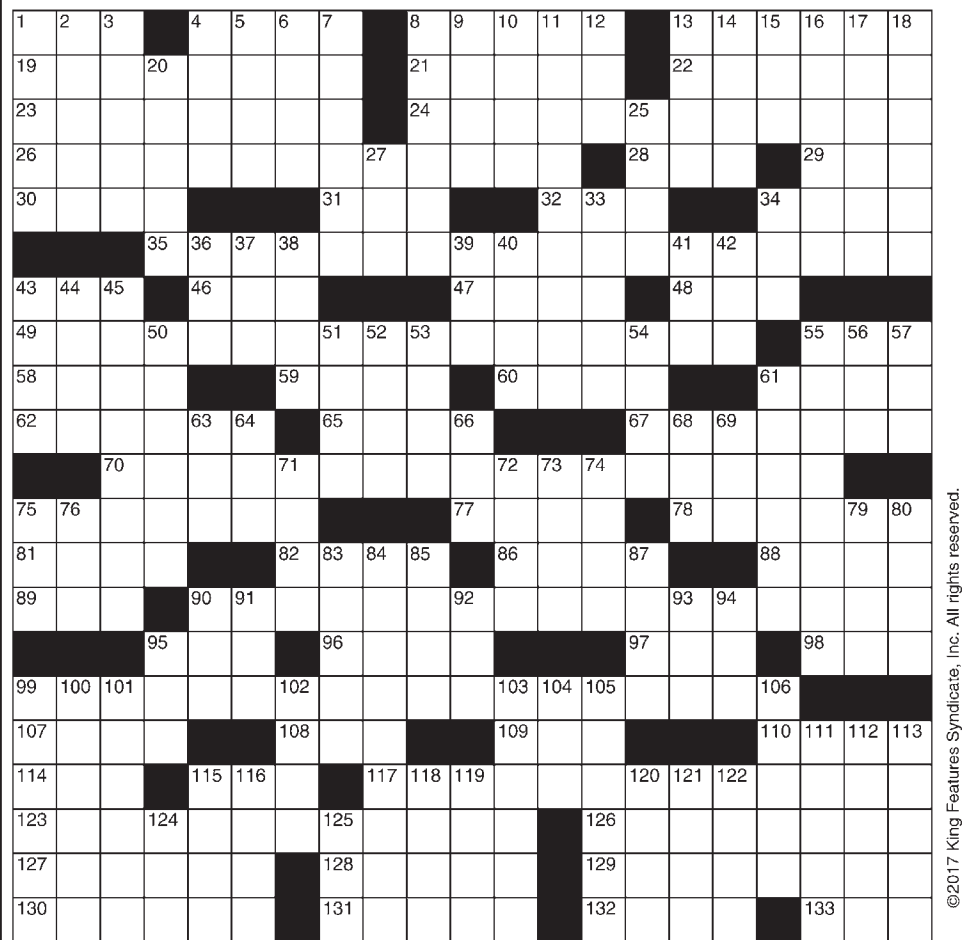

Young Frankenstein: North Street Playhouse Summer Program Is Ambassador to Community and Inspiration to Interns

When North Street Playhouse decided to stage “Young Frankenstein” for this year’s summer program, it hoped to cast off any lingering seriousness from last year’s sold-out production of “Rent,” and once again engage the community in a professionally staged musical production.

“The board told us they wanted to do something different; they didn’t want another angsty production,” said Producer and Production Stage Manager Mary Stiegelbauer.

A large cast with the ability to accommodate many interns and professionals were additional criteria Stiegelbauer and Artistic Director Terry Bliss used to narrow this year’s summer program selection. The result was the “very campy” musical “Young Frankenstein.”

The name recognition was also an important factor. “It’s very culty,” Stiegelbauer said.

With name recognition, it was important to cast the right people. The theater held open auditions and Stiegelbauer sifted through more the 400 electronically-submitted auditions. She shipped the best to Director and Choreographer Jimmie Lee Brooks III, of Manteo, N.C., who made the final selections. Local auditions were held as well, to round out the ensemble.

As with last year, the Playhouse turned to the community to help pay for the actors, dancers and off-stage professionals. The theater’s annual budget is around \$100,000. The summer program runs about \$32,000, “because we are bringing in professionals, and they need to be paid for their work,” said Stiegelbauer. “We are so close to our fundraising goal.”

Brooks also directed and played Angel in last summer’s “Rent.” “It really surprised me how much support this community has for this theater,” he said. “I’ve never been a part of a community where we didn’t sell a single ticket at the door. All the shows were sold out” last summer for “Rent.”

The Playhouse turns the same strong support inward to its interns as they work with the team of paid professional actors, dancers and technical staff.

“The intern program is amazing,” said Melanie Comeau, a professional featured dancer from New York City.

Actor Liz Acosta, of Virginia Beach plays Frau Blucher. She says the internship gives students permission to ask anything they want about acting. “I wish I had that,” she said, when she was starting out.

That’s because the interns are hearing first-hand what is involved in a career in the performing arts. They attended coaching workshops at North Street Playhouse to help prepare them for the auditions that landed their internships. Each intern is assigned a professional to shadow, and regularly scheduled conversations with their mentors and with the entire cast are an important component.

“We are preparing for this as a career and they will answer every question you have,” said Meg Morrison, an intern shadowing actor Cat Yudain, who plays Dr. Frankenstein’s saucy sidekick, Inga. Meg is a rising junior at Nandua High School. “We are learning from people who are getting paid to do what they love.”

Nathan Downing Garcia, an incoming sophomore is working with featured dancer Timiki Salinas. “I’m exploring and getting experience by being who I am as a true dancer,” he said.

Being true to oneself is a recurring theme with the interns. Joel Joyner, who graduated with a two-year degree from Eastern Shore Community College, was looking to gain behind-the-scenes experience as an intern to Brooks. He was encouraged by that reinforcement of authenticity. “It’s necessary to be yourself, not some imitation of someone else,” he said, because the professions stress this is the most valuable and original thing each person has to bring to an audition.

“We’re all weird, but in a good way,” said Katie Higgins, another intern, and incoming freshman at Nandua High. “It’s nice not to be judged” for being yourself.

Second-year intern Isabeau Drewer, a rising sophomore at Nandua High, summed it up this way. “Lee told us the first day, ‘Embrace the awkward.’”

Brooks says it’s all part of the theater experience. “We have a really good group. I’m happy for the interns to see such hard work and dedication.”

Stiegelbauer says the program has seen results for former interns. One former intern, Heidi Waldenmaier worked backstage last year and landed a position

this summer with “The Lost Colony” production in Manteo.

However, she says it’s not just about getting young people into performing arts careers. “I hope they gain a respect for the

theater,” she said. “Connection, empathy, understanding...And you get rewarded for doing the work, not just showing up.”

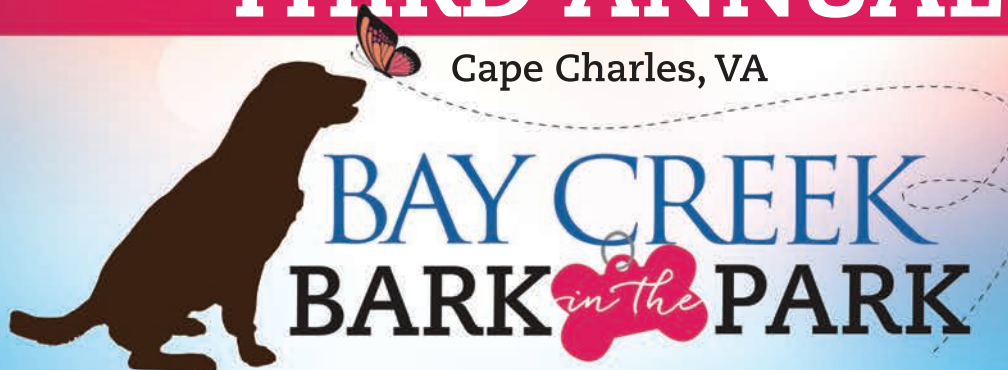

"I know you'll find a special meaning to the day, walking down the Blueberry Way..." sings Deedra Ervin in Chincoteague Island's Blueberry Festival's official song, "Blueberry Way."

Kicking off on Friday, July 21, and going until Sunday, July 23, the Blueberry Festival will host vendors selling blueberry-themed foods, crafts and goods combined with live entertainment and family-friendly activities all day long.

"It's the largest fine arts and crafts event on the Eastern Shore of Virginia," festival promoter Sam Serio said.

The festival began in 1987 as a way to celebrate summertime, and the founders settled on centering it on blueberries because of their durability.

"The ladies looked for something to hold up to summer heat," Serio said. "Strawberries or peaches wouldn't work."

Thirty years later, blueberries are still as popular as ever due to a recent spike in interest due to their high amounts of vitamins and antioxidants, which help fuel the growth of Chincoteague's Blueberry Festival. This year, more than 100 different vendors from 16 states will be featured, including artists from as far as Florida and

Missouri. Serio described the Blueberry Festival as a Christmas in July shopping experience.

"There will be anything that you can imagine that has to do with blueberries," Serio said, "There are jams, jellies, massage oils, people integrate blueberries into everything they do."

Local businesses also get involved to celebrate blueberries for the weekend. Serio mentioned that Sugarbakers Bakery and Café will prepare the "ultimate blueberry pie" and Island Creamery makes a special blueberry ice cream for the festival.

Aside from blueberry food and goods, Serio said the festival will have nonstop live music and entertainment. Three locally loved artists, Deedra Ervin, Jessica West and Emily Guemple, will perform on Sunday, July 23, during the women's singer showcase. Other performers include Hemlock Hollow, Blind Wind, The Reasoners, Dalton Elliot and Virginia Creek, Wayne and Chris Young, Bryce Hitchcock as well as magic shows performed by Jamal the Magician all three days.

"I enjoy interacting with the people that come to the festival, the exhibitors and attendees, they're all interesting

people," Serio said.

The Blueberry Festival will take place at the Chincoteague Center, 6155 Community Dr., from 9 a.m. to 4:30 p.m. Admission is \$5 for an adult day pass, \$8 for a two-day pass, \$10 for a three-day pass and children 12 and

under are \$1.

BUTTER CAKE WITH BLUEBERRY TOPPING

INGREDIENTS:

- 1 (18-1/4-oz.) PACKAGE YELLOW CAKE MIX
- 1 EGG
- 8 TABLESPOONS BUTTER, MELTED

FILLING:

- 1 (8-OUNCE) PACKAGE CREAM CHEESE, SOFTENED
- 2 EGGS
- 1 (16-OUNCE) BOX POWDERED SUGAR
- 1 Tbsp. VANILLA

DIRECTIONS:

- PREHEAT OVEN TO 300 DEGREES F.
- COMBINE CAKE MIX, EGG, AND MELTED BUTTER & MIX WELL. PAT THE MIXTURE INTO THE BOTTOM OF A LIGHTLY GREASED 13 BY 9-INCH BAKING PAN.
- IN A LARGE BOWL, BEAT THE CREAM CHEESE, THEN ADD THE EGGS AND VANILLA AND BEAT TOGETHER UNTIL SMOOTH.

- 1/3 CUP WATER
- 1 Tbsp. LEMON JUICE
- 1/4 CUP SUGAR

• PLACE BLUEBERRIES IN A SAUCEPAN WITH WATER AND SUGAR. HEAT OVER MEDIUM-HIGH HEAT UNTIL MIXTURE COMES TO A LOW BOIL AND BLUEBERRIES JUST START TO BREAK APART.

• ADD DISSOLVED CORNSTARCH TO SAUCEPAN AND BRING MIXTURE TO A ROLLING BOIL. TURN HEAT DOWN AND SIMMER ON LOW HEAT FOR 2-3 MINUTES, OR UNTIL SAUCE REACHES DESIRED CONSISTENCY. ADD WATER, ONE TABLESPOON AT A TIME, IF THE SAUCE GETS TOO THICK.

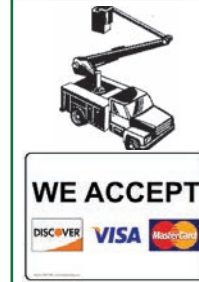

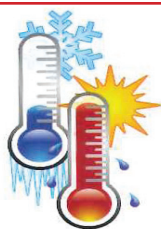

More Kudos for Taylor

Dear Editor:

The health of the Chesapeake Bay is gravely threatened

in the next three years. Over a decade of progress could be washed away when the Conowingo Dam reaches capacity.

Recent studies by EPA Scientists said they have determined that the original estimate of when the dam reservoir would fill was off by more than 15 years. Rather than reaching capacity in 2030 to 2035, it is already 95 percent full and could cease protecting the bay from sediment before 2021.

The U.S. Geological Survey has estimated that when the Conowingo reservoir reaches capacity, sediment entering the bay would increase nitrogen and phosphorus by about 250 percent and 70 percent respectively.

Nitrogen and phosphorus are algae superfoods. They make the underwater plant grow out of control. As its quick life cycle ends around summer, microbes feed on it so ravenously that they suck oxygen from the water, killing fish, crabs and anything that cannot escape.

President Trump’s proposal to cut 31 percent of the EPA’s budget would eliminate the Chesapeake Bay cleanup program and the 90 employees who coordinate it.

Members of congress who represent those of us who live along the bay have strongly supported the Chesapeake Bay Cleanup, and Scott Taylor has consistently spoken out voicing his support. Just thanking him is not enough.

This is not a Democrat/Republican or Conservative/Liberal issue. We all need to call and write to Representative Taylor and Senators Warner and Kaine expressing our support for the cleanup program. Tangible evidence of broad public support is the most powerful tool our representatives

have in their efforts to convince other members of congress that the Chesapeake Bay Cleanup Program must be saved.
