## IN LATEST ELDER-CARE SHUFFLE, THE HERMITAGE IS SOLD, BUYERS DROPPING SKILLED NURSING

A deal to sell the Hermitage on the Eastern Shore in Onancock has been made and the buyer is promising to invest \$3 million for capital improvements,

convert the skilled nursing wing into memory care for residents with Alzheimer's disease and dementia, and add independent living services to the already upscale retirement center.

The sale price was not disclosed in an announcement made late Wednesday by the buyer, Commonwealth Senior Living, of Charlottesville, Va., which has 21 such communities in Virginia, and Pinnacle Living, of Glen Allen, Va., a not-for-profit organization that was formerly United Methodist Homes and currently owns the Hermitage. The facility will be renamed Commonwealth Senior Living at the Eastern Shore.

The new company will take over management next month "once the nursing beds are converted," the announcement stated. "The transaction is expected to be

complete before the end of the year with construction starting shortly thereafter."

Residents "are expected to remain and will not see any increase to their base rate for at least 12 months," according to the announcement. The two companies "will work together during the transition from nursing to assisted living to determine staffing needs ... associates not retained will be offered a severance package from Pinnacle Living." The announcement said future job opportunities are anticipated as "renovations are completed and occupancy grows."

# EASTERN SHORE MAN DIES SUNDAY FROM GUNSHOT WOUNDS

A 21-year-old Cape Charles native died from multiple gunshot wounds early Sunday morning, Alvin Hopson, of the Medical Examiner's Office in Richmond, Va., reported Wednesday. The incident is being investigated as a homicide.

Sheriff Todd Godwin identified the victim as Hasaan Burton, of Virginia Beach, Va. Another gunshot victim was treated and released from the local hospital but was not identified.

Godwin said at nearly 4:30 a.m. his office received a report the two victims were being taken to Riverside Shore Memorial Hospital from the Exmore area. Upon their arrival, deputies learned Burton had died from his injuries.

Godwin later said the unnamed victim is not being cooperative with authorities in providing information about the incident. Godwin said it is believed the shooting occurred on Lankford Highway in Keller when shots were fired from one car into another. The other victim was the only other

person in the vehicle with Burton.

Godwin also said authorities think an argument may have started at the University of Maryland, Eastern Shore. There were also incidents at the Royal Farms in Princess Anne, Md., and in New Church that may have been related. Videos of the properties are being analyzed by authorities, Godwin said.

No other information was released

and no arrests have been made. The Burton family has declined to comment. Burton's Facebook page said he was a 2015 graduate of Landstown High School in Virginia Beach.

A spokesperson for the Eastern Shore of Virginia 9-1-1 Center reported that Northampton EMS and Accomack Public Safety responded to the call. Sprint vehicles from both counties also went to the site at

the intersection of County Line and Main Streets.

Officers from the state police, Northampton County Sheriff's Office, and Exmore Police Department assisted Godwin's deputies. # FEDEx CONTRACTOR SAID CONFRONTATION WITH HOGG 'LIKE FROM THE OLD WEST'

The FedEx contractor thought he was encountering a man who wanted to learn about a delivery. But the former Northampton supervisor thought he had found another thief on his property.

Kyle Miller, who lives in Chesapeake, Va., was delivering packages with an employee, who lives in Norfolk, Va., on Sept. 23. They were near Cherrystone on the Eastern Shore.

"I got a smile on my face," Miller said late last week. "Maybe, he is asking us about a package," he thought when former Supervisor Granville Hogg blocked the delivery van's path.

Instead, Miller said, the man had a gun and started yelling. "What the hell are you doing here? Who are you?" Miller said Hogg demanded to know. "After I gave him our information and everything, he was looking at us like 'make a move.' Like (from) the Old West," Miller said. "You're on my f..... property and I can do what I want to do," Hogg told them, according to Miller.

The contractor said he objects to Hogg's "insinuation that we were doing something wrong. He was acting like a vigilante."

Miller said he asked Hogg to put the gun away. But Hogg wouldn't. "He took both of the IDs into his hand," Miller said, contrary to Hogg's claims that he never got close enough to the vehicle to see them.

"I have had several issues in the past," Hogg wrote to an Eastern Shore Post reporter Wednesday night. "Stolen vehicles, stolen equipment, break-ins, trespassing on oyster grounds, removal of oysters, theft of a house full of antiques. Three or four of these were foiled by me. I either had them on camera, been alerted by a security service that there was an intruder, or observed the persons in the act. The theft of the antiques has not been solved."

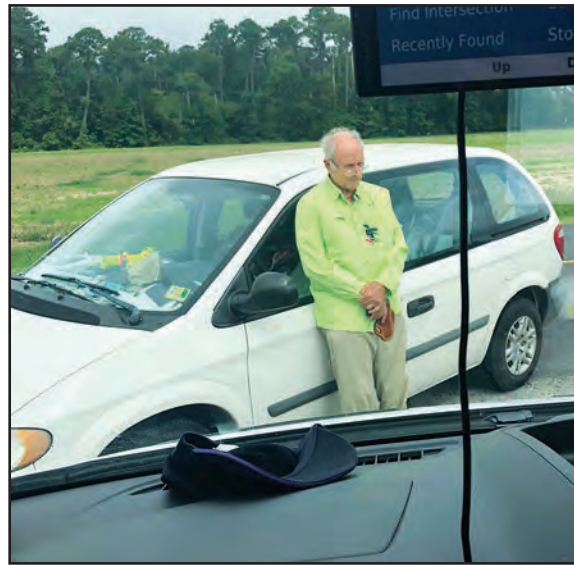

He got trespassing warrants for Miller and his employee, Anthony C. Sivels.

"It is my belief they have been sent to the law enforcement agency ... where FedEx is located. This is likely due to the limited information which I had," which did not include their addresses.

Miller said he did not know why the GPS directed them to Secretairy Road when they were looking for Oyster Cape Road, which they later found out was on the other side of Lankford Highway. "We are numb to the fact that it wasn't on that street," Miller said.

Miller said his deliveries were backed up because of the threat of the hurricane and

because the Chesapeake Bay-Bridge Tunnel had several closures around that time.

"There were probably 4,000 packages in the terminal" waiting to be delivered, Miller said. "Close to 200 to 210 packages (in the van) that day. That's why I had a helper ... I don't want my reputation tarnished ... It was Sunday. I wanted to be home drinking a beer, watching football. I didn't want to be out there. I wanted to be home with my family ... I couldn't allow my truck to come over sooner."

Miller said Hogg continued to hold on to the gun while they waited between five to 10 minutes for police to arrive.

"It floored me when he said he was in fear of his life," Miller continued. "He literally came from down the road to block us in. I don't see how he was in fear of his life."

Miller said they called 911. When the deputy arrived, he told them that Hogg "and the sheriff are friends. They are buddies." Miller said the deputy talked to the sheriff who referred the deputy to the commonwealth's attorney. He was later told Hogg would be charged with a felony.

Instead, Hogg was charged with two counts of brandishing a firearm, which are misdemeanors, according to records filed in Northampton General District Court. The charges were brought by Miller and Sivels.

Northampton Commonwealth's Attorney Beverly Leatherbury, who also serves as the county attorney, asked to be removed from the case. Accomack Commonwealth's Attorney Spencer Morgan was appointed by Judge W. Revell Lewis III of the local county circuit courts. Morgan would not comment on the case when asked about it Tuesday.

In an email, Hogg indicated the men were not in a FedEx vehicle. Instead, they were in a Penske rental truck. He said they were trespassing. The property is posted.

"Based on the conduct I witnessed, out of fear and respect, I have never been close enough to the individuals to read any identification they presented and (that was) the reason the sheriff's department was notified," wrote Hogg. "To my knowledge, they did not have a parcel addressed to me or the tenant nor any former tenant ... When you see individuals driving recklessly, acting totally out of character, not being able to provide good reason for being on your property, I believe I have good reason to think my life is being threatened."

# CHERITON POLICE CHIEF SACKED IN AUGUST, CITIZENS WANT ANSWERS

At Cheriton's latest town council meeting on Sept. 26, unrest among citizens persisted and questions remained unanswered about the police department and its future.

Marc Marshall was the chief and sole member of the newly formed Cheriton Police Department that had been in operation for barely one year when the council voted 5 to 1 on Aug. 29 to terminate his contract.

No reason for the termination was provided by the council or Mayor Larry LeMond, who cited a "personnel matter."

Councilman Wesley Travis, who cast the only opposing vote, was not present at the Sept. 26 meeting. Instead, he left a resignation letter for Town Clerk Stacey Salenski to read into the record.

According to the motion to terminate Marshall's contract, "The police chief was put on administrative leave with pay, pending an investigation," Travis wrote.

"I voted 'no' because there was no investigation and no due process," he explained.

"Since that meeting, I have experienced many forms of harassment by the general public and council members' families. I have been cursed out, given dirty looks, been the subject of rumors

and accusations. This pains me because there was no content to go along with the vote, and for that reason I am resigning from Cheriton council effective immediately," Travis concluded.

LeMond responded, "I'm sorry to hear that. ... He has his opinion. Five of the other council members didn't agree with his opinion."

About one month following Marshall's termination, the council had no plan to replace him and voted to cancel an eSummons software maintenance agreement and return related computer equipment for refunds totaling more than \$19,000.

During the public comment session, Jason Van Marter, a Cheriton resident and restaurant owner who some citizens hope will be appointed to the open seat on the council, said, "By canceling the eSummons and sending back all the equipment, at least to me, it appears that you've already made a choice on the Cheriton police force whether you voted on it or not."

Councilman Matthew Yancy responded, "A final decision has not been made concerning the Cheriton police department. ... it will be inactive until either A) a police officer is hired, or B) this council votes to disband it."

"Relax your minds, we still have a police department, it's just not active right

now," he said.

"And will remain so until we hire a certified, fully trained law enforcement employee, or send our employee to the police academy and get certified," LeMond said.

According to LeMond, the Virginia Department of Criminal Justice said the police department could remain inactive indefinitely.

Neither LeMond nor the council provided the rationale for canceling the eSummons or deciding to return the equipment hardly a month after terminating the police chief.

In response to concerns that Cheriton is once again relying solely on the Northampton County Sheriff's Office to patrol the town and provide revenue through traffic tickets, LeMond said, "The sheriff's department is doing what they always have done. They've always patrolled this town. ... Even when we had a police department, the sheriff's department was patrolling the town."

Travis' letter stated, "I believe that Cheriton needs to move forward and not backward. We spent many years getting from out underneath the county and to run back to them as soon as there's a problem shows a lack of leadership for our town."

Citizen Joanne Fitchett said, "I was

very taken aback with the way that the council didn't include the town people before a lot of these decisions were made."

"I feel like we don't have a voice in the community. We just come here and sit, you make the decisions, and it's a done deal," she said.

Fitchett spoke out about Marshall's termination. "We need to know why you fired him," she demanded. "He lives in our community. His children, wife ... it puts a burden on his family to be looked at, and everyone has a story to tell, but we never got the story."

LeMond repeated that neither he nor the council can discuss personnel issues.

"Forgive us that we can't bring you in on every decision ... unfortunately, this was one of them," Yancy said.

Fitchett also wanted to know why council had not followed through on its plan to form a committee to find alternative sources of revenue for the town, "so that you're not putting pressure or putting a dollar amount or ticket amount on one person, which I thought was very unfair," she said.

"We just haven't had time," Yancy answered. "I'm hoping after tonight ... that we now can move on."

Another citizen, Nancy Brown, had no harsh words for new council members Yancy and Mary Mears, but told Barry Down-

ing, Norma Spencer, and Bo Lewis they have “done nothing” about revenue generation.

“You just put it all on Marc Marshall and said, ‘Yah, mule,’ kept cracking the whip, and told him to bring in more tickets,” which was “unfair” and “unsustainable,” Brown said.

She wanted to know why the investigation of Marshall was not done. “Where’s any accountability for that?” she asked.

“We’re not going to comment,” LeMond answered.

A few minutes later, a soft voice spoke up. It was Mears. “I hope we will move for-

ward. We just haven’t got there yet, but we’re working on it,” she said.

Elaine Meil from the Accomack-Northampton Planning District Commission will visit the council next month to discuss funding sources the town can pursue, Mears said.

Both Spencer and Downing admitted mistakes had been made, and Spencer said, “We definitely don’t want to repeat those, so we wanted to carefully move forward.” Downing echoed Spencer’s statement and asked citizens for their “cooperation to help us move forward from this situation.”

## VDOT OFFERS LIGHT AT CAPE CHARLES FOOD LION

A last-minute change was made to Northampton supervisors’ agenda for their Oct. 9 meeting to accommodate a surprise visitor, Virginia Department of Transportation Accomack Residency Administrator Chris Isdell.

After VDOT’s safety improvement plan for Route 13 by the Cape Charles Food Lion was carefully reviewed and an additional traffic study was conducted, Isdell was able to offer supervisors three new options, including installation of a traffic light at the intersection of Route 13 and Country Place at the shopping center’s busy south entrance.

A VDOT public hearing held in July had garnered much criticism from Cape Charles area residents. VDOT’s original proposal mainly consisted of widening and lengthening turn lanes, but it made no provisions for safety at the dangerous intersection where there have been many accidents and close calls, residents said.

Previously, when supervisors requested adding a traffic signal to the safety improvement plan, Isdell cautioned them that it might drive up costs too high for the project to qualify for VDOT’s Smart Scale program.

Furthermore, the county did not request a traffic signal on the original Smart Scale application it submitted in 2016, and if the application was amended, there was no guarantee it would be approved a second time, Isdell had told supervisors in August.

But this time, Isdell seemed confident that the traffic signal is a favorable option.

The project’s “scope would have to be re-evaluated to make sure that the funding that is currently there will work, and by doing so, it has the potential to trigger a rescore of the project,” Isdell said.

“However,” he continued, “we feel like the project is a strong project and may score as well” as previously.

All three options for amending the safe-

ty improvement plan are: closing the intersection to all traffic except vehicles making left turns; converting the intersection to an RCUT or J-turn intersection, achieving the same outcome as the first option but enabling vehicles to make U-turns; or installing a traffic signal preceded by warning beacons and rumble strips.

The new traffic signal would be near the existing traffic signal at the intersection of Route 13 and Stone Road, leading into the town of Cape Charles. Isdell said the traffic lights would be timed similarly to the series of traffic lights seen on Route 13 in Exmore, Onley, and Oak Hall.

According to Isdell, at least two turn lanes would still be widened and/or lengthened on the stretch of road less than half a mile long, including the turn lane leading to Cape Charles. The original safety improvement plan included widening and lengthening eight turn lanes, which some citizens deemed unnecessary.

But the project would not include a speed reduction from 55 mph to 45 mph, as occurs in most other towns in Northampton and Accomack counties where there are multiple traffic signals close together.

“That may be something to look at later, but this is definitely progress,” Chairman Spencer Murray said.

Isdell agreed and said the traffic signal would be taken into consideration when the next speed study is done.

Supervisor David Fauber asked everyone to recognize former supervisor Granville Hogg, who was in the audience, for all his hard work on the project. Hogg advocated for road safety improvements at the Cape Charles area shopping center both as a county supervisor and, after his term ended, as a concerned citizen.

Supervisor John Coker said, “Granville deserves all the credit for this. He’s been working on this for over a decade.”

Explanation for Proposed Constitutional Amendment to Be Voted On at the November 6, 2018, Election

### PROPOSED CONSTITUTIONAL AMENDMENT

ARTICLE X. Taxation and Finance.

Section 6-A. Property tax exemption for certain veterans and their surviving spouses and surviving spouses of soldiers killed in action.

#### BALLOT QUESTION

Shall the real property tax exemption for a primary residence that is currently provided to the surviving spouses of veterans who had a one hundred percent service-connected, permanent, and total disability be amended to allow the surviving spouse to move to a different primary residence and still claim the exemption?

#### EXPLANATION

##### Present Law

The Constitution of Virginia currently requires the General Assembly to exempt from taxation the principal place of residence of any veteran who has been determined by the U.S. Department of Veterans Affairs to have a 100 percent service-connected, permanent, and total disability. This tax exemption is also provided to the surviving spouse of such a veteran, so long as the surviving spouse continues to occupy that property as the surviving spouse’s principal place of residence.

##### Proposed Amendment

The proposed amendment would allow the surviving spouse of any veteran who has been determined by the U.S. Department of Veterans Affairs to have a 100 percent service-connected, permanent, and total disability to continue to claim the tax exemption currently provided, even if the surviving spouse moves to a new principal place of residence that is owned by the surviving spouse.

A “yes” vote will allow these surviving spouses to move to a new principal place of residence that is owned by the surviving spouse and still claim the tax exemption.

A “no” vote will not allow such surviving spouses to move and still claim the tax exemption.

#### FULL TEXT OF AMENDMENT

Amend Section 6-A of Article X of the Constitution of Virginia as follows:

#### ARTICLE X TAXATION AND FINANCE

##### Section 6-A. Property tax exemption for certain veterans and their surviving spouses and surviving spouses of soldiers killed in action.

(a) Notwithstanding the provisions of Section 6, the General Assembly by general law, and within the restrictions and conditions prescribed therein, shall exempt from taxation the real property, including the joint real property of husband and wife, of any veteran who has been determined by the United States Department of Veterans Affairs or its successor agency pursuant to federal law to have a one hundred percent service-connected, permanent, and total disability, and who occupies the real property as his or her principal place of residence. The General Assembly shall also provide this exemption from taxation for real property owned by the surviving spouse of a veteran who was eligible for the exemption provided in this subdivision, so long as the surviving spouse does not remarry. This exemption applies to the surviving spouse’s principal place of residence without any restriction on the spouse’s moving to a different principal place of residence.

(b) Notwithstanding the provisions of Section 6, the General Assembly by general law, and within the restrictions and conditions prescribed therein, may exempt from taxation the real property of the surviving spouse of any member of the armed forces of the United States who was killed in action as determined by the United States Department of Defense, who occupies the real property as his or her principal place of residence. The exemption under this subdivision shall cease if the surviving spouse remarries and shall not be claimed thereafter. This exemption applies regardless of whether the spouse was killed in action prior to the effective date of this subdivision, but the exemption shall not be applicable for any period of time prior to the effective date. This exemption applies to the surviving spouse’s principal place of residence without any restriction on the spouse’s moving to a different principal place of residence and without any requirement that the spouse reside in the Commonwealth at the time of death of the member of the armed forces.

### Pair Charged With Wire Theft

A Maryland couple were charged with stealing green copper wiring from several areas on the Eastern Shore belonging to Accomack-Northampton Electric Cooperative, according to a release issued jointly by sheriffs Todd Godwin and David Doughty.

Darek Snyder has family ties in Maryland and Tangier, a court document stated. He also has convictions for marijuana possession and theft.

Amanda Snyder has been convicted on charges of DUI and theft.

the state police, Eastern Shore Drug Task Force, and the Parksley Police Department.

### Five Charged With Felonies

Five men were arrested recently and charged with felonies, according to records filed in Accomack General District Court.

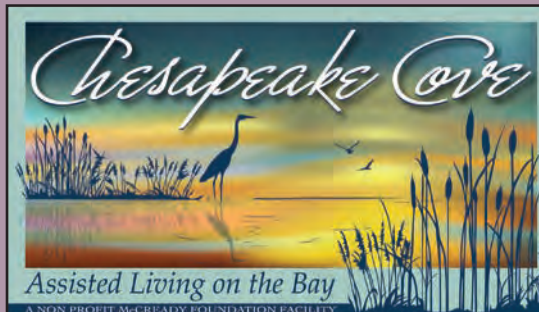

# Community Mourns Favorite History Professor

History Professor Barry Neville's "greatest quote was 'Life is good,'" according to former student Victoria Pruitt. For many local residents, life is going to be less good for a while as they mourn his death.

When Eastern Shore Community College announced his passing on Facebook Monday, many commiserated on the site. By Wednesday morning there were 240 testimonials to his lasting impact as a teacher, mentor, friend, colleague, and as some said, "a genuinely good person."

His talents as an instructor were undeniable. "I've actually stood outside his room to listen to him even though I wasn't even in his class," Jennifer Haycox Nicholson posted. It was not uncommon for him to notice people outside his door and invite them in to listen, said others.

Mark Flanders, whose office was across the hall from Neville's for about four and a half years, described the consummate professor in his remembrance. "One December evening, I walked by his classroom and I could hear that voice. I looked in and one student had shown up for an optional exam review. He was teaching to that one student like it was thirty," he said. "Students loved being in his history class, even students who normally did

not like history. He converted many into wanting to teach history."

His students almost universally enjoyed his classes, learning not just history, but the love of history. "He made history come alive and I looked forward to all of his classes," commented Georgia Ben Justis, who credited Neville with helping her devise study strategies that raised her D grade to an A.

Compassion is a word that surfaces repeatedly in the condolence messages. So are gentle and kind. And witty.

Neville also taught at Salisbury University, where his classes also earned glowing student reviews. "I would joke with him about all the miles he would drive to teach at both colleges," wrote Jerry Waldron.

In addition to his teaching, Neville was an ordained deacon in the Episcopal church, serving as a volunteer chaplain at Atlantic General Hospital in Berlin.

Jefferson Boyer worked with Neville at Salisbury University, Wor-Wic Community College, UMES, and taught with him in the college program at Eastern Correctional Institution. "I met him in graduate school, and he was always so generous in giving beginning teachers an ear to listen, and encouraging words," said Boyer. "He was a total historian, an

enthusiastic teacher, a man of very deep faith and a kind heart, and a down-home boy beneath it all. He represented all the best things about the people of the Eastern Shore."

Neville is survived by his wife, Karen Callahan Neville, and brothers Thomas Allan Baker and his wife, Karen, of Virginia Beach, and William Craig Neville and his wife, Cathy, of Salisbury.

A funeral service will be held on Sunday, Oct. 14 at 3 p.m. at St. Paul's Episcopal Church in Berlin. 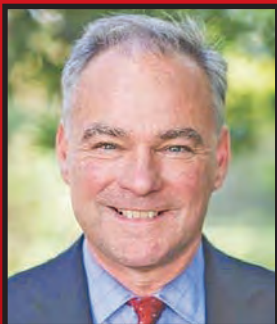

## U.S. Senate, Congressional Seat, And Local Elections on Nov. 6 Ballot

By Linda Cicoira

Preparations are underway for the Nov. 6 general election in Accomac and Northampton counties for federal and local contests.

Those who want to register must do so by 5 p.m., Monday, Oct. 15. The deadline to request a ballot by mail is 5 p.m., Oct. 30. Offices will be open in Accomac and Eastville for in-person absentee voting during regular hours and on Saturday, Oct. 27, and Saturday, Nov. 3, which is the last day for absentee voting.

Voters across the Eastern Shore will cast their ballots for races for the U.S. Senate and the U.S. House of Representatives. Elections for town offices will be held in Cape Charles, Eastville, Nassawadox, Painter, Bloxom, Onley, and Melfa. In Northampton, voters will also choose a commonwealth's attorney. In Accomac, a commissioner of the revenue will be selected. Two constitutional amendments are being proposed regarding taxes.

### Senate

Voters will choose between incumbent Sen. Timothy (Tim) M. Kaine, a Democrat, who also served as Virginia's governor and lieutenant governor; Corey A. Stewart, a Republican, who is at-large chairman of the Prince William County, Va., board of supervisors; and Matt J. Waters, a Libertarian and a political fundraiser from Hampton Roads.

### Congress

The ballot will include incumbent Rep. Scott W. Taylor, a Republican who was a Navy SEAL sniper, served in Operation Iraqi Freedom, and was injured in a combat mission in Ramadi, Iraq. He is a real estate developer in Virginia Beach, Va. Taylor is being opposed by Elaine G. Luria, a Democrat, who served for 20 years as a Surface Warfare Officer and nuclear engineer in the Navy "deploying six times—twice forward-deployed on ships stationed in Japan—conducting operations in the Middle East and Western Pacific on destroyers, cruisers, and aircraft carriers."

### Accomack

Deborah T. Midgett is running unopposed to fill the unexpired term of the late Commissioner of the Revenue Leslie Savage. Midgett has been serving as interim commissioner and is a longtime worker in that office.

### Northampton

Commonwealth's Attorney Beverly Leatherbury is seeking to fill the unexpired term of former Commonwealth's Attorney Bruce Jones, who retired. Leatherbury is not opposed. She was Jones' assistant prosecutor for many years.

In Northampton, the District 4 polling place has changed. Voters will cast their ballots at Johnson's United Methodist Social Hall, 11175 Bayside Rd., and not the middle school gym. Signs will be posted to help voters find their way.

### Bloxom

Former Councilwoman Jenny K. Kreisl is running unopposed for mayor. Five are running for the six council seats. Council Members Samuel H. Bloxom Jr., Louella H. Fox, and Christopher F. Kreisl (the mayoral candidate's husband) are looking for another term. Michael P. Barnes Jr. and R. Scott Callander are also running.

### Painter

Mayor Connie W. Campbell is unopposed. Kim Randall Savage, Stephen J. Hearne, Eric Talmadge Harris, James Sturgis, Barry Chance Frey, and Thomas Lee Willett are seeking re-election to the council.

### Melfa

Charles R. Wilbur is running unopposed for mayor. Three registered for election to the six council seats. They are Councilmen James R. Wilson and David Allen Peffer and newcomer James D. Brown.

### Onley

Two are seeking the mayor's seat and 11 are running for council. Voters will choose between Councilman Matt D. Hart and former Councilman W.R. "Bill" Ferguson. Mayor Dawn Dize, a former councilwoman, was appointed recently after Mayor Jack Pierson died.

Council Members Susan M. Rillo, Melvin T. Bliss Jr., and Woody W. Zember are seeking re-election. Also running are Planning Commissioner Rose Mary Pierson; Vice Mayor Henry S. "Ned" Finney; former Mayor Billye D. Custis; Custis' husband, former Councilman John L. Dennis; Claudia Carpenter Harmon; Theodore F. Cathey Jr.; Jason E. Byelich; and Jerry D. Savage.

### Cape Charles

Three are vying for a seat on the



town council. Former town attorney and Councilwoman Cela J. Burge, who is Accomack County's attorney, wants to stay on the council. Former Belle Haven Councilman Herbert A. "Herb" Thom Jr. wants a seat and former Councilwoman Joan L. Natali is in the race.

**Nassawadox**

Mayor Patsy S. Stith is seeking re-election. Running for council are John W. Hallett Sr., Drury M. Stith, Elizabeth P. "Liz" Freund, Lisa Lindberg, and Claude F. Jones.

**Eastville**

Mayor James C. Sturgis is running unopposed for another term. Council members Eleanor C. Gordon, Denise W. Bland, and John D. Crockett are seeking re-election. Former Councilwoman and Northampton Commissioner of the Revenue Anne G. Sayers wants to join the panel. Newcomer Barbara M. Thomas wants to serve and Councilwoman Mary Beth Briggs, who was appointed to the position recently, is seeking election.

The town election for Eastville will also be at Johnson's United Methodist Social Hall, 11175 Bayside Rd. Signs will be posted to help voters find their way.

**Amendments**

"We urge voters to read up on the issues (regarding the amendments) before they get in the voting booth," said Terry Flynn, Northampton's voter registrar. "In order to remain neutral, officers of election will not be able to help explain the issues to voters. There will be brochures at the polling places for voter information."

According to a sample ballot, the constitutional questions are:

- Should a county, city, or town be authorized to provide a partial tax exemption for real property that is subject to recurrent flooding, if flooding resiliency improvements have been made on the property?
- Shall the real property tax exemption for a primary residence that is currently provided to the surviving spouses of veterans who had a 100 percent service-connected, permanent, and total disability be amended to allow the surviving spouse to move to a different primary residence and still claim the exemption?


Voters are also reminded they need to fill out both sides of the ballots.

## Benefit For Watermen To Establish Fund for Medical Bills

When members of the Cape Charles art community heard that a family member of one of their own was badly injured at his job on the water, they were eager to combine their talents and resources to help.

The result is Cape Charles' first-ever Benefit for Watermen, a tribute and fundraiser happening at the Palace Theatre on Saturday, Oct. 20, from 7 p.m. to approximately 10 p.m.

The benefit was organized by Lemon Tree Gallery, owned and operated by Clelia Sheppard, and nonprofit partner GEAR (Global Exchange Arts Roundtable), a 501(c)(3) directed by Sheppard's daughter, Renata Sheppard.

The event is for Andrew Talbot, the grandson of Vera Miller, the Palace Theatre's costume mistress. The theatre, purchased by Clelia Sheppard and her husband, John, earlier this year, is right next door to Lemon Tree Gallery.

Talbot comes from a long line of Eastern Shore watermen spanning about 200 years, following in the footsteps of his father, Albert Heath Jr., and his grandfather, Albert Heath Sr.

He was hurt on the job this June while the crew he was working with were out in the water setting up a fish trap. The crew were driving poles when one pole slipped and sprang up into the air, then fell and struck Talbot in the face and head.

Several bones in Talbot's face were crushed. His injuries were repaired with three permanent metal plates and five screws. Talbot, who has no health insurance, was left with astronomical medical bills.

His doctor instructed him to do no strenuous work for six to nine months. With a family to support, including two children, ages 2 and 7, Talbot recently decided to return to work performing simple tasks such as mending fishing nets. "His babies need to eat," Miller said.

Proceeds from the event will benefit Talbot. Admission costs \$10 and includes refreshments such as an assortment of cheeses and desserts. For an additional cost, both steamed clams and oysters on the half shell will be available, donated by Miller's daughter, Kimberly Heath Horn, and Eddie Bell, respectively. A white watermen's boot will be passed around to fill up with donations.

"If we have 200 people here, I'd be delighted," Clelia Sheppard said.

The staff at Lemon Tree Gallery wishes the Benefit for Watermen will be successful and become an annual event.

There will be live music by a variety of performers, including members of the group formerly known as Grassafra.

The main artist to be featured at the event is photographer Jay Fleming, who specializes in depicting life and work on the waters of the Chesapeake Bay.

He is the son of former National Geographic photographer, Kevin Fleming.

Jay Fleming is currently based in Annapolis, Md. The photographer and author of "Working the Water" is making a special visit for the benefit. He is expected to immerse the audience in his art with photos and an original documentary. There will also be a book signing.

Organizers want the event to be mutually beneficial to Eastern Shore watermen and the arts that depict them.

"Aquaculture is an essential part of life here in the Eastern Shore," Renata Sheppard said.

The watermen and their families don't often visit the gallery or theatre, yet, "we're all part of the same community here," and "the water has inspired so much art," Clelia Sheppard said.

They hope the benefit will make the arts more accessible and enjoyable to a wider audience.

Northampton High School is pleased to announce the first member to be inducted into its Hall of Fame will be George Willis Young. Young will be inducted into the Northampton Hall of Fame on Tuesday, Dec. 11, during halftime at the Arcadia vs. Northampton girls' basketball game, which starts at 5:30 p.m. The boys Arcadia vs. Northampton game will follow the girls game.

Young worked at Northampton High School as a teacher, coach, assistant principal and principal from 1954 to 1969. Young coached football, baseball, basketball, and track and field. He served as the division superintendent from 1969 to 1989.

As a teacher, coach, and administrator, including Division Superintendent, Mr. Young has impacted the lives of hundreds of students and adults. He epitomizes the term educator. No man, other than my father, has had more influence on my life than Mr. George Young," said long-time teacher and coach at Northampton High School and current Hall of Fame committee member, Kenny Webb.

"Mr. Young always listened and had to time to meet with his fellow workers. When I was a bus driver, Mr. Young took the time on multiple occasions to meet with me and listen to my concerns and suggestions. He was a fair man who was committed to what was best for young people in Northampton County," said current Northampton County employee of 40 years, Melvin Burton.

As a young teacher and coach, Young was instrumental in the development of the physical education program, as well as various sports programs. In 1950, Young, to properly equip the Northampton football

team, drove his own Chevrolet car to William and Mary in Williamsburg, and loaded it with all kinds of football equipment including, but not limited to, helmets, shoulder pads, hip pads, thigh pads, old uniforms, etc. William and Mary, thanks to Young's initiative and phone call, donated unused equipment to Northampton.

Young served in various other positions, including the Virginia Department of Education and as an adjunct faculty member for Salisbury State University. He also served in the U.S. Army.

Young held numerous memberships and presented at multiple local, state, and national conferences over his long distinguished educational career. He was selected for many honors and awards, including, but not limited to Who's Who in Educational Administration, Community Leader of America, Who's Who in Education in the South, Who's Who in American Education, Honorary Life Membership, National Congress of Parents and Teachers, Honorary Life Membership, Virginia Congress of Parents and Teachers, Kappa Delta Pi, International Honor Society in Education, Excellence in Communication Award, Northampton Education Association, Honorary Virginia State Farmer Degree of the Future Farmers of America, Distinguished Service Award, Virginia Congress of Parents and Teachers, and Distinguished Administrator of the Year, Virginia Educational Media Association.

Young and his wife Rosalie have three daughters, Sally Richardson, Suzanne Conrow, and Karen Foley, all of whom are educators. Young has three grandchildren, Whitney Turner, Tye Burns, and Elizabeth Richardson, and two great-grandchildren, Finley Turner and Sutherland Burns.

His parents, Clarence Sharp (he prefers to spell his name without an "e") and Tomashie Sharpe, still live in Painter and are both still working in their late 70s.

Sharpe, 58, said, "I know I am blessed to have two parents at this age who are still alive and together. My parents weren't strict, but you knew what they expected of you. Work hard and treat people right. That will carry you far in life."

had eight kills, two digs, and one ace, Bono notched five kills, 11 aces, and two digs, and Truitt killed two with one dig and one ace.

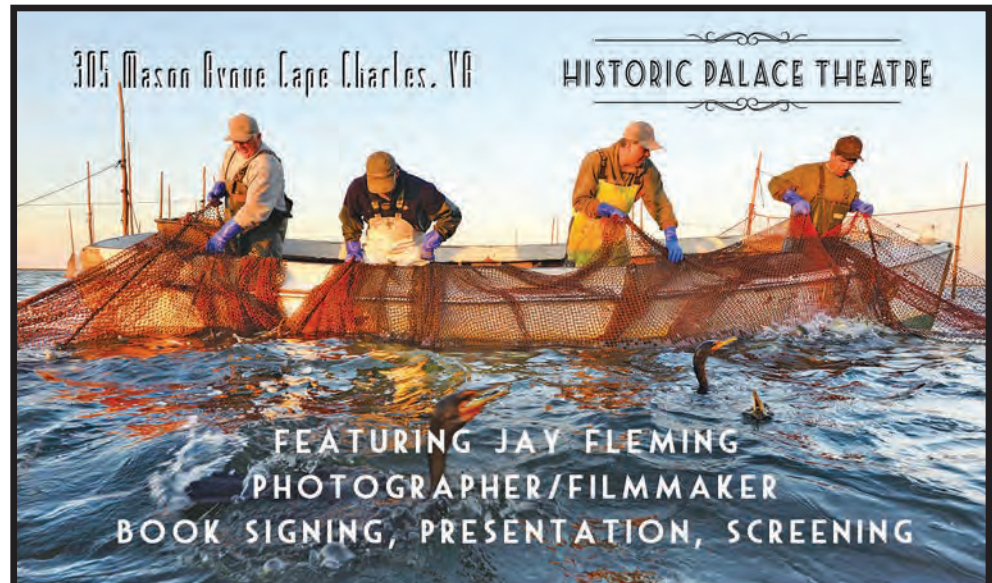
The Warriors will be back on the court in Virginia Beach for a tournament Saturday beginning at 4 p.m.

# Fishing from the Shore

Shallow water anglers are still awaiting the arrival of keeper-sized speckled trout. The trout population so far, although numerous, has consisted overwhelmingly of undersized fish. Increasing numbers of big red drum are starting to show up in the barrier island surf, as a few exceeding 50 inches in length have been released over the last week.

The Fish Hogs, a surf fishing team composed of members of the Eastern Shore Anglers Club won the 2018 Mid-Atlantic Surf Fishing Tournament, their third winning effort in the last three years. The team, consisting of Brian Hill, Clark Crockett, Danny Kidd, Ray Willett, Marty Bull, and team captain Jamie Logan, won in dominating fashion, capturing all four of the tournament's sessions. In addition, members Crockett and Hill tied for the Top Angler Award for the most scoring fish.

**Upper Shore** - Captain Matt Abell, at the Sea Hawk Sports Center, reports that red drum have been caught from the beach on both the Maryland and Virginia portions of Assateague Island. Josh Barfield landed a 50-inch red drum from the surf on Wallops Island. According to Captain Abell, the flounder bite on the inside of Ocean City has gone crazy and he is hoping that the Virginia waters will produce similar results. Abell said that there were "tons" of speckled trout off Smith Island. A casting trip on Monday produced a mixed bag of speckles, rockfish, bluefish, and even flounder. Most of the speckles were throwbacks, but the trip did produce a three-pounder. Jenna Redmond was trolling for rockfish in the shallows of Beasley Bay with her husband Ian, when she was surprised with a nice 28-inch citation Spanish mackerel. The big fish hit a Bass Assassin soft plastic bait and tipped the scales at 5-pounds, 8-ounces. Offshore, the dolphin (mahi) bite remains strong.

**Chincoteague** - Jimmy Vasilou, at Captain Steve's Bait & Tackle, said that there have been a few more large red drum caught off the beach and reports

of a couple of others lost in the suds. The shop has registered release citations for fish measuring up to 52 inches. Surf anglers targeting smaller species have beached snapper bluefish, kingfish (whiting) and even a few keeper-sized flounder. Catches of spot have also been made from the beach down near the point. Offshore, some big (dolphin) mahi have been landed, the shop weighed in one recently that exceeded 32 pounds. Inside the bay, catches have consisted of small flounder, small speckled trout and seabass. The rocks off Inlet View has produced some under-sized tautog. Schoolie rock are hanging out around the bridges.

Donna Rae, at Captain Bob's Marina, reports that there are still flounder to be caught in the Assateague Channel, though most are under the legal size limit. Kingfish (whiting) are still available in the canal, near the mouth of Chincoteague Inlet. The population of inshore coastal sharks is starting to decline, though there are still some there for the taking. Undersized rockfish are being caught and released around the bridge pilings. She had heard reports of a showing of drum in the surf, but had not heard anything from the offshore fishery.

**Lower Shore** - Mark Snook, at Chris' Bait & Tackle, reports that speckled trout and puppy drum are being caught on the seaside, but there are few keepers. Large red drum are being caught over the shoals near the Chesapeake Bay Bridge-Tunnel. Sharks continue to be an unwelcome by-catch in the drum fishery. Anglers have had to switch from bunker baits to hard crabs as the pound nets that were suppling the bunker have been removed for the season. The removal of the pound nets has also reduced the amount of speckled trout holding structures, according to Snook. A couple of late season cobia were caught over the weekend by sight casters. The fishing pier at the Kiptopeke State Park is producing spot, croakers, and lots of swelling toads. A nice sheepshead in

the 7-to 8-pound range was caught at the Concrete Ships and was brought into the shop, but it was the only bite in several hours of fishing the structures.

Jeb Brady, from Bailey's Bait & Tackle, reports that speckled trout have been the primary focus of most fishermen on the lower shore this week. A lot of fish were being caught, but there were only a few keepers in the mix, some anglers reported catching 20-30 speckles with only one or two large enough to keep. Most of the keepers he believes were caught inside Hungar's Creek. Bottom fishermen were finding decent numbers of spot while using bloodworms for bait.

### Veteran Legislation

Recently, the U.S. Department of Transportation announced a new employment opportunity for veterans. Under the Federal Motor Carrier Safety Administration (FMCSA) grant, Tidewater Community College (TCC) has received over \$457,000 in award money to train veterans in obtaining their Commercial Driver License (CDL) and job placement. TCC has again received the grant for this year.

The FMCSA grant provides tu-

ition to help train current and former members of the armed forces, including National Guard, reservists, DHS, and spouses to obtain their CDL. The TCC Truck Driver Training Program is an intense 16 weeks of combined classroom instruction (30 percent) and practical training (70 percent). (Tractor-trailers are on-site.) They offer day and night classes, which meet Monday through Thursday, 7 a.m. to 2 p.m. or 4 to 11 p.m.

Interested veterans or spouses should speak with the program recruitment and job placement program coordinator for the trucking

grant, Alesia Wroten, or an academic advisor at TCC Center for Military Veterans and Education (CMVE) Kempsville Bldg., Virginia Beach campus, for information.

The training program saves veterans \$2,936 in tuition, books, and fees and provides 16 college credits. Wroten said that even though the program is free, there are some out-of-pocket expenses for participants.

Explanation for Proposed Constitutional Amendment  
to Be Voted On at the November 6, 2018, Election

**PROPOSED CONSTITUTIONAL AMENDMENT**

ARTICLE X. Taxation and Finance.  
Section 6. Exempt property.

***BALLOT QUESTION***

Should a county, city, or town be authorized to provide a partial tax exemption for real property that is subject to recurrent flooding, if flooding resiliency improvements have been made on the property?

***EXPLANATION***

Present Law

Generally, the Constitution of Virginia provides that all property shall be taxed. The Constitution of Virginia also sets out specific types of property that may be exempted from taxation. For example, the Constitution of Virginia allows the General Assembly to permit localities to provide a partial exemption from real estate taxes as an incentive for property owners to make substantial improvements to existing structures by renovating, rehabilitating, or replacing those structures.

**Proposed Amendment**

The proposed amendment would authorize the General Assembly to allow localities to provide a partial tax exemption for real property that is subject to recurrent flooding, if improvements have been made on the property to address flooding. The General Assembly and participating localities would be allowed to place restrictions or conditions on qualification for the tax exemption.

A “yes” vote will authorize the General Assembly to allow localities to provide a partial tax exemption for real property that is subject to recurrent flooding, if improvements have been made on the property to address flooding.

A “no” vote will not allow such a tax exemption.

**FULL TEXT OF AMENDMENT**

Amend Section 6 of Article X of the Constitution of Virginia as follows:

ARTICLE X  
TAXATION AND FINANCE

**Section 6. Exempt property.**

(a) Except as otherwise provided in this Constitution, the following property and no other shall be exempt from taxation, State and local, including inheritance taxes:

(1) Property owned directly or indirectly by the Commonwealth or any political subdivision thereof, and obligations of the Commonwealth or any political subdivision thereof exempt by law.

(2) Real estate and personal property owned and exclusively occupied or used by churches or religious bodies for religious worship or for the residences of their ministers.

(3) Private or public burying grounds or cemeteries, provided the same are not operated for profit.

(4) Property owned by public libraries or by institutions of learning not conducted for profit, so long as such property is primarily used for literary, scientific, or educational purposes or purposes incidental thereto. This provision may also apply to leasehold interests in such property as may be provided by general law.

(5) Intangible personal property, or any class or classes thereof, as may be exempted in whole or in part by general law.

(6) Property used by its owner for religious, charitable, patriotic, historical, benevolent, cultural, or public park and playground purposes, as may be provided by classification or designation by an ordinance adopted by the local governing body and subject to such restrictions and conditions as provided by general law.

(7) Land subject to a perpetual easement permitting inundation by water as may be exempted in whole or in part by general law.

(b) The General Assembly may by general law authorize the governing body of any county, city, town, or regional government to provide for the exemption from local property taxation, or a portion thereof, within such restrictions and upon such conditions as may be prescribed, of real estate and personal property designed for continuous habitation owned by, and occupied as the sole dwelling of, persons not less than sixty-five years of age or persons permanently and totally disabled as established by general law. A local governing body may be authorized to establish either income or financial worth limitations, or both, in order to qualify for such relief.

(c) Except as to property of the Commonwealth, the General Assembly by general law may restrict or condition, in whole or in part, but not extend, any or all of the above exemptions.

(d) The General Assembly may define as a separate subject of taxation any property, including real or personal property, equipment, facilities, or devices, used primarily for the purpose of abating or preventing pollution of the atmosphere or waters of the Commonwealth or for the purpose of transferring or storing solar energy, and by general law may allow the governing body of any county, city, town, or regional government to exempt or partially exempt such property from taxation, or by general law may directly exempt or partially exempt such property from taxation.

(e) The General Assembly may define as a separate subject of taxation household goods, personal effects and tangible farm property and products, and by general law may allow the governing body of any county, city, town, or regional government to exempt or partially exempt such property from taxation, or by general law may directly exempt or partially exempt such property from taxation.

(f) Exemptions of property from taxation as established or authorized hereby shall be strictly construed; provided, however, that all property exempt from taxation on the effective date of this section shall continue to be exempt until otherwise provided by the General Assembly as herein set forth.

(g) The General Assembly may by general law authorize any county, city, town, or regional government to impose a service charge upon the owners of a class or classes of exempt property for services provided by such governments.

(h) The General Assembly may by general law authorize the governing body of any county, city, town, or regional government to provide for a partial exemption from local real property taxation, within such restrictions and upon such conditions as may be prescribed, (i) of real estate whose improvements, by virtue of age and use, have undergone substantial renovation, rehabilitation or replacement or (ii) of real estate with new structures and improvements in conservation, redevelopment, or rehabilitation areas.

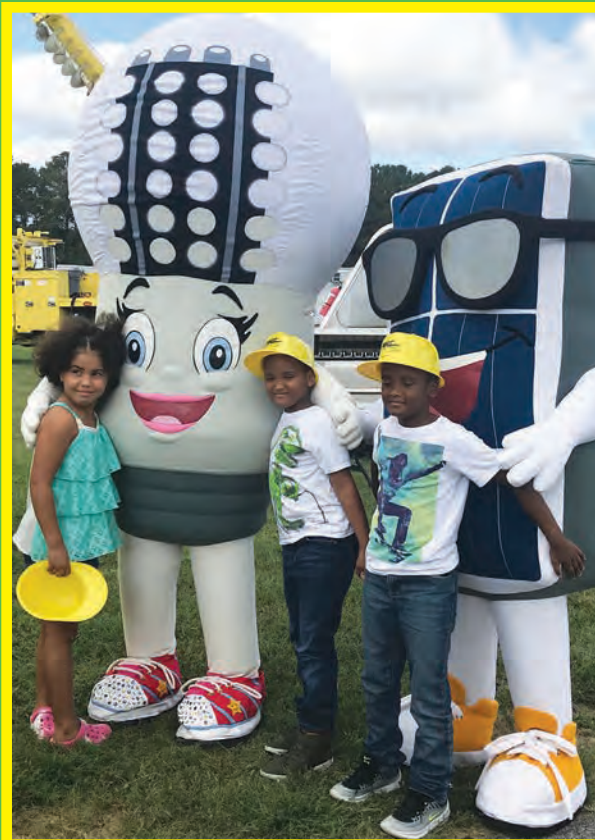
(i) The General Assembly may by general law allow the governing body of any county, city, or town to exempt or partially exempt from taxation any generating equipment installed after December thirty-one, nineteen hundred seventy-four, for the purpose of converting from oil or natural gas to coal or to wood, wood bark, wood residue, or to any other alternate energy source for manufacturing, and any co-generation equipment installed since such date for use in manufacturing.

(j) The General Assembly may by general law allow the governing body of any county, city, or town to have the option to exempt or partially exempt from taxation any business, occupational or professional license or any merchants' capital, or both.

(k) The General Assembly may by general law authorize the governing body of any county, city, or town to provide for a partial exemption from local real property taxation, within such restrictions and upon such conditions as may be prescribed, of improved real estate subject to recurrent flooding upon which flooding abatement, mitigation, or resiliency efforts have been undertaken.

# Eastern Shore Barber Proves He Is A Cut Above the Rest

Atlanta-based celebrity barber Korey Finney may have left his native Eastern Shore years ago to find his success, but he never forgot where he came from or the community that helped him become what he is today.

Finney grew up in Nassawadox and attended Northampton schools. After his graduation from Northampton High School in 2006, he started on the path to become a celebrity barber, attending Champ's Barber School in Lancaster, Pa.

By 2008, he owned the barber shop on Lankford Highway in Exmore. But about six years later, with the desire to capture "a different spark," Finney left for Atlanta, Ga., encouraged by an uncle who lived there.

Finney had the dream and the drive to become a barber to the stars, but it didn't happen overnight.

For about six months, Finney was an insurance salesman. He kept his barber equipment in his car. One day, he gave his manager a haircut in the office, and the manager was so impressed with Finney's work, he said, "You don't need to be selling insurance." Finney quit his job the same day and never looked back. He had been in Georgia not quite a year.

Finney's first job as a barber in Georgia was in Decatur, just a few miles away from Atlanta. It wasn't long before he was competing, placing in, and winning barber competitions across the metro area.

In February 2016, things started heating up for Finney when he placed third at the Bronner Brothers International Beauty Show in Atlanta, competing in cut and color enhancement.

By April, Finney was on fire, winning first place at two different competitions two weeks in a row. The first was the Glitz and Glam Barber Show in Decatur. The second was the beard competition at the International Hair Show, where he was recognized by Uncle Jimmy's Grooming Products and became a "platform barber and brand ambassador," appearing at more

hair shows and selling the company's products.

Finney left Decatur in February 2018 and finally became a barber in Atlanta at Salon Eshelon, owned by hip hop artist Yung Joc, who has appeared in VH1's "Love and Hip Hop: Atlanta."

Finney has cut Yung Joc's hair and that of another "Love and Hip Hop" star, rapper Safaree.

Arguably, Finney's most famous client is Grammy-winning music producer Jermaine Dupri, who has worked with some of the biggest names in hip hop and R&B, most notably, Mariah Carey.

Other familiar names who are Finney's clients include rapper and "Growing Up Hip Hop: Atlanta" star, Bow Wow (formerly Lil' Bow Wow), and stand-up comedian and movie and TV actor Brandon T. Jackson.

Another name high on the list of importance for Finney is Craig "CJ" Bailey Jr.

Bailey isn't a celebrity; he's the manager of the Dream Team barber shop in Exmore that Finney still owns and operates. Bailey keeps everything running smoothly while Finney is in Atlanta.

Finney said, "I'm never going to forget where I came from," and he visits whenever he can.

He enjoys giving back, and in September, he threw the Youth Give Back Kick Back at the barber shop. Lots of customers' kids attended, but all kids were welcome. They were treated to hamburgers and hot dogs and were given free book bags, school supplies, and hair care supplies.

Finney wanted to give kids the message, "Care about your future and look good while you're doing it," and to let them know there's "somebody in your corner."

He wants kids to see his success and realize that "you don't have to sell drugs" to make it, all you need is "a dream and motivation," and it can start right here on the Eastern Shore.

"Atlanta made me a better businessman," Finney said, but "the Eastern Shore made me into the man I am today."

**Increase In Natural Preserve**

Last week the Department of Conservation and Recreation (DCR) closed on three tracts of land that were added to two state Natural Area Preserves. Fifty-three acres of that were added to Magothy Bay Natural Area Preserve in Northampton County. These acquisitions were completed during Virginia Public Lands Week.

Magothy Bay Natural Area Preserve has woodlands, forested wetlands, and extensive salt marshes. Its land provides habitat for a variety of coastal species. ## Neubeam Has Problems

Dear Editor:

Those of us who have had real broadband internet in the past (COX in my case) are really not too happy with Neubeam’s quality and reliability. In my case the service is relayed to an antenna sitting in the front yard at 4530 Seaside Rd. The transmitting antenna sits low enough that a fair sized truck interrupts the signal causing things to freeze.

Back in May there was an electrical fire in the house and my internet was down for over a day while a battery backup was brought. Neubeam’s service manager here on the Shore told me he had been afraid something like that would happen, but he had hoped the new hub they were building would be up before that (still waiting).

I would be very happy to have fiber to my house. In Newport News I typically had speeds well over what Neubeam’s highest level can deliver, and rarely had problems. Neubeam’s call center is apparently

a shared affair, and more than once I have called a problem in, and after several hours called again, and frequently have to remind the CSR that I need a ticket number for the record.

I currently pay \$65/month for “Basic Beam,” 10 Mbps down and 5 Mbps up. In Newport News, I was paying \$79/month for TV, internet and phone. Here I have separate suppliers for TV (AT&T now), Internet (Neubeam) and phone (Verizon). Total is \$215.80, this is more than absurd considering the phone system is an old analog copper wire system and the internet is sometimes bog slow. Biggest ripoff by far is AT&T for TV, though.
