Northampton Confronts EMS Issues

The Northampton County Board of Supervisors received an update on the status of the county's Emergency Medical Services (EMS) program from Director Hollye Carpenter. The picture painted by Carpenter was anything but rosy.

Carpenter cited the need for additional equipment and manpower in order to keep EMS above water.

Currently, residents of Northampton County are serviced by volunteer companies in Cape Charles, Exmore, and Nas-sawadox, backed up by career EMS providers in Exmore and Cape Charles. A first-responder vehicle in Machipongo provides additional Advanced Life Support (ALS) as needed. The three squads and county EMS first-response units handle over 2500 calls a year, with the numbers rising steadily. With the planned move of Riverside Shore Memorial to Accomack County and travel times for Northampton's ambulances more than doubling, residents of Northampton can expect longer delays in receiving EMS care unless changes are made.

Noting that the county plans to purchase its own ambulance to supplement the five units located at the three rescue squad locations, Carpenter said it is to be housed in Machipongo at the former middle school site. The county EMS goal is to have an ambulance on the scene of 911 calls within 20 minutes of being dispatched. To meet this need, Carpenter recommends that the number of career staff, both full-time and part-time, be increased. She also called for a concentrated effort to recruit more volunteers.

Carpenter said the EMS budget would need to be greatly expanded if manpower and equipment needs are to be met. If, at some point, the county were to move to a 24/7 career EMS staff at three sites, the cost could exceed \$1.2 million annually, she said.

Supervisor Oliver Bennett asked Carpenter about the possibility of increasing the number of Automatic External Defibrillators (AEDs) in the County. An AED provides an electrical shock to try to restart the heart of someone in cardiac arrest. According to Carpenter, there are just over 30 AEDs in Northampton County. Most are scattered throughout county-owned buildings, which makes them unavailable after normal work hours. Others can be found in some police vehicles. A few organizations and subdivisions have purchased AEDs and placed them in areas with higher concentrations of residents or in more remote areas of the county. Carpenter said that while more AEDs would be a plus, finding suitable and secure sites where the public could access the devices is a challenge. The cost of an AED is between \$800 and \$1,000, with some running upward of \$1,500, depending on the manufacturer.



Halloween Scaredy-Cat

Though his name is Punkin, this Gargatha feline will not be celebrating on Halloween. His expression denotes his opinion of the proposed Accomack ordinance that would require him to be licensed and wear what he terms "an unsightly metal tag." The proposal will go before the Accomack Board of Supervisors in November and could be set for public hearing in December. According to the proposed ordinance, "it shall be unlawful for any person to own a ... cat four months old or older" without a license. The tags for male and female cats would cost \$10, the same as for dog licenses. Licenses for neutered or spayed cats would be \$5. Kennel fees for up to 20 cats would be \$25; for 21 or more felines, the fee is \$40. Duplicate license tags are \$1. Before being granted a tag, the cat owner would have to show that the animal has had a rabies vaccination by a licensed veterinarian. The issue is being spearheaded by Supervisor Ron Wolff.

Advice Offered for Protecting Credit

A credit monitoring service Web site suggested by Accomack officials for use by property owners offers only a free trial.

"The county has learned that the site provided, Freecreditreport.com, offers only a free trial of their credit monitoring service, which comes with free access to your Experian credit report and credit score," according to County Administrator Steve Miner. The site was suggested in about 35,000 notices the county mailed to property owners who may have their privileged information compromised due to the theft of a county-owned laptop computer.

"If you don't cancel before the trial expires, they will charge you," Miner said. "But if you do call them and cancel, you won't be charged anything. While this is a reputable service, it isn't free. It is a paid service which you can monitor all you like, once you pay."

Miner suggested another site, wwwannualcreditreport.com, that is "totally free" and "allows you to

request a free credit file disclosure, commonly called a credit report, once every 12 months from each of the nationwide consumer reporting companies: Equifax, Experian and TransUnion."

According to Miner, "The folks at FreeCreditReport do tell you up front that they are a fee-based service, assuming you don't cancel, so they aren't really a scam."

Assistance is being offered to Accomack property owners seeking relief since receiving notices that their information could be breached.

"We know that some people need assistance," said Miner. "While many have taken the steps we outlined in the letter and have called the companies, we know that others may not have. Some folks may need assistance or maybe just aren't aware of the importance of taking protective steps. Churches are helping and many have friends and relatives who have assisted, but (county) supervisors have requested that we make help available in all areas of the county."

On Chincoteague, Supervisor Wanda Thornton coordinated help through the town offices.

In northern Accomack, help is available from 9 a.m. to 4 p.m. Mondays, Wednesdays and Fridays and from 10 a.m. to 4:30 p.m. Tues-

days and Thursdays at the parent resource center at Arcadia High School. County workers will assist property owners from 8:30 a.m. to 4:30 p.m. weekdays at the Accomack Administration Office in Accomac and at the airport in Melfa

Do You Favor Meals' Tax?

More than 53 percent of Accomack residents who participated in an e-mail survey conducted by the Eastern Shore Post this week said they will vote "no" Tuesday on the meals' tax referendum. About 38 percent favor the tariff and the remaining 9 percent are undecided.

"I am sick, sick, sick, sick to death of paying taxes and will not support another tax of almost any kind," said Deborah Gilmore of New Church.

"Consumers don't need any more taxes put upon them," wrote Vic Peppler of Wachapreague. "Governments should learn to work within their budgets just like families do."

Shane Whealton said that in Chincoteague, he is "taxed for everything already with the highest meals tax around. Plus, I have to pay county taxes on top of local Chincoteague taxes. I'm financially persecuted for living on the Island. The problem is the county is going to keep trying to raise all taxes every year and yet these people make 100K plus salaries for one of the poorest counties in Va. Does not add up. ... Even if this tax bill is a good idea, I fight all taxes because they slowly cook you in the pan instead of frying you right away."

But Brian Saulsbury of Captain's Cove in Greenbackville favors it. "I will vote for the tax," he wrote. "I realize that a large number of travelers on Route 13 are not from the Eastern Shore and therefore I personally don't mind if they are taxed as they stop here to eat. I would like to see us get more revenue from our tourists ... possibly local restaurants could offer a 'locals only' discount to keep their loyal customers but still tax the 'out-of-towners.' The bay bridge tunnel raised its prices, why can't we?"

Dennis Schirmer of Onley also favors the tax. "No one wants new taxes," he said. "But we need to level the playing field on all the great eateries here on the Shore."

Onley, Onancock and Chincoteague already collect a meals' tax. The county's proposal would allow Accomack to impose the same tax as the towns but would not apply in addition to the town tax. The county meals' tax would generate an estimated \$500,000 to \$700,000 annually for education. It is comparable to a 1-2-cent increase in the real-estate tax rate.

Bobby Crutchley of Melfa has not decided how he will vote. "Although I am not in favor of any tax, the meals' tax does not necessarily bother me as much as other taxes or tax increases," he said. "It would be a tax that everyone will be paying. Better to have a meals' tax than an unfair increase in real-estate or personal-property tax."

Linda Nicola of Onancock also hasn't decided how she will cast her ballot. "You can't get good schools and roads without money," she said. "I do think the county can use their funds better and not so wastefully. I just need to look at this issue further."

Cecilia Baker of Temperanceville wrote, "I am not sure. Although the county needs the money to support the schools, I would rather the county obtained permission to levy additional taxes on tobacco products rather than on food. I am not in favor of taxing hot foods from the grocery store. Hence the dilemma, the schools need the money, but I am generally not in favor of consumption taxes, as they are regressive. My exceptions are the sin taxes, as using tobacco is unhealthy."

Jim Frese of Chincoteague opposes the meals' tax. "The Board of Supervisors only grows government with a more than extravagant legal department, bloated planning department, millions wasted on trash sites, lining their own pockets via their Cadillac health insurance (for) some of them. ... Until the BOS (Board of Supervisors) exercises honest and sound judgment in governing, I do not support any



Dolphins Beached on Chincoteague Euthanized

Samples from four dead Risso's dolphins were sent to a pathologist for study to determine why they got stranded in the marsh near the beach at Tom's Cove in Chincoteague earlier this month.

According to Maggie Lynott of the Stranding Response Program of the Virginia Aquarium and Marine Science Center in Virginia Beach, the dolphins, which were between 5.5 and 8.5 feet long, were reported to be stranded on Oct 17 about 300 yards from the road. "We're not quite sure why they stranded," she said. "They had no obvious pathologies."

Lynott said one was dead when the strand team arrived, one died on its own and the other two dolphins had deteriorated to the point that they needed to be euthanized. "We take into consideration all possible options," she noted.

"It's rare to find candidates that are strong enough" to survive, Lynott said. "When they strand, they immediately" prepare themselves for a dive by lowering breathing and heart rates which cuts flows."

"We want to learn as much as we can," Lynott said. "The Eastern Shore is actually quite a busy place for us."

Supervisors Put Accomack Stormwater Plan on Hold

Accomack supervisors voted last week to postpone enacting a proposed stormwater management ordinance that was first drafted about two years ago.

Supervisor Wanda Thornton said adopting it would be equivalent to "confiscating every vacant lot on Chincoteague." But planners say the ordinance would help developers save money by "doing it right the first time."

Jim Belote, a retired county Virginia Cooperative Extension agent from Onancock, is opposed because he wants "government regulation out of my life." Belote contends that the area "is better off environmentally than we ever were," and that the regulation would increase the cost of housing. "Please vote no on this ordinance," he urged.

Planning Director Jim McGowan said the rules would apply to those preparing subdivisions, not the individual lot owners.

Norman Pitt, a planner who oversees stormwater issues, said, "This ordinance would help me ...

do the stormwater management checklist. I'll still be doing the same things. It will have more teeth."

Toni Trepanier, a real-estate agent who lives in Hallwood, was also opposed. These are the "worst economic times we have seen in my lifetime ... facing foreclosures ... increased problems coming upon us ... we're not expecting five million people to come into Accomack County ... so what are we talking about here?" she asked. "We can't get to the point where you can't breath (with) too much government interference ... it's just time to say 'no.'"

According to an advertisement, "The proposed ordinance would establish minimum stormwater management requirements to protect properties and aquatic resources by reducing flooding, siltation, stream bank erosion, etc.; minimize non-point source pollution from stormwater runoff; provide for stormwater control devices; and establish administrative procedures for the processing of stormwater management plans and projects."

The supervisors voted 7-2 to postpone until the state forces the issue. Thornton, Chairwoman Laura Belle Gordy, Vice Chairman Donald Hart and Supervisors Jack Gray, Grayson Chesser, Sandy Hart-Mears, and Phil McCaleb

voted to delay. Supervisors Steve Mallette and Ron Wolff wanted to adopt the proposal.

The supervisors also voted unanimously for the chairwoman to appoint a committee to study the possibility of a county lobbying program.

Flounder Hearing Set for November

The Virginia Marine Resources Commission proposed raising the summer flounder size limits for commercial hook and line fishermen Tuesday that will match the recreational possession limit and set a flounder vessel possession

limit of 150 to 200 pounds.

The panel voted 9-0 to advertise the plan for a November public hearing when it expects to vote. Currently, commercial hook and line license holders may keep substantially smaller flounder than may recreational anglers.

Court Postings

Accomack & Northampton Circuit Courts

The former director of Eastern Shore's Own Art Center in Belle Haven pleaded guilty recently to charges in both Accomack and Northampton circuit courts in connection with a total of \$65,000 taken from the nonprofit organization.

Rene Diane Scott, 48, who now lives in Collin County, Texas, pleaded guilty in Northampton County Circuit Court Monday to five charges of passing bad checks. Commonwealth's Attorney Bruce Jones said Scott also was indicted on seven counts of forgery, but he did not prosecute those charges.

Scott pleaded guilty in Accomack County Circuit Court last week to two counts of embezzlement. She contended her innocence in those cases, even though she entered the pleas.

In both courts, sentencing was deferring pending completion of a presentence report.

tax increases or even the high rates now charged."

Laura Flournoy of the Hopeton/Parksley area wrote, "Hard question. There seems to still be a large number of issues that have not been hammered out ... if I had seen a document with solid detail as to how the county was going to monitor, collect and allocate the funds, I would be voting 'yes' because I value the public school system and the people that work for it. I would also be voting 'yes' because I am willing to give near everything I have for the future of my children ... I would like to see the county bring this matter to vote in 2011 after significant planning and arrangements have been made."

Matt Hart of Wachapreague wrote, "I plan to vote against it because of the current state of our economy and because I believe that taxes need to be reduced instead of increased. Vote 'NO FOR NEW TAXES.'

Nathan Metzger of Craddockville said, "I will vote in favor of the meals' tax. Although taxes seem like a bad thing, they provide us as citizens with goods and services that we need. If the tax money goes towards things such as road improvement, the local school system and other needs the government provides us, I am all for it. What is an extra few dollars here and there for me if it can better help the community as a whole? If people don't want to pay for the sales tax, then choose to stay at home and eat, instead of going out. It is cheaper to purchase your own food and make it than it is to eat out."

Jack Mason of Accomac is opposed. "I'm not that educated on the subject but there must be another way to solve problems other than taxation," he noted.

Eveline Cropper of Horntown favors the meals' tax because it is "one that all citizens can participate in unlike personal-property or real-estate taxes. This revenue is much needed for our educational programs."

Kimberlee Ormsby of Onancock is against the meals' tax. "If they could police this money and assure

me that it goes towards education as stated, I would vote yes," she wrote. "However, there are not any assurances and so far our county government has shown little responsibility in the handling of our tax funds."

Carl Nesensohn of Onancock says "nay" to the tax. "We are taxed too much already."

Mary Hollandsworth of Onancock favors it. "The most important impact we as citizens can have on our future is to continue to support our public schools, just like we did last spring when the tax increase was approved," said Hollandsworth. "This money is slated to come mainly from people who travel up and down Route 13 and since we don't have tolls that support our local area, why not take advantage of these visitors? I would so much rather vote yes on this proposal than to be faced with another budget shortage in the spring. If you don't support this, spend some time in our schools and see the great work that goes on there each and every day."

Kay W. Lewis of Parksley wrote, "I believe it will give the taxpayers in the county a break from increasing real-estate taxes. We have to fund education and thus far it has been through increasing taxes. This tax would get to education and the good part about it is that a great amount of it would be paid by non-residents who are driving through and stop to eat. ... Towns such as Onley and Onancock have been charging the meals' tax and no one has even paid any attention to it. It is time for the rest of the county to jump on board."

Bettie Fletcher of Parksley favors the tax. "We already pay taxes on food and beverage, but the main reason is that 100% of the revenue will go towards the cost of education in Accomack County. I worked in the school system for 38 years as a secretary. When teachers came in to place orders for supplies and they were told there were no funds available or not enough for what they needed, these educators went and purchased their supplies and materials for the classroom out of their own pocket. Now, with all the salary cuts, loss of jobs and no raises for several years, it's time to bring in revenue from wherever the county can get it."



CAPITAL LETTERS

The end of summer brings with it increasing legislative duties. There are numerous public events and activities throughout the fall and also earnest preparations for the fast-approaching 2011 Virginia General Assembly Session which will convene in Rich-

mond on Jan. 11. This will be a "short session," lasting until Feb. 26, 2011.

My first annual Community Day at the Eastern Shore Community College was a success. Thanks to all the local government officials who took time to attend and to everyone for coming out. It was a great opportunity to interact with your elected officials in a relaxed, family-oriented setting.

The good news is that Virginia's economy seems to have stabilized and begun a slight upturn. Economic activity has generated an increase in August and September of the commonwealth's revenues. As you may have already heard, the commonwealth budgeted but did not fund a 3 percent bonus for state employees. That bonus is now funded and will occur in December 2010.

The issue of privatization of Virginia's Alcoholic Beverage Control System has been at the forefront of public discussion for several weeks. The governor has abandoned his intention to call a Special Session in November to consider that issue and other less controversial government efficiency proposals. The matter is only postponed and the Administration will offer a privatization plan during the regular 2011 session. While there is certainly merit to the governor's arguments regarding the propriety and appropriateness of the state's participation in what normally would be the private enterprise of liquor sales, alcoholic beverage control is woven into the fabric of our state's finances and after 80 years may well be difficult to extricate. As former Gov. Mark Warner, who

also considered this proposal when he was governor, said, if we were having this discussion 80 years ago, we may well choose to go down a different path. However, that is not the case. While I am very receptive to the concept of allowing private enterprise do what private enterprise can, I have grave concerns about the effects of privatization on our commonwealth's budget and on our ability after having instituted approximately \$7 billion in cuts to our state budget to provide for the core services of government, particularly in public safety and public education. I will look to seeing the final form that the governor's proposal will take as the details have changed many times over the last few weeks.

Fall is a busy time for community events. I was pleased to be the keynote speaker at the kick-off breakfast for the Eastern Shore United Way Campaign. This great organization provides funding to so many Eastern Shore groups and organizations that provide valuable and needed resources to our Eastern Shore citizens. I hope that everyone supports and makes a success of this great campaign. In addition, what I think will be a momentous event in the history of the Eastern Shore and economic development was the official ribbon cutting of the Eastern Shore broadband infrastructure. We were pleased to have Sen. Jim Webb, who has been a real ally and champion of this project in Washington, with us for the ribbon cutting. I hope that our entire Eastern Shore community can come together to build on this terrific infrastructure asset. On Saturday, Oct. 16, I participated in the dedication of the Chincoteague Bridge. I know that the reality of a new bridge has been a hard-fought battle for the Chincoteague community and this will be a great milestone, not only for Chincoteague but for the entire Shore.

I am also preparing for my regular series of town hall meetings which will be held between January and the start of the Virginia General Assembly Session. We continue to work on legislation and legislative ideas and will soon begin filing portions of our legislative package with the House of Delegates.



Mary N. Smith School May Be Converted To Apartments

By Linda Cicoira

The Accomack-Northampton Planning District Commission is working with a Texas developer at the request of Accomack Administrator Steve Miner to find funding to turn the former Mary N. Smith School site into affordable housing.

"Representatives of the developer, the county and the Mary N. Smith alumni have met on a couple of occasions to discuss the scope design and possible funding sources for the project," according to a memo that was included in the Accomack Board of Supervisors agenda packet. A preliminary plan includes renovating the existing building into a maximum of 25 one- and two-bedroom apartments. In addition, the surrounding property could be used for construction of 60 two- and three-bedroom units.

The major funding source would

be federal low-income housing tax credits, the memo states. Dave Koogler of Mark Dana Corporation requested the county apply for additional funding through the Virginia Department of Housing and Community Development (DHCD) block grants. However, the subject did not come up at the supervisors' meeting for discussion.

DHCD agreed to provide an unspecified amount of planning funds that would help pay for a preliminary engineering report. Koogler has agreed to front the funds for preliminary architectural drawings, a market study, an assessment of hazard materials and an environmental review.

The application for tax credits is due March 11, 2011, and must include an option to acquire the property. The county application for block grant funds is also due in March.
