Countywide Accomack Candidates Face Off

Three men who want to be Accomack's sheriff for the next four years squared off at a debate Wednesday night at Nandua High School before about 200 spectators. Just prior to that, Treasurer Dana Bundick faced her challenger, former county Supervisor Greg Duncan.

They all asked voters to favor them at the polls next Tuesday. Citizens For A Better Eastern Shore

(CBES) sponsored the event. Both races feature Independent candidates.

Sheriff Todd E. Godwin of the Parksley area, who filled the unexpired term of Sheriff Larry Giddens in August, wants to keep his job. Also seeking the position are Onley Police Chief Walter E. Marks and former

"Crime is down by over 17 percent," said Godwin. New mobile computers in squad cars have allowed more visibility and an officer was recently transferred to the Eastern Shore Drug Task Force, Godwin said, adding that since taking over, he's increased the weekend work force and will be asking for a zone enforcement officer to help alleviate the area's litter problem. He touted 10,000 answered calls, 11,000 criminal warrants and 1,500 traffic summons that were written last year.

Marks said better cooperation between law enforcement agencies in the county and neighboring areas is needed. He wants a monthly meeting to share arrest and other infor-

mation. "It's time for a change," he said, adding that officers need to "be seen more in the community. ... The only way this county is going to be safe again is to work together."

"I have the bravery that is needed," said Rogers. "I have the vision that is needed. ... I would love to be your next sheriff." He complained that deputies are overworked and are unable to take vacation and compensatory time because there is so much that needs to be done. Morale is low because of the workload. "We have to do something about manpower," Rogers said.

He suggested educating the public about spotting crime and protecting themselves and their belongings, as "most crimes are crimes of opportunity." He wants to create a volunteer force to lighten the load. Rogers also said jail conditions need improvement, including training officers to identify mental illness, and complained that there isn't a secure area to unload prisoners.

Marks said he is unfamiliar with the jail but would do a security survey to make sure the situation is safe for inmates and workers. He said deputies should be sitting in high drug areas to deter trafficking.

Godwin said cameras have been installed to protect against false accusations at the jail and rounds are being completed every two hours. He hosted a meeting of local agencies recently and established a partnership that he promised to continue. Godwin explained that the number of officers is controlled by the state Compensation Board and that while an auxiliary sounds good, the training would still be costly, about \$12,000 per officer.

Rogers said local fire and rescue companies prove that volunteers can be used. He added that a bilingual officer is needed. "A lot of money is spent on interpreters," Rogers noted.

Godwin was asked why Giddens left office before his term was over.

"I had no control over Sheriff Giddens' retirement," said Godwin.

Rogers said that at the beginning of Giddens' term, "He told us all he was going to do eight years. I was told to wait my turn — wait 12 years" to run for sheriff. "A lot of us saw this coming."

Godwin said he is committed to the job and will continue to offer existing programs and promote fairness.

Both candidates in the treasurer's race are Independents from the Parksley area.

Bundick has been at the job for 16 years and recently was criticized in a county study for running a system that lacks "effectiveness and efficiency."

"Nobody likes to pay taxes," she said Wednesday night. "I've taken a lot of heat ... we'll always have delinquent taxes."

Bundick admitted that there are \$8 million worth of overdue bills in Accomack. But, she said 623 real-estate sales have brought in \$2.4 million plus another \$700,000 that went unclaimed in the process. In addition, she said \$1.3 million in stops to Department of Motor Vehicles registrations were completed. "We've got lots of tools on there to use and I plan to use them all," Bundick told the crowd.

Two Onancock Councilmen Resign Over Personnel Issue

A tie vote of Onancock Town Council, broken by Mayor Bruce Paone, has resulted in two members resigning.

Last week, members George Miles, Travis Bradley and Michelle Marsh voted to hire a new police chief. Paone said Officer Eric Williams "has been with the town for 10 to 12 years. All of the other applicants, three or four, were from out of state and were not certified" in Virginia, the mayor said. "The former chief (Bryon Heaster) recommended him. ... I figured it was better to hire from within," Paone added.

Council members Fletcher Fosque, Kris LaMontagne and Richard Pearsall were opposed. LaMontagne was chairman of the Personnel Committee. Both LaMontagne and Pearsall submitted letters of resignation to the Town Office late Tuesday afternoon, more than a week later. Their resignations were effective immediately.

Paone said Town Manager/Attorney Thomas Robinett would look into the best way to fill the seats.

Reached by telephone, LaMontagne asked that his letter be obtained from the town. "I think the town needs to deal with it. I felt it was unethical" to vote for a chief before the screening process was completed. "I can't work in that environment."

"I take this action seriously and am doing so after much consideration," his letter says. "At the Oct. 24, 2011, council meeting, a vote to hire a police chief circumvented town personnel policies and procedures and in doing so failed to exercise impartiality and due diligence. In addition, a personnel discussion was held in a public forum which may have violated privacy rights of the candidates."

"My resignation has nothing to do with the individual" who was hired "but rather has everything to do with actions that showed a disregard for town policies and a failure to be impartial in the discharge of council duties, as required by the oath of office," wrote LaMontagne.

He said the screening process ap-

proved in January 2009 requires review of applicants by the committee. "At this point, the ... committee had not yet provided its recommendation and evaluation of the candidates to Town Council for a vote," wrote LaMontagne. The committee, he added, "received applications and began the review and screening process at its Oct. 18, 2011 meeting. The process was to be complete and a candidate selected by Nov. 4."

LaMontagne said "of greater concern is that this action sets a precedent whereby any town policy can be disregarded. ... I ... must follow my moral compass of integrity, professionalism and sense of equity and fair play."

LaMontagne also resigned from the Broadband and Hospital committees and as co-chairman of the Marketing Committee.

Pearsall resigned as member of the Personnel, Harborfest and Hospital committees; chairman of the Waterfront Committee; and council representative for Friends of Onancock School. He was also the town's liaison

for the landing grant, creek water trail grant, watershed restoration project grant, harbormaster facility boating infrastructure grant, Chesapeake Bay Gateway Network, National Parks Service, and designated lead for OP-SAIL 2012, and the Delmarva Water Transportation Committee.

"I had hoped to contribute my ... experience ... to improve the welfare ... of the community while raising the standards of conduct in the ... management of the town," wrote Pearsall, "but find that I am unable to do so in the town leadership climate that prevails today."


Pearsall's letter agreed with LaMontagne's and added that during this "public spectacle, the town attorney regrettably did not advise Council of the pitfalls of not following established policies and allowed the mayor and council members ... to bring the matter to a vote."

Town Clerk Kim Lochrie said Williams officially assumed the position Thursday. "We are in good hands," she added.

Planning Commission's Action Reflects Sign of the Times

At its November meeting, the Northampton County Planning Commission fielded a request from Michael and Nan Arpino to change the county zoning ordinance to allow them to use existing sign structures in the Existing Business (EB) District for off-premise advertising signs.

The property the Arpinos own at the north entrance to Eastville is not currently operated as a business, but has held commercial occupants over the years.

Commissioner Roberta Kellam remarked that the request was consistent with the County's Comprehensive Plan and would be beneficial to local business interests.

Commissioner Mary Miller also supported the concept if there is some way to insure that the signs are used for local businesses rather than allow-

ing the space to advertise off-Shore businesses.

Commissioners Mike Ward and Dave Kabler questioned how this could be imposed legally as a limitation.

In the end, the commissioners voted 7-0 (Commissioner Severn Carpenter was absent) to endorse the request for the amendment and forward it to the Board of Supervisors for a public hearing.

The commissioners discussed the upcoming review of the Comprehensive Plan. Miller and Kellam recommended the use of stakeholders to help review the current plan and recommend changes. Chairman Dave Fauber suggested that each commissioner develop a list of potential stakeholders to help with the project. The group agreed to work on gathering a stakeholder list and continue the discussion at the next session.

April 2010 incident. All but 14 years was suspended. Blake also was ordered to pay court costs and restitution of more than \$133.

William Young, 19, of Fletcher Road in Bloxom pleaded guilty to receiving stolen property. Judge W. Revell Lewis III withheld judgment and ordered a presentence report.

Ricky Drummond, 20, of Coal Kiln Road in Painter pleaded guilty to a count of stealing a car stereo valued at \$315 from Walmart in Onley on Nov. 15, 2010. He was sentenced to three years in prison, with all but 45 days suspended. Drummond also was ordered to pay restitution.

Clark Leslie Bowman, 51, of Edenton was sentenced to 10 years on each charge, to serve consecutively, with all but five years suspended. Jones said Bowman also was ordered to pay \$115,000 in restitution.

The defendant was paid the money by a waterfront homeowners' association in Jamesville. He was supposed to buy materials and erect a bulkhead. Instead he spent the money on other items, including a motorcycle.

Andre Lamon Harrison, 36, of Pine-tops, N.C., was sentenced to 10 years for credit-card larceny and 12 months for credit-card fraud, to run concurrently, with all but three years suspended.

Irving Alfred Stevens, 75, of Hampton, Va., was sentenced to 10 years for obtaining money by false pretenses, with all but 12 months suspended.

Two alleged robbers were arrested last week and charged in connec-

Harrison was arrested the next day. Both are being held in Accomack County Jail without bond, the sheriff added.

Wildlife Habitat Preserved

The recent acquisition of 88 acres in Northampton County is expected to lead to the protection and restoration of one of the world's migratory songbird hotspots, as well as a reduction in nitrogen runoff entering the Chesapeake Bay.

The property will be owned by the Virginia Department of Conservation and Recreation and managed as a state natural area preserve.

Located on the southern tip of the Shore, approximately three miles from the Chesapeake Bay Bridge-Tunnel, the property features natural wetlands, a freshwater pond, threatened secondary dunes and maritime forests that serve as habitat for migratory songbirds and other coastal species.

For decades, much of the land has been used to farm soybeans, corn and potatoes. Under DCR's ownership, the fields gradually will be converted to native shrubs and trees to reduce nitrogen runoff from farm fertilizers into the bay. The newly established vegetation will provide food and habitat for migratory songbirds and other coastal wildlife.

Funding for the acquisition was provided by American Electric Power, whose local utility subsidiary, Appalachian Power, serves a significant portion of western Virginia. The AEP funding was available as part of a mitigation plan required by a consent decree with the U.S. Environmental Protection Agency under the Clean Air Act to mitigate nitrogen runoff in the Chesapeake Bay. The purchase was completed in late September.

Sheppard and Jo Ann Davis, sellers of the property, had long shared a vision to conserve their land for future generations. They purchased it in 1984.

"We could have gotten 100 lots subdivided on it," said Sheppard Davis, who moved to the Eastern Shore in the late 1970s. "We chose not to because we knew it was an important ecological property. All we did was create 10 lots on the bay and left the rest."

"We always intended for it to remain in its natural state. It was, to us, a very important thing not only for our family but also for the wildlife."

The property is an addition to the DCR's Pickett's Harbor Natural Area Preserve and will be managed as part

of Virginia's Natural Area Preserve System, a designation that provides permanent land protection. Staff from DCR's Virginia Natural Heritage Program will manage the property.

"We were very pleased to acquire this outstanding property on Virginia's Eastern Shore and grateful to the Davis family for their long-term commitment to protecting the land," said DCR Director David A. Johnson.

Tom Smith, DCR Natural Heritage Program director, said, "DCR, working with many partners, has been focused on conserving through studies, land protection and habitat restoration, habitat in what is truly one of the world's hotspots for migratory songbirds. AEP's assistance was vital to this project. These 88 acres impact species from Canada to Latin America. That's success."

"With our long history of environmental stewardship, AEP and Appalachian Power are pleased to partner with DCR to increase and protect biodiversity along the Chesapeake Bay," said Charles Patton, president and chief operating officer of Appalachian Power.

The southern tip provides critical habitat for raptors, shorebirds, waterfowl and songbirds. An estimated 5 to 6 million neotropical landbirds and 10 to 12 million temperate landbirds pass through the southern tip during fall migrations.

Protecting the property was a top priority for the Eastern Shore Southern Tip Partnership, a group whose members have worked for more than 20 years to conserve wildlife habitat in the region. The partnership is composed of the DCR, Nature Conservancy, Virginia Coastal Zone Management Program at the Department of Environmental Quality, Department of Game and Inland Fisheries, Ducks Unlimited, Virginia Eastern Shore Land Trust and U.S. Fish and Wildlife Service.

"The Southern Tip Partnership has been a tremendously successful venture," said Laura McKay, program manager for the Virginia Coastal Zone Management Program. "Together, we've protected more than 24,000 acres of critical habitat that now provides the infrastructure for a growing ecotourism industry on Virginia's Eastern Shore."

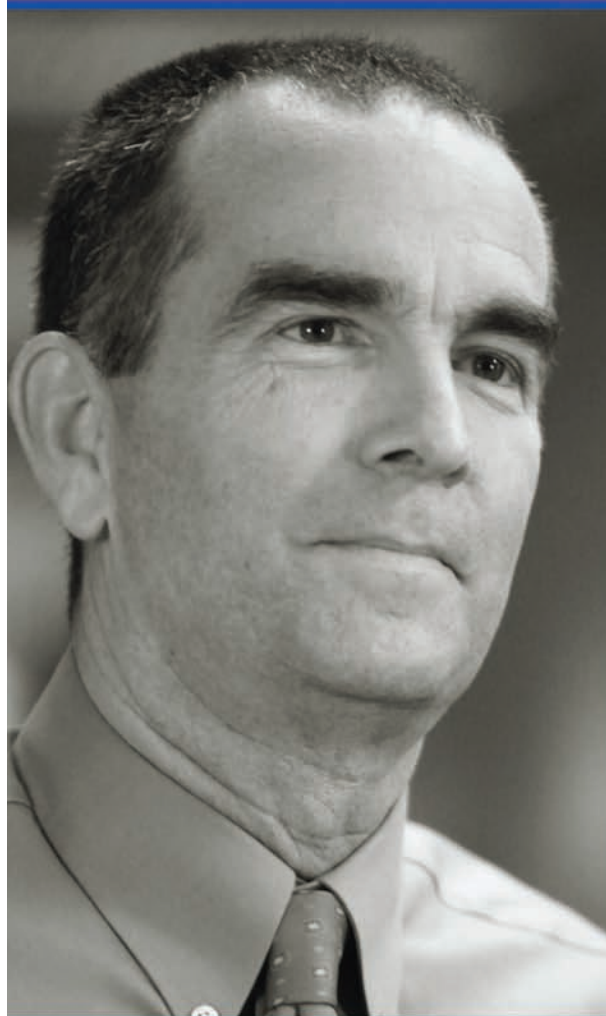

Onancock Improvements Suggested

“Live, work and play” were the focus of Onancock’s Marketing Committee, according to a report made last week to Town Council by group member and Councilman Kris LaMontagne. Making people more aware of the town’s many assets was the key.

Creating a town that will encourage people to live there and “invigorating pride in the community” was the first category. Enhancing commerce by bringing in new businesses with recreational opportunities for everyone also was listed.

“In order to facilitate the protection, the creation and the marketing of Onancock’s assets for the benefit of everyone, the town needs a plan,” the report stated. It was recommended that the committee be reorganized and new members be recruited for better representation. No action was taken by Council.

“Businesses should be encouraged to work together,” the report stated. “Everyone should be encouraged to continue to take pride in their property and protect these valuable assets so that the unique ‘look’ of Onancock is never lost.”

The report advises maximizing the Internet for promotion and paying attention to town aesthetics. “Insure zoning ordinances are in place and enforced,” it recommends. “Coordinate

look of town signs, plantings, banners etc. throughout the town” and “increase visibility of the police force.” Constructing sidewalks and bike lanes to Four Corner Plaza, and the proposed hospital and library “should also be included in the town’s planning,” the report says.

The committee suggests that business owners meet periodically to coordinate hours of operation and marketing events, and expand their hours between Sunday and Tuesday.

“Create a package for new and prospective businesses outlining what Onancock has to offer, use of the Enterprise Zone and how to link ... businesses to others,” the report continues. Training businesses to use the Virginia Employment Commission when hiring workers would enable the town to meet the requirements for the broadband grant, the report notes.

It also states that businesses need to be educated regarding Internet use, advertising and related opportunities; businesses that support boating should be welcomed; parking should be protected; and the local theater’s value should be noted. “Engage the Virginia Tourism Corporation to explore grant programs, partnerships and outreach,” the report suggests.

The report recommends more activities, including skateboarding, disc golf, geo-catching and dinner/cocktail cruises.

Blue Crab Harvest Board OK’d

The Virginia Marine Resources Commission last week authorized Fisheries Chief Jack Travelstead to proceed with his proposal to establish a blue crab harvest advisory board.

Commissioner Steven G. Bowman will choose the members with consideration to “crab gear users for all geographical regions of the state, as well as crab processors and packing houses.” Additional representatives will be chosen from environmental and academic communities and input will be received from the public.

“This panel will work on how the crab fishery should look over the next five, 10 and 20 years and how to achieve those goals,” the commissioners agreed. “To get started, staff will do a crab industry-wide survey to get the input of average watermen.”

Travelstead said this panel will not “supplant the current crab management advisory committee, which will continue to be very active in reviewing and making recommendations on short term crab regulation changes.”

The commission also voted unanimously to:

- open the fall commercial flounder season on Nov. 14 and increase the vessel landing limit to 10,000 pounds every 15 days and the vessel possession limit to 20,000 pounds;

The change will increase the cubic yards per dredge cycle from 65,000 to 100,000.

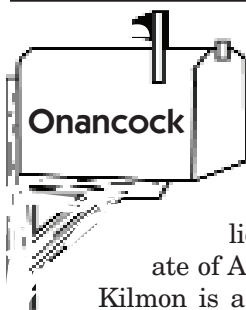

Onancock Activist Claims FOIA Violations

An Onancock activist complained to Town Council last week that his right to public information has been denied since August.

Charles Landis of Holly Street said this violation of the Freedom of Information Act (FOIA) involves his request for a copy of the town attorney/manager's employment contract. He also contends that Council should not have discussed a town policy in closed session.

Landis said a letter from Town Attorney/Manager Thomas Robinett, dated Aug. 17, 2011, advised Landis that the State Code exempts Robinett's contract from the FOIA. "As town attorney, he knew or should have known, this was not true," said Landis. "Virginia Code ... specifically states his employment agreement is not exempt from disclosure under FOIA," said Landis.

"The agreement Mr. Robinett posted on the town website is not his actual employment agreement," said Landis. "It is undated, unsigned, and his start date is July 1, 2011, not his actual start date, which was August 1."

"Prior to July 25, 2011, town policy required" Robinett "to reside in town," said Landis, adding that the purpose of the July 25, 2011, closed meeting was to change that policy. Landis contends the closed meeting was also a violation of the FOIA.

"If the date on which he signed his employment agreement is prior to July 25, 2011, then in effect the secret meeting had purpose or consequence to cover up a violation of town residency policy with a residence policy of personal interest and benefit to Mr. Robinett," Landis wrote to Council on Oct. 24.

That day, Landis addressed Council.

"I suggest ... Robinett deliver to me not later than close of business Tuesday, Oct. 25, 2011, a copy of his employment agreement including ... a signed letter stating the agreement is a true and only agreement ever entered into between Mr. Robinett and Town Council." He further suggested that "members of the Personnel Committee (Robinett and Council Members Kris LaMontagne, Richard Pearsall and Michelle Marsh) sign a waiver of disclosure exception for all correspondence between them relating to Mr. Robinett's employment agreement."

"If I have not received notice of decision on waiver by Nov. 1, 2011, I will consider it a decision by the Personnel Committee to continue to cover up violations of law and to deceive citizens of Onancock."

Robinett responded in a prepared statement he carbon-copied to members of Council, "I'm not sure why you are requesting a copy of my employment contract, as it was on the town's website, available for download, for at least two weeks. I'm certain you are aware of that. Nevertheless, I am forwarding a copy of the very same docu-

ment which was on the website, with the dates and signatures redacted for obvious reasons. The dates were also in my handwriting and the mayor's. I signed on June 16 and the mayor on June 23. Therefore, consistent with Virginia Code ... the requested record has been provided."

"Next, you have requested a letter from me stating that the enclosed contract ... is a true and only agreement." Robinett said that "the requested record does not exist in the hands of the town and therefore will not be provided," as is allowed by state law,

Robinett also said Landis requested "a waiver of disclosure exception signed by me and various members of council." He said that also "does not exist in the hands of the town, and ... will not be provided."

"Lastly, I note that the invoice I sent you last August for previous FOIA documents remains unpaid," Robinett wrote to Landis. "Please note that, although I am providing you with a response to this request," law "expressly provides that a request for further documents may not be processed until this invoice is paid if it is more than 30 days old."

A Message from Dana T. Bundick, Accomack County Treasurer

I am honored to have served the citizens of Accomack County as Treasurer for the past 16 years. Having served in this capacity with honesty, dedication to the job, and to the fair treatment of all of our citizens, I feel I must address some of the accusations that have appeared in recent articles.

The process of collecting taxes for the county involves cooperation of several offices within the county government, including the Commissioner of the Revenue, Finance Department, County Administrator and others. At times the many county departments do not communicate effectively, which can cause relatively simple processes to become inefficient. For example, the Treasurer's office depends on information from the Commissioner of the Revenue and County Assessor in order to create bills and notices. When this information is not exchanged in a timely manner, tax bills and notices may be delayed.

The comment was made that the order in which delinquencies are collected is to start with unimproved lots and out-of-state owners prior to sending the delinquencies of local homeowners. This has always been my practice, as a way to give fair warning to homeowners. When the collection attorney advertises properties in the newspaper, this often catches the attention of homeowners, many of whom contact us and begin paying toward their delinquencies. When a residential property has to be sold for delinquent taxes, I personally visit the homeowner or tenant to make sure they are fully aware of the situation. This collection tool has resulted in over 600 properties being sold and more than \$2.4 million being collected.

Collection rate percentages, that appeared to compare unfavorably to other counties, included delinquencies that are participating in payment plans. These should not be included in the uncollected percentage figures, according to the Administration. When the payment plan numbers are removed, Accomack County's collection rates are in line with other counties.

Budgets to purchase needed software applications and equipment to improve processes must be approved by the Board of Supervisors. Many such requests from the Treasurer's office have been denied, particularly in recent times of our weak economy. During this past term, I have requested the installation of electronic check deposit technology in order to deposit checks directly at the time they are received, and this request was denied by the Administration. Requests to eliminate decals were denied for 3 years, before finally being approved. Budget requests for postage cost increases, equipment improvements, and services to locate residents who do not provide their forwarding address all have been denied. I am happy to report that an electronic system to view and pay tax bills from the Internet has been approved and is already scheduled to be implemented for the June 2012 tax bills.

Most of the staff in the Treasurer's office have from 8 to more than 20 years of service in the office and are committed to providing excellent service to our citizens. Formal policies, procedures and job descriptions are in the process of being implemented, and I am seeking to fill the position of tax collector.

I am a lifelong resident of Accomack County who is committed to serving the residents of Accomack County. I will use all of the tools available to me to collect your tax dollars and will treat everyone fairly and with integrity. I will provide quarterly updates of public information regarding tax collections to the local media in order to keep citizens informed of the activities of the Treasurer's office. I look forward to serving the citizens of Accomack County as Treasurer for another four years.

Bundick said she'd start attaching income tax and lottery winnings, take out court judgments and continue to collect and expand wage attachments and vendor checks.

Duncan, a former car salesman and chicken-plant manager, said that if elected, he would create job descriptions in the office, respond in a more timely manner to complaints, get out quicker delinquent notices, educate the public and make better use of technology, including linking the treasurer's website to the county site.

Duncan also said he would try to work with those whose salaries are being garnished instead of taking more than 25 percent of their paycheck even though that is allowed by law. "I don't want them to go home with a dollar" he said.

Bundick defended that action used on county employees because notices went out in earlier paychecks. "It's not like it was a surprise," she said.

Both candidates said they would investigate the lockbox method, a faster way to deposit payments. Bundick defended her use of an out-of-town at-

torney for real-estate sales because he doesn't have conflicts with local residents who are his relatives or customers.

Duncan said he would find a way to use local lawyers and would treat everyone the same whether they live in the county or live elsewhere and own property here.

There are also three hot races for seats on the Accomack Board of Supervisors. CBES scheduled debates between those candidates for Thursday, after the Eastern Shore Post's deadline, so the Post will be unable to give readers a report of the events before the election.

In District 7, Emory F. Hurst Jr. of the Cashville area is challenging Vice Chairwoman Laura Belle Gordy of Onley, who has served on the board for about 20 years. Both are Independents. Onancock Mayor Bruce Paone and Troy J. Farlow of Onancock registered to run in that race, but both dropped out.

In District 9, Supervisor C. Reneta Major, a Democrat from Boston, who has been elected before but more recently was appointed to fill the unexpired term of Phil McCaleb, is being challenged by Wesley R. Edwards, an Independent, who lives near Craddockville.

District 4 Supervisor Sandra (Sandy) Hart-Mears of the Parksley area is seeking re-election as an Independent. Activist Kay W. Lewis of Lee Mont, who lost to Hart-Mears in the last election and is also an Independent, is challenging her.

The rest of the candidates in Accomack are running unopposed and include District 1 Supervisor Wanda J. Thornton of Chincoteague; District 2 Supervisor Ron S. Wolff of Assawoman; District 3 Supervisor Grayson C. Chessner of Jenkins Bridge; District 5 Supervisor John C. (Jack) Gray of Modest Town; District 6 Supervisor Robert D. Crockett (the county's former sheriff) of the Onancock area, who was appointed in January to fill the unexpired term of Steve Mallette, who resigned; and Commissioner of the Revenue Leslie Mears Savage of Parksley. All of those candidates are Independents.

Unopposed Democratic candidates include District 8 Supervisor Donald L. Hart of Keller and Commonwealth's Attorney Gary R. Agar.

A Special Election also will be held for a Wachapreague Town Council seat. There were no candidates to qualify for

that race, so write-in campaigns likely will be offered.

In Northampton County, Carol A. Glowacki of Nassawadox, who was seeking election to the Northampton treasurer's seat, has dropped out of the race. That leaves Interim Treasurer Cynthia S. "Cindy" Bradford of Exmore and T. Charles Renner of Franktown vying for the position. Both are Independents.

District 5 Supervisor Larry J. Trala of Exmore is facing opposition from former Supervisor M.E. "Betsy" Mapp of Jamesville. Richard L. "Rick" Hubbard of the Eastville area is on the ballot to represent the redrawn District 4. Yvonne Bagwell of Smith Beach is seeking that seat in a write-in campaign.

Commonwealth's Attorney Bruce D. Jones Jr., Commissioner of the Revenue M.A. "Anne" Sayers and Sheriff David L. Doughty Jr. are running unopposed.

Shorewide, Republican Ben Loyola is challenging state Sen. Ralph Northam, a Democrat. Del. Lynwood W. Lewis Jr., a Democrat, is unopposed in his quest for re-election.

Absentee ballots can be cast in person at the county registrar's offices until Saturday.

Tourists Leave Their Money Here

As Virginia realized a 6.7 percent increase in tourism revenue over 2009, the Eastern Shore shared in that success.

Gov. Bob McDonnell recently announced that visitors to Virginia generated \$18.9 billion in revenue in 2010, supported 204,000 jobs and provided more than \$1.3 billion in state and local taxes.

Despite a dismal U.S. economy, since 2009, Accomack County had a 5.5 percent increase in tourism dollars, equating to \$145 million.

Northampton saw an even higher percentage increase than the state, with an 11.2 percent upswing that translated into \$63 million.

"The increase in revenue from tourism is very encouraging," said McDonnell. "Tourism is an instant revenue generator and job creator for Virginia, which is why I continue to advocate for more resources for tourism marketing. Smart investments in tourism provide economic benefits to communities across the commonwealth and good

jobs for our citizens."

Both Shore counties realized a sizable increase in tourism revenue from local taxes.

In 2010, Northampton collected \$1.25 million in tourism-related taxes and Accomack \$4.5 million.

"These kinds of dramatic increases don't happen in a vacuum," said Donna Bozza, director of the Eastern Shore of Virginia Tourism Commission. "Because of our strong working relationship with Virginia Tourism and our local tourism partners, along with Accomack and Northampton counties investing regionally through the Tourism Commission, we are all able to reap the economic benefits of increased tourism dollars."

The Virginia Tourism Corporation receives this annual economic impact data from the U.S. Travel Association. The information is based on domestic visitor spending (travelers from within the United States) from per person trips taken 50 miles or more away from home.




"We are pleased to have tourism revenue trending upward," said Alisa Bailey, president and CEO of the Virginia Tourism Corporation. "However, the economy continues to pose challenges for visitors and our industry. We'll work with our industry partners to build on these positive gains, increase our marketing efforts and bring more visitors to Virginia."



He was born on the Shore, reared on the Shore, and played a lot of baseball and basketball for old Onancock High School. He hunted and fished on the Shore. During the summers, he mated on a charter boat out of Wachapreague. He is third-generation Eastern Shore.

Ralph Northam graduated from VMI where he was a battalion commander and president of the Honor Court. After graduation from medical school, Dr. Northam, as a military doctor, tended to wounded soldiers overseas during the first Iraqi war.

Since leaving the military after eight years of duty, Ralph has practiced as a pediatric neurologist at Children's Hospital of the King's Daughters, and also teaches as an associate professor of neurology at Eastern Virginia Medical School.

Ralph maintains a monthly clinic on the Eastern Shore to be more accessible to our children. He also consults for Eastern Shore Rural Health. He has tended to and helped many a Shore child and their parents in his practice.

It is not unusual to see Ralph on the Shore, either with family, participating in charitable events, or helping to prepare the Little League fields at Onancock.

Since his election to the Senate in 2007, Ralph has certainly been a dynamic force in the General Assembly. When an issue arises, Ralph Northam does not put his finger into the wind to see how the political winds are blowing so as to pad his re-election chances. He calls it like he sees it and that is refreshing!

In 2009, Ralph sponsored the Virginia Indoor Clean Air Act which established a statewide ban on smoking in restaurants. In 2010 he sponsored a bill developing guidelines dealing with student athletes and concussions. He voted in 2011 to restore some \$75,000,000 in funding for our public schools. He has worked hard to insure funding for the Spaceport at

Wallops Island and high-speed Internet broadband infrastructure, so as to stimulate economic development and jobs on the Shore.

Ralph also has been diligent in protecting the Chesapeake Bay and its resources, consistent with his upbringing. In 2011, he co-sponsored a bill eliminating phosphorous runoff into the Bay.

When necessary, Ralph has no reservations about crossing party lines when it is to the benefit of his district or the state. A few years ago, he broke a deadlock for a Virginia Beach judgeship and backed a Republican candidate because the vacancy was creating so much difficulty with the administration of justice in Virginia Beach. He took a lot of heat for his stance from his party.

My greatest admiration for Ralph, however, comes from something that he was not able to accomplish. A sustainable level of menhaden is critical to the health of the bay and the fisheries so vital to the Shore. Menhaden are an integral part of the food chain, the only fish regulated by the General Assembly, as opposed to the Virginia Marine Resource Commission. Ralph, along with some members of the General Assembly of both parties, attempted to change that. The General Assembly has refused to approve the change.

I have practiced law on the Shore for some 43 years, serving as Accomack County commonwealth's attorney for some 12 years, Accomack County attorney for probably 10 years, and Chincoteague town attorney for over 20 years. I personally know the importance to the Shore and its issues of government leaders, as well as private citizens, of being able over the years to pick up the phone, or walk into the office of a representative who has personal knowledge of the Shore and most likely those issues — a Bill Fears, a George McMath, a Bob Bloxom, a Lyn Lewis, or a Ralph Northam.

You don't have to explain where Cashville, Clam, or Capeville is located.

I would hope Shore citizens will give strong consideration to Ralph Northam. It would be devastating to lose one who has achieved so much in his 52 years.
