## Stolen County Laptop Saga Continues ...

The Virginia Department of Motor Vehicles (DMV) will not terminate Accomack County's access to its data system despite the fact that the county stored sensitive data on an unencrypted laptop computer, thereby violating an agreement with the agency.

In a letter to county Finance Director Mike Mason dated Oct. 22, DMV Commissioner Richard D. Holcomb wrote, "It has come to my attention that a laptop ... under the control of your department was stolen and that the contents of the laptop ... included personal information belonging to many DMV customers ... some if not all of the personal information may have been obtained from the DMV."

"I learned of this incident not from you or anyone in your department, but because a number of Accomack residents ... came into our Onancock Customer Service Center to see if they needed to get new driver's licenses," Holcomb continued. "You have ... entered into a number of agreements with the DMV ... to permit your department to access DMV records through electronic means."

DMV's security policy states, "Sensitive data is not to be stored on a laptop computer without

substantial business justification and unless the information is encrypted," he wrote. "To my knowledge, no such justification was determined and the information on the laptop hard drive was not encrypted."

"You further agreed that 'information received from DMV will be kept in a locked and secured location available only to authorized users,' " Holcomb wrote. "You agreed 'to report any incidents of non-compliance with the terms of this agreement immediately upon suspicion or detection thereof to the DMV contract specified in the agreement.' You failed to do so."

Names and Social Security numbers or DMV customer numbers "cannot on their own be used to conduct DMV transactions" because additional information is required, Holcomb wrote.

"While I remain deeply concerned about this incident ... I have decided not to terminate your access ... at this time provided you and your department are fully cooperative with DMV personnel in their efforts to ascertain that your office has taken all necessary corrective action and that DMV information will be secure in the future," Holcomb added.

Mason answered on Nov. 2, "Let me assure

you that no one is more deeply concerned about this issue than myself and the rest of our response team, most of whom have sensitive data we suspect was on the laptop that was stolen."

"We have been working diligently to notify all those who may be impacted ... and to provide answers to their questions," Mason wrote. "We have mailed thousands of letters, set up a call center to help citizens through this ordeal and have published a list of frequently asked questions. I want you to know that we are doing everything possible to keep the public informed."

"I was not aware that sensitive data was resident on that device," Mason wrote. "It was not common practice for sensitive data files to reside on a laptop. We only learned of their existence upon review of our data archives. This review was conducted shortly after we received notification that the laptop was stolen. If I had known of their existence, they would have been removed immediately."

Mason further noted, "The majority of the data was obtained from a query of the county's personal property software system data tables.

# No Action Taken on Jail

The Northampton County Board of Supervisors delayed action Wednesday on what to do about stabilizing or retrofitting the 1899 and 1914 jail structures located on the Courthouse Green in Eastville.

Engineer Thomas Wells Jr. presented several alternatives. Proposed renovations or stabilizations to the two structures ranged from a low of \$34,000 to demolish the two structures, to just over \$230,000, which would include renovation of both buildings as well as extensive landscaping of the Courthouse Green.

Several area residents expressed concerns over demolishing the structures. Retired educator Jerry Doughty spoke of the historical value of both structures. Doughty, who currently works at the Barrier Islands Center, said that once the buildings were razed, it would create a horrendous void in what was once the center of government for the county.

Tommy Rayfield read a letter

from former county resident Robert Burton in which he stated the need to retain the buildings, as they are part of the history of the county over the past 400 years.

Johnny Stevenson likened the loss of the two buildings to a beautiful smile that would be destroyed by exposing missing teeth. She noted that artifacts, including the former whipping post and a slave measuring stick, both of which were once used on the Green, are still preserved on the site.

Joan Wehner echoed the other speakers in an effort to get the supervisors to allocate the funds to stabilize the buildings.

Granville Hogg suggested that while the buildings retain historical value for the county, it would be better to find outside sources of funding to renovate them. Hogg indicated that the funds could be better spent on other county needs, while letting a private enterprise

## Island Restaurant Destroyed

The Chinese restaurant Great Wall II on Maddox Boulevard on Chincoteague Island was destroyed in a fire Monday night.

Denise Bowden of Chincoteague Volunteer Fire Company said the blaze was reported at about 8:20 p.m. When Assistant Chief Harry Thornton arrived two minutes later, "he found the structure fully involved," she said.

In addition to firefighters from Chincoteague, units from Atlantic,

Greenbackville, New Church and Wallops Island responded. Saxis sent its ambulance to stand by while rescue units from Chincoteague ran other calls.

It took between 10 and 15 minutes to control the fire, according to Bowden. An unidentified firefighter was taken to Peninsula Regional Medical Center in Salisbury, Md., to be treated for dehydration and heat exhaustion and was released later that night.

"It was a fast-, fast-moving fire," said Bowden. Firefighters used "two ladder trucks (one from Greenbackville and the other from Chincoteague) to fight it from the top of the building ... two walls are left standing ... the roof caved in," she said. Firefighters stayed on the scene for about two hours, Bowden added.

State police investigators are probing the scene to determine the cause and origin of the blaze.

Also damaged was a neighboring business, Glamour Nails.

The restaurant building was owned by Kruno Fillipic.

refurbish the buildings and possibly even use them to attract tourists.

Following a lengthy discussion, the board agreed to delay action for 120 days while allowing jail supporters an opportunity to locate an outside source of funding.

The board currently has funds set aside to stabilize the buildings.

In other business, Eastville Town Council presented a request for a boundary adjustment that would enlarge the town's borders to the north and south. Much of the property that would be added is in the town edge. While Eastville cur-

rently provides most of the items the supervisors consider to be important for a town to offer citizens who might be included in any boundary change, the supervisors resoundingly voted against the proposal. Supervisor Richard Tankard indicated that he opposes any town taking in agricultural land. It will be left to Eastville Town Council to decide whether to pursue the boundary adjustment by other means, such as annexation, or to wait and re-evaluate after the 2011 election of supervisors.

County Administrator Katie Nunez provided a brief update on efforts to obtain grant funding for public wastewater. The supervisors reviewed a grant application for \$250,000, which would go to-

ward the \$11 million cost of a wastewater system in and around Cheriton. As proposed, the wastewater would be pumped to the plant now under construction in Cape Charles. Tankard questioned the need for public wastewater treatment in that area, noting that he does not agree with statistics provided regarding the number of failing septic systems. The board voted 4-2 to allow Nunez to submit the application. Supervisors Tankard and Spencer Murray cast dissenting votes.

By a 4-1-1 vote, the supervisors agreed to advise applicants for Agricultural-Forestal Districts (AFDs) that they should not assume the county will automatically approve their request. Supervisor

Sam Long abstained from the vote, while Tankard voted against it.

During the public comment session, resident Nikita Coles, speaking on behalf of Citizens for Social Justice in the Bayview area, told the board that the group has been working to pay back taxes and fees owed to the county. Coles noted the value of the area to the county's tax base. Several parcels in the Bayview area have been sold recently at auction to recover back taxes for the county.

A final discussion of the evening surrounded a request by Shore Christian Academy in Exmore for tax-exempt status. Prior to making a decision on the issue, the board wants to determine how other non-public schools are treated for tax purposes.



# AUTUMN DRIVING CALLS FOR VIGILANCE

Fall is the picture-perfect time of year when many drivers take to the road to view the autumn colors. The leaves are beautiful to see, but when wet or in piles on the roads, they present driving hazards unique to the season. The Car Care Council reminds drivers to prepare for fall driving conditions by having their vehicles' tires, brakes and wipers checked before heading out on the road.

"Drivers should be aware that wet leaves on the road surface can make stopping difficult, and

piles of leaves can obscure potholes, curbs and streets," said Rich White, executive director, Car Care Council. "Add to these hazards the fact that road conditions can change from ideal to miserable in a matter of minutes, and what you have is a potentially dangerous situation."

Tires can affect the car's ride, handling, traction and safety, and are a critical connection between the car and the road in all types of driving conditions. To maximize tire life and safety, check the inflation pressure and the tread depth, and inspect the sidewalls for cracks or punctures. As a general rule, tires should be rotated every 6,000 miles and balanced.

The brake system is the car's most important safety system. Brakes are a normal wear item

for any car, and brake linings, drums and rotors, as well as brake fluid, should be checked at each oil change.

To help ensure the performance and safety of wipers, blades

should be replaced every six months or when cracked, cut, torn, streaking or chattering. Windshield wiper fluid should be checked monthly and only washer fluid should be used.

## Northampton Grand Jury

Eight county residents were indicted Monday by a Northampton County Grand Jury on charges ranging from destruction of property to abduction.

According to Commonwealth's Attorney Bruce Jones and information from court files, those indicted were:

- Bryan Keith Elliott, 33, of Cape Charles, on a count of possession of cocaine on Aug. 6, 2010;

- Juanillo Lorenzo Ibbara, 35, of Eastville, on a count of conspiracy to possess cocaine with the intent

to distribute it on Jan. 1, 2010;

- Ryan Patrick Long, 24, of Cape Charles, on two counts of assaulting a police officer and assault and battery on Sept. 19, 2010;
- Ivonne Luis, 50, of Jamesville, on 16 counts of welfare fraud;
- Robert Munguia Jr., 52, of Cheriton, on a count of felony destruction of property July 3, 2010;
- Eddy Jo Powell, 39, of Cheriton, charged with a third offense of larceny on July 10, 2010.

## Accomack Sheriff's Office

Two men have been arrested in connection with an armed robbery that occurred at Corner Mart in Oak Hall shortly before midnight Oct. 10.

According to Maj. Todd Godwin of the Accomack Sheriff's Office, "When deputies arrived at the scene, it was determined that two suspects had entered the store and robbed the clerk of an undisclosed amount of money and property." Both fled on foot prior to the officers' arrival, Godwin said.

On Nov. 2, Dijon Ryheem Smith

of New Church was arrested and charged with robbery and use of a firearm in connection with the incident. He is being held in Accomack County Jail without bond.

On Nov. 9, Denzel Maurice Timmons was arrested by the Chestertown, Maryland Police Department. Timmons is currently incarcerated in Kent County Detention Center awaiting extradition to Accomack County.

## Accomack Circuit Court

Two county men were sentenced in Accomack Circuit Court last week to a youthful offender program for attempted robbery and related charges.

According to Commonwealth's Attorney Gary R. Agar, Rory Tomlin, 19, of Melfa will serve in the program for convictions of attempted robbery, maliciously shooting at an occupied vehicle and use of a firearm.

Davon Davis, 21, of Painter also was sentenced to the program. He was convicted of armed burglary, attempted robbery and use of a sawed-off shotgun. The two men

could spend up to four years in the program. Davis' sentence will run concurrently with terms given in Northampton Circuit Court.

Anthony Turner, 54, of Painter was sentenced for distribution of cocaine to 10 years in prison, with all but a year and eight months suspended.

Cathy Jones, 45, of Onancock was convicted of welfare fraud and passing bad checks. Sentencing was deferred until a presentence report is prepared.

## Cape Charles Developer Charged

Former Cape Charles developer James C. Alberts, who built high-end condos in a restored building on Mason Avenue and constructed other luxury homes in the area, was charged recently with conspiracy to commit bank and wire fraud and forfeiture in U.S. District Court in Norfolk.

The charges involve nearly \$2,816,000 in mortgage financing and funding. In addition, the 45-year-old New Jersey resident and native has yet to be tried in Northampton Circuit Court, where he was indicted for several dozen counts of fraud in 2008. He is free on \$10,000 bond.

Alberts is now employed by the Poll Restaurant Group in New York City, according to Norfolk court files, which note, "Alberts ... and other uncharged conspirators, unlawfully and knowingly ... conspired ... to commit one or more" offenses from September 2005 to September 2008 "to execute and at-

tempt to execute a scheme ... to defraud various financial institutions and to obtain ... assets owned by and under the custody ... of said financial institutions, by means of materially false and fraudulent pretenses. ... Alberts would falsely certify to financial institutions including Bank of America, Fulton Bank, SunTrust Bank and other lenders that subcontractors had been or would be paid in full for services and materials provided on certain residential construction projects."

The Northampton charges involve 54 counts of intent to defraud by misusing funds intended to pay for labor and supplies between September 2006 and April 2008. There are also 14 counts of obtaining money by false pretenses between September 2006 and August 2007. The second set of indictments includes 12 counts of intent to defraud funds. A third set of indictments was for seven counts of intent to defraud funds and one count of obtaining money under false pretenses.

# Should Cats Prowl Without a License?

According to the wall plaque at Marie Bonawell's Bloxom home, "Cats are Like Potato Chips, You Can't Have Just One." But will the phrase ring true if Accomack supervisors require owners to get their felines licensed?

An e-mail survey conducted by the Eastern Shore Post showed mixed reviews on the subject, with some fearing the fee would mean more homeless cats. Others said tagging the animals would cause them to get caught in the brush. Still, several seem to think the proposal would miraculously solve the feral cat population problem. The county already requires dogs to be licensed.

"I wouldn't mind if I believed that all cats would be licensed and thereby checked for rabies vaccinations," said Betty Taylor of Chincoteague. "I have an elderly neighbor who feeds a dozen or more cats. They are flea-ridden and have no shots and they move freely about the neighborhood at night." Taylor is afraid of getting "rabies from petting my cat who had physical contact with an unvaccinated cat — just a bit of saliva on her coat would do it."

Since 1997, Northampton has required cats and dogs to have licenses. Treasurer Ilva James said there were 54 female, 87 male and 556 unsexed 2010 animal licenses issued. Janice Williams, the county administrator's assistant, said, "The current budget has a \$6,000 line item for animal license revenues but it's not broken down by species."

Taylor said. "If the county will protect all county residents from rabies, it would be well worth \$10. But the revenue will probably be used to cover the costs of their most current snafus, perhaps laptops and credit bureau costs."

"I think there is going to be a very sad outbreak of cats hanging themselves," wrote Jo Ellen Ellis of Bloxom. "Cats are climbers. Dogs are not. We put break-away collars on our cats, they are usually lost the first day."

"What a ridiculous idea," Deb Gilmore of New Church wrote. "How will it be monitored, especially if it is a 'house cat'? How does it apply to stray cats that live in the woods? Maybe the county supervisors should pay more attention to health, education and jobs and take less trips on the people's nickel," she said.

Cats "are easier to care for than dogs; therefore people usually own more than one," Bonawell said. "There are also a lot of stray cats. Who is going to pay for their tags? I think the cat license is a crazy idea ... what is next? Licenses for raccoons?" she asked.

"I have never been thrilled about the licenses for dogs," said Cheryl Comstock Williams of Onancock. "I am less thrilled about the cat license. I am curious as to where the tax money will be going. I am guessing animal control ... when do the people doing the right things stop paying for those who don't?"

"What next? The goldfish, the hamster or better yet, your stuffed animal collection?"

wrote Kay Lewis of Lee Mont, who worked in Northampton for more than 33 years. "Cats ran free everywhere, especially near the dumpsters. I am sure that the majority was unlicensed ... cats are a different breed of animal. They are not the dogs that come when called or sit on command. Many of them could hardly be called man's best friend or anyone else's. I know all this because I have a psychotic cat."

Supervisor Wanda Thornton called the proposal "(Supervisor) Ron Wolff's Cat Tax," not supported by the whole board. "I cannot support this," she said. "We don't have enough personnel to keep up with dogs, let alone cats."

Wolff said he brought the issue up after a Health Department spokesperson reported an increase in rabies cases.

Linda K. Smith of New Church said, "What will the county think of next to get money out of taxpayers? Since many people feed and care for cats out of kindness, it would be a shame to jeopardize that."

Charlie Ross of Belle Haven said, "As a counter proposal why don't the supervisors do the right thing and forgo their lavish health care plan? We are one of the poorest counties in the state; yet these folks get free health care as a perk."

"I have a major concern about collars," wrote Barbara Thackray of Chincoteague. "Both my cats roam in the woods and keep vermin down, but collars could catch on a vine or branch and either strangle them or cause them to starve."

Dr. Vicki Koenig of Exmore thinks licensing is "great. If the money goes to SPCA and/or other animal shelter, even better," she said. "People sometimes forget that rabies is a very real threat ... to have an unvaccinated cat is criminal. Even indoor cats get out occasionally ... I like the reduced rate for spayed and neutered animals."

"I would take it one step further and not allow people to have a license without having their cats spayed or neutered," wrote Melinda McPeck of Cape Charles. "Cats are not 'temporary' or 'disposable' ... pet ownership comes with serious responsibilities ... it is not too much to ask someone to obtain a \$5 license for their pet. The ordinance should have a provision that addresses feral cat colony caregivers."

Judy Reasonover of Modest Town said, "I think it is a good idea. There are too many people that have animals, not pets, and are not responsible for anything except feeding them ... I don't own a dog or cat but I still have to clean up dog poop out of my yard. Yes, it aggravates me, but there is nothing I can do about it."

Emily Brothers of Assawoman wrote, "Too many kittens and cats are already dumped by ignorant, hard-hearted people. I would rather see a plan in cooperation with groups already working with abandoned cats to sterilize and give rabies shots. This service could

be offered to all cat owners. All would get tags. Forget about cats wearing collars."

"As for those that are feral, perhaps Mr. Wolff could organize a posse to round up all the feral and abandoned cats for fixing and rabies shots," Brothers wrote. "As to who would pay for the licenses, maybe jars could be put in stores for public contributions for the common good."

Will Tucker of Chincoteague said, "I believe if enacted ... it could help control the cat population. The problem is deciding who, if anyone, actually owns the cats. I see many of them just hanging around. Would a property owner be held responsible for the tax because they may be feeding a hungry animal?"

Martha Simpson of Parksley said, "It's about time! Parksley is over-run with cats. Why should cat owners be exempt from licenses? Cats should not be allowed to run free either."

## ~DMV Response~

The intent of that query was to identify taxpayer names that were incorrectly formatted as a result of a recent software conversion. The data extracted contained names and Social Security numbers of most county taxpayers including those that have taxable property other than that which is registered with the DMV.”

“The data file did not contain any vehicle specific information such as vehicle identification numbers, title numbers etc. I certainly acknowledge that most of the data in the county’s personal property system is obtained from the DMV but there are other sources as well. I viewed this as a breach of county data and not that of DMV data because of where the data was extracted from. With that said, I sincerely apologize that the DMV was not contacted sooner,” Mason wrote.

“I am personally sorry for the inconvenience this has placed on

your agency and am grateful for the assistance you and your employees have provided to our citizens in their time of need,” he continued. “Rest assured that we are taking the necessary steps to avoid a repeat occurrence. We have implemented immediate emergency actions to secure both devices and ordered data loss prevention software and will be requesting a security audit to identify potential areas of risk.”

On Tuesday, County Administrator Steve Miner updated a “frequently asked questions” list. “To our knowledge there has been no loss or claim of loss that would give us cause to believe that any data has been compromised,” he noted. “There have been no attempts to defraud any persons that have resulted from the theft. ... We have received approximately 500-600 calls. Of those, we have had seven reports of suspicious activity on existing credit cards or bank accounts, but no attempts to defraud any persons through the creation of new credit accounts. There was

no existing credit or bank account data on the stolen computer. So it is not credible to believe that the reports of fraud on existing accounts would have resulted from the computer’s theft.”

“In reality, if your personal identity is lost or stolen, you may never know if or when the risk ends,” Miner wrote. “Practically speaking, however, with the passage of time and no attempts to use the data are noted, it becomes more likely that there is no problem. The county will continue to monitor calls relating to the situation. The county attorney’s office has been assigned to investigate all calls relating to instances where fraud is suspected.”

“Several citizens have paid for fraud protection services” and some “have requested reimbursement,” Miner wrote. “We have no established funds with which to reimburse these costs.”

According to Miner, “Some data that may have remained on the computer was extracted from other sources, including the state DMV

and Game and Inland Fisheries, and was installed into Accomack County tax billing and collection software. The data contained some names, which simply didn’t have a connection to Accomack County, for any known reason. We have talked with the DMV and they strongly feel that their staff does not commonly make the mistake of entering the wrong locality when registering vehicles.”

Miner cited “mistakes made by car dealerships which register cars for customers and put the wrong locality codes in the registration.” He also said, “boat and RV dealers ... mistakenly register sold vehicles in the wrong locality” and “others with access to the data set or the files from which it is created” make errors.

“It is impossible for users of the system to remove an entry, so even if you have left the county or no longer should be taxed, the system user can only mark your data as dormant,” he wrote. “It will not produce a bill but continues to reside, silently, within the data set.”

# Shore Declared Disaster Area

Gov. Bob McDonnell has announced that the U.S. Secretary of Agriculture has designated 59 Virginia counties, including Accomack and Northampton, natural disaster areas because of reductions in farm production caused by drought and excessive heat this year.

These disaster designations make farmers eligible for low-interest loans and any supplemental relief that might be provided by Congress in the future.

Disaster declarations make farm operators in both primary and contiguous areas eligible to be considered for low-interest emergency loans from the Farm Service Agency (FSA) of the U.S. Department of Agriculture (USDA), provided they meet certain eligibility requirements. This assistance includes emergency loans and the Supplemental Rev-

enue Assistance Program.

Farmers in eligible counties have eight months from the date of a disaster declaration to apply for emergency loan assistance. FSA will consider each application on its own merits by taking into account the extent of the losses, security available and repayment ability. Local FSA offices can provide affected farmers with additional information.



Dogs can't; why should cats?"

Diane Ames of Temperanceville said, "This change ... is needed. Cats should also be included in the leash ordinance. Cats carry just as many diseases and are now allowed to roam freely."

C.L. Marshall of Pocomoke/Sanford wrote, "I think it's about time. Discrimination runs rampant in the pet community. Dogs are held to a higher standard with licensing, required shots, leash laws, etc., while feral felines are allowed free reign over their yard, their neighbors and the whole neighborhood without repercussion. Cat owners should be held responsible ... and ... required to maintain control of their pets, the same as dogs."

"My dog is fairly well trained," he said. "He's a duck-retrieving machine. Let him out ... in the morning and a cat from three doors down is in my yard. My dog chases the cat, as dogs will do, and my dog gets busted." He further complained that a local boat ramp "boasting more than 50 feral felines became almost unusable due to this problem. Documented disease, negative impact to certain wildlife species and harm to property all are in play with such large populations ... plus there's county revenue in them tags."

James Price, a summer resident of Cape Charles, suggested that \$100 be charged for cats that haven't been altered.

Ina Birch of Melfa said, "My cats always lose their tags when they go investigating and it is difficult to keep cats from roaming. They are not like dogs."

Liz Omps of Onancock wrote, "I think the desperation of the supervisors for cash is evident in this preposterous behavior."

Greg Jones of Chincoteague said, "The main issue ... is that cats are seen as 'expendable' by too many people. They are allowed to go astray unvaccinated and without spaying and neutering. The result is a tragic amount of animals roaming sick and breeding more strays. The reduced fee for spaying and neutering is a step in the right direction, as is the required rabies vaccination. ... Would veterinarians be allowed to issue the licenses? This might bring more cat owners into the fold."

Irene Henderson of Nassawadox likes the idea of Accomack issuing cat licenses. The Northampton resident said, "I have three cats and all are licensed and have had their shots."

Laura Flournoy of Hopeton called the proposal "absurd! I personally don't believe cats should be considered domestic." She has 11. "When an animal can return to a wild state within its life cycle, is it truly domestic? Take all the cats and kittens thrown out on the side of the road or at green boxes or left in our marshes and wooded lots. Cats ... are very resourceful and within a week will be finding their own food either by scavenging or hunting and they will not seek human contact. ... Throw a ... dog out and he would starve to death seeking human companionship. Dogs are domestic. ... Will they try to tax birds next? ... Dog tax, I get. ... But CAT tax? NO!"

### Dr. Gubb Was the Answer

Dear Editor:

I have suffered chronic illness for over 15 years, with little explanation. Always in the back of my mind lingered the memory of tick bites, followed by unusual illness. In 2001, a severe tick bite occurred in Virginia Beach, which signaled the beginning of a whole new nightmare. In the years that followed, my life as I knew it would come screeching to a halt, but not before grinding me in to the ground, until finally there was nowhere else to go.

During this time, I relentlessly sought out medical attention. By 2007, I was deemed disabled as by then I was no longer able to work. I had been seen by a total of more than 50 doctors and specialists, and though some would eventually uncover one condition or another, it was never the solution. Most, however, would not even try. Some simply left me for dead.

The illusion that the medical system is there to help dies hard. I, like most people, was of the mentality that if you are sick, they are there to help; that if your issues or complaints are a mystery, they are naturally curious to investigate; and that if you have health insurance, all is possible.

I was wrong. That is, until Dr. Geoffrey Gubb. Dr. Gubb is one of those rare individuals who care to look outside the box if you do not fit into the standard textbook definition. He treats the individual patient. Dr. Gubb ran testing no one else had attempted, beyond tickborne illness, but certainly including those, which proved positive. He discovered and began treating conditions that no one else had even looked for and that explained why previous standard treatments for other illnesses, related most likely to untreated tickborne, had failed, and he actually did something about it. He tailored my treatment to what my body could handle and

ordered not only treatments for my multiple infections, but other medical protocols to help relieve my suffering and make the unbearable bearable, none of which included narcotics.

Dr. Gubb observed and listened and methodically, not recklessly, began to unravel the puzzle of my illness. He referred me to appropriate specialists when necessary. He worked to keep me safe in the medical system by ensuring that tests, procedures and treatments done outside his office were administered with consideration of my physical limitations.

It took years of medical neglect to get this ill, yet in the two years I have been with Dr. Gubb, I was beginning to make real strides. From my experience, I feel it would be virtually impossible to find such a doctor again.
