## Many Would Rather Clean Than Shop Today

It's Black Friday, aka Blitz Day. This 24-hour spread immediately following Thanksgiving is when most of America starts the search for the perfect Christmas present and the best bargain.

And while Eastern Shore residents may have full bellies and long gift lists, the majority will not be out shopping today.

According to results of an e-mail survey conducted by the Eastern Shore Post, more than 65 percent would rather clean the house, relax, put up the Christmas tree, watch football or do just about anything than fight the crowds.

About 13 percent will be working. Some of the remaining 22 percent will be serious enough about their task to get up before dark to take advantage of special deals.

Karen Simpson of Quinby is not in the latter group. "I wish to enjoy my shopping, not struggle with tons of people on the highway and in stores," she wrote. "And I certainly will not get up in the wee hours of the morning to attend early a.m. sales."

Her traditional activity on this

day is "eating fantastic leftovers. I will go shopping on the Saturday after Turkey Day," she wrote.

Annette Mills of Pocomoke, Md., said she would likely "stay home and wrap Christmas presents. Previously we've gone to Salisbury ... and window-shopped and watched everyone else ... while we have a cup of coffee. We try to have our shopping complete by Black Friday."

Steve O'Kusky of Maine, formerly Craddockville, said, "We NEVER go shopping on Black Friday. I used to and got really fed up with the crowds of mean, rushed, hateful people all trying to get the 'good deals' on that day."

"Holiday gifts are all bought already," he wrote. "I usually start shopping early in the year and hopefully will have everything bought and ready to be wrapped before November gets here."

"Still have some more holiday shopping to do," wrote Sandy King of Quinby. "Thank heavens for catalogs and the Internet."

Amanda Parker of Onancock is ready to go 'til she drops. "I plan on being on the road at 3:30 a.m. and

headed to Salisbury with my husband and best friend for a long day of SHOPPING!!!!"

"I work for the federal government and we generally do not get off the day after Thanksgiving," wrote Pat Dworske of Greenbackville. "This year I have taken leave for that day. I will be relaxing and doing a little shopping; probably at Salisbury."

Dworske is one of the lucky ones. She plans to spend what she did in 2008. "My income is stable, so I will probably do about the same as other years," she wrote.

Linda Regula of Machipongo is going with her daughter to shop "across the bay." They are "getting up at O-dark-thirty too!!! (I) used to put up the Christmas tree (on Black Friday) until my daughter talked me into shopping with her."

"With four children and a tight budget we plan on going shopping with a leave-the-house time of around 3:30 a.m.," wrote Robin Horne of Bloxom. "After shopping we decorate the house and tree."

"We will be using cash," she continued. "In this economy if we can't

afford to pay for it in cash, we will not get it. Our budget is set much lower this year. The company I work for has put us on furlough (on) Fridays, so less cash flow than last year. And the addition of a new baby girl ... need I say more?"

Chris Chandler of Norfolk (formerly of Onancock) said he will be doing "yard work and household chores" today. "I usually just enjoy the day off ... don't plan on being anywhere near a store on Friday."

Chandler said he probably wouldn't be spending as much for presents this year. "Number one, bonus will not be as large," he wrote. "Number two, just trying to scale back Christmas since the kids have gotten older."

"Times are tough," wrote Margi McCaleb of Craddockville. "We plan to buy a fish pond for a Third World country from all our grandkids from World Vision International."

Ed Bachmann of East Point wrote that he traditionally takes the Eastern Shore Artisans' Open Studio and Vineyard Tour on Black Friday. "On Saturday we will prob-

# County Considers Alternative Energy Projects

A solar energy project being planned for Tasley probably won't create a lot of jobs in the community, according to an Accomack official. But the investment and taxable property the project could bring are estimated at \$15 million to \$20 million.

Community Energy, a Pennsylvania company specializing in

wind and solar power, is proposing to fill the area with solar panels. Accomack Director of Economic and Community Development Larry Forbes said 400 acres east and 800 acres west of the Tasley overpass are proposed for the project.

"It's a great company, very well respected," Forbes said. "Working with the farmer ... it's a true benefit ... we've looked at it pretty carefully. We don't see any harm to the soil ... all issues are being taken into consideration."

Forbes said the location would allow the energy to be easily sold to nearby Accomack-Northampton Electric Cooperative.

"At a time when homegrown, pollution-free energy has never been more important, Community Energy is leading the way to energy independence and a healthy environment," according to the company's Web site.

The company is responsible for developing of some of the first utility-scale wind farms in the Northeast and the Midwest.

## Wind Study

Forbes reported last week to the Accomack Board of Supervisors that the National Aeronautics and Space Administration is putting \$600,000 toward the study of birds and wind turbines.

Alan Silverman of Onancock, an MIT graduate who is gathering information about wind power, is expected to address the issue when the supervisors meet on Dec. 16.

Forbes also told the supervisors about plans for a Meteorological Tower (also known as MET Tower) in Oak Hall. The towers are used to gather wind data necessary for site evaluation and development of

wind energy projects.

In other business last week, the supervisors informally agreed to stick to plans for spartan renovation at Accomack Primary. The officials are proposing that the former school be turned into offices for school workers now housed at the county administrative building.

But a no-frills renovation won't solve all the space needs.

The goal is for the county to stop renting 6,200 square feet and put the money into owning the space. The county needs an additional 3,800 square feet so that workers won't be cramped and there will be adequate room for storage.

Offices for the commonwealth's attorney and Departments of Parks & Recreation, Public Works, Planning, and Public Safety are all rented.

Howard Collins, an architect who studied the county's office needs, reported that the scheme would only free up 4,500 square feet.

"That's half of what is needed," he told the supervisors. "Some will go into the administration building, some will move."

Where the latter workers will wind up has yet to be determined.

"Storage gets put aside," said Collins. "Not many people talk about it." He said records and supplies are "loading attics," which were not made to hold the weight. In addition, when the school employees move into Accomack Primary, Sheriff Larry Giddens will lose storage space there. Some criminal evidence is already kept in a shed outside the Sheriff's Department, Collins said.

The Health Department needs an expansion of about 3,100 square feet, he continued.

County Administrator Steve Miner said a structure could be built on Onancock Fire Department property for public safety workers. The price, he said, would beat anything that could be done by the county.

Revamping the primary school would include a six-month design phase, two months to acquire bids and between 12 and 24 months for construction, said Collins.

Supervisor Jack Gray, a former School Board member and Arcadia High School principal, suggested that the renovation include "bare-bones" work that would bring heat and air-conditioning up-to-date and promote safety.

"When the two middle schools were built, the architects were paid a flat fee, not the more it costs the more the architect gets," Gray said. "Money needs to go to the most important thing ... teachers' salaries."

Collins said Superintendent Rick Bull also talked of a modest approach to refurbishing the building.

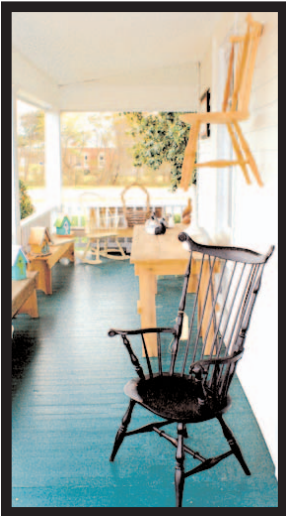
## Off-Shore Wind Leasing

Supervisor Phil McCaleb was unanimously appointed to serve on a state task force that will recommend areas and timeframes for offshore wind leasing.

The Department of Minerals, Mines and Energy (DMME) is putting the panel together, according to a memo sent from Elaine Meil of the Accomack-Northampton Planning District Commission to Miner.

"Two companies that are looking at areas off of Virginia Beach" prompted the DMME to look into the ventures, Meil stated in the letter. "They are intending to have the first meeting Dec. 8 in Virginia Beach."

ably check out the Chincoteague craft show and ride around Assateague Island."

He also expects to spend the same as last year for gifts. "Might spend more if Mama Girl (an artist on the tour) has something neat for the grandkids," he wrote.

Lynn Gillingham of Onancock also said she'd be checking out the art. "The artisan tour has been tradition for the past three or four years. Prior ... we did anything we could to stay as far away from stores ... after a very bad experience ... at a Walmart a number of years ago."

"If I buy anything from the artists," wrote Gillingham, "I will pay with cash or check."

"We always eat leftovers on Black Friday. No special recipes. Everyone just digs in to make his or her own meals from what is in the fridge while the Thanksgiving cook takes a well-deserved break," she continued.

Terry Ann Ewell of Young's Creek has been "taking off on Black Friday since the inception

(almost 10 years ago) of the Cape Charles Historical Society Oyster Roast, which is held the Saturday after Thanksgiving.

"We put up the tent, hang the lights, set up chairs and tables, collect and set up items for the silent auction, do the prep work for the food, clean the pots and pans, haul wood for the fire, etc," she wrote.

Jean Ames said she and her husband "are spending Thanksgiving with our four children and their families which include our four little grandchildren. We are all staying with our son and daughter-in-law in northern New Jersey where they have recently moved."

"They live close to New York City," she wrote. "We are going into the city by bus on Thursday morning for the Macy's Thanksgiving Day Parade for the first time. If we survive ... I would like to go back on Black Friday and Christmas-shop in Midtown Manhattan at Macy's, F.A.O. Schwarz and the Disney Store. Hopefully some of our children will want to go as well because I know my husband will not want to!" wrote Ames.

"Yes, we will be spending the

same amount this year. Every year we have a set amount that we spend on our family," she wrote. "This year will be no different because we save up for it all year long. If sales are really good ... we may be able to get by spending a little less."

Jennifer L. Simpson of Exmore said she wants to spend the day putting up her Christmas tree. If she does do some shopping she won't be using a credit card.

"If I cannot pay for it, I can't afford to get it is how I try to look at Christmas now. It used to be charge it (and) I'll figure it out later, but those interest payments are not as low as they used to be." She'll be spending less this year.

"Most of my crowd is just giving to the kids ... and meeting for a great meal and some exceptional company" for Christmas, Simpson wrote. "It is usually way too busy for me on Black Friday weekend."

Deb Gilmore of New Church will be spending as much as she did last year. "Christmas is a special time and the gifts exchanged express our love, not our dollars."

Betty Armstrong of Belle Haven wrote, "We're trying to celebrate the

holidays in a more appropriate way — concentrating more on family fun and fellowship instead of gifts."

Does this differ from other years, the questionnaire probed? "Only to the degree that we're spending less money and putting even more emphasis on the true reason for the season," wrote Armstrong.

"I don't work on Black Friday," said Donna F. Belote of Onancock. "Our family from out of town comes for Thanksgiving and not Christmas. So the females get up early Friday morning and start shopping. We usually end up at Salisbury and eat at Red Lobster for lunch. We exchange our gifts but don't open until Christmas. Then we all come back to our house Friday night and eat leftovers. I use cash or check. We are trying to cut back this year," Belote wrote.

"Heck no," said Thomas Rakowski of Melfa when asked about going shopping today. Rakowski is going to play golf. If there's any food left he'll eat a turkey sandwich. Will he spend as much money on the holidays as he did last year? "No, don't want to go into debt," he wrote.

# Classic Guitar Donated for School Band Fund-Raiser

Mike Henry, the band director for Northampton High School, has announced that Paul Reed Smith, founder and maker of the world-famous PRS Guitars, has donated a \$5,000 PRS 20th Anniversary Electric Guitar to Northampton High School Marching Band to help in its fund-raising efforts.

In October, the marching band, under Henry's direction, began a fund-raising drive to replace the uniforms the band will need to perform and compete in the 2010-11 school year, as well as subsequent seasons. The recent donation by Smith will be raffled off to help in that effort.

"The band uniforms my students use now are about 30 years old and are seriously outdated," Henry said. "Paul's donation will help us get closer to the goal of outfitting our students in the manner and dress they deserve."

This marks the first year in nine years that there has been a

marching band at Northampton High School. There are 27 students in the band at the current time, and each new uniform will cost \$350. Henry estimates that the fund-raising drive will have to generate about \$10,500 to enable next year's marching band to enjoy new, modern uniforms.

"We started our fund drive in the beginning of October and thanks to the generous support of the community, we have already raised enough to buy 11 uniforms," Henry said. "The success we have enjoyed so far, along with the added support from Paul Reed Smith, is compelling proof that the marching band is important to many people and I am proud to be a part of this team effort."

The PRS 20th Anniversary guitar is electric blue and sports a mother of pearl inlay on the fretboard. It retails for \$5,000 and is a limited edition, sought after by the most discerning collector and play-

er. Smith began building guitars in the late 1970s, basing his early models on the famed Les Paul gold-top models. His guitars soon caught the eye of Peter Frampton and Carlos Santana and shortly thereafter became world famous.

Artists performing with PRS guitars include Ricky Scaggs, Brad Paisley, Orianthi, Aerosmith, and David Grissom. Even Taylor Swift (who, of course, plays a Taylor guitar) is accompanied by her lead guitarist playing a PRS.

The guitar will be raffled off in January. Tickets are \$5 each or five for \$20. Tickets will be avail-

able at Shore Bank in Exmore, the Yellow Duck in Exmore, A Cut Above in Exmore, and Wachina Co. in Exmore. The guitar will be on display beginning Nov. 30, 2009 at Shore Bank in Exmore. As Tuition Rises, so does Eastern Shore Community College's commitment to the Shore.

At the start of the fall semester, ESCC experienced a significant reduction in the level of funding it was expecting to receive from the state. At the same time, the college experienced an 11 percent increase in enrollment for the semester and currently is serving 974 students.

In spite of these budget cuts, the college has continued to work hard to ensure that the educational opportunities and services that it provides to the residents of Accomack and Northampton counties

will not suffer.

Recently, the State Board for Community Colleges voted to approve a mid-year tuition increase, effective for the upcoming spring 2010 semester. This increase of \$7.30 per credit hour will raise the cost of a credit hour for ESCC students from the current \$94.70 to \$102. The cost of a typical community college class will increase by \$21.90.

The tuition increase will help ESCC manage the budget cuts we have had to weather during this and previous years and allow us to continue to offer classes and support services that will help students reach their academic and training goals. Additionally, it will keep us from having to turn away students, as many colleges in other states have done.

While this was not an easy decision for State Board members to make, I support them in their efforts to help provide colleges with needed funding. ESCC staff has been exploring the potential impli-

cations of this increase on our students and believe that the majority of our students, many of whom are receiving some type of scholarship or financial aid, should not experience too much of a hardship in covering their spring semester tuition.

Last year the college provided students with approximately \$1.7 million in financial assistance through federal, state and local financial aid and scholarship programs. The college also has an interest-free, monthly payment plan to help students and families budget their college expenses. ESCC will continue to work earnestly to ensure that students have the financial resources to obtain the education they need and desire.

would accompany the program.

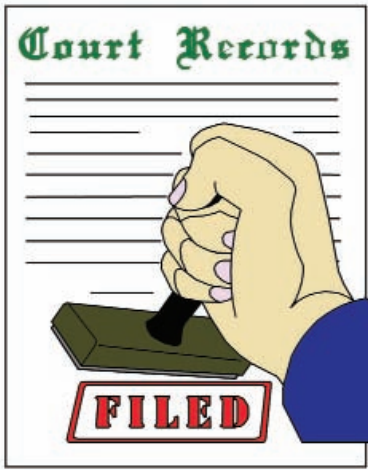

## Autism Program Expansion

Family Preservation Services, Inc., with locations in Oak Hall and Belle Haven, is in the process of expanding their Autism Program.

"Eastern Shore Faces of Autism" is a support group for parents of children in the Autism Spectrum. The next meeting will take place Dec. 3 from 11:30 a.m. to 1 p.m. at the Sage Diner in Onley. Family Preservation Services will provide lunch, but request that potential attendees call to register at 442-7690 or call Wendy Crockett at 709-0505.

Autism Program Director Linda Lust said, "We offer camaraderie and we also have a lending library. We are happy to assist parents in research online or otherwise."

In addition to the parent program, intensive in-home therapy is offered. The federally funded Medicaid program, which accepts patients up to 21 years old, focuses on behavioral analysis of families impacted by Autism Spectrum Disorder. The program is based on behavioral rewards that help increase function, according to Lust. Therapists work with the children in whatever setting is most conducive, whether in school or at home. Through behavioral training, upwards of 20 hours per week, they hope to increase adaptive function and communication skills. The therapists also consult with parents, caregivers and other therapists to arrive at the best form of therapy for the patient.

"Our goal is shaping behavioral therapy to increase function," said Lust. "I would love to see this program continue to grow and for its members to become fully functioning members of society."



In fact, the only delivery that I didn't make was to Captain's Deck Restaurant in Nassawadox. You know from recent articles in the Post that this wasn't because of the nor'easter, but rather a fire a few days earlier.

Like a lot of people, I couldn't believe it happened because the Captain's Deck was such a popular eating and gathering place. The Exmore Rotary Club, Cape Charles Lions Club and the Eastern Shore Fraternal Order of Police all hold their monthly meetings there, to say nothing of a steady clientele of regular din-

ers who meet there as well.

Plus, the owners (and husband and wife), Nuri Onal and Shellie Onori, support and give to local causes like Habitat for Humanity, Eastern Shore Literacy Council, Little League and more. So, it was more than a restaurant. It was a part of the community.

And, a part of my paper route, too.

"You're late," Rhonda Arrowood would always good-naturedly chide me whenever I arrived with my papers after 6 a.m.

"No," I would always smile back, "I'm doing my imitation of Dale Junior, coming in last."

Rhonda, I'd found out over the years, loves NASCAR racing and Dale Earnhardt, especially; so after I'd say this to her, she would say something like, "Don't talk about my boy that way," laugh (or sigh) and go back to being a waitress because that's what she was at the Captain's Deck.

Not just any waitress, as far as I'm concerned, but as good a waitress as I've ever seen. The first time I saw Rhonda waiting tables was 10 years ago at the old Paradise Cove in Melfa. She could take care of the whole place at the height of a breakfast rush, if she had to.

She could do the same thing at the Captain's Deck, too, if another waitress got sick.

"I'm so sorry," I said, calling her this past Monday because both she and the Captain's Deck stayed on my mind. "I really liked seeing

you and Nuri when I delivered my papers. How do you feel?"

"Sad," she answered, though not in a down-and-out way. "I miss my customers and not being able to take care of them. And I miss the cooks and everybody else there. We were all like family."

"The morning the fire happened I was getting ready for work and a neighbor who has a scanner called me and told me," she continued. "I got there about 5:30 a.m. and for the rest of the day I saw so many people and customers. It was so sad. We all cried."

Rhonda isn't going to look for another job right away because she doesn't like to change jobs.

"I started at Paradise Cove when I was 14 and stayed there for 20 years until it closed. So far, I've been at the Captain's Deck for seven years, and I'll wait," Rhonda added. "Nuri and Shellie do plan to reopen and if they plan to start again, I'd like to start again with them."

I called Shellie and Nuri on Wednesday morning and Shellie confirmed it is their intention to rebuild.

"Thank God, we had insurance," Shellie said. "However, it always takes awhile to get this kind of stuff straight. But when we do, we'll rebuild."

And, I'll get to deliver the Post to them again, nor'easters or not.
