# Retired Investigator Lt. Gerald Goga Loses Battle With Cancer

Gerald Goga quietly set the standards for all county law enforcement and later oversaw the investigations division at the Accomack County Sheriff's Office.

Goga retired last year after almost 30 years of service and was only 53 years old when he lost his fight with cancer last week leaving behind his family and fellow officers who loved him.

"Hiring Gerald as a deputy in 1989 was one of the best decisions I made as sheriff," Robert Crockett, a retired sheriff who now chairs the Accomack Board of Supervisors, said Sunday. "He was a dedicated public servant who always conducted himself in a professional manner and treated everyone with respect. He worked his way through the ranks at the sheriff's office, being promoted to lieutenant in 2005, in charge of investigations."

Before becoming a police officer, Goga served in the Army. He started his career in law enforcement in 1987 with the Chesapeake Bay-Bridge Tunnel. Goga was married and had four children.

For retirement, "He had no plans oth-

er than dedicating his time to family," his sister-in-law, Edean Bundick, said. "He just finished building his garage to house his 'baby,' (also known as) his boat. He was enjoying just being a husband, father, (and) friend."

"I never heard Gerald speak an unkind word towards anyone, nor anyone speak an unkind word against him," Crockett continued. "To be able to say that about anyone, especially someone in law enforcement, who made numerous arrests, speaks for itself. Gerald was a good and decent man and a man that I was proud to have known and served with."

That was the way everyone described Goga. For a while, just before retiring, he was put in charge of making statements

to the press and also handled that task in a friendly and professional way.

"I had the privilege and honor working with Gerald most of my adult life," Capt. Todd Wessells of the sheriff's office said in a eulogy this week. "Gerald could be described as laid back, genuine, humble, friendly, honest, patient, knowledgeable, and dedicated to serving his community. He took pride in his work.

He was a great mentor. It didn't matter if you were a correctional officer, deputy, trooper, town officer, or investigator, he

would stop what he was doing and give you a hand or advice if needed. Gerald gave 110 percent all the time."

"Serious calls would follow Gerald when we were either working our midnights and later when we were on-call supervisors," Wessells continued. "The only thing I could figure out ... was ... God wanted the best law enforcement officer on the case."

"Gerald was a professional. When he would have to talk to a victim or a victim's family, he was so sincere and it showed that he cared about their situation ... There are so many days I could talk about when Gerald faced danger whether it was dealing with an armed homicide suspect in Parkley, an armed bank robbery suspect on Jenkins Bridge, or assisting countless officers in dangerous situations," Wessells said. "He was always there, steadfast, and never hesitating. ... Deputies were still calling him asking for his opinion. ... That just goes to show the confidence and respect deputies had for him. Gerald was a great police offi-

**Parksley Woman Killed in Nelsonia Crash**

A 31-year-old Parksley woman was killed Sunday night in a two-vehicle crash on Lankford Highway in Nelsonia.

Shakiah Lolette Matthews, of Woodland Park Avenue, was driving a Honda Civic north on the highway, about a mile south of Nelson Road, when she ran into the grassy median and over

## Baby Can't Wait To Be Born

In the world of beer and babies, Zach Harmon, of Keller, will forever be known as the delivery man.

Not only does Zach truck brews-kis to your favorite local establishments for his job at a local distribution company, but in his spare time, he helped deliver a beautiful baby boy, his son, while parked on the side of Lankford Highway, in the wee hours of the morning, just a couple of weeks ago.

Braycen Adahy Le'von Harmon came into this world at 6:15 a.m., Oct. 18, in a field next to the Dollar General Store in Painter. The sun had not yet risen and the townsfolk were fast asleep.

The youngest member of the Harmon clan later weighed in at seven pounds, 10 ounces, and was 20 inches long. Braycen immediately made use of his lungs and was healthy and happy.

Just minutes before that, Fallon Harmon, who's due date was Oct. 23, told her husband, "We need to go." She

was ready to deliver.

Fallon went to the hospital the previous night but was sent home because she was still only a half-centimeter dilated, the same as she had been for about three weeks. They tried to time Fallon's contractions but the pains were too irregular to measure. As the night progressed the contractions started getting stronger but were never regular.

The pregnancy was considered high-risk because Fallon's firstborn, Damori Awan Lee Hopkins, was four months old when he died from multiple congenital defects. He was delivered at 30 weeks and weighed less than three pounds. The normal gestation period is 40 weeks.

When Zach was alerted that they needed to start driving, he threw a couple of bags in the car and grabbed a blanket and a pillow and off they went to Sentara Norfolk General Hospital, which is more than 70 miles away from their home.

The couple got as far as Painter,

two or three miles away, when her water broke. "And I felt that great pressure," Fallon said. "Zach asked me what I wanted to do. He pulled the car over and I hopped out. I could feel his head," she said of Braycen. "I could feel that I was ready to push. So Zach was asking me what he was supposed to do."

Fallon is an EMT for Northampton County. Zach is a volunteer firefighter in Accomack but when it comes to birthing babies, he hasn't even had a Lamaze class.

"Zach called 911," Fallon said. "The dispatcher was trying to give him instructions. He was brave but he was freaked out at the same time. He said he was praying the whole time that the ambulance would show up before the baby came."

"So the dispatcher instructed him to lay the blanket down and get me on my back," she said.

"I got on my knees and let gravity do its job. I gave a little push and Zach could see the head. And I gave another push and the head came out. And one more big push and he was out. Zach caught him."

"We were on the side of the road, in the southbound turn lane, in front of Dollar General. I was right in the field beside Dollar General," Fallon remembered. "I can't even imagine what those people (driving by) thought was happening. There was traffic. Nobody stopped. I'm glad I wasn't getting murdered. Only about a minute later, I could hear the backup alarm from the ambulance."

Moments after Braycen arrived, an ambulance was on the scene to rush the Harmons to the Riverside Shore Memorial Hospital in Onancock. "They loaded me into the ambulance and Zach cut the cord" with guidance from the rescuers.

"I'd do it over again," Zach said. "I was more nervous than scared. I wound up managing it ... Couldn't ask for anything better I can tell you that."

The couple also has another son, Tayden Ahanu La'Rue Harmon, who was born Feb 3, 2017, at Sentara. Alura Marie Harmon, 4, is Zach's daughter and Fallon's stepdaughter and often stays with the couple.

"If I do try again," Fallon said, "I'm giving it at least four years."

## Four Sentenced In Accomack Circuit Court

A 20-year-old man was sentenced to 10 years in prison last week in Accomack Circuit Court for the aggravated sexual battery of a girl younger than 13.

All but four years and three months of the term was suspended for Marcos Perez-Morales, of Hope Land Road in Modest Town. The crime occurred between Sept. 1, 2015, and June 30, 2016. Perez-Morales was taken back to Accomack Jail where he will be held until he is transferred to the state department of corrections.

In another case, Travis McKendrick Harris, 38, of Dreamland Avenue in Accomack, was sentenced to 15 years with six years suspended for robbing Jeremias Priciliano Ventura Perez on Jan. 25. He was also given a two-year suspended sentence for grand larceny for taking Perez's wallet.

## Jail Sentence For Manufacturing Marijuana

A Franktown man was given a month in jail Monday in Northampton Circuit Court for manufacturing marijuana for others.

Joseph Lee Giddens, 42, admitted in an earlier trial to possession of more than a half-ounce but less than five pounds of marijuana with intent to distribute. He was sentenced Monday to three years in prison with all but a month to serve in connection with the November 2017 offense.

Printice Alvin Wiggins, 60, of Cape Charles was sentenced to 10 years in prison with seven years and two months suspended for possessing a Schedule I or II drug in May. He was also fined \$100 and his driver's license was suspended for six months. Indefinite supervised probation was ordered. He got 30 days for possession of marijuana.

## Three Attacked by Animals Believed To Be Rabid

Three people in two separate incidents in the Kerr and Market streets area of Onancock Wednesday were attacked by "aggressive gray foxes" believed to have been rabid, according to the Accomack County Health Department.

Two raccoons were captured, but authorities are unsure if they were the same ones that had bitten the victims.

The three people, who were not identified, have sought treatment. Both foxes were observed displaying symptoms associated with the rabies virus.

"The Town of Onancock strongly encourages residents to keep small children and pets inside, unless attended by a responsible adult," said Onancock Town Manager Bill Kerbin. "The town also advises residents to refrain from leaving pet food outside or feeding stray animals. If you see an animal acting strangely, please call the Accomack County Sheriff's Office at 757-787-1131."

Health official Jon Richardson said residents should immediately contact the health department if foxes come in contact with people or pets. "Please en-

sure your pets' rabies vaccinations are up to date. If they are not, please make arrangements with your veterinarian for a booster shot as soon as possible.

"An announcement urged people to instruct children not to approach wild or stray animals. If a wild or stray animal attacks you, immediately wash the wound with warm soapy water and/or alcohol, then notify the health department and your physician. If your pet is attacked, immediately notify the health department and call your veterinarian. If you handle your pet after an encounter, please wear gloves and immediately wash your hands with warm soapy water and/or alcohol."

Explanation for Proposed Constitutional Amendment  
to Be Voted On at the November 6, 2018, Election

**PROPOSED CONSTITUTIONAL AMENDMENT**

ARTICLE X. Taxation and Finance.  
Section 6. Exempt property.

***BALLOT QUESTION***

Should a county, city, or town be authorized to provide a partial tax exemption for real property that is subject to recurrent flooding, if flooding resiliency improvements have been made on the property?

***EXPLANATION***

Present Law

Generally, the Constitution of Virginia provides that all property shall be taxed. The Constitution of Virginia also sets out specific types of property that may be exempted from taxation. For example, the Constitution of Virginia allows the General Assembly to permit localities to provide a partial exemption from real estate taxes as an incentive for property owners to make substantial improvements to existing structures by renovating, rehabilitating, or replacing those structures.

**Proposed Amendment**

The proposed amendment would authorize the General Assembly to allow localities to provide a partial tax exemption for real property that is subject to recurrent flooding, if improvements have been made on the property to address flooding. The General Assembly and participating localities would be allowed to place restrictions or conditions on qualification for the tax exemption.

A “yes” vote will authorize the General Assembly to allow localities to provide a partial tax exemption for real property that is subject to recurrent flooding, if improvements have been made on the property to address flooding.

A “no” vote will not allow such a tax exemption.

**FULL TEXT OF AMENDMENT**

Amend Section 6 of Article X of the Constitution of Virginia as follows:

ARTICLE X  
TAXATION AND FINANCE

**Section 6. Exempt property.**

(a) Except as otherwise provided in this Constitution, the following property and no other shall be exempt from taxation, State and local, including inheritance taxes:

(1) Property owned directly or indirectly by the Commonwealth or any political subdivision thereof, and obligations of the Commonwealth or any political subdivision thereof exempt by law.

(2) Real estate and personal property owned and exclusively occupied or used by churches or religious bodies for religious worship or for the residences of their ministers.

(3) Private or public burying grounds or cemeteries, provided the same are not operated for profit.

(4) Property owned by public libraries or by institutions of learning not conducted for profit, so long as such property is primarily used for literary, scientific, or educational purposes or purposes incidental thereto. This provision may also apply to leasehold interests in such property as may be provided by general law.

(5) Intangible personal property, or any class or classes thereof, as may be exempted in whole or in part by general law.

(6) Property used by its owner for religious, charitable, patriotic, historical, benevolent, cultural, or public park and playground purposes, as may be provided by classification or designation by an ordinance adopted by the local governing body and subject to such restrictions and conditions as provided by general law.

(7) Land subject to a perpetual easement permitting inundation by water as may be exempted in whole or in part by general law.

(b) The General Assembly may by general law authorize the governing body of any county, city, town, or regional government to provide for the exemption from local property taxation, or a portion thereof, within such restrictions and upon such conditions as may be prescribed, of real estate and personal property designed for continuous habitation owned by, and occupied as the sole dwelling of, persons not less than sixty-five years of age or persons permanently and totally disabled as established by general law. A local governing body may be authorized to establish either income or financial worth limitations, or both, in order to qualify for such relief.

(c) Except as to property of the Commonwealth, the General Assembly by general law may restrict or condition, in whole or in part, but not extend, any or all of the above exemptions.

(d) The General Assembly may define as a separate subject of taxation any property, including real or personal property, equipment, facilities, or devices, used primarily for the purpose of abating or preventing pollution of the atmosphere or waters of the Commonwealth or for the purpose of transferring or storing solar energy, and by general law may allow the governing body of any county, city, town, or regional government to exempt or partially exempt such property from taxation, or by general law may directly exempt or partially exempt such property from taxation.

(e) The General Assembly may define as a separate subject of taxation household goods, personal effects and tangible farm property and products, and by general law may allow the governing body of any county, city, town, or regional government to exempt or partially exempt such property from taxation, or by general law may directly exempt or partially exempt such property from taxation.

(f) Exemptions of property from taxation as established or authorized hereby shall be strictly construed; provided, however, that all property exempt from taxation on the effective date of this section shall continue to be exempt until otherwise provided by the General Assembly as herein set forth.

(g) The General Assembly may by general law authorize any county, city, town, or regional government to impose a service charge upon the owners of a class or classes of exempt property for services provided by such governments.

(h) The General Assembly may by general law authorize the governing body of any county, city, town, or regional government to provide for a partial exemption from local real property taxation, within such restrictions and upon such conditions as may be prescribed, (i) of real estate whose improvements, by virtue of age and use, have undergone substantial renovation, rehabilitation or replacement or (ii) of real estate with new structures and improvements in conservation, redevelopment, or rehabilitation areas.

(i) The General Assembly may by general law allow the governing body of any county, city, or town to exempt or partially exempt from taxation any generating equipment installed after December thirty-one, nineteen hundred seventy-four, for the purpose of converting from oil or natural gas to coal or to wood, wood bark, wood residue, or to any other alternate energy source for manufacturing, and any co-generation equipment installed since such date for use in manufacturing.

(j) The General Assembly may by general law allow the governing body of any county, city, or town to have the option to exempt or partially exempt from taxation any business, occupational or professional license or any merchants’ capital, or both.

(k) The General Assembly may by general law authorize the governing body of any county, city, or town to provide for a partial exemption from local real property taxation, within such restrictions and upon such conditions as may be prescribed, of improved real estate subject to recurrent flooding upon which flooding abatement, mitigation, or resiliency efforts have been undertaken.

# Chincoteague Pony Essie Dies from Swamp Cancer, Others Ailing

## But birth of late-season Medicine Hat foal has raised spirits and left pony lovers hopeful

Essie, a member of the famous herd of wild ponies from Assateague, died from swamp cancer or pythiosis, a fungal infection, according to an announcement made late Tuesday by the Chincoteague Volunteer Fire Company.

But pony lovers are feeling hopeful the six others ailing ponies will get well due to treatment and the birth of a Medicine Hat colt, that is very rare and is said to have special powers and be a good luck charm.

The foal is white with a colored patch covering his ears and the top of his head. This one has the classic blue eyes too. The legend of the Medicine Hat goes back to Native American tradition.

The swamp infection occurs via a wound when the animals stand in water that has pathogens. Areas that don't have harsh winters are more likely to see problems because the water there doesn't freeze.

Essie "had her surgery but apparently, her infection was too far gone," said Denise Bowden, a spokesperson for the

fire company, which owns the herd. "We had our hopes up but it wasn't meant to be. So far the others seem to be doing OK. It's a waiting game."

Bowden said she and Harry Thornton, the company's first assistant chief, met with the U.S. Fish and Wildlife Service Tuesday. The refuge is bringing in another fungus expert. "Over time, they will be collecting soil, water, and plant samples to see if we can get this mess contained. There has just got to be a solution."

The good news is the new colt "is gorgeous!" Bowden said. "Thanks, you all, for your continued prayers and kindness as we deal with all this. Our cowboys have been at the carnival grounds day and night taking care of these precious animals. Their dedication is nothing short of amazing."

Bowden said she sat in on one of the surgeries. The vet cut the wound open and showed her "the little seed-like fungus," that she compared to sesame seeds.

"They bunch up in one area like grapes and then spread to other areas,"

Bowden continued. "The ponies were constantly monitored with their pulse and breathing rates through the whole process. I am so impressed by the vet team and our cowboys."

The ponies were recovering by

"chomping away on hay and enjoying siestas in their hospital rooms with sawdust and low lighting. They think they are at the Plaza Hotel," she remarked.

"It will take 6-9 weeks to see good results. So keep praying!" Bowden urged.

# VIMS EASTERN SHORE CONSTRUCTION UPDATE AND TENTATIVE PLANS

**By Krystle Bono**

Virginia Institute of Marine Science Director John Wells conducted a town hall meeting at the VIMS location in Wachapreague last Friday to discuss the new construction plans and timeline for completion.

The new construction plan will erect six new facilities on the Wachapreague seaside location, and will include a new administration, education, and visitor centers, aquaculture and maintenance facilities, and maintenance storage, totalling 22,218 square feet, and will be modeled after the existing Seaside Hall and Seawater Laboratory architecture, which were constructed in 2012.

Building will be completed in phases to not interrupt productivity beginning July 2019. Sequence 1 will demolish

Lewis House basement, foundation, Hill House, Hill House garage, the current administration building, pole shed, and remaining storage structures, and then the site will be prepared and underground utilities established.

Sequence 2 will construct the new visitor's and administration centers, and the aquaculture and maintenance facilities. Owen's and bath houses will be demolished during this sequence.

Sequence 3 will demolish the existing hatchery, maintenance shed, and surrounding storage sheds, and then construct the new maintenance storage and education center.

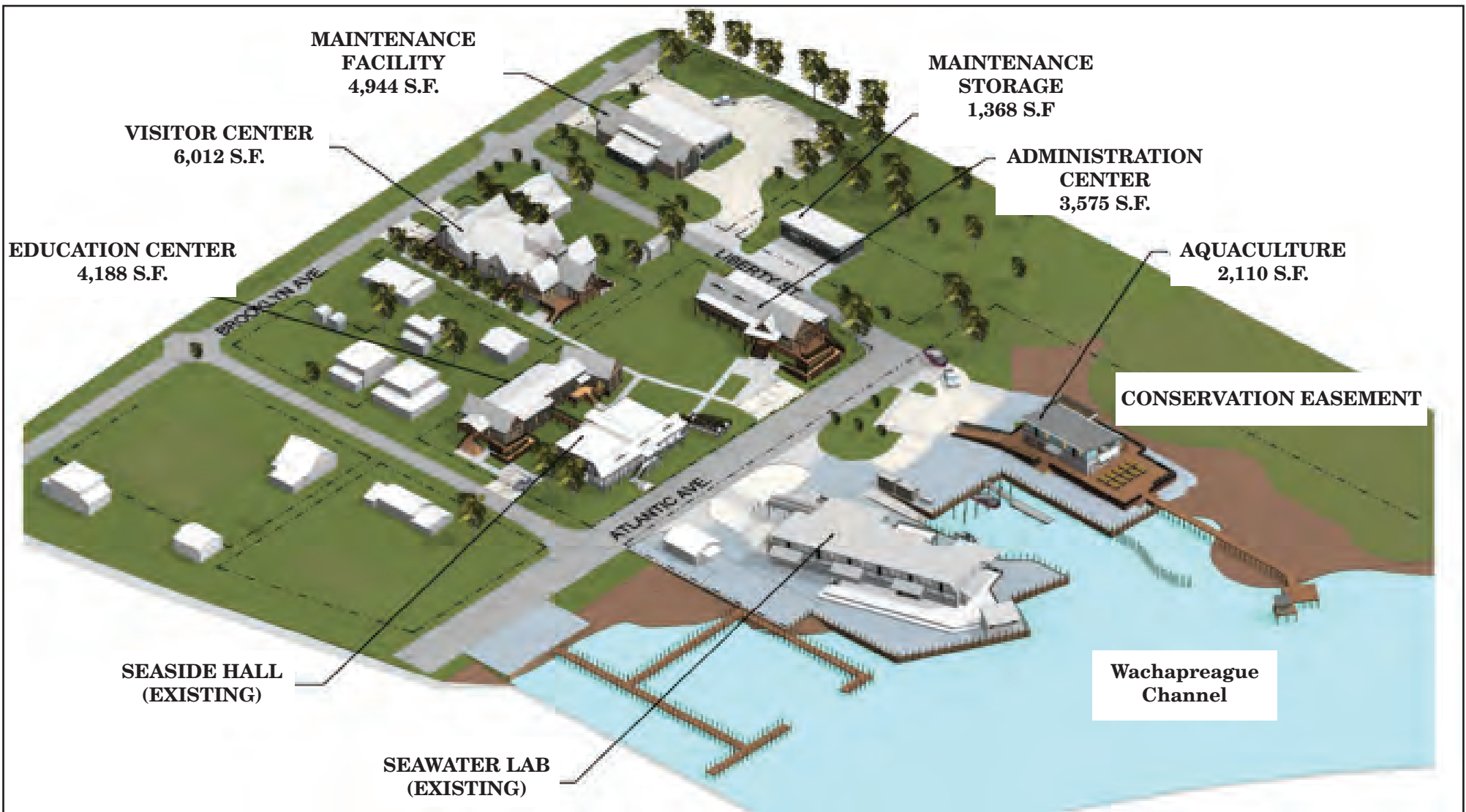
The purpose of the project is to put some of the buildings out of the flood zones; the new administration building will be build up on stilts, and the

new visitor center will be placed on the ridge of high ground off of Brooklyn Ave. The aquaculture center will be on

the waterfront, but will be flood-proof. Construction is projected to be completed by March 2021.

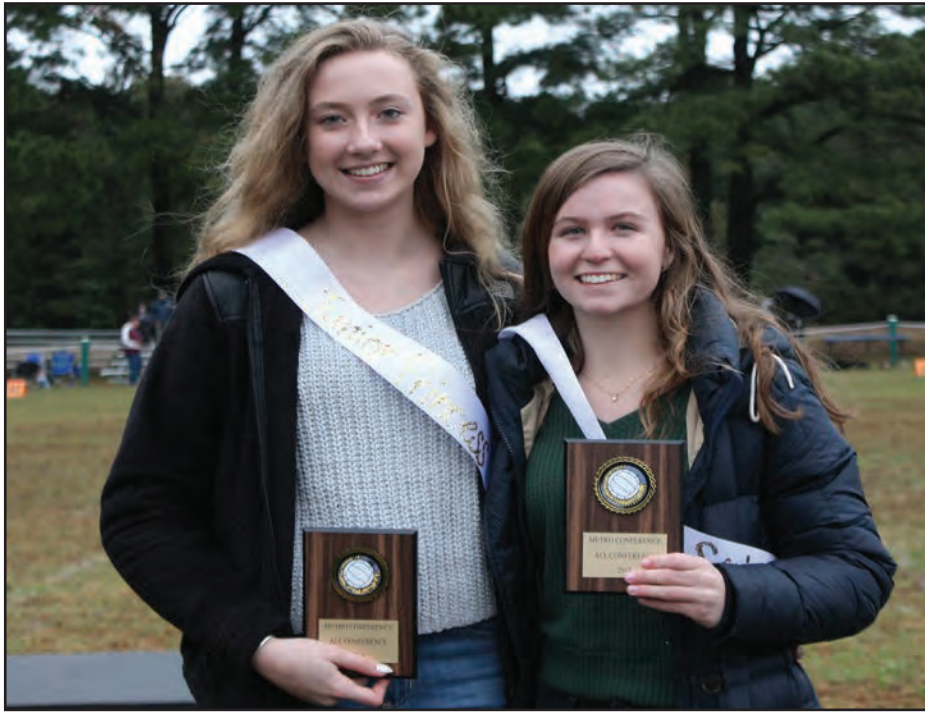

Explanation for Proposed Constitutional Amendment to Be Voted On at the November 6, 2018, Election

### PROPOSED CONSTITUTIONAL AMENDMENT

ARTICLE X. Taxation and Finance.

Section 6-A. Property tax exemption for certain veterans and their surviving spouses and surviving spouses of soldiers killed in action.

#### BALLOT QUESTION

Shall the real property tax exemption for a primary residence that is currently provided to the surviving spouses of veterans who had a one hundred percent service-connected, permanent, and total disability be amended to allow the surviving spouse to move to a different primary residence and still claim the exemption?

#### EXPLANATION

##### Present Law

The Constitution of Virginia currently requires the General Assembly to exempt from taxation the principal place of residence of any veteran who has been determined by the U.S. Department of Veterans Affairs to have a 100 percent service-connected, permanent, and total disability. This tax exemption is also provided to the surviving spouse of such a veteran, so long as the surviving spouse continues to occupy that property as the surviving spouse's principal place of residence.

##### Proposed Amendment

The proposed amendment would allow the surviving spouse of any veteran who has been determined by the U.S. Department of Veterans Affairs to have a 100 percent service-connected, permanent, and total disability to continue to claim the tax exemption currently provided, even if the surviving spouse moves to a new principal place of residence that is owned by the surviving spouse.

A "yes" vote will allow these surviving spouses to move to a new principal place of residence that is owned by the surviving spouse and still claim the tax exemption.

A "no" vote will not allow such surviving spouses to move and still claim the tax exemption.

#### FULL TEXT OF AMENDMENT

Amend Section 6-A of Article X of the Constitution of Virginia as follows:

#### ARTICLE X TAXATION AND FINANCE

##### Section 6-A. Property tax exemption for certain veterans and their surviving spouses and surviving spouses of soldiers killed in action.

(a) Notwithstanding the provisions of Section 6, the General Assembly by general law, and within the restrictions and conditions prescribed therein, shall exempt from taxation the real property, including the joint real property of husband and wife, of any veteran who has been determined by the United States Department of Veterans Affairs or its successor agency pursuant to federal law to have a one hundred percent service-connected, permanent, and total disability, and who occupies the real property as his or her principal place of residence. The General Assembly shall also provide this exemption from taxation for real property owned by the surviving spouse of a veteran who was eligible for the exemption provided in this subdivision, so long as the surviving spouse does not remarry. This exemption applies to the surviving spouse's principal place of residence without any restriction on the spouse's moving to a different principal place of residence.

(b) Notwithstanding the provisions of Section 6, the General Assembly by general law, and within the restrictions and conditions prescribed therein, may exempt from taxation the real property of the surviving spouse of any member of the armed forces of the United States who was killed in action as determined by the United States Department of Defense, who occupies the real property as his or her principal place of residence. The exemption under this subdivision shall cease if the surviving spouse remarries and shall not be claimed thereafter. This exemption applies regardless of whether the spouse was killed in action prior to the effective date of this subdivision, but the exemption shall not be applicable for any period of time prior to the effective date. This exemption applies to the surviving spouse's principal place of residence without any restriction on the spouse's moving to a different principal place of residence and without any requirement that the spouse reside in the Commonwealth at the time of death of the member of the armed forces.

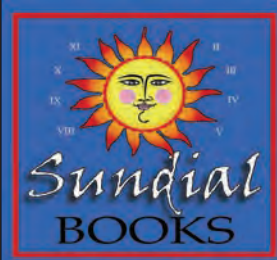

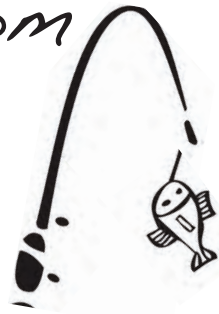

# Fishing from the Shore

By Bill Hall



Last weekend's gusty conditions prevented most anglers from venturing out on the water, but better conditions this week have resulted in improved catches, particularly on the Chesapeake Bay. Fall surf fishing has been productive, especially for small-medium sized bluefish, although a number of species are available for anglers using a variety of baits, rigs, and hook sizes. Striped bass on the Chesapeake Bay continue to be numerous but small, though a few more legal-sized fish are starting to show up. It will probably be at least a few more weeks before any numbers of trophy-sized rockfish enter the bay. Legal-sized speckled trout are starting to become more abundant off the lower part of the peninsula, but larger fish are still scarce. Flounder fishing around the south end of Chincoteague Island has produced flatfish to five pounds.

**Chincoteague** – Pete Vasilou, at Captain Steve's Bait & Tackle, reported that there has been a "ton" of snapper blues in the surf. Anglers are catching most of the fish on fireball rigs with cut bait. Red drum remain the trophy target for most surf anglers, with at least one caught from the surf on Tuesday. One angler reported catching seven different species during a single outing, including a red drum, small black drum, speckled trout, kingfish (sand mullet, whiting), bluefish, swelling toads, and two species of rays. Chincoteague Bay has produced a lot of flounder, short stripers, and a variety of small panfish. A nice flounder bite continues in the Curtis Merritt Harbor area, particularly from the creek around the harbor and into the Chincoteague Channel and south. Vasilou said that nobody has been able to get offshore due to the recent windy conditions, but there is some clean, warm water available offshore that should be holding fish. The Captain Steve's Annual Fall Surf Fishing Tournament is scheduled for Nov. 16-18 with awards for the largest red drum, striped bass, bluefish, and kingfish (whiting).

**Lower Shore** – Jeb Brady, of Bailey's Bait & Tackle, reported that he has received reports of good speckled trout fishing along the beaches south of Kiptopeke State Park. Some anglers had limit catches of fish measuring 8 to 14 inches, with a few puppy drum among the catches. A few small striped bass have been caught inside the lower

shore creeks and along the jetties. With the recent cold snap, Brady said that he hopes to see some bigger fish soon.

Mark Snook, at Chris' Bait & Tackle, reported that there have been a "few" fish caught off the Kiptopeke Park pier, including croakers, spot, and swelling toads (puffers). A few speckled trout

catches have occurred along the beach, north and south of the park. Snook said that "the weekend was windy, pretty much a blowout, so fishing has been pretty slow."

**Upper Shore** – Captain Matt Abell, at the Sea Hawk Sports Center, described the fishing for rockfish in the shallows of Tangier Sound as "very, very good." A charter trip on Tuesday landed over 100 fish, measuring up to 27 inches in length. Another trip during the early part of the week produced additional limit catches of rockfish, plus a puppy drum. Most of the fish have been caught on Bass Assassins Paddle Tail models and DOAs. Matt had received reports of good numbers of speckled trout

near the pound nets on the lower shore as well as a good flounder bite at Curtis Merritt Harbor.

**Tournament Results** – The Fish Hoggs, a local surf fishing team, hit pay dirt again by capturing first place at the Assateague Mobile Sportsman Association Ronald Bounds Memorial Surf Fishing Tournament, which was held Oct. 20-21. It was the second year in a row that the team earned top honors. Team members included Jamie Logan (team captain), Brian Hill, Clark Crockett, Ray Willett, Danny Kidd, and Marty Bull. The team won \$2,000 for its effort.

He has been named Virginia Saltwater Angler of the Year and Virginia Saltwater Release Angler of the Year. Bill is an I.G.F.A. International Committee Representative and a longtime member of the Virginia Saltwater Fishing Tournament Committee. He is the Virginia Recreation Fishing representative on the ASMFC Striped Bass Management Panel and is a past recipient of the CCA-VA Virginia Outdoor Writer Conservation Leadership Award.*

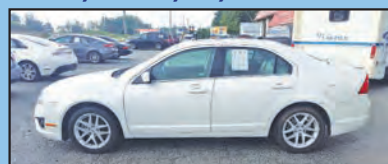

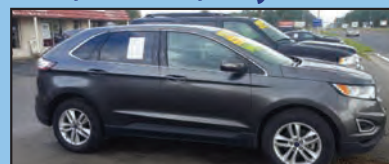

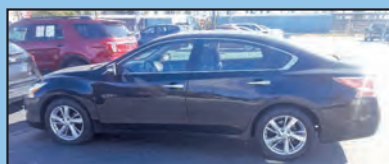

# The Tragic Dual End to the Cobb Island Hotel and the Nathan F. Cobb Ship

Nathan F. Cobb and his family moved from Massachusetts to Northampton County in 1837 and settled into a community near the village of Oyster where they opened a small store. In December 1838 Nathan applied to the county for a license to operate a tavern and sell distilled spirits, and in March of the following year he bought Sand Shoal Island, an 84-acre barrier beach east of Oyster.

Nathan and his three sons soon began construction of a small residence on the island, and from there they operated a business salvaging ships that had the misfortune of running aground on shallow island shoals. The Cobb family constructed additional living quarters on the island, and soon they were entertaining guests who would come in the summer to bathe in the surf and in winter to hunt the innumerable waterfowl that populated the island.

But the Cobbs in those days were mainly known for salvaging ships. This was some 30 years before the U. S. Lifesaving Service was formed, so the Cobbs provided an important service to mariners. If a ship went aground, the Cobbs would rescue the crew and then bargain with the owners for salvage rights to the cargo. It is said that the Cobbs added many improvements to their island with lumber and other goods salvaged from ships.

The Cobbs had a reputation for being hard bargainers when it came to salvaging cargo, but they never charged a fee for saving a life. Indeed, the Cobbs were known for feeding and clothing stricken crew members and treating them just as they did paying guests in their quickly growing resort.

The Cobbs' salvage business lasted until the government opened a lifesaving station in the 1870s, and by then the family was spending most of its time operating its grand hotel, which in the years following the Civil War attracted visitors from all over the country. Nathan Cobb, though, was still thought of with reverence in the maritime industry,

recognized for the many lives he had saved and the cargo he had salvaged.

Soon after Cobb died in 1881, a shipping company commissioned a 656-ton, three-masted schooner to be built in his memory. The 167-foot Nathan F. Cobb was launched in Rockland, Maine, in 1890 and soon began shipping freight among East Coast ports.

The Cobb Island Hotel continued to operate after Cobb's death, but a series of coastal storms seriously damaged the old resort, and it went through a series of owners and operators. The end finally came late in 1896 when a massive storm

raked the East Coast. The hotel was damaged beyond repair, and local newspapers reported in 1897 that the furnishings were sold at auction for \$850, thus bringing an end to a colorful era of Eastern Shore history.

But the storm of 1896 had other victims as well. News reports announced that a square-rigged schooner bound for New York carrying lumber and cross-ties capsized off the coast of Georgia in the gale. The cook and a shipmate drowned when they were swept overboard, and the ship drifted for four days before coming to rest on a sandbar off Ormond Beach, Fla.

In a tragic coincidence, the schooner Nathan F. Cobb perished in the same coastal storm that destroyed the hotel Cobb had built more than a half-century earlier. Fittingly, local folks salvaged the remains of the Nathan F. Cobb and built a cottage on Ormond Beach with lumber taken from the ship. The ship nameplate was hung over the fireplace. The Cobb Cottage today still stands at 137 Orchard Ln. and is part of the Ormond Beach Historic Trail.

A campaign is underway to fund the new ESVA Heritage Center, which will require specialized architectural design, and environmental controls and equipment. 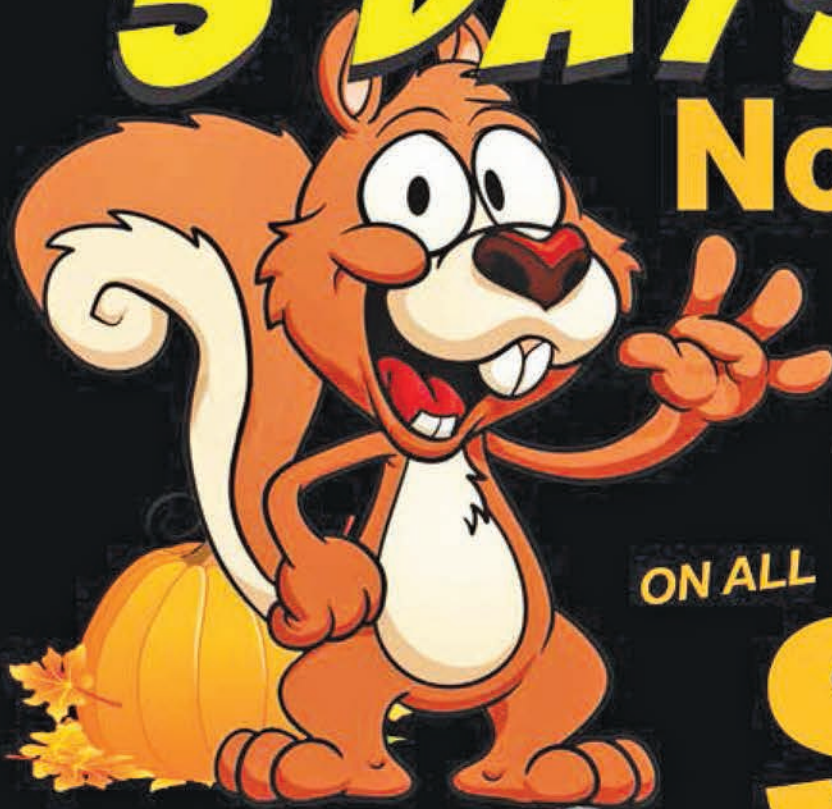

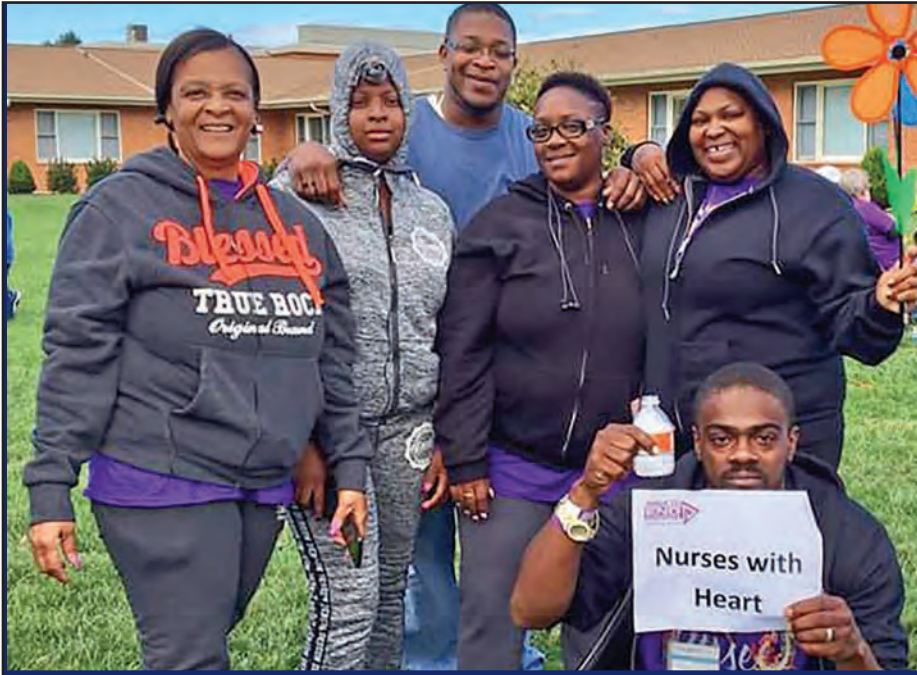

# Health Matters **Free Skin Cancer Screening**

One wouldn't think something the size of a pencil eraser could turn the world upside down, but for Rachael Fluhart, that's exactly what happened.

Fluhart attended a Riverside skin cancer screening in October of last year. She was referred to a dermatologist after a small spot on her back began to bother

her. The suspicious spot was removed and sent for testing. She was shocked to find out that at 21 years old she had skin cancer: melanoma.

"After that, things moved very quickly," Fluhart said.

There were additional procedures to remove more tissue, helping to ensure they had gotten all the cancer cells and a biopsy of her lymph nodes. She then received even worse news. The melanoma had spread. She had invasive nodular metastatic melanoma.

So just as Fluhart was graduating from nursing school and taking her nursing exams, she was also dealing with a major health crisis. Her treatment included removing all of the lymph nodes on her left side and now she's undergoing targeted immunotherapy at the Riverside Shore Cancer Center.

Fluhart remains upbeat despite all the setbacks caused by that tiny little spot. "Staying positive has been a goal of mine through all of this. I feel like the mental part is half of the battle of a cancer diagnosis,"

she said.

The first step in diagnosing skin cancer is a visual examination, and Fluhart encourages everyone on the Shore to

have a skin check by their primary care provider or at the free screening held Tuesday, Nov. 13, from 4:30 to 7 p.m., at the Riverside Shore Cancer Center. Appointments are required and can be made by calling 302-2600.

Skin cancer is the most common form of cancer, according to the American Cancer Society. Each year more people are diagnosed with skin cancer than all other cancers combined. Basal and squamous cell cancers, which are the most common and treatable forms of skin cancer, are typically found on areas most exposed to the sun, like the face and hands. Melanoma, though not as common, is more likely to spread to other areas of the body.

While Fluhart's melanoma had a genetic cause, by far, most skin cancers are caused by exposure to ultraviolet (UV) rays, either from the sun or tanning beds. To decrease exposure to UV rays, the American Academy of Dermatology recommends using a sunscreen with a sun protection factor (SPF) of 30 for everyday use and an SPF of 50 for outdoor activities. Limiting sun exposure when the rays are strongest, typically between 10 a.m. and 2 p.m., also goes a long way at minimizing sun damage.

Other risk factors for skin cancers include being fair skinned and having freckles or light hair. Age also plays a role, as most skin cancers occurs in older adults, though that is changing. Melanoma is one of the most common cancers in people under 30.

# Consumer Rip-off Tipoffs

We are all bombarded by advertisements of products and services aimed at our pocketbooks and wallets. They come by air (TV), by mail (email and surface mail), via print media, and even by word-of-mouth. Within these messages there are tipoffs that should caution one to be extra careful.

A good example of this is any financial or insurance product or service that says in its ad that it is not available in New York State and/or California. One such ad is for a payday lender where TV personality Montel Williams is the spokesperson. At the end of the ad, Williams says the service is not available to residents of New York State due to interest rate limitations. New York State and California are aggressively serious about consumer protection; other states not so much. Let that be a guide to a potential rip-off.

Automobile advertising is another example. Try reading all the microscopic

print that flashes on the screen for a second or two. Ask yourself why this is, why can't a car dealer create an advertisement without unreadable small print? The answer is they want to get you into the showroom and whet your appetite for their product. That is when the small print and bait-and-switch comes into play. There are new methodologies now for car sales where there is no small print in the pitch. They might get increasingly popular. I was able to read part of the small print for a recent car ad. It said that the seemingly fantastic advertised price for the vehicle applied only to cars with manual transmission. Very few people want an everyday car with manual transmission. Clearly a case of get 'em into the showroom and then apply the bait-and-switch.

The language used is often deceptive, designed to make the consumer abandon their common-sense thought process. "Only a few left" is one such example. Common sense would say if there are only a few left, why spend

big bucks on advertising? "Offer/price expires soon" is another such phrase designed to push the consumer into a quick decision rather than a well-thought-out decision. If a seller has a product they want to move off the shelves, why would they, in a few days, raise the price? "Get yours before anyone in your group gets theirs." The motivation here is obvious. My reaction to this kind of hype is mathematical. I am less likely to buy when there is too much hype. That's just me. Hopefully you'll at least buy with some caution.

Avoid self-employment schemes that are based not on you selling a product but rather on you being able to enlist people under you to sell the product. This is "multi-level marketing" and unless you are in at the beginning, it is usually a disaster. This field contains several well-known companies and much litigation.

If you have an elderly relative or friend, here are two signs that this person is being financially abused.

- Large bank withdrawals not necessitated by reasons such as health(some

banks now notify authorities about this as a preventive measure).

- An accumulation of subscription magazines or other material, making it appear that your friend or loved one has turned into a hoarder.

Elder financial abuse is a growing problem. A power of attorney in the wrong hands can devastate an elderly person. If you suspect something like this may be happening to someone you know and care about, you should, at a minimum, contact your local County Area Agency on Aging and perhaps also the commonwealth's attorney office for your county.

With regard to advertising, read and listen carefully, and you will spot cautions in much of the advertising that comes your way. Put on your critical thinking hat. As always, you are your own best financial self-defense.

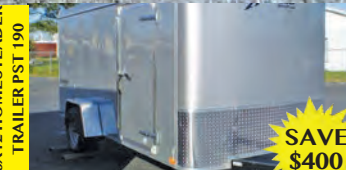
