ARMY CORPS OF ENGINEERS SEEKS COMMENT ON PLAN TO RESTORE WALLOPS SHORELINE

The U.S. Army Corps of Engineers posted a notice Monday soliciting public comment regarding the proposed dredging and excavating in the ocean at Wallops Island aimed at reducing potential storm damage or loss to assets of the NASA Wallops Flight Facility, the Navy, and the Mid-Atlantic Regional Spaceport.

The applicant, NASA, proposes to use "dredge material to nourish the shoreline." Six rubble mound breakwaters would be installed to restore the shoreline to pre-Hurricane Sandy conditions. "Restoration is necessary as the existing seawall is being undermined due to little or no protective sand beach remaining in the proposed work area," the notice stated.

An estimated 1.3 million cubic yards of sand would be placed along about 19,850 feet of shoreline. "The beach fill material will come from excavating and performing minor dredging at the north Wallops Island beach."

The proposal involves dredging 37,515 cubic yards of sand from the north-end of Wallops Island and would impact 31 acres of land seaward of mean high water, the notice continued. This and material exca-

Mold Found at Chincoteague High School Requires Professional Cleanup

At Chincoteague High School, two rooms inspected earlier this month were found to have elevated levels of mold and required professional cleaning.

Room D6 contained a 3,147 count of penicillium/aspergillus per cubic meter and Room D9 had an 11,147 count of penicillium/aspergillus per cubic meter, both “elevated levels” of mold, the environmental report stated.

The concentration of mold in the air is measured by the number of colony-forming units (cfu) in one cubic meter of air.

According to the World Health Organization, a concentration of mold up to 499 cfu per cubic meter is low, between 500 and 999 cfu per cubic meter is moderate, and 1,000 or more cfu per cubic meter is high.

Each of the four rooms tested had higher concentrations of penicillium/aspergillus than any other mold.

The other two rooms, D5 and B12, contained a 453 count of penicillium/aspergillus per cubic meter and a 640 count of penicillium/aspergillus per cubic meter, respectively, within the low

to moderate range. Those rooms were deemed “acceptable with no further cleaning required.”

Accomack County Public Schools Director of Operations Mike Tolbert reported that a qualified contractor completed the cleanup on Nov. 12.

Sussex Environmental Consultants, of Lewes, Del., was contracted to conduct the mold and moisture evaluation.

Four rooms were tested for mold in response to concerns about previous issues with humidity in those areas.

The environmental company collected air samples and sent them to Aerobiology Laboratories of Dulles, Va. The samples were examined under a microscope and up to nine types of mold or fungal particles were identified.

The molds detected were airborne particles such as spores, not surface molds that are visible to the naked eye.

Penicillium and aspergillus are often categorized together because their spores are indistinguishable without knowing their source.

Sussex Environmental Consultants recommended cleaning the rooms us-

ing a HEPA filtered air scrubber and having the air ducts in the rooms professionally cleaned by a company belonging to the National Air Duct Cleaning Association.

The company also recommended retesting the affected areas after cleaning to ensure the mold levels had been reduced.

According to the U.S. Environmental Protection Agency, indoor humidity levels should be kept below 60 percent to discourage mold growth, and between 30 percent and 50 percent humidity is ideal.

No molds other than penicillium/aspergillus were detected at elevated levels. The next largest amount of mold particles found were low to moderate levels of basidiospores, spores produced by mushrooms and other common fungi.

According to the Mayo Clinic, the most common health issues associated with mold are allergies. A person who is allergic to mold can develop the same symptoms associated with other upper respiratory allergies, including sneezing, runny or stuffy nose, postnasal drip,

coughing, watery or itchy eyes, itchy nose and throat, and dry, scaly skin.

Mold can trigger an asthma attack in people who have both mold allergies and asthma.

In some cases, mold exposure can cause an infection of the mucous membranes or skin.

The Center for Disease Control and Prevention (CDC) cites inhaling aspergillus spores as a cause of a condition called aspergillosis. A person with a weak immune system or a chronic lung illness is more likely to develop aspergillosis.

None of the molds detected at the high school was related to stachybotrys chartarum, a black mold that can produce toxins that may cause rare health conditions.

The CDC states that “toxic mold” is a misnomer because mold itself is not toxic and the relationship between toxin-producing molds and certain health conditions is unproven.

Accomack schools Superintendent Chris Holland said the issues at Chincoteague High School will continue to be addressed and the health and safety of students and staff is a top priority.

Thanksgiving Crash Claims Life Of Accomac Man, Injures Brother

One brother died and another was seriously injured in a traffic crash early Thanksgiving morning in Accomac.

Billy Gene Padgett, 38, of Baylys Neck Road, was driving a 2012 Dodge Charger on Church Road, failed to negotiate a turn, and ran off the road

and into an abandoned house at the edge of Front Street. The incident occurred at 2:08 a.m.

The passenger, Ray Phillip Padgett Jr., 44, also of Baylys Neck Road, died at the scene. Billy Padgett was flown to Sentara Norfolk General Hospital.

Sgt. Michelle Anaya of Virginia State Police said, "Speed was a contributing factor and it is unknown at this time if alcohol contributed to the cause of the accident." The men were not wearing seatbelts, she added.

It was the fourth fatal crash in Accomack County in 2018. Five people died in those incidents. Northampton County has had two fatal crashes with two people killed in 2018.

Last year at this time, there were three fatal crashes with three people killed. Northampton figures were the same as this time last year.

Charges are pending for the latest fatal crash, police said.

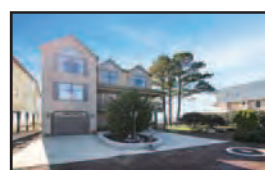

Onley Fire Co. Sells Real Estate For One-Third of Assessed Value

The Onley firehouse and five surrounding properties were sold last week for \$100,000, or just under a third of the assessed value. The move was a final step in settling the assets of the former fire company dissolved by the Accomack Board of Supervisors in July 2017 for not providing services.

A file filed in Accomack Circuit Court showed the property at 25489 Maple St. in Onley was purchased by Ronnie Lescalette, of Exmore. Lescalette was not available for comment about his plans for the properties by press time Thursday.

Last January, an ambulance, the chief's car, and a heavy rescue truck were picked up by the finance company, at the request of Royal Governor, president of the former Onley Volunteer Fire and Rescue Co. Inc.

At that time, Governor said the vehicles would be sold to pay off the

debt on them. There was \$21,000 owed on the ambulance and car. He was hoping the sale would be enough to persuade the finance company to write off the rest. About \$68,000 was owed for the heavy rescue truck, which was valued at about \$120,000. The truck was 26 years old. "They might write it off" as well, he said.

Tuesday Governor was reached by phone but could not speculate about what Lescalette was planning. The president was asked about the remaining debt and stated, "I'm working on those numbers now" with an attorney.

When the company was dissolved, the ambulance needed repair, a dispute with a former chief caused the operational medical director (OMD) to resign, and the fire engine had no tags or title because it was purchased from New York, where those things are not required.

All hope of rekindling the unit disappeared for volunteers who planned to fight for more time to get reorganized when the supervisors took action.

County Assessor Brent Hurdle said the total assessed value of the six parcels was \$307,900. The value of the firehouse and lot was \$295,700.

County Administrator Mike Mason said Monday when the supervisors voted to dissolve, the company's board of directors was directed to "wind up" the organization which they are legally required to do anyway.

The last financial statements the county received before that were in June 30, 2016. "According to this information, they owed over \$200,000 which was tied to two notes payable," Mason said.

Also among the reasons cited for closing the station were: a member was convicted in 2014 of embezzling money from the company, there was another conviction of a member who set a truck ablaze in 2016, and a former chief's report said the company would close in early 2017. The hospital's move to Onley also had an impact on the need for service in the area.

vated from uplands will be used to re-nourish. About 140 acres of subaqueous bottom seaward of mean high water will be involved. The breakwaters would be placed seaward of mean low water and would impact 1.64 acres of subaqueous bottom. "No mitigation is proposed for the impacts to subaqueous bottom."

A pan excavator would remove sand from about "200 acres of the beach to the mean low water line. The average excavation depth is 2.35 feet. Sand will be stockpiled and then loaded onto dump trucks for transport on existing roads to the southern end of the island. Bulldozers will be used to spread the fill material once it is placed on the beach. All heavy equipment will access the beach from existing roads and established access points. No new temporary or permanent roads will be constructed to access the beach or to transport the fill material to re-nourishment areas."

The beach fill will start about 1,500 feet north of the Wallops Island-Assawoman Island boundary and extend north for about 3.7 miles, the notice continued. The initial fill will form a 6-foot-high berm extending a minimum of 70 feet seaward of the existing seawall. The remaining fill will slope seaward with varying distances.

The breakwaters would be constructed in two equal sets about 200 feet offshore from the mean high water line of the re-nourished beach ... Each breakwater will be constructed of VDOT-type I armor stone for the outer layer and Class II Stone for the core. The stone would be placed parallel to the shore and will measure approximately 130 feet long and 10 feet wide at top crest elevation. The breakwaters will be placed approximately 100 feet apart. Water depths in these areas are approximately 4 to 8 feet. The southernmost breakwaters will be constructed about 4,000 feet north of the southern extent of beach nourishment. The second breakwaters will be put about 10,000 feet north of the southern extent of beach

nourishment. The rocks for would be brought to the Wallops Flight Facility by rail and then trucked to the site. It would then be loaded onto barges and placed.

American beach grass would be planted at 18-inch intervals over the re-established dune between Oct. 1 and March 31.

A hearing could be requested. A preliminary review indicates "no environmental impact statement will be required." But NASA consulted the U.S. Fish and Wildlife Service regarding potential effects on Endangered Species Act listed birds and sea turtles that could be affected by the project and the two agencies "developed ... mitigation measures to reduce the probability and intensity of potential effects."

They propose no work will be conducted in the borrow area at the north-end of the island during plover or turtle nesting from April to September. NASA would employ a biological monitor to survey the project site on a daily basis should work occur during those months and promised to

educate all workers in the construction area on recognizing protected species and their habitat. From March to September NASA surveys the island for plover, red knot and sea turtle activity as part of its Natural Resources Management Program. "Any nests discovered are identified" with signs. Staff "provide outreach to beach users, including security staff and recreational users."

NASA also consulted with Virginia Department of Historic Resources regarding the project. "The inadvertent discovery of any previously unidentified archaeological resources would result in immediate cessation of work and notification of the Wallops Flight Facility Cultural Resources Manager." NASA also consulted with NOAA regarding potential effects on listed marine mammals, fish, and in-water sea turtles.

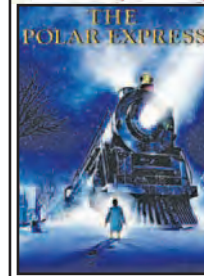

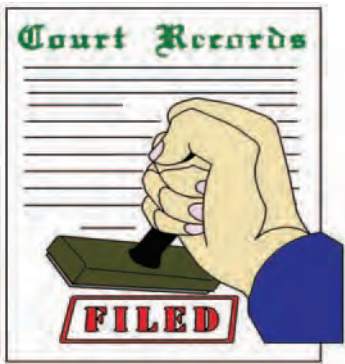

Several People Accused Of Felonies in Accomack

Several people were accused last week of committing felonies, according to records filed in Accomack General District Court.

In another case, Donna Lee Hanbidge, 75, of East Point Road in Onancock, was charged with a third offense of shoplifting, which is a felony. Records show she was seen on a store surveillance video putting two containers of 24-oz Coors Light in her purse. The incident occurred at Corner Mart in Onancock Nov. 6. An unsecured bond was set for \$5,500. Hanbidge was arrested Nov. 7. Officer Kim Whitelock of the Onancock Police Department investigated.

Steve Jean, 23, of Hampton Arbor Avenue, and Marquise DZhaun Thomas, 22, of Main Sail Drive, both in Hampton, Va., were charged with possession with intent to distribute more than a half-ounce of marijuana on Nov. 20. They were arrested the same day. An unsecured bond of \$5,000 was set for Jean. Thomas is free on a \$3,500 unsecured bond. Deputy K.A. Reese of the Accomack County Sheriff's Office investigated.

Maryland is seeking to extradite Matthew Grimes, 49, of Luff Court in Greenbackville, as he is wanted in connection with two counts of second-degree burglary and a count of failure to appear in Towson. Grimes is being held without bond.

Ryan Dennis Taylor, 20, of Savannah Road in Hallwood, will not be prosecuted for a felony charge. He was accused of maliciously shooting at an occupied vehicle on Oct. 5.

Jason Allen Altemose, 39, of Donato Drive in Ashley, Pa., will not be prosecuted in connection with the July 21 malicious wounding of Jimmy Lee Ramsey. When an officer arrived at the scene, a witness said Altemose stabbed Ramsey, who was found with a wound to his right forearm. He had

been bitten on the left forearm and had contusions to the left side of his forehead and above his right eye.

Convicted Murder Charged With Jailhouse Assault

Zachary Isaiah Townsend, a convicted murderer who was sentenced in July in Accomack Circuit Court to 48 years in prison, will go before a district court judge in Northampton for assault and battery of an Eastern Shore Regional Jail inmate.

Referred to as a remorseless killer by the prosecutor, Townsend, of Gretna Road in Atlantic, was 17 when he committed murder, robbery, and related gun offenses over a \$20 drug deal gone wrong. He was charged in October with the Sept. 20 assault and battery of Jordan Lewis Sterling. Both are being held in the Eastville jail.

Sterling, 34, of Seaside Road in Exmore, was sentenced to 10 years in prison with all but a year suspended for abducting his girlfriend on Sept. 24, 2017. He was also sentenced to a year in jail for assault and battery of a family member.

Lt. Michelle Hallett of the Northampton County Sheriff's Office investigated the recent charge against Townsend.

In another case, Thomas Anthony Conklin, 20, with addresses of Monroe Avenue in Exmore and Widgeon Lane

in Machipongo, was charged with rape and sodomy in connection with a Sept. 6, 2017, incident. The crimes were described as being "accomplished through the use of the victim's mental incapacity or physical helplessness." Conklin is being held without bond. Chief A.P. Dimartino, of the Exmore Police Department (EPD), investigated.

Tamekia Nakesha Davis, 28, of Savagetown Road in Painter, was charged with embezzling merchandise having a value of \$500 or more from Food Lion on July 15. She was arrested Nov. 20. An unsecured bond was set at \$2,000. Sgt. A.T. Zieger, of EPD, investigated.

Machipongo Man Convicted of Rape

A Machipongo man was convicted Monday in Northampton Circuit Court of raping a married friend who had passed out at a party after drinking vodka in January 2017.

Tavarus Jewel "TJ" Stratton, 33, of James Allen Drive, was remanded to the Eastern Shore Regional Jail until sentencing, which was scheduled for April 8.

Stratton claimed he and the victim had consensual sex in his car two days earlier at Indiantown Park. She denied that occurred. She said he was charged with the crime after she woke up to him having sex with her while she was intoxicated and sleeping in a bedroom of the

house where the party occurred. He had pulled her pants and underwear down.

"He was in the bed with me and that was a place he was not supposed to be," she testified. When she realized he was in the bed, she said she saw him "smiling at me with his gold tooth in his mouth." Then, he left the room. When she confronted him, "He's not saying anything. He's not denying, he's not agreeing. He's not saying anything."

The woman said the crime occurred at another friend's house, where she often partied and felt safe. She called her husband to come to get her after the incident occurred. He took her to the hospital where an examination was performed. She was hoping the incident "was a dream" but soon learned it wasn't as the sperm found on her belonged to the defendant. The Eastern Shore Post does not report the names of victims of sexual assault.

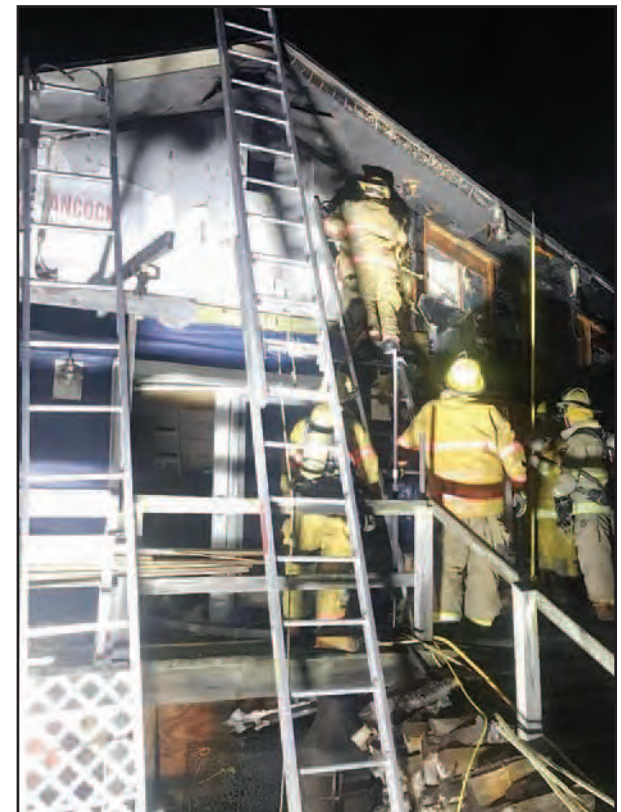
"We arrived to find a shed in the backyard fully involved with extension into the back of the house," James said. "We were able to get a quick knock down — in about 15 minutes. All occu-

\$1.8M Federal Grant Will Speed Expansion of Shore Broadband

Eastern Shore Communications, the Shore's first wireless internet service provider (ISP) powered by the Eastern Shore of Virginia Broadband Authority's fiber optic network, received a federal grant of nearly \$1.8 million to build out its service area on both sides of the Chesapeake Bay.

Eastern Shore Communications will offer high-speed, broadband internet to Chincoteague, Wallops Island, Accomac, Exmore, and Cape Charles, as well as Virginia Beach, Chesapeake, and Norfolk.

U.S. Senators Tim Kaine and Mark Warner announced the federal grant award earlier this month.

"Broadband access is vital to the economic success of the Commonwealth and the nation," they said. "These federal funds will help Virginia connect to the digital age while expanding access to healthcare, educational, and job opportunities."

The money comes from the U.S.

Department of Agriculture (USDA) Rural Development office's Community Connect program for constructing and expanding broadband access in rural and underserved communities.

Eastern Shore Communications is not the only one of the Shore's three ISPs to benefit from USDA programs supporting widespread access to broadband internet. Declaration Networks, better known as Neubeam, obtained an \$8.7 million loan from USDA last year to expand its wireless broadband internet service in Accomack and Northampton counties and Garrett County, Md.

When Neubeam received the USDA loan, USDA Assistant to the Secretary for Rural Development Anne Hazlett said, "nearly 40 percent of rural residents and businesses lack access to the same quality service available in urban centers" and "broadband is truly a lifeline to prosperity in rural communities."

With its expansion, Eastern Shore

Communications will offer speeds of at least 25 megabits downloading and 3 megabits uploading, in line with the latest definition of broadband as introduced by Tom Wheeler, chairman of the Federal Communications Commission (FCC).

According to the FCC, the definition of broadband changes with "advances in technology, market offerings by broadband providers, and consumer demand."

The FCC has changed the definition of high-speed internet three times in the last two decades.

Broadband was originally defined as internet speeds of 200 kilobits in 1996. In 2008, the broadband standard was 768 kilobits to 1.5 megabits, which many internet users would recognize as a typical range of speed for DSL. In 2010, broadband was redefined as internet speeds of 4 megabits downloading and 1 megabit uploading. In 2015, the current standard of 25 megabits downloading and 3 mega-

bits uploading was established.

Eastern Shore Communications began in 2012 as the first high-speed internet service provider to use the fiber optic network built by the Eastern Shore of Virginia Broadband Authority that was established in part with funding from Accomack and Northampton counties.

The original fiber optic cable installation has been called the Shore's broadband "backbone" because it runs through the middle of the peninsula, along Route 13, from the Chesapeake Bay Bridge-Tunnel to the Maryland border.

In 2013, Eastern Shore Communications celebrated the grand opening of its high-security and fully redundant network operation center, the Eastern Shore Data Center, used to monitor the ISP's network from the back end for quality assurance.

The ISP also offers bundled services, including digital telephone, high-definition television, and home security services.

\$140M in New Funding for Wallops’ Rocket Lab

Rocket Lab, the New Zealand-based company that is planning to build a launchpad at Virginia Space and Mid-Atlantic Regional Spaceport on Wallops Island for its Electron rockets, announced \$140 million in new funding last week.

According to the technology news site, www.newscenter.io, the company closed a Series E financing round “led by investor Future Fund, with participation from Greenspring Associates, Khosla Ventures, Bessemer Venture Partners, DCVC (Data Collective), Promus Ventures, and K1W1. New investor ACC also contributed to the round.”

The round brings total Rocket Lab

funding on Nov. 21, “To more than \$288 million, with the company now soaring past its previous \$1 billion valuation.

The round also follows “the opening of Rocket Lab’s new mass production facility for the Electron vehicle, as well as the announcement confirming the location of Rocket Lab’s second orbital launch site.”

The story stated construction has begun on Rocket Lab Launch Complex 2, based within the Mid-Atlantic Regional Spaceport at NASA Wallops Flight Facility. The plan is for monthly launches to occur there.

“Between the two Rocket Lab launch complexes, the company expects to support up to 130 orbital missions per year.”

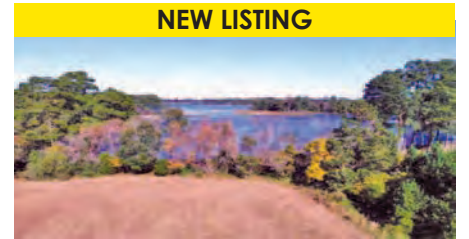

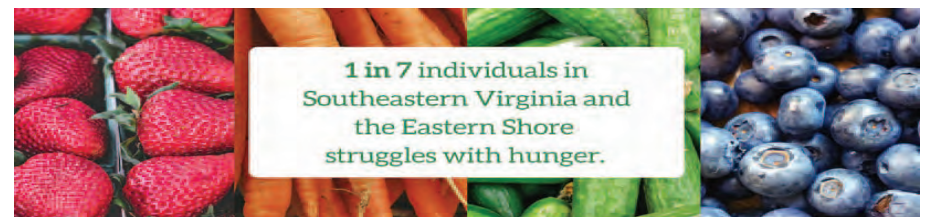

Northampton Supervisors Sign Off On New Tourism Commission

In a cooperative effort with Accomack supervisors, Northampton supervisors voted on Nov. 20 to re-establish the Eastern Shore of Virginia Tourism Commission after a controversy put the organization in jeopardy.

Accomack supervisors threatened to defund the tourism commission after discovering its executive director, Kerry Allison, opposed the poultry industry. Allison announced her retirement shortly thereafter.

Eastern Shore Chamber of Commerce Executive Director Robie Marsh will be the interim executive director of the tourism commission.

His contract will run from Jan. 1, 2019, until June 30. The new tourism commission will decide at the end of the trial period whether Marsh will continue in his new role.

The new tourism commission has six voting members, three from each county. That includes one supervisor from each county: Supervisor Billy Joe Tarr, of Chincoteague, for Accomack, and Supervisor John Coker, of Cape Charles, for Northampton.

Each board of supervisors appointed one citizen to the commission: Accomack chose Adam James, of Onancock, and Northampton chose Clarice MacGarvey, of Exmore.

The Chincoteague Chamber of Commerce and the Cape Charles town council also will each appoint a member.

The seventh, nonvoting member is Staci Martin, the Eastern Shore representative of the Virginia Tourism Corporation.

Coker was instrumental in getting Northampton a fair deal in the re-organization of the tourism commission.

He worked closely with Robert Crockett, the chairman of Accomack's board of supervisors.

Coker commented on the fact that Northampton and Accomack now have equal representation on the commission: "The key thing here is, no major decisions get made unless we have a majority of the voting members, which means that we have to work together."

Coker reported that he and Crockett agreed Accomack and Northampton should pay equal amounts to support the tourism commission.

Northampton currently pays \$150,000 per year for the tourism com-

mission, while Accomack pays \$100,000.

Coker also announced the tourism commission has a new location with better visibility – at the Eastern Shore of Virginia Chamber of Commerce on Route 13 in Melfa. (The tourism commission is renting space in the building.)

He said the chamber of commerce and tourism commission will maintain separate budgets, finances, and staff members.

Comparing the tourism commission's new and old locations is like "night and day," Coker said.

Spencer Murray, the chairman of the Northampton board of supervisors, was "delighted" with the outcome.

But not everyone shared that sentiment.

Allan Burns, manager of the Eastern Shore of Virginia Welcome Center, was concerned that the only requirements for membership on the tourism commission are "geopolitical," and reconstructing the commission with nearly all new members could cause "a loss of continuity, a loss of experience, relationships, and things of that nature."

"In two of the last four years we've been the most rapidly growing tourism

segment in this Commonwealth of Virginia and I do not want to see that interrupted," Burns said.

He pointed out there is no representative of the Chesapeake Bay Bridge-Tunnel on the new tourism commission.

Burns also was "not excited" about Marsh acting as the executive director of both the Eastern Shore's chamber of commerce and its tourism commission. He believes supervisors are being "unrealistic and expecting too much from one individual."

Carol Evans, who was the first tourism commission member that was not a county supervisor, agreed that "somebody will be shortchanged in the process" of one person taking on two full time positions.

"It's the best we can do right now," said Supervisor Robert Duer, equating the alternative — such as Accomack and Northampton dissolving the tourism commission and going their separate ways — to a "nuclear" disaster.

Murray agreed. "It would have divided the two counties," he said. "We would have no impact whatsoever advertising as a destination of the Eastern Shore."

EASTERN SHORE RURAL HEALTH SCHOOL DENTAL PROGRAM HELPS STUDENTS SUCCEED IN THE CLASSROOM

Eastern Shore Rural Health CEO Nancy Stern and Chief Dental Officer Scott Wolpin brought smiles to the Accomack school board meeting with their update on the health system's dental program offering clinics at two schools and dental services for all Accomack elementary and middle school students.

School-based dental care "contributes to improved academic performance, positive behavioral outcomes, increased attendance, and better quality of life for students at all grade levels," Stern said.

Offering dental health services at school increases the overall dental health of children in the community "significantly."

Eastern Shore Rural Health System (ESRHS) operates dental clinics at Metompkin Elementary School in Parksley and Pungoteague Elementary School. The dental program has served Accomack students since 1995.

ESRHS provides a Traveling Oral-health Preventative Program (TOPs) that includes middle school students.

Portable dental equipment allows kids to get checkups, cleanings, fluoride treatments, and even X-rays.

Eastern Shore Rural Health's school-based dental services include preventative, restorative, and emergency care. Students requiring dental surgery may be treated at the Atlantic or Franktown community health centers.

ESRHS also contracts with the Accomack school division to provide dental health services to children in Head Start, the federally funded preschool program for children ages 3 to 5 from low-income families.

One common dental procedure performed at the clinics is the application of dental sealants. These are thin plastic coatings painted onto a child's molars that prevent tooth decay by as much as 70 percent.

Of Accomack students who needed dental sealants, 97 percent received them within six months of their initial visit to one of the school clinics.

The school-based dental clinics exceeded the goal set by the Health Resources

and Services Administration (HRSA), an agency of the U.S. Department of Health and Human Services for improving access to healthcare. Dental treatment plans were completed for 78 percent of students, surpassing the benchmark of 60 percent.

School-based dental clinics "address some of the barriers that parents face when attempting to access oral health care for their children," Stern stated in her presentation.

The dental clinics are located on Accomack school grounds, but they operate year-round, even during summer vacation and on some holidays – further breaking down barriers to oral health care access. The dental clinics provided 253 days of service at Metompkin Elementary and 252 days of service at Pungoteague Elementary for the year ending May 31, 2017, and they were open during nearly 100 percent of instructional days.

About 2,800 kids received dental treatment without parents having to miss work to take them to appointments.

Another 579 kids in middle school, ages 11 to 13, participated in TOPs.

Children with poor dental health are

more than twice as likely to perform poorly in school and are three times as likely to miss school compared to children with no dental health issues.

Eastern Shore Rural Health is a member of the Virginia Community Healthcare Association and the National Association of Community Health Centers that serves more than 24 million people in 10,400 rural and urban communities nationwide.

Community health centers are non-profits that serve medically underserved areas or medically underserved populations regardless of patients' ability to pay. These facilities receive HRSA funding.

One in 12 Americans rely on community health centers for medical care, including one in nine children, one in five rural residents, and one in three people living in poverty. These health centers also serve more than 355,000 military veterans.

America's first community health center program was launched in 1965 under the influence of former President Lyndon B. Johnson's War on Poverty initiative, and the founding of the National Association of Community Health Centers followed in 1971.

Pull Up a Seat and Listen or Join the Jam at the Chair Place

Earlier this month, something magical occurred right around where “up the road” meets “down the county.” There would have been standing room only that cold Saturday night, were the Chair Place in Craddockville not aptly named. Those who arrived early claimed seats inside, most of them singular antiques. Latecomers huddled outside around the doorway, telling tales and scanning for a vacant perch. At its peak the crowd looked to be dozens strong.

For the past 18 years, Chair Place proprietor Bill Aeschliman has hosted weekly acoustic jam sessions for a rotating cast of musical characters. These informal gatherings, which take place on Thursdays at 8 p.m., are open to the public and welcoming of new and young talent. On Saturday, Nov. 17, this amorphous collective treated enthusiastic guests to a concert for the ages.

Up on stage, three generations of players wielded hand drums, horns, a keyboard, an upright bass, and about half a dozen guitars. There was a banjo,

a mandolin, and a harp – or harmonica, to the uninitiated. The sound of this jam-packed amalgam could have easily disintegrated into cacophony; to the contrary, it was quite the joyful noise. In fact, the arrangements appeared effortless as the group sailed through compositions by the likes of Johnny Cash, Jerry Garcia, and Bo Diddley. Said Pocomoke percussionist and relative newcomer Pete Bottinelli, “This is the easiest gig ever.”

If so, the quality of the players involved certainly presents no obstacle. The caliber of musicianship at the Chair Place is famously high, to the point where its reputation can sometimes intimidate. When asked why he had taken so long to attend his first jam, Mike Waterfield, of Atlantic, responded, “I had heard the legends and I was too chicken to show up.” He needn’t have been. Waterfield’s performance on lead guitar the night of the concert was masterly; however, virtuosity is not a required credential in this part of downtown Craddockville. All one really needs to be a respectable musician here is a certain measure of curiosity, humility, and perseverance.

Take for example one Alex Holt, a talented up-and-coming young picker with the purplest hair in the place, and no slouch on guitar himself. Holt said he doesn’t find playing with so many old-timers all that daunting, even though most of them probably have decades more experience. “They’re all, like, a thousand times better than me anyway,” he mused (although they aren’t). Hyperbole notwithstanding, Holt’s attitude exemplifies the kind of humble moxie that garners respect from his elders on the scene. It also speaks volumes about an environment in which one so young can feel safe to be vulnerable and uninhibited. Those don’t grow on trees in the way that chairs seem to sprout from the walls of this fertile garden.

And it isn’t only newcomers to the stage whose participation is encouraged and valued. Sporadic singalongs dot the musical landscape to engage the crowd — “Shake, Rattle and Roll” was particularly rousing the night of the concert — and spectators with instruments such as bongos and spoons blur the line between performers and audience. Almost everyone keeps time in some

visible, if not audible, manner, and frequently the entire room seems to pulse and breathe as a single being. As singer Amanda Butler remarked from the edge of the stage, “You’re just as much a part of this as what’s going on up here.” She then proceeded to bring down the house with a, at times, teary rendering of “The Wayfaring Stranger,” a plaintive song taught to her years ago by her late mother, Candy. The Chair Place community shares more than just smiles and laughs.

When asked at the close of the evening how he feels about being the heir apparent to such a scene, precocious young Nathan Butler — nephew of Amanda, the daughter of owner Bill — smiled and said simply, “I just want to keep it going.”

And the Shore will be ever the better place for it if he does.

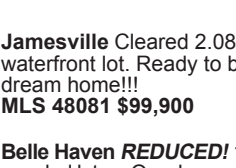

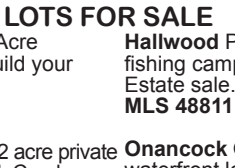

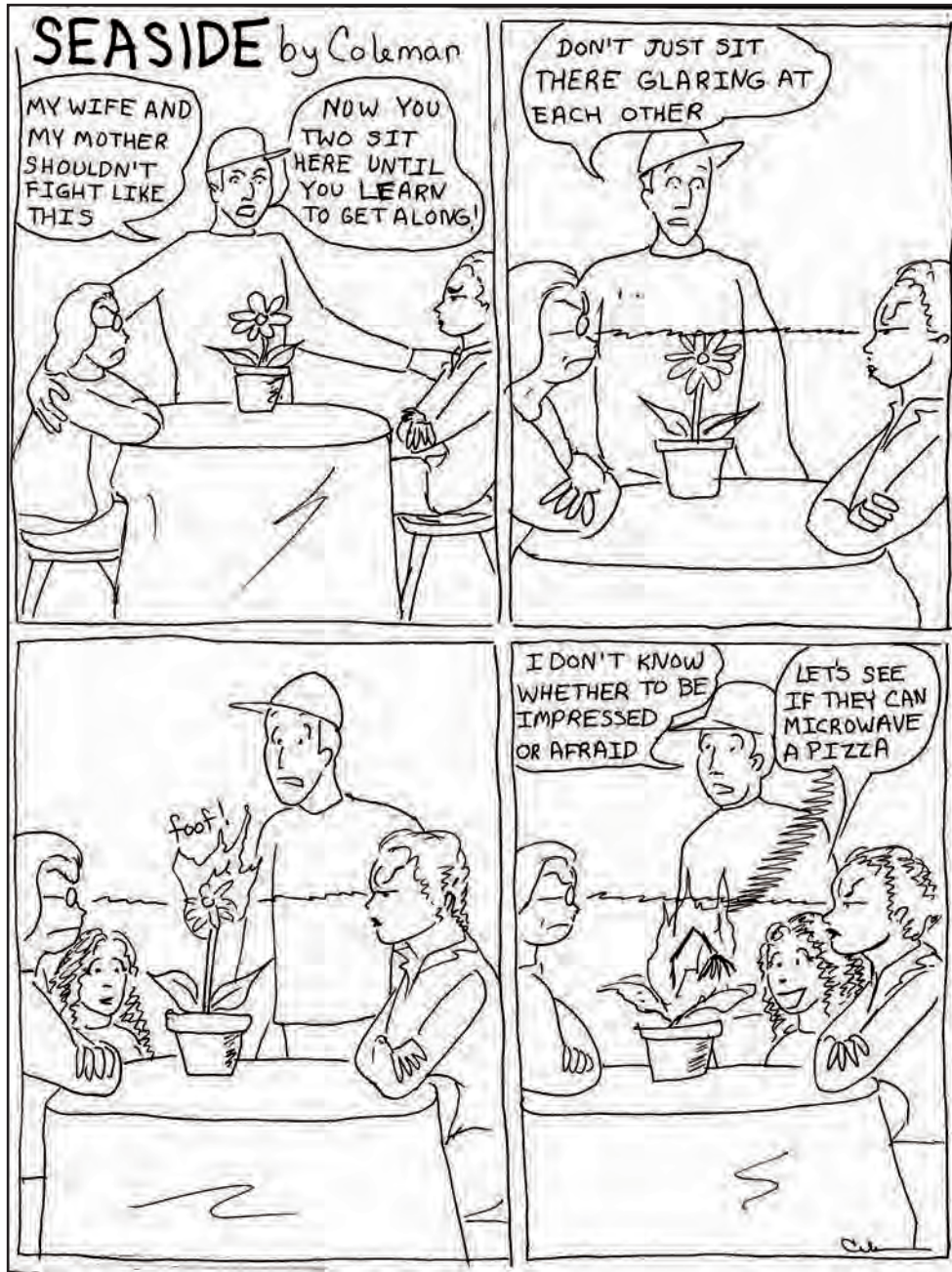
"Our collection of homes is designed to offer something different for each

New Model Says Number of Maryland Market-Size Oysters Half of 1999 Count

A new study of oysters in the Maryland portion of the Chesapeake Bay estimates not only has the population of market-size oysters not rebounded in the last 19 years, it has been cut in half.

A 1999 estimate put the number of oysters in the upper bay at 600 million. A study by Mike Wilberg of the University of Maryland Center for Environmental Science places that estimate closer to 300 million.

The new estimate was derived us-

ing a model. The model, methodology, and conclusions were reviewed by an independent panel of experts in August and found to be sound.

Maryland's General Assembly called for the oyster stock assessment in 2016.

According to a report in the Baltimore Sun, the state is resisting a moratorium for now, although some consider expanding oyster preserves as serving the same purpose as a moratorium, because it prevents watermen from taking oysters within the protected areas.

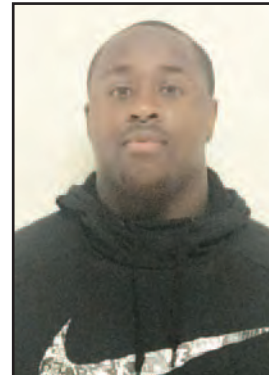

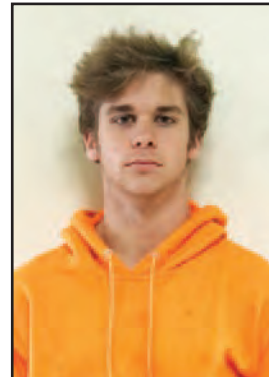

Rain sang the Broadwater cross-country team a lullaby at the VISAA State Cross Country meet on Nov. 9.

Athletes from independent schools across the state – 848 boys and girls to be exact – converged on Fork Union Military Academy in the foothills northwest of Richmond to test their physical and mental strength over the school's hilly three-mile course.

Broadwater competed in the girls and boys races for Division II, which includes schools with smaller enrollments.

running in the last cross-country meet of her high school career.

"We were covered in mud and the times were slow, but it was a memorable way to end our season," added senior co-captain Kate Gomer, who started competing in cross-country for Broadwater in sixth grade.

Led by Gomer, the Broadwater girls placed 16th out of 24 teams. Sophomore standout Mahika Patel crossed the finish line second for the Vikings, followed by Wardius and freshmen Carrie Watson and Ronnie Guinan.

Duo Seeks To Resurrect Railroad, Starting with Cheriton-Cape Charles Trolley

By Stefanie Jackson

The former New York, Philadelphia and Norfolk Railroad (NYP&N) in Cape Charles has been earmarked for historic preservation and economic resurgence by railroad enthusiasts John Paffrath and Roger Malick of the nonprofit New York, Philadelphia and Norfolk Railroad Resurrection.

The duo from across the Bay have received positive feedback on their ideas from Cape Charles residents, including 160 petition signatures collected in

one week.

The railroad organization recently sought support from the Cape Charles town council and the Accomack-Northampton Transportation District Commission.

Their first goal is to establish a Cape Charles trolley system starting at the beach and ending in Cheriton, attracting tourists and locals alike.

The plan is to start out small to see if a new rail system can be economically successful.

But first the group must acquire the rights to use the tracks. "We have to secure the tracks at all costs. All bets are off if there's no train tracks," Paffrath said.

Some existing tracks would remain, particularly those near the harbor and along its perimeter. Many tracks on the parcel between the harbor and Mason Avenue (the town's commercial main street) would be removed. Those tracks would be reused to extend the rail line to Cape Charles beach, if permitted by

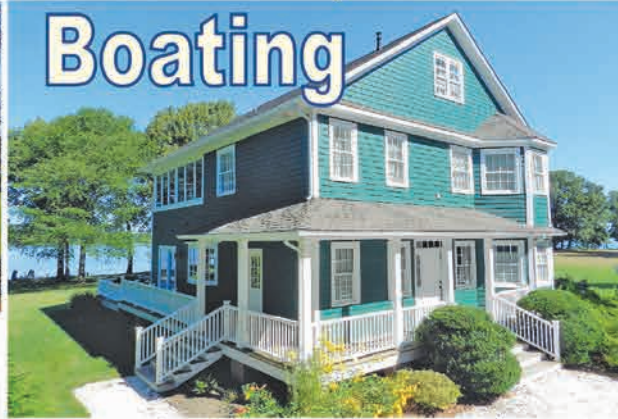

developers building on the land.

Rearranging the tracks and leasing or purchasing a trolley will constitute the project's first phase.

The trolley would be a propane-electric hybrid to keep pollution at a minimum, Malick said.

He recommended a double-decker trolley so tourists could ride on the upper deck in fair weather.

A future project phase could include reconstructing the railway turntable (traditionally used to turn a train around on the track to make a return trip) as an additional tourist attraction.

There is also interest in running

a high-speed ferry between Cape Charles and Norfolk.

Malick discussed strategies that would maximize the rail project's eligibility for federal grant funds.

The Transportation Equity Act for the 21st Century (TEA-21), enacted in 1998, provides funds to help improve transportation infrastructure, encourage economic growth, and protect the

environment.

A TEA-21 grant could fund reconstruction of the Cape Charles train station if the building's original concrete footers are used (the sections that support the foundation). Paffrath and Malick expect the project will qualify for the grant even if the footers are moved from their original location. They would like the

train station to be near the end of Peach Street if that road is extended (across Mason Avenue and approaching the harbor).

The original train station was at the east end of the harbor, near the current location of The Shanty restaurant.

The idea to extend the rail line from Cape Charles to Cheriton is also part of a funding strategy. Connecting the two towns by trolley would be considered a provision of commuter transportation and would open up further federal funding opportunities.

Construction of the New York, Philadelphia and Norfolk line extended the railroad from Pocomoke City, Md., to Cape Charles in 1884.

The NYP&N railroad was built by Alexander Cassatt (the namesake of Cassatt Avenue in Parksley) who Paffrath called a “young upstart executive” for the Pennsylvania Railroad, and William Scott, a member of the U.S. House of Representatives from Erie, Pa.

They created a shorter route from Pennsylvania coal country to the

Hampton Roads coal docks, crossing the Eastern Shore by rail and the Chesapeake Bay by ferry.

Using Scott’s name, Cassatt also bought the 136 acres on which Cape Charles was built.

Decades ago, “it was predicted that the East Coast of the U.S. would become a metropolis from Boston to Norfolk” and “the Eastern Shore would be preserved as a wildlife park,” Paffrath said.

Now the railroad Cassatt and Scott built “is all that is left of their legacy.”

“Times are changing and in order to carry out that ideology very carefully the Shore will have to adapt without exploiting the beauty it is,” he continued.

“If a track cannot be productive, rails to trails (using railroad right-of-ways to build hiking and biking trails) is a great way to preserve the easement,” Paffrath said.

“But wouldn’t it be nice if both coexisted side by side ... and the line served as three divisions: public transportation, tourist rail line, and freight?”

Readers Share Cape Charles Memories and Ideas for Rail Yard

Plans for the future of the Cape Charles railroad yard and memories people have of the town could have a vital connection. Participants of an email survey conducted by the Eastern Shore Post this week were asked about both topics.

Anne Gibbs, a former Shore resident, said she married a man who first caught a glimpse of her in the town more than six decades ago.

"The nicest thing about Cape Charles is my husband saw me walking down the street and asked my cousin's husband who I was," she wrote. "We later met and married." He was the "love of my life."

The young Anne Hopkins lived in Oakland Park near Exmore and was visiting her uncle for dinner. Her cousin was also there with her husband and child. Hopkins took the "little girl for a walk and this young man saw me with her," she wrote. That man, Randy Gibbs, who grew up around Bayview, and Hopkins, married a year later. Randy Gibbs died in

2011. "We were married 53 years and five months."

"He knew whosse child it was, as my cousin was married to one of his best friends," Anne Gibbs continued. "He asked them who I was and the next day, he came to my home with my cousin and her husband so he could meet me." It was Oct. 13, 1957. "We were married in 1958."

"He was in the Navy and I was going to nursing school at Nasawadox," she continued. "I finished nursing school and we began our military life. We

were married in my parents home ... I was involved in a train accident in 1956, almost lost my life," Anne Gibbs said. "My husband always said God saved me for him."

She didn't give her opinion on the best use of the rail yard but she made it clear all Cape Charles is all about love for her.

Cara Burton, director of the Eastern Shore Public Library system, suggested a town commons be constructed with new accessible town offices, a large meeting hall,

a public library, a visitor kiosk, an outdoor seating area with shade "for people to mingle and enjoy the hometown feel of Cape Charles."

"The Cape Charles Memorial Library is well used and, while quaint, its building limits the programs, technology, and book collections the community and visitors need," wrote Burton. "Public libraries are gathering spaces and provide towns the opportunity to celebrate its culture and provide diverse learning experiences."

The library is in a former bank in town.

"My childhood memories are of going to the antique store," Burton said. "Eastern Shore antique stores and auctions were history and cultural museum experiences for me."

Heather Burkett, of Sanford, recalled the gazebo on the beach and a bed-and-breakfast where she stayed with her mother and sister several times. She suggested that trails — nature, walking and for bicycles — be put at the rail site.

Julie Nash, of Parksley, suggest-

ed a park venue, picnic area, and amphitheater to be considered. “The health walk that I took with my students,” was a favorite memory in Cape Charles. “We had so much fun that day taking pictures, laughing, and taking in all the beauty of Cape Charles. We are so blessed. Also lunch with my friend Paul Muhly. We ate at the converted old plantation house right across from the bay. We were served lunch on the porch and we watched a big ship go by with a grand American flag. It was a beautiful day.”

Judy Brunk, of Jamesville, has found memories of King’s Creek and the two old sunken boats there. She would like to see “a rest area with picnic tables and a roof over them like at Kiptopeke Park. People could have a place to rest when shopping and sight-seeing. Restrooms would save the merchants unnecessary traffic and high water bills.”

“Maybe if you have a few cars or get some train car kits and turn them into some small businesses,” said Marilyn Wohlrab, a shop owner in Parksley. “Expand your current museum, dedicate different train cars to different eras ... I have seen

how Cape Charles promotes and wish I was there instead of here.”

Ken and Mary Dufty, of Wardtown, noted “fishing from the pier, enjoying the beach and the many eclectic shops and galleries that make Cape Charles fun and memorable.

“Certainly Cape Charles and the county will come up with an exciting project and development plan, but a combination of storefronts, a tourist draw — museum/theme park, concert venue — and hotel may be

worth considering,” he wrote.

“I directed a chorus there,” said Shirley Christian, of Melfa. “The people were exceptionally friendly and kind, so I would have to say, the people” are her favorite memory.

Bill Payne, of Cape Charles, favors recreation, housing, and commercial ventures for the rail yard. His favorite memory of the town is “its rebirth.”

Lisa Lindberg, of Nassawadox, suggested “a hiking path that is dog-friendly” for the site.

“I have always said that the best use for the old railroad tracks, which would include the Cape Charles tracks, is for the governments, state and federal, to reuse the existing infrastructure for a lite rail system that could possibly start at the Pocomoke City, Md., area and run the entire Shore to Cape Charles with some stops along the way to other towns,” wrote Alex Coleman of Wachapreague. “I think this would help

businesses that are dying out, rebuild the local economy, and help the ones less fortunate that can't drive to go to places along the Shore whether it is for work or for just a day out shopping, dining, or meeting family and friends."

Coleman's favorite memories of Cape Charles are its sunsets at the beach, browsing through Watson's Hardware and "lately the brewing company, distillery, and the newest shops."

Wesley Edwards, of the Belle Haven area, is chairman of the Accomack Economic Development Authority. "The books should be open so the owners — Northampton and Accomack tax payers — can have an informed opinion," he wrote. "If the assets are to be sold they should be equally divided between the two counties where the taxpayers have been subsidizing for many years, while big assets disappeared and big salaries were being paid to a few." He answered "none" for his fa-

vorite memory of the town.

Robert F. Doughty, of South Chesconnessex, remembers visiting his grandmother in Seaview when he was a child. "We would always drive to Cape Charles to get her a block of ice for her icebox. She didn't have electricity. The ice plant was where Rayfield's Pharmacy is now."

Doughty said the rail yard will "most likely" be made into "single family homes with shops, restaurants, and a grocery store.

Valerie Vandegrift, of Virginia Beach, Va., suggested a Wal-mart or Harris Teeter grocery be built on the rail yard. "With all the tourists, you need a grocery store in town and a C-store (convenience store).

Her memories include "the trains when my father was a fireman for Pennsylvania Railroad and we could catch the train and go to Michigan every year. Also, Griff's, Kenny's, Palace Theatre, Savage's Drugstore were hangouts for teenagers."

"I would like to see a water-themed park similar to the Central Park at the school" for the railroad yard, wrote

John Griffith, of Cape Charles. His favorite memory "is just growing up in our little town. We knew everyone."

Nicki Tiffany, of Cape Charles, favors his historical railroad preservation. Her favorite thing about the town in the last few years has been Festive Fridays.

"I think that the best use of the railroad property in Cape Charles would be some kind of publicly accessible active railroad exhibition park that could, in time, and with grant money, transition to an operational local public transportation and freight business, wrote Junius Neville, another Cape Charles resident. "An organization, NYP&N Resurrection, has organized for this purpose." The website is <https://www.nypnrr.org/>

"My best memories of Cape Charles are of growing up here in a town that was the epitome of small-town America in the 1950s," Neville continued. "We didn't have a car because we could walk to school, the doctor, the movie theaters, and the grocery store, and had local access to most anything we wanted or needed. Couldn't have asked for a better place to grow up."

CAPE CHARLES MEMORIAL LIBRARY LAUNCHES 100TH ANNIVERSARY CELEBRATION

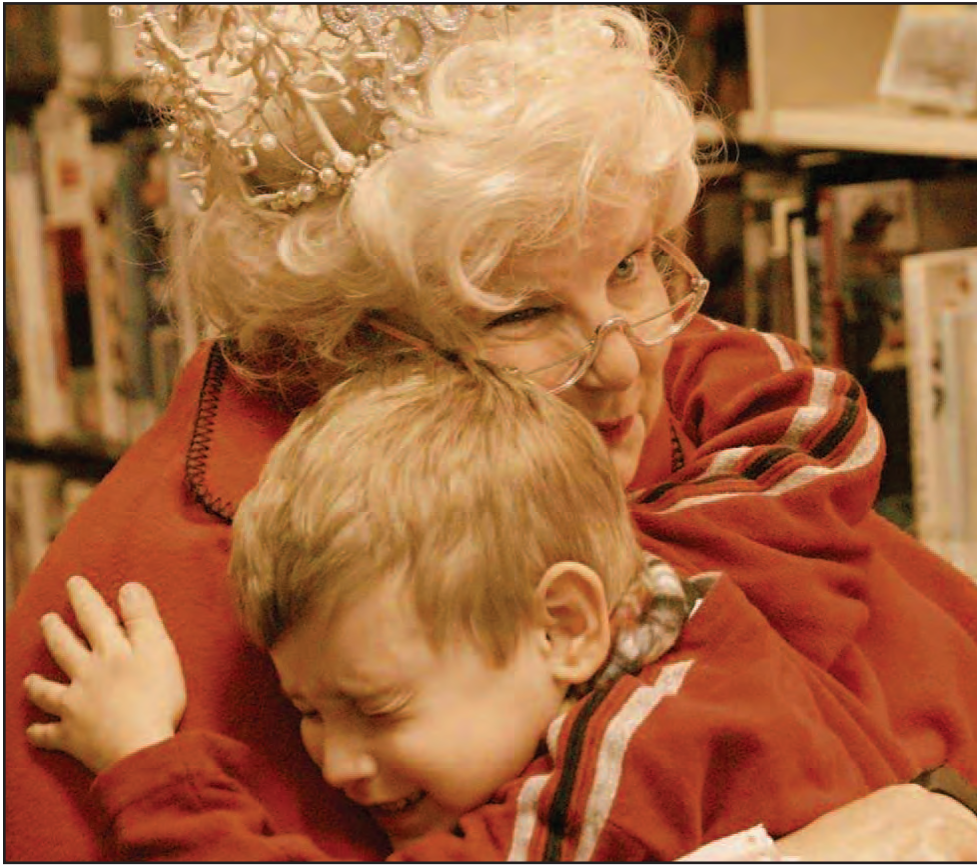

The Cape Charles Memorial Library won't reach its 100th anniversary until June 2019, but it's not too early to start celebrating. The party officially starts during Festive Fridays in December.

Kids are invited to the library on Friday, Dec. 7, at 6:30 p.m. for a free event, the Children's Christmas Candlelight Story Reading.

Mrs. Santa Claus will stop by to read Christmas classics by candlelight to boys and girls, a special tradition at the Cape Charles library.

The name was changed to the Cape Charles Memorial Library in 2009.

The library moved again in 2013, into the former bank building at 201 Mason Avenue, its current location.

HAND CRAFTED ALCOHOL KEEPS CAPE CHARLES IN HIGH SPIRITS

With the opening of three establishments offering distinctive craft alcoholic beverages in Cape Charles, one could say the town is in high spirits going into the holiday season.

The first to open was Cape Charles Brewing Co., which spent a year readying a former lumber yard on Stone Road.

"It's a great little seaside town, very close to the Hampton Roads metropolitan area," said owner Mark Marshall in an interview last November with the Eastern Shore Post. "I know people will be willing to cross the bay." The property, he said, lends itself to special events. "We want to be a destination," modeling the Cape Charles Brewing Company after other successful Virginia destination breweries.

What does Cape Charles have in common with those locations? "They are literally nowhere. The closest urban areas are 40 minutes, and they are still successful," said Marshall. "They have mountains, but we have one of the greatest beaches."

The beach town was already on the radar of Will Correll, owner of Buskey Cider on the Bay. His grandmother had family ties to Cape Charles, spending summers there. Correll had spent time there as a kid.

Buskey Cider is based in Richmond, but when people started telling Correll he should look into Cape Charles as a second tasting room location, "I drove out with my wife," who is also his business partner.

"The pieces just came together," said Correll. "We found a neat piece of real estate" at 109 Mason Ave., and "local distributor Wendell's wanted to pick us up." Within a month of first considering opening a satellite tasting room, the new Cape Charles location was open.

He found an able workforce in off-duty teachers. "It's more education and entertainment" than waiting tables, he said, and "teachers were a good fit."

Even though high season is over, the tasting room remains open Thursday through Sunday. "It's fun," he said. "I'm out there almost every week."

The Cape Charles Distillery has also

dropped back to Thursday-Sunday operations.

It boasts of cooking locally grown corn and grains with mountain spring water to create its flagship bourbon, whiskeys, moonshine, and vodka.

While the distillation is done off-site, the spirits are labeled for Cape Charles and mixed and served in concoctions meant to celebrate the town's heritage.

Its purpose is "celebrating Cape Charles' rich history," according to the company's Facebook page. Company representatives were unavailable for an interview.

All three locations emphasize mak-

ing the most of the town's unique character, while making their own contributions to the local flavor.

"We're going to give them another reason to come to the Eastern Shore," said Marshall.

Good Beer and Good Design Come Together on Stylish Label

Carter Tuttle, a native of Wachapreague, used the existing Cape Charles Brewing Co. logo with the local lighthouse to design the label for the company's crowler cans, the 32-ounce containers that are filled with tap beer and then sealed on site for customers to take home.

"There are really two things in play," said Tuttle, who now lives in Del Ray, a small neighborhood in Alexandria, Va., but comes back home to visit family and friends. Tuttle is also the company representative for Southern Graphic Systems at Nestle in Northern Virginia. "I love good beer, and in my professional life, I specialize in printing and packaging for consumer goods," he said.

Tuttle learned about the Cape Charles brewery in early 2017 "after reading a few online articles announcing the plan to build at the old Reliable Building Supply location on Stone Road."

Two brothers, Chris, and Mark Marshall, joined forces with their mom, Deborah Marshall, to start the business.

"I initially reached out to Chris asking if I could help design some of their packaging,"

Tuttle said. "At the time, packaging was not a top priority, but once the brewery found out one of their beers would be featured on the Discovery Channel show "Killing Fields," we kicked things into high gear and started to work on various label designs."



Tuttle and Chris Marshall "have a lot of mutual friends, but we had not met prior to working together."

Tuttle has brewed his own beer. "My father (Joe Tuttle) got me interested in brewing after I tried some of his home-brewed ginger beer," Tuttle said. "Cape Charles Brewing's operation is really impressive. Despite being relatively new to the brewing scene, they brew a strong variety of styles. I have yet to spend a day brewing with the team there, so I can't really comment on technique. That said, after sampling a few flights of their beer, I couldn't find one I didn't like."

"There were a lot of good beers to choose from," Tuttle said. "If I had to pick a favorite it would be their Weizenbock. It's a really cool mashup of a traditional wheat Weizen ale and a malty sweet bock style beer."

The Cape Charles Rotary Club is doing something new. It's offering 100 percent crab meat, no-filler, crab cakes just in time for your holiday season festivities.

The history of the Cape Charles Rotary Club crab cake began in the 1980s when a donated pop-up tent trailer was converted into a crab cake sales stand, and the club began its signature fundraising program. Back then, sandwiches were prepared and sold at Cape Charles' July 4th and fall festivals.

Selling the sandwiches to the general public was fun, but it was also hard work and sales were limited. Furthermore, the health department began to frown upon the cooking arrangement and the "crank-up" camper

became a maintenance issue. Around the turn of the century, the club skirted these issues by simply selling uncooked cakes.

By eliminating the deep-fryer, the club was able to distribute their gastronomic seafood delights up and down the Eastern Shore. In fact, more than 3,000 crab cakes have been sold annually for the last three years. The crab cakes are offered in trays of six for \$40. Orders are requested by Dec. 7 for Dec. 14 delivery.

EDITORIAL

Not taking action to remedy Northampton High School's structurally unsound condition is like waiting to see if a hurricane will increase from a Category 4 to a Category 5 storm before evacuating.

The delay could kill someone.

Meanwhile, members of the Northampton Board of Supervisors continue to deny the seriousness of the structural issues. They appear to be keeping their fingers crossed while waiting for a solution to materialize. The school board is at the supervisors' mercy. It is spending money at the supervisors' behest to get yet another opinion.

Parents have told the supervisors they

want action. School officials have told the supervisors a new school is needed. The Post has been writing stories about the condition of the building for years.

The supervisors contend there may be no money for the project without a significant tax increase. An investment firm has run multiple scenarios on possible funding options without increasing taxes, and with different levels of tax increases.

The school continues to deteriorate. Nothing changes but the faces of the children.

Cracks in the walls of Northampton High are as wide as an inch. Think about that as you stare at your bedroom wall while trying to sleep at night. The small gymnasium walls have bowed far enough

to knock the padded mats from the walls. In the 2007 report titled, "Another Brick in the Wall," the circa 1954 building was already in "poor" condition.

What will happen if your child, wife, husband, mother, father, or other relative is injured on the premises from a wall collapse?

Recently, Superintendent Eddie Lawrence told the Eastern Shore Post, "Northampton County Schools does have a liability insurance policy on its buildings." That will be cold comfort in the aftermath of a serious incident.

On top of that, Northampton doesn't have an emergency storm shelter, so Accomack must step up and open one in one of its schools for Northampton

residents. It is the right thing to do.

Northampton doesn't have a plan if the high school was to be closed by the state. So again, Accomack might be asked to come to the rescue.

The school is operating with the threat of catastrophe.

Perhaps Accomack County should be preparing for an influx of educational refugees equivalent to the entire Northampton High population. A weather disaster could cause such a circumstance in this geographic location. Some Nandua High School classes are already crowded.

Trying to stall the inevitable is irresponsible. It will take time to plan and build a new facility. Meanwhile, 2019 elections are getting closer.

Had these sites been checked ahead of time, this probably would not have happened. Also, the fact that it was a probably unregulated, unregistered investment instrument with a "guaranteed" rate of return should have been red flags. It also looks like a case of "affinity fraud" where the perpetrator first insinuated himself into the organization to earn their trust.

I certainly hope the fire company recovers its money,

but I would be pessimistic on this score. That is why I refer to this as a teachable moment for other organizations.
