## Islanders and Others Grieve Another Chincoteague Pony Death From 'Swamp Cancer'

Messages of support and grief from across the country were posted on the Chincoteague Volunteer Fire Company's Facebook page this week in response to an announcement that another member of the famous herd of wild ponies died Monday from swamp cancer or pythiosis, a fungal infection.

"Last week I told you all that we weren't out of the woods yet," a fire company representative wrote. "Well, today, precious little Rain Dancer galloped over the rainbow bridge. This baby just couldn't kick it and developed some ligament and tendon issues related to this disease. The buy-back owners have been notified and again, we ask for your patience and support in this matter. Our vet has been up here every other day and of course our great team of cowboys have basically put their lives on hold attending to these ponies."

The comments noted the firefighters' relentless commitment to the ponies.

The swamp infection occurs in a wound or cut when the animals stand in water that has pathogens. Areas that don't have harsh winters are more likely to see problems because the water there doesn't freeze.

Five other ponies are continuing to recover from the infection.

## Cheriton Appoints Hardesty to Open Council Seat

The Cheriton town council determined in late October it would appoint a new council member at its next regular meeting on Nov. 28, but by that date the open seat had already been filled by Greg Hardesty, who had previous experience on the council.

Hardesty replaces former Councilman Wesley Travis, who resigned

on Sept. 26, citing his disapproval of the manner in which the council handled the firing of Cheriton Police Chief Marc Marshall.

According to Virginia law, a special election must be held for the open council seat, but the council may appoint someone to fill the seat until the special election is held.

Cheriton Mayor Larry LeMond not-

ed that arranging special elections is costly, and he requested that Cheriton's special election coincide with the next general election on Nov. 5, 2019, to reduce the cost to the town.

Cheriton's May election cost \$1,900, LeMond said, but holding a special election at the same time as a general election would only cost \$200 to \$300.

# Repairs To Begin on Northampton High School Auditorium Walls

The Northampton school board chose a local contractor to repair the badly damaged exterior walls of the Northampton High School auditorium in a unanimous decision Nov. 29. The contract was awarded to Jim Wert Builder Inc., of Belle Haven.

The local contractor submitted the low bid of \$49,271. Conrad Brothers Inc., of Chesapeake, Va., which previously had done similar work on the high school cafeteria, submitted a bid of \$59,888.

Northampton schools Director of Operations Chris Truckner was initially concerned about the \$10,000 gap between the two bids received, but after further discussion of the work with a representative of Jim Wert Builder, Truckner recommended accepting the local contractor's bid.

Both bids were low in Truckner's opinion. He suspects that after the project is begun, workers will discover further damage that needs attention, which was the case when the cafeteria walls were repaired about three years ago.

Truckner is staying "open-minded" about how much work the auditorium will need. The contractors are "being realistic and have black and white plans in front of them," but "once they get in there and start removing the veneer, that's when we're going to find out the unforeseen," he said.

When the cafeteria wall repairs were started, after the veneers were removed "we found out that there was over nine-and-a-half inches of movement in the top corner and cracks you could stick your arm through," Truckner said.

The demolition portion of the auditorium project will take place during Christmas break or on weekends when no students or staff are present on school property in case of a "catastrophic failure."

In light of Truckner's suspicions, Northampton schools Chief Financial Officer Brook Thomas made the unconventional decision to build a 50 percent contingency into the project cost. (Most construction projects include a contingency of 5 to 10 percent of the total cost to cover unforeseen

expenses that may be incurred during the course of work.)

Thomas proposed transferring the \$65,116 left from the cafeteria project to the auditorium project and appropriating an additional \$33,426 for a total school budget appropriation of \$98,542, exactly double the bid submitted by Jim Wert Builder.

Thomas' intent is to avoid a delay such as stopping work during the two-week Christmas break for an emergency school board meeting to authorize more funds if additional necessary repairs are discovered after the work is begun.

However, "I can guarantee you that the final scope of this project is going to be far greater than \$98,000," Thomas said.

Truckner warned that the metal roof decking over the auditorium is corroded and rotted, and it will be "completely destroyed" and need to be replaced by the time the wall repairs are completed. The roofing just outside of the auditorium project area will also be affected.

Making only the immediately nec-

essary roof repairs will cost about \$200,000 as opposed to \$700,000 or \$800,000, Truckner said.

## Audio Recordings

School board member Nancy Proto made a motion suggesting audio recordings of the school board's public meetings should be made available on BoardDocs, the website used by Northampton schools and many other organizations to store and manage meeting agendas, minutes, and other documents.

Proto, an at-large school board member and resident of Cape Charles, says several citizens in her jurisdiction have requested audio recordings of school board meetings because they can't attend due to work or family obligations.

They also complained that school board meeting minutes are often not completed and not posted on BoardDocs until a month or two after the meeting and the minutes are difficult to locate on the website.

Proto envisioned an inexpensive solution – posting the simple audio recordings that Executive Secretary

Karen Pitt makes and uses when compiling meeting minutes.

Superintendent Eddie Lawrence said if the school board would make audio recordings of its meetings available to the public, it should be done right. An audio recording system with nine or 10 microphones for use by school board members, the superintendent, and citizens making public comments is priced at \$3,500 to \$4,000 – a prohibitive cost.

School board Chairman William Oakley said he didn't know if it was necessary "to react to a small group" and he would be more apt to support Proto's idea if there was a large group backing it.

School board member Randy Parks was concerned that the knowledge of being recorded might "diminish" the "spontaneity among us."

"I don't mind saying something stupid in front of you guys, but maybe if the whole world could be listening I will be, you know, less spontaneous," he said.

Proto's motion was not seconded and there was no further discussion of the matter.

# Firefighters Use Pots and Pans to Douse Blaze Until Truck Arrives

Armed with fire extinguishers, a watering can, and pots and pans of water, Tasley firefighters battled a blaze at the circa 18th-century house, Ravenswood, Sunday until an off-road truck was able to get through a muddy two-mile private driveway to bring equipment and water to the scene.

"It was a first for me," Deputy Fire Chief Don Amadeo of Tasley Volunteer Fire Company said Tuesday. "Never had to pile a crew on a tractor to get to a house fire in my 34 years in the fire service. The owner of the property, Bill Valentine, met us on his tractor as we were walking in and gave us a ride. We couldn't get the engine to the house due to the recent wet weather making the driveway impassable to anything but four-wheel-drive vehicles."

"It was a good save," Amadeo added. "We were lucky the occupants of the house had also used extinguishers ... that undoubtedly bought us some time ... minimal fire damage to one bedroom, attic, exterior wall, and porch. Yes, they are still living there."

Firefighters from Wachapreague soon arrived in a brush truck that carries equipment and water and were able to get through the muddy path near Daugherty. The call came in at 8:33 a.m. In addition to Tasley and Wachapreague, units from Parksley, Onancock, and Melfa responded. There were no injuries. Onancock and Melfa rescue volunteers and ambulances were also there.

Amadeo said the fire started in an outside light fixture. About 100 gallons of water were needed to fully extinguish the blaze. There was a garden hose attached to a spigot on the other side of the house but the hose wouldn't reach the fire.

"Great work was done by all compa-

nies involved in this difficult situation and damage was held to a minimum," according to Tasley Fire Company's Facebook page. "Units cleared in about two hours."

Fire Chief Jeff Beall was in charge. He was not available for comment.

**NASA Wallops Flight Facility**  
**Draft Shoreline Enhancement and Restoration Project Environmental Assessment**  
 December 2018

NASA announces the availability of the Draft Shoreline Enhancement and Restoration Project Environmental Assessment (EA) for renourishment of the infrastructure protection area at NASA Goddard Space Flight Center's Wallops Flight Facility (WFF), Accomack County, Va.

The Draft EA evaluates the environmental consequences of a range of reasonable alternatives that meet NASA's needs, as well as the needs of the other federal Cooperating Agencies, restore the Wallops Island shoreline in order to reduce the potential for damage to, or loss of, NASA, U.S. Navy, and Virginia Commercial Spaceflight Authority's Mid-Atlantic Regional Spaceport assets on Wallops Island from wave impacts associated with storm events.

The Proposed Action would involve placement of approximately 1.3 million cubic yard of sand in areas that have been eroded in recent storm events. Sand could come from the north Wallops Island beach or from offshore Unnamed Shoal A. Additionally, NASA may construct a series of parallel nearshore breakwater structures that would reduce the intensity of wave action and slow sediment transport.

# EXMORE'S NEW WELLS OUT FOR BID; SEWER SYSTEM STILL NEEDS ATTENTION

Exmore's economic infrastructure continues to grow and town officials are working steadily to get water and sewer service up to par and find employees to keep the town running.

By fall, Exmore will have new wells and a greensand filtration system, improving the overall taste, odor, and color of town water.

The project was put out for bid on Nov. 18. Bids will be accepted until Dec. 18 at 2 p.m.

Exmore is expected to break ground on the well project in late January and the new system should be ready to go in October, around the same time the town will make the first loan payment to the Virginia Resources Authority.

The total cost of the project that the town began planning five years ago is approximately \$1.8 million before adjusting for inflation. More than \$800,000 is covered by the loan the town will repay. Exmore received more than \$500,000 in state funding for principal forgiveness and an-

other \$500,000 from the Virginia Department of Housing and Community Development.

"It's better than paying full price," Town Manager Robert Duer said. "We got \$1 million free."

"I guess it's better to get hit with a whiffle ball bat than with a steel one," Mayor Douglas Greer remarked.

Exmore's sewer system is operating at a loss on nearly a monthly basis and Duer advised the town council that sewer rates must increase next year, especially if the town gets a new sewer system. The sewer rate is currently \$39.50 per month and will need to increase to at least \$60, Duer said.

Duer will attend a U.S. Department of Agriculture meeting on Dec. 20 regarding the sewer system. The possibility of USDA funding is one of three options being considered for the town's sewage needs.

Exmore will need two new employees in its public works department. The town advertised for someone to fill the director of public works posi-

tion held by Mike Johnson, who died last month. An additional person will be needed to monitor the new well system. That position has been offered to a current town employee who will need to be replaced.

Exmore's two newest police officers, Jonathan Gonzalez and Brian Parks, graduated from the police academy on Nov. 20 and each must complete 100 hours of field training before officially starting work. The town's police force will increase from four to six officers.

"Six is better than four. ... Do you think seven is better than six?" citizen Brenda Sample Bailey asked. She suggested now is the time to begin planning to hire another police officer so training can be completed in time for the busy summer months.

"Exmore's getting ready to blossom," she said.

"I got a plan for that," Duer answered.

Another Exmore police officer, Jason Campbell, celebrates eight years with the department this month.

A fast-food restaurant and two gas stations in town are preparing to remodel to draw more business. "We're on the rise," Duer said.

In other business, Duer suggested transforming the area outside the Exmore town hall, on the corner of Main Street, into a memorial park to honor longtime town employees who have died.

There is already a memorial stone and tree there in honor of former police chief Steve Elliott. Duer would like to add two benches bearing the names of Mike Johnson and 17-year public works employee Johnny Alaniz who died in 2014.

The town council consented to Duer's suggestion and Bailey requested that the possibility remain open for other names besides those mentioned to be memorialized. Duer agreed.

Exmore's annual Christmas parade will be Saturday, Dec. 8, 6 p.m.

The townwide, outdoor Christmas lighting contest will be Friday, Dec. 14, from 7 p.m. to 9 p.m.

Northampton circuit court judge, Hon. W. Revell Lewis III, informed LeMond he would only consider the request if the town met the legal requirement to appoint an interim council member within 45 days of the previous council member's resignation, making Nov. 10 the deadline.

The council was compelled to make the appointment three weeks earlier than they planned.

Jason Van Marter was the first candidate to speak at the Nov. 7 special meeting.

He is fairly new to Cheriton, but he has been associated with the town for 13 years through family.

Van Marter mentioned the town motto, "Small Town, Big Heart" and said, "I can offer some fresh ideas to help fill that vision ... and, hopefully, make some changes that can help us grow into the future that is pounding on the Shore's doorstep."

"If elected, I'll do my best to help out with the town; if not elected, I'll

still be the same," he said.

Neither Scott Berger nor Hardesty was able to attend the meeting, but Town Clerk Stacey Salenski read their comments into the public record.

Berger said the "two primary driving forces in my life" are "to solve problems and to help others," the reasons for his 25-year career as an architect designing buildings for the military.

Berger and his family "are come-heres, but that means we have a choice and we chose Cheriton."

Hardesty indicated the "extensive roots" he put down in Cheriton in 1977 at age 14. The Northampton High School graduate worked in various jobs across the Bay before returning to Cheriton 12 years ago. He now works in aquaculture.

Hardesty served two previous terms on the town council and volunteered for the Cheriton fire department.

Bruce Nutter withdrew his candidacy but volunteered his advice to the town council: "bring some diversity in, like younger people that have a level head on their shoulders."

Only 25 percent of Cheriton's population is age 62 or older, Nutter said, and younger citizens like himself "feel pushed out, and we don't feel like we're being represented very well."

"That's why all the anger is coming through the community," Nutter continued. "This is an emotional thing for all of us because we love the town so much."

Councilman Barry Downing said he does not object to young people serving on the council, but it would

be fair to choose the candidate who had the most votes at the May election – Hardesty.

Downing nominated Hardesty, seconded by Councilwoman Norma Spencer.

Councilwoman Jackie Davis nominated Van Marter, pointing out that he participates in every council meeting. Downing seconded that motion.

Hardesty won in a 3-1 vote.

Van Marter plans to run for the Cheriton town council in the special election expected to be held in November.

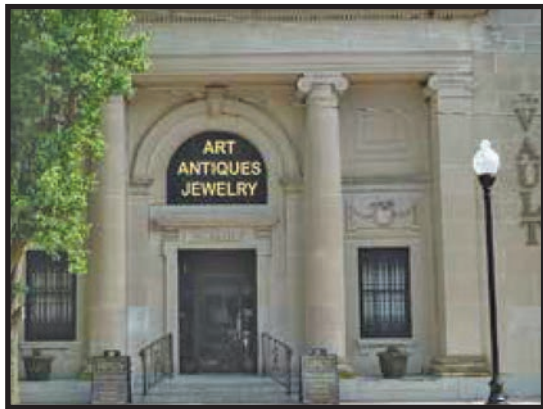

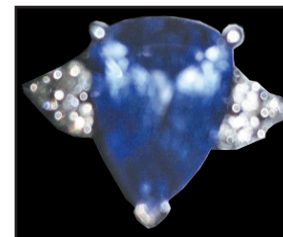

### Indictments Handed Down in Accomack

A former Accomack man, who was convicted last year in Maryland for having sex with a child, was indicted Monday by an Accomack grand jury on counts of embezzling from the Marine Science Consortium on Wallops Island while he was the office and finance manager there.

Dallas Fenton, 59, who lived on Lankford Highway in New Church, is serving decades for the sex offenses. He is in the Roxbury Correctional Institution, in Hagerstown, Md., but will likely be extradited from there to stand trial here.

Commonwealth's Attorney Spencer Morgan would not comment on how much money or property Fenton is suspected of taking from the consortium. The indictments said he stole from the agency between January and March 2015, May and October 2016, and October 2016 and January 2017. Special Agent Robert Barnes, of the state police, investigated.

Fenton's LinkedIn page also states he was once a business manager for Northrup Grumman at Wallops Island.

According to a report, Fenton was convicted of eight counts of a third-degree sex offense, sexual solicitation of a minor, and indecent exposure. He was sentenced to 38 years in prison with 15 years suspended. He met the 14-year-old through an app called Whisper, chatted with the girl on Skype, and then went to Wicomico County, Md., "four times where he had sex with the teen. At one point, he had sex with the juvenile on the side of the road and then dropped her off at a middle school dance."

In another case, Keshawn Abbott, 26, of Fox Grove Road in Parksley, was indicted on counts of arson and burglary at a house belonging to Christopher Kuhn last July. Barnes investigated the arson. Deputy C. Hargis, of the Accomack County Sheriff's Office, investigated the burglary.

Darek Earl Snyder Sr., 38, of Costen Road in Westover, Md., was indicted on seven counts of grand larceny of copper wire that belonged to ANEC. The offenses occurred between July and October on property at Mears Sta-

tion Road, Firehouse Lane, Mappsville Road, Greenbush Road, Cashville Road, Daugherty Road, and Folly Farm Road.

Investigator Aaron Turner, of ACSO, gave information to the grand jury about Snyder.

Tyris Javon Davis, 29, of Kelly Road in New Church, was indicted of unauthorized use of a vehicle belonging to Jerome Holden and hit-and-run with injury in connection with Aug. 4 incidents. Trooper D.P. Tudor investigated.

David Anthony McCain, 28, of Boston Road in Painter, was indicted on counts of obtaining property by false pretenses from Walmart and a third or subsequent offense of petty larceny, on Sept. 21. Both charges are felonies. Cpl. C. Hodgson, of ACSO, investigated.

### Felony Cases Heard In Accomack

Several felony cases were heard last week in Accomack Circuit Court.

Yun Kim, also known as Joshua, 20, of Vanalden Avenue in Northridge, Calif., pleaded guilty to carnal knowledge without force of a 13-year-old. The offense occurred in Accomack between April 4 and May 31, 2017. A presentence report was ordered. The case was continued until January. Kim is being held in Accomack Jail.

Devan Hinman, 29, who was listed as homeless with a former address on Saxis Road in Temperanceville, was sentenced to 10 years in prison with all but a year and 10 months suspended for possession of heroin with the intent to distribute. He was also given a 30-day suspended sentence for possession of marijuana, a 60-day suspended sentence for possession of cocaine, and a three-year suspended sentence for possession with intent to distribute cocaine.

Mark Warren Holcomb, 57, of Ridge Road on Chincoteague, was given three years in prison for assault and battery of a police officer with all but six months suspended. He was ordered to be on good behavior for five years.

Christine Huffman, 22, of Stone House Road in Onley, was sentenced to 12 months in jail with all but time served suspended for uttering in September 2017. Unsupervised probation was ordered. Huffman will be on good behavior for 10 years.

Thomas Phillips Collins, 47, of Hemlock Lane in Horntown, pleaded guilty to making a threat to Judith Meseke to burn a structure on March 27. He was

also charged with making threats to two others but those charges will not be prosecuted in accordance with a plea bargain. The case was continued pending completion of a pre-sentencing report. Records stated Collins could be fined up to \$2,500 and sentenced to up to 10 years in prison.

### Attorney Withdraws From Defending Man Accused Of Trying to Kill Officer

Attorney Allan Zaleski, of Norfolk, Va., was granted a motion in Accomack Circuit Court last week to withdraw as the defense lawyer for a man suspected of attempting to kill an Accomack deputy.

A new lawyer will have to be appointed for Deandre Breshon Ayres, also known as De'Andre Breshon Ayres and Deondre Brashaun Ayers, 29, of Hanson Avenue in Norfolk, and previously of Painter.

It was disclosed during the hearing that Ayres had made complaints about Zaleski, who has practiced law for about 50 years.

Ayres was indicted on counts of attempted capital murder of an officer, use of a firearm in a felony, possession of a firearm by a felon, shooting from a vehicle, shooting at an officer's squad car. The charges stem from incidents that occurred Sept. 26, 2016.

Maryland officers were investigating a robbery at the PNC Bank in Pocomoke at about 2 p.m. that day. Authorities said three people threatened to blow up the bank, but did not display weapons or explosive devices to tellers. Afterward, they were seen running towards the 6th Street Car Wash and getting into a silver Chevy Malibu with a Virginia tag.

Just after hearing an alert, Deputy Eric Nottingham of the Accomack County Sheriff's Office saw the vehicle fitting the description near Temperanceville. He followed and when it ran a stop sign, he attempted to pull the car over.

"The vehicle was acting like it was stopping," Nottingham testified at a preliminary hearing. It rolled to about 5 to 10 miles per hour "and then floored it and went up to 80 to 90 mph." When the car suddenly jammed on the breaks, Nottingham saw an arm come out of the driver's window with a gun pointed towards him.

"It started popping off," he said. "I



heard metal clanking around. I just heard a whole bunch of shots." Nottingham put the squad car in reverse and the Malibu took off again. The deputy tried to chase it but his car quit running. "Three bullets struck my vehicle, one of them hit the transmission cord," he continued.

An Eastern Shore man was charged with hit-and-run this week in connection with a traffic accident that occurred in Northampton County last summer, according to court records.

Juan Alfaro Rea, 43, with addresses of Crystal Beach Road in Onancock, and Beacon Street in Melfa, was arrested Dec. 3 for the June 30 incident. He is being held without bond. Trooper C.R. Hughes investigated.

### Bond Granted For Woman Accused of Sex Crime Against Child

A \$10,000 secured bond was granted Tuesday in Northampton Circuit Court for a young Exmore woman accused of committing sex crimes against a 13- or 14-year-old girl.

Melissa Spates, 19, of Exmore, was indicted on counts of taking indecent

liberties with a child, attempted sodomy with an object by force, and contributing to the delinquency of a minor in connection with Sept. 8 incidents.

Judge W. Revell Lewis III set conditions to the bond. Spates is not allowed to have any contact with the victim or the victim's family and is not allowed on social media for the duration of the case. Spates was arrested Nov. 14.

In another case, Jabias Keandre Kellam, also known as Nika, of Exmore, failed to successfully complete the youthful offender program. The sentences for his crimes were reinstated. He was given 15 years with six years and seven months suspended and indefinite probation for both burglary and robbing a business with a gun. The crimes happened in August 2015.

Kellam was 18 and living in Willis Wharf when he robbed a nine-year-old girl with a semi-automatic pistol at El Rachito store in Cheriton.

Daniel G. Randall, 45, of Exmore, pleaded guilty to petty larceny, a misdemeanor, and was given a 12-month suspended sentence. He was initially indicted on a count of robbery by violence. The incident occurred July 28.

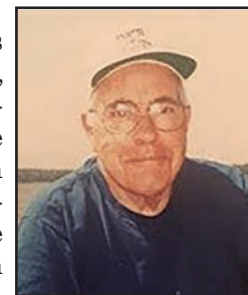
## Billups E. Lodge

# Elected Officials Preview Next Legislative Session at Annual Eggs and Issues

Virginia politicians representing citizens from Accomack and Northampton counties gave their constituents a preview of the first session of the 2019 general assembly at the semi-annual Eggs & Issues breakfast sponsored by the Eastern Shore Chamber of Commerce Dec. 5.

State Sen. Lynwood Lewis announced the six-week session will begin Jan. 9.

Virginia passes a two-year state budget in every even-numbered year, so 2019 will serve as what Lewis dubbed a “tweaking year” in which adjustments are made to the budget prepared by former Gov. Terry McAuliffe and submitted by Gov. Ralph Northam.

Lewis said Virginia is one of the last states to recover from the Great Recession, but the state economy is in good shape.

He cautioned the audience that “the rubber band snaps back eventually” and Moody’s financial forecasters predict a mild recession in late 2019.

But Lewis added the state’s rainy day fund is “robust” and Virginia is one of only a few states to maintain the highest rating of “AAA” with all three bond-rating agencies, meaning it is financially strong and able to repay its debts.

The state has a \$500 million budget surplus, but Lewis indicated that money will be spent on “bills in the drawer” like healthcare and the state retirement system.

He said state unemployment stands at 2.9 percent, the lowest it’s been in 11 years and almost a record low. He acknowledged that Accomack and Northampton counties “still have ground to make up” in lowering unemployment.

According to the Virginia Employment Commission, the current unemployment rate is 3.4 percent in Accomack and 4.7 percent in Northampton.

Both Lewis and Del. Rob Bloxom emphasized the need for Virginia to examine tax conformity, or how well state tax laws align with federal tax laws.

State legislators are undecided

whether they want to conform to the current federal tax code that will no longer be in effect in four years.

Lewis and Bloxom offered different ideas on how to improve Virginia’s tax code. Lewis conveyed Northam’s interest in making the earned income tax credit refundable on the state level as it is on the federal level, at a cost of \$250 million.

(When tax credits are nonrefundable, taxpayers cannot be refunded more money than they paid. When tax credits are refundable, taxpayers are paid the total dollar value of the tax credits even if they do not owe taxes or are owed a refund.)

Bloxom is considering raising sales taxes and eliminating the state income tax.

He believes his most controversial idea is allowing a noncitizen working in Virginia to obtain what he calls a “driver’s privilege card” so any Virginia resident working in the state, even if that person is not a citizen, can legally obtain a driver’s license if they have a valid passport.

In the pursuit of fairness, Bloxom fa-

vors requiring state parks to pay transient occupancy taxes like privately owned campgrounds. He also supports requiring an online business to charge sales taxes like a business operating in a physical storefront.

As an accompaniment to the proposal to charge sales taxes on online purchases, Lewis said legislators are considering offering state funding for school infrastructure. The estimated cost for all current construction needs of Virginia public schools is \$3 billion to \$6 billion.

“Traditionally, that has been a local responsibility,” Lewis said, “but we’re so down the rabbit hole” legislators feel obligated to step in. He cited Northampton High School as a prime example of a school that needs assistance.

# NASA HAS PAID HIGH SCHOOL SUMMER INTERNSHIPS

Pat Benner, the education specialist and internship coordinator at the NASA Wallops Flight Facility, spoke to the Accomack school board at Chincoteague High School on Dec. 4 about opportunities the facility offers to students.

Students interested in STEM careers (science, technology, engineering, and math) are welcome to apply for summer internships at NASA.

A summer intern is paid a stipend of \$2,400. There are minimum requirements to apply to the program: the student must be a U.S. citizen age 16 or older, live within a 50-mile radius of the facility, and maintain at least a 3.0 GPA.

There are 12 slots available for NASA internships, but only two were filled last year. "We need our local students at Wallops Flight Facility," Benner said.

Job Shadow Day, held every year around Groundhog Day, is a chance for students to meet employees at Wallops Flight Facility who work in the students' career fields of interest and spend the day learning their jobs.

Often, students' job shadowing experiences will lead to summer internships

at the high school level and college undergraduate level, Brenner said.

NASA also offers fall and spring programs, with student participation counting as credit in their high school classes.

Benner said, "It is my job and my joy" to work with young people.

Chincoteague High School Principal Harold Holmes recommended March 2 Success, an educational program introduced to him by Sgt. Juan Cortazar, of the U.S. Army recruiting station in Salisbury, Md.

March 2 Success is a free program for students ages 13 or older who want to improve their performance on standardized tests such as the SAT, ACT, and the military entrance exam, the Armed Services Vocational Aptitude Battery (ASVAB).

# Sentence Reduced for Jailhouse Witness in Murder-for-Hire Case

The prison term of a Cape Charles man, who testified in August against the alleged shooter in a murder-for-hire scheme, was reduced by a month Tuesday in Northampton Circuit Court.

Danny Lashawn Campbell Jr., 32, formerly of Wilson Court, testified he was in jail with Roquan Leeteq Rogers and Rogers confided in him details about the murder conspiracy.

In May, Campbell was sentenced to 15 years in prison with 11 years suspended for possession of cocaine with intent to distribute. He was also given five years with a year and eight months suspended for a third offense of assault and battery of a family member.

The terms were set to run concurrently for a total of seven years and four months. Campbell's offenses occurred in September 2016 and June 2017. During Rogers' trial, Campbell said no promises were made in exchange for his testimony.

"Mr. Campbell provided the Commonwealth of Virginia with substantial assistance in the prosecution of Roquan Rogers for, among other charges, attempted first-degree murder in the Accomack Circuit Court,"

defense lawyer Paul Watson wrote.

Judge W. Revell Lewis III reconsidered the term for family member assault Tuesday and suspended a year and nine months of the five-year term.

Rogers, also known as Kake, 19, of Benjamin Banneker Road in Exmore, was convicted by an Accomack Circuit Court jury of three counts of conspiracy. The panel was deadlocked on nine other counts including attempted capital murder of an Eastern Shore Drug Task Force informant and his then-girlfriend last Halloween in the Boston area of Painter.

The jury recommended a total of 17 years in prison with 10 years for conspiracy to commit capital murder for hire, five years for conspiracy to commit capital murder involving a prisoner, and two years for conspiracy to commit obstruction of justice.

When the jurors were polled, a male juror said that he did not agree with the recommendation.

In that case, Lewis could decide the sentence himself or impanel another jury. If the latter is done, Lewis said the jury would be read the transcript omitting parts that were done in the absence of the jury or that the jury was told to ignore.

He chairs the VFBF Specialty Crops Advisory Committee and is a member of the organization's Compensation Committee. He is a past president of the Accomack County Farm Bureau and former chairman of that organization's Young Farmers Committee.

In addition to his Farm Bureau involvement, Hickman is a board member and past chairman of the Virginia Irish Potato Board, a member of the Accomack County Board of Equalization, and a member and past director of the Virginia Potato and Vegetable Growers Association.

He is a co-owner and operator of Dublin Farms Inc., which produces corn, potatoes, snap beans, soybeans, and wheat. He and his wife, Chessie, have three sons, two of whom are involved with the farm operation.

### Sign Up Now for the Gift of Conservation

Are you shopping for ways to improve the health and function of your land in the coming year? USDA's Natural Resources Conservation Service (NRCS) is now offering the gift of conservation with customized



plans for large and small acreages and funding through the Environmental Quality Incentives Program (EQIP) to help put them into action.

Virginia farmers and forest landowners can sign up for financial assistance to install recommended conservation practices on cropland, pastureland, and non-industrial private forestland. NRCS accepts applications year-round but makes funding selections at specific times. Those interested in fiscal year 2019 funding must submit applications on or before Jan. 18.

NRCS will continue to accept general EQIP applications with these special fund pools available to Virginia producers/landowners:

- High Tunnel System – Steel-framed, polyethylene-covered structures to extend the growing season in an environmentally safe manner.
- Longleaf Pine – Stand establishment and management within the historical range in Southeastern Virginia;
- Northern Bobwhite in Working Grasslands – Native grass restoration to address habitat loss while maintaining or improving cattle production on the land.
- American Black Duck Initiative – Focused conservation practices to restore wintering habitat in the Delaware Bay and Chesapeake Bay watersheds;
- Golden-winged Warbler – Young forest habitat restoration in Appalachian breeding territory.
- National Water Quality Initiative (NWQI) – Targeted practices to clean up impaired streams and improve aquatic habitats in the War Branch and Mountain Run watersheds in Rockingham County and Gap Creek in Rockingham and Shenandoah County.
- On-Farm Energy – Agricultural

Energy Management Plans (AgEMP) or farm energy audits to assess energy use and recommend ways to reduce it.

- Organic – Practices to help certified organic growers, those working to achieve organic certification, and specialty crop producers address resource concerns on their operations.

- StrikeForce – Priority ranking for cropland, high tunnel, and livestock practices to support program participation among underserved producers in rural communities.

- Joint Chiefs Landscape Restoration Partnership – Cropland and forestry practices to reduce wildfire threats, protect water quality, and enhance wildlife habitat in the Upper and Lower Cowpasture watersheds.

- Conservation Activity Plans – Development of site-specific plans to recommend conservation practices that will address an identified natural resource need.

Each applicant should submit a signed and dated Conservation Program Application to the local NRCS service center by close of business on the published deadline for a given batching period. Applicants must meet USDA program eligibility requirements to be considered for funding. NRCS will not accept applications from individuals/entities without farm records established through USDA's Farm Service Agency. The name, tax identification number, and address provided must also match IRS income tax records.

Applicants approved for financial assistance will receive a payment based on an NRCS determination of incurred costs and income sacrificed for practice implementation. If you previously applied for EQIP and were not funded, contact your local NRCS Service Center for more information.

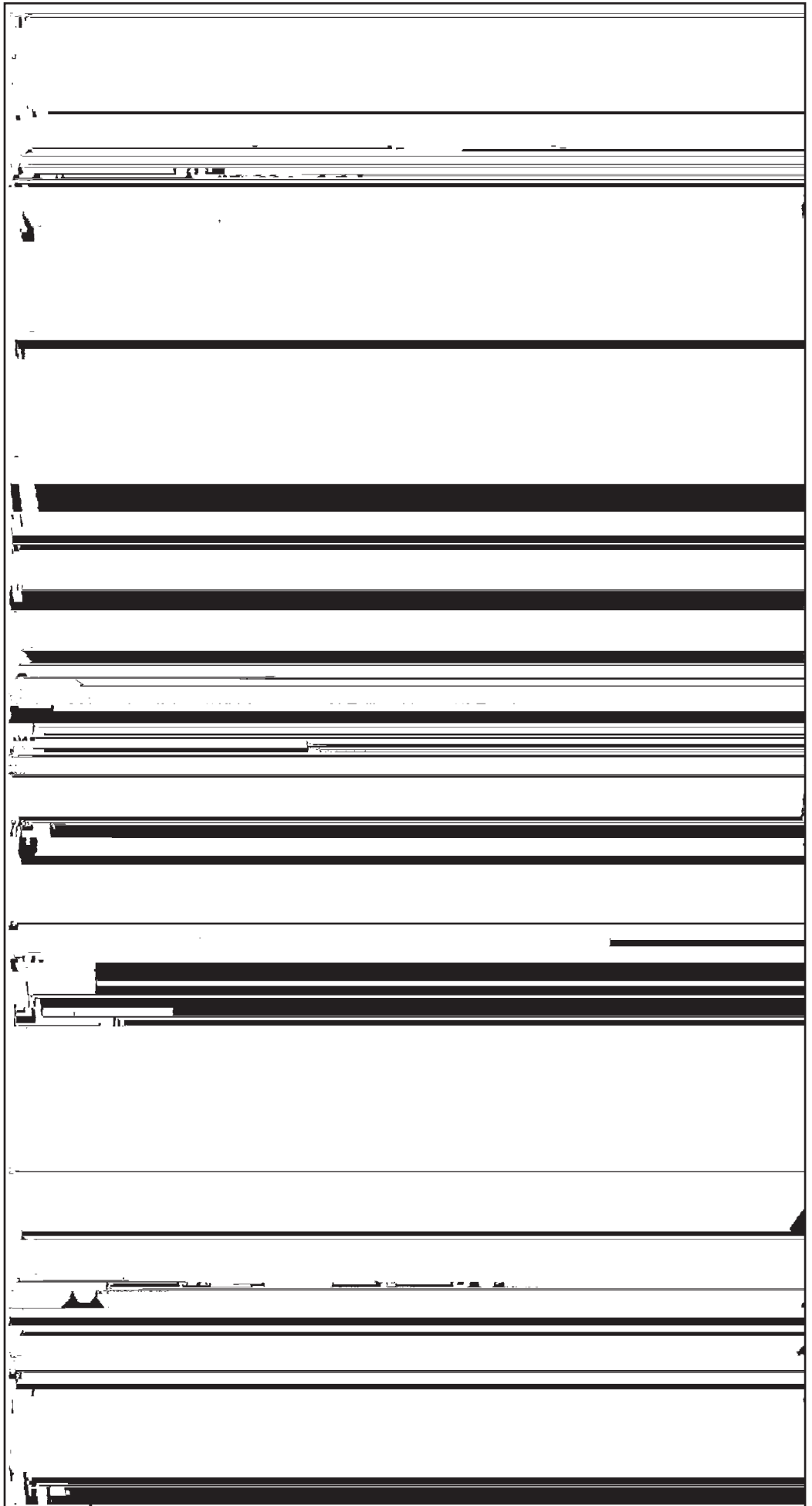
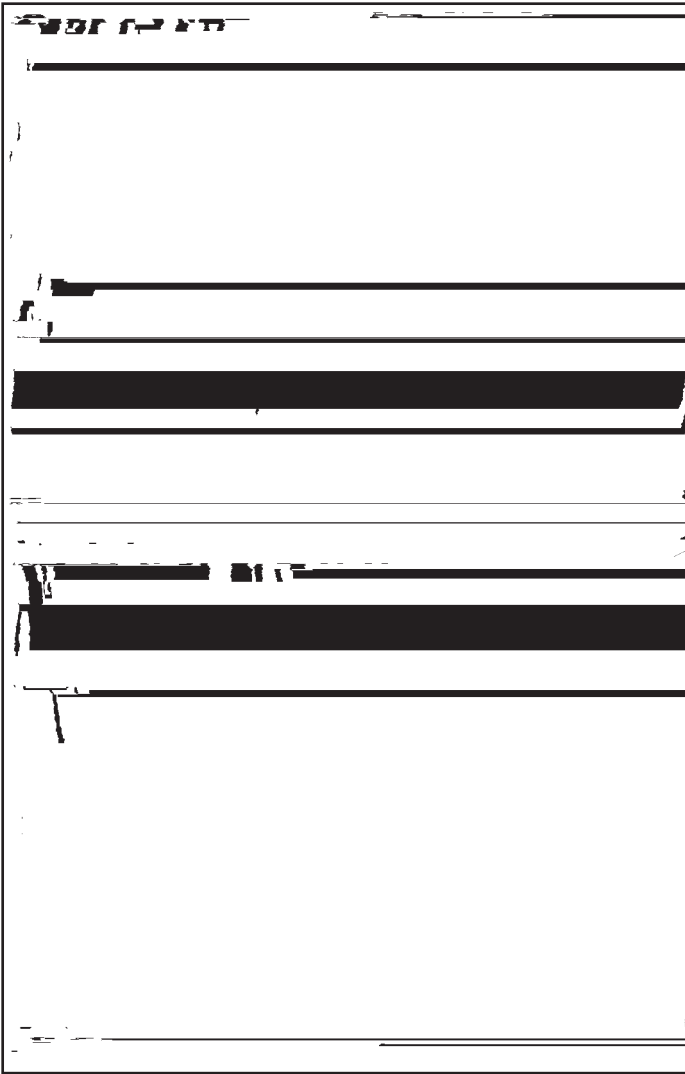

## New York Businessmen Living Large at the Accomac Club

*Information for the following article was drawn from the resources of the Eastern Shore Room, soon to be expanded into the Eastern Shore of Virginia Heritage Center within the ESVA Regional Library to be built in Parksley.*

The most luxurious of the gunning clubs that sprang up on the Eastern Shore seaside in the late 1800s was the Accomac Club, situated on a point of high marsh between Wachapreague and the north end of Parramore Island. The club was incorporated Jan. 12, 1887, with seven members, all of whom were businessmen from New York. The club's first president was Benjamin W. West, secretary of the Fulton Market Fishmon-

gers Association, and the vice president was S.L. Stoner, president of the same association.

The club grew quickly and limited its membership to 35 men, most of whom were business associates. New members were admitted only by unanimous vote and were required to pay a \$100 initiation fee plus \$75 in annual dues, billed quarterly.

The club built a large two-storied clubhouse with a wide porch, plus separate dining quarters, a cookhouse, boathouse, and numerous other improvements. Old photographs depict the dining room as especially ornate, with intricate woodwork and expensive furniture. An excellent reproduction can be seen at the Barrier Islands Center in Machipongo.

The initial assumption is that the wealthy New Yorkers, isolated in their island womb of privilege, far removed from the sweat and toil of the commoners along the Wachapreague waterfront, probably kept their distance from the local folks. Newspaper accounts of the day, however, tell a different story.

The Peninsula Enterprise, a newspaper published in Accomac, provided regular coverage of the Accomac Club, especially when the annual regatta came around in May. The Countryside Transformed, a digital archive of maps, photographs, and printed media maintained by the Eastern Shore Public Library, has files from the Enterprise dating back to the 1880s, so we can tune in to our

computers and read all about the latest news from the Accomac Club.

The Enterprise reported on June 6, 1891, that several hundred local people attended the regatta, where local boaters competed for trophies and prizes. Following the races, visitors returned to the clubhouse "where a sumptuous and elegant dinner, furnished by the Club, was spread, and where costly Madeiras, Hollands, Cognacs, and lager flowed as from a living fountain, of which not a few freely partook."

Following the feast, prizes were presented to the winning sailors, and speeches were made. Abel Crook, a New York lawyer and secretary of the club, made "one of the most beautiful and thrilling addresses to the winners

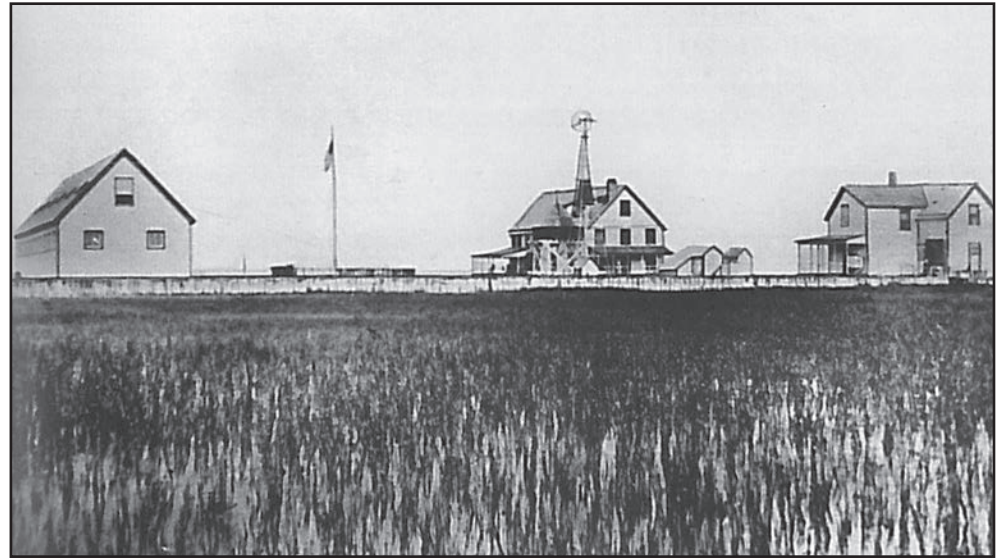
and to the citizens of Accomac your correspondent has ever heard." His speech was responded to by George F. Parramore, Esq. "in a felicitous and forcible speech that carried conviction to the hearts of all present."

The regattas were held annual-

ly for a number of years, with the club hosting hundreds of local residents and providing prizes such as gold watches and silver tea sets. A sumptuous dinner would be served, and then a member of the club would make a speech extolling the virtues of Accomac (as it was spelled then) County, and a county representative would respond in turn. In 1896, the celebration featured music by the Cashville Cornet Band.

Many of the old gunning clubs fell victim to a rising sea level and the disastrous storm of 1933. The Accomac Club, however, was a victim of the Great Depression, which eroded the fortunes of most of the members. By the time the '33 storm hit, membership was down to "six or seven men."

The old seaside gunning clubs are a part of local history that leaves no footprint. Most of them long ago washed out to sea. But if you're heading from the Wachapreague dock out to the Dawson's Shoal area, look to the south where a cluster of pilings line the edge of the high marsh. A century ago, this was one

# Holly Run Is a 50-Year Christmas Tradition for Tangier Island

Weather permitting, about 50 small planes will leave a Maryland airport near the Chesapeake Bay Bridge tomorrow morning heading for a tiny airstrip on Tangier Island to continue a tradition that was started 50 years ago.

The Christmas season on Tangier Island really kicks off with the Holly Run that was first started by a lone aviator and now includes more than 100 people and delivers evergreens to the island's churches and toys to the youth.

The tradition began in 1968 when Ed Nabb, a Cambridge, Md., attorney who often visited Tangier to patronize his favorite sandwich shop, realized the holly trees and evergreens were no longer available because of rising waters.

Acting alone, Nabb loaded up his Er-coupe plane with two boughs of holly and flew them to Tangier, giving one to Swain Memorial United Methodist Church and the other to New Testament Church. Adventure and generosity guided Nabb's life. He was elected to the Marine Racing Hall of Fame in 1947 and funded thousands of dollars in scholarships.

The event is always set for the first Saturday in December, but rain postponed the flight last week. With good weather, pilots will depart the Bay Bridge Airport in Stevensville, Md., tomorrow morning with numerous bags of holly and one special passenger, Santa Claus, bearing gifts for the island's kids.

Many of the pilots making the 71-nautical mile flight to Tangier Island are employees or students of Chesapeake Sport Pilot, a flight school based in Maryland's Queen Anne's County.

Celebrating the 50th anniversary of that first flight, the pilots have expanded its mission of bringing holly to the island by also giving away school supplies to the island's teachers. "Chesapeake Sport Pilot looks to help the community in any way it can," said Helen Woods, owner of the school and organizer of the event for the past eight years. "Teachers on the island can't just run out to Walmart like we can."

The group this year is also helping to spay and neuter the feral cat population on Tangier.

"It's a really wonderful holiday tradition," added Woods. "The details have evolved over the years, but the spirit remains the same."

would gather. Marshall would lead a discussion of life on Tangier.

Now 91 and no longer able to greet the pilots, Marshall fondly recalled those early days of the Holly Run. "Mr. Nabb was just a wonderful man," she said. "I often had him here to the house for lunch. We looked forward to his visit every year, and I know he enjoyed coming to Tangier with the holly each Christmas."

The group piles into Lorraine's for lunch after delivering the holly to the churches. Lorraine is Marshall's daughter and recalls waiting on Ed Nabb when he first started making his visits to the island. "He just had a big heart and enjoyed helping others," said Lorraine,

whose daughter, Jamie Parks, also works in the restaurant. "We enjoy having the pilots here each year. It really starts the Christmas season for us."

Hedy Bowden, 71, also has been among the Holly Run greeters for over 30 years and continues today, usually escorting Santa Claus to the church on her golf cart. "All the kids on the island look forward to the day and gather at the airport to see Santa come off the plane," she said. "We take Santa to visit any kids who are sick and unable to make it to the airport. It's a wonderful thing they do for the island."

Nabb passed away in 2002, but his son, Ed Nabb Jr., is an honored guest today. "Tangier was his getaway place. It was a good excuse for him to fly his plane, have some great seafood, and visit with friends and talk about things that did not have to do with legal issues since he practiced in Maryland," said Nabb Jr.

Unlike his father, who never attended law school and was among the last to read for his law degree, Nabb Jr. was busy with law school and thus did not make the Holly Run trips in the early years. However, he also got his pilot's license and when a second plane was purchased in 1986, Nabb Jr. became a regular. By then, the number of planes making the trip was growing each year.

"Before we had computers, we would copy the information and mail to all the pilots. It became quite a process to coor-

minate everything to make the trip," recalled Nabb Jr.

Early on, one of the participants would wear a Santa Claus hat and hand out candy canes to the young ones. Nabb said that changed when Jim Schultz took on the role of Santa Claus. "He looked the part. He didn't need anything but the suit. When he agreed to make the trip, he said he had one condition — that he be allowed to buy presents for the children out of his own pocket. And that's what he did right until he died in 2012."

Ralph Hoover has taken over as the Holly Run Santa, very capably filling some big shoes, with his wife Laura ac-

companying him as Mrs. Santa Claus.

When Nabb Jr. retired, he handed the reins off to Woods. "She has done a great job of organizing the Holly Run. There's a cutoff limit of 50 planes because of the limited parking space on the island. All the credit for the Holly Run today goes to Helen and her team," said Nabb Jr., 68, who still looks forward to the Tangier visit each year.

In 1968 when Ed Nabb first started flying evergreens to Tangier, the island had more people and considerably more land than it does today. As documented in numerous newspaper stories, TV accounts and, most recently, a

book, "Chesapeake Requiem - A Year with the Watermen of Vanishing Tangier Island," by Earl Swift, who spent 14 months living among the islanders, Tangier's population has dwindled from more than 1,200 in the early 1900s to approximately 480 today. Its land mass has shrunk by two-thirds since 1850, from 2,173 to 789 acres and is now losing at least nine acres a year.

Scientists have projected that without some dramatic change or steps to prevent erosion, Tangier Island will not exist in another 50 years. In August it was announced that construction of a \$3 million seawall is to be completed in 2019. But Tangiermen have heard such announcements before and know time is growing short for action.

Chris Gunther, who flies each year and handles media requests for the Holly Run, said he hopes the tradition of hauling evergreens to Tangier will continue for many more years. "I am happy to be a part of the history of the Holly Run," he said. "It is a great way for two communities to

come together. Pilots have a great excuse to fly one last time before winter sets in. People from Tangier Island open their church, museum, and restaurants for us. I am pleased we are able to help in the ways we do."

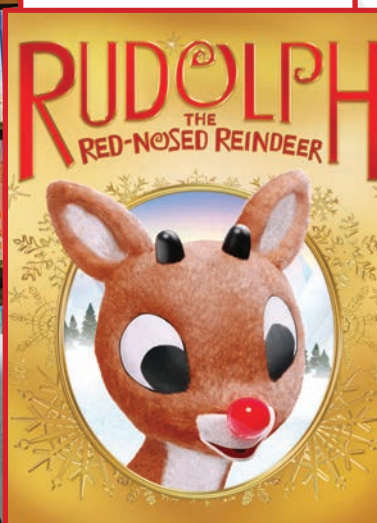

# Pulitzer Prize-Winning Historian Shares Lessons for 'Leadership In Turbulent Times'

Pulitzer Prize-winning, best-selling, world-renowned historian Doris Kearns Goodwin came to the Eastern Shore this past weekend to sign books for a VIP crowd and then give a one-hour talk (to a sold-out audience at Nandua high school) on her latest book, "Leadership in Turbulent Times."

Goodwin, 75, is on a national book tour that started in early September and has included more than 50 engagements in major metropolises like New York City, Boston, Miami, Washington, D.C., London —and, yes, Onley. She was wrangled to the Eastern Shore through some local connections, including Megan Ames, of Parkley, who works with Goodwin on her speaking engagements.

Goodwin's appearance was a coup for the Historical Society of the Eastern Shore of Virginia and the Joan Marshall Lecture Series, which is made possible by the Jane Batten Donor-Advised Fund of the Hampton Roads Community Foundation. The lecture series is named for Joan "Johnny" Marshall, former president of the historical society. Amy Savona, of the historical society, said that the VIP reception was limited to 60 attendees and sold out at \$100 per ticket. The general admission tickets also sold out at a total of 470, \$10 for members of the historical society and \$15 for nonmembers.

Goodwin's interest in presidential history began when she worked as a White House fellow during the Lydon Johnson administration, later assisting Johnson with his memoirs. She has written seven books about presidents and one memoir. In 1995 she won the Pulitzer for "No Ordinary Time," her history of Franklin and Eleanor Roosevelt during World War II. Her book about Abraham Lincoln's brilliance as a politician, "Team of Rivals," was

adapted into a screenplay by Tony Kushner for Steven Spielberg's 2012 movie, "Lincoln," which was nominated for 12 Academy Awards. Daniel Day-Lewis won the Oscar for his portrayal of Lincoln. At her Nandua High School talk Saturday, Goodwin said she was the one who convinced Spielberg to include in the movie a story that Lincoln liked to tell about the British hanging a portrait of George Washington in the privy.

Goodwin has an incredible amount of energy, arriving at the Charlotte Hotel in Onancock around 8 Friday evening, staying one night, traveling the local area the next day, making the reception and speech that night, then leaving early the following morning for Washington, D.C. One reception attendee said Goodwin was the Energizer Bunny.

On Saturday while at the Charlotte Hotel, she fielded multiple phone interviews from news organizations that wanted her perspective as a presidential historian on the presidency of George H.W. Bush who died Nov. 30. She told the Eastern Shore Post that Bush's legacy was not restricted to his time as president but should be viewed in terms of his whole life. "His legacy is one of public service, of devotion to country and family, and of decency."

This was Goodwin's first trip to the Shore, which she called "a magical place." She toured Accomac, Onancock, Onley and told the Post she was impressed by the area's "beautiful churches" and "amazing houses."

Although her current book's title, "Leadership in Turbulent Times," sounds as if it was written for today, Goodwin said during her talk that she chose the title five years ago. The book covers the special circumstances faced, and leadership shown, by four presidents: Lincoln, Theodore Roosevelt, Franklin D. Roosevelt, and Lyndon B.

Johnson. In her presentation, Goodwin outlined the leadership qualities of those presidents and emphasized that those same qualities can be applied to our personal and business lives.

Goodwin said one quality of good leaders is that they surround themselves with talented people who are not afraid to speak truth to power. She said one prime example of this kind of presidential advisor was Eleanor Roosevelt who disagreed with her husband, Franklin, whenever she thought he was getting something wrong.

Goodwin explained that Eleanor Roosevelt was also an advocate for women. When women reporters weren't allowed into White House briefings, Eleanor Roosevelt made a rule that no men, only women reporters, could attend her First Lady press conferences. This forced newspaper editors around the country to hire women reporters for the first time, launching many news careers for women. Eleanor Roosevelt also championed women working in factories and shipyards, a move that was opposed by the owners because they feared production would drop if women joined the workforce. But when the owners of those facilities were forced to hire women during the worker shortage created by World War II, the owners discovered that productivity went up. Goodwin

said studies showed that the reason for this rise in productivity was that women workers asked for directions on how to operate machinery "while you men, well, you know that window never goes down to ask directions."

As expected from a writer who has become enormously successful at popularizing history, Goodwin proved to be a good storyteller. Her audience frequently laughed and applauded and, at the end, gave her a standing ovation. She's also a fast speaker. It seemed her listeners got a 90-minute speech compressed into an hour. And although she decried the lack of civility in our current times, she never mentioned President Donald Trump.

# Are you a fan of the Great British Baking Show?

## Do we have a Christmas side dish for you: *Hot Water Crust Vegetable Pie*

### Hot Water Crust

#### Ingredients:

- 1lb., 3.5 oz. plain flour, sifted, plus extra for dusting
- 1 teaspoon salt
- 2½ oz. chilled butter, cut into cubes
- 7fl oz. water
- 5½ oz. lard or shortening, cut into cubes, plus extra for greasing
- 1 egg, beaten, to glaze

1. Mix the salt into the flour. Cut the butter into the flour as you would for a regular pastry crust.
2. Bring water to a boil over medium heat. Add the lard/shortening and let it melt.
3. Make a big hole in the middle of the flour and pour in the liquid mixture.
4. Mix with a wooden spoon until all the flour is incorporated and the mixture binds together. Place the dough on a floured surface and knead until smooth. Divide the dough in half. Divide each half into three-quarter and one-quarter pieces for the pie and the lid.
5. Grease an 8- or 9-inch springform pan.
6. Form the pie by rolling out the three-quarters of one pastry ball and fitting to the springform pan. Be sure to pat it into the corners and along the side.

### The Vegetable Filling

#### Ingredients:

- 2 red onions (thinly sliced for caramelizing)
- 1 pound of carrots (chopped into matchsticks)
- 8-9 oz. of fresh mushrooms, sliced (We used a combination of portabella and shiitake.)
- 24 oz. of potatoes, sliced
- ¾ of one can of cream of mushroom soup (We used some that had added garlic in it.)
- 1 ½ cups of vegetable broth
- ½ teaspoon of thyme
- ½ teaspoon of marjoram
- 2 tablespoons of cornstarch
- Egg wash (optional): One egg mixed with one tablespoon of half-and-half

1. Preheat oven at 350 degrees Fahrenheit.
2. Line hot water crust pastry along the bottom and sides of a greased springform pan as instructed in step 6 above. (Reserve one-fourth of the dough for the lid and decorations.)
3. Align the potatoes along the base of the pie.
4. Add carrots in on top of the layer of potatoes.
5. Add mushrooms tossed with 2 tablespoons of cornstarch on top of the layer of carrots.
6. Add caramelized onions on top of mushrooms.
7. Sprinkle thyme and marjoram on top.
8. Whisk together soup and vegetable broth and pour into the pie (half of the mix in each pie).
9. Roll out the lid and add on top of the pie.
10. Crimp the edges to prevent the juices from seeping out of the pie. (No soggy bottoms!)
11. Score the top to let the steam escape and add decorations to the top. You can also add the egg wash in this step.
12. Bake at 350 for an hour and a half in the oven's center rack. Cover with foil if it browns too quickly.
13. Remove the pie from the oven and wait about 15 minutes before attempting to remove from the springform pan.
14. Cut and serve.

# Health Matters Food Safety Tips for The Holidays

**W**hether celebrating at home or dining out, there are simple steps that can be taken to keep safe and healthy this holiday season.

Preparing a holiday meal at home? Prevent foodborne illness by washing hands and surfaces frequently, avoiding cross-contamination, cooking foods to proper temperatures, and refrigerating foods promptly. If cooking a holiday turkey, follow these four tips to take the guesswork out of preparation:

**Thawing:** Thaw turkeys in the refrigerator, in a sink of cold water (changed every 30 minutes), or in a microwave. Frozen turkeys are safe indefinitely, but thawing turkeys must defrost at a safe temperature. Turkeys left out for more than two hours at room temperature can creep into the danger zone between 40°F and 140°F, where bacteria can grow rapidly.

**Handling:** It's flu season! Be sure to thoroughly wash your hands to prevent the spread of germs, using soap and clean running water for at least 20 seconds. This will help prevent the spread of bacteria from raw poultry, too. Don't forget to also thoroughly wash utensils and work surfaces to protect your food and family!

**Stuffing:** If you stuff the turkey, do so just before cooking. Bacteria can survive in stuffing that has not reached 165°F and possibly cause food poisoning, so use a food thermometer to make sure the stuffing's center reaches this temperature. For optimum safety, cook your stuffing in a casserole dish for even cooking.

**Cooking:** Set your oven to at least 325°F, and place the completely thawed turkey with the breast side up in a 2- to 2.5-inch deep roasting pan. Cooking times will vary depending on weight, so use a food thermometer inserted into the center of the stuffing and the thickest portions of the breast, thigh, and wing joint to make sure the bird has reached a safe internal temperature of 165°F. Let the turkey stand 20 minutes before removing all stuffing from the cavity and carving the meat.

**Dining out?** Follow these four tips from CDC to prevent food poisoning:

- Check inspections online for restaurants. Restaurant inspection data for Virginia is available by the health district.
- Make sure that the restaurant is clean. If not, you may want to visit a different establishment.
- Check that your food is cooked thoroughly, and send back any undercooked food as it may contain harmful bacteria if not cooked adequately.
- Properly handle leftovers by refrigerating within 4 hours of eating. Eat leftovers within 3 to 4 days from purchase.

## Campbell Field Designated IFR Site

Nine sites in Eastern Virginia and northeast North Carolina are fully operational for Instrument Flight Rules (IFR) landings by the Nightingale Regional Air Ambulance. One of those sites is Campbell Field in Northampton County. The FAA designation creates designated air space, allowing flights in cloudy, rainy weather which had to be turned down under current Visual Flight Rules (VFR) limitations. IFR allows Nightingale to meet ground ambulances at designated safe sites in poor weather rather than remote scenes.

IFR development was funded by a grant from the Sentara Foundation Hampton Roads, which included targeted gifts from donors in host communities. These gifts included \$40,000 from private donors on the Eastern Shore. Also, Currituck County, North Carolina, appropriated \$25,000 from its tourism fund to support two IFR sites at the Corolla and Carova EMS stations.

I am not talking about criminal thieves, but rather those people, companies and institutions that steal our time. Time is a wasting asset. We have only so much. 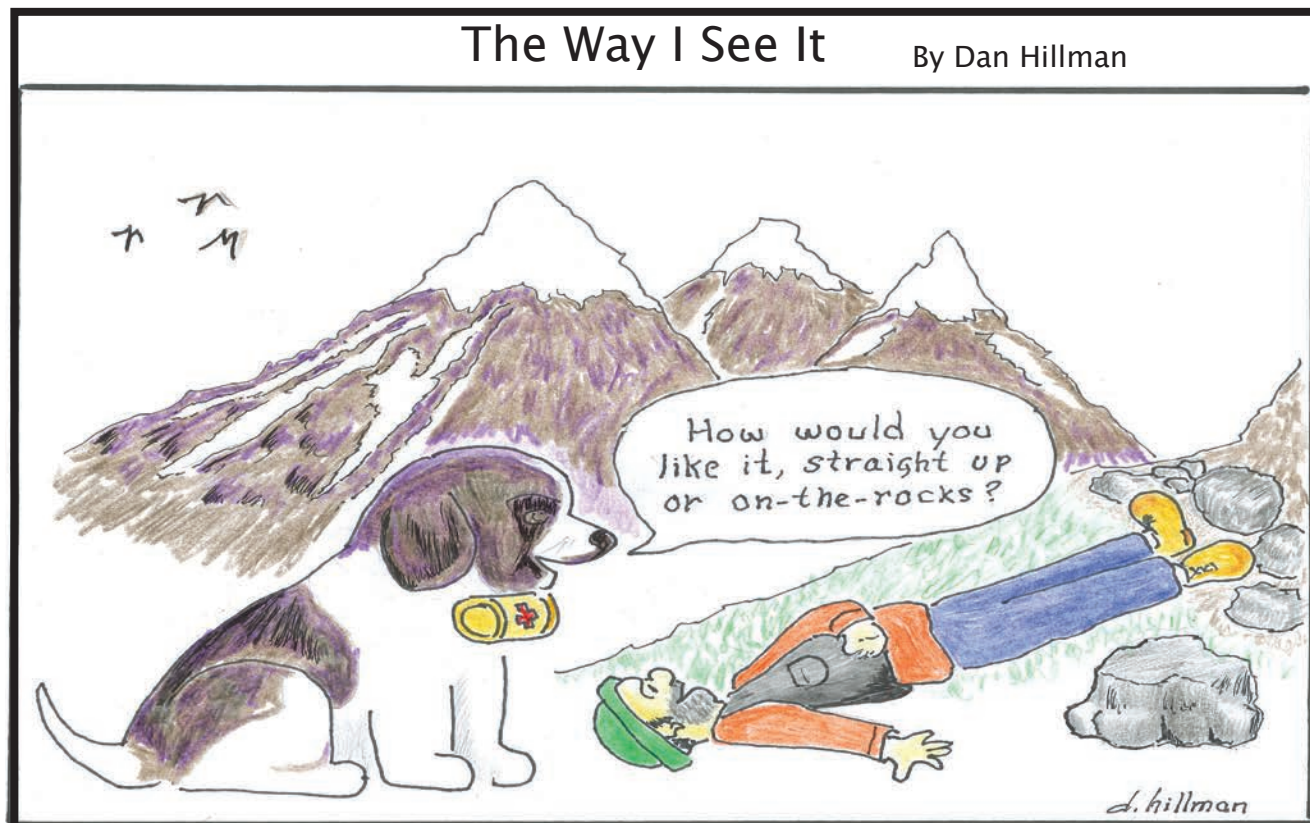
For example, you call a company or institution because you need a specific piece of data or to correct a mistake or whatever. You are greeted, electronically with “your call is important to us, please hold for the next available representative”. So you hold, but after 10 minutes of recorded music and repetition of that annoying message, you realize that your call is not important and you are left with basically two choices, hang up or continue to sit on hold for who knows how long while more of your time is stolen.

Or, for example, you show up at the scheduled time for a medical appointment but you end up sitting in the waiting room or a back room (sort of like the on-deck circle in baseball) for who knows how long with your time wasting away due to what amounts to a lack of “truth in scheduling.” Any reader who is in the medical profession should ask themselves how a medical practice would work if patients started randomly showing up 30 or 45 minutes late for their appointments. It would be chaos.

You dial a call center, wait for a human being (after going through one of those exasperating, time-consuming menus) only to be told by the human at the other end that it is “not their department” and you have to be transferred. The cycle starts all over again. Or you ask for a supervisor and are left on hold listening to music until you realize that the ignorant person you talked to has no intention of transferring you. Your time is stolen because too few people take responsibility for anything these days. Any reader who inflicts this kind of disrespect as part of their “job” should learn a phrase that used to be a watchword in different times. “OK I’ll take care of it.” Try a little empathy. Put yourself at the other end of the phone. One last thing: Never talk to an offshore person if you can help it. There is no chain of accountability. Why would someone thousands of miles away care about your concerns?

You are in line at, say, a bank. It is your lunch hour, you do not have a lot of time. There are people behind the window moving papers around, but not serving any customers. They, too, are time thieves. Whatever those papers are, can they be more important than the customers who ultimately generate the jobs of those employees?

There are more examples, but you get the point, I hope. People who have the ability should do something to reduce this thievery. Often there is nothing the individual consumer can do because of sole-sourcing, such as an electric utility or a cable company or a government agency. But in cases where there are multiple providers of the product or service in question, the consumer can vote with his or her feet. You do not have to stay with a service or product pro-
