Hospital Site Announced

Evaluation of two properties has determined that a 55-acre parcel on Market Street behind Four Corner Plaza in Onley will best meet the needs for a new hospital.

Riverside Shore Memorial Hospital (RSMH) has applied to the Virginia Department of Health for a Certificate of Public Need to relocate the inpatient hospital from Nassawadox. RSMH's evaluation team and its local board chose this site as the best location from which to serve the medical needs of all the citizens on Virginia's Eastern Shore for decades to come.

"From this location we will be positioned to serve the entire Eastern Shore community well into the future," said Joseph P. Zager, administrator of RSMH. "We chose the location because of its ease of access from Route 13 and its proximity to the center of population in our service area."

Riverside is planning to convert the Nassawadox campus to an ambulatory healthcare complex to include urgent care, diagnostic imaging, laboratory and rehabilitation services, and a strong physician presence.

Redistricting Begins

Accomack supervisors informally mapped out new election district lines Wednesday, taking major steps in the process by accepting "corrected" Chincoteague census figures and moving Tangier to District 6, which is represented by an island native.

"There's no way around Tangier moving out of District 2," said Supervisor Ron Wolff, who currently represents the district, which includes the Chesapeake Bay island. "They feel more at ease with a Tangierman if change must occur," he added, referring to Supervisor Robert Crockett.

"You've done a good job representing them," said Supervisor Sandy Hart Mears of District 4. Others agreed, but conceded that Crockett too "is well liked over there."

Crockett explained that his "mother and two brothers live" on Tangier. He was happy to include the more than 500 residents in his sector.

Other proposed changes include putting Saxis in District 4; moving Melfa including the Accomack Airport and Industrial Park to District 9, which is represented by Supervisor Reneta Major; combining all

Two Die in Causeway Crash

Two Accomack County brothers were killed in a head-on collision on the Chincoteague Causeway Monday night.

Robert Cherrix, 67, of 4100 Cherrix Lane on Chincoteague and Laurence Gordon Cherrix, 62, of New Church died at the scene, according to Sgt. Michelle Anaya of the Virginia State Police.

Neither of the men was wearing seatbelts. Both were passengers in a car driven by Christina Gallagher, 47, of the island. She also was not wearing a seatbelt. Gallagher was flown to a hospital with major injuries.

The accident occurred at about 5:15 p.m. on Route 175, the only road linking the mainland to Chincoteague. Traffic was at a standstill for about three hours as emergency workers freed and treated the victims and officers reconstructed the accident. Finally a

wrecker cleared the site. Vehicles stretched across the Causeway for more than a mile with many of the cars and trucks managing to turn around and leave the scene as the sun began to set.

Anaya said, a 2004 Volvo driven by Ivan Klychnik, 63, of California, who works locally, was going west on the road and swerved into the eastbound lanes striking a 1995 Ford Taurus driven by Gallagher. Klychnik was also flown to a hospital with major injuries.

Robert Cherrix was a passenger in the front seat of the Taurus. Laurence Cherrix was in the back. Alcohol was not a factor in the accident, Anaya said. An investigation is continuing. Trooper K. Johnson is working the case.

Chincoteague, Oak Hall and Wallops rescue units responded. The drivers were taken to the NASA airport and then transferred to Maryland State Police helicopters.

Northampton Planners Set Priorities

The Northampton County Board of Supervisors and Planning Commission met last week to set priorities for the coming year.

County Administrator Katie Nunez listed a number of items that need to be addressed by the Planning Commission, including wind turbines, town edge plans, Zoning Ordinance updates, the Subdivision Ordinance, stormwater management and capital improvements.

With regards to the required review and possible update of the county's Comprehensive Plan, Long noted the need to define the roles of the Board of Supervisors and Planning Commission in the matter. Commissioner Mike Ward stressed the need for public input in the entire process for updating the Comprehensive Plan.

Supervisor Sam Long Jr. noted that the Planning Commission needs to be flexible when businesses indicate an interest in locating in the county. Planning Director Sandra Benson questioned if there is anything in the current Comprehensive Plan stopping business growth.

Commissioner Roberta Kellam said the Planning Commission needs to continue gathering data regarding

population shifts and other changes for the economic portion of the Comp Plan. Supervisor David Kabler urged everyone to move forward with the economic portion, noting that there are things that could be put in place to help businesses. Board Chairman Willie Randall stated that one business opportunity in the area of Oyster had been stalled by the wording of the Comprehensive Plan. Supervisor Spencer Murray said the county needs to look hard at people who might want to manipulate the Comprehensive Plan to get what they want.

The supervisors again tried to tackle redistricting, agreeing to advertise for a public hearing on the matter, to be held April 25 in Machipongo.

Supervisor Richard Tankard proposed that the Board of Supervisors write Accomack supervisors, urging them to support a request that Riverside Health Systems provide 24/7 emergency medical coverage for the entire Shore. The letter notes that building a health-care facility in Accomack County without providing for citizens of Northampton would put them at risk. The board voted unanimously to support sending the letter to the Accomack board.

Planners Put I Do's On Hold

A request for a minor special-use permit by William Parr that could provide an idyllic setting for weddings was less than a marriage made in heaven for some members of the Northampton Planning Commission Tuesday.

Parr, who lives on a farm near Townsend, was requesting that the planners allow the use of a historic 127-year-old barn as a site for special events. Parr has extensively renovated the structure, which overlooks the seaside marshes. Parr pointed out that his proposal is exactly what county planners have been calling for in that it is eco friendly as well as a way to bring in tourists. Parr said county staff had inspected the structure and area around it and deemed it suitable for a maximum of 500 attendees.

Despite the support voiced for the plan by residents, the commissioners voted to table the request to obtain additional data on it.

A public hearing was conducted with

respect to a request for a special-use permit to install a temporary Meteorological Tower (MET) near Kiptopeke to gather data to determine the feasibility of wind-turbine-generated electricity. The proposed MET is a single pole, 197 feet tall, with guy-wires for support. Only gauges and a small transmitter, which are powered by solar power, are on the pole. The commission agreed to forward the request to the Board of Supervisors for review.

The commission also discussed zoning text changes requested by Walker Brothers Seafood in Willis Wharf. Tom Walker noted the need to expand their operation, which produces millions of shellfish and seedlings each year, but some of the text in the county Zoning Ordinance regarding setbacks would limit the expansion. Walker told the commission he has the support of the other seafood operators and neighboring property owners.

The commissioners voted to send the request to a public hearing.

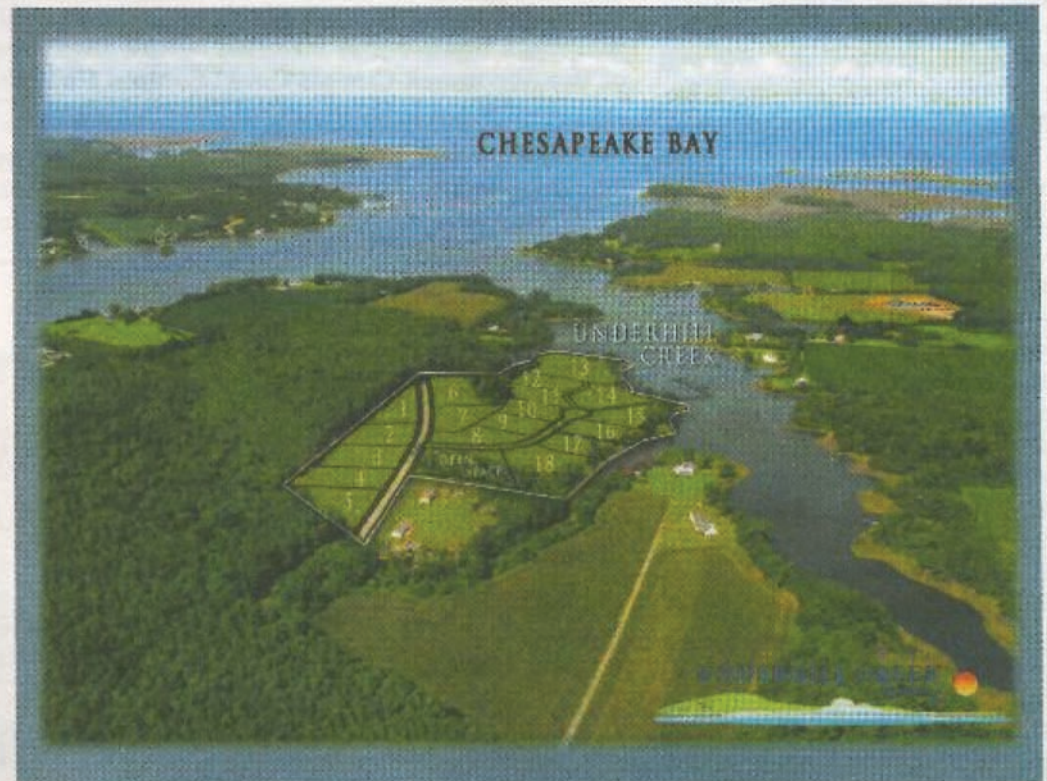

Local couples are in love and planning their weddings. Should they elope or have a big church affair? Which dresses, tuxedos, shoes, locations, hair-styles or food do they want to include?

There are so many choices. But a local man knows the most important answers. He and other Accomack and Northampton residents participated in an e-mail survey conducted by the Eastern Shore Post.

"Plan on working at staying married," said Ed Kehrig of Jamesville. Wed nearly 40 years ago, he knows what he's talking about. "It's not all sex and parties," he said. "It takes work."

The best thing about his wedding was "having my brother and wife and my sister there. They flew from Detroit, Michigan, to northern Scotland where I was married." His pet peeve about weddings is there aren't enough of them. "Too much living together. Find a minister," he said.

Kehrig recommended umbrellas for outdoor ceremonies and tissues for indoor ones. He cries at the events. "It reminds me of my wedding. A man's handkerchief does fine."

Dominique Buterbaugh of Exmore has been married for 18 months. "The best thing about my wedding was really the entire thing," she wrote. "It was amazing. ... I did not have to do any planning and ... only my parents attended."

Buterbaugh explained that her husband really wanted to attend his cousin's wedding in Las Vegas. She was try-

"When he kept pestering me, I said why don't we go ... and get married ... there too." The cousins were getting

hitched on 09/08/09, "which meant we could get married on 09/09/09," she said.

"We looked online, booked a helicopter wedding out to the Valley of Fire

(near the Grand Canyon) and my mom, dad, husband (to be) and I were flown out to a private plateau (not accessible by ground vehicle) with a photographer and priest. We were married ... photographed, then had a small celebration (wine, cake, and hors d'oeuvres) and came back to enjoy the rest of the week in Vegas!"

"The best thing was also the worst," she said. "I wish others could have been there to share the moment ... some family members were sad we chose a destination wedding ... we did have a reception for everyone to attend ... the only thing that was traditional ... was that we caked each other in the face at both the wedding and reception."

Mark Krogh of Cashville got married 41 years ago. "I was nervous," he wrote, remembering when he uttered the words of Elmer Fudd — "With this wing, I thee red!"

He recommends that couples avoid a sandy setting. "If you are going to

the beach by boat, maybe you'll fall overboard and sharks will get you," he warned. "It's a much easier end." He says "booze" is a necessity at all weddings. Krogh added that he doesn't cry at weddings, "but I should have cried at my own. After 25 years, we went back to the place where we stayed for our honeymoon. This time I stayed in the bathroom and cried," he said.

"We got an electric toaster, an electric blender and an electric can opener," Krogh continued. "My wife said there are too many electric gadgets and no place to sit down, so I got her an electric chair."

Linda Nicola of Onancock said, "My best advice for brides and grooms about weddings is something will always go wrong. Always. No wedding is perfect. Approach the imperfection with grace and humor and everything will be okay. This is just one day in your married life ... many brides think more about the wedding than the marriage."

The 29-year marriage veteran said, "Grooms, never smush the cake in the bride's face. Never. Ever. And if your bride is a bridezilla (defined by an online encyclopedia as a 'difficult, unpleasant, perfectionist bride'), your wife will also be a wifetzilla," Nicola added.

"Weddings are holy events," she continued. "They should be treated with dignity. Over sexing it, drunkenness, stupid themes destroy the sanctity of the event. But you can and still should have a fun wedding."

"I also dislike the huge expense of weddings," Nicola said. "Some of the best weddings I've been to have been very low-cost. Don't bankrupt yourself and start a marriage in debt. In the old days, men were supposed to have a ring and a savings account before proposing marriage. I think that's a good idea still. If a couple can't plan ahead (and) have the self-discipline to save money,

then they aren't mature enough to be married," said Nicola.

Glenn Muhle Jr. of Silver Beach got married 18 years ago. He said the best thing about his wedding was "knowing that the beautiful woman beside me was soon to be my wife." The worst was "trying to come up with my own vows."

Janet Dudley of Cape Charles has been married for 52 years. She said it's not "necessary to have the traditional wedding but whatever you do, do it in good taste."

Gil York of Onancock has "been happily married to my wonderful wife, Janice, for 33 years. The best thing about our wedding was the music. The worst thing was having to get on my knees for a prayer (I had bad knees even back then). The second worst thing was the ugly green gloves my wife's mother wore."

"My pet peeve at some weddings is that the spirituality significance is slipping away in the vows," he said. "Let's try to keep the Bible foremost in each ceremony. And let's keep the cell phone OFF!" He added, "I always cry at weddings, even my own. And I'm a Marine ... sometimes we give money and a small Bible when we go to friends' or family weddings."

Kelly Fox of Chincoteague got married on an already special day. "We eloped on my senior class trip to Disney," she wrote. "It was on my 18th birthday. And in June we'll be married 26 years." The only bad thing about it was "having to tell my parents."

Linda Martin Warner, formerly of Belle Haven, will be married seven years in June. "Finding the love of my life late in life" was the best thing,

she said. The worst was "our minister fell ill and was an hour and a half late for the wedding."

Linda Regula of Machipongo got married 43 years ago. She loved that her "whole family" attended the ceremony. Regula urged others to show restraint. "I hate it when they push cake in each other's face and the long time taken for pictures." She also suggested that there be "programs so you will know who is in the wedding party."

Twenty years ago when Rose Jeffers of Parksley got married, she "designed and created my own wedding dress and veil from head to toe. I also did my own floral arrangements all on a tight budget. I was later commissioned to design my neighbor's wedding dress."

Her "hands were scratched from straight pins due to my hard work finalizing last minute splurged details to beading. The dry cleaners (in PA) ruined my dress," she said. "Had I understood the dry cleaning process I would have spot cleaned the dress myself; the sequin pearls melted and damaged the satin. I expected the dress to be an heirloom for my future daughters."

She always cries at weddings because of "the passion of love and the expectations held for a successful marriage."

Selene Olivaria of Painter got married eight months ago. Her pet peeve is "people don't R.S.V.P. in a timely fashion!!!! Or people say they are coming and are a 'no-show.' Also wedding crashers come just to eat and drink. My remedy would be make your wedding by invitation only to avoid some of these issues."

She cries "a bucket of tears" at weddings. "Just to see two people proclaim their love for one another and just to witness the love and adoration two people in love share ... tissues are a must."

Carlee and Matthew Henry of Belle Haven "met, started dating, got engaged and got married all in the same place! Camp Occohannock on the Bay" near Craddockville. They were both counselors in the summer of 2002. After college (four years later), "he proposed to me on the final night of the summer camp session. We were married the following year, right in between the end of summer camp and the beginning of the school year!!"

A Bloxom man who was charged in March with several violent crimes, including rape and sodomy, was released from custody this week after serving about 16 days in jail.

Officials say Kevin Leigh Taylor, 39, a self-employed carpenter who lives on Anne's Cove Road, will not be prosecuted because his accuser recanted her story. In turn, she was charged with giving a false report.

Maj. Todd Godwin of the Accomack Sheriff's Office said Taylor was released Tuesday from the county jail where he had been held without bond.

Teresa Lynne Annis, 46, also of Bloxom, was arrested the same day and charged with knowingly (on March 20, 2011) giving a false report to police, a misdemeanor. She was released on \$2,500 bond. Court records show she will be arraigned on April 27. The hearing will be on May 2.

Taylor was arrested on March 21 and charged with abduction, rape, forcible sodomy and assault and battery in connection with the incident, which Annis initially said occurred in the Parksley area.

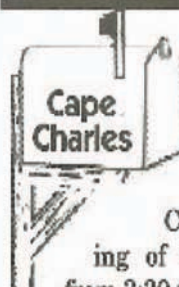

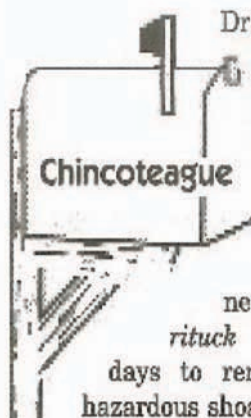

Exmore Honors 3 Prominent Citizens

Exmore Town Council unanimously agreed this week to honor three lifetime residents and past leaders who served the town for a number of years.

Joseph Grayson Duer and Albert "Bert" Ashby, both of whom served for three terms, were praised for their dedication to the town. Also honored was Police Chief Stephen Trader Elliott, who died in an accident on April 14, 2010. Elliott served with the town police force for over 27 years.

Plaques honoring all three will be placed in a prominent location in the Guy Lawson Memorial Municipal Building during a ceremony April 14 at 4 p.m.

Local resident Donnie Kellam addressed Council about locations in the town that were vandalized with graffiti over the past weekend. Police Chief Tom Potts said it did not appear to be gang related. Council asked that the property owners be made aware of the situation and have the areas cleaned up.

Interim Town Manager Arthur Miles presented a request to Council for non-support of the Riverside Hospital Systems Certificate of Public Need (COPN) with regards to efforts to move hospital in-services to Accomack County from Nassawadox. Council supported Miles' recommendation.

Council agreed to accept a proposal to replace damaged rain gutters on the municipal building at a cost of \$940.

Council decided that the annual town yard sale will be held Sept. 24 and that the Town of Cape Charles will be contacted to investigate its interest in making it a multi-town event.

Citing a safety issue posed by overgrown grass in portions of the median

strips along Lankford Highway in town, Council agreed to request a permit from the Virginia Department of Transportation (VDOT) to conduct voluntary mowing. Miles indicated that the town currently has the needed equipment to handle the mowing, and that VDOT could provide the needed signage.

Council discussed the draft personnel policy update and while agreeing to it in concept, tabled a final decision until the full council was present. (Councilman Dave Scanlan and Mayor William Moore Jr. were absent.)

Regarding the debris from demolitions along Gladstone Lane on the south end of town, Miles announced that Accomack-Northampton Electric Cooperative (ANEC) will work with the town to deal with power lines in the area prior to burning the materials. As a safety measure, the town is asking that the fire department assist with the undertaking.

In a related issue, Miles said that other properties in the town are on tap for demolition and that once an excavator arrives in the area, it could be made available to assist in the process.

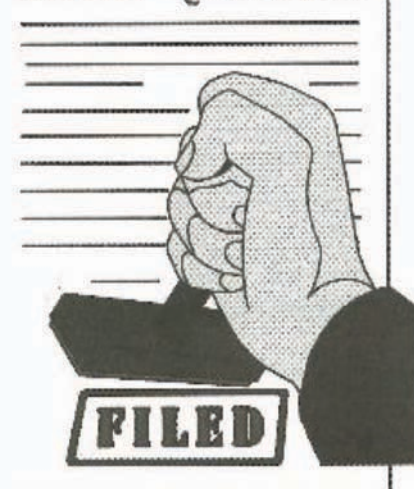

of Savageville and Texacotown in District 8, which is represented by Chairman Donald Hart; and moving part of the Wishart's Point area and a section of Horntown into District 3, represented by Supervisor Grayson Chesser.

The villages of Assawoman and Atlantic were previously divided and now would be in the same district, according to preliminary work. Officials noted that the proposed lines also keep Boston and White Rabbit undivided. The changes were drawn with an eye toward balancing minority and majority populations.

With the exception of the Tangier move, the redistricting measures were agreed to by consensus only, since Vice Chairwoman Laura Belle Gordy was absent due to illness and other supervisors wanted to review changes with staff.

Chincoteague Mayor Jack Tarr said his town is collecting data to correct the Census Bureau's claim that the island lost 1,383 residents since 2000. He said there are 3,666 residents. Documents in an agenda packet showed a population of 4,324 ten years ago. The

2010 census claims 2,941.

The town, dissatisfied with the bureau's findings, distributed its own census cards. That census deadline is April 15. The figure quote by Tarr was based on registered voters, of which there are 2,604, school population of about 450 and full-time water customers. "We know who's passed away. We know who's been born," the mayor said.

County Attorney Mark Taylor said it will be helpful in winning the approval of the U.S. Justice Department to have the town's work as justification.

The supervisors also voted to adopt the county's proposed \$51 million fiscal 2011-12 budget without a hike in the real-estate or personal-property tax rates.

In addition, they unanimously passed a resolution supporting Riverside Shore Memorial Hospital's quest for a Certificate of Public Need for a future hospital in Accomack. "I thought long and hard about it," Chesser said, explaining that his decision should not be taken as "a vote against Northampton" County, which would lose the existing hospital.

A Maryland man was sentenced in Accomack Circuit Court to 21 years in prison for robbery and related charges.

Sidney Cottman, 34, of Eden was convicted of armed burglary, robbery and use of a firearm. Judge Edward Hanson Jr. sentenced him on March 31 to a total of 54 years. With concurrent terms, his sentence amounts to about 21 years, court records show.

Cottman must remain on good behavior for 25 years after release. He was ordered to pay court costs of \$10,750 and restitution of \$3,528 to Tru-Blue, \$28 to Royal Farms #105 and \$143 to Dollar General in Oak Hall.

New Hospital Garner's Island Support

Chincoteague officials favor Riverside Shore Memorial Hospital's (RSMH) proposal to erect a new facility 18 miles closer to island residents, thereby "making inpatient care more accessible to the Eastern Shore's largest community."

In a resolution, Chincoteague Town Council unanimously voted Monday to support the construction of facility in Accomack County.

"The Town of Chincoteague has a continuing need for health care services for our resident and summer visitor populations," the resolution states. "Be it further resolved that the town ... agrees with the stated goal of a physician recruiting effort for the Eastern Shore and the provision of expanded local outpatient services."

The resolution comes in time to support RSMH's application for a certifi-

cate of public need. Accomack County officials also voted recently to support the move.

In other business after discussion in a closed session, Council voted to extend Town Manager Robert Ritter's employment contract by two years. The contract expires in June. Councilman John Howard was the only member to vote against the extension. "In my opinion, he doesn't meet the job criteria," Howard said later.

Howard made a motion to stop Public Works employees from returning to town facilities to take breaks. He argued that too much time is spent getting to the break room. "I still want them to have the 15-minute break they're entitled to," Howard said, adding that his way is "a good business decision."

The other council members didn't agree and Howard's motion died without a second.

Fuel Assistance Available

Members Helping Members, Inc. (MHM), a community non-profit 501(c)(3) organization, assists families in need to pay their electric service bills.

The Accomack and Northampton County Departments of Social Services determine qualified candidates for assistance in the program. To be eligible, a family must be at or below 100 percent of the Federal Poverty Guidelines,

have a delinquent electric account of more than \$50, and receive assistance only once in any given calendar year.

A family that qualifies may be eligible for up to \$250 per year in assistance. Anyone who received funds in the previous year will not be eligible to receive funding for one year.

For the 2011 program, the application period begins on April 12. Applications for the program will be taken at either Department of Social Services on any Tuesday between 9 and 11 a.m. Applicants must bring a copy of their bill and verification of income to apply.

ANEC, in cooperation with MHM, secures funding through voluntary donations through ANEC's electric service bills. Members of ANEC who would like to donate to the program may do so by checking a box on their electric service bills, authorizing ANEC to add \$1 per month to their bills.

All of the tax-deductible donations go to those in need.

Government Leaders Discuss Range of Local Issues

State, county, and local government leaders met last week at Aqua in Cape Charles to discuss issues of interest.

U.S. Congressman Scott Rigell briefly described the process of ironing out a budget in Washington. Rigell noted that his main goals upon arriving in Washington were creating jobs, controlling federal spending, taking care of the military, and cutting dependence on foreign oil. He said he continues to work toward those goals and is leading by example with regards to cutting federal spending. Rigell said he is helping to work out a funding agreement to keep the government in operation while not increasing the federal deficit. On the topic of Social Security, Rigell predicted that the time will come when American workers will need to delay receiving benefits to help keep the program solvent.

Del. Lynwood Lewis addressed the need for the state to continue its redistricting efforts. Changes to district lines may change Lewis' district prior to the next election. Lewis stated that the budget and transportation needs are the main priorities for the state at this point. "Maintenance is the number one goal in the state with regards to the Virginia Department of Transportation (VDOT)," he said.

Northampton County Board of Supervisors Chairman Willie Randall stressed that the highest priority for the county is economic development. He insisted that the county government is business friendly and doing what it can to get that message across. Randall noted that the county needs to look at ways to support small businesses, as well as the concepts of aquaculture, agriculture, and tourism. "We need to help businesses in the county to promote growth,"

Randall said. "The majority of the tax burden is currently being shouldered by residential taxation." Randall spoke of the importance of the Public Service Authority (PSA) as a way to develop infrastructure, which is needed to attract new business. Randall briefly discussed the county's efforts at redistricting, noting that the plan being considered would reduce the number of supervisors from six to five.

Supervisor Richard Tankard stressed the need to meet the medical needs of Northampton residents. Tankard spoke on the proposal by Riverside Medical Systems, which calls for an "urgent care" facility in

the county once the new hospital is built in Accomack County and the Nassawadox hospital is closed. He stressed that the urgent-care facility would not provide the emergency care currently available in the county. Tankard pressed all present to get involved in seeking a solution that would provide care for those who need it. "We need to be more vocal on the issue due to what we are losing in the county," Tankard told the gathering. He suggested that there be two facilities, one in Accomack County and another to serve Northampton County.

Cape Charles Mayor Dora Sullivan discussed the positive moves that have been made in recent months in the town, including the soon-to-be-completed wastewater plant, new floating piers, breakwater, and town trail. Sullivan echoed Tankard's concerns about the loss of the hospital and the need to find a medical solution for the lower end of the county.

Cheriton Vice Mayor Larry LeMond addressed the need to continue working to develop a wastewater system through the PSA. He indicated that a second goal of his town is to complete the data package that will be forwarded to the county with Cheriton's request for a boundary adjustment.

Eastville Mayor Jim Sturgis mentioned the town's efforts at revitalization and the sale of surplus county properties to increase revenue for both the town and the county in the long run.

Interim Town Manager Arthur Miles spoke of Exmore's efforts to improve its wastewater system. Miles noted that the town needs more infrastructure to attract business. "The town is poised for growth," he said. "While we are not a destination for visitors, we do have two fine new hotels for people to stop at as they pass through."

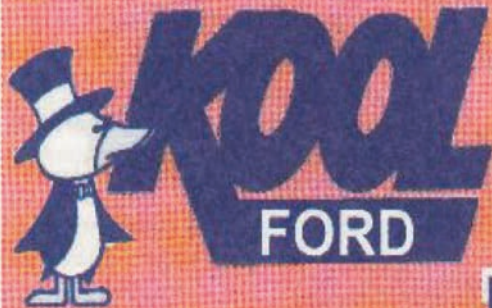

Daughter Seeks To Ensure Double Murderer Stays in Prison

Fifty-three-year-old Javis Enos (Shaft) Holland, who was convicted of the 1990 murder of two Eastern Shore residents, is set to go before the parole board Monday in a quest for freedom from his sentence of life in prison.

Nicki Moon, daughter of victim Camellia Moon, said she wants to stop any possibility of Holland's parole and is seeking the help of others in a letter-writing campaign to the parole board.

Nicki Moon said that in the years since the murder of her mother — who taught at Nandua High School and lived in Wachapreague — and Scott Stone, an employee of the Moon family gun business and a recent high-school graduate, she has compiled a history of the violent crimes committed by Holland.

Moon said three years ago similar letters helped the Parole Board deny Holland's freedom. "To this day, when I talk with staff at the parole board, they recall the quantity and quality of those letters and the impact it made on

them," she said. "It made a difference to have letters from ... the Shore."

"The Parole Board has recently been replaced by Governor (Bob) McDonnell and there appears to be a shift in mindset to 'emphasize prisoner re-entry efforts' and noting that it is 'too expensive to keep large numbers of prisoners who could be safely released,'" Moon said. "I am worried that may mean this violent person could be released to hurt others."

"All letters must be received prior to May 16, 2011, when my family will meet with the Parole Board members," she said. They should be sent to Virginia Parole Board, 6900 Atmore Dr., Richmond VA 23225. Moon said letters can be e-mailed to her at nmoon123@gmail.com and she will make sure the Parole Board receives them.

If the letter writers "knew Mom or Scott, they may reference that, how they knew them, and what kind of person they each were," she said. "The letter may be as simple as noting ... Hol-

land's name, inmate number (193655) and stating an opposition to his parole," she added.

"Mr. Holland has an incredibly violent history and I worry about his release from prison," she said. Her research shows that in addition to the local mur-

ders, Holland was arrested and charged with first-degree murders in Maryland, possessing a firearm after having been convicted of a felony in Kentucky, the rape of a 14-year-old girl while threatening a 5-month-old baby in Pennsylvania and robberies in Delaware.

OSV Zone Closed Overnight

Caution is the word for residents and visitors who enjoy overnight fishing on the southern end of Assateague Island.

"We didn't want someone to get stranded on the Hook and not be able

to reach them in a timely fashion if they had a medical emergency," stated Refuge Manager Lou Hinds. "I believe these measures, coupled with the continued cooperation of the community and our visitors, will help ensure the safety of all involved."

The OSV zone, an area on the beach designated for four-wheel drive vehicle use, has been partially closed to all OSV, boat and pedestrian use since March 15. The incremental closure of public access to this small area occurs annually to protect the piping plover and other migratory shorebirds.

Car Care

APRIL IS NATIONAL CAR CARE MONTH BASIC MAINTENANCE HELPS AVOID REPAIRS

National Car Care Month in April is the time of year to give your car some extra attention. Basic maintenance can go a long way toward improving the safety and dependability of your vehicle, plus it helps avoid costly repairs down the road.

"Neglected vehicle care almost always means much higher costs down the line in the form of more extensive repairs or lost resale value," said Rich White, executive director, Car Care Council. "Chances are if you own a car, it needs some work. National Car Care Month in April is the perfect time to focus on your vehicle's maintenance needs."

Results of community car care events held throughout the country in 2010 show that most consumers are neglecting their cars, with seven out of 10 vehicles failing at least one component of the vehicle inspection process.

"These results show that the majority of vehicle owners could save money by being more proactive when it comes to their vehicle," White said.

The Car Care Council recommends 10 basic maintenance procedures to keep your car operating at its best:

*Check the oil, filters and fluids. Oil should be checked at every fill-up and changed per the owner's manual recommended intervals. Brake, transmission, power steering, coolant and windshield washer fluids also should be checked regularly. Your car's filters, including those for the transmission, fuel system and interior ventilation, need regular inspection and replacement.

*Inspect hoses at each oil change and have them replaced when leaking, brittle, cracked, rusted, swollen or

restricted. Check V-belts and serpentine belts for looseness and condition, and have them replaced when cracked, frayed, glazed or showing signs of excessive wear. Typically replace the timing belt between 60,000 and 90,000 miles or the interval specified in the owner's manual to avoid a breakdown or serious engine damage.

*Check the engine brake system every year and have the brake linings, rotors and drums inspected at each oil change.

*Check that the battery connection is clean, tight and corrosion-free. The battery should be securely mounted. If it is three years old or more, the battery should be tested and replaced if necessary.

*Inspect the exhaust system for leaks, damage and broken supports or hangers if there is an unusual noise. Exhaust leaks can be dangerous and must be corrected without delay.

*Schedule a tune-up that will help the engine deliver the best balance of power and fuel economy and produce the lowest level of emissions.

*Check the car's heating, ventilating and air conditioning (HVAC) system.

*Inspect the steering and suspension system annually, including shock absorbers and struts, and chassis parts, such as ball joints, tie rod ends and other related components.

*Check the pressure of all tires, including the spare, at least once a month. Check the tread for uneven or irregular wear and cuts and bruises along the sidewalls. Have your car's alignment checked at least annually.

*Test exterior and interior lights and have bulbs that are not working checked immediately. Replace windshield wiper blades every six months or when cracked, cut, torn, streaking or chattering.

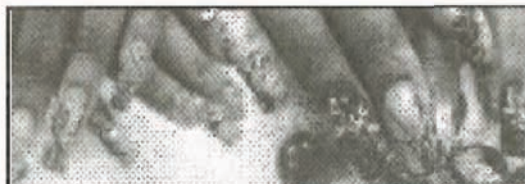

The plans of Riverside Shore Memorial Hospital have generated a great deal of attention in recent months. While our board members and staff have always been keenly aware of the critical role our local hospital plays in the lives of our Eastern Shore neighbors, it is gratifying to know that our community shares that interest.

As a not-for-profit provider, our mission to serve the entire Eastern Shore is what drives our planning and decision making on both a short- and long-term basis. That mission can be achieved, however, only if the hospital remains viable. Simply put, Riverside Shore Memorial Hospital has to meet the financial obligations of doing business. A failure to do so, as with any other enterprise, means that valuable services can no longer be provided.

What makes this responsibility even more critical in our region is the fact that there is no safety net, no other provider of services on this level. Understanding this mandate to remain an effective hospital, our board closely examines our efforts now, as well as how we are positioned to provide care well into the future.

Years ago, our board and its Strategic Long Range Planning Committee looked into the possibility of building a second hospital on the Shore to expand access to health services. When our hospital affiliated with Riverside, this possible direction was revisited with the assistance of healthcare consultants. In both cases, findings indicated that the potential for additional reimbursement would not offset the

significant cost of duplicating hospital services. The predicted losses would jeopardize our ability to continue to effectively serve the Shore, an option that.

Building a new hospital, which after lengthy study proves preferable and more cost-effective than renovation, will alleviate some of the plant-related obstacles to assuring economic viability. New construction will allow our patient units and support areas to be sized and located more efficiently. At the same time, a new building will better accommodate the communication infrastructure of advancing technology, a critical element for patient care as well as for recruiting physicians and employees accustomed to this level of technology in their training and former practices.

As is the case with any successful service enterprise, a hospital must be conveniently located to the people it serves. Our analysis of population trends shows that the Onley/Accomac area is the best location from which to serve the entire Shore. The factors considered in this decision include where the population is centered, drive times from the far-northern and far-southern areas of the Shore and the distance to hospitals on the Maryland Eastern Shore and across the Chesapeake Bay.

What is important to note, is that the existing Nassawadox campus will continue to serve as well. Because most healthcare is centered on outpatient services, the current campus will be converted to an ambulatory healthcare complex that will include urgent care, diagnostic imaging, laboratory and rehabilitation services, and a strong physician presence.

As a result, most people needing outpatient care will have the choice of the new facility or the Nassawadox complex.

In emergency situations, we will continue to rely on the Shore's first responders. We are proud to partner with these dedicated volunteer and paid Emergency Medical Services (EMS) personnel who offer

exceptional emergency services. In recognition and support of their critical efforts, the Riverside Foundation donated \$21,000 to Northampton County EMS for equipment in five ambulances and one quick-response vehicle. These funds will help make it possible to transmit information about heart-attack status before a patient arrives at the hospital.

Our vision to expand services and healthcare providers on the Shore will be supported by Riverside's leadership in keeping people well.

We believe that the future of healthcare lies in increasing access to clinical care while rewarding wellness and preventive care, and we are poised at the forefront of that movement. Building a new hospital and maintaining a strong outpatient resource at the current location will be important in bringing that potential to reality.
