Local Leaders Tell Kaine Offshore Drilling Is Too Risky

With offshore drilling comes the possibility of an oil spill. And no one on the Eastern Shore wants threats to aquaculture, commercial and recreational fishing, tourism, NASA rocket launches, wildlife, beaches, marshes and the way of life here.

That's what local officials and residents told Senator Tim Kaine when he visited Wachapreague on Monday.

"We take the standpoint there is a risk," said Robert Crockett, a native of Tangier Island and chairman of the Accomack Board of Supervisors. "What would be the rewards?" he asked rhetorically. "I don't see locally an economic benefit at all. I don't believe it would create jobs for the Eastern Shore of Virginia. They (the workers) wouldn't leave from here. You can see the poten-

tial damage to our local economy. Assateague Beach would probably be the first one to be hit."

Chincoteague represents 25 percent of the county's taxable real estate, said Crockett. "If you look at tourism up and down the Eastern Shore ... a huge part of it is Chincoteague ... damage to aquaculture ... the risk would be huge," he added. "I have to look at what's best for Accomack County and the Eastern Shore of Virginia ... the rewards would just not be there."

"There's a natural and understandable skepticism to it," said Spencer Murray, chairman of the Northampton Board of Supervisors. "People really want to know, if we did this, would it work? Can we really trust those people who are supposed to be watching the store?" he asked.

"My constituents are telling me that they don't see a benefit. New technology will not work," said Murray. "I can say there is not a lot of openness" towards drilling. "The Chesapeake Bay would be the victim. A spill of that sort would not be a thing they could get over ... it would be decades."

Kaine explained the process that included a public hearing and comment period between each phase for five years. He let it be known that his former thoughts of openness on the subject are gone. He went on record in 2016 as being opposed to drilling off the Virginia coast.

So far, public comment from 190 localities along the Atlantic are in opposition to oil drilling off the coast, said Kaine. Add to that 1,200 elected officials, 500,000 in the fishing industry and aquaculture and tens of thousands of businesses.

Heather Lusk is vice president of H.M. Terry Company of Willis Wharf, a fourth-generation aquaculture business. She is a former securities lawyer and a member of the Virginia Marine Resources Commission, the Virginia Aquaculture Advisory Board and the Shellfish Growers of Virginia. And she is against offshore drilling.

"We are very concerned about any kind of risk to that water quality," she told Kaine. She said aquaculture is a \$56.6 million business. The Shore is on top in hard clam production in the United States and first in oyster production on the East Coast. "That's coming from Northampton County ... Our hatcheries are on the seaside." But she said there are also significant ones on the bayside.

"They are touted as being the best of

Borrow Pit Owner Seeks Expansion but Not for Bridge-Tunnel Spoils

Gary Wagner, a Northampton landscaping contractor seeking to expand his business, is out of the running to receive spoils from digging the new section of the Chesapeake Bay Bridge-Tunnel but is running into opposition from the county planning commission.

Last year, Wagner applied for a special use permit to expand the existing borrow pit on his property from 10 to 18 acres, for disposal of up to 700,000 cubic yards of dredge spoils that would be produced during construction of the CBBT parallel tunnel at Thimble Shoals.

In April 2017, supervisors approved the special use permit 4 to 1, with several conditions regarding safety and operations.

But the petroleum-based lubricants applied to the cutter head of the boring machine that will dig the new tunnel would contaminate the spoils beyond what is allowed at a disposal site where the ground is unprotected, as is the case with the Wagner borrow pit.

Up to 50 milligrams of contaminates

per kilogram of soil are allowable. The petroleum-based contaminates are referred to as total petroleum hydrocarbons, or TPH. Sample spoils from the Chesapeake Bay Bridge-Tunnel site were tested and found to contain 75 milligrams of TPH per kilogram.

Spoils from the CBBT work site must be transferred to a landfill with a liner to prevent petroleum hydrocarbons from leaching into the soil and contaminating groundwater.

On March 6, 2018, Wagner reapplied for the special use permit to expand the borrow pit, not to fill it with outside materials but to further extract soil for use in his landscaping business, as he has done for the past 20 years.

The site has been permitted through the Department of Mines, Minerals and Energy since 2004 as an open pit sand mine. Wagner renews the permit annually and DMME inspects the site biannually. The most recent inspection shows no violations.

Director of Planning and Zoning Susan McGhee reported to supervisors

April 10 that the planning commission reviewed Wagner's application April 3, but a motion to approve it failed. A second motion made to table the petition until "the commissioner receives information on the location of existing wells, septic tanks and drain fields for all adjacent commercial and residential properties," passed unanimously.

McGhee said the planning commission's concern was that the expanded borrow pit may negatively impact nearby wells, septic tanks, and drain fields, not the other way around.

Chairman Spencer Murray requested evidence from the planning commission how a "perfectly functioning septic system" and an adjacent property could affect one another.

Supervisor David Fauber wanted empirical evidence that reducing the buffer around the Wagner site from 200 feet wide to 100 feet wide, as the owner requested, would make a negative impact on adjacent properties.

The planning commission had suggested reducing the buffer to 175 feet, not 100 feet, as Wagner requested.

Fauber noted a drain field is allowed to be 50 feet from a well, and he did not understand why a borrow pit and a well would require more separation.

Murray agreed. "Everybody knows how I feel about property rights. I think people ought to be able to use their property as long as they're not hurting somebody else," he said.

Supervisor John Coker was concerned that Wagner had a stockpile of concrete onsite, which was inconsistent with the guidelines set by Northampton's zoning ordinance stating a borrow pit is used for "extraction of material and not for stockpiling or bringing material onsite."

Wagner said his DMME permit allowed him to bring inert materials onsite, including concrete and asphalt.

Supervisors presumed the state's authority would overrule the county ordinance, but they agreed to seek confirmation from McGhee.

Supervisors will not make a decision on Wagner's request until they hear back from the planning commission.





the best," Kaine agreed.

The Eastern Shore is "one of the most special ecologically sensitive areas on the planet," said Curt Smith, manager of the Accomack-Northampton Planning District Commission (ANPDC). He said there are also other federal investments on the Shore including money spent on eel grass replenishment aimed at bringing back the bay scallop fishery.

Lusk said there are also plans for other new products. "We are a sustainable industry. We put back more than we take out."

"If things are put in the wrong spot, they (oil riggers) could potentially close us down," said William Wrobel, director of NASA's Wallops Flight Facility.

NASA is the fifth largest employer in Accomack, said Crockett. "When they are concerned, we are concerned," he added. Crockett said it all has a rippling effect. "The person who goes out there and retrieves those rockets is a local fisherman."

"Cape Charles in Northampton is the Chincoteague of Accomack," said Elizabeth Dodd Russell, executive director of the Northampton County Chamber of Commerce. "We're busy 12 months out of the year now. That would be taken away in two seconds," she said.

"We are the last 70 miles on the whole East Coast that is not developed," said Carol Evans of the Eastern Shore of Virginia Tourism Commission. "We don't have to invent any reason for people to visit us like a Disney World. We are authentic." She boasted the Shore is the smallest and fastest growing tourism attraction in Virginia for the past four years. "We've seen 60 new businesses in the past five years," Evans

said. "We're holding on to the ethics and the vitality that is here."

"I remember an oil spill here on the Eastern Shore when I was a child," said Cara Burton, director of the Eastern Shore Public Library. "I can't remember details ... it was on the bayside ... we are stewards of this beautiful coastline."

Others agreed the spill must have been from a transport vehicle. "We already bear the risk of transport," said Burton.

"This is a major flyway as well," said Greg Sutter, an Alaska resident visiting Wachapreague, where he used to live. "We leave plenty of room for the ducks and the geese. This is one of the last places where birds can actually rest ... If you look at the coastline in New Jersey, there's no place for those birds."

Paul Berge, who retired a decade ago as director of A-NPDC, said he camps on the barrier islands every year and from Texas to Florida. "Whether they spill or don't spill, they also generate a lot of trash," Berge said of the drillers. He once picked up a hard hat while camping. "The amount of trash can be pretty devastating to the shoreline."

Robie Marsh, executive director of the Eastern Shore Chamber of Commerce. said all 420 members of his group took a stand against oil drilling off the coast.

"Just protecting Virginia is not enough," said Richard Snyder of the Virginia Institute of Marine Science. He contended that oil drilling off nearby states could be devastating here too.

Rod Hennessey, a local conservation worker and teacher, said two decisions that were made locally have kept the area from ruin. One was not allowing in Brown & Root, a Texas industrial services contractor, and the other was keeping the barrier islands from being connected by a series of bridges. "We

wouldn't have migratory birds, aquaculture ... we'd have Ocean City ... don't want to make a decision like that now."

"It's rare to get a number of people like this together a group of people in this number to agree on one thing," said Crockett.

Wachapreague Flood Insurance Premiums To Drop Average of \$94

Wachapreague real estate owners will receive a 10 percent reduction in their flood insurance premiums through an increase of various floodplain management measures encouraged by the Federal Emergency Management Agency (FEMA), according to an announcement made this week.

The rating system change for Wachapreague shows the town's commitment to protecting itself from the dangers of flooding, said MaryAnn Tierney, FEMA's Region III administrator. "We would like to thank Wachapreague for taking actions to protect lives and property."

Under the rating system, local officials are asked to reduce flood losses, facilitate accurate insurance rating and promote awareness of flood insurance. Communities can earn a Community Rating System rating by submitting an application explaining the projects they have in place or are developing.

Wachapreague is among 25 communities in Virginia that have received this recognition, the announcement stated. "With the steps taken by Wachapreague to protect its citizens and increase its resiliency, it has entered the CRS program as a Class 8 participant." Communities can earn up to 45 percent off their premiums.

Wachapreague policyholders saved an average of \$94 in annual premiums.

The Dollar General Store proposed for 14093 Lankford Hwy. in Mappsville three years ago has been revived, Deputy County Administrator Rich Morrison told the Planning Commission Wednesday.

The three-acre parcel was rezoned from residential to business in 2015 by

Accomack supervisors. They voted 6-3 to allow Dollar General to build despite opposition from nearby Matthews Market, other neighbors, customers and friends.

But the store never came. Recently, the property was sold. VDOT approved access, during the first process.

That action will allow the new owner,

Par 5 Development Group LLC of North Carolina, to construct a 130-foot by 70-foot structure. It will be 18 feet high and have an area of 9,100 square feet. The estimated cost of construction is \$365,000. The building permit fee was \$4,236. Rhetson Companies Inc., also of North Carolina, is the contractor, according to the permit.



Car Theft Charge Won't Be Prosecuted; Malicious Maiming Trial Set for May 8

A felony charge against a Parksley man, whose tooth was once connected to a murder case, will not be prosecuted, according to papers filed in Accomack Circuit Court.

Brian Marquis Northan, 30, of Leslie Trent Road, was indicted last year on counts of maliciously maining John Anthony Foster Jr., of Wattsville, and unauthorized use of Foster's vehicle on Oct. 23, 2016.

Foster testified at a preliminary hearing that Northan and another man beat him up. The victim said he ran and hid in the woods. His car was later found in a different location.

According to the court document, the charge of unauthorized use of the car will not be prosecuted against Northan. A May 8 jury trial is scheduled for the maiming charge. Northan is being held in Accomack Jail.

Foster said he was giving Lamonte Demetris Johnson, of New Church, a ride home from playing cards. They stopped at Northan's house. Foster said he met Northan for the first time that night. The three ended up at Johnson's house, where Johnson started hitting Foster.

"I was trying to block it," Foster said.
"I didn't expect him to start punching."

Then both men "rushed me," Foster said. "Brian had a wrench ... he broke my arm with it. After I was getting beat and couldn't defend myself, I ran to hide in the woods. I just laid there until I could hear no one moving

Family Dentistry ... once I got up ... I was just hobbling along beating on peoples' doors."

Johnson was sentenced to five years in prison for each charge. All but 10 months of the terms were suspended.

Northan was accused of capital murder in the 2010 death of Anthony Wayne Wilson, 46, of Felton, Del. Wilson was found dead at the scene of a traffic accident near Greenbush. But he didn't die from the crash. A medical examiner ruled Wilson's life ended from a gunshot wound to the head and neck.

Found in the vehicle was Northan's tooth, according to DNA evidence. After spending three years in jail awaiting trial, Northan pleaded no contest to voluntary manslaughter in a plea bargain and was sentenced to 10 years with all but two years suspended. He got another two years for possession of a firearm by a felon to run consecutively with the first term. In addition, he was given two years for shooting at an occupied dwelling in connection with an incident that occurred a month after Wilson died. The latter sentence was set to run concurrently for a total of four years to serve.

In the murder case, a witness changed his mind three times about what he saw. The doctor, who would have testified about the tooth, moved to Canada and the murder weapon, which was found in the Pocomoke River, was bought and sold several times among felons, allowing Northan to say it wasn't his.

On February 20, 2018, A & N Electric Cooperative ("ANEC" or "Cooperative") filed with the State Corporation Commission ("Commission") an application ("Application") pursuant to §§ 56-231.33, 56-236, 56-238, and 56-585.3 of the Code of Virginia requesting approval of a proposed increase in rates and charges for bills issued on or after October 1, 2018.

ANEC represents that a rate increase is needed because the Cooperative's capital and operating costs have continued to increase over the past several years while load growth is lacking. Specifically, the proposed rates and charges are designed to increase the Cooperative's jurisdictional revenues by \$2.9 million per year based on the Cooperative's filed rate year levels for an overall net jurisdictional rate increase of 4.49%. ANEC represents that the proposed rates will result in a jurisdictional rate of return on rate base of 5.57% and produce a rate year jurisdictional Times Interest Earned Ratio ("TIER") of 2.25x.

ANEC states that, in developing the proposed rates, it sought to develop rates that more closely reflect the cost of providing service, as well as to introduce greater consistency in the rates of return of various rate classes. ANEC states that revenue and rate neutral changes to base rates are applied as necessary to rebalance all rates between supply and distribution costs so that the rate year level of electric supply service ("ESS") revenue matched the rate year purchased power expense. The Cooperative further asserts that it sought to bring the unit charges more in line with the unit costs derived from the cost of service study, and to increase rates to a level that would generate an appropriate TIER for the Cooperative.

The Cooperative seeks to rename the "Customer Delivery Charge" as an "Access Charge," and proposes an increase to Access Charges in each rate class to better reflect the cost of service classified as customer-related.

Of the proposed \$2.9 million revenue increase, \$2.6 million is allocated to the Schedule A-1/A-2, resulting in a 6.48% increase to the class, compared to the overall jurisdictional increase of 4.49%. The Cooperative indicates that the largest percentage increase, 9.81%, has been applied to Schedule I.

ANEC also proposes a number of changes to its rate schedules including: renaming certain rate schedules; the introduction of seasonal price differentials to certain schedules; ESS pricing and rate design changes to certain schedules; and the introduction of new schedules.

The Cooperative represents that it is not making any substantive changes to its Terms and Conditions at this time. Notwithstanding, ANEC will need to make several non-substantive revisions to its Terms and Conditions to reflect the changes being made to its rate schedules. Interested persons are encouraged to review the Application and supporting documents for the details of these and other proposals. While the total revenue that may be approved by the Commission is limited to the amount produced by the Cooperative's proposed rates, TAKE NOTICE that the Commission may approve revenues and adopt rates, fees, charges, tariff revisions, and terms and conditions of service that differ from those appearing in the Application and supporting documents and may apportion revenues among customer classes and/or design rates in a manner differing from that shown in the Application and supporting documents.

The Commission entered an Order for Notice and Hearing that, among other things, permits the Cooperative to place its proposed rates, charges, and terms and conditions of service into effect, subject to refund, for bills rendered on and after October 1, 2018.

By Hearing Examiner's Ruling dated March 29, 2018, a public hearing was scheduled at 10 a.m. on August 14, 2018, in the Commission's second floor courtroom located in the Tyler Building, 1300 East Main Street, Richmond, Virginia 23219, to receive the testimony of public witnesses and the evidence of the Cooperative, any respondents, and the Commission's Staff. Any person desiring to testify as a public witness should appear at the hearing location fifteen (15) minutes prior to the starting time of the hearing and contact the Commission's Bailiff.

Innovative Program Doubles Number of Students Eating School Breakfasts

With a public hearing on Northampton County's budget not scheduled until May 29, school officials in attendance at this week's supervisors meeting were given a reprieve from debating 4 percent raises for teachers or the cost of providing custodians and cafeteria workers a living wage.

Instead, they were invited to comment on the success of a new program that encourages more students to start their school day by eating breakfast and fueling their brains for learning. Supervisor Oliver Bennett, a Northampton public school teacher, asked Superintendent Eddie Lawrence to talk about the Grab 'N' Go program, which gives students a more convenient alternative to traditional school breakfast.

Northampton schools received a grant for the kiosks in the hallways where students can get breakfast as soon as they arrive at school in the morning, bypassing the cafeteria and taking their food to their classrooms to eat.

Lawrence said Grab 'N' Go has doubled the number of students at the

middle and high school who eat school breakfast, with participation increasing from 19 percent to 38 percent.

He admitted he was initially skeptical of Grab 'N' Go but was pleasantly surprised by the outcome. As an added bonus, the program gives students the opportunity to socialize with different people and make new friends, Lawrence said.

Finance Director John Chandler presented school budget amendments in the following amounts: \$4,550 for a Virginia Department of Education grant for the teacher mentoring program that will support 22 first-year teachers; \$1,500 for Northampton County Education Foundation funds for tutoring student athletes; a \$10,000 appropriation from the school food service fund balance to replace kitchen equipment; and an approximately \$4,500 appropriation representing the balance of funds from the eLearning Backpack Supplemental grant.

County budget amendments included an insurance reimbursement of about \$11,000 for a damaged sheriff's vehicle, a \$10,000 transfer from the regional jail

fund (payroll vacancy savings) to the sheriff's general fund for vehicles and equipment, and a \$7,600 insurance reimbursement for ice damage to the dock at Oyster.

It is a property reassessment year in Northampton. Supervisors approved an ordinance establishing Aug. 31, 2018, as the deadline for the Board of Equalization to complete its deliberations. July 2, 2018, is the deadline for property owners to apply to the Board of Equalization to review their real estate assessments.

A boundary adjustment in Eastville resulted in the town gaining 17 new residents. In accordance with Virginia law, those residents must be transferred from Cheriton's voting district, District 2, to Eastville's voting district, District 4.

These citizens will no longer be represented by District 2 Supervisor David Fauber and will become constituents of District 4 Supervisor, Chairman Spencer Murray.

General Registrar Terrence Flynn refreshed supervisors on the matter which was tabled in October 2017 when supervisors requested confirmation of their authority to move voters to a different voting district.

Samantha Buckley, a policy analyst with the Virginia Department of Elections, confirmed that "precinct and district lines are a local issue and are not under the authority of the Department."

Supervisors must hold a public hearing, likely in May, before amending the ordinance and allowing the 17 affected voters to be moved to the proper and lawful voting district.

Another issue supervisors could not act on immediately involves a subsidiary of the Eastern Shore Community Services Board, Mendisadd Inc. They submitted two applications for special use permits for group homes for individuals with developmental disabilities in Exmore and Franktown.

The county zoning ordinance requiring special use permits for group homes is unlawful under Virginia code. State law requires facilities where no more than eight disabled persons reside to be treated as a single-family residence. A zoning ordinance amendment should be ready for supervisor review next month.

Felony Wounding Charge Reduced

Charges were reduced from felony malicious wounding to misdemeanor assault and battery last week in Accomack Circuit Court in the case of an Onancock man who threw a bottle at a vehicle and broke the driver's door window last year.

Christopher Michael Strand, 21, of Pine Street in Onancock, was convicted of assault and battery of Anjinai Blake and Kentara Tazewell and of throwing a missile at an occupied vehicle. The incidents occurred Sept. 10, 2017. Strand was remanded to Accomack Jail to await the completion of a presentence report.

Tazewell told authorities she went to the home of Blake and Strand because the two had been arguing. Strand threw the bottle after Blake got in Tazewell's vehicle. Trooper A.D. Montross wrote in the file, "Both had lacerations on their arms. ... I observed the window being broken out ... and the bottle inside the van. Ms. Blake advised she was in the passenger seat when Mr. Strand threw the bottle."

Strand told the officer he "did not want to hurt anyone but she (Tazewell) was swinging the bottle at me." There were two small children in the van, who were not injured, Montross reported.

In another case, Elisha Azel Corbin, 25, of James Allen Drive in Machipongo, was sentenced to three years in prison for felony eluding and six months for assault and battery in connection with June 9, 2017, crimes. All but 10 days were suspended. Corbin will be permitted to serve those on weekends. He was ordered to be on good behavior for five years, supervised probation for two years and complete 50 hours of community service with a church or youth program.

Thomas Christopher Toner, 52, of High Seas Drive in Greenbackville, was given five years each for burglary of a house and theft of a vehicle belonging to Kimberly Zeleny. The terms were set to run consecutively with all but six months each suspended. Toner was put on probation for three years and ordered to be on good behavior for 10 years. The incidents occurred in 2016.

Michael Warren Custis, 60, of Cashville Road in Onancock, pleaded guilty to misdemeanor giving a false report. He was initially charged with felony making a false claim regarding a boat in August 2017. He was sentenced to 60 days in jail with all but four days suspended.

Gary Joseph Fleig, 42, and Amanda Jean Kelley, 28, both of Marsh Market Road in Hallwood, pleaded guilty to petty larceny. The charge was originally felony theft that occurred Jan. 6, 2014. He was sentenced to 13 months in jail. She got 12 months in jail. Both terms were suspended. Fleig and Kelley were each ordered to pay \$900 in restitution to Wayne Norton.

Ebony Rena Baines, 27, of Washington Street in Exmore, was given a three-year suspended sentenced for possessing cocaine on Aug. 8, 2016. It was her second offense. Baines was also ordered to be on good behavior for five years and supervised probation for three years. Her driver's license was suspended for six months.

Jordan Lewis Sterling, 34, of Decormis Street in Accomac, pleaded guilty to assault and battery of Deputy Brian Misener in connection with a July 30, 2017, incident. A presentence report was ordered. The case was continued until August. He is being held in the Eastern Shore Regional Jail.

Aimee Beth Long, 41, of Wallops Mill Drive in Horntown, was sentenced to five years with all but time served suspended for unauthorized use of a vehicle on Sept. 25, 2017. Long was put on supervised probation for three years. Her driver's license was suspended for a year and she was ordered to make restitution of \$1,500 to David Long, also of Horntown.

A \$12,500 secured bond was granted for Lachelle Vaneette Collick, 39, of Worcester Highway in Pocomoke, Md. She is being held in Accomack Jail in connection with charges of stealing property belonging to Mike Smolinski, burglary and receiving stolen property in November 2017.

Man Sentenced for Fraudulent Payroll Checks

Brian Terrell Walker, who was convicted of manslaughter in the 2010 death of a baby, will serve 18 months in the Eastern Shore Regional Jail for changing his payroll checks so he could fraudulently obtain \$300.

Judge W. Revell Lewis III sentenced Walker, 32, of Lee Street in Belle Haven, Monday in Northampton Circuit Court. Walker got three years in prison for each of the three counts of forgery with all but six months each suspended. The terms were set to run consecutively. Walker could have gotten up to 15 years in prison and an unspecified fine for the offenses. He initially told authorities, "His boss wrote the checks wrong."

In exchange for the guilty pleas, Commonwealth's Attorney Beverly Leatherbury previously agreed not to prosecute him for two more counts of forgery and for uttering a check.

Walker worked for Simpson Tree and Bobcat Service. Leatherbury said the defendant attempted to cash an altered check at Tru Blu in Exmore in March 2017 and was caught.

Walker was convicted in Accomack Circuit Court of involuntary manslaughter in the death of his then-fiancée's 11-monthold son. At that time, he lived in Parksley with the family of the victim. He was sentenced in accordance with a jury's recommendation of five years in prison.

In another case, Antwine Tazewell, 36, of Cheriton, was convicted of possession with intent to distribute cocaine in October 2016. The case was continued pending completion of a presentence report. Tazewell was not prosecuted for a misdemeanor charge of possession of marijuana.

Larry Goffney III, 30, of Chester, Pa., was sentenced to five years in prison with all but eight months suspended for distribution of Vicodin in September 2015. He

was given a month in jail for failure to appear, which was set to run consecutively with the other term. Goffney was ordered five years of good behavior and two years of supervised probation.

Todd Countain, 36, of Brooklyn, N.Y., was given suspended sentences for credit card crimes that occurred June 28, 2015. He got three years with all but two months suspended for five counts of credit card larceny and three years with all but three months suspended for possession of forgery equipment. The terms were set to run consecutively. He was ordered to be on supervised probation for three years.

Assault Charge For Wachapreague Man

A Wachapreague man was charged Sunday with assault and battery of a police officer, according to records filed in Accomack General District Court.

Brandon Q. Harmon, age unavailable, was arrested the same day and is being held in Accomack Jail.

Deputy K.M. McGregor, of the Accomack County Sheriff's Office, was the complainant in the case. A May 21 preliminary hearing was scheduled.



Northampton Chairman Reacts to Offshore Drilling Forum

At Tuesday's meeting of the Northampton Board of Supervisors, Chairman Spencer Murray offered his reaction to the forum on offshore drilling attended by Sen. Tim Kaine at the Virginia Institute of Marine Science Eastern Shore Laboratory in Wachapreague on Monday.

Murray asserted there is "unanimous opposition" to offshore drilling from representatives across the Eastern Shore.

He and the chairman of the Accomack Board of Supervisors, Robert Crockett, represented their respective counties at the forum. Representatives of the Shore's tourism and aquaculture industries, as well as NASA and Wallops Island, were also present, Murray said.

The environmental risk presented by offshore drilling would not be balanced by any economic benefit, because it would not create local jobs, Murray said. Kaine suggested the county could receive "royalties" from offshore drilling profits.

"If we had an oil spill ... what difference would royalties make? ... What

would we spend it (the money) on?" Murray asked, suggesting an oil spill would effectively eliminate the Shore's tourism and aquaculture industries.

The risk to the shoreline is "overwhelming," he added. Murray is skeptical of the safety of current offshore drilling practices.

"They told us also that when (Hurricane) Katrina hit ... they said the levees would hold, but they didn't. When the Deepwater Horizon (oil well drilling platform) had an explosion and fire, they said that the blowout valve checkpoints would work, and they didn't. And billions and billions of dollars of ecological and commercial damage followed."

In January, Gov. Ralph Northam wrote a letter to Secretary of the Interior Ryan Zinke, asking that Virginia be exempt from the Trump administration's plan to expand offshore drilling. To date, Florida is the only state to be exempt from the plan.

Northam attended an offshore drilling forum at Old Dominion University in Norfolk in March. Monday's Virginia Institute of Marine Science

event in Wachapreague was the first of its kind on the eastern side of the Chesapeake Bay.

Northampton has finished one project supporting aquaculture and tourism. County Administrator Charles Kolakowski announced repairs at Morley's Wharf are complete, "proving to be a popular improvement with both the commercial and recreational boaters," he said. Among the repairs, two battered docks were replaced with new, floating docks, enabling boaters to launch their vessels and perform their work more quickly and efficiently.

The next step is dredging Willis Wharf. The county has applied for new grants to help fund that project, Kolakowski said. It was delayed when previously awarded Virginia Port Authority grant funds were transferred to the Morley's Wharf project.

Cleaning up county property is a foremost concern for citizens and supervisors. Kolakowski mentioned a complaint by at least one citizen about the drainage pond at Bayview convenience center in Cape Charles, which is full of both water and trash. Supervisor John Coker said the problem is made more apparent following rainfall and "It just looks disgusting."

Supervisor Oliver Bennett agreed Northampton has a trash problem and said he has seen "dump truck loads of trash ... on both sides of the road." He suggested strategically placing security cameras in areas known for littering and holding offenders accountable to set an example and deter the problem in the future.

Bennett, a Northampton public school teacher, read statements by some of his seventh-grade students who are concerned about the cleanliness and well-being of their county.

"On my back road ... there is a sign that says, 'No Littering,' and people still litter on the road. ... I want to change that because it's wrong to be dumping trash anywhere there's a dumpster that they can go to and dump their trash. Thank you and have a nice day," one statement read.

Murray indicated Sheriff David Doughty has plans to address the county's litter problem later this spring.

Northampton Explores Means of Social and Emotional Support for Students

Northampton public school students represent diverse cultural backgrounds and not all come to school socially or emotionally prepared to learn and follow behavior expectations, school psychologists Heather Welch and Julia Doherty discussed with school board members March 22.

The duo have been searching for an evidence-based program teachers can implement in the classroom to address students' ongoing social and emotional learning needs.

Northampton schools already participate in the Positive Behavioral Interventions and Supports program, funded by the U.S. Department of Education. PBIS is used by schools all over the country to positively reinforce good student behavior through rewards systems. For example, many schools issue students good behavior "tickets" that students can save and redeem for participation in special school functions like pizza parties.

However, as stated on its own website, PBIS is not intended as a standalone or magic wand solution to disruptive classroom behavior. "The cli-

mate of each learning community is different; therefore, a one size fits all approach is less effective than interventions based on the needs of each school," it says.

Northampton schools are ready to take the next step by providing children with direct instruction in social and emotional well-being, supplemented by the positive behavioral reinforcements already in place.

After reviewing over a dozen different programs, Welch and Doherty recommended Second Step, which they believe will fulfill the goals of equipping students with competence in five main areas: self-awareness, self-management, social awareness, relationship skills and responsible decision-making.

Second Step can be used for grades pre-K through eight, although Northampton schools' initial focus of the program will be at the elementary level.

Second Step is designed to be easy to use. While some social-emotional lessons are designed to take up a whole class period, each of Second Step's 22 to 28 topics can be incorporated into the teacher's scheduled activities

across a five-day period and require minimal planning, according to Welch and Doherty's report.

The lessons are written out stepby-step and include activities, games, songs, and other interactive media. They also include materials to be shared with parents at home to reinforce the lessons.

The lessons and activities can be retaught and reused as alternatives to suspensions, Welch and Doherty's presentation stated.

For grades pre-K through 3, the Second Step curriculum is broken into four units: skills for learning, empathy, emotion management and problem solving. For higher grades, the material is condensed into three units:

- Unit 1 of Second Step guides teachers as they equip students with basic skills like listening, paying attention, following directions, and staying on task.
- Unit 2 teaches empathy by helping students learn how to identify their feelings and to show others they care.
- Unit 3 focuses on managing emotions like anger and frustration,

teaching children how to calm down in stressful school situations, whether they get an answer wrong or feel wronged by one of their peers.

 Unit 4 expands on the topic of peer relations by teaching students problem solving through playing fair, inviting others to join, and handling playground issues like peer pressure or name-calling.

According to the organization, Committee for Children, featured on the Second Step website, schools that teach social-emotional learning experience a 50 percent reduction in discipline problems, and students score 10 percent better on achievement tests.

Welch and Doherty estimate Second Step would cost just under \$7,000 for two kits, one for each of the county's two elementary schools, Occohannock and Kiptopeke. There would be no recurring charges for materials, and the program includes free online training for teachers.

They recommend implementing the program either with teachers presenting the lessons independently or in cooperation with school counselors.



NOAA ANNOUNCES VOLUNTARY SPEED RESTRICTIONS TO PROTECT WHALES

The National Oceanic and Atmospheric Administration (NOAA) announced voluntary speed restrictions for vessels traveling in a zone that includes the coast of Northampton County.

The goal is to protect five North Atlantic right whales sighted 69 nautical miles northeast of Virginia Beach. Mariners are requested to go around this area or travel at 10 knots or less

Seventeen of the whales died in 2017 and another was lost this year. This is "an alarming number for such a critically endangered species with a population currently estimated at about 450."



Chincoteague Chamber of Commerce Easter Decoy and Art Festival Awards

The Chincoteague Chamber of Commerce Easter Decoy & Art Festival is one of the largest on the East Coast with a loyal following of attendees and exhibitors. It is one of the first festivals on the Eastern Shore of Virginia and is considered a rite of spring on the islands. Fine art, carvings, jewelry, sculpture and other artisan crafts were showcased by 80 exhibitors at the two-day festival.

People's Choice Award for Best Carver was awarded to Chincoteague native Cork McGee. An island native for 87 years, McGee began carving hunting rigs - he guided hunting trips for ducks and geese for 58 years. He mentored under Cigar Daisey as he "hung out in his shop." His family lived on Assateague Island for many years and his father was a waterman. Now his decoys are collectors' items.

People's Choice Award for Best Artist was awarded to island local Nancy Richards West. West has been a professional artist on Chincoteague Island since 1974. Her primary focus is the creation of oil paintings of landscapes, birds and animals, still life and nudes. She works in pastel and the ancient art of sumi-e painting (Chinese brush stroke painting). Many of West's landscape paintings are

done en plein air (outdoors), where she is "drawn to the challenge of painting the fleeting light."

Best Photograph of Chincoteague or Assateague was presented to Captain Debbie Ritter for her outstanding photo of the early morning Pony Swim in 2017. Ritter has studied and captured images of wildlife on the Eastern Shore for over 30 years and has a large body of work featuring wild Chincoteague ponies. She captains her own cruise boat under the name Chincoteague Nature Encounters.

The Curtis Merritt Award of Excellence is awarded to an exhibitor demonstrating exemplary qualities as an artist or carver as chosen by a jury of their peers. The 2018 recipient is Grover Cantwell Jr. Cantwell is a self-taught artist whose goal is to capture the mood of the marshes, beaches and wildlife through the changing seasons of his native Eastern Shore of Maryland. Watercolor is his most frequently used medium, but he enjoys oils, pen and ink, and pastels as well.

The Chincoteague Combined School Band was the recipient of the Pre-Loved Treasures silent auction proceeds. A wide variety of pre-owned

southern herd around 4:30 p.m. Friday. The ponies will be taken to the pen on Beach Road. The roundup usually takes a couple of hours. While the cowboys are busy with the second roundup on Saturday, the vet will be checking the ponies that were herded on Friday. The ponies will be inoculated against West Nile and equine encephalitis. They will also be dewormed and given an overall check. After the vet is done there, those ponies will be released back into the wild and the vet will head up to the northern corral to perform the same services on those ponies. Once he is done there, they are released into the wild to roam and await the next roundup.

n Saturday, April 28, from 10 a.m. to 2 p.m. the Northampton Sheriff's Office and the Drug Enforcement Administration will give the public its 15th opportunity in 8 years to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. Bring your pills for disposal to Northampton Sheriff's Office at 5211 The Hornes, Eastville, Va. (The DEA cannot accept liquids or needles or sharps, only pills or patches.) The service is free and anonymous, no questions asked.

Last April, Americans turned in 450 tons (900,000 pounds) of prescription drugs at almost 5,500 sites operated by the DEA and more than 4,200 of its state and local law enforcement partners. Overall, in its previous Take Back events, DEA and its partners have taken in over 8.1 million pounds—more than 4,050 tons—of pills.

This initiative addresses a vital public safety and public health issue. Medicines that languish

in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental



poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—both pose potential safety and health hazards.

Chincoteague Couple Receives ANEC Good Samaritan Award







Local Term Limits Needed

Over the last few years, we have all watched with horror as school shootings across the United States have taken place. We have been fortunate here in Virginia to avoid such an incident in recent years. Following the tragic events that took place at Virginia Tech in 2007, the General Assembly made significant, meaningful reforms aimed at not only keeping colleges and universities safe, but also our schools. After the Sandy Hook shooting in 2012, the General Assembly established a grant program for schools to purchase and install security equipment. We cannot simply take actions once and assume all is well. We must continue to look at ways we can keep students safe in school. Additionally, we must evaluate what we have done, how well it is working, and what else needs to be done.

Last month, Speaker Cox announced the formation of the House Select Committee on School Safety to take a new, in-depth look at how we keep children safe at school and ways we as a commonwealth can improve. This is the first select committee established in more than 150 years in Virginia. This underscores the importance of this matter. Select committees are reserved for matters of considerable significance that fall beyond the jurisdiction of conventional and established standing committees. The select committee's work will be focused on strengthening emergency preparedness, hardening school security infrastructure, implementing security best practices, deploying additional security personnel, providing additional behavioral health resources for students, and develop-

ing prevention protocols at primary and secondary institutions across the commonwealth.

We must ensure students are able to learn in safe environments without the fear of violence. I am proud of the steps we have taken in recent years to protect our schools, but there may be more we can do. The select committee is tasked with developing the next steps on this important issue, with recommendations made by the committee up for consideration by the General Assembly during the 2019 session.
