## ANNUAL PONY PENNING STARTS SATURDAY

As the Chincoteague Volunteer Fire Company's Saltwater Cowboys round up the Chincoteague ponies this weekend in preparation for Wednesday's 93rd pony swim, more than 30,000 people are expected to flock to the island to witness the annual event.

The ritual has deep roots. "I really don't have all the words to explain it. It's something that's in our blood, this whole pony thing," said fire company spokesperson Denise Bowden. "There is just nothing to compare it to for us."

The southern herd round-up is Saturday, July 21 around 4 p.m. Ponies will be herded into the southern corral. The public may view the arrival of the ponies to the corral.

The northern herd roundup is Sunday around 7 a.m. The public is not permitted to be present for this roundup.

At daybreak Monday morning, the Saltwater Cowboys will escort the northern herd along the beach to be joined with the southern herd. The ponies will undergo veterinarian checks while in the southern corral. The public can visit the corral and take photos July 21-24.

The swim is scheduled for Wednesday between 8 and 10 a.m. at slack tide, a point at which there is no current. After the swim, the Saltwater Cowboys guide the ponies through town to the carnival grounds.

The auction commences Thursday at 8 a.m. sharp. Registration is not required for bidding.

## TASLEY CRASH CLAIMS TWO LIVES, SENDS TWO TO HOSPITAL

A Parksley area couple was killed in a traffic crash at the intersection of Accomac Road and Lankford Highway in Accomac late Monday afternoon, said Sgt. Michelle Anaya of the state police.

Their two daughters, both juveniles riding in the backseat of the car, were taken to Sentara Norfolk General Hospital to be treated for serious injuries. They were not identified.

Juan Enriquez Martinez, 39, of Greenbush Road, was driving a 2003 Pontiac Rendezvous east on Accomac Road, according to a preliminary investigation. He failed to stop for a red light and pulled into the path of a 2014 Peterbilt tractor-trailer that was southbound in the left lane of the highway. The truck then struck

the car.

Martinez and his wife, Christina Martinez Lopez, 41, who was in the front passenger seat, died at the scene.

The crash occurred at about 5:20 p.m. Juan Carlos Melgarejo Borrego, of Hialeah Gardens, Fla., was driving the truck. Anaya's report did not mention if Borrego had injuries.

Tasley, Onancock, and Parksley fire companies responded, according to a 911 dispatcher. Parksley and Onancock ambulances also went to the scene.

Members of the Martinez family said Tuesday they had witnesses who saw the tractor trailer driver go through a red light and that Martinez had a green light. They were seeking legal help to prove that and to get custody of the two girls.

# Supervisors Endorse “Road Diet” for Market Street in Onancock

Dieting was discussed Wednesday by the Accomack County Board of Supervisors. But the supervisors weren't talking about eating more fruits and vegetables. Instead, it was a lane reduction plan, known as a road diet, for Route 179, also known as Market Street, from Riverside Shore Memorial Hospital's entrance to the edge of Onancock.

The supervisors agreed to send a letter of support to VDOT for the quest. County Administrator Mike Mason explained primary safety concerns included the increase of bicycle riders and pedestrians using the road to get to the hospital and Four Corner Plaza and the lack of a dedicated center turn lane.

Route 179 is four lanes in this area. The change would mean reducing the lanes to three with the middle lane for turning. No construction would be needed. But the road would have to get new stripes. The extra space would be

used for pedestrian/bicycle lanes on both sides of the road.

Historically, a middle lane has been referred to as a “suicide lane” as impatient drivers from both directions tend to use it as a passing lane.

Supervisor Laura Belle Gordy voiced concern about the change. “There will be a lot of confusion because it is a very busy place,” she said. “Old people like me will have to be really thinking. I think it's going to be really dangerous.”

Mason said Onancock leaders are supporting the change and those in Onley are expecting to also favor it.

“If it doesn't work, you can change it back,” said Chairman Robert Crockett.

The supervisors also voted to spend about \$20,000 to install lighted time-of-day school zone speed-limit signs on Warrior Drive near Nandua Middle School. They also reiterated the need for road work on Redwood Road in Onley. VDOT reported “no improvements” are needed at the intersection of Chincoteague and

Fleming roads in Wattsville.

A dozen or so members of the Bayside Community Revitalization Team asked the supervisors for assistance in their quest to improve the area, which is known as White Rabbit by older residents. Myra Riley Taylor, who lives in Maryland but owns property in the community, said among the group's goals are bringing back prosperity, getting ditches cleaned out, improving the quality of drinking water, slowing traffic, and updating the former school. Nearly 50 homes there are occupied while almost 40 are abandoned or dilapidated, some because the structures lacked plumbing. There are also 26 vacant lots and 28 wooded ones. Once 250 people lived in Bayside. Now there are about 100. Improvements and possible funding are being studied by the Eastern Shore Planning District Commission.

The supervisors also:

- Approved increasing sewer rates from \$19.12 per thousand gallons to \$21.70 to adjust for hikes made by the

Town of Onancock.

- Agreed to spend between \$15,000 and \$31,000 to modify county software so 14 towns could bill for vehicle license fees and eliminate decals. The county already creates and/or prints real estate and/or personal property bills for the municipalities.

- Accepted a formal policy for the use of non-county entities for county facilities like the board chambers, airport conference room, and Saw Mill Park.

- Accepted a bid of \$198,264 for improvements to the old NASA ferry dock to Murtech Inc. of Maryland, for second phase of the project.

- Appointed Andre Elliott of Painter to the Eastern Shore Community Services Board and Robert Budd Martin of Atlantic to the Accomack Social Services Board.

- Greeted Donna Sample Smith, the new head of the Eastern Shore Area Agency on Aging. The 1975 graduate of Onancock High returned to the Eastern Shore, which she loves, after 43 years.

# Sidewalks Off the Sidelines in Cape Charles Discussions

A recent petition from a Cape Charles couple to the town council revealed a disagreement about who is responsible for the construction of sidewalks, but at least one local says the conflict is nothing new, and for her, the issue has continued for 40 years.

Larry and Pam Reynolds recently completed construction of a new home on the corner of Washington Avenue and Fig Street, in the northeastern part of town. They installed a sidewalk in front of their home on Washington Avenue but were not aware one was required on the Fig Street side of the property.

According to Cape Charles town code, section 62-4, the council “may require and compel the owner of property within the town to construct or maintain sidewalks abutting on the property of such owner along existing streets.”

Since 2001, it has been common practice for the town to require owners of newly constructed homes to install

sidewalks, acting Town Manager Larry DiRe said.

The Reynolds family requested an exemption from continuing the sidewalk onto Fig Street due to unspecified “existing obstructions.” Submitted photos of the property show two rows of orange flags placed by Virginia Department of Transportation Area Land Use Engineer Dale Pusey, outlining the path the sidewalk should follow – with a tree stump in the middle.

The Reynoldses are also worried about their privacy. The sidewalk would run within seven feet of their living room window.

Cost is another concern. The Reynoldses paid about \$2,900 for the 5-foot-wide, 40-foot-long sidewalk in front of their home on Washington Avenue. If they paid the same amount per square foot to continue the sidewalk along the Fig Street side of their lot, which is 100 feet long, it would cost \$7,250.

An unexpected \$7,250 expense would be a hardship. Larry Reynolds

said building the home was “planned to the penny” and the family has already paid a lot to live in Cape Charles, including more than \$12,000 to hook up to the town water and sewer system.

But the Reynoldses will have no choice but to face the hardship. On July 12, the town council voted 4 to 1 to compel the Reynoldses to complete the sidewalk. (Tammy Holloway cast the opposing vote and Cela Burge was absent.)

When a reporter spoke to Larry Reynolds on Tuesday, the town had not yet notified him of the decision made on the previous Thursday.

Other Cape Charles residents are at odds with the town council over Fig Street sidewalks for a different reason. They want sidewalks – to keep pedestrians safe. The current sidewalk system on Fig Street is sparse and inconsistent and has been that way for at least 40 years.

In May, Dianne Davis said when she moved back to Cape Charles in 1978, sidewalks were lacking on Fig

Street and the town still has done nothing about it. In July, she added that during segregation, Fig Street belonged to the “African-American section” of town “so no one cared” if those residents had sidewalks.

Phil Goetkin also wants the town to complete construction of sidewalks. Unless the town forms a sidewalk management plan or increases taxes, “there will be no sidewalks in our lifetime” or the lifetimes of residents’ children or grandchildren, he said.

Others sided with the new homeowners. Diane D’Amico said the language in the town code, such as the use of the word “may” instead of “shall,” is not strong enough to give council the authority to compel homeowners to install sidewalks at their own expense.

Reynolds said, “you have to really want to live in Cape Charles” because of how expensive it is. He and his wife, Pam, plan to spend their retirement there. “She just loves being in Cape Charles.”

# Some Say Proposed VDOT Project at Stone Road/Food Lion Is the Wrong Fix

The Virginia Department of Transportation is planning to begin work on what VDOT Accomac Residency Administrator Chris Isdell dubbed the "Food Lion intersection project" in Cape Charles, though Northampton supervisors say most of the planned road improvements are unnecessary and fail to address the root of the problem at the dangerous crossroads.

The estimated cost of the project is \$1.7 million and is expected to be completed in 2021.

The road improvement plan is the culmination of a corridor safety study and an application submitted by Northampton County to VDOT's Smart Scale program in 2016, Isdell said.

VDOT summarizes its Smart Scale program as "investing limited tax dollars in the right projects that meet the most critical transportation needs in Virginia."

The goal is to improve safety on Route 13 near the Food Lion shopping center in Cape Charles. The sec-

tion of road about .3 miles long has been redesigned according to current federal standards.

The main feature of the redesign is the widening and lengthening of eight turn lanes, most up to 200 feet.

The affected turn lanes traveling southbound are as follows: the left turn lane onto South Bayside Road, to Cheriton; the left turn lane onto Country Plaza, to Dollar General; and the right turn lane onto Country Plaza, to Union Bank & Trust.

The affected turn lanes traveling northbound are as follows: the right turn lane onto Country Plaza, to McDonald's; the left turn lane onto Country Plaza, to Union Bank & Trust; the right turn lane onto Country Plaza, to Dollar General; the right turn lane onto South Bayside Road, to Cheriton; and the left turn lane onto Stone Road, to Cape Charles.

The southbound shoulder between Stone Road and Country Plaza also will be widened to 4 feet.

Other safety enhancements in-

clude tapered roadway edges, six-inch-wide road markings, upgraded road signs, and an addition that particularly "excited" Isdell – highway lighting at the intersections leading to the shopping center and to Cape Charles, he said.

But Supervisor John Coker disagreed with VDOT's plan for safety enhancements.

"It just seems to me you're doing a lot of expanding of lanes and turning lanes, when really all you need to be doing is basically three things," lowering the speed limit to "45 (mph) with some blinking lights, like you have in pretty much every other town on Route 13 north of us," closing the Food Lion crossover so drivers exiting the bank must turn south and customers leaving Food Lion must turn north, and widening and lengthening the left turn lane onto Stone Road.

"The one thing you don't know – people ... come out of the bank and go straight over to Food Lion. ... I've almost been killed there, two or three times. ... It's a damn dangerous inter-

section," Coker told Isdell.

"I think what you're doing is good, okay, but it's not good enough," Coker said.

Chairman of the Board of Supervisors Spencer Murray agreed with Coker that speed is a problem and the Food Lion shopping center in Cape Charles should be part of a reduced speed zone like Shore Plaza in Exmore.

If the crossover between Food Lion and the bank was closed, an access road could be built from Business Route 13 to the shopping center as an alternative means of entrance and exit, but it would cost \$4.5 million and would not be an eligible project for the Smart Scale program. Northampton County would not get the opportunity to submit an application for that project until 2020.

VDOT will hold a public hearing on the planned road improvements at Route 13 and Stone Road, aka the "Food Lion intersection project," on July 24 at the Cape Charles Civic Center, 500 Tazewell Ave., Cape Charles, from 4 p.m. to 6 p.m.

# NORTHAMPTON CONSIDERS MORE SCENARIOS FOR NEW OR RENOVATED HIGH SCHOOL

Northampton Chairman of the Board of Supervisors Spencer Murray may count himself among the “mean, old supervisors who must not care about education,” but at the board’s July 10 meeting he agreed to form a joint committee of supervisors and school board members dedicated to solving the issue of the poor physical condition of Northampton High School.

Northampton schools Superintendent Eddie Lawrence proposed the creation of the committee. Supervisor John Coker was the first to volunteer to serve on it.

It could be the first step in correcting what Northampton County Education Foundation Board Member Andy Teeling called a “misunderstanding.”

“Everyone wants the same thing ... to fix the school,” he said.

The committee will form a plan for Northampton High School, whether that involves renovation, construction, or a combination of both. “Any idea is a good idea,” Murray said.

His out-of-the-box suggestion is “renovation of the Machipongo middle school with new heating and cooling infrastructure, upgraded auditorium, cafeteria, and using the existing gym, athletic fields, and tech center that we already own.

“At a cost of approximately \$5 (million) to \$7 million that option would increase operating costs but perhaps (lessen) debt service on \$40 million and, if feasible, it would provide a nearer term option for only 248 middle school students.”

Lawrence wants to move the sixth grade from the elementary schools to join the seventh and eighth grade in middle school, which would increase the number of middle school students to 393.

It is unknown exactly how much money could be saved on the high school project by renovating the middle school and relocating hundreds of students, although the option would address the concern raised by parents that Northampton middle school students have no autonomy in their current situation sharing a facility with high school students.

Stephanie Zodun, whose children

attend Northampton schools, said, “My middle school kid didn’t have a middle school, he had a hallway.”

Though supervisors have left the public with the impression that “No, you’re not getting \$45 million, period,” as concerned citizen Michelle Surran said, they are still considering scenarios in which borrowing more than \$40 million for a new school may be feasible.

On June 25, supervisors asked financial consulting firm, Davenport & Company, to devise a scenario in which Northampton could borrow the money for a new school while keeping its current debt service – how much the county pays annually on its debts – to \$3.1 million.

In a previous scenario, the county could have borrowed the money and kept its debt service at about \$3.2 million, but accounting for interest and fees, Northampton would have paid nearly \$72 million for a \$40 million school.

Murray said this scenario would “handcuff” the county “with no new capital or services possible” for 20 years.

In the new scenario, new debt would be issued as the county’s old debt is paid off. Payments on both interest and principal would begin in the year the debt is issued and continue for 20 years. Including interest and fees, Northampton would pay about \$62 million for a \$40 million school, saving roughly \$10 million compared to the previous scenario.

Supervisors will discuss the new scenario in a future meeting and decide if it’s feasible.

Davenport also calculated how much additional debt the county could take on with a 2-cent tax rate increase.

Northampton could borrow an extra \$11 million at a total cost of about \$16.5 million, including interest and fees, starting payments on principal and interest in the same year.

By paying only interest for a period before beginning principal payments, Northampton could borrow \$19.9 million at a cost of about \$32 million, or \$29.7 million at a cost of about \$48 million.

In spite of unfounded rumors, in no circumstances have supervisors proposed doubling taxes.

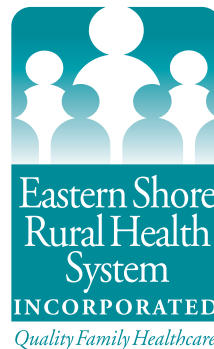

### Nandua High School Teacher Sentenced In Barroom Brawl

A deal was struck in Northampton Circuit Court that allowed a Nandua High School teacher to get a slap on the wrist for his part in a barroom brawl last Christmas Eve in Cape Charles.

Jeffrey Antonio Wayman, 39, a physical education and driver's education instructor who coaches football and Little League, pleaded guilty to assault and battery and disorderly conduct, both misdemeanors. A felony charge of strangulation will not be prosecuted in exchange for those pleas.

Judge W. Revell Lewis III gave Wayman two six-month suspended sentences for his crimes. Rows of friends and family members, two Northampton deputies, and Nandua Principal George Parker were among his supporters.

Commonwealth's Attorney Beverly Leatherbury agreed not to pursue the felony because of his otherwise clean record. But she also unsuccessfully urged Lewis to give him jail time.

"This is stuff that should not happen in our community," said Leatherbury. "However, the commonwealth has backed off because of his lack of record and (his) good standing in community ... this looks like a reaction of a bully ... something that a mature person, a person in a leadership position of children" should not do. "Give him the same jail time (as the other man in the incident) and the \$250 fine," she urged.

Wayman testified he was sitting on a barstool at Kelly's Gingernut Pub at about 1 a.m., Dec. 24. Tyler Combs, 21, of Seaside Road in Capeville, was beside him. The two were friends. Wayman said Combs was urging him to switch from water to alcohol, calling him a disparaging name for not doing so and making other remarks about Wayman's 22-year-old girlfriend. Combs said she was too young for Wayman.

Wayman said he had been in the bar for about 90 minutes and was watching a football game. Earlier he had dinner at his parents' house and asked them to watch his children so he could go home to Belle Haven to wrap Christmas presents. He stopped at the bar before going home.

A video from the pub was shown to the court several times. Wayman was seen

putting Combs in a headlock and holding him there for about seven seconds. Leatherbury said he put "heavy pressure on Combs' windpipe." The recording had no audio. Leatherbury said Wayman told Combs they could go outside to see who was the tough one.

There was a roomful of people at the pub but no one called the police. Combs did not testify at Wayman's trial. Officer Andrew Spencer of the Cape Charles Police Department, who investigated the case, also was not called as a witness.

Earlier this year, Combs pleaded guilty to disorderly conduct and reckless handling of a firearm in connection with the incident. Both are misdemeanors. Retired Judge James A. Moore of the fifth judicial circuit was brought in to hear the case. Judge Gordon Vincent recused himself because he works with Wayman's aunt, Clerk of the District Court Karen Sparrow Merritt. Tony Branch, a deputy clerk of the district court, sat in for Merritt.

Moore sentenced Combs to six months in jail for each offense — the same terms Wayman received. But Combs had to serve a month in jail and pay a \$250 fine.

Character witnesses for Wayman said his actions that morning were not typical.

Defense lawyer Paul Watson accused Combs of getting drunk on previous occasions and picking a fight with Wayman. Combs said insulting things to Wayman and pushed a drink over to him, the lawyer said. "Wayman pushed the drink back over to Combs. Wayman put his arm around Combs' shoulder. Combs strikes him in the face. That's why Wayman put him in a headlock." Watson said testimony at a preliminary hearing had Wayman talking to Combs as he held him down. "I'm going to let you go," a witness said he heard Wayman say. "Don't swing on me. Swing on me and we're going to fight."

Principal Parker praised Wayman for his work as a football coach and teacher. "Mr. Wayman is an outstanding employee ... he is an extremely valuable member of my team ... his relationship with students is appropriate, cordial."

Parker said he thought Wayman could keep his job if he gets convicted of a misdemeanor.

Deputy Steve Lewis and Investigator Michelle Hallett, both of the Northampton County Sheriff's Office, also testified on Wayman's behalf.

Lewis said he has known Wayman for 30 years and he is a devoted coach. "I've talked to him in the last six and a half

months. He's told me ... he's very sorry for what he did. It was a momentary lapse."

Hallett worked with Wayman in Little League and said he always went the extra mile to help the kids and prepare fields. She praised him for his dedication.

Watson pointed to those in the courtroom who were there to support Wayman, including his ex-wife and mother of his children, along with friends, relatives, grandmother, parents, and Merritt.

"Why are you drinking water?" Wayman said Combs had asked him. "You're in a bar." He said Combs called him a name and said something inappropriate about the girl he was dating.

"I asked him to stop. He called me another name and pushed me across the face. That's when I grabbed him. I never intended to do any harm to Mr. Combs." When Wayman let him go, Combs pulled the gun.

"He called me several times that night begging me not to file charges," Wayman testified. "He called me 19 times." Wayman said after the gun was pulled and Combs went outside, he asked the bartender to call the police. He said he felt threatened by Combs because "he put a gun in my face. I tried to defuse the situation by grabbing him. I could have stood up and walked out. I've lost a lot in terms of how people view me. I lost a friend that night," Wayman said.

### Plea Could Get Texas Man 150 Years And \$1.3 Million Fine

A Texas man could get 150 years in prison and be fined more than \$1.3 million for his part in a July 2017 racketeering scheme that involved illegally obtaining nearly \$70,000 from three Northampton businesses.

Darwin Josue Lopez-Ramos, of Houston, Texas, pleaded guilty to 10 felony charges Monday in Northampton Circuit Court. Seven other counts were not prosecuted in exchange for his pleas.

The charges involved forging and uttering nearly 80 bad checks and obtaining money by false pretenses. Fraudulent checks belonging to Lippman Farms were cashed by Lopez-Ramos while he changed clothes and sometimes wore a hat. The businesses were Casa Hispana LLC in Nassawadox, B&B convenience store in Machipongo, and El Ranchito. Several others have also been indicted for their part in the scheme,

Sentencing was deferred until Sept. 17. A short-form presentence report was

ordered.

In another case, Tyler Logan Lewis, 22, of Masden Cut Lane in Machipongo, was convicted of DUI maiming in connection with a traffic crash that occurred March 10 at the intersection of Lankford Highway and Stone Road near Cape Charles.

Lewis admitted to authorities he was drinking alcohol and had used cocaine when he ran a red light.

According to testimony, he struck a car that was going 55 mph on the highway just after leaving The Shanty where he drank five glasses of whiskey. He was not served a sixth drink because he was too intoxicated. His alcohol level was between .17 and .19 grams per 210 liters of breath. The legal limit is .08 grams.

Christian Drummond and her husband were driving through the area on their way back to Delaware from a basketball competition in Norfolk when their vehicle was hit. Her arm was broken into "a z-formation," her nose was broken, she had a punctured lung, five broken ribs, and four fractured vertebrae. Drummond testified she did not return to work for 101 days. She said the pain was worse than childbirth and ranked a 12 on a scale of one to 10. She still needs help dressing and cannot hold or bathe her children.

Lewis was permitted to remain on bond until sentencing. His driver's license was suspended.

Rontari Malik Warren, 24, of Diamond Road in Birdsnest, was sentenced to five years in prison with all but six months suspended each for two counts of felony credit card theft that occurred on Feb. 9 and 22. He got 12 months each with six months suspended for three counts of credit card fraud. The terms were set to run consecutively for a total of two and a half years. He will be on five years of probation upon release.

Iquan Jerrell Smith, 23, of Clearbrook Road in Newport News, Va., was sentenced to 12 months in jail with all but a month suspended for misdemeanor distribution of marijuana. He was initially charged with a felony. Smith will be permitted to serve his time on weekends. His driver's license was suspended for six months. The crime occurred Nov. 3, 2017.

Robert Burgess, of Capeville, was sentenced to five years with all but six months suspended for two counts of possession with intent to distribute cocaine. The crimes happened Sept. 22, 2016. Burgess was ordered to be on probation for two years.

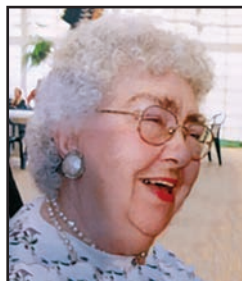

# Acquittal in Captain's Cove Cases, One New Warrant Filed

Timothy R. Hearn, president of the board of directors of Captain's Cove Golf & Yacht Club, was acquitted Monday in Accomack General District Court of seven misdemeanor charges brought by seven residents of the community.

Judge Gordon Vincent dismissed the allegations against Hearn, 58, a commercial real estate developer, because Justin Wilder, the development's communications coordinator, testified he couldn't remember who sent the email directing him to upload 1099 tax documents of former board members and others to the community website.

Hearn later asked Wilder to redact the tax documents to remove Social Security numbers, which Wilder did. But the forms, in violation of state and federal code, are still posted.

Assistant Commonwealth's Attorney Elizabeth Wolff stated the posted forms are illegal despite the Social Security numbers being removed.

Tuesday, John Ward, one of the for-

mer board members who filed the initial warrants, filed one against Wilder, who also lives in Captain's Cove.

It states Wilder illegally posted the IRS tax form 1099 misc. in violation of Virginia law. The posting included three years of tax information about 32 people. "My 1099 was one of those," Ward said.

The original seven contend secrecy of information, restricted use of Social Security numbers, and the Virginia Consumer Protection Act of 1977 were violated. In addition, they say posting the information is contrary to the Internal Revenue Code, the Social Security Act of 1942, and the Social Security Number Privacy and Identity Theft Protection Act of 2007. The other six did not join Ward in bringing a charge against Wilder.

Hearn, who has been president of the board for about five years, predicted how the case would end. "I'm sure once it is in front of a judge, it will quickly be resolved in my favor," he said soon after being charged with the

Nov. 4 crimes.

While Wilder couldn't remember who asked him to upload the information, when he was alerted that Social Security numbers were included, he contacted Hearn to ask what he should do.

The complainants said the website is not accessible to the public but has 1,300 members who could easily copy and paste the information to others.

The underlying issue is money. "From 2008 to 2012 while these individuals and others were on the board of directors, the association lost on average \$250,000 per year ... through fiscal mismanagement," said Hearn. "Every year an audit was done and those numbers were shown" but the directors didn't try to make it up. "They were not investing in capital improvements," he added. "They had not been transparent."

Ward claims mostly former directors were targeted because they were paid for serving. "He (Hearn) decided to tell everyone that we stole," Ward said. "He decided to tell everyone we

took money we weren't supposed to take. He stopped the stipends." Ward said the payments were legal and were included in the group rules. But, giving out the Social Security numbers or employer identification numbers of those recipients is not legal. "Everybody who got a check in a two-year period" got a 1099 tax form that included their numbers, he said.

Ward said state Sen. Lynwood Lewis' employer ID is also on the site because he did legal work for the organization. Lewis was not among the complainants.

"John Ward challenged the current board of directors to prove he took the money," said Hearn. "A piece of the evidence was the 1099s." Ward went to the state HOA ombudsman and requested the forms be shown without redaction and then claimed they showed too much information, said Hearn.

The former directors "were taking money from the association under the guise of being reimbursed for travel expenses" of between \$200 to \$400.

“Very creative from their point when most were a quarter-mile away. Over five years, the money they took, and as members of the Environment Control Committee was close to \$200,000 ... None of the (new) board members have taken any money or requested any of this fictitious travel money.”

“They are very bitter,” Hearn continued. “Their actions were revealed publicly.” Ward is “on record as stating all the successes in his business career” was why he should be paid. Hearn complained the former directors provided “no receipts. They just went to meetings and had money paid to them.”

“I think they are embarrassed,” Hearn continued. “The community is just a wonderful place. No dues increase in four years now. It’s just a question of having a group of professional civic-minded people.”

In addition to Ward, the charges against Hearn were filed by Janice Widmyer, of Starboard Street in Greenbackville; Wayne Woodhams, of Merrimac Court in Greenbackville; John R. Vincent, of Lakeland Drive in Pocomoke City, Md.; George J. Dattore, of High Sea Drive in Greenbackville; Judith Ann Hunt, of Scimitar Way in

Greenbackville; and Richard W. Eicher, of Goby Trail in Bonita Springs, Fla.

## Accomack Schools Hear About Intervention Services

Accomack schools have another opportunity to reduce the number of in-school and out-of-school suspensions for its students.

Family Preservation Services, a provider of school-based, therapeutic day treatment, gave an overview of its services and performance to the Accomack school board on Tuesday.

Eastern Shore Regional Director Jonda White introduced herself, then turned over the presentation to Director of Program Development Jessie Woods.

Woods believes "every kid should love school," and Family Preservation Services fulfills that vision by helping students achieve readiness to learn, increase social and emotional skills, learn safe behaviors, improve attendance and reduce suspensions.

Family Preservation Services helps children become more independent and able to self-regulate their behavior using an evidence-based curriculum called Skillstreaming.

It also emphasizes trauma informed care, meaning counselors are trained to recognize and understand when children have experienced trauma, handling each situation with care and helping children restore their sense of safety and control.

Instead of taking students out of class to receive services, each counselor stays in the classroom all day, working with four to six students.

Family Preservation Services collaborates with administrators, solicits feedback from teachers, and provides on-site supervision of its counselors. Woods said the goal is "to become a part of your school culture."

Counselors make weekly phone calls to parents and quarterly home visits.

Out of one representative sample of students, approximately 66 percent were still enrolled in the program, about 25 percent had graduated, and less than 10 percent had been referred to more advanced services.

The average student graduates from the program in 1.8 years.

Family Preservation Services is currently in 204 Virginia schools and has served the Eastern Shore since 2001.

Accomack schools currently take advantage of a similar school-based, therapeutic day treatment provider, Therapeutic Interventions.

Northampton schools use Therapeutic Interventions and have also used Family Preservation Services for the last five years.

Both are licensed and accredited service providers with offices in Belle Haven.

# Fishing from the Shore

By Bill Hall



Offshore action has rebounded after the passage of last weekend's tropical system, especially with dolphin (mahi) and billfish. Tuna catches have been inconsistent though.

Inshore structure fishing has been a highlight of the early summer as gray triggerfish, sea bass, and keeper-sized flounder continue to provide steady action during periods of slow current and calm seas.

Cobia and red drum continue to hit in the lower bay, but action in the upper Chesapeake Bay has been disappointingly slow.

**Lower Shore** – Mark Snook, at Chris' Bait & Tackle, reported that cobia action remains good, with anglers finding success while bait fishing on Latimer Shoal, the Inner Middle Grounds, and on Nine Foot Shoal, while sightcasting has been steady at the Hot Dog and buoy 36A area. Croaker, mostly on the small side, have been reported out of Oyster and marker 262 in Magothy. Latimer Shoals was also producing sea mullet. Spadefishing has slowed around the bridge islands and pilings, and the recent fish that have been caught have been smaller in size.

Donnie, at Bailey's Bait & Tackle, reported that cobia action is still good "up and down" the bay. He commented that spadefish remain available at the lighthouse. Flounder action was described as slow, and bottom fishing in general also remains slow, with the exception of a few croakers being caught out of Oyster.

**Wachapreague** – Captain Lindsay Paul, of Trident Tackle, reported that several billfish were released over the weekend and that "right many" dolphin (mahi) and a few tuna have been caught. The Miss Molly released two white marlin and the Bite Me had a white marlin release. Dale Dirks released a blue marlin and boated blueline tilefish, dolphin, and tuna over the weekend. Closer to shore, flounder fishing on the wrecks had slowed due to strong currents, Anglers were having to resort to 7-ounce weights to keep the baits in the strike zone. One boat returned with only one keeper for their efforts on Sunday. Fishing was described as "bad" inside the inlet!

**Chincoteague** – Peter Vasilou, at Captain Steve's Bait & Tackle, reported that kingfish (whiting) and spot as well as "toothy" sharks were providing action in the Assateague surf. Croaker were hitting Fish Bite baits from the back bay to the inlet. Keeper-sized flounder were described as "scattered" with some landed in Chincoteague Channel, inside the canal, off the southern tip of the island and a few in Queen Sound. Offshore,

nel. Sharks were being caught near the inlet. The inshore wrecks have been producing sea bass triggerfish, and some small tautog, while the offshore wrecks held larger black sea bass. Offshore anglers were finding yellowfin tuna and mahi in the canyons.

**Upper Shore** – Captain Matt Abell, at the Sea Hawk Sports Center, reported that the offshore dolphin (mahi) action has been the highlight of the weekend. Abell said that some of his customers reported catches of as high as 35-40 mahi per boat. There was some tuna action in the Washington Canyon and north, with one boat landing five yellowfin. Choppy water conditions prevented most anglers from fishing the railcars out of Chincoteague. Abell said that cobia fishing was still good in the lower bay.

the shop saw some nice wahoo brought in. The biggest weighed 68 pounds and was caught aboard the Aquaholic with Captain Frank Borowicz and crew.

Mike, at Captain Bob's Marina, reported that fishing has been "slow and spotty" for croakers. Flounder catches were coming from Assateague Channel and inside Chincoteague Channel. The inshore wrecks have been producing flounder, black

# NORTHAMPTON DEPUTY CHOSEN AS VIRGINIA LAW ENFORCEMENT OFFICER OF THE YEAR

She's smart. She's loyal. She is dedicated to her job. She goes the "extra mile" to help fellow officers.

Besides being a single mother, Investigator Tara Leckel, 35, of Exmore, a deputy with the Northampton County Sheriff's Office, gained another status last weekend when she was named the state 2017 American Legion Law Enforcement Officer of the Year. Leckel will be competing for the national title.

All of this has left Sheriff David Doughty beaming when he talked about Leckel's success. "The big thing is she's always willing to lend a hand when it's needed."

"She has excellent critical thinking and communication skills and a strong background in working with juvenile offenders," Doughty said in an application he submitted without her knowledge to the American Legion in Cheriton in February. "Investigator Leckel has demonstrated excellent skills in interviewing, crime scene processing, evidence collection, and overall case management," he wrote.

Commonwealth's Attorney Beverly

Leatherbury said the honor is one Leckel "richly deserves. You really should do a story on this remarkable young woman," she told the Eastern Shore Post.

"I'm so impressed with Tara and the detail she applies to her cases," said Traci Johnson, clerk of the Northampton Circuit Court. "She asks the most intelligent questions, which only come to me after she has already done her research into the topic. Tara is an asset to the sheriff's department and truly raises the bar as an investigator every day and it is evident that she loves her work."

"Investigator Leckel demonstrates a high level of professionalism with both her fellow law enforcement officers and the citizens of Northampton County," said Doughty. "She sets a positive example for new employees and is always willing to go that extra mile to see that the job is done right. I have the utmost confidence that she will follow through with any task that she is asked to perform."

"Investigator Leckel has been always willing to go above and beyond her normal duties to ensure the safety of the public," the sheriff said. "She has future plans to obtain a degree in Crimi-

nal Justice and to complete the Forensic Science Academy. She is a past recipient of the Mothers Against Drunk Driving Award. Investigator Leckel has been involved in several community activities. She assists with the annual Sheriff's Office Charity Golf Tournament that benefits Hospice and The Randy Custis Memorial Fund. She also participates on our February Freeze Team to benefit Habitat for Humanity."

"I'm super grateful for my sheriff to think of me out of all his employees," Leckel said Thursday. "It feels fantastic that he recognized my work ethic. I think what moves me the most is past awards were given to one great moment, but for me it's an overall (recognition)."

"It's a good feeling when you work you case real hard and all these different things come together — the chase of it," she added.

In my younger years, I always wanted the challenge physically and mentally of a career and it was between military and law enforcement. I wanted to do something memorable. Something with me being the first woman," Leckel said. She was the first female officer to serve

with the Exmore Police Department.

Leckel has been employed full-time with the Northampton County Sheriff's Office for five years. She previously was with the Exmore Police Department for six years and was an investigator there for a year. She also is a 2001 graduate of Northampton High School. Her numerous certifications include Basic Law Enforcement in 2007, New Detective and New Criminal Investigator Training, Basic Radar/Laser Training, Laser Certification, Basic Gang Intelligence, Driving Under the Influence Detection Training, Interview and Interrogation Training, Basic Crime Scene Investigation Certification, Online Social Media Investigations Training, Crime Scene Sketching Training, General Instructor Certification, Intoxilizer Operator Certification, Firearms Instructor Certification, and Virginia Fusion Center Liaison Training.

"Investigator Leckel has excelled on many levels with the Sheriff's Office," Doughty continued. "She frequently has to prepare and deliver testimonies for court. Being assigned to the Investigative Division she is responsible for investigating ... fraud, identity theft, forgery,

embezzlement, sexual assault, rape, robbery, malicious wounding, and murder.”

Doughty said Leckel has also been the lead investigator on several high-profile cases that required extensive investigations. “She regularly assists with investigations with our neighboring law enforcement agencies and has worked hand and hand with several federal agencies. ... Leckel regularly volunteers investigative assistance to our patrol deputies while still maintaining a heavy caseload of her own. She continually brings fresh and new ideas to the attention of her supervisors and is willing to step up and take the lead. She has developed a great working relationship with our current and former commonwealth’s attorney.”

“She is probably one of the hardest workers I’ve seen in a while,” said Doughty.

Commander Bill Stramm of the Cheriton Legion said Leckel had come to the post to give a talk about Lifesaver Program and was surprised by the local post’s award that was presented to her. He then told her about the state award. “It’s quite an honor,” he said.

It has been eight years since an Eastern Shore officer received this honor. Senior Trooper Kurt Johnson was awarded after he saved a three-year-old girl. She was trapped in her family’s overturned car, which had flipped after slamming into a three-foot concrete drain pipe on Lankford Highway. Within seconds, Johnson crawled into the vehicle filled with thick smoke and yanked the girl free from under the dashboard just before flames engulfed the car.

Stramm said he will be asking the chief of the Chesapeake Bay Bridge-Tunnel Police Department to recommend an officer for the award for 2018.

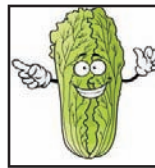

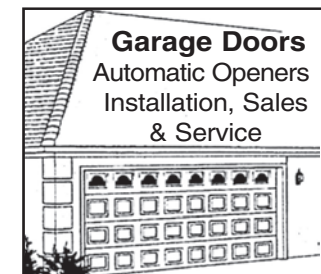

The purpose of the meeting is to conduct regular business and public hearings on the following matters:

**A. SUP 2018-05:** Addie Sue Smith has applied for a minor special use permit to construct a single wide mobile home on her lot. The property is located on Johnson Town Road near Birdsnest. **Part One, Section Three** deals with the economic plan noting current issues, considering existing industries, looks at business and workforce development, and makes recommendations.

**Part One, Section Four** looks at housing, noting assets, issues, inventory and demographics, livable communities, and organizations to help with obtaining housing, and makes recommendations.

**Part One, Section Five** covers environment, natural resources, and open spaces. It considers our assets, examines environmental issues, and suggests planning, goals, and strategies for their conservation.

**Part One, Section Six** examines community facilities and services, both public and private. It inventories these assets, looks at existing and potential issues, and gives goals and implementation strategies.

**Part One, Section Seven** deals with transportation, including assets, current issues, planning, and goals and implementation strategies to meet those goals.

**Part Two, Section One** covers the history and geography of our County.

**Part Two, Section Two** examines population and demographics of the County, trends, projections, household data, family data, and poverty data.

**Part Two, Section Three** includes economic data about

the workforce, jobs, types of employers, major industries, economic development, and taxes and revenues.

**Part Two, Section Four** is the housing analysis section. It looks at housing inventory, its distribution, rentals, building permits issued, housing conditions, affordable housing, and influences on future trends.

**Part Two, Section Five** includes environmental data on topics including climate, topography, soils, Carolina bays, forest land, ecological communities, water resources, and our shoreline, wetlands, and barrier islands.

**Part Two, Section Six** contains data about our community facilities and services, including art and culture resources, churches, communication systems, utilities, water and wastewater facilities, solid waste management, emergency services and law enforcement, government services, libraries, parks and recreation, and schools and education.

TABLED ZTA 2018-05:** The Northampton County Board of Supervisors propose to add a new use “short term rental”, with minimum standards and a definition to the Northampton County Zoning Ordinance dated 04/12/2016: §154.2.003 Definitions and accompanying use charts. With this ZTA, the Board also proposes 2 options for the allowance of short term rental units. Option #1 would allow short term rentals throughout the County by-right with certain minimal performance standards. Option #2 would permit them to be allowed by-right in certain areas, allowed with a Minor Special Use Permit in some other areas, and not allowed at all in the rest, (similarly to the B&B use). Also a part of the ZTA is eliminating the use and definition of “tourist cottages” and “flexible term rental units”. A new section, numbered 154.2.120 “**SHORT TERM RENTAL**” with minimum standards is proposed to be added.

The Board of Supervisors shall also conduct public hearings on above items A, B, D, and E on Tuesday, August 14, 2018, at 7:00 p.m., in the Board Chambers. ## Contact DEQ About Poultry Water Permits

Dear Editor:

I recently saw a very small ad in the classified section of the Eastern Shore Post. It was from the Department of Environmental Quality, asking for public comment on consent order actions taken to remedy a very serious error having been committed in allowing 58 industrial poultry operations to continue pumping massive amounts of our public groundwater before legally required monitoring or metering has taken place.

If I, as a citizen, did not have my proper well permit in place, I wouldn’t be able to live in my house.

## Post Office Mail

It is not proper or wise for the county or state governments to allow these industrial poultry factories to continue to use public groundwater supply before each location submits the necessary modeling and monitoring documents. Indeed, the poultry houses have been found in violation of Va. Codes 62.1-158 and 25 610-40A.

The Eastern Shore is a Groundwater Management Area, because the fresh water is obtained from a sole source, confined aquifer. Virginia Code prohibits the withdrawal of 300,000 gallons of groundwater or more monthly without a permit. The collective groundwater withdrawals from the 58 operating poultry facilities (actually a total of 85 in process), will exceed re-charge of the aquifer. It is not likely that the state will shut down operation of newly built facilities. However, since they are collectively exceeding recharge amounts (based on average industry numbers), then how can the public have assurance that DEQ is doing their part to protect the public good? The outside-the-box, rubber stamp permitting process helps big poultry profits, but does nothing to protect the public right to fresh, potable water.

The DEQ website lists the 58 facilities by name, but does not give 911 addresses or tax parcel numbers. Residents nearby have no way of knowing what may be happening to the long-term availability of their home or commercial water supply, or why they may experience saltwater intrusion in the near future. We cannot rely on our county government to rein in this problem. So far, I am not aware that any

Accomack County official has spoken directly about this consent order in public venue. Our Eastern Shore Groundwater Committee is not in session for another month to answer questions.

This is a complex problem where regional agencies, as well as state and federal agencies share oversight of industrial poultry facilities. Then there are also the large corporations profiting from the poultry, who place much liability on growers, yet dictate the use of unsustainable water use practices. It is hard for local residents to know the impacts of the new facilities, which have sprung up all over Accomack County, until the well literally runs dry or turns salty.
