GOVERNOR NORTHAM ADDRESSES CHAMBER OF COMMERCE AT ANNUAL MEETING

Gov. Ralph Northam spoke Monday night of a company that wants to erect wind turbines at Cape Charles and a school that would employ 150 instructors to train 500 pilots that is interested in setting up shop near NASA Wallops Flight Facility's expansive runway.

The Onancock area native wanted his fellow Eastern Shore friends to open their minds to the possibilities.

"I'm proud to be from the Eastern Shore," he said, adding he boasts that fact across the state whenever he can and knows there are a few more state maps that need the addition of Accomack and Northampton counties.

Nancy Stern, chief executive officer of Eastern Shore Rural Health, introduced the governor but not before singing his praises and offering him a contract as a pediatric neurologist in the local health

system when his stint as governor is over in a few years.

Northam had already announced he and his wife would be moving back to the Shore after his four-year term is over.

Holding up a large manila envelope with the details of her offer, Northam told Stern he would probably be knocking on her door in the future. He thanked her for her compliments.

Northam was addressing Eastern Shore Chamber of Commerce members and local dignitaries Monday at the \$45 a plate event that fit snugly into the banquet room at the Eastern Shore Community College. He also presented the group's awards to highly motivated business owners at the annual session. Northam appeared to enjoy himself as he laughed, talked, and hugged many of those in attendance. Retired Navy Dentist's School Program Brings Smiles All Around

Dr. Peter Schlepsky, who heads the Northampton schools dental program, is retired from a 20-year career as a Navy dentist but says his current job helping kids is the most rewarding thing he's ever done.

Simply known as Dr. Pete by his youngest patients, he operates three dental clinics, one at each of three Northampton schools – Occohannock Elementary, Kiptopeke Elementary, and Northampton Middle.

Schlepsky has headed the school dental program on a contractual basis since 2005 and is looking forward to his 14th year providing dental health services to Northampton students.

These services cost nothing to Northampton schools except for the provision of utilities such as water and electricity to the clinics.

Last year, there were 1,000 Northampton students enrolled in the dental program. The clinic was open five days a week and received 3,000 visits, 2,000 for cleanings and 1,000 for fillings. At an average of three fillings per visit, that's about 3,000 fillings Northampton kids got through Schlepsky's services last year. The clinic also addressed an average of 10 dental emergencies per week, or about 400 for the year.

About 90 percent of the patients Schlepsky sees are on Medicaid, but the clinic also accepts private insurance. He said last year the clinics performed around \$500,000 worth of dental work and collected about \$240,000 in payments, enough to pay staff salaries, but not much for himself.

He said "it's OK" if he doesn't profit from the clinics, because he has a military retirement to fall back on. Though the clinics operate at a modest loss or break even, Schlepsky is happy to be able to keep his staff employed and provide dental health services for 1,000 Northampton children.

He had two minor concerns about the dental clinic program. He would like his contract with the school division to last more than a year at a time to give his employees more confidence in their job stability. He would also like

to see more cooperation from teachers to allow students to leave class for appointments at the clinic.

Having a dental clinic on school grounds results in less lost instructional time for students. One dental visit results in about one lost hour of instruction for the student; when students visit a dentist off campus, their parents are likely to take them out of school for the entire day, Schlepsky said.

Schlepsky is proud of his staff and their ability to develop relationships with students who may start the school year afraid to see the dentist but finish it excited for their next visit. He credits his staff with the dental program's success.

In a climate of rising health care costs, Superintendent Eddie Lawrence reported health insurance costs for Northampton school division rose only 1.5 percent this year, "partly because of the way we use it," he said.

Only eight emergency room visits by Northampton school employees were deemed unnecessary by the health insurance company last year, Lawrence said.

Northampton school employees fared better than Northampton County employees, whose health insurance costs increased 24 percent, causing a major headache for supervisors when they balanced the budget for the new fiscal year that began July 1.

Northampton schools want to start an employee wellness program with Anthem insurance company to further control costs. Two options under consideration are called Get Strong and Get Control, focusing on maintaining healthy habits and managing chronic conditions, respectively.

A full-time school nurse supervisor will be needed to develop and coordinate the wellness program, among other duties such as overseeing school clinics, evaluating nurses, maintaining student health records, coordinating school services for homebound students, and acting as a substitute nurse. One regular, full-time school nurse position will be eliminated to help cover the cost of the supervisor position.

Public Has Lots to Say About Improvements to Intersection at Cape Charles Food Lion

Concerned Northampton citizens bombarded the Virginia Department of Transportation with comments on its proposed road improvement plan for the intersection at the Food Lion shopping center in Cape Charles during a July 24 public hearing.

Various comments on the dangerous crossing included, "It scares the stuffing out of me," "My car was totaled there," "You've got to spend money to save lives," and "How many people have to die?" for VDOT to improve road safety at the location.

The location in question is the intersection of Route 13 and Country Place, aka Country Plaza, which crosses the highway from Union Bank & Trust on the west side to the Food Lion shopping center on the east side.

Many locals describe frequently encountering heavy traffic in both the northbound and southbound lanes and low visibility, combining to create difficulty crossing the highway safely. Several drivers reported they had either been in an accident or experienced close calls at

the intersection.

Locals offered what they termed a "simple" solution: installing a traffic light at the intersection. But VDOT representatives insisted a traffic light would not solve the problem and could even make it worse.

Cost is also a factor. Transportation engineer Ryan McCreedy, contracting with VDOT as a design consultant for the Food Lion project, said a traffic light would cost about \$250,000. That would drive up costs prohibitively high for the VDOT Smart Scale project that is currently budgeted at about \$1.4 million for construction.

When costs of engineering, right-of-way acquisition, and utility relocation are factored in, the total project cost is \$1.7 million.

The project as originally proposed by VDOT includes safety measures such as widening and lengthening eight turn

lanes, tapering roadway edges, installing lighting and road signs, but no modifications to the Route 13 and Country Place intersection.

Locals also suggested closing the intersection altogether, restricting access to businesses on either side of the highway to "right in, right out."

That means northbound drivers traveling to Union Bank & Trust or southbound drivers traveling to Food Lion, both of which would appear on drivers' left, would have to continue several hundred feet and make U-turns to reach their respective destinations. Likewise, northbound drivers exiting Union Bank & Trust and southbound drivers exiting Food Li-

on would need to make U-turns.

A third option that could serve as a compromise between closing the intersection and installing a

traffic light is converting the crossing into a J-turn intersection. A barrier in the middle of the intersection would prevent vehicles from crossing the highway but would permit vehicles to turn either right or left off the highway. Only northbound drivers exiting Union Bank & Trust and southbound drivers exiting Food Lion would be required to make U-turns.

Scientifically speaking, proceeding farther along the road and making a U-turn is safer than driving straight across the highway, even with a traffic light, McCreedy said. The road design could be modified to allow tractor-trailers making deliveries to safely execute the U-turn, he added. Furthermore, constructing a J-turn intersection would not significantly increase total project costs, McCreedy said.

Citizens also want to improve safety along the .44-mile stretch of road by reducing the speed limit to 45 mph. Anecdotal evidence states motorists frequently travel 65 mph to 70 mph or more through the area, though past VDOT speed studies did not qualify it for a speed reduction.

Supervisor John Coker was present

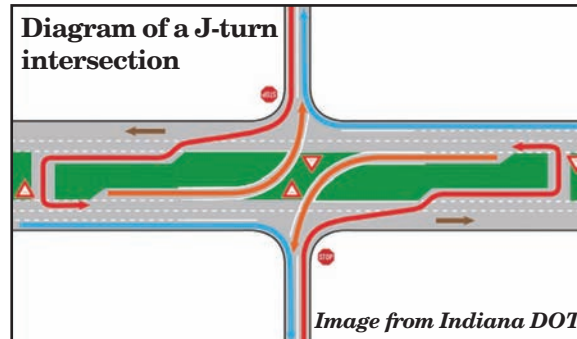

Northampton Examines Debt Scenarios for High School Building or Repair Project

Northampton Board of Supervisors Chairman Spencer Murray recommended three supervisors Monday night for the joint committee with Northampton school representatives that will plan the financing and renovation or reconstruction of Northampton High School, addressing its ongoing structural issues.

Supervisor John Coker, a retired banking executive, will provide financial expertise, Supervisor Oliver Bennett, a Northampton teacher, will offer an educational perspective, and Supervisor David Fauber, Cape Charles Director of Public Works and Utilities, will contribute architectural knowledge.

and asked if anyone in the room believed the speed limit should remain at 55 mph. No one spoke or raised a hand.

Public comments on the proposed road safety improvement project may be submitted online to VDOT Project Manager John Harman at JohnG.Harman@VDOT.Virginia.gov until Aug. 3, 2018.

Northampton County Administrator Charlie Kolakowski and Finance Director John Chandler will also participate in the joint committee.

Chandler conducted a review of the scenarios prepared by financial consulting firm Davenport & Company in which the county may be able to borrow \$40.5 million to build a new school.

He used an analogy to explain the review of the financing options. "We basically are going to the bank and saying, 'We want to buy a house, how much house can we afford?' versus going and looking for houses ... and then going to the bank ... for a loan ... after you decided what your dream home is going to be, and then the bank turns around and says, 'You're not approved.'"

Supervisors found the first three financing options too expensive. Northampton is currently paying \$3.1 million annually on its debts. The first three scenarios would increase annual debt payments up to \$5.6 million, \$4.3 million, or \$3.9 million, respectively.

Chairman Spencer Murray said, "We'd better find some gold mines somewhere." Supervisors worried that any of those

three financing options had the potential to bankrupt the county.

The fourth and final scenario Davenport & Company generated would keep the county's annual debt payment at \$3.1 million. The problem with that scenario is the \$40.5 million would not be issued all at once. New debt would be issued only as old debt is paid off.

About \$1.6 million could be available as early as 2020. The largest amount of funds, about \$24.5 million, wouldn't become available until 2026. In 2030, another \$10 million in debt could be issued, with the final amount of about \$6 million available in 2034.

That's where a tax rate increase would come into play. A modest increase to real estate taxes would give Northampton the spending power to get the bulk of the money needed to fix or rebuild the high school sooner.

Supervisors are proposing a real estate tax rate increase of 2 cents or possibly 4 cents per \$100. A Northampton citizen who owns property valued at \$100,000 currently pays real estate taxes of 83 cents per \$100, or \$830 annually. A

2-cent or 4-cent real estate tax increase would raise that annual tax payment to \$850 or \$870, respectively.

The next step for supervisors is to ask Davenport to redo the fourth scenario – the one that would allow the county to borrow money for a new school without raising its annual debt payment above \$3.1 million – and account for the additional funds that would be available with a 2-cent tax increase.

Murray took the opportunity to clear up a misconception about the state of Northampton's finances. He said a report that "we maxed out our credit card by building the jail ... couldn't have been more inaccurate."

Doug Gebhardt, vice president of Davenport & Company, said on June 25 that if Northampton had a credit rating, it would be rated A or AA on a scale where AAA is the highest and D is the lowest.

"It's not a question of whether you can borrow, it's a question of, 'Can you pay it back?'" Murray said.

"We're going to borrow something. We're going to do it," he affirmed. "But it has to be within boundaries that we can live with."

Hickman Sentenced for 2013 Murder

Nearly five years after he killed a man at a party in Tasley, Jamar Edjuan Hickman was sentenced last Friday in Accomack Circuit Court to 25 years in prison for first-degree murder in the shooting death of 32-year-old James Marke' Wyatt. The term was made in accordance with a jury recommendation.

Judge W. Revell Lewis III also sentenced Hickman, 27, formerly of Giddens Lane in Tasley, to three years for using a firearm in the murder, which was also the time suggested by the panel. Lewis set the terms to run consecutively for a total of 28 years.

The maximum term was life in prison and a fine of \$100,000. Initially, Commonwealth's Attorney Spencer Morgan also asked for reimbursement of more than \$5,000 for the victim's compensation fund, which paid for Wyatt's funeral. But that requirement was withdrawn after Hickman's lawyer, Michael Fasanaro Jr., of Norfolk, said he would file an appeal and Morgan didn't want anything to cause the conviction to be overturned.

Fasanaro asked for Lewis to dismiss the verdicts. He also complained about the "extremely excessive" length of time it took for Hickman to get sentenced. "It leaves the defendant in nowhere land," he said.

Morgan argued there was no mention of that until May of 2018. "He requested a long-form presentence report," he added.

With no previous public statements and nearly three years of waiting in the Accomack Jail to be sentenced following the jury's verdict, Hickman took the witness stand to apologize to his family and the victim's mother last week.

None of Wyatt's family attended the sentencing. Hickman's family gathered to ask for leniency.

"I'm not the monster they're painting me to be," Hickman testified. "Either way, I'm sorry for wasting everyone's time and I ask for the court's mercy."

It was the second time Wyatt's mother, Annie Mears, lost a son in a shooting. "I have to see two headstones," she wrote in a victim impact letter to the court. "As for his (Wyatt's) four children, his youngest wants to know where is his daddy," Mears wrote. The others, she said, are

also having difficulties handling the loss. The mother also sent a message to Hickman. "I want you to remember, you will still have a life after this is over ... Every day I do okay until I come home and then I just cry because I miss them so much."

"When my daughter told me we had to go to the hospital because he got shot, it was a nightmare all over again," she said. "To wait for that one doctor to tell you he is gone is unbearable."

Tamara Miller, a drug addiction counselor and Hickman's mother, asked Lewis to consider Hickman's mental health issues and that he had been drinking when the shooting occurred to compensate for his illnesses. "When you're not right up here," she said pointing to her head, "it makes you try to fix things."

His mental evaluation stated he has schizophrenia. He was found competent to stand trial. His mother mentioned he also has bipolar disorder. "I'm asking for your leniency," Miller said. Incarceration won't help him, his mother added. "Being in prison, lifting weights to get big, you don't learn anything about your mental health," she concluded.

Hickman's brother, Steven Johnson, cried on the witness stand. He told the story of finding the right path. "I went to prison for nine years. Been out for eight years, married for six. I have my own home, two cars and own a business. I know it doesn't take 20 to 30 years for someone to rehabilitate. Don't need a lifetime to change," he said. "I'm an example of second chances or even third chances."

Tamara Johnson, the defendant's sister, described Hickman as a giving and loving person. "This has been bothering me because I have evidence that proves that he may not have done this. Jamar always put his best foot forward. He is very, very smart. It's just that I see him as helping someone before he would hurt them. He's kind to people. He's kind to animals. I would ask that you just have mercy on him. The things I want to say, I can't say. I really believe that God's got him."

Witnesses told the jurors they saw Hickman shoot Wyatt outside a Daugherty Road home in 2013. Wyatt died a short time later from a gunshot wound to the torso, according to the medical examiner's report. He was hit by at least two bullets. One was found in a lung.

Dozens of photos of the victim and evidence found in the yard where the shooting occurred were shown to the jury, and several police officers told about the bul-

lets and metal fragments found at the crime scene.

Leeshawn Davis, who lived at the mobile home where an argument got started, heard Hickman say he "was going to get his gun. ... He came back to my house (by car); he had a gun" and shot Wyatt.

Another witness, Larry Strand, said he saw Hickman go to the back of a car. "That's when he started shooting. The gun was big enough that he had to lean it over the back of the trunk." Strand said he heard four shots. "I ducked down and ran towards the back of the house. I saw Wyatt clutching the side of his neck."

Reputed Gang Member Sentenced

A reputed Bloods gang member, who grabbed an Accomack deputy by the front of his shirt and then threatened to come back and kill him, was sentenced to five years in prison last Thursday in Accomack Circuit Court for felony assault and battery.

Jaquan Cortez "Buck" Portier, 27, formerly of Dennis Drive in Parksley, was being detained in a holding cell in Accomack Jail for a probation violation while awaiting transfer to Chesterfield, Va., when the incident occurred Dec. 15, 2016. He pleaded not guilty to the assault and battery of Sgt. D.M. Williams of the Accomack County Sheriff's Office in July 2017.

Portier was brought from the Eastern Shore Regional Jail last week for sentencing. He was returned there and will continue to be held at the Eastville facility until he is assigned to the state system.

"He was uncooperative and belligerent," to the local officer, according to court records. Portier was "banging on the bed and throwing the phone." He "kept screaming, 'Get me the f... out of here!' After that, restraints were utilized to try and stop his behavior. The officers exited the cell and I was last to exit," Williams said. "Portier made it to his feet and charged at me trying to grab me. We struggled for a few minutes in the corner. He then reached up to my chest and grabbed my shirt and ripped my tie off" and stated, "I'm going to murder your ass."

Testimony at previous hearings showed Portier was associated with gang leader Tyvon "Teddy" Smith, who is serving 30 years in prison for directing other gang members to set fire to a house in 2013. The arson was an effort to keep witnesses from testifying against him. Smith is being held in Buckingham Correctional Center near Dillwyn.

At one point, Smith and Portier were accused of shooting at a house in Rolling Acres causing the inhabitants to duck for cover. A witness said she was riding in the car with Smith and Portier and testified against them at a preliminary hearing. But she could not be found when Smith went to trial. Two other witnesses got "amnesia" and couldn't recall what happened. Those charges were dropped against both men.

In 2016, Portier was shot seven times and survived. Another man admitted to being the shooter but at a preliminary hearing, Portier said he didn't know who shot him but it was not the suspect, who then went free.

In July 2015, 10 charges were made against Portier, including the shooting of four victims, one a teenager who was paralyzed. Those charges were dismissed when a witness didn't show up and said he was moving to another state and others said they could not identify the shooter. Portier contended, through his lawyer, he had been at the party but was long gone before the shooting occurred.

"I just want to apologize for my actions," said Portier. "I feel like it was a misunderstanding," he said of the incident with the deputy. "I did not think before I acted," Portier said. He took a class while in jail for that reason. "I learned a better way of thinking, to think before I act ... Today, I just ask that you not judge me for my past. I've made bad decisions. Judge me on my present."

"That day he became aggressive ... was disrespectful to the officer," said Commonwealth's Attorney Spencer Morgan. "There were a number of other deputies present who stopped him from further action" against Williams.

Maiming Charge Placed

An unemployed Pennsylvania man was charged with malicious maiming, according to records filed in Accomack General District Court.

Allen Altemose, 39, of Donato Drive in Ashley, was accused of the July 21 crime on Chincoteague. He was arrested the same day and is being held in Accomack Jail without bond. The victim was Jimmy Lee Ramsey. Officer A.G. Miller of Chincoteague Police Department investigated.

Norman Hugh Thomas, 50, of Seaside Lane in Painter, was charged with stealing property valued at \$500 or more from Royal Farms on July 18.

It was unclear from the court records

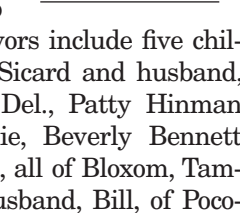
David Raymond Chew Sr.

Philip Walter May

Mr. Philip Walter May, 79, died peacefully on July 22, 2018, after a lengthy battle with cancer. Mr. May was born on Oct. 1, 1938, in Hackensack, N.J., but spent his formative years in Park Ridge, N.J. He graduated from San Jose State with a degree in advertising and began his career as a junior copywriter at J. Walter Thompson in Los Angeles. During this time, Mr. May reveled in the music of California's 1960s folk revival and carried a passion for that music all his life.

After marrying in 1962 and starting a family, he and his late wife, Betsy Paterson May, moved back east when Mr. May transferred to J. Walter Thompson in New York.

They ultimately settled in Pearl River, N.Y.

Mr. May worked for several of the top advertising agencies in New York, including J. Walter Thompson and Dancer Fitzgerald Sample.

A gifted wordsmith and storyteller, Mr. May quickly ascended the ranks of the agency world. It is believed that he was the youngest person ever made a vice president at JWT at the time. When he retired, after more than 20 years in the business, he was a senior vice president and creative director at DFS with a commanding view from his office in the Chrysler Building. Mr. May won numerous advertising awards, including a Bronze Lion at the Venice Film Festival for a Kodak commercial that first aired during the Academy Awards.

After retiring in 1986 to pursue his dream of becoming a fiction writer, Mr. May moved to the Eastern Shore of Virginia, where he completed several novels. Among his published works are "Twenty Silver Ghosts," an exquisitely illustrated volume that chronicles the history of Rolls Royce cars, and "The Rifle Musket," a young adult fiction book set in the Civil War era.

Mr. May owned or restored 68 cars and three motorcycles. He had a passion for British sports cars, particularly the MG TC, of which he owned five. Other favorites included five wooden station wagons, seven Model A Fords, a 1913 Model T Ford, two Morgans, an AC Ace, and an Austin Healey 100-4.

He was a history buff and collector. At age 10, he began collecting Civil War weapons. A 1964 issue of Gun Report featured his cover story about the weapons and diary accounts of his great-grandfather, a Union Army cavalry officer during the Civil War.

Following the untimely death of his wife, Betsy, in 1990, Mr. May was blessed to earn the love of Lucinda "Cindy" Wharton Kellam, and they married in 1996. With each passing year the couple's blended family of seven children grew, ultimately producing 16 grandchildren. To Mr. May's three daughters, Cindy seemed an absolute miracle — restoring joy to his life and becoming a much-needed and adored grandmother to their six kids, Betsy and Virginia Edinger, Stuart, Josie and Garnett Martin, and Eliza Moore.

Mr. and Mrs. May spent many years on the Eastern Shore of Virginia, where they took pleasure in the company of good friends, including their book club. Together they enjoyed international travel as well as regular trips to family and friends.

In 2001, they moved to Williamsburg, Va. They found meaningful volunteer work, and Mr. May served as a tour guide

at Endview Plantation. The couple also joined the Williamsburg MG Club and had great fun on group tours of Virginia's scenic byways in their MG TC, the wind blowing through their white locks.

Mr. May is survived by his loving and devoted wife of 22 years, Cindy May; brother, John Timothy "Tim" May (Deborah May-Buffum), of Petaluma, Calif.; three daughters, Darcy Paterson May (Greg Edinger), of Greenwich, N.Y., Jamie Eliza May (Will Moore), of Williamsburg, Va., and Wendy Westerfield Martin (Todd), of Richmond, Va.; four much-loved stepchildren, Lucinda Kellam Jones (Chris), of Winston-Salem, N.C., Luke Kellam (Patty), of Franktown, Va., Whit Kellam (Susu), of Baton Rouge, La., and Anna Kellam Murray (Mike), of White Bear Lake, Minn.; and 16 adored grandchildren, who reveled in love and holidays at his home. 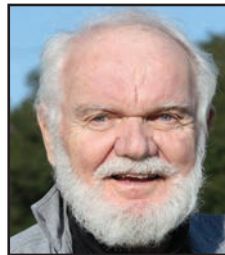

The beach walk on Assateague takes place every year when the Saltwater Cowboys (members of the Chincoteague Volunteer Fire Company) walk the wild ponies from the southern corral to the northern corral, where they wait for the Pony Swim and the Pony Penning auctions.

An estimated 3,000 people attended the event. The ponies and Saltwater Cowboys came into view just after 7 a.m., but a large crowd had gath-

ered by 6 a.m. Fortunately, the rain held off for the event and just before the ponies came into view, a rainbow appeared.

Many folks saw a foal riding in the back of a small utility vehicle behind the herd and many people were worried that the foal was injured. As it turns out, the foal decided to run away from its mother just before the beach walk began. The cowboys decided to give the foal a lift and let it reunite with its mother in the corrals.

Actor Martin Clunes, who portrays Dr. Martin Ellingham on the British series, “Doc Martin,” was spotted in the crowd of onlookers. “He was there for work making a series called ‘The Islands of America,’” according to his agent Samira Davies.

After a short rest, the ponies were paraded through town to the carnival grounds.

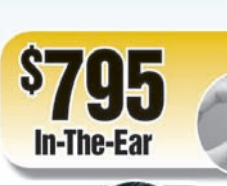

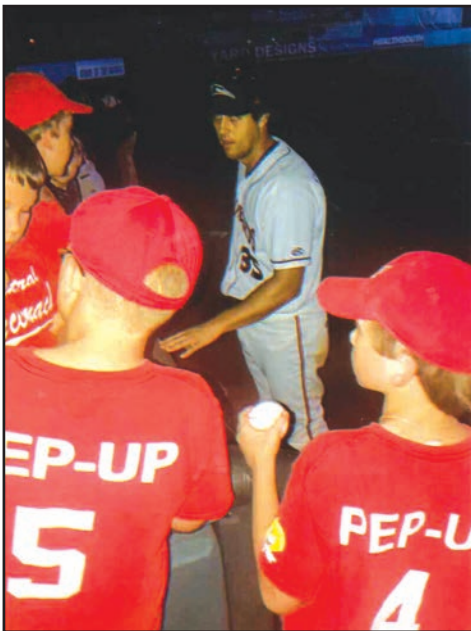

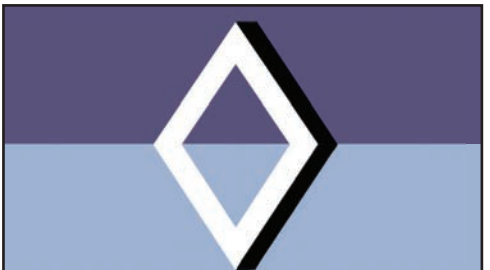

Fishing from the Shore

Unstable weather moved in over the weekend bringing winds, intermittent rain, and limiting the fishing opportunities for most anglers. Let's hope the weather conditions improve for this weekend's Eastern Shore Marlin Club Annual Billfish Release Tournament out of Wachapreague.

This week is also Pony Penning week on Chincoteague, so most of the charter vessels have been booked for the pony swim. This coupled with the closing of the boat ramp on Queen Sound and the nearly impossible task of trying to tow a boat through the throng of tourist vehicles that have descended on the island has severely limited angling pressure in nearby waters.

Chincoteague – Jimmy Vasilou, at Captain Steve's Bait & Tackle, reports

that the surf of Assateague is still producing catches of spot and kingfish/whiting on bloodworm and Fish Bites baits. There have also been plenty of sharks in the suds as well as in the back bay. One angler, fishing from a kayak, "boated" a five-footer long enough to have a picture snapped by a fellow kayaker. Hunter Durham boated a 10-pound, 12-ounce citation sheepshead off the pier at the Robert Reed Town Park. A limit of flounder was made off Inlet View by an angler fishing along the rocks. The inshore wrecks have been productive when the weather has been cooperative, according to Vasilou. The shop is planning a youth croaker tournament at the beginning of August.

Donna Rae, at Captain Bob's Marina, reported that the flounder bite improved with the appearance of clear water before the recent spell of nasty weather. Popular flatfish locations were in the Chincoteague Channel in front of Beebe Road north to Daisey's Dockside and Waterside Inn and along the causeway near the Marsh Island exit in the old Black Narrows. Action inside Queen Sound was described as slow. Kingfish/whiting and a "scattering" of croaker were coming from the canal out toward the mouth of the inlet. Assateague Channel has produced "mostly crabs" over the last week. The structures off Blackfish Banks have been inconsistent on the few days that boats could fish them.

Upper Shore — Captain Matt Abell, of Sea Hawk Sports Center, reports that the rail cars have been "hit or miss" with anglers limiting out one day on flounder and almost getting skunked the next. One customer limited out on flounder on a recent trip to Quinby In-

let, while another customer boated three cobia off Cape Charles. Offshore runs, when conditions allow, have produced nice catches of black sea bass. Yellowfin tuna have been available to the north for anglers chunking at the Hot Dog. Spot have moved into the waters off Crisfield and are being targeted hard by both recreational and commercial fishermen.

Wachapreague — Captain Lindsay Paul, at Trident Tackle, reported that a few dolphin (mahi) have been caught along the 20-fathom line and a "handful" have been caught in the canyon. Paul reported the presence of "lots of pretty" water, just not much life, and he is hoping things improve for this weekend's billfish release tournament. There was one marlin release that he had heard of on Friday. Wreck fishing on the Monroe has produced catches of triggerfish, sea bass, and flounder. One angler found a nice school of triggerfish around a large piece of floatsam. The inshore wrecks have been productive when anglers could get out to them. Most recent offshore trips have been cancelled due to the weather. Inside the inlet, flounder fishing was described as "way off" from what it should be.

Lower Shore — Chis Snook, of Chris' Bait & Tackle, reported, despite the weather, the cobia bite is still "good." Spadefish have still been available at the fourth island of the bridge-tunnel. Larger croakers, in the 12- to 14-inch range, have appeared outside of the concrete ships. Red drum have been hitting in the evenings off buoys 16 and 13. Flounder fishing has improved for anglers jigging along the pilings of the Chesapeake Bay Bridge-Tunnel and around the span's fourth island. There have been catches of spot

BEEHIVE DISTRIBUTION PROGRAM

Virginia's recently established Beehive Distribution Program provides beehives to both new and established beekeepers in an effort to increase the number of actively managed bee colonies across the Commonwealth. The program is administered by the Virginia Department of Agriculture and Consumer Services (VDACS).

The Beehive Distribution Program provides beehive equipment directly to eligible beekeepers. Residents of Virginia who are 18 or older are eligible to receive up to three beehive units per year. Individuals who receive a beehive unit will be registered as beekeepers with VDACS, allowing for periodic inspection of beehives by the agency.

Staff will review applications for the Beehive Distribution Program in the order in which they are received. If all available beehive units are distributed before the fiscal year ends on June 30, 2019, VDACS will stop accepting applications and notify applicants that the program has ceased processing applications for the fiscal year. Applications will not carry forward to the next fiscal year.

"Last winter Virginia lost 59.5 percent of its hives," said Keith Tignor, State Apiarist. "The Beehive Distribution Program will help counteract those dramatic losses by assisting beekeepers in establishing new hives."

Family Matters in Finances

In a departure from my earlier writings, this column will not directly deal with fraud but rather with avoidable situations that can otherwise cause intrafamily pain and stress at a time of already existing pain and stress.

The typical "business model" for older couples still often remains one where the male half is in charge of the family finances and the female half has no idea where accounts are located, how much they contain, and how to access them. Then, when the male dies or becomes seriously incapacitated, the woman, at a time of grief and stress, is left with the task of finding out what her situation actually is so that her life can continue with no added unnecessary stress. This can be avoided.

Tutor your spouse (or significant

other) so that the mundane but necessary financial aspects of life can continue. Be wary of outsiders who might want to help "clear up the confusion" or come to the aid of a vulnerable surviving spouse. In my personal life there exists a simple spreadsheet showing all necessary data including passwords, websites, and phone numbers so that the financial ship of state can keep moving forward.

This tutoring might also include the nature of the funeral itself. Decide in advance what is wanted and stick to it.

Co-signing of financial documents can be another intrafamily stress point. Know that if you co-sign a financial obligation (such as a car loan) for your adult child

and the child fails to keep up the payments, the creditor can come after you for the money and your credit profile can be damaged. The decision to co-sign a document is obviously a personal one that varies with the particular circumstances, but know the risks when you consider your decision.

We live in a mobile and changeable society. As a result, situations can occur with regard to life insurance, bank accounts, etc., where the person once listed at the outset as the beneficiary may not be the one you want now to be a beneficiary. Review your documents and make sure your beneficiaries reflect your current status and wishes.

A story out of New York some years ago graphically illustrates what can

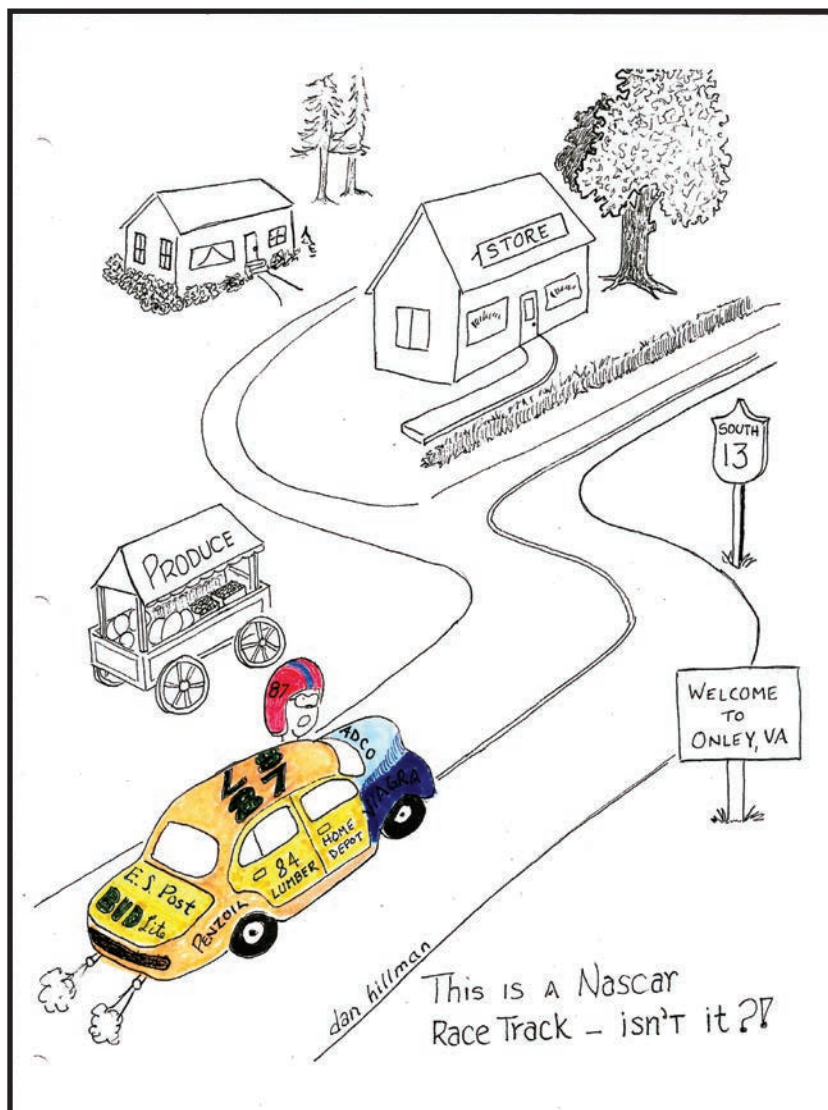
go wrong. Man marries a teacher. It is his first

marriage, her second marriage. Her first marriage ended in divorce. Woman has sizable savings in a TIAA account (the equivalent of a 401K for teachers). Woman dies, bereft widower is somewhat comforted by belief he will have this comfortable inheritance. Lo and behold, the teacher had never updated the beneficiary designation on her TIAA account. The designation was still her long-divorced first husband. The second husband, now a widower, got nothing and when he tried to discuss it with the first husband, it went nowhere.

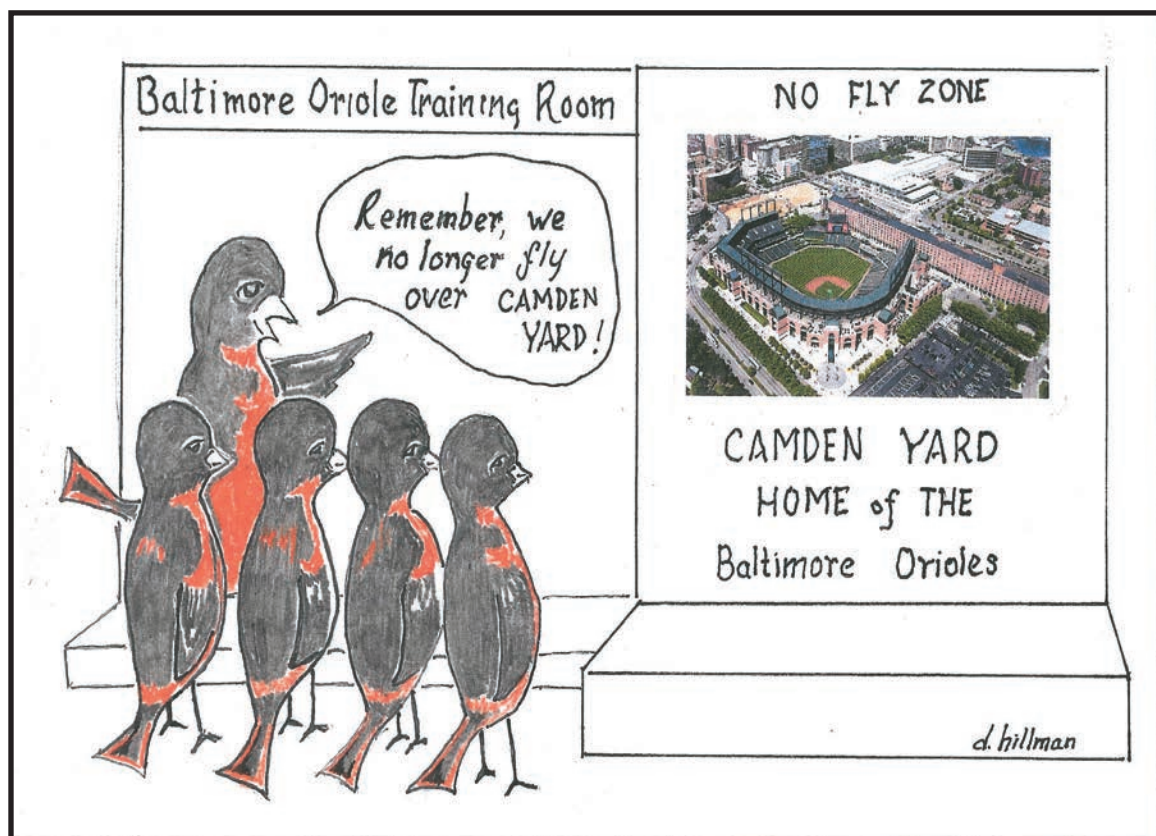
Even in familial matters, finances need to be especially defended because after today's trauma, life continues tomorrow.

Attention: Now Hear – No, Listen – to This!

Hearing and listening may seem to relate to the same activity but hearing is a passive occurrence that requires no effort. Listening, however, is a voluntary act used to make sense out of the noise we hear. It demands concentration and effort. The difference between the sense of hearing and the skill of listening is attention.

The communicative arts of speaking, writing, reading and, Why, Yes! listening, are all connected. We acknowledge the inner voice we hear when reading silently. Our writing often “reads” similarly to the way we speak. We learn to talk as children based upon the word choice, volume, rhythm, and tone of the voices we hear around us. We cannot improve our physical capability to per-

ceive sound, but we can learn to be attentive and active listeners.

From birth, we are constantly exposed to a world of sounds. To paraphrase neuroscientist and New York Times contributor Seth S. Horowitz, a sudden, loud noise that makes an infant jump is the first and most obvious evidence of the child’s ability to hear. Neurons from the ears to the spine convert that sudden, loud noise directly into a defensive response that elevates the heart rate, hunches the shoulders and compels us to check to see if whatever we heard is hazardous to our health. This simplest form of attention — the startle — requires almost no brains at all and has been observed in every studied vertebrate.

Unlike with adults, nearly all sounds are new to infants and toddlers. The noises that surround us constantly, car-

ry information about the world. A higher form of attention is in use when we listen in an effort to make sense of or understand our surroundings. Imagine a child’s first time hearing thunder, a siren, a violin, a bell, or the buzz of a nearby bumblebee. Toddlers rely on the comfort of their caregivers and the explanations and answers to thousands of questions to help them make sense of a world full of sounds.

Sadly, most of us don’t listen with the intent to understand. We are easily distracted after a sentence or two by our surroundings, our electronics, or even the looks of the speaker. It’s happened to all of us. “You never listen!” is not just a complaint of a problematic relationship. Our society seems to listen with the intent to reply, rather than to understand.

Let’s work to become civil, empath-

ic and “active listeners.” In addition to listening to spoken words,

1. Observe the speaker’s nonverbal messages like tone of voice, nervousness or eye contact.
2. Give full attention to the speaker; don’t do anything else while listening.
3. Respect the speaker by allowing him or her to finish.
4. Acknowledge and confirm the message, even if you don’t agree.

In other words, pay attention. I like the anonymous quote that says, “Speak in such a way that others love to listen to you. Listen in such a way that others want to speak to you.”
