NORTHAMPTON STUDENT CHARGED WITH RAPE, ABDUCTION OF ANOTHER STUDENT

The news of the rape and abduction of a Northampton High School girl on Valentine's Day circulated across Facebook Tuesday night bringing comments of compassion, denial, contempt, and shock.

A male Northampton High School student, who is underage and therefore was not identified by police, was charged with the crimes earlier in the day. A message to parents was also sent home with students on Tuesday regarding the incident.

Sheriff David Doughty reported the crimes in a prepared announcement. He said the incident occurred at the school and that the suspect is being held at the Norfolk Detention Center.

There was no word on the condition of the girl. She was not identified either. The Eastern Shore Post does not disclose the names of victims of sexual assault without their permission. The paper also does not disclose the names of juveniles unless they are considered adults by the court.

Doughty's office is handling the investigation and the county school administration is assisting in the probe. He urged anyone with information about the crimes to contact the sheriff's office at 678-0458 or use Tip411 by texting 847-411 and begin the tip message with NHCS.

"We sent a letter home both Friday and yesterday," Superintendent Eddie Lawrence said in answer to

an email query. "Our letter basically covers the same points as the sheriff's press release. The incident is both a student matter involving two juveniles and an ongoing criminal investigation therefore, I cannot add any further details. We are cooperating with the sheriff's department with the investigation."

The letter parents received Tuesday stated, "Following dismissal on Thursday, Feb. 14, 2019, the Northampton High School administration was made aware of a potential assault which had occurred on the school campus.

The Northampton County Sheriff's Department initiated an investigation into the incident. The school's administration fully cooperated with the investigation. On Friday, the student accused of the assault was not allowed to attend school. Today, Tuesday Feb. 19, the sheriff's office has filed charges against the student for sexual assault and abduction. Since this is both a student matter and an ongoing criminal investigation, any further questions should be addressed to the Northampton County's Sheriff's Department."

Victims in Nelsonia Fire Were Stabbed

All three victims found in the remains of a fatal fire in Nelsonia earlier this month were stabbed to death before the fire was set.

Wilson L. Escalante-Perez, 24, died from a stab wound to the chest, Donna Price, a spokesperson for the Medical Examiner's Office, in Norfolk, Va., said Wednesday. The manner of his death is pending. He lived at the house trailer.

Oraliz Alejandra Gonzalez-Miranda, 26, whose body was also removed from the remains of the mobile home, also died from a stab wound to the chest. Her 3-year-old daughter, Daniella Escalante-Gonzales, identified by her grandfather as Sofia Escalante, died from stab wounds to the chest and abdomen. Both of those deaths were ruled homicide, Price said.

The man who died was the girl's uncle. Other children who lived at the residence are ages 17, 13, and 7 and were in school when the fire was reported at 10 a.m., Feb. 1, at Johnson Court, to the Eastern Shore 9-1-1 Center.

Other residents of the trailer, the grandfather, Feliciano Ortiz and his wife, Celestina Perez (mother of Wilson Perez), were not at home when the fire was reported. They work at Tyson Foods. Yener Perez, the father of the girl, also lived there.

The residence was destroyed. Officers from the Bureau of Criminal Investigations in Chesapeake are continuing to pursue "numerous leads related to the arson and suspicious deaths," said Corinne N. Geller, public relations director for the state police. "The Medical Examiner confirmed the three bodies suffered additional injuries inconsistent with a fire."

Dos Santos Community Services is coordinating assistance to the family. Checks can be sent to Dos Santos Food Pantry, P.O. Box 758, Accomac, VA 23301. Donors should write Ortiz-Perez on the check in the memo field.

"They are trying to figure out where they are going to live," said Angelica

SCHOOL BOARD GETS EARFUL ABOUT LACK OF NOTICE IN ARCADIA THREAT

A parent of three Arcadia High School students and an Accomack supervisor criticized the communication skills of the Accomack School Board at the board's Tuesday night meeting after its office failed to provide parents with information on an alleged gun threat made by a student at the high school on the previous Thursday, Valentine's Day.

In a Feb. 14 Facebook post that received 94 shares and 59 comments, Burke Landon, of Atlantic, stated all three of his children who attend Arcadia High had come home and told him the same story: "a student was escorted off school property today threatening to shoot up the school tomorrow."

His wife called the school board office "and of course gets the run around and no one including the superintendent (Chris Holland) knows anything about it," the post continued.

Landon said Tuesday night that he had spoken to Accomack's District 2 supervisor, Ron Wolff, and discovered the student had actually threatened students who had bullied him. "Either way, it was going to be a school shooting," Landon said.

According to Landon, the superintendent was not aware of the incident when Landon's wife spoke to him Feb. 14., wanting to know if students would be safe to attend school the next day. Holland called back about an hour later and reportedly said, "I'll think they'll be fine."

"Really?" Landon said.

"With social media, why is it so difficult for someone in the school system to say, 'Hey, parents, here's what happened today. Don't be alarmed, we've got it under control'" and explain how local authorities responded, he asked.

Landon also complained that when he and his wife visit the school, they walk through the metal detector, but it's never on. "If airport security is so important these days ... isn't the safety of our next generation also that important?"

Wolff also spoke during the public comment period. "There was absolutely no communication from this board to

the general public" following the Feb. 14 incident, he said.

The incident "was resolved very quickly by the Accomack County sheriff's department. I spoke with them this morning," he continued. "But this board did not communicate to the general public."

He suggested the school division could have used its automated phone system to relay the message to parents early last Friday morning that the previous day's incident had been resolved.

"The only call that I received Friday morning was from my grandson, a student at Arcadia High School, who called home to tell us that there was only about 200 students in school that day," Wolff said.

According to school records, there are 666 students enrolled at Arcadia High.

"They feared the school was going to be shot up," Wolff said. "Why couldn't the school board inform the public that an incident that we've seen happen across the country time and time again had been averted ... ? Our children would have been safe to go to school on Friday."

According to Wolff, school board Vice Chairman Ronnie Holden said he first heard of the incident on Feb. 15 during a phone call from a grandparent of an Arcadia High School student.

Wolff blamed Arcadia High student absences that day on a communication "breakdown" by the school board.

Holland responded, "It's a student matter and it's being investigated as we speak." He called safety a "top priority."

Later, school board member George Waldenmaier commented, "Parents should never be doubting the safety of their children while they're in our charge, and if that happened, then there's clearly a communication breakdown" that shouldn't be repeated.

He recommended reviewing school safety procedures at the next school board meeting. "We want our schools to be safe, and we want our schools to be welcoming and family friendly," but "an airport security system is incompatible with that."

Northampton Supervisors Seek Long-Term Solution to Short-Term Rentals

Spencer Murray, the chairman of the Northampton Board of Supervisors, has often said, “Northampton County doesn’t have a spending problem, it has a revenue problem,” and supervisors are continually seeking new sources of revenue for the county.

Del. Robert Bloxom recently presented his fellow Virginia legislators with a bill that would have allowed the county to charge transient occupancy taxes on state park campground and room rentals, but it was defeated in the House in a vote of 19 to 78.

In Northampton, it would have required Kiptopeke State Park to collect transient occupancy taxes on its campground rentals like Sunset Beach Resort and Cherrystone Campground and remit those to the county, if Northampton opted in.

“We think it’s a fairness issue,” Murray said. “You have the public sector ... competing with the private sector.”

“It just doesn’t make sense to me that state parks don’t have to get transient occupancy tax to benefit the locality.”

But Northampton can pursue ad-

ditional transient occupancy tax revenue from short-term rentals – rooms or other lodging rented for a period of 30 days or less, according to the definition proposed by county planning staff.

The proliferation of short-term rentals in Northampton – particularly in its tourist center, Cape Charles, where there are about 200 – appears to be linked to the increasing popularity of apps and websites like Airbnb that make it easier for anyone with a spare room or vacation home to earn money by renting out property.

Northampton supervisors suspect they are “leaving a lot of money on the table” in the form of unpaid transient occupancy taxes because of people “flying under the radar” with their short-term rental businesses.

Supervisors have considered requiring special use permits for short-term rentals, but Murray said it would be a “nightmare” for county staff to process hundreds of applications at once.

A possible solution was proposed Feb. 12. About 200 or 300 people who are already paying transient occupancy taxes from short-term rentals could

be “grandfathered in” and receive “administrative” special use permits.

Murray noted provisions must still be made to protect adjacent property owners’ rights.

Northampton supervisors also debated how to define an oyster watch house within the county’s zoning ordinance.

Traditionally, an oyster watch house is a structure built on the water, or in the water on pilings, for watching oyster grounds, safeguarding against poaching. It is not meant to be used as a dwelling or to generate rental income.

Providing a definition of “oyster watch house” in the zoning ordinance would mean the property could not “morph into a building used for other purposes,” Northampton’s planning commission chair, Dixon Leatherbury, stated in a Feb. 11 letter to supervisors.

Northampton County waters are protected by the Chesapeake Bay Preservation Act, enacted by Virginia legislators to minimize negative impacts on water quality such as overdevelopment.

Supervisors are also considering another solution to their problem – deleting

“oyster watch house” from Northampton’s zoning ordinance as a permitted use.

Anyone wishing to construct an oyster watch house would still be required to obtain permits from agencies like the Virginia Marine Resource Commission, the Virginia Department of Environmental Quality, and the Virginia Department of Health.

“It’s a Smith Island cake now, why have another layer on it?” Supervisor Robert Duer said.

Furthermore, Northampton County does not own a boat and is unable to enforce regulations on a water-dependent facility, Director of Planning and Zoning Susan McGhee said.

Water-dependent facilities fall under the jurisdiction of the Virginia Marine Resource Commission.

The public hearing that supervisors held Feb. 12 specifically concerned defining an oyster watch house in Northampton’s zoning ordinance. Deleting “oyster watch house” from the zoning use table would require a separate public hearing, County Attorney Beverly Leatherbury advised.

Supervisors voted to table the matter until another public hearing is held.

Accomack To Refund \$91,000 to Four Companies That Overpaid Taxes

Accomack supervisors voted Wednesday to refund nearly \$91,000 in overpaid taxes due to erroneous assessments made on local property.

Commissioner of the Revenue Debbie Midgett certified that refunds are due to four companies. The supervisors followed the recommendation of county staff and directed Treasurer Dana Bundick to issue the payments, which include interest.

Del Monte Fresh Production Inc. will get back \$6,098.16; William D. and Therese B. Lovell Poultry Farm is owed \$7,889.92; Chesapeake Bay E.N.T. will be paid \$28,975.84, and Sharp Energy Inc. will receive \$47,748.15.

County Administrator Mike Mason said the funds would "come out of revenue coming in this year. It's all in a net," he added.

Tourism and Commerce

A savings of more than \$21,000 annually will be realized with the merging of tourism and commerce, reported Robie Marsh, director of both the

Eastern Shore Tourism Commission and the Eastern Shore of Virginia Chamber of Commerce. The tourism office in Onancock was closed and is now operating from chamber headquarters in Melfa. Marsh has been managing the two entities for nearly two months.

The ten goals of the merger were also outlined by Marsh and include restructure staff roles to maximize efficiency; fill empty positions; launch new website that supplies a state tourism calendar; create, print, and distribute the new travel guide in about three weeks; eliminate a \$65,946 deficit by June 30; make a strategic marketing plan that would include the 50-year anniversary of Virginia is for Lovers; coordinate an 18-month audit; maintain the success of the southern welcome center; and reestablish a welcome center at the chamber office.

News About Roads

Local VDOT Director Chris Isdell briefed the supervisors on road work

including the bridge washout at Hillsborough near Belle Haven.

Branscome Eastern Shore is in charge of the project, which has a June 15 completion date, Isdell said. The company is "out there working ... setting pipe ... building it up to what the upgrade needs to be ... progressing quite nicely," he added.

Isdell also reported the traffic light for Route 13 and the Accomack Industrial Park, in Melfa, is set to be completed by the summer of 2020. The project is in the right of way stage. Turn lane upgrades will be made and the crossover in front of the Eastern Shore Community College will eventually be closed.

Improvements are also planned for T's Corner with construction to begin in May 2020. A traffic signal will be installed at Saxis Road and Route 13 with minor improvements being made to pavements and Church Street traffic being diverted to Route 695. Cemetery Road in Belle Haven will have a \$3.9 million overhaul beginning in

late 2022.

Supervisor Ron Wolff thanked Isdell for a recently completed project that removed between 70 and 80 tires from Thornton Road.

Money for School Division

The formula the county usually follows to increase the local contribution for schools produces an increase of \$286,000. Finance Director Beth Onley said the division's budget shortfall is about \$100,000 more. Depending on what the General Assembly does, she noted, that amount could increase by almost \$300,000. The school budget includes a 3 percent increase for all salaries. The operating budget proposal is nearly \$52.5 million.

County Budget Set for Public Hearing Without Tax Increase

The supervisors unanimously agreed to advertise a public hearing for the proposed 2019-2020 fiscal budget of \$58.2 million for Monday, March 11. The proposal is balanced without increases in personal property or real estate rates.

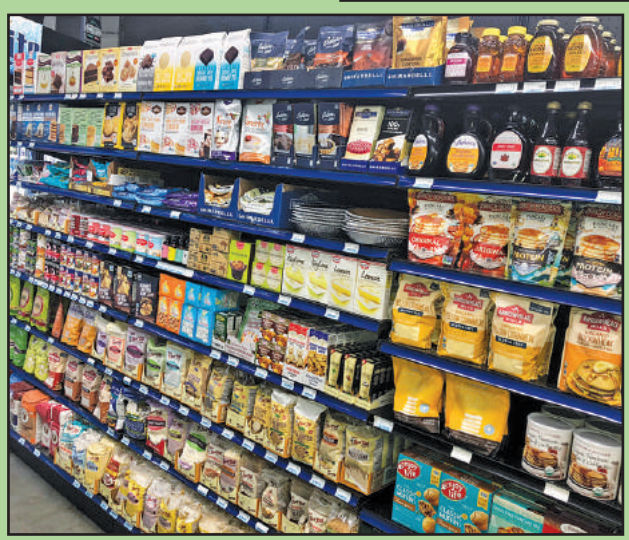

Manslaughter, DWI Charges Certified In Christmas Eve Crash That Killed Teen

Charges of manslaughter and driving while intoxicated with a child on-board were certified to a Northampton grand jury last week in the case of a crash last Christmas Eve that killed a local teenager.

Judge Gordon Vincent found probable cause to certify the charges against Calvin Earl Berryhill Jr., 40, of Madame C J Walker Lane in Exmore, the driver.

In the court file, Trooper B.M. Tripp stated he responded to the incident

on northbound Route 13, near Cape Charles, at 2:40 a.m. Tripp determined a 2003 Saturn VUE, driven by Berryhill, ran off the road, overturned, and struck several trees.

Trevonne Avant Stith, 17, of Banks Road in Cape Charles, died at the scene. His mother, Tracy Shavonn Stith, was also in the vehicle. She was taken to a hospital for injuries that were not life-threatening.

The suspect “stated he had several mixed drinks and beers prior to the crash,” Tripp noted in the record. Berryhill tested at .11 grams per 210 liters of breath. The legal limit is .08.

Suspended Sentence For Woman Who Embezzled From Post Office

An Exmore woman was given a suspended sentence last week in Accomack Circuit Court for embezzling money between November 2017 and September 2018.

Laquida Burton, 29, was given a 90-day suspended term for two counts of stealing from the U.S. Post Office in Pungoteague.

Dajon Trikece Wise, 22, of Redwood Road in Melfa, was acquitted of assault and battery. He was convicted of petty larceny, two counts of resisting arrest, and unauthorized use of a vehicle belonging to Norman Keller. The crimes occurred April 30, 2018. A pre-sentence report was ordered. Sentencing was set for April 11.

Quarmaine Deshon Bailey, 27, of

Cutlers Court Road in New Church, was given a two-year suspended sentence for making a false statement about criminal history on a firearm purchase form. The incident occurred Feb. 23, 2018.

Yashica Tonya Hope, 39, of Melfa, formerly of Mappsville, was sentenced to five years with four suspended for assault and battery of Deputy E. Thornton. Good behavior was ordered for four years with indefinite supervised probation. The incident occurred June 11, 2017.

Garcia, the agency’s director. “They are completely displaced,” she said. The family also needs money for the unexpected funeral expenses.

The names of the two adults were released by the state police Sunday — 16 days after the suspected arson/ homicide was committed.

Ortiz said the family moved to Virginia in 1997 from Guatemala. He describes a quiet family that kept to itself. They did not come “to steal or to kill,” he said. “We just came to struggle and work” for a better life.

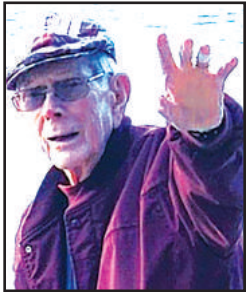

John Smith Shrugs Off Teasing in Light of Past ‘Persecution’

Hallwood Councilman John Smith has taken a lot of ribbing around town since residents learned the town council voted earlier this month to pay for his recent tooth extraction.

“I’ve had people say, ‘Hey John, I got this medical condition ...’” Smith said Wednesday, adding that they are “just kidding me.” The extraction, “It’s all done, and it’s doing great, was a tooth that broke off with my gum line ... it was a front tooth.”

The majority of the town council agreed to pay for his dental work because Smith couldn’t afford it and members do not get paid for serving on the council.

“People seem to be concerned about spending \$250,” said Smith. “But nobody ever put up a fuss about spending \$14,000” in legal fees.

Smith came into the Eastern Shore Post’s office in Onley Tuesday to drop off copies he had saved of the town’s bills incurred from when he was taken to court 12 times. Some of the charges arose for the town’s defense when Smith filed complaints. He said the cases didn’t cost

him anything because he filed on his own and represented himself.

The total of the legal fees was about \$14,200. Attorney Lynwood Lewis, now a state senator representing the Eastern Shore, charged the town \$8,071.50 while attorney Tommy Dix’s bill was \$6,125. Smith said Dix never got paid a portion of the money. In retaliation against Lewis, Smith ran against him when Lewis was seeking re-election as state delegate.

In a written statement, Smith said, “Hallwood apparently took sides” with his neighbor “after a property line dispute. Over a four-year period, 2007 to 2011, Hallwood policeman arrested me 12 times. The feud went on until they ran low on money. Sometimes I sued the town attempting to get (back) my business license ... I believe the amount billed is much higher but I do not have copies.”

The fines levied against Smith were for three charges of not having a business license and totaled \$250 — the same amount it cost for his tooth extraction. The rest of the charges, including one for stalking, were dismissed. He said he was also charged for having a

junkyard without a permit and “everything in the world imaginable.”

The stalking charge involved Smith making photos of the former town police chief when the chief was visiting Smith’s neighbor, who Smith said was the main complainant against him. Smith said the neighbor’s wife’s foot was in some of the pictures because she was sitting on a porch behind the chief. “I did not even know she was there,” Smith said. “It was thrown out. Wasn’t anything to it. I had to post a \$10,000 bond for that.”

Court records show Smith was acquitted of the charge in 2009.

The neighbor, Donald Wayne Merritt, was harbormaster for the Town of Chincoteague, which obtained a no trespassing warrant against Smith. “They retracted the notice the next day,” Smith said. “The harbormaster just simply asked him (the town manager) to do it.”

“The feud began when I tore down the old building on my lot and brought in the motor home,” Smith said. That was in 2007. His home was a converted school bus that Smith had painted pur-

ple, the only paint color he said he had.

“One night I was walking down the road and somebody busted out ten windows,” he said of his bus. Eventually, “I got rid of it. I have a little camper here on the property” now, he added.

“At the time they were spending all that money on me, nobody ever said a word,” Smith said. “It was selective persecution.”

Since then, Merritt retired and left town, the police department was disbanded, and after trying for 20 years to become a town council member, Smith won an election with 12 votes.

Angel Taylor, the former town clerk, whose car burned with all the town records in 2017 just before an audit, was recently charged with 65 counts of embezzlement.

Smith said Taylor came to all of his court proceedings. She lived across the street from his house.

Court records show Taylor was the complainant in a case against Smith for failure to rid his property of debris in May 2009, which was not prosecuted, and a charge of failure to obtain a zoning permit in May 2010, which was dismissed.

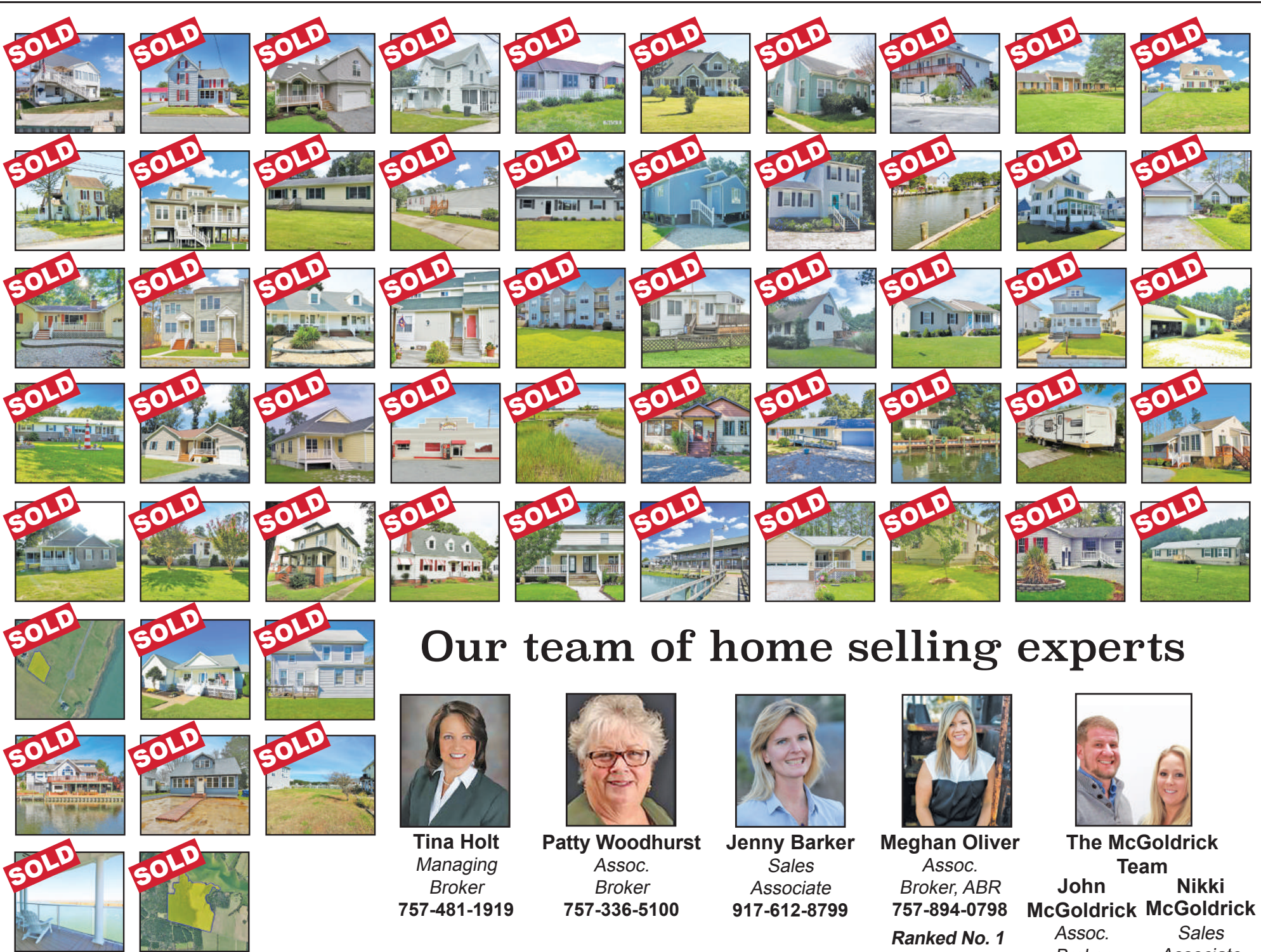

Hernandez Announces Candidacy for 100th District Delegate's Seat

Philip "Phil" Hernandez, a Democrat and a staff attorney at the National Employment Law Project (NELP), in Norfolk, Va., announced last week that he will seek the delegate's seat in the 100th District of Virginia in the November election.

The district includes Accomack and Northampton counties and Norfolk City. Rep. Rob Bloxom, a Republican, holds the job.

"I was raised (in Hampton Roads) in a community that showed up for each other," Hernandez said this week on Twitter. "My mom, who's one of the strongest women I know, built an at-home daycare business so she could raise and provide for me and my sister. Mom also taught herself, and then me, American Sign Language (ASL) so that we could show up for my sister, Brittany, who was born deaf. When we were with extended family, including those who didn't know ASL, my sister and I would stick together as a unit, with me translating the conversation

around us so she could be included," he continued. "As siblings, this was how we had each other's back."

"When someone trusts you, the way families trust each other, there's an opportunity to build a stronger, more inclusive community. When we earn the trust people place in us, we can rise as a community."

"Here's another truth," Hernandez continued, "I would not have made it to college without my community having my back. I knew that I had what it took to attend college, but with the skyrocketing costs of tuition, I didn't know how I'd get there. Thanks to mentors at First Colonial High School, including my music teacher, Mr. Garcia, I was encouraged to apply to a scholarship for first-generation college students like me," he said.

Before attending Berkeley Law, Hernandez worked in the Obama administration for three years as a senior policy analyst in the White House Domestic Policy Council. In that role, he said he advocated poli-

cies aimed at expanding clean energy, reducing harmful pollution, and promoting U.S. leadership on climate change. Hernandez got his bachelor's degree from the College of William and Mary.

A NELP staff attorney since 2017, Hernandez also favors "policies that expand economic opportunity for all people. His background includes a variety of positions at the intersection of law and public policy. Most recently, he litigated at Lieff, Cabraser, Heiman & Bernstein, where he co-authored an amicus brief challenging the constitutionality of the Trump administration's immigration policies. During his time with the East Bay Community Law Center (EBCLC), he developed a policy proposal to better protect innocent tenants involved in eviction lawsuits and prevent homelessness. He partnered with a diverse coalition to advance that proposal (AB 2819) through the California legislature before Governor Brown signed the bill in September 2016. In addition, Phil previously



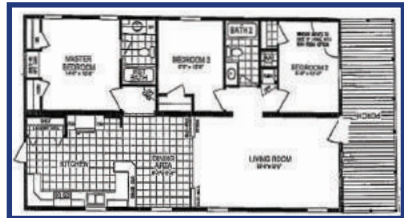

served as a judicial extern to Justice Goodwin Liu at the California Supreme Court."

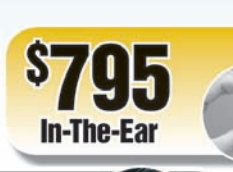

Johnson Announces Run for District 3 School Board Seat

Lisa Cropper Johnson, a pastor from Horntown, announced Wednesday that she will run for the District 3 seat on the Accomack School Board in the November General Election.

Johnson is on the School Board Selection Commission, a post (appointed by the circuit court judge) that will no longer be needed since an elected school board was approved in a referendum. Johnson also serves on the county's parks and recreation advisory board and as commissioner on social justice with the Eastern Shore Virginia/Maryland Baptist Association. Johnson said she is also actively involved in the Horntown Community Improvement Association and has been a Superintendent's Community Advisory Committee member.

"As an education proponent," Johnson said her "foundational belief is that educational excellence requires unified efforts, that of a village." She said she "feels that a strong collaboration among teachers, parents, stu-

dents, and community is necessary."

One of her main interests is "providing pre-school for all students so that a head start is uniformly available." Johnson said she is concerned about "equitable discipline that is restorative not just punitive. School safety is of utmost importance." Johnson said she "does not mind addressing difficult topics and views herself as well-rounded and an empathetic listener."

Johnson was salutatorian of the Chincoteague High School class of 1984. She has a bachelor's degree in Communication Arts from Salisbury University, a master's degree in Guidance and Counseling from the University of Maryland Eastern Shore (UMES), and a doctorate in Organizational Leadership from UMES. Her doctoral research topics were servant leadership, humility, and conflict resolution, she said.

She is a former vice president for the Horntown Educational Learning Project Inc. During the 1990s, the nonprofit program provided summer camp, tutoring, and other educational services for the community. She celebrated five years as a local pastor last August. She has led youth ministry with responsibility for a multi-disciplinary team and developing curricula and implementing diverse programs.

Johnson's "community leadership skills include leading projects, budgeting, and all aspects of personnel management from making appointments, leading elections, conducting employee development, conflict management, and effecting terminations." She joined Delta Sigma Theta Sorority Inc. more than 20 years ago and is an active member of the Accomack-Northampton alumnae chapter. In the sorority, she said she has "co-lead youth initiatives, assisted with technology management, led social action, and provided journalistic services."

Groundwater Committee Nominates Five for Annual Award

The Eastern Shore Groundwater Committee is considering five people/communities as the potential recipient of the annual groundwater award and asked staff Tuesday to investigate whether two nominees could be chosen.

The committee's agenda included two names:

- Mark Reiter of Virginia Tech, whose "major program focus areas are proper management of fertilizer sources, inorganic and poultry litter, oilseed, and vegetable production systems. He is also working on soil quality improvements and nutrient loss reductions by introducing new cover crop species and mixes. All research, teaching, and extension centers around improving yield and quality of Eastern Shore produce and crops while also reducing nutrient losses to waterways."

- The Town of Exmore, which through leak detections, infrastructure/leak repairs, and other conservation efforts pumped less water and expects that trend to continue. In 2015, two new wells were drilled and in 2018 prices for

a new filtration system were requested.

Roberta Kellam, a former State Water Control Board (SWCB) member, asked that Bob Meyers of the groundwater committee be added to the list of nominees and the panel agreed. "He gets called upon in Northampton for his expertise," said Kellam. He is "completely unpaid and a volunteer," she added.

Kellam also wanted Sen. Lynwood Lewis added "because of his advocacy for this groundwater bill. I can say it is no easy task to get something passed in this environment in the general assembly right now."

She was referring to Senate Bill 1599 that would direct the SWCB to adopt regulations providing incentives to those who withdraw their water from the Columbia aquifer including extending permit terms to as long as 20 years and accelerated permit process, discounted permit fees. The bill has been voted on numerous times with no objections at the General Assembly and is awaiting the governor's signature.

Britt McMillan, the groundwater committee's hydrogeologist, suggested adding the NOAA at Wallops Island to

the mix. "They did what we've been advocating," he said. The agency is using the preferred aquifer, is pumping less, and has installed water-tabled wells.

Shannon Alexander, coastal resources program manager for the Accomack-Northampton Planning District Commission, said the award program was developed in 2004. The award has been given to those whose decisions in water resource use are responsible and sustainable in the categories of water conservation, recharge area protection/preservation, aquifer protection, recycling/reuse, pollution prevention, and public education and community outreach.

"There is no cash award," Alexander replied. "There is a framed award given to the recipient, they are added to our plaque in the A-NPDC conference room, there is a press release, (and) the award is given in a public setting." It is an honor.

Past winners include: 2005 — Jane Corson-Lassister of Eastern Shore Environmental Education Council; 2006 — Richard Davis of Ivy Farm Nursery; 2007 — William Neal of Hermitage Farms Nursery; 2008 — Chuck Tankard of Tankard Farms;

2009 — Robin Rinaca of Eastern Shore Nursery of Virginia; 2010 — Walmart Supercenter of Onley; 2011 — Cherrystone Campground and Aqua-Farms; 2012 — Town of Cape Charles Wastewater Treatment Plant; 2013 — Eastern Shore Rural Health Onley Community Health Center; 2014 — Waste Watchers of the Eastern Shore; 2015 — Fitchett Farms; 2016 — Commonwealth Chesapeake Company; and 2017 — John Lauer of Accomack County Regulatory Compliance Specialist.

The groundwater committee also briefly discussed community septic systems at Makemie Park and Withams where Supervisor Grayson Chesser said some residents are left trying to collect money from the others to pay for needed maintenance and repairs and costs that occurred because of the poor care.

"It's a mess and it's going to get worse," Chesser said of Makemie Park's system. "They don't listen to maintenance needs and (instead they) lower the rates," he said, "The system is owned by the group. I can't see Accomack County taking it over ... it would be those people's worse nightmare because we would get judgments."

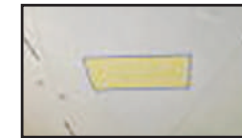

CONSERVATION GROUPS SUE TO BLOCK START OF SEISMIC AIRGUN BLASTING IN ATLANTIC

A group of conservation organizations asked a federal judge this week to block the start of seismic airgun blasting for oil and gas exploration in the Atlantic Ocean. It is the same group that sued the federal government in December to prevent the same activity.

The suit and the injunction contends the Trump administration has given approval to five companies for seismic airgun blasting in violation of three federal laws: the Marine Mammal Protection Act, the Endangered Species Act, and the National Environmental Policy Act. The request for an injunction was filed because the suit has not yet been heard.

“This important issue deserves a fair day in court,” said Diane Hoskins, campaign director at Oceana, one of the organizations that is party to the suit. “We can’t let this dangerous activity cause a species to go extinct just so the oil industry can open our oceans to offshore drilling.”

Hoskins is referring to harm envi-

ronmentalists say will come to mammals — particularly the right whale — from seismic airgun blasting, which the filing says creates one of the loudest sources of noise in the ocean.

The suit claims, “These surveys cover overlapping territory and will likely be simultaneous: the five authorizations allow nearly 850 combined days of around-the-clock activity, amounting to more than five million total seismic airgun blasts.”

Because sound travels farther in the ocean, and marine species rely on sound for communication, locating food, avoiding predators, and navigation, the seismic activity on the scale approved for the five companies will be harmful to marine life, including critically endangered North Atlantic right whales, the suit alleges.

“Up and down the Atlantic coast, businesses, communities and bipartisan elected officials are overwhelmingly opposed to seismic airgun blasting,” said Hoskins. “Every East Coast governor and over 90 percent of coastal municipalities in the

blast zone are opposed to opening our coast to drilling — this is ‘States versus President Trump.’ We are going to do everything in our power to stop this unlawful, irreparable and needless harm.”

The towns of Cape Charles, Chincoteague, Exmore, and Onancock, and the boards of supervisors in Northampton and Accomack counties, have all passed resolutions opposing offshore drilling and seismic airgun blasting. The Eastern Shore Tourism Commission has also sent a letter opposing the practice.

The filing also asserts that because the blasts will happen approximately every 10 seconds for weeks or months at a time, there will be overlapping, simultaneous, and cumulative effects greater than the effects of any individual seismic blasting operation. It also takes issue with the National Marine Fisheries Service (NMFS) determination that a small number of whales and dolphins would be harmed.

A Dec. 7, 2018, notice published

in the Federal Register specified the “incidental harassment authorizations” granted to five companies: Spectrum Geo Inc, TGS-NOPEC Geophysical Company, ION GeoVentures, WesternGeco LLC, and CGG Services Inc. for their East Coast seismic blastings.

The “harassments” are divided into Level A, those with the potential to injure a marine mammal or marine mammal stock in the wild, and Level B, those with the potential to disturb a marine mammal or marine mammal stock in the wild by causing disruption of behavioral patterns, including, but not limited to, migration, breathing, nursing, breeding, feeding, or sheltering.

Each company has a different zone from Delaware to Florida within which it will conduct activities, but all include the areas off the coast of Virginia and Maryland.

TGS was given authorization for Level A harassments (potential direct injury) for four humpback whales, four minke whales, four fin whales, five Kogia, and three harbor por-

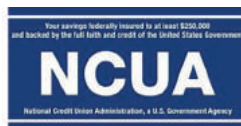

poises. Level B harassment authorizations were granted for nine right whales, 56 humpback whales, 208 minke whales, two Bryde's whales, two sei whales, 1,140 fin whales, one blue whale, 3,579 sperm whales, 1,216 Kogia whales, 12,072 beaked whales, four bottlenose whales, 50 melon-headed whales, six pygmy killer whales, 28 false killer whales, and 8,902 pilot whales. In addition, the permit grants Level B harassment of 261 rough-toothed dolphins, 40,595 common bottlenose dolphins, 821 clymene dolphins, 41,222 Atlantic spotted dolphins, 1,470 Pantropical spotted dolphins, 91 spinner dolphins, 23,418 striped dolphins, 53,728 common dolphins, 204 Fraser's dolphins, 48 Atlantic white-sided dolphins, 3,241 Risso's dolphins, and 322 harbor porpoises. That's 20 Level A harassments and more than 150,000 Level B harassment authorizations for one of the five companies, albeit the largest operation of the five.

Although no harassments of North Atlantic right whales were authorized, the plaintiffs claim the

blasts could irreparably harm the the species on the verge of extinction because of the blasting's proximity to migration and calving grounds. There are about 400 right whales remaining in the Atlantic.

The suit also alleges the number of mammals authorized to be harassed is contrary to the Marine Mammal Protection Act, which prohibits activities that can disturb, injure, or kill marine mammals, unless NMFS authorizes the activities after making certain findings. "NMFS may give its authorization only if it finds, among other things, that activities will injure or disturb 'small numbers' of marine mammals and will have no more than a 'negligible impact' on each marine mammal species or stock.

"NMFS's conclusions that the authorized seismic surveys in the Atlantic meet these requirements defy science, law, and common sense."

NMFS concluded in its Notice of Incidental Harassment Authorizations that "the best available science" indicates disruption of behavioral patterns is likely (Level B harassment) "and a limited amount of auditory injury" (Level A) may occur for a few species.

"No mortality is expected to occur as a result of the planned surveys, and there is no scientific evidence indicating that any marine mammal could experience mortality as a direct result of noise from geophysical survey activity. ... Such authorization was neither requested nor proposed" by any of the five companies, accord-

ing to NMFS.

Sixteen South Carolina coastal communities and the South Carolina Small Business Chamber of Commerce also filed a lawsuit to prevent seismic blasting. That lawsuit has been merged with the one from the conservation groups. Ten East Coast attorneys general, including South Carolina's Alan Wilson, have intervened in the combined lawsuits.

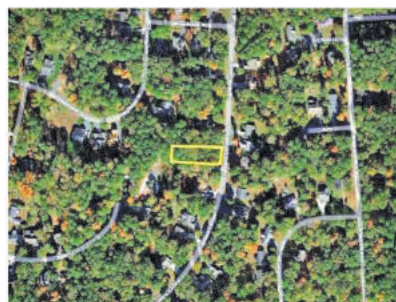

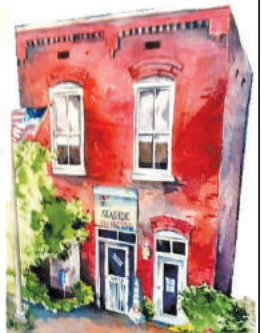

Yellow Jacket Aizmani Joseph earned a fourth-place finish in the 138-pound bracket. He defeated George Wythe's Alyssa Waller by a fall time of 46 seconds in his first match, then went on to top Grundy's Jacob Stiltner in the quarterfinals by a fall of 3:32.

Joseph fell to Riverhead's Lane Cash by a decision of 13-6 in the semifinals, putting him in the consolation rounds, in which he won by major decision of 16-6 over Honaker's Dylan Shortridge. The third-place match went to Lancaster's Dominique Veney by a major decision of 14-4, settling Joseph in fourth.

Northampton's 170-pound grappler, Gary Peart, finished fifth overall. He received a bye in the first round, and fell to Wytheville's Terry Morgan by decision of 8-5 in the quarterfinals. Peart defeated Middlesex's Owen Miller by a fall time of 2:08 in the consolations, and then he

downed Stonewall Jackson's Udreka Claude by a decision of 10-5. In the consolation semis, Peart fell to Northumberland's Christopher Davis by a 5-2 decision, putting him in the running for the fifth-place match, in which he came out victorious over

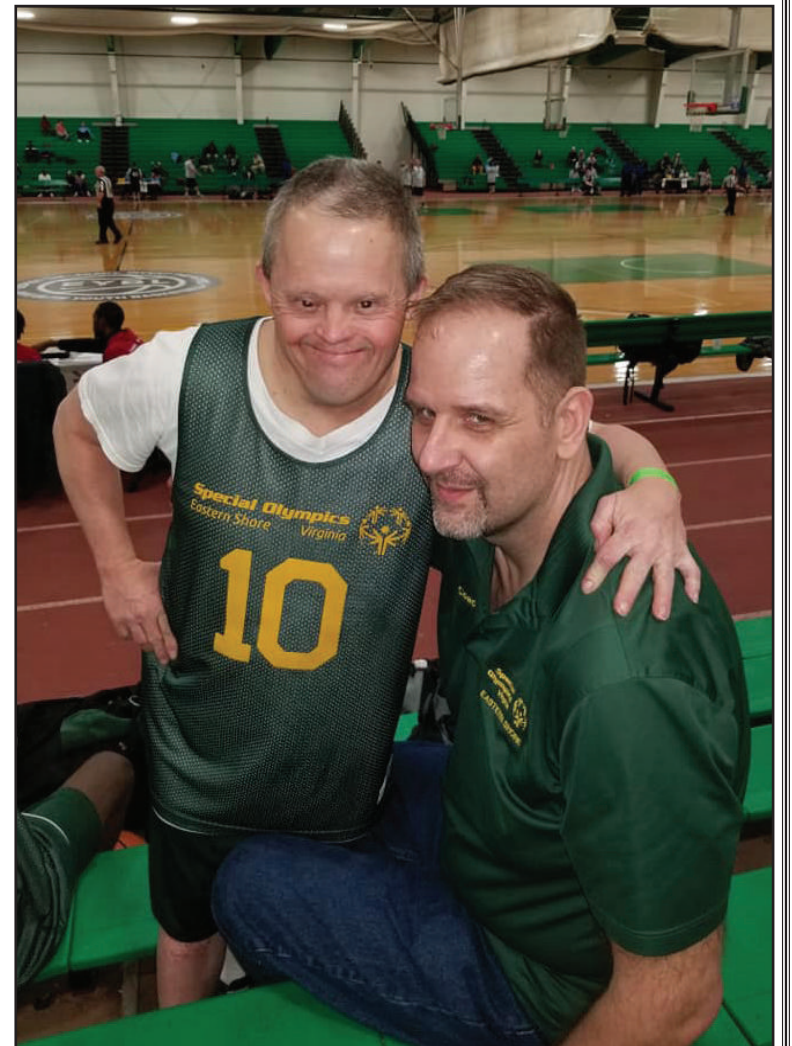

Shore Swim Competes at Regional and State Levels

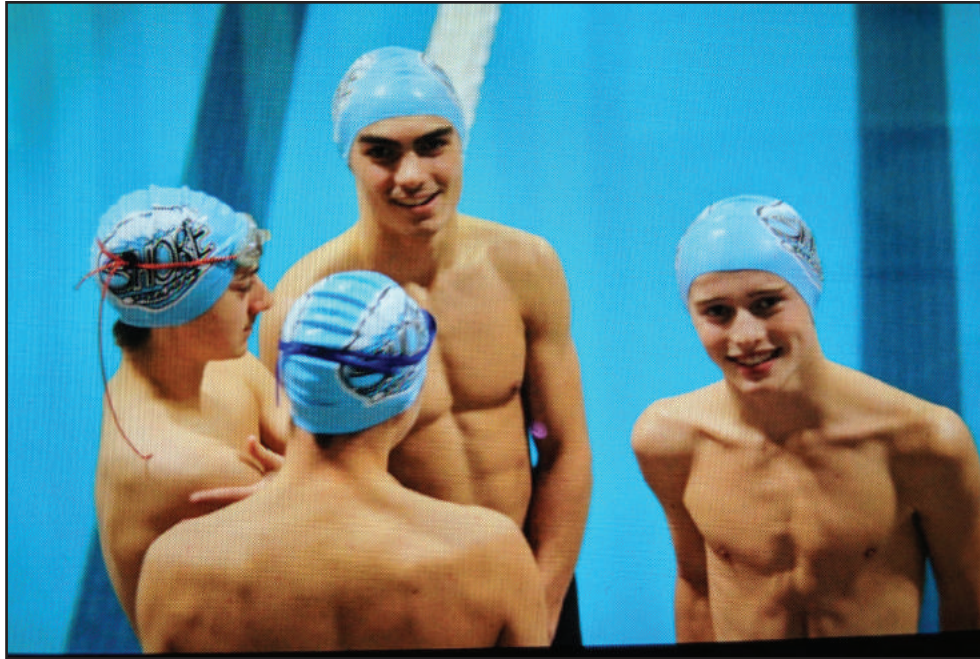

Governor Northam Announces 11th Annual Conference on Ag Trade

Governor Ralph Northam will co-host the 11th Annual Governor's Conference on Agricultural Trade with the Virginia Tech Department of Agricultural and Applied Economics, the Virginia Department of Agriculture and Consumer Services (VDACS), Virginia Farm Bureau Federation, and the Port of Virginia on March 5, at the Richmond Marriott Hotel. The one-day conference will bring together producers, agribusinesses, entrepreneurs, exporters, foreign ambassadors and government ministers, educational leadership, state and federal government officials, and many more to discuss challenges and opportunities for global agricultural exports.

"For more than a decade, the Governor's Conference on Agricultural Trade has served as an important forum for stakeholders from Virginia's two largest industries to come together and hear from key leaders in government, business, and international relations on the outlook of the trade environment," said Governor Northam. "Global trade is a vital component of a strong Virginia economy and my administration remains committed to growing opportunity for producers and exporters in every part of our Commonwealth."

The Governor's Conference on Agricultural Trade will feature an outstanding array of speakers from the front lines of our trade sector, individuals who are involved in this complex marketplace every day. Conference participants will hear from foreign dignitaries, private-sector leaders, trade negotiators and others on topics that are timely and relevant for 2019 and beyond.

"Our high-quality Virginia agricultural and forest products are in demand around the world," said Secretary of Agriculture and Forestry Bettina Ring. "As we continue working to build markets around the globe for the Commonwealth's producers, this conference gives us a chance to discuss the challenges of the current trade environment and find new opportunities for growth."

This year's conference will focus

on a shifting trade environment, the challenges and opportunities for agriculture, and the outlook for important trade negotiations. Key speakers and participants include Thomas Barkin, the president and CEO of the Federal Reserve Bank of Richmond and Jim DiMenna, the Canada-based CEO of Red Sun Farms, as well as trade negotiators, a variety of industry experts, and dignitaries and officials from many countries, including China.

Compared to 2017, Virginia Farmers Storing Less Corn, Soybean, and Barley Stocks

The Virginia Department of Agriculture and Consumer Services announced that the U.S. Department of Agriculture's National Agricultural Statistics Service (NASS) 2018 Grain Stocks report shows less Virginia corn, soybeans, and barley stocks have been stored in off-farm facilities than in 2017.

Virginia corn stocks stored in off-farm facilities on Dec. 1, 2018, totaled 12.2 million bushels, compared to 13.0 million bushels stored off-farm on Dec. 1, 2017.

Soybean stocks stored off the farm totaled 4.72 million bushels on Dec. 1, 2018, compared to 7.25 million bushels stored off the farm the previous year.

Virginia wheat stocks stored off the farm totaled 7.40 million bushels on Dec. 1, 2018, compared to 7.22 million bushels stored off the farm a year earlier.

Oat stocks stored off the farm on Dec. 1, 2018, totaled 30,000 bushels, up 14,000 bushels from Dec. 1, 2017.

Barley off-farm stocks totaled 109,000 bushels on Dec. 1, 2018, compared to 166,000 bushels last year.

Cut Flower Growers' Conference Set for March

Five years ago, the U.S. Census of Agriculture estimated that the number of Virginia cut flower producers had jumped from 117 in 2007 to 227 in 2012.

Even more producers have entered the field since then, raising flowers for



the floral bouquet market.

The 2019 Cut Flower Growers Conference on March 13 and 14 at the Fredericksburg Expo and Conference Center will offer newcomers and experienced growers a chance to learn more about cut flower opportunities.

Raising flowers has many advantages for small-scale producers, according to Virginia State University's Small Farm Outreach program. They're a high-value crop that can be raised on a small footprint, requiring only a few people to raise them. And if growers use a high tunnel or a greenhouse they can sell their products year-round.

"Around here in Southside Virginia, flowers are like vegetables. People like what they know and grew up with," noted Amy Carwile, co-owner of Archlynn Farms in Charlotte County. She and her husband grow fruits and vegetables, and in 2018 she added cut flowers to the mix. "I like to grow pretty flowers, ones you can take home, put on a kitchen table or share with your friends," Carwile said.

Jessica Hall, master grower and designer for Harmony Harvest Farm LLC in Augusta County, said farm-fresh flowers are a "great way to marry agriculture with the niche market of cut flowers." She and her mother, Chris Auville, started their cut flower business in 2013. They sell their flowers nationwide and to the Whole Foods Market chain.

Fresh Herbs Resurge Under Virginia Greenhouses

Greenhouse herb operations are popular in Virginia, and there seems to be a resurgence in the popularity of locally grown herbs.

Greenhouses are located on 51 Virginia herb farms, which produced 29 acres of fresh-cut herbs in 2012. That was down from the previous decade,

when there were 73 herb operations.

But the market is changing, and there's been consolidation within the industry. Most greenhouse herbs are sold to grocery chains year-round. And while cooking herbs are top sellers, up to 40 million adults now use herbal supplements in their diets.

The Growers Exchange has found a niche in this unique farm sector. It began in 1985 as a retail garden center in Richmond and later became a greenhouse operation on a 900-acre family farm in Charles City County. Today it is a modern production facility that includes five greenhouses, a packing warehouse, and an office complex in eastern Henrico County, where it sells fresh organic potted herbs to consumers online.

"I love sharing our products with people and then getting the feedback," noted Kenan White, Growers Exchange marketing director. "And I've got to say, after 20 years of retail in a brick-and-mortar store, we've got more relationships with people now than we did then. It's the quality of the interaction, whether it's through social media, email or even a phone call that makes the difference," she said.

While greenhouses offer controlled growing conditions year-round, the biggest change for the Growers Exchange has been in its production room. It's more efficient and streamlined than in the past, said Briscoe Smith, Growers Exchange president.

"Potting soil, pots, flats, tags, seeds, sometimes started baby plants that we buy from another greenhouse" all come through the main door, Smith shared. Workers then feed up to 1,000 pounds of potting soil into an agronomic potting machine, which mixes organic fertilizer and biological fungicide into the soil. The herb seedlings are then quickly transplanted and moved directly to the greenhouses.

Moving to eastern Henrico allowed the greenhouse operation to be within a few hundred yards of a major post office distribution center, another key part of the business, Smith said.

Popular garden herbs at the Growers Exchange include basil, chives, cilantro, oregano, and parsley, and they cultivate a dozen more varieties of seedlings. More information about their operation is available on "Real Virginia", Virginia Farm Bureau's weekly television program.

MARCH MADNESS IS AROUND THE CORNER

Plan ahead for some healthy snacking.



Pita Bread

- 2 teaspoons active dry yeast
- ½ teaspoon sugar
- 1 cup of water
- 2 ½ cups flour, plus ¼ to ½ cup for shaping
- 1 teaspoon kosher salt
- 2 tablespoons olive oil

In a large bowl, add one cup of flour, dry yeast, and sugar. Mix with a wooden spoon.

Heat water to 120-130 degrees. Make a well in the flour and pour in the water. Stir to incorporate. Once mixed, set in a warm place to allow yeast to work. When the mixture becomes bubbly and starts to expand, add oil, salt, and the other 1 ½ cups of flour. Mix well with wooden spoon (the dough will be stringy), before turning out onto a floured surface to knead lightly until smooth, about 2 minutes. Let it rest, then knead lightly again. Place the dough in a clean bowl, cover, and allow to double in size.

Heat oven to 475 degrees. Place a heavy pan or baking stone on the bottom shelf to heat. Divide dough into 10 pieces, then let rest a few minutes.

Flatten one disk to about 6-8 inches in diameter, using small amount of flour to keep from sticking. Place on baking stone/pan and cook for a couple of minutes on each side until golden spots just start to appear. Repeat with remaining dough balls.

Homemade Hummus

- 2 cans of chickpeas
- ¼ cup tahini
- ¼ - ½ cup extra virgin olive oil
- 2 large cloves garlic
- juice of one lemon
- salt to taste

Drain chickpeas and place in food processor with blade. Process until they are in small pieces. Add tahini, ¼ cup olive oil, garlic cloves, and lemon juice. Process until smooth. Add more lemon juice, if needed, to make hummus smooth. Add salt to taste.

Serve with pita wedges, carrots, or favorite dippers.

Baptism to Embalming and Funeral: With Deep Roots on the Shore, The Rev. Stephanie Castro Cares for Her Community Through it All

The Rev. Stephanie Morris Castro plays a vital role in the lives of the members of St. Paul's AME Church at Pungoteague and St. Joseph's AME Church near Painter.

As their pastor, she baptizes babies, marries couples, and gives the eulogy for those who pass away. And before the eulogy, she sometimes also handles the funeral arrangements as the third-generation director of John O. Morris Funeral Home in Nassawadox.

"It's a delicate balance performing the service and handling the arrangements, but in the 11 years I've been their pastor I've done it a few times," said Castro recently at her funeral home office on Route 13 just north of Nassawadox.

Her grandfather, John O. Morris, founded the funeral home in 1914. Castro said hers was a deeply religious family as her grandfather's middle name, Offer, came from John Offer, a bishop who founded several of the AME churches on the Eastern Shore.

On Sundays, her father, Alvin Morris, would take all six of the Morris children to Sunday school at New Allen AME Church in Franktown. Her mother, Eunice, would join them for the service. There was never a question on Sunday morning that the Morris family would be in church.

Castro graduated from Northampton High School in 1977. She calls that "the year of the twins." In a class of about 200 students, there were seven sets of twins. She ticks off the names, the Williamses, the Cooleys, the Kellams, the Reeds, the Smaws ...

And then there was Stephanie and her twin brother, Stephen. "He was the extrovert. I was the introvert," said Castro. "Everyone said when he entered a room, people gravitated to him. He had this loud voice, engaging smile and deep laughter. I was his shadow."

They both attended Virginia State University, the alma mater of their mother, their freshman year. "We had other options but really no choice. She said this is where you need to go."

But Stephen left after a year and transferred to VCU to study business. "It was the first time we were ever apart," recalled Stephanie, "but still I saw a lot of him. You could ride a bus from Richmond to Petersburg for 50 cents then. And this was before there were co-ed dorms, but he would knock on my door and announce himself in his usual loud voice. Boys weren't supposed to be in the dorms, but they made an exception for Stephen."

Castro said twice a month they would get together in Richmond. "I would take my 50 cents and ride a bus to Richmond, where they had steak

and lobster every other Friday night at the VCU culinary arts school. We always had fun together."

Castro said it was a life-changing event when Stephen died at 26 from cancer. "He loved running, completing a number of marathons, including the New York City Marathon. I hated running. He often urged me to join him, even grabbing my wrist once and pulling me along," recalled Castro.

"When he died, I started running. I listened to music, mostly gospel, and that led me to eventually enter the ministry. I also thought about him and looked for answers, such as 'Where is he?' and 'Why him and not me?' I also thought a lot about my own spiritual journey."

After graduating from Virginia State University with a degree in psychology and a minor in math, she spent 12 years in New Jersey as a statistical analyst with a state agency. There, she married her first husband and started a family. The marriage was blessed with two daughters, but ended in divorce, though she and her former husband stay in touch.

When her father was diagnosed with cancer in the early 1990s, she returned to the Shore to help him with the funeral home business, "He taught me to embalm, and I worked alongside him until he died in 1998, learning all the aspects of running a funeral home," Castro said. "He was my supervisor during my apprenticeship." She earned her license as a funeral service provider from John Tyler Community College. In 2007, she earned her Master's in Divinity from Regent University.

Her father, like four of his six brothers, died of prostate cancer. Castro, who helps families through grief in both of her roles as a pastor and a funeral home director, has had more than her share of sadness. Her brother, Kevin, an outstanding high-school athlete and top-notch student who was named Who's Who among high-school students and eventually earned degrees from Tufts and Johns Hopkins universities, died at 53 after a routine checkup revealed stage-four prostate cancer. "Kevin was convinced he could beat that disease and battled it until he was skin and bones," Castro said. "He would not give up. I guess you could say prostate cancer has been the generational curse of our family."

And then in 2009, she married Eric Webber, who was 6 feet, 5 inches tall and maintained a strict diet and ideal weight for his height. "He had battled diabetes, but he thought he had it controlled, or at least as much as you can control diabetes." Two years later, he died suddenly of a massive heart attack. She keeps the name of her first husband because that is the name of her children and the name her church members knew when she arrived to the charge.

Castro, now 59, was among the youngest of that generation that bridged the gap from segregation to integration on the Eastern Shore. "Integration was slow to come to the Eastern Shore," recalled Castro. "We didn't have full integration until I was in the fifth grade, but my parents sent their younger children to Birdsnest Elementary School several years before that. When everyone came together in the fifth grade, it seemed like first grade all over again with the new classmates."

Castro said the saddest thing for her about the year full integration came to the Shore was that "my very best friend left Birdsnest to attend Broadwater because I imagine her parents didn't know what integration would mean for the public school system."

"It was pretty much all positive," said Castro, thinking about her school years. "I had white friends and black friends, and we all saw each other through our own experiences. At the end of the day, I don't think we saw color all that much."

"Life shapes our attitude," added Castro, "and

it's always a process for us to develop our own viewpoints. I think the younger children handled integration better than the older kids. It seemed my brother, Kevin, only two years older, got in a fight almost every day."

Castro is the same age as Gov. Ralph Northam, who also grew up on the Eastern Shore. She describes him "as a good man." Although she does not know him personally, she has been at the same table with him and has heard him speak a number of times.

"I think he might be a bit naive about racial issues based on some things he has said, but I don't believe he is a racist, and I don't think he should resign," Castro said. "I don't think his past actions, whatever they might have been, shape his politics or policies today. I think talking with more black people will help him understand the issues that have been so much in the news this month."

A year ago, much against her nature, Castro won an election for a position on the school board. "Stephen would have been the type to do something like that, not me, but a member of the board of supervisors convinced me I could contribute. I hope to bring more technology into our school system," said Castro, whose mother was a school teacher and is still in good health at the age of 92.

"We have wonderful conversations," said Castro about her mother, with whom she lives near the funeral home.

There are also fourth-generation members of the Morris family involved in the funeral home. Castro

said both of her daughters help when and where they can from their homes in Virginia Beach. Cristen, 25, who is a CPA, is also studying part-time to be a licensed funeral service provider. Caren's role is limited as the mother of Castro's three grandchildren, a 3-year old and, yes, 1-year-old twins, who just happen to be a boy and a girl.

"I suggested some really easy names for the twins, like Stephen and Stephanie," said Castro with a laugh. "They had other names in mind, but the girl's middle name is Stephanie, and the boy has my mother's maiden name, Fisher, for his middle name."

ton-Accomack Memorial Hospital in Nassawadox and today is a trustee at St. Paul's. "Many of our members feel like they are coming home when attending services here."

"This church is really like your family," said Castro, who recently had discussions with members of the even older St. George's Episcopal Church nearby about having some services together. "It wasn't mentioned directly, but I think the underlying motivation for having joint services is to have a dialogue about what we can do to make the Eastern Shore a better place to live in light of what has transpired recently."

CAPITAL LETTERS

We are wrapping up with legislative business in Richmond and work on the budget by conferees is being completed.

While there has been lots of activity and issues unrelated to legislation during this General Assembly, we were still able to have a successful session and make significant progress on areas of importance to the Shore.

More than half of the bills I filed this year passed both the Senate and the House and are now headed to the governor's desk to be signed into law. These bills include my enabling leg-

islation to codify the recently passed constitutional amendment pertaining to tax exemptions and flooding remediation, legislation to expand CPACE (Commercial Property Assessed Clean Energy) financing to include resiliency and legislation that will incentivize use of the Columbia aquifer. The latter will be particularly beneficial for the Shore, as encouraging use of the Columbia aquifer will aide in the effort to save the Yorktown-Eastover aquifer resources for the highest beneficial use.

Budget work is still being completed by budget conferees and I will use my final column next week to highlight any appropriations or budget language that specifically pertains to the East-

ern Shore and the 6th Senate District. As I've mentioned before, I am hopeful that we will see additional dollars allotted for Virginia Institute for Marine Science (VIMS) to develop and conduct the initial sand modeling study for the Chincoteague Inlet Study, as well as hard-fought funds for my Shoreline Resiliency Fund.

In addition, we should see appropriations for rural broadband expansion and continued funding of critical agricultural best management practices (BMPs). I am confident that the much-needed increase in teacher pay will remain in the final budget and am hopeful that we will see the guidance counselor student-to-counselor ratio appropriation fully funded as well.

As we prepare to wrap up our work in Richmond, we are also gearing up for town halls back home. Please be on the lookout for the announcement for town

halls across the Shore and the district. To provide the most opportunities for residents to attend a town hall, I will be hosting town halls both before and after veto session, which will convene on April 3.

Short sessions are always hectic and chaotic, and this year was no exception. The busy weeks were always brightened by our visitors from home. Thanks to those who were able to make the trip to Richmond and to those who wrote or called over the course of session. We will adjourn sine die (for an indefinite period) Feb. 23, but I encourage everyone to continue to reach out to my office with concerns and questions.

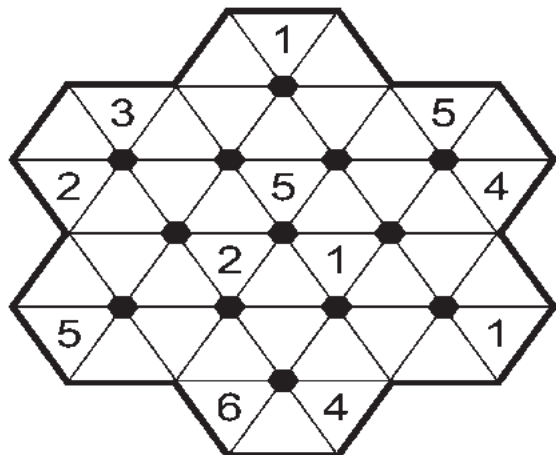

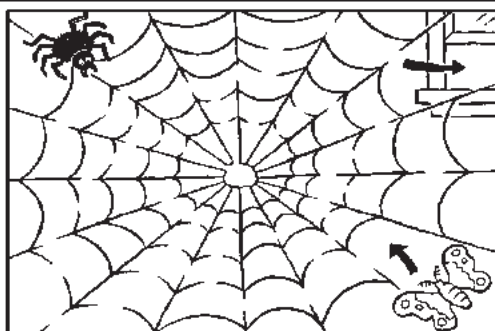

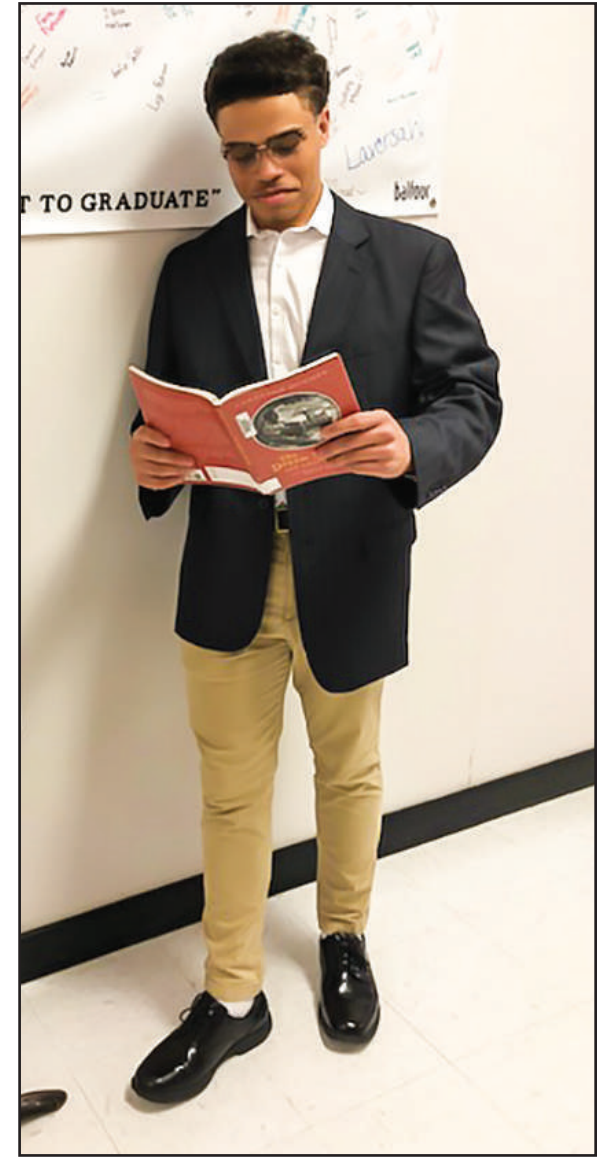
Arcadia High School Students “Wax” Creative for Black History Month

A “soulful” dinner was provided by culinary arts lead, Alyese Justis.

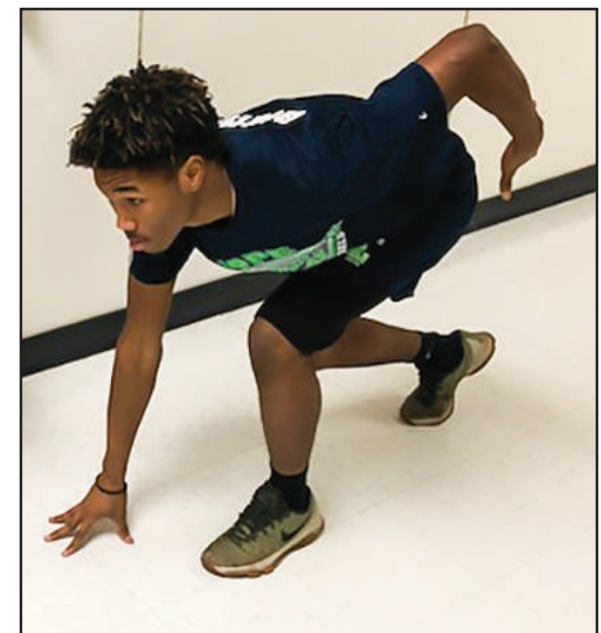
Student Kaylen Wharton also made an appearance as Arthur Ashe.

A TAXING SEASON

We are now approaching tax season, or, depending on your point of view, already in it. Tax season is filled with frauds and misconceptions, all of which operate to disadvantage the consumer. Enumerated below are a few of them to be on the lookout for as part of one's eternal financial vigilance.

If you get an email purporting to be from the IRS, ignore it since it is certainly a scam. The IRS is firmly rooted in the past and never uses email to communicate with the taxpayer. And if such an email has an attachment, do not open it. Or if you open it, do not supply any of the requested information. Failure to observe this red flag will probably result in your bank account(s) being drained.

If you get a phone call purporting to be from the IRS or the Treasury De-

partment, perhaps threatening you with arrest, ignore it since the IRS does not communicate this way either. Better yet, report this scam attempt to local law enforcement so officials can spread the word.

Please do not take a "tax refund anticipation loan" or similar product that is heavily advertised in this season. Between interest and "fees," you will pay an annualized interest rate that approaches triple digits, all for the dubious privilege of getting your refund a few weeks quicker. Speaking of refunds, consider this. You are getting a refund because you probably had too much money withheld over the course of the year. In effect, you loaned the government money and are simply getting it back, without interest. Do you really want to do that? Fill out a new W-4 form with your employer to have less money withheld.

held each paycheck (and more in your pocket each paycheck). Conversely, the new tax law may result in you owing money to the IRS due to some of the major changes. If that is true for your tax return for 2018, adjust your W-4 with your employer to have more withheld so you do not repeat this "sticker shock" next year.

If you get a notice from the IRS after you file that they have already received and processed your return (before you filed your actual return), you are the victim of identity theft. Unfortunately, you will have to now embark on a long and arduous process of straightening this out with the IRS, your credit card companies, etc. It is in your interest to file your return as early as possible, so as to beat any would-be scammer to the punch.

The new tax law makes it less likely that individuals who are not business owners or landlords will item-

ize on their returns, making the return far simpler. If that describes your situation, please try to empower yourself by doing your own return. Don't be intimidated, it is not rocket science, and you'll save some money. And if you do employ a tax preparer or tax preparation service, make sure it is a reputable one as opposed to a "barstool accountant." This is an unregulated field, so be careful. Also, the IRS keeps track of services that are prone to produce "shady" returns, something that could work against you since you are responsible for your return, even if it is prepared and co-signed by somebody else.

As always, it is your money so defend it!

I FOUND 400 YEARS OF MY FAMILY HISTORY AT THE EASTERN SHORE PUBLIC LIBRARY, AND YOU CAN TOO!

Genealogy is fun!

Three years ago I got the genealogy bug and began searching for my father's line within the Floyd family of Virginia. At the time, I only knew of the many exciting stories passed down through family legend and lore about dangerous military exploits in Wales and England and their eventual journeys to America, with many Floyds settling on the Eastern Shore of Virginia.

I hit the genealogy jackpot when I learned of the Eastern Shore Room

in the Eastern Shore Public Library. This room provided almost every resource I needed to get started, but I believe the best resources are the people who work in this room. They showed me how to find every book and reference that I needed in their collection, from 1618 ship manifests to their wonderful online database, "The Miles Files," which lists almost every settler in the area since the 1600s. The library's many invaluable resources include census records, wills, land patents and grants, and a whole lot more.

If the library does not have the reference you need, the staff searches for it in other library holdings around the country for you, often the same day you request it. Once located, the book, article, or relevant copies of the reference will be mailed to the library. This process saves you time, travel, and expense. Throughout my research I never had to physically visit another library.

My three-year library search resulted in self-publishing a book through a www.ancestry.com

program. The book, "The Descendants of Nathaniel Floyd and Reverend Rowland Jones — 400 Years in America 1618-2018," is now part of the library's holdings. Throughout this process I also experienced the fun of finding new relatives on the Eastern Shore. We met, shared stories, swapped old photos, and formed new friendships.

Once you find your ancestors from the Eastern Shore and throughout the United States, you may want to research them prior to migrating here. Library staff can help point you to resources to start you on that search journey, too.

The Eastern Shore Room has books with records that go back many centuries through Europe. I currently visit this room on a regular basis to research my ancestral history in England and Wales. I do this by browsing their many holdings, which include Plantagenet and Magna Carta ancestry and ship passenger lists. They also provide free access to www.ancestry.com online and also guide you to the many global online resources available.

The Eastern Shore Room's vast holdings will eventually be transferred to the upcoming new library's Eastern Shore Regional Library and Heritage Center, and will have much needed

additional room to house many of the currently stored archives.

With the wonderful resources available in this library, you too can find your ancestors, find previously unknown living relatives, and experience the joy of being connected to your family roots, history, and life stories. You may even want to publish your own book!

There is nothing better than homemade chicken and dumplings from the Eastern Shore of Virginia. It is the ultimate comfort food and ranks right up there with corn pudding and clam fritters. Yippee!

I call them slick dumplings and I love them. Editor Connie Morrison makes the puffy-ball kind of dumplings and boasted that one of her children didn't come up for air until eating three bowls during a recent visit.

My mother also made those, which were mighty good, but the rolled-out flat dumplings stole my heart the first time I ate them at Belle Haven School

and I have never recovered.

The Eastern Shore Post's classifieds manager, Angie Crutchley, just calls them dumplings unless she is trying to make it clear that she is not talking about puffy dumplings. Another Perspective on Immigration

I just returned from the Tucson area, having spent five days with friends who are part of Green Valley Samaritans. Like several other Arizona groups, the Samaritans provide food and water stations in the Sonoran Desert, trying to combat the death rate among migrants crossing from Mexico. Providing food and water is all the mercy they can offer without running afoul of the law, and even that is now challenged by the guilty verdict recently issued to four members of the similar group No More Deaths.

The four are convicted of entering and abandoning property (food and water) in the Cabeza Prieta National Wildlife Refuge, a remote area of 800,000 acres on the Arizona/Mexico border. Thirty-two sets of human remains were found in Cabeza Prieta in 2018; 155 border crossers are known to have died there since 2001. Over the entire U.S.-Mexico border, law enforcement has found the remains of about 8,000 migrants who died while crossing since the 1990s. And though illegal border crossings have fallen sharply over the past decade, hundreds of migrants still try. Many die. At least 413 were found dead along the border in 2018, according to a preliminary count by the International Organization for Migration, up from 412 in 2017 and 399 in 2016.

Responding to the guilty verdict, No More Deaths volunteer Catherine Gaffney said, "This verdict challenges not only No More Deaths volunteers, but people of conscience throughout the country. If giving water to someone dying of thirst is illegal, what humanity is left in the law of this country?"

My last day in Arizona, I leave my Samaritan friends and drive west on Arizona Route 86. Five miles west of Tucson, the hilly skyline is studded with saguaro cactus, armed protrusions like plates on a stegosaurus' back. Fifteen miles farther, the vegetation shifts to grasslands and

mesquite. At the Three Points crossroad, I take Arizona 286 south and cross into Buenos Aires National Wildlife Refuge. With the U.S. government largely shut down, there are no Wildlife vehicles on the road, but many Border Patrol, more Border Patrol than civilian cars.

What if a migrant approaches me? Could I refuse him water, knowing he's near death? Would I give her a ride, knowing that's a felony?

I pass through one Border Patrol checkpoint, then another. The officers are polite, helpful. They're just doing their job, but thanks to the shutdown, they're not getting paid.

I turn east onto a dirt road heading toward the Las Guijas Mountains. Half a mile along the potholed road, something scattered under a mesquite tree 30 feet off the road catches my eye.

It's clothing. Sweatpants, a scarf, along with food wrappers, a Magic Marker, a bra. And a backpack. The backpack is patterned in brown, black, and green camouflage. I look inside, check for scorpions. No scorpions, just sand. An empty disposable water bottle, all its wording in Spanish. A brown elastic hair band strung with two black beads, eyebrow tweezers, an eyebrow pencil, a black comb, "Annie" embossed on its spine. A toothbrush, a dental floss holder, floss wrapped on its handle. A tiny tube of toothpaste.

A plastic bag filled with granular white powder. Cocaine? I taste it. Salt. Then something which explains the salt: a plastic pouch labeled "Electrolitos APO. Evita y previene la deshidratación." ("Electrolytes APO. Avoid and prevent dehydration.")

Avoid and prevent dehydration. (Migrants are often in the desert heat for a week.)

Mexican coins totaling 42 pesos. Two dollars and twenty-one cents.

On my return, my hosts show me a child's backpack they found just a hundred yards from their home. Lead-

ers in Green Valley Samaritans, they've found many such backpacks, many such piles of clothing. Their wearers may have been taken into Border Patrol custody; they may have met a prearranged ride to take them farther from the border and ditched their telltale migrant baggage.

I ask about the backpack's contents. Why the focus on cosmetics, the clean teeth, plucked eyebrows? "She needs to look as good as she can to get a job."

This is why the typical migrant comes to our country. Not to smuggle drugs, to steal or rape. She comes for work, and to escape horrendous conditions in her homeland. Spurred by gang violence and the drug trade, the murder rate in the "Northern Triangle" (Guatemala, El Salvador, and Honduras) is ten times that of the U.S. Mexico had a record 33,341 murders last year. Sixty-four percent of Honduras' population lives in poverty. Nearly half of Guatemalan children under age 5 are stunted from poor nutrition.

Many of the same reasons that drove immigrants to America's shores from Ireland and Poland and Italy over the centuries past.
