## Cape Charles Yacht Center Poised for 'Super' Expansion

The Cape Charles Yacht Center is now operated by two business professionals from Maine with a plan to expand the shipyard into a superyacht service and refitting facility, adding as many as 130 new jobs in the next two years.

J.B. Turner and Nicole Jacques, partners in the new venture, both head up businesses based in the bay coast town of Belfast, Maine.

Turner is the co-owner, general manager, and president of Front Street Shipyard, a superyacht marina and

construction and repair center founded in 2011.

Jacques is the owner of Rhumblin Communications, a marketing agency focusing on marine facilities, specializing in increasing market share for existing businesses and launching new businesses into the global market. She currently manages Front Street Shipyard's marketing efforts.

According to a Cape Charles Yacht Center press release, the Cape Charles shipyard was established in 2013 by South Port Investors, a company

owned by local developer Eyre Baldwin, with the expectation of eventually becoming a superyacht facility. With Turner and Jacques onboard, that expectation is set to become reality.

The deal between Baldwin and the Maine business partners was the result of about three years of talks. According to Jacques' recollection, she

# VIMS: Water Quality Data Suggest No Stormwater Impacts from Poultry Houses

*Fecal contamination elevated in all samples;  
highest in areas without poultry operations*

Accomack County folks don't need a study to tell them about the abundance of rainfall in the last year. They lived it. The water has made ponds in our yards. The accompanying mud has clung to our shoes and made its way into our houses. Ditches are full and sometimes overflowing.

If stormwater runoff from chicken houses could be a problem, now would be the time. But the Virginia Institute of Marine Science (VIMS) studied the issue and reported: "in general, the spatial variability in the data for all parameters and the lack of correlation of any high values to poultry sites does not suggest stormwater runoff impacts from poultry operations."

That means the chicken houses are not causing runoff problems. Will it stay like that as the influx of poultry houses age? VIMS says, "Further sampling at these locations will monitor any changes in these water quality parameters as the poultry operations mature, and will help to assess the adequacy of siting regulations to ensure they are protective of the marine resources downstream of these operations."

"High nitrogen values were recovered during all three sampling events at the stream crossing Bobtown Road near the intersection of Hollies Church Road," the report stated. But "no poultry operations are in this watershed. ... For all samples taken in watershed segments containing poultry operations with any chance of receiving runoff or groundwater, no differences were found when compared to watershed segments with no poultry operations."

"Warm-blooded animal or human fecal contamination were generally elevated in all samples, with the highest concentrations occurring in areas not containing poultry operations or litter applications," the report found. "High Fecal indicator counts are common on the Eastern Shore of Virginia and the wooded stream basins and wooded swamps characteristic of ESVA watersheds provide habitat for wildlife

that contributes to these data ... Many homes in the watersheds and (those) close to waterways have drain fields with a potential to add fecal loads to the stream flow. Outhouses and cesspools are known to exist but were not located or surveyed in the study."

Zoning permits have been authorized for 240 poultry houses since July 1, 2014, in Accomack County. Fifteen more houses are proposed and pending. The county's planning staff estimates that 284 houses existed before that time.

"Historically speaking, the majority of the poultry houses in the county were located north of Parksley," the report stated. "Since 2014, a significant number of new poultry houses have been located south of Parksley." The report states, "It is not entirely surprising that concerns are being raised given the relatively small number of poultry houses that existed in the southern part of the County prior to 2014."

The report boasts that the county amended its zoning ordinance in February 2016 "to tighten regulations regarding confined poultry operations" and received expert advice from the health department regarding the updates.

"Another notable ordinance amendment occurred in July 2017 when the county removed the possibility of new poultry houses being constructed in residential and general business zoned areas," the poultry report states.

Groundwater withdrawal has also gotten a lot of attention with permits from the state Department of Environmental Quality (DEQ) being required for those withdrawing 300,000 gallons of water a month or more.

"A groundwater withdraw number of 3.1 million gallons per day was widely circulated throughout the community," the recent county poultry report stated.

“The 3.1 million-gallon per day withdraw was an estimate for all poultry houses that have a Virginia Pol-

lution Abatement Permit from DEQ. The 3.1 million gallon number does not reflect projected actual usage and is approximately 37 percent higher than the high range of staff estimates for usage.”

The staff estimated drinking and cooling needs per poultry house at “70,950 gallons per month – Low Range; 81,625 gallons per month – Mid Range; 152,875 gallons per month – High Range.”

“Each poultry farm’s stormwater management system has been designed to make sure that the peak flow rate leaving the developed site will be less than or equal to the peak flow rate in the pre-developed condition,” the report noted.

Still, in the last year, DEQ determined 54 poultry operations need groundwater withdrawal permits.

The economic impact from Perdue and Tyson processing plants was also included in the county report. Payroll figures presented to the county board of supervisors in January 2016 was \$121,251,000. “The local economy also benefits from the poultry industry with employment and payroll” of “poultry growers and farm workers, truck drivers, grain elevators, and grain farmers.”

The report also noted future items to consider and monitor are “ammonia and airborne particulates,

groundwater withdraw regulation and law modification relative to the Columbia aquifer, buffer effectiveness, personal property taxes, and groundwater withdraw.”

The county report also states “two of the recently constructed poultry operations are utilizing the surficial Columbia aquifer for some of their water supply.” This upper aquifer was recommended by the local groundwater board for use as the deeper aquifer replenishes at a much slower rate.

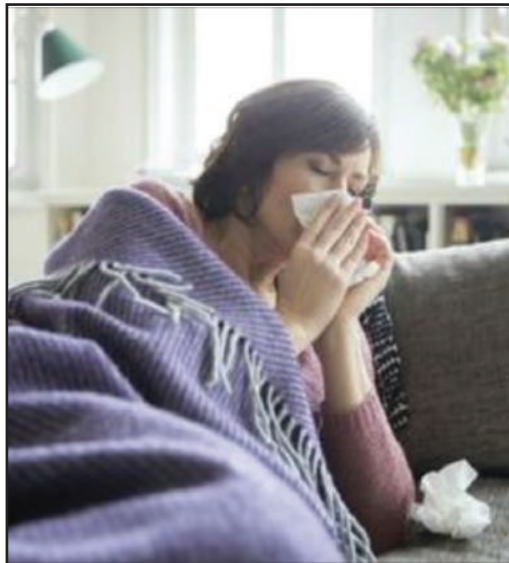

# Millions of County Dollars at Stake With 2020 Census Count

Bill O' Hare, a professional demographer from Cape Charles, informed Northampton supervisors Tuesday that when the county participates in the 2020 U.S. Census, if the count misses 1 percent of the population, or 120 people, it would mean a loss of \$7 million in federal funding over a 10-year period.

The U.S. Census is mandated by the U.S. Constitution and has been conducted every 10 years since 1790.

It's a "large and complex operation" and some people are unintentionally missed, O'Hare said. He spoke to raise awareness and request help in ensuring Northampton's population is accurately counted next April.

Census numbers are used to calculate how much funding states and localities can receive from federal government agencies.

Virginia received about \$17.7 bil-

lion in federal funds in 2016. O'Hare estimates the federal government will give state and localities about \$26 trillion in the decade following the 2020 census. An accurate count will ensure Northampton County gets its fair share of those funds.

O'Hare's credentials include more than 40 years of experience with census data and service on the 2000 and 2010 Census Advisory Committees. Currently, he is a Census Bureau consultant to the Leadership Conference on Civil and Human Rights.

The conference considers the 2020 census a civil and human rights issue because historically, racial minorities, rural and low-income families, and young children are among the groups most often missed during the census.

Preschool children, ages 4 and under, are the most undercounted group, O'Hare said.

People who live in blended families, multi-generational households, nontraditional housing, or are homeless are also considered hard to count, he said.

O'Hare initially requested supervisors join a committee dedicated to a complete count in Northampton on the 2020 census.

Spencer Murray, the chairman of the board of supervisors, referred O'Hare

to County Administrator Charlie Kolkowski for assistance.

"This is a revelation for me," Supervisor John Coker said. He guessed up to 80 percent of Northampton residents are unaware of the effect of the census on the county's federal funding opportunities.

"We need to make sure everybody in this county knows that they need to be counted."

## Painter Woman Dies in Princess Anne Crash

A young Accomack County woman was killed in a traffic accident in Princess Anne, Md., early Tuesday morning, according to Maryland police.

Courtaja Antrice Duncan, 19, of Painter, had been driving alone in the vehicle and was discovered by a trooper who came upon the crash.

At about 1:35 a.m., March 12, the officer was patrolling the intersection of Route 13 and Stewart Neck Road in Somerset County, Md., and found a white Dodge Magnum, which dis-

played a Maryland license plate, had been southbound on Route 13, and for an undetermined reason left the road, and struck the heavily wooded portion of the median. The cause of the crash has not been determined, according to Duty Officer Ron Synder.

A Maryland State Police reconstructionist was called to take over the investigation. The Chief Medical Examiner's Office and the State Highway Administration also assisted. The Accomack County Sheriff's Office notified the woman's parents, Maryland authorities stated.

and Turner first met Baldwin in Florida at the Fort Lauderdale International Boat Show, when Baldwin approached Turner for ideas about how to make the yacht center more successful.

“We identified Cape Charles Yacht Center as an ideal location for superyacht services because it’s central for vessels traveling along the East Coast between New England and Florida,” Turner said.

“For years we’ve encouraged our customers at Front Street Shipyard to stop into Cape Charles when traveling south, and their feedback has been very positive about the location, quality of service, and amenities.”

Cape Charles Yacht Center boasts an 18-foot-deep channel, 1,000 feet of face dockage, and a 75-ton boat lift. It can accommodate yachts up to 200 feet long.

Its modern marina has both 30/50-amp single-phase power and 100-amp three-phase power. It offers shower and laundry facilities and a lounge area for ships’ crew members.

In addition to its central location

on the East Coast, the Cape Charles Yacht Center is a short distance from downtown Cape Charles and its dining, shopping, and entertainment options, as well as the Bay Creek resort and golf course.

“We intend to maintain Cape Charles Yacht Center’s great reputation for service among their existing customers throughout the Chesapeake,” Jacques said.

“Our first initiative is to grow the yard’s talented workforce and equip them with more modern equipment so we can attract additional international vessels seeking service and major refits.”

The expansion plan includes constructing additional floating docks, acquiring a 600-ton mobile boat lift, and constructing a 30,000-square-foot service building that will accommodate the new lift.

The yacht center will remain in full operation during the expansion and is in development as a full-service shipyard for not just superyachts, but also recreational boats and commercial vessels.

The entire expansion, including construction of the 30,000-square-foot building, is expected to be finished in

2021. Currently, a smaller, four-bay service building is being built across the street from the yacht center’s main entrance on Bayshore Road.

Jacques said she and her business partner live and work in Maine full time, but they will stay deeply involved in the Cape Charles Yacht Center. They visit Cape Charles twice a month, and when they’re not in town they stay connected through video chat, email, and phone calls with the “great group of people” at the yacht center: office manager Renee Rice, dockmaster Rob Maguire, and service manager George Baker.

The yacht center currently has about 10 employees, but there may be as many as 140 by the time the business expansion is completed in 2021. The yacht center will be hiring riggers, mechanics, electricians, and carpenters. All previous experience will be considered – for example, if a mechanic has worked on cars and trucks but not boats.

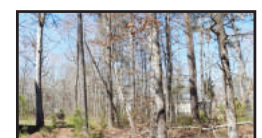

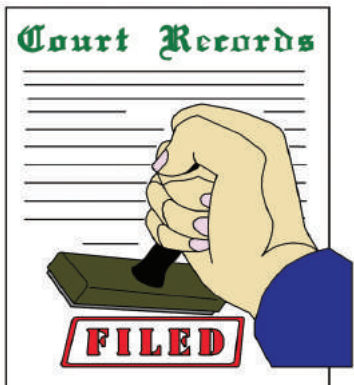

## Navy Engineer Pleads Guilty to Break-Ins

A Navy engineer pleaded guilty last week in Accomack Circuit Court to seven felony charges including burglarizing two local pharmacies.

Cole Kambarn Conklin, 29, of Mad-dox Boulevard on Chincoteague, waived going before a grand jury and admitted to two counts of burglary, grand larceny, possession of Adderall, possession of hydrocodone, possession of burglary tools, and property destruction. The crimes included breaking into H&H Pharmacy in Oak Hall on Jan. 11 and stealing property, and breaking into Walgreen's in Onley on Jan. 16 while possessing burglary tools and damaging property.

Conklin is being evaluated for a community corrections alternative program. A presentence report was ordered. Conklin is in Accomack Jail.

In another case, judgment was withheld for Elvis Northam, 61, of Nock's Landing Road in Atlantic. The case will be considered in a year in accordance with the first offender statute. Northam was charged with possession of cocaine in connection with a Sept. 28, 2018, incident. He pleaded guilty to the offense.

A count of grand larceny was dismissed against David Brian Holland III, 23, of Sheephouse Road in Pocomoke City, Md. He pleaded not guilty to Oct. 19, 2016, charge, which involved stealing property belonging to Dan Luu.

## Oyster Thefts

Three Accomack county men were charged recently with felony theft of state-owned oysters, according to records filed in the county's general district court.

Wesley Lamont Hodge, 45, of Dutchess Court in Mears, was charged with stealing planted oysters worth more than \$500 belonging to Virginia, unlawfully taking or catching oysters, and transporting an oyster dredge or equipment between Jan. 18 and 19. Hodge was arrested Feb. 21. A preliminary hearing was scheduled for May 6. An unsecured bond was set at \$5,000. The charges were brought by Officer Marshall B. Reedy of the Virginia Marine Police (VMP).

Keith James Martin, 47, of Keith's Lane on Saxis, and Gary Joseph Fleig, 43, of Savan-

nah Road in Hallwood, were charged with transporting the dredge and two counts of stealing oysters between Jan 18 and 19. They were also accused of transporting the dredge and stealing oysters on Feb. 1. An unsecured bond of \$6,000 was set for Martin. Fleig's bond was set at \$5,500. Fleig was arrested Feb. 20. Officer Allen Marshall, of VMP, investigated.

In another case, Robert Michael Selby Jr., 22, of Center Street in Onancock, is accused of possessing a Schedule I or II drug on March 8. He is being held without bond in Accomack Jail and is also wanted in Maryland on forgery and theft charges. Trooper B. M. Tripp investigated.

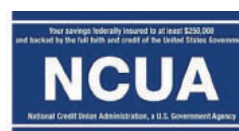

## Court: Bloxom Man Exploited Incapacitated Person

A Bloxom man was convicted Wednesday in Accomack Circuit Court of six counts of financially exploiting a mentally incapacitated person.

Keith Earl Carver, 54, of Shoremain Drive, pleaded not guilty to the charges. He contended that he was friends with Ricky Burford, 68, a retired teacher who is Carver's wife's cousin, and was only trying to help the man when he withdrew a total of \$4,800 from Burford's bank account in May and June 2018. Carver lives with his wife in Burford's former salon and flower shop.

Carver said he used Burford's ATM card to get money out at Royal Farms in Onley and Parksley as Burford instructed. The six ATM visits included multiple withdrawals each time and occurred May 28 and 29 and June 3, 5, 9, and 12.

Terry Lynn Carver, 63, the defendant's wife, was also charged with the crimes but due to a lack of evidence Assistant Commonwealth's Attorney Elizabeth Wolff did not prosecute her. As Terry Carver, and her lawyer, Patrick Robbins, were leaving the defense table, Judge H. Thomas Padrick Jr. said the charges could be brought back up against her later.

Padrick ordered a presentence report for Keith Carver and allowed him to remain free on bond. A date was not set for sentencing. Videos of Carver using the ATM machines were shown during the trial.

At first, the judge would not allow defense lawyer Allan Zaleski to call Burford to the stand, saying that Burford was not competent to testify.

Dr. Robert Paschall, a neurologist, reported that on May 15, 2018, he determined Burford was incompetent due to progressive vascular dementia. Paschall said Burford had "too numerous to count" small strokes that had an adverse effect on his "memory, insight, and reasoning capabilities" and suffered from "a fixed delusional belief system ... It is progressive, irreversible and will only, stepwise, get worse," the doctor said. Paschall has been treating Burford for about 15 years. Burford "did not know the purpose of his visit" when Paschall made the determination, the witness testified.

Last August, the court also formally declared Burford to be incompetent and ordered Jewish Family Service to act as his caretaker.

Eventually, the judge allowed Bur-

ford to take the stand. "I make my own money," Burford said. "Mr. Carver, he's been like a brother to me." Burford said he was in the car when Carver would get money from his account. "He gave me the money exactly," Burford said, agreeing that Carver would hand it over and Burford would count it. "I would give them (the Carvers) some because I knew they didn't have any. I would pay for groceries." He said he would sometimes give them \$20. "I trust him 100 percent. Wish I could trust the world like that."

"We got to be real good friends," Carver said. "His niece was supposed to take care of him. We went everywhere together. He was never getting out of the house ... He can drive, but he don't drive ... I took him everywhere he wanted to go. I was his ride ... We went to Ocean City (Md.) one time. He wanted Thrasher French fries, walked on the boardwalk ... He bought nine or 10 buckets of caramel corn and we delivered it (to Burford's friends) on the way back ... One time he gave his niece's daughter \$300 or \$400 to go back to college."

"Why did it stop?" the judge asked. "His niece had his money cut off," Carver said. "She had him cut off."

Connie Burford, who also lives on Shoremain Drive in Bloxom, said for about 20 years, she helped her uncle with his businesses, took care of his finances, paid his bills, took him to doctor's appointments and the grocery store and to run other errands. She said she was the caretaker for both her son and her uncle. The only time he wanted cash was to go out to eat Chinese food on Friday nights, she said.

"Rarely did he use a lot of cash," she added. "My uncle was a very frugal person." She said after the Carvers moved into the building, "they were in the house a lot. They would take him out early in the morning. He was not eating properly and not taking his medicine. They were not concerned." Connie Burford said her uncle is a diabetic and would become incoherent.

She said she had the power of attorney for her uncle but the Carver's took him to a lawyer to get that revoked.

Selena Coulbourne, of the county department of social services, said after receiving a complaint of adult financial exploitation, she talked to Carver. On May 24, Carver told her he was aware that it was being said Burford was incapacitated. But he didn't believe it. "He stated that he would continue to take Ricky to the bank anytime he asked him," Coulbourne said.

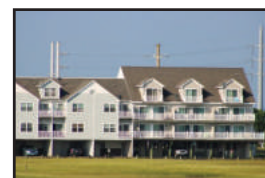

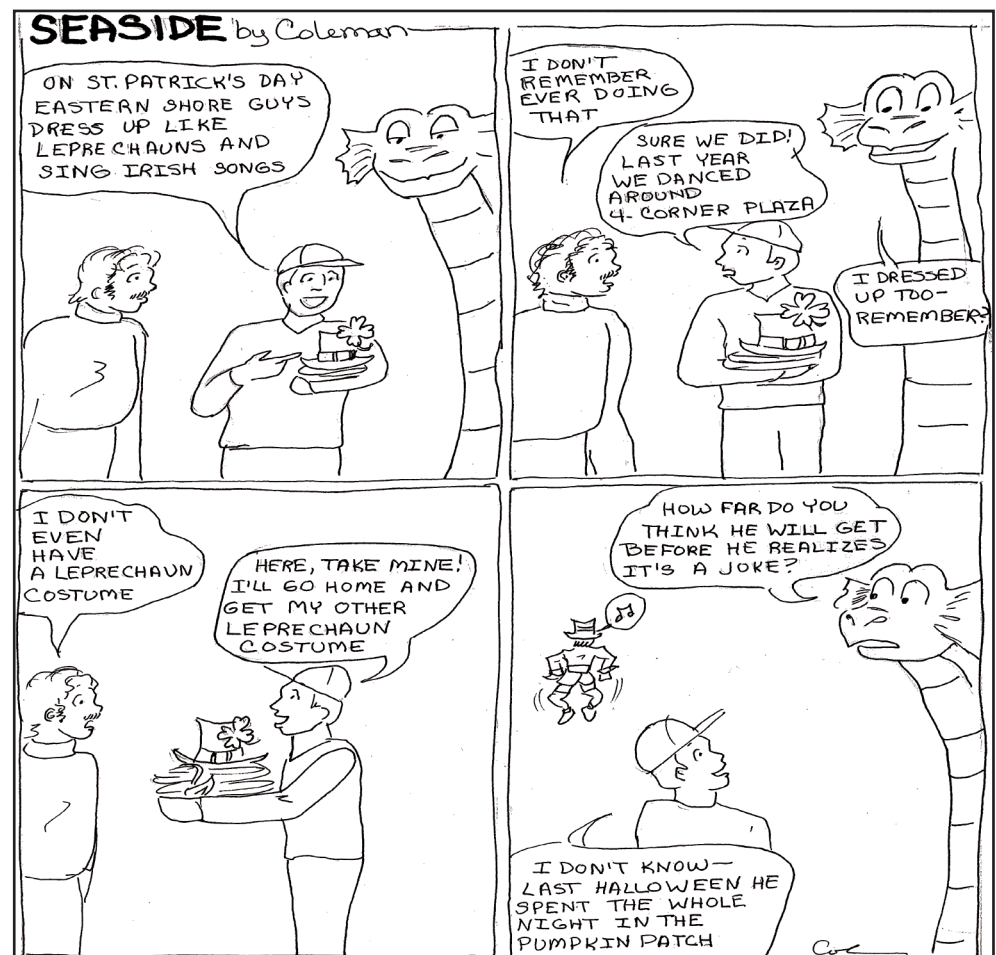

# Spencer Murray Will Not Seek Re-Election to Board of Supervisors

Spencer Murray, chairman of the Northampton board of supervisors, announced Tuesday night that he will not run for re-election this November.

“While I will always support Northampton County, I plan to pursue the life I promised myself over 50 years ago when I started to work,” Murray said in a prepared statement.

He decided to make the announcement Tuesday so his fellow citizens would have time to consider seeking the office and getting on the ballot. Murray represents Northampton’s fourth voting district, which includes the town of Eastville.

Supervisor Robert Duer also is not seeking re-election. Supervisors John Coker and David Fauber began four-year terms in 2018 and are not up for re-election.

It’s possible that all but one of Northampton’s five supervisors will start 2020 on the board with two years of experience or less.

Supervisor Oliver Bennett is the exception. By the end of 2019 he will have 18 years of experience. He has

served on the board from 1996 through 2003 and from 2010 to present.

Murray will leave with eight years as a supervisor under his belt. He served from 2008 through 2011 and returned for a second term in 2016 after attending to a prolonged illness in the family.

“I certainly did not accomplish everything I wanted,” Murray said in an interview with the Eastern Shore Post Wednesday, but until the end of 2019 he intends to remain focused on the board’s current initiatives.

“Largely, my first term was consumed with the new 2009 comprehensive plan that was adopted, but hopefully that plan will be revised by year end 2019, and a new zoning review and consolidation will follow shortly after that,” he said.

Since Riverside Shore Memorial Hospital relocated to Accomack two years ago, Murray has advocated for an urgent care facility in Northampton. It has not yet come to fruition, but Murray is confident that, “when financially feasible, Northampton should have a satellite emergency room to

which our ambulances can transport.”

Northampton’s new courthouse and jail were built before Murray became a supervisor, but he was on the board that worked out of the former Northampton Middle School while the new administration building was under construction.

His second term has focused on “building an experienced county staff while holding taxes flat.”

Since his re-election, Murray has supported renovations in Eastville—the county seat, further development of existing Northampton businesses and the addition of new ones, including resorts, hotels, and restaurants, and construction of the Eastville Community Health Center.

He believes the working relationship between the county and its towns has improved, calling them “two halves of the same hinge” that “clearly need to work together if we are to move forward.”

Murray is part of the team from Northampton and Accomack that restructured the Eastern Shore’s short line railroad and is working with the

Cape Charles town council on a new “economic engine” for the Cape Charles rail yard that will benefit both counties.

He will leave as supervisors face “a ton of new challenges,” including housing, wastewater treatment—particularly in Exmore and Nassawadox—funding improvements and maintenance at Northampton public schools, supporting working watermen, and “expanding revenues wherever we can.”

“I enjoyed very much the working relationship that I have today with my fellow supervisors who also love Northampton County and serve diligently,” he said.

Murray’s first advice for his future replacement is “listen and learn.” County supervisors must make decisions that impact people’s lives, and “hopefully, the impact, for the most part, is in a good direction.”

“The responsibilities are very, very serious and only serious-minded, dedicated people willing to spend the time and energy need to take it on,” he said.

“I remain very optimistic for Northampton and its future.”

# Ronnie Holden in the Ring for District 8 School Board Seat

Ronnie E. Holden will seek election to the District 8 seat on the Accomack County School Board in November. The retired University of Maryland Eastern Shore administrator has served on the board in an appointed position for about 28 years. This will be the first election for school board members since a referendum to change the way board members are selected was approved by voters nearly two years ago.

Holden is a native of the Shore and describes himself as a “product of the Accomack County Public School System.” He also got an associate degree in business administration from the Eastern Shore Community College, a bachelor’s degree in accounting from Virginia Tech, an MBA from Salisbury University, and a doctorate in education from the University of Maryland College Park.

He holds the vice chairman’s spot on the board but has also served as chairman several times. In a prepared statement, Holden said during his time on the board four elementary schools and two middle schools were built and two 1960s elementary schools were renovated. He also took credit for being instru-

mental in recommending that a division swim team be formed and that upgrades to several schools be made. “During his tenure, the academic and student service enhancements have been continually made to ensure the maximum support for all students and enabling the accreditation of all schools,” the statement said.

“My experience, education, and professional demeanor will continue to be an asset to the Accomack County School Board, and will continue to allow me to serve my community,” Holden said.

Holden retired in 2014 after 37.5 years at the University of Maryland Eastern Shore. He started there as an accountant in charge of the Office of Student Accounts. He later served as budget analyst, acting comptroller/business manager, budget director, and assistant vice president for administrative affairs. He was appointed vice president for administrative affairs in 1986. In this position, he said he was the chief financial officer, which managed a 140-plus million-dollar budget and provided oversight to 14 institutional departments. During his tenure at the university, he saw the school grow from having about 800 students to more than 4,500. He said

he had a major role in the growth from less than 400,000 square feet to more than 1.9 million square feet. “Under his leadership, more than \$700 million in capital construction projects were completed,” the statement continued. “The university was named the second most beautifully landscaped campus in America for two consecutive years in a row.”

Holden is a former member of the Eastern Shore Community College Foundation Board, has an endowment scholarship at the community college and at the University of Maryland Eastern Shore for local students. He served on the board of directors for the Village of Hope, a nonprofit shelter for women and children; the Executive Committee of the Business Council for the Association of Public and Land-Grant Universities; the Maryland State Chamber of Commerce; the National Association of College and University Business Officers; the National Association of College and University Auxiliary Services; and College and University Personnel Officers. He was an executive of Boy Scouts Troop 305, Cub Scout Pack 305, and Ventures 305.

He is the Sire Archon for Gamma Theta Boule of Sigma Pi Phi Fraternity,

Inc., a life member of Alpha Phi Alpha Fraternity Inc., and a member of the Virginia School Board Association, Minority Leadership Round-Table, and Eastern Shore Men’s Outreach. He is also a member of Jerusalem Baptist Church, in Temperanceville, where he serves as a deacon and on several auxiliary services.

Holden and his wife, Brenda, live in Onley. They have four adult children and manage a residential rental business.

This is Del. Rob Bloxom with this week's 2019 Virginia General Assembly Capitol report. This week's topic is the question of Virginia ratifying the so-called "Equal Rights Amendment" (ERA). Let me start by saying, everyone agrees men and women deserve equal rights. These rights are already guaranteed with the Fifth and Fourteenth amendments to the U.S. Constitution. Equal pay for equal work is a federal law that has been in place since the mid-1970s.

When it comes to the ERA, the deadline, which was in 1982, has long passed for the states to ratify the amendment. Voting for this would have no real significance, except for the likelihood that multiple court cases would ensue costing taxpayers millions of dollars.

After going through the normal committee process, like every other piece of legislation does, the legislation was voted down meaning the ERA was effectively dead for the year. However, at the 11th hour of the session, a number of freshman Democrats tried to change the rules and bypass the committee structure. No matter which way I vote on an issue, I will not forego the rules of the House of Delegates, just to get my way. This is truly a Washington-style play that has not served our country well. To that end, the vote that actually came to the floor for consideration was to change the rules. I voted against changing the rules of the House.

Looking at the evidence, I believe the ERA would hurt women, and let me explain why. Should the ERA be passed

in Virginia, many of our laws and regulations would likely become unconstitutional. For example, the ERA in other states has prevented states from placing restrictions on late-term abortions. The exact language the ERA resolution uses is the same language used in Alaska, New Mexico, and Connecticut's constitutional ERA amendment. Courts ruled in those states that taxpayer money could be used to fund abortions and that states could not prohibit late-term abortions. Why? Because since abortions are something only women can have, the states could not pass a law that was solely directed at women.

Truthfully, this renewed push for the passage of the ERA is driven by groups like Planned Parenthood and the National Association for the Repeal of Abortion Laws (NARAL) to increase access to late-term taxpayer funded abortions.

Other impacts from the ERA include the elimination of the Violence Against Women Act, Title 9 Sports Equalization, and the preferential treatment of women in government business contracts because all of these would be considered unconstitutional. In addition to these, women could become eligible for military draft.

For me, what it simply came down to was I was not willing to take the risk of having a court decide that residents of Virginia be forced to fund late-term abortions with their tax dollars.

# Northampton Historic Preservation Society To Document Historic Jails

The Northampton Historic Preservation Society has persevered in educating the public and saving the history of the 1700s and 1800s, whether it means looking beyond the county for funding or accomplishing its goals by more creative means.

The group recently received a \$3,000 grant from Virginia Humanities to produce a documentary on the jails that have stood on the historic courthouse green in Eastville, the county seat.

Virginia Humanities is the state humanities council, based in Charlottesville, Va., about 200 miles from Eastville. The council is one of 56 created by the National Endowment for the Humanities, with the mission that it “connects people and ideas to inspire cultural engagement and deepen mutual understanding.”

The historic society’s documentary will focus particularly on the 1914 Northampton County jail that was demolished in December 2017. Its cell doors featured unique locking mechanisms, similar to those used at Alca-

traz and the Indiana jail where John Dillinger was incarcerated.

The locking mechanisms were once considered cutting edge technology, allowing one to three doors to be opened either together or separately.

When contractors submitted bids in the fall of 2017 for the jail’s demolition, Joyce Kappeler, then president of the historic society, was prompted to ask county supervisors for funding to remove cell doors and other historic artifacts from the building.

The Northampton board of supervisors had donated money for historic preservation in the past. For example, in the 1950s, the board contributed funds to repair and refurbish the 1731 courthouse, the old clerk’s office, and the old debtor’s prison, according to historian Frances Bibbins Latimer.

But in 2017, Kappeler’s request for funding was turned down, with supervisors citing financial hardships such as “teachers to pay” and “schools to build.”

Reportedly, a local welder had volunteered his services to the historic so-

ciety, but that plan also fell through.

But none of that stopped the historic society. Mike Ash, its current president and a past member, took the initiative to show up in person at the jail demolition site, and he discovered the contractor was happy to help the historic society’s cause. The main door to the jail cell block was lifted with a crane and placed directly on a truck to haul it away to safety.

That and other salvaged items, like a dumbwaiter that transported food from the kitchen to the third floor, remain in storage in Eastville’s historic district, awaiting restoration of the 1907 jail, where the historic society hopes the artifacts eventually will be displayed.

The 1907 jail is one of five historic buildings still standing on Eastville Court Green, with the 1899 courthouse that now serves as the county’s administration building, the circa 1814 debtor’s prison, the 1800 clerk’s office, and the 1731 courthouse.

The historic society decided to produce the jail documentary on the advice of historical architecture expert

Carl Lounsbury, who retired from the Colonial Williamsburg Foundation.

The documentary is the second in a series of three. It was preceded by a film about Pear Valley, a circa 1740 planter’s cottage in Eastville and an example of early Chesapeake architecture.

Originally known as the Northampton County branch of Preservation Virginia, the historic society maintained Pear Valley for Preservation Virginia since 1986. In 2013, the Northampton Historic Preservation Society got its current name and became an independent nonprofit. In 2014, it received the deed to Pear Valley from Preservation Virginia.

The third documentary will cover the Eyreville archaeological dig site, near Eastville.

A film premiere will be scheduled for the jail documentary later this year.

The historic society will continue its popular Lecture on the Lawn series this spring, with two events scheduled in June – a lecture at the Cessford plantation house on Courthouse Road, and a walking tour of Willow Oak Road, both in Eastville.

### **Trade Conference Highlights Winter of Discontent, Hope for Spring**

Speakers' remarks evoked a mix of hope and frustration at the 11th annual Virginia Governor's Conference on Agricultural Trade. The event was held March 5 in Richmond and drew more than 300 participants, including representatives from 15 foreign embassies.

Gov. Ralph Northam made brief luncheon remarks, reporting that, as of November 2018, Virginia farm and forestry exports for the year were valued at \$2.7 billion, which represents a 16 percent increase over exports for all of 2017.

He added that agricultural and forestry exports account for more than half of containerized cargo moving through The Port of Virginia, and that in 2018 the Virginia Department of Agriculture and Consumer Services helped more than 290 companies with their international marketing efforts.

Zhu Hong, minister for commercial affairs at the Chinese embassy, expressed hope that trade tensions between the U.S. and China will be amicably resolved, emphasizing, "We need to get back to normal."

He noted that China is not able to

provide all the foods its citizens need or desire, because many parts of the country's open land is not arable. Growing demand for protein foods poses an additional challenge. On a basic level, Zhu said, "we are feeding one-fifth of the world population with only 7 percent of the world's arable land."

Chinese and U.S. negotiators are engaged in talks to end a trade war and retaliatory tariffs, and Zhu said he is "personally optimistic that the trade dispute will finally get resolved" adding that "Chinese people need Virginia pork products, Virginia poultry, Virginia corn, Virginia soybeans" and other commodities.

China was the second-largest market for Virginia ag exports in 2017, with the state's exports to China valued at \$1.72 billion.

Ambassador Gregg Doud, chief U.S. agriculture negotiator, said, "It isn't that we're trying to impose our will on other countries" like China with tariffs, but "if we're going to trade roughly the same amount of product back and forth, the tariff has to be the same" for both players.

He also said the Chinese market should be open to many more U.S. products at which China historically has balked. "Yes, they buy soybeans, but look at all the other things that we ought to be able to sell to China. ... They're already importing it from other countries."

Updates on trade relations between the U.S. and the European Union, as well as the United States-Mexico-Canada Agreement, were part of the conference agenda as well.

Assessing trade disruptions over the past year, two commodity association officials said a second disrupted year will be even more trying for producers.

"It's going to be a difficult year," said Maria Zieba, director of international affairs for the National Pork Producers Council. She said that or-



ganization is focusing on broadening the global market for U.S. pork.

"We actually export more to the 20 countries with which we have a free trade agreement than to the rest of the world," Zieba said, adding later that the council "would love to have a free trade agreement with the Japanese."

Bret Davis, secretary of the American Soybean Association, told conference participants that every third row of soybeans grown in the U.S. was exported to China until recently. The past year has been a reminder, he said, "that you can't put all your eggs in one basket."

Fair trade conditions will be key in resolving the dispute with China, Davis said, but the nation's soybean growers need an agreement that will last. "We've got basically four year of carryover (surplus soybeans) sitting here in the United States that we need to get rid of."

### **Farmers Ask for Flexible Livestock Hauling Regulations**

Virginia farmers are asking the U.S. Department of Transportation to consider the unique circumstances of transporting live animals over long distances, and amend regulations for farmers and other drivers hauling livestock.

Current DOT regulations limit drive time for livestock haulers to 11 hours and limit on-duty hours to 14. But many farmers transport their cattle and other animals across several states to deliver them, making it extremely difficult to meet DOT standards while adhering to animal welfare standards.

Ben Rowe, national affairs coordinator for Virginia Farm Bureau, said that organization's producer members "believe that the 11- and 14-hour rules were not draft-

ed with livestock haulers in mind and thus do not accommodate the unique character of their loads and nature of their trips."

Animal welfare, he noted "is priority No. 1 while hauling livestock. Livestock trailers are designed to keep animals comfortable while in transport, not sitting by the side of the road for hours. Industry guidelines mandate that drivers avoid any stops while hauling livestock, especially in warmer weather. Unloading animals to take a mandatory rest break is not only impractical but also increases stress on the animals.

"There are very few cattle pens available on or near interstate highways. Frankly, it's safer for the animals to make the trip nonstop, provided they are in good health and have a driver with a good safety record who has completed fatigue management training."

Farm Bureau has submitted formal comments on the regulations to the Department of Transportation and is urging its producer members to make their own comments before March 8. Their request is to allow a small set of drivers, specifically farmer-owners and animal haulers, to be able to drive through the 16th hour after coming on duty and drive a total of 15 hours during the 16-hour period before stopping for a rest.

The current DOT drive time restrictions were announced last year and were controversial among farmers, so much so that Sens. John Hoeven of North Dakota and Michael Bennet of Colorado have introduced a bill to address farmer concerns. The Modernizing Agricultural Transportation Act would reform the hours of service and electronic logging device regulations and delay enforcement of the electronic logging regulations until a working group develops more satisfactory guidelines for the safe and humane transport of livestock.

"Whether the DOT takes our concerns to heart, or the new bill makes changes, farmers need reform," Rowe said. "Our producers, especially in Southwest Virginia cattle country, feel they're being squeezed by these new trucking hours of duty regulations."

# Global Performer Finds Opportunity and Satisfaction on Local Stage

Local performer Ashley Aigner Antunes' life could be the script for a Broadway show.

Dance training led her to Virginia Ballet Theatre, the Richmond Ballet, Interlochen, the Governor's School for The Visual and Performing Arts, and American Dance Festival, New York.

She lived in Vermont, fell in love, and moved to Brazil for a time. When she, her husband, Lucas, and daughter, Tulipa, moved back to the states, they wanted to be close to family, so they chose the Eastern Shore.

To her surprise, she was able to fulfill her professional aspirations here. Like Dorothy in "The Wizard of Oz," she found everything she needed in the place she started.

She says things have changed between the time she left for college in 2004 and when she moved back to Locustville full time in 2011. Specifically, there is a new, healthy vibe in the arts community. "There are professional opportunities for performers here on the Shore," she said. "Paying opportunities."

"I'm lucky enough to have found jobs that support my passion and (allow me) to be close to home," she said.

Antunes is assistant director of Eastern Shore's Own Arts Center, better known as ESO, in Belle Haven and also teaches there and at North Street Playhouse. And when the Onancock theater mounts a large-scale production, Antunes is there either in a lead role, as with the upcoming "Dames at Sea," or as part of the ensemble cast, as she was with "Young Frankenstein" and "Rent."

It's what she and fellow artist Mary Stiegelbauer dreamed of as young dancers. "When we were kids, this is what we were trying to do. It's great to be 'playing with Mary,'" said Antunes.

"Ashley was in the very first ballet I ever choreographed at North Street," said Stiegelbauer, who was 11 years old at the time. Antunes was 13 years old.

"So when I say, 'I'm home,'" Antunes gestures toward the stage and Stiegelbauer as if to say, "I'm home."

Now the two are working together professionally on "Dames at Sea," a musical comedy set in the 1930s.

"It's all laughs, light entertainment (with) 30s style musical songs," said director Sally Stuart. "This is a very funny take on that era. ... Lots of

big numbers brilliantly staged by Emily." Staging and choreography are by Emily Price.

In this homage to musicals of the Depression era, fresh-faced Ruby from Utah comes to Broadway to make it big. But she is just a chorus girl and the

show's diva, Mona, isn't going anywhere. When the theater is torn down hours before showtime, a new venue must be found. Dick, a sailor and wannabe songwriter, just might have the answer but the solution brings its own set of complications that could give Ruby her big break.

"It's a huge tap show," added associate producer and production stage manager Stiegelbauer. "These musicals in the 30s (were) a way to escape the Depression."

"The tap dancing is going to blow people's minds," said Price. "You don't get to see tap dancing anymore."

An avowed tap dance fiend, Price began teaching North Street Playhouse interns last summer when she was part of the cast for "Kiss Me, Kate." That extra attention is paying dividends as three of the interns – Nate Downing,

Katie Higgins, and Meg Morrison – are building on their earlier tap experience to fill ensemble cast roles. Another intern, Nikki Drewer, is gaining experience as assistant stage manager.

Antunes will take the stage as diva Mona Kent. "I'm so grateful to be here and to be playing a lead role," she said. "That's something I haven't done in a long time." The character has an elaborate period-appropriate wardrobe. "That's challenging in itself. I have seven or eight costume changes."

Other actors include North Street newcomers Lauren Rathbun (native of Utah, currently residing in New York City) in the role of Joan and also serving as dance captain, and Sean Michael Jaenicke (of Raleigh, N.C.) as Lucky. Audience members will recognize North Street veterans Jimmy Wencel (as Dick), Graham Shadow Boxer (in the roles of Hennessy and the Captain), and Cat Yudain (as Ruby).

"I never saw myself living on the Shore as an adult," said Antunes. "Things have changed. Maybe just a new generation has come through and is keeping this thing alive," she said.

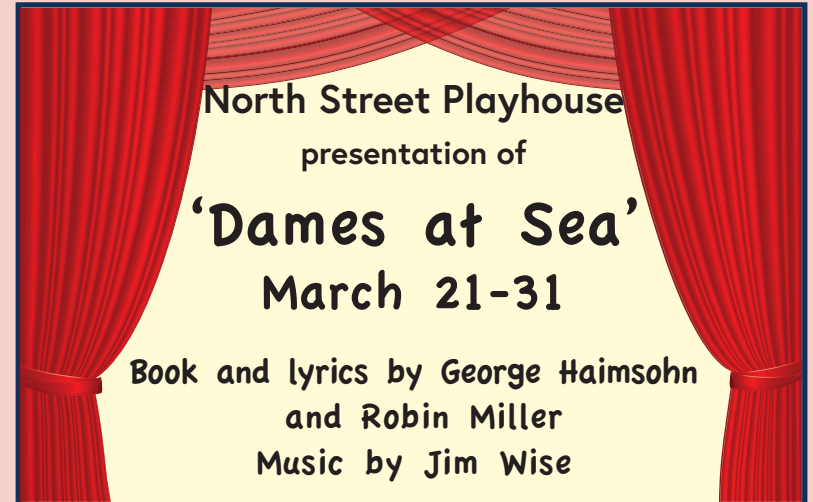
Part of that change she attributes to imagination and resilience, and a community that steps up to support the arts. "There's this great opportunity to create your own opportunity on the Shore," she said. "The community is so supportive. I haven't been in a single show that hasn't sold out every single night. I have to tell my family 'Buy your tickets in advance.'

"We initially thought of it as a jumping off point," she said, but now, "we're just making our lives here."
