Store Robbery That Injured Customer Gets Harmon 53 Years

Antonio Lamar Harmon used a sawed-off shotgun to rob a clerk of \$40 at the Painter Corner Mart on Lankford Highway in 2018. A customer, who had gone inside the store to retrieve a gas receipt, was injured when Harmon struck him before fleeing.

Wednesday, Judge W. Revell Lewis sentenced Harmon, 37, of Mini Road in Tasley, to a total of 53 years and nine months in prison for the crimes. With suspended time, he was set to serve 17 years and nine months. He could have been fined up to \$602,500 and been sentenced to two life terms plus 23 years.

"He hadn't been out of prison very long before this," said Assistant Commonwealth's Attorney Randy Fultz. Probation hasn't been able to get him to change his ways. ... Mr. Harmon is just a threat to the community. ... He admitted that he had intended to kill both the clerk and

Town Declines to Sell Property to Shanty Restaurant Owner Ownership Would Give Him Equity for Expansion Says Businessman By Stefanie Jackson

In a tough split decision March 21, the Cape Charles town council turned down an offer from a local restaurant owner to purchase the harborfront property on which his business is built, which would have given him the equity he needed to expand the restaurant to meet customer demand.

"Over 20 years, this is the hardest decision I've ever made," Councilman Chris Bannon said before voting against the sale that he believed would not be in the town's best interest.

In 2012, Jon Dempster, of Cape Charles, took the risk of opening the Shanty restaurant at the town harbor, development that was called for in Cape Charles' harbor plan.

Now the restaurant is so popular that during the summer tourist season there's a two-hour wait. Building an addition to increase the restaurant's capacity would help cut that wait time down to an hour, Dempster said.

The sale and business expansion would create a "win-win situation" for the restaurant and the town, generating more tax revenue and jobs, Dempster said.

Earlier this month, his company, Hungry Crab LLC, presented an unsolicited offer of \$262,000 for the .4-acre portion of the lot on which the Shanty is located, not including the parking lot or watermen's memorial in front of the

restaurant.

The offer was deemed fair market value by W.R. McCain and Associates, of Salisbury, Md., in an independent review.

But Cape Charles citizens who spoke up or wrote in at a March 14 public hearing and the March 21 regular town meeting disagreed.

In an email, David Gay called the \$262,000 offer "an insult" and said the Hungry Crab already has a "sweetheart deal" in its lease that costs \$500 a month and 1 percent of gross revenues.

Town Manager Larry DiRe recommended the council reject the offer, in part because the majority of public opinions were against it. The town should maintain full control of its harbor during planning of future development at the harbor and the adjacent rail yard, his report continued.

Against DiRe's recommendation, Councilman Andy Buchholz motioned to permit the sale, seconded by Councilwoman Tammy Holloway. Both council members are also business owners. Councilman Paul Grossman said it would be in the town's best interest if the Hungry Crab continued paying rent and property taxes. Buchholz said that position was "short-sighted" and did not consider that the town would get more revenue from meals taxes after the restaurant expansion.

Councilwoman Cela Burge indicated she would support the motion if there were "guardrails" around the deal.

On Burge's advice, Buchholz amended his motion to give the town first right of refusal of any resale of the land, which could not be resold for more than \$262,000, the original offer.

Burge was the third "yes" vote, but three councilmen voted "no": Bannon, Grossman, and Steve Bennett.

Mayor Smitty Dize said he would have voted "yes" to break the tie, but his vote would not have counted, as a super majority vote of at least 5 to 1 was needed to permit the sale of townowned property.

Dize said the council was "making a big mistake" by not selling the property and "we need to do due diligence to be in the business of helping businesses."

In another matter, the council vot-



ed unanimously to send a letter to the Virginia Department of Transportation in support of Cape Charles giving up the public right-of-way on a portion of Bayshore Road near the Cape Charles Yacht Center.

Eyre Baldwin, who owns the yacht center and has already purchased the 1.5-acre parcel that contains the right-of-way, wants the road for transporting boats from the yacht center to a repair facility on another of his properties.

Community College Has 3 Years To Prove Its Viability

The Eastern Shore Community College has a three-year plan that will protect the school's independence, prioritize the students, and provide tools to meet the needs of the Eastern Shore, according to a recent letter ESCC Board Chairman Jeff Holland sent to faculty, staff, board members, and school supporters.

The plan includes bringing classes to Chincoteague and Cape Charles and offering classes at times that align with Star Transit's schedule. Classes for working students with limited access to internet and transportation will also be available.

The college will be reassessed by the Virginia Community College System in 2022, the plan states. At that time, ESCC will either prove it can stand on its own or it will be consolidated with another state community college.

Hiring a new permanent school president appears to be a move for independence as an interim president has been in place for more than a year. However,

the task of consolidating services is included in the first year of the plan.

For 2019, cost-saving measures associated with consolidating administrative functions with another school will be identified and made "resulting in reduced annual administrative personnel costs without sacrificing the quality of teaching and learning," the plan states.

Opportunities to consolidate "select student services while maintaining support structures necessary for student success" is also included for this year. Workers schedules will be adjusted to "ensure campus operating hours seven days a week and evenings" this year. Staff assignments will also be modified "to ensure appropriate coverage of administrative and student services." Development of a plan "to adequately fund faculty and staff professional development, including succession planning" is also part of the plan.

Next year, the college will look into expanding its relationship with Virginia Tech and the Virginia Institute of Marine Science (VIMS). More collaboration with local public secondary schools and Broadwater Academy will be made "to identify shared challenges and possible efficiencies through partnership" including "shared facilities and faculty," the plan states.

ESCC will also look at the "feasibility of on-campus dual enrollment college academies."

This year a plan is in works to develop the college's role as "the hub for community engagement" with implementation in 2020 and 2021.

Grants will continue to be pursued "to support academic and workforce training programs and to promote post-secondary access and success."

Starting this year, the college plans to "establish ongoing internship and apprenticeship programs with key regional industries and employers, including but not limited to: healthcare, hospitality, chicken production —Tysons and Perdue, aquaculture, agriculture, and aerospace."

Online training for general education courses with other community colleges will be implemented and academic and workforce programs will be set to meet community needs.

Programs will be added and discontinued also according to greatest need, the plan states. Equipment sharing for CDL training and mobile labs will also be established.

The school plans to ask regional employers to identify workforce solutions and demands.

The college foundation will provide money upfront and reimbursements for bridge-tunnel tolls when needed this year. The school plans to develop a mentor program in 2020.

CHINCOTEAGUE ELEMENTARY TEST SCORES DROP, EDUCATORS CONCERNED

Chincoteague Elementary School's test scores dropped unexpectedly last year, and now teachers are fighting an uphill battle to help their students reach academic heights.

"We entered the year with a group of teachers that were heartbroken, not quite sure how all of this has happened, but they know that they wanted to improve," Principal Marjorie Rosati told the Accomack school board March 19.

Last year's third grade had the most trouble passing the benchmarks. Previously, the school's three-year average passing rate for reading was 87 percent, but that fell to 78 percent when just 64 percent of third graders passed the reading test.

Only 55 percent of those same third graders passed the math benchmark.

The subgroups of African-American students and students with disabilities struggled even more. One of seven African-American third-grade students, or 14 percent, passed the reading benchmark. Two of eight third-grade students with disabilities, or 25 percent, passed the reading benchmark.

Another 14 percent of African-American third graders and 12 percent of students with disabilities in third grade passed the math benchmark.

"Is this a fluke, or is this a trend?" school board member George Waldenmaier asked.

The three-year average passing rates for African-American and disabled students has always been "out of whack," Rosati said. Previously, the performance of these subgroups was considered "too small to measure," but new testing regulations reversed that conclusion.

Special education teacher Leigh Holmes noted that examining test scores of very small groups creates a "skewed" picture of student performance. If one student in a group of three doesn't pass, "your percentages don't look real good," she said.

"I'm not sure that some of these test scores represent what our students know," Rosati added. Several fourth graders have ADD (attention deficit disorder) and struggle both in understanding the content and taking the tests. These students will be taught test-taking skills, she said.

Holmes also stressed the importance

of telling the difference between a learning disability and a "learning difficulty."

Identifying a student with a learning disability and placing that student in special education requires evidence of the learning disability and its "educational impact" on the student.

Often, students are not identified for special education until they reach second or third grade and are already a year or two behind, Holmes said.

"That makes it really hard, at that third-grade level – that first year of SOL testing – to get those guys where they need to be," she said.

One problem is Chincoteague Elementary has only one reading specialist, and the school isn't eligible for funding from Title I – the largest federally funded education program, targeted at schools with large populations of low-income students.

Parents often believe putting a child in special education will make life easier, but it actually means the student must do "double duty," Holmes continued. If a child has 20 spelling words to study, she adds another 20 lower-level words to help the student catch up.

Another challenge facing special ed-

ucation teachers is scheduling. Attending meetings or addressing crises, such as student behavior issues, takes time away from working with students in the classroom, Holmes said.

A special education teacher for every one or two grades would be ideal, she told school board vice chairman Ronnie Holden when he asked what would help. Holmes currently teaches special education in third, fourth, and fifth grade.

Teachers are "desperate" to help students with learning difficulties and connect students with learning disabilities to special education resources, Holmes said.

"I've been doing this for a long time," fifth grade teacher Debra Lewis said through tears. "Our scores have always been phenomenal, and we want the best for these kids, and we're doing everything we can.

"I welcome anybody to come in and tell me something else to try." After "31 years, you'd think my job would be getting a little easier, but I don't feel like it is, and I take this very seriously," she said.

Jessica Vasilou teaches the fourth graders whose third-grade test scores brought down the school average last year. "Tve never taught so hard ... than I have this

year," she said in a wavering voice.

She tries to instill work ethics in her students, "but I'm only in front of them seven hours a day."

"When they go home, I don't know what happens," she continued. Chronic absenteeism is also a problem. "The parents expect me to catch them up. When? I'm teaching 20 other kids, and your kid hasn't been here for five days."

Last year, nearly 11 percent of Chincoteague Elementary students missed 10 percent or more of the school year.

Parental involvement is also a concern. One of the first school improvement efforts made at Chincoteague Elementary this year was inviting parents of struggling students to a workshop that taught parents how to help their kids learn at home and encouraged better communication with teachers.

In the classroom, teachers now follow "one uniform lesson plan ... the county lesson plan," Rosati said. Teacher schedules were adjusted to allow time to meet with the special education teacher and discuss strategies to address specific student learning issues.

Rosati monitors grades and arranges after-school tutoring when needed.

She is also tracking academic growth.

This year, African-American third graders have achieved 1.36 years of academic growth, and students with disabilities in third grade achieved about 1.5 years of growth.

Peebles' Exmore Store To by lanuary

Another store is going out of business in Exmore.

Peebles Department Store, in the Shore Plaza Shopping Center, on Lankford Highway, will shutdown on Jan. 18, 2020, an operator in the corporate office said Tuesday.

We are "closing stores all over," she added. "Some are opening a Gordmans (in the same location,) but not this one."

She transferred an Eastern Shore Post reporter's call to the real estate division where another worker said he didn't "have any information about it" and hung up.

Peebles, Gordmans, Bealls, Palais Royal and Goody's are all owned by Stage Stores, which operates 793 stores in 42 states with headquarters in Houston, Texas.

The Exmore Peebles store manager. Renee Morrell, was not at work this week. She did not return an inquiry left on her cell phone's answering machine.

A worker there said the store was sell-

ing its inventory at reduced prices and would be able to stay open until January by continuing to get clearance items to sell from other stores in the chain. A banner hanging in front of the business also says there is a closing sale in progress.

George Christacos, of Washington, D.C., owns the shopping center, which is listed online as being for sale for \$5 million.

Joe Poole, of Poole Accounting, in Maryland, identified himself as Christacos' business manager and accountant. He was unsure why the Peebles store was closing, but confirmed that the lease would expire in January and the business wasn't planning on renewing it.

"Their sales haven't been horrible, but they obviously haven't been great," Poole said. "Roses and others have been impacted by the Walmart that opened several years ago."

"We're working on that," Poole said, when asked if another business would be moving in.


grade, students with disabilities have gained about half a grade level, and African-American students have gained between half and one full grade level.

The shopping center has lost several tenants over the years including A & N. which closed all of its stores in 2008: Kmart, which was closed in 2003; and Roses. The Verizon store and Dollar General moved out after building their own stores across the highway in more recent years.

Other businesses that closed in Exmore were Sally & Bob's, Wendy's, KFC/Taco Bell, Burger King, Sage Dinner, Trawler Restaurant, Radio Shack, Cato's, Shoe Show, and Fresh Pride.

The Benjamin Building, a three story structure, on Main Street in downtown Exmore, was the original location of Peebles. Now painted yellow, the 16,580-square foot structure has been vacant for years and is listed at \$499.900.

Frank Mapp, of Exmore, grew up in the town and his father John Mapp was the first mayor. Mapp said Peebles bought the store from Benjamins, which had a merry-go-round on the third floor and another business in Salisbury, Md.

Woman Pleads Guilty to Embezzlement From Hardees

A 30-year-old Painter woman pleaded guilty last week in Accomack Circuit Court to embezzling more than \$2,400 from Hardees in Onley.

Jackee Dortisha Giddens, of Big Pine Road, admitted she committed the May 12, 2018, crime. Judge W. Revell Lewis III allowed Giddens to remain free on \$5,500 bond until sentencing, which was set for June 27. Restitution of \$2,431.60 was ordered.

Giddens could be sentenced up to 20 years in prison and fined \$2,500.

Odai Mustapha, also known as Odai Mustafa, 28, of Lankford Highway in New Church, pleaded guilty to felony possession with intent to distribute marijuana and misdemeanor possession with intent to sell paraphernalia. The crimes occurred Aug. 17, 2017.

A presentence report was ordered. Mustapha could get up to 11 years in prison and a fine of \$5,000.

Connie Jolanda Walker 55, of Mini Road in Accomac, pleaded guilty to credit card fraud, credit card forgery and credit card larceny between March 16 and May 25, 2018. A presentence report was ordered and sentencing was set for June 27.

Tennessee Man Sentenced for Racketeering

A Tennessee man was sentenced Monday in Northampton Circuit Court to 25 years in prison for conspiring to racketeer in 2017 and related charges.

All but two years and six months of the terms were suspended for Brandon Michaell Maldanado, also known as Brandon Michae Maldanado-Caro, 25, of Nashville.

He was given five years with half the time suspended for the conspiracy count. Two-year suspended sentences were given for seven counts of uttering and three counts of obtaining money by false pretenses. The terms were set to run consecutively. He was initially charged with 17 felonies.

The crimes occurred July 28, 2017, and involved checks that were cashed at Casa Hispana LLC, in Nassawadox; B&B convenience store, in Machipongo; and El Ranchito, in Cheriton.

In another case, Shane Isia Smith, 36, of Lankford Highway in Eastville, was given a total of 10 years for three felonies that involved illegally obtaining money from Virginia Medical Assistance Services in 2016. All but two years of the terms were suspended. Supervised probation was ordered for Smith for three years.

James Beasley Jr., 41, of Creedmoor, N.C., pleaded guilty to grand larceny in connection with an incident that occurred Sept. 19, 2018. Sentencing was set for June 24.

Bond was denied for Jefferey Arthur McNeilan, 30, of Cape Charles, who was indicted earlier this month on counts of unauthorized use of a vehicle, reckless handling of a firearm, and disorderly conduct. The offenses occurred Jan. 23. McNeilan is being held in the Eastern Shore Regional Jail, in Eastville.

Man Charged With Child Porn Waives Hearing

A Tasley man, charged with possessing child pornography, waived

his right Monday in Accomack General District Court to have a preliminary hearing regarding the alleged offense.

Details regarding the charge against Sejour Richerson, 43, of Daugherty Road, will be given to the grand jury April 1. Richerson is accused of knowingly possessing a pornographic video on July 14 and showing it, via a cell phone, to two fellow workers.

A complaint was made to the Accomack County Sheriff's Office from Perdue Farms in Accomac. Records state the phone was seized.

In another case, Carrol Thomas Baker, 32, of Cooper Lane in Accomac, was accused of stealing property valued at \$500 or more from Walmart, in Onley, Jan. 25. Baker was arrested March 22. Deputy M. R. McCready, of the Accomack County Sheriff's Office, investigated.

Marionville Woman Accused of Two Crimes

A Marionville woman was accused last week of committing two crimes, according to records filed in Northampton General District Court.

Amy Gladden Sturgis, 38, was charged with felony obtaining money by false pretense and misdemeanor defrauding a garage keeper in connection with incidents that occurred March 22. She was arrested the same day and is being held in the Eastern Shore Regional Jail, in

Eastville. A preliminary hearing was set for April 25. Exmore Police Chief A.P. DiMartino investigated.

Pabnesia Anne Zachary, no age available, of Milford, Del., was charged with felony possession with intent to distribute marijuana and possession of a Schedule I or II drug. The offenses occurred March 21. She was arrested the same day. Officer Shelley Beasley, of the Chesapeake Bay Bridge-Tunnel Police Department, investigated. A May preliminary hearing was set.

Naked Offender Sentenced

Jeffery Klutts, of Belle Haven, was drinking and doing drugs on July 2, 2018. He was naked when he used a stranger's garden hose to shower and then walked into the house asking for a towel and scaring the owner.

The 42-year-old Belle Haven Road resident was convicted of burglary in January in connection with the incident. He was sentenced last week to five years in prison with all but the approximately nine months he had served in jail suspended. A condition of the term was that he complete a Community Corrections Alternative Program (CCAP), which takes between 42 and 48 weeks.

Commonwealth's Attorney Spencer Morgan said Klutts will continue to be detained until a bed is available at the program, which won't be for three or four months.

the customer. He decided not to at the last minute. He might not do so the next time."

The incident occurred at about 11:30 p.m., March 28, 2018. According to court records, the injured man was Lawrence Levinson. He was treated on the scene by Painter Emergency Medical Services. The name of the clerk was not disclosed.

"This is clearly a mental health case," said Defense lawyer Garrett Dunham. "He was literally hearing voices in his head and things like that." Dunham said when he first talked to Harmon, "He was not there." Since then he's getting treat-

ment and the jail is giving him his medications, he added. "He didn't kill those people. The defendant who is here today" is not the same person who did the crimes. "We have a person who now sees how serious this is. He took responsibility and turned himself in."

Lewis sentenced Harmon to nine months for brandishing a firearm (a misdemeanor),10 years with eight years suspended for malicious wounding, three years for use of a firearm in a felony, 20 years for possession of a sawed-off shotgun with all but two years suspended, and 20 years for robbery with half the time suspended.

Dunham told the court that Harmon has a tattoo that was popular where he grew up. But that he is not a member of a street gang.

"Your criminal record stands for many years going back to 2000" in Accomack and Chesterfield and Virginia Beach, Va., said Lewis. "You have been on probation in each of these jurisdictions and you had probation revoked. You continued to commit serious offenses."





In this week's Capitol Report, I want to discuss a few pieces of legislation that we considered this year that I think would be of interest to you. We voted on over 2,500 pieces of legislation which is hard to believe considering we were only in session for 45 days. It is hard to imagine so much could be wrong with our commonwealth.

A lot of bills that were put forward are for the localities to ask permission to do something that is different from what is already in the state code. We are a Dillon rule state, which means that the state's laws take precedence over local laws. This, in turn, requires the legislature's permission on any change or variance. Changing a town's charter to the allowance of golf carts on a road within a town's limit and

restricting the parking of oversize boats on the streets of Cape Charles are just two examples of bills that were brought before us.

Quite a few bills are the result of federal law changes, so it is necessary for us to adapt to these laws. Tax code conformity and tax on internet sales are merely a couple examples of this type of legislation.

Other bills deal with changes in technology. The technology relating to drones is a challenging issue. While individual privacy needs to be protected from drones, these technological advances, in turn, need to be promoted for societal benefits. Similar to this, the telephone industry has telemarketers that are increasingly becoming a burden in individuals' personal lives, but our laws are unable to keep up with their new tactics.

The last bill of interest is one that I think will make you shake your head like

it has made me shake mine. Do you know what I mean when I refer to the parking space with the diagonal blue lines that is situated by the handicapped space in a parking lot? If you are like me, you probably thought it was illegal to park in these particular places. Well, as of July 1, it will be, but unbeknownst to my colleagues and me, we just learned we could have been parking in these spaces all along. This is just one example of assuming a law is in code, when in reality, it has been omitted. Such is the complicated, head-shaking day in the life of a legislator.

Northampton Supervisor: 'State Not Serious About K Through 12 Education'

The Northampton school board's presentation of its proposed budget for fiscal year 2020 initiated a discussion with county supervisors Tuesday night on the growing trend of state legislators shifting the burden of funding public education onto localities.

"The state of Virginia is not serious about K through 12 education," said Spencer Murray, chairman of the Northampton board of supervisors.

In the last decade, Virginia's operating budget has increased nearly 54 percent, but the amount set aside for public education has decreased more than 3 percent.

In FY 2009, the state budget was more than \$37 billion, and a little more than 9 percent of that was basic aid for public education. In FY 2019, the state budget reached nearly \$57 billion, but less than 6 percent of it was designated for public education.

State legislators have a formula for calculating the level at which localities are expected to fund their public schools, resulting in a figure called the composite index. Northampton's composite index is approximately .47, meaning the county must provide about 47 cents of every dollar spent on its public education system.

Northampton's composite index recently decreased by .02, but Murray said the composite index is still "incredibly unfair" for a rural area that is land rich and cash poor.

For comparison, Accomack's composite index is .35 and Norfolk's is just under .30.

The composite index allows many Virginia cities to pay less for public education even though "research has shown that it costs more to educate rural students," Superintendent Eddie Lawrence said.

For example, it costs more to bus students across greater distances, and broadband internet access is more expensive than in the city, Lawrence said.

Even with Northampton schools' projected ADM (average daily membership) dropping from 1,515 to 1,500 students, the number hasn't fallen

enough to enable the school division to cut teaching positions to save money.

However, Northampton schools expect to save nearly \$260,000 from various sources, including about \$243,000 in attrition savings, which come from hiring teachers and staff on the lower end of the pay scale to replace those who left the school system at the higher end of the scale.

Northampton schools' current total operating budget is about \$21.6 million, of which approximately \$8.8 million is funded by the county – about \$2 million more than the county is required by law to provide, for which Lawrence thanked supervisors.

One of the school board's top priorities for next year is hiring a school social worker at a cost of about \$60,000.

The school board also plans to give Northampton teachers a pay increase of \$1,175 each, the equivalent of a 2.5 percent raise on a mid-range salary of \$48,172.

Last year, teachers received an average raise of 3.67 percent.

These salary increases will align

with state legislators' goal of giving Virginia teachers a 5 percent raise over a two-year period, and the school division will qualify to receive state funding for those raises.

The amount of funding is based on the composite index, so Northampton will pay about 47 percent of the raises, and Virginia will pay nearly 53 percent – but only for teaching positions required by the state standards of quality (SOQ).

Northampton must pay 100 percent of raises for teachers in non-SOQ positions.

The school board is asking the county for about \$340,000 more this year for the school division's operating budget. Murray said supervisors will give "every penny we possibly can."

In another matter, supervisors unanimously decided that Northampton County will abandon the public right-of-way on a portion of Bayshore Road near the Cape Charles Yacht Center, allowing the private business free use of the road to move large boats to a refitting facility on a nearby, 80-acre parcel.

HEALTH DEPARTMENT STILL GETTING REPORTS OF INFLUENZA

"Do not underestimate the flu," officials from the Eastern Shore Health District warned this week as they continued to receive reports from the community of respiratory illnesses.

"Influenza viruses infect the nose, throat, and lungs and spreads mainly from person to person by droplets from the nose or throat that are released when an infected person coughs or sneezes," according to a prepared statement. "Sometimes, people may become infected by touching something with influenza virus on it and then touching their mouth or nose before washing their hands. The infectious period begins up to a day before symptoms start and can last for five to seven days."

If you become ill with fever, sore throat, and/or cough, health officials urge you to stay home and avoid contact with other people. Most people are able to recover at home and do not need to be tested during peak flu season. Your primary care provider encourages you to call by phone if you have any questions and can advise you if you or your child needs to be seen in the office.

The usual treatments are getting rest,

drinking plenty of liquids, and taking over-the-counter medicine for fever. Some prescription drugs may reduce the severity of influenza. Aspirin should not be given to children with fever-causing illnesses because of the possibility of a complication called Reye's syndrome. Antibiotics are not effective at fighting the flu.

Young children, adults who are 65 or older, pregnant women, and those with certain chronic medical conditions are among those groups at high risk of serious flu complications, possibly requiring hospitalization and sometimes resulting in death.

Sinus and ear infections are examples of moderate complications from flu, while pneumonia is a serious flu complication that can result from either influenza virus infection alone or from co-infection of flu virus and bacteria. Other possible serious complications triggered by flu can include inflammation of the heart (myocarditis), brain (encephalitis), or muscle (myositis, rhabdomyolysis) tissues, and multi-organ failure (for example, respiratory and kidney failure). Flu virus infection of the respiratory tract can trigger an extreme inflammatory response in the body and can lead to sepsis, the body's life-threatening response to infection. Flu also can make chronic medical problems worse. People with asthma may experience asthma attacks while they have the flu, and people with chronic heart disease may experience a worsening of this condition triggered by flu. Anyone with serious complications should seek emergency

medical care as soon as possible.

It is not too late to get a flu shot. Being vaccinated annually protects the person who gets the shot and can prevent the spread of influenza in the community.


Several post members were close friends of the deceased. They raised more than \$11,000 through 144 dona-


The money they raised will help support Appenzeller's 14 –year-old son and six-month-old twin girls.



VIMS Updates Maps to 11,885 Miles of Chesapeake Bay Shoreline

Researchers at the Virginia Institute of Marine Science (VIMS) recently updated online maps that display the condition of all 11,885 miles of Chesapeake Bay shoreline -- every beach, breakwater, boathouse, boat ramp, bulkhead, dock, jetty, living shoreline, marina, mud flat, oyster reef, tidal marsh, and tree-lined bank.

Decades in the making, according to the VIMS website, the interactive tools can be used by citizens to view each aquaculture site, conservation easement, oyster lease, and underwater grass bed, as well as a model-based recommendation for maximizing shoreline health at any location.

Go to https://www.vims.edu/ccrm/ccrmp/portals/index.php and click one of the 44 coastal areas. The tool to view sea level rise and vulnerability is available for Accomack and Northampton counties.

The latest additions combine digital mapping and GPS technology. VIM's Center for Coastal Resources Management workers checked out thousands of high-resolution aerial images and traveled in small motor boats along all 62,752,800 feet of Virginia and Maryland shorelines, the website states.

"Their mapping of tidal wetlands began in 1972 and continued until the late 1980s. In 1990 ... researchers began mapping shoreline position and conditions. That work wasn't completed until 2018."

Program manager Carl Hershner said the push for the coastal inventories began with the passage of the Tidal Wetlands Act in 1972. Alarmed by widespread dredging and filling of coastal marshes, the General Assembly passed the legislation to prevent "despoliation and destruction" of wetlands and "to accommodate necessary economic development in a manner consistent with wetlands preservation," Hershner said.

The Dunes and Beaches Act in 1980

and the Chesapeake Bay Preservation Act in 1988 followed and concern for and protection of state beaches, bluffs, and coastal uplands grew.

Technology in the 1970s was difficult. "We did all of a mile and a half in the first year," says Hershner, "so that clearly wasn't going to work ... we knew the USGS topo maps weren't right, but nobody had anything better. We had high-altitude aerial imagery, but it wasn't of high enough resolution to really do a good job at interpreting."

In the 1980s and 90s GPS was added. Mapping the Chesapeake Bay shoreline by boat remained a daunting task.

VIMS employees continued to sift through imagery and recorded characteristics of the shoreline in the field by boat. Marcia Berman joined CCRM in 1989 to direct the mapping of shoreline conditions and update the Tidal Marsh Inventory.

On a typical day, said Berman, "We would trailer a boat, drive to a ramp and launch, then motor along for 20 or 30 miles."

At least two people would take the journey — a pilot and someone to collect all the information relating to the condition of the bank, shoreline structures, and land use.

By the mid-2000s, digital imagery had gotten so detailed that it precluded the need for field mapping. "The procedures now are mostly done on the desktop," says Hershner. "There is a field component, but most of it is done on a computer with aerial imagery, which allows us to get really precise."

Today's imagery is so detailed, "If for some reason you wanted to count the number of rocks in a breakwater you could do it, while back in the early imagery you wouldn't even be able to see the breakwater," said Bergman.


The Yellow Jackets will be back on the field tonight in Eastville against Stephen Decatur at 4:30 p.m.





Those Spring Chicks are Cute, but Think before Adding Them to Your Farm or Backyard

At feed and farm supply stores across Virginia right now, baby chicks are chirping away. According to Dr. Charles Broaddus, state veterinarian with the Virginia Department of Agriculture and Consumer Services, before making on-the-spot decisions about buying chicks, people need to learn what the birds require. "I love to see people connecting with agriculture in a way that is so personal," says Broaddus, "but they need to keep in mind their responsibility to defend the flock."

In four to five weeks, those little chicks will become full-grown chickens that require housing, feed, water, and protection from predators. They also need good biosecurity to keep the birds and their owners healthy and disease-free. Biosecurity is a program designed to prevent the introduction and transmission of diseases into a flock or herd.

The U.S. Department of Agriculture offers six points about biosecurity that all bird owners should follow:

- Keep your distance. Restrict access to your property and your birds. People who care for birds should be careful when attending bird shows or other events where birds are present, and should take extreme precautions when doing so, including changing and washing clothes and footwear before interacting with their own birds. If visitors to your property want to see your birds, be sure they wash up first and clean their shoes, or keep clean boots or shoe covers for visitors to wear.
- Keep it clean. To keep your birds germ-free, have a pair of shoes and a set of clothes to wear only around your birds, or clean and disinfect your shoes and launder your clothes before you work with your birds.
- Do not haul disease home. If you travel to a location where other birds are present, or even to the feed store, be sure to clean and disinfect truck tires, poultry cages, and equipment before you return to your property.
 - · Do not borrow disease from

your neighbors. Do not share birds, lawn and garden equipment, tools or poultry supplies with your neighbors or other bird owners.

- Know the warning signs of infectious bird diseases: Sudden increase in bird deaths; sneezing, gasping for air, coughing and nasal discharge; watery and green diarrhea; drop in egg production; swelling around the eyes, neck and head; purple discoloration of the wattles, combs and legs; and tremors, drooping wings, circling, twisting of the head and neck, or lack of movement are all signs to call a veterinarian knowledgeable about poultry.
- Report sick birds. Call your local cooperative extension agent, local veterinarian, the state veterinarian 804-786-2483 or USDA Veterinary Services office 866-536-7593.

"Enjoy your birds," Dr. Broaddus says, "but please keep them and your family safe and healthy by observing these six rules. And remember, it is always a good idea to wash your hands after handling your birds, especially for younger children."

Rainy Winter Turns to Soggy Spring on State's Farms

It's no secret it's been a wet winter in Virginia. As of Feb. 25, the U.S. Department of Agriculture's crop progress report estimated 82 percent of the state's topsoil had surplus moisture.

In addition to creating muddy pastures and cropland, the weather has started to seriously delay farm operations.

"Some growers across the state are saying they're as much as two months behind" in preparing cropland for planting, said Robert Harper, Virginia Farm Bureau Federation grain marketing manager.

In Accomack County on Virginia's Eastern Shore, "we're about a week behind our normal start of planting, and we need about two weeks of good drying weather to get caught up," said potato and grain producer David Hickman, a mem-



ber of the VFBF board of directors. "And they're calling for more rain this weekend, so who knows when our fields will be fit to plant."

Hickman said Virginia potato growers are concerned, but their counterparts in North Carolina are a full month behind their normal planting time because of wet fields. That affects Virginia growers, because the potato harvest is staggered as the season moves from south to north each year. If North Carolina potatoes hit the market at the same time as Virginiagrown spuds, prices will suffer.

"If we have good growing weather once the potatoes are planted, normally we can make up some of this lost time," Hickman said optimistically. "But there's a lot of water standing in the fields over here right now. We've had two days of fieldwork since probably the second week of December. That means no spreading of manure or top-dressing wheat; the fields are just too wet to put equipment in."

Last year was the wettest on record for neighboring Northampton County, and the winter wheat crop has suffered a lot of stress, noted Ursula Deitch, a Virginia Cooperative Extension agent in Northampton. Nutrient losses and potential disease issues from wet weather threaten to have a major negative impact, she reported.

It's just as wet farther west in Appomattox County, and farmers there are worried about ripple effects into next fall.

"So many people couldn't get their small grains in last fall, so now they're worried about having grain for their feed or forage crop for this season," explained Darrell Roach, an Appomattox County cattle and grain producer. "They're going to be short on feed for this coming fall. And there's a lot of folks with hay stored in staging areas, but it's so wet they can't get it out to feed the cattle.

"We aren't delayed on summer crops yet. We're about three weeks from planting, and I'm hoping we'll get dry enough to start on time," Roach added. "Still, all the feeding areas for cattle are all mucked up. Folks are upset about that. They haven't been able to clean them up. It's a big mess for sure."

Agritourism accounts for \$2.2 billion in economic activity in the state and brings people to Virginia farms for a diverse range of experiences, from apple picking and wine tasting to cutting the family Christmas tree.

The event at the Hotel Roanoke & Conference Center will feature interaction with experts on developing an agritourism business, celebrating its successes and managing its challenges. Agenda topics include delivering exceptional customer service, ensuring farm safety, and marketing collaboratively within a region.

Bettina Ring, Virginia secretary of agriculture and forestry, will be one of the featured speakers. Julia Clark, executive director of the Virginia Foundation for Agriculture, Innovation and Rural Sustainability, will moderate a panel discussion with Dr. Dixie Dalton of Southside Community College and Seth and Courtney Umbarger of Laurel Springs Beef on "Building a Plan." A discussion on "Making the Agritourism Voice Heard" will include Kyle Shreve, executive director of the Virginia Agribusiness Council, and Andrew Smith, associate director of governmental relations for Virginia Farm Bureau Federation.

Tours will be offered at Roanoke-area farms with agritourism operations.



USS Chincoteague is Prime Example of Eastern Shore Importance

The importance of the Eastern Shore of Virginia to the United States is evident as several commissioned ships of the Navy were named after places here

The USS Chincoteague is a prime example. Ship Commander Ira Earl Hobbs, who retired as a Navy Vice Admiral, was awarded the Silver Star for actions during WWII aboard the vessel, "Which was damaged and under repeated attacks by Japanese bombers in the vicinity of the Santa Cruz Islands" between July 16 and 21,1943. "Commander Hobbs skillfully maneuvered his ship and opposed repeated attacks of the enemy during this period, and although his ship was damaged by fire and flooding, he coolly and tenaciously fought against overwhelming and discouraging odds. His action resulted in his ship and surviving personnel being saved," according to award documents.

The Chincoteague received six battle stars for World War II service. A seaplane tender of the Barnegat class, it was built by Lake Washington Shipyard and was launched April 15, 1942. It was commissioned about a year later and served the Navy until December 1946.

Chincoteague sailed from San Diego for Saboe Bay in the Santa Cruz Island arriving on July 6, 1943, to support the New Guinea operations as tender for Fleet Air Wing 1. On July 16, "The Japanese launched eight air attacks at Saboe Bay, killing nine of Chincoteague's crew and damaging the ship badly through one direct hit and two near hits," the Navy reported.

"Dead in the water and adrift, she endured intermittent attacks," another file stated. "The next day, destroyer USS Thornton arrived, and took the ship ... to Espiritu Santo for emergency repairs." Chincoteague was later taken to San Francisco for a "thorough overhaul."

In January 1944, Chincoteague set out for Pearl Harbor in support of the consolidation of the northern Solomons, the occupation of the Marshalls, air action on the Treasuries, and at Green Island. The boat carried "freight, mail, and passengers among the Solomons, Marshalls, Gilberts, Marianas, New Hebrides, and the Phoenix Islands, and voyaged from Guadalcanal to Auckland, New Zealand, returning with aircraft engines. Escorting a convoy, Chincoteague sailed from Eniwetok (in September) for Pearl Harbor, and overhaul."

Chincoteague returned to active operations in December 1944 at Kossol Roads in the Palaus, "Where she conducted salvage and rescue operations for the next two months. She arrived at Guam Feb. 13, to join the assault force bound for Iwo Jima, and on Feb. 20, arrived off the bitterly contested island to tend seaplanes until March 8. Similar

operations at Ulithi followed until June 8, when she sailed for a west coast overhaul."

"On occupation duty, Chincoteague sailed to the Far East to care for seaplanes at Okinawa and Tsingtao, China," between October 1945 and March 1946. One record shows Chincoteague was decommissioned and placed in reserve in 1946, and in March 1949 the vessel was lent to the Coast Guard. Redesignated a High Endurance Cutter in 1966, Chincoteague served until June 1972.

The Chincoteague was transferred to South Vietnam later that month and was renamed RVNS Tran Binh Trong. The boat was sold to the Philippines in April 1976 and renamed RPS Andres Bonifacto. The vessel was decommissioned in June 1985. The final fate of the Chincoteague was listed as "unknown."

There were also Navy vessels named USS Saxis, USS Tangier, USS Accomack, and the USS Oyster Bay. The USS Wachapreague was featured in Part 1 of this series. Information about all the boats continues in this article. There was also a Coast Guard boat called USCGC Assateague.

The USS Oyster Bay had to be named after the waterway near Chincoteague, as the boat was built around the same time as the USS Chincoteague and the USS Wachapreague and in the same place. Oyster Bay also tended patrol torpedo boats at the same time as Wachapreague.

The 1,760-ton Oyster Bay was commissioned in November 1943 and departed San Diego in January 1944 for the Southwest Pacific. It "tended PT boat squadrons in the forward area almost continuously through the end of the war," records show.

Ending service at Milne Bay, "Oyster Bay served in numerous operations in the New Guinea area, supporting her PT boats and, on at least one occasion, providing gunfire support for army troops ashore. In October 1944 Oyster Bay moved to Leyte Gulf as part of the Philippine campaign. She participated in operations at several locations in the Philippines and continued to tend PT boats there for the remainder of the war. She departed the Philippines in November 1945 for inactivation at San Francisco. She was decommissioned in March 1946, stricken from the Navy List in April, and transferred to the Maritime Commission for sale in August."

Three years later, Oyster Bay was reacquired and reinstated by the Navy. The boat was reclassified and remained in reserve until 1957 when she was reactivated for transfer to Italy. The vessel was given a large seaplane crane and a single 3"/50 gun. It eventually became Pietro Cavezzale, an Italian special forces tender serving in the Italian Navy for more than 35 years. The boat was decommissioned in October 1993 and scrapped in February 1996.

The USS Saxis was a Navy patrol vessel in 1917.

Built as a civilian motorboat of the same name by a man named Thomas Scott. The Navy acquired the Saxis from the Virginia Fish Commission May 5, 1917, during World War I. "Saxis was wrecked when she became stranded at West Point, Va.," in July 1917, according to Navy records. It was unclear if the vessel was commissioned or saw Navy service before that.


The USS Accomac, a 187-ton tugboat, was built for commercial use in 1891 at Newport News, Va. Seven years later the vessel was acquired by the Navy and named USS Algonquin. During the Spanish-American War, Algonquin was assigned to Key West, Fla., and was later renamed Accomac.

The boat served at several East Coast and Gulf Coast Navy facilities, including Boston Navy Yard, and was renamed again around 1920 as the Nottoway. During World War II, the boat was renamed YT-18 in 1942 and YTL-18 in 1944. "Placed out of service in April 1946, the old tug was sold the following October," the record stated.

The USS Tangier was placed in full commission Aug 25, 1941, and assigned to the Asiatic-Pacific Theater during WWII. The Tangier supported and consolidated operations at Pearl Harbor from Aug. 1 to Sept. 17, 1944, and was involved in the Bismarck Archipelago operations from March 31 to April 17, 1944. Tangier earned three battle stars.

After the war, the boat was assigned to Occupation Service in the Far East and China Service in October,

November, and December 1945 and February and March 1946. Tangier was decommissioned in January 1947 at Philadelphia and was laid up in the Atlantic Reserve Fleet, Philadelphia Naval Shipyard Group. Eventually, records show, Tangier was struck from the Naval Register June 1, 1961, and was sold to Union Minerals and Alloys Corp of New York City in 1962 for \$177,689.89. Tangier was soon sold again to Sea-Land Service and renamed SS Detroit and converted to a car carrier/container ship. The boat was scrapped at Valencia, Spain, in December 1974.

The USCGC Assateague was an island class cutter constructed at Bollinger Machine Shop and Shipyard in Lockport, La., and commissioned in 1990. Assateague supported multi-mission operations throughout Sector Guam, which included the U.S. Exclusive Economic Zone surrounding Guam and the Commonwealth of the Northern Mariana Islands. It conducted search and rescue response missions and coastal security operations. Assateague is 110 feet long, has a beam of 21 feet, and a draft of seven feet when it was constructed. Its "hull is made from highly strong steel, and the superstructure and major deck are constructed from aluminum." Island class boats can go nearly 30 knots. Assateague was decommissioned in September 2017.

Tales of the USS Wachapreague, in

last week's edition of the Eastern Shore Post, caused Robert Doughty, of South Chesconessex, to recall some of his Coast Guard memories. The Wachapreague later became the **USCGC** McCulloch on which Doughty served from September 1968 to April 1970 doing ocean station patrols.

"The patrols were from 31 to 33 days duration on station," he said. "We were in the middle of the Atlantic halfway between the continents. Our purpose was for transatlantic air flight to get a fix on our location and the point of no return if an aircraft had to ditch."

"We collected weather data and sent it back to National Weather Service, in Washington DC We were there for search and rescue or recovery, which we had a couple of those. I was a radioman, morse code operation, crypto, and radio teletype. It was a great experience for a 20-yearold and you rekindled some fond memories," he wrote to a reporter earlier this

Tuesday. Jill McCabe, of Salisbury, Md., told about her brother, John Lewis,, of Saxis, who also served in the Coast Guard on the McCulloch. In 1959, Lewis was lost at sea during a bravo patro. in the North Atlantic between Greenland and Labrador.

"He was swept off in a bad storm," Mc-Cabe said. "The waves were up to 60 feet." Lewis was only 19.

Barrier Island Center Exhibit of African-American WWI Servicemen Includes Shore Soldiers

The Barrier Islands Center in Machipongo is hosting a temporary exhibit on loan from the Library of Virginia, "True Sons of Freedom."

To commemorate World War I. "True Sons of Freedom" uses photographs of African-American soldiers from Virginia who fought overseas to defend freedoms they were denied at home. African-Americans from all parts of the commonwealth served in the army and navy during World War I. The soldiers highlighted in "True Sons of Freedom" came from locations across Virginia and most worked as farmers or laborers before the conflict.

Reflecting the pride and determination of African-American World War I servicemen, the images were submitted by these veterans with their responses to military service questionnaires created by the Virginia War History Commission as part of an effort to capture the scope of Virginians' participation in the Great War. The series of questions about the veterans' experiences provides invaluable genealogical

information about the soldiers, their families, and their service records.

World War I recruitment efforts aimed at African-Americans brought new soldiers into the armed services, providing them with opportunities to travel, to work, and, in many cases for the first time, to face cameras—all outside the restrictions of the Jim Crow South. These pocket-size portraits, made outdoors or in makeshift studios, became mementos for families and sweethearts. More importantly, these photographs challenge the crude and demoralizing cultural products of an era that often reduced African-Americans to stereotypes and denied them full participation as citizens of the United States. They posed in uniform, some in casual stances, others with a rifle to show their combat readiness. Here were African-Americans presented as they wanted themselves seen.

The exhibition is on display in the former African-American Almshouse. which now serves as the Education and Community Building and is available for viewing anytime the museum is open.

and homes of Virginians. The 'Profiles of Honor Tour' revitalizes that history, from the home front to the frontlines."





Federal Agencies and Fishing Industry Group Sign Memorandum on Offshore Wind Energy

NOAA Fisheries, the Bureau of Ocean Energy Management (BOEM), and the Responsible Offshore Development Alliance (RODA) signed a 10-year memorandum of understanding that brings local and regional fishing interests together with federal regulators to collaborate on the science and process of offshore wind energy development on the Atlantic outer continental shelf.

The federal government has 15 active leases covering nearly 1.7 million acres in the outer continental shelf for potential offshore wind development. Collectively, these leases could generate more than 19 GW of energy — enough to power more than 6.5 million homes and further solidify our nation's energy future. Virginia's offshore wind energy area contains 113,000 acres. Its western edge is located about 23.5 nautical miles from the Virginia Beach coastline.

NOAA Fisheries manages more than 42 commercially and recreationally important species as part of 14 fishery management plans. In 2016, approximately

4,600 vessels landed more than 1 billion pounds of key fish species, supporting roughly 140,000 seafood jobs. The region is also vital for many endangered and threatened marine species, including the North Atlantic right whale, necessitating protective measures to ensure their survival for future generations.

Fishing has occurred in New England and Mid-Atlantic waters for hundreds of years and is an integral part of the region's culture and economy. Regional fisheries not only provide a healthy and sustainable source of food for both domestic and international markets, but also recreational opportunities for thousands of anglers, divers, and nature enthusiasts. Fisheries also support numerous shoreside processing jobs and support industries important to the economies of many coastal communities.

Safe, reliable, and affordable domestic energy production powers the U.S. economy, supports jobs, and is critical to our nation's security. Offshore wind is an abundant, domestic energy resource that is located close to major

coastal load centers, providing an alternative to long-distance transmission or development of electricity generation in these land-constrained regions.

"Any development on the outer continental shelf must consider how these activities can affect current ocean users and the marine environment," said BOEM Acting Director Walter Cruickshank. "That is why working with federal, state, and local agencies, fishing communities, and the public is such an essential part of our renewable energy program. We look forward to working with NOAA and RODA through early and constant communication to ensure that the most recent information is available to decision makers."


"With wind energy developing in the New England/Mid-Atlantic region, this collaboration comes at a crucial time," said Chris Oliver, assistant administrator for NOAA Fisheries, the primary federal agency charged with sustaining U.S. marine resources and habitats. "This memorandum of understanding will help achieve NOAA Fisheries' strategic national goal of maximizing fish-

ing opportunities while supporting responsible resource development."

RODA, which is a broad membership-based coalition of fishing industry associations and fishing companies, will work with NOAA Fisheries and BOEM to compile, develop, and deliver the best available scientific products and information necessary to address offshore development, fisheries management, and ecosystem health.

"The fishing industry has expressed its concern about the potential impacts of rapid large-scale wind energy development to coastal communities and sustainable fishing practices," said Annie Hawkins, executive director of RODA. "This agreement paves a way forward for fishing communities to give meaningful input to federal regulators in determining the future of our ocean resources."

Working together to engage local and regional fishing interests early and often throughout the offshore wind development processes will help develop a collaborative regional research and monitoring program and lead to scientifically sound decisions.



I first heard about sea nettles when my family moved to the Eastern Shore when I was almost 10 years old. I was warned to look out for the jellyfish when swimming or wading in the nearby waters to avoid getting stung.

I was reminded of that advisory last week when I was out gathering news and someone mentioned there were deadnettles in my yard.

I pictured the lawn full of the clear jelly slime left belly up. I reasoned that they swam into the newly formed ponds about my property caused by all the rain we had. They must have gotten stuck in the field. I grimaced at the thought of trying to clean up what would be comparable to the fish kill I once saw at Quinby Harbor.

Would they sting me while I gathered them? Ugh.

But I was wrong. That's not what is blanketing the place. I was instead being told about the plant with the purple flowers that seem to be spreading everywhere in both Accomack and Northampton counties. They are purple deadnettles with the scientific name of Lamium purpureum or Greek for "the devouring purple monster."

As a member of the mint family, the deadnettles are supposed to be medicinal. But if you pick a couple, as I did so I could take a photo up close, you can catch the fragrance, which in my opinion stinks. I'm NOT recommending that it be consumed although several websites did just that.

The website www.ediblewildfood.com said the leaves can be put in salads or added to smoothies.

Another site, www.naturallivingideas. com, recommended putting the leaves in soup and making tea with them. "Generally, you can use it just like you would any other green. The plant can also be finely minced and used as a garnish like you would an herb ... Purple deadnettle is highly nutritious. It's abundant in vitamins, particularly Vitamin C, along with iron and fiber, while the oil in its seeds is packed with powerful antioxidants."

The site suggested the leaves be placed on wounds or cuts to stop bleeding. "Research published in 2007 in the Hacettepe University Journal of the Faculty of Pharmacy in Turkey, found it to be effective against the E. coli bacteria and others too. Its anti-inflammatory properties were documented in 2008 research in the Journal of Ethnopharmacology."

In the 17th century, "Culpeper's Complete Herbal: A Book of Natural Remedies for Ancient Ills," listed the leaves as making the "head merry, drives away melancholy, quickens the spirits, is good against quartan agues, stancheth bleeding at mouth and nose, if it be stamped and applied to the nape of the neck; the herb also bruised, and with some salt and vinegar, and hog grease, laid upon a hard tumour or swelling, or that vulgarly called the king's evil, do help to dissolve or discuss them; and being in like manner applied, doth much allay the pains, and give ease to the gout, sciatica, and other pains of the joints and sinews.

It is also very effectual to heal green wounds, and old ulcers; also to stay their fretting, gnawing and spreading. It draweth forth splinters, and such like things gotten into the flesh, and is very good against bruises and

burnings."

So, my yard is filled with the wonder drug that also is also supposed to be loved by bees. But, in my yard, the bees prefer cherry blossoms, just like me. Yippee!
