Eastern Shore Remembers a Life of Service and an Education Legacy

John "Jack" Gray would squint his eyes and wave his hands when he talked about something that was important to him. Two of those subjects, in particular, were county schools and his alma mater, ODU. But he was interested in everything having to do with his native Accomack County.

The former teacher, school principal, school board member, and county supervisor died last week, a day after his 88th birthday, causing hundreds to change their Father's Day plans so they could attend his funeral Sunday at Modest Town Baptist Church.

Most people knew him as "Mr. Gray," following the traditional way to address a teacher.

Mr. Gray was a teacher at Atlantic High School, which later became Arcadia, for six years. He served as principal at Parksley, Atlantic, and Arcadia High Schools for a total of 24 years; was on the Accomack school

School Board Member Challenges Others To Think Differently About Discipline

Northampton schools attempt to manage student behavior using a broken discipline system that simply needs “restoration,” not a complete transformation, according to one school board member.

“We have challenging students, and we need to be responsive because that’s the hand we were dealt,” said school board member Nancy Proto, a retired school psychologist who lives in Cape Charles.

Northampton ranked in the top 10 or 20 of 130 Virginia school divisions for high suspension rates five years in a row, from 2012 to 2017.

Proto is an advocate for reducing Northampton’s suspension rates by implementing restorative discipline in its schools.

Restorative discipline ranks teaching good behaviors above punishing bad behaviors as a more effective means of changing behavior.

At the Northampton school board meeting June 13, Proto challenged existing ideas on student discipline by showing two video clips of disruptive students (not from Northampton County) and asking school board members how those students should be disciplined.

One clip showed a student sitting in a school bus, arguing with the driver and shouting obscenities at her.

For this nonviolent but defiant behavior, school board chairman William Oakley said the student would “get off the bus for the rest of year. I don’t care how long it was. When I was an administrator, he’d be gone.”

“That’s an adult he’s speaking to,” he added. “I would talk to him, explain to him what he did, why it was wrong, and why it’s not acceptable.”

School board member Maxine Rasmussen agreed. As a parent, she would not allow the teen to ride the bus. He would have to ride his bicycle to school.

“If he were my child, he’d have his mouth washed out with soap,” school board member Jo Ann Molera said.

School board members saw only a one-minute clip of the video that was taken by another student and posted

on YouTube.

According to the YouTube user, the student didn’t yell or curse until after the bus stopped. The driver stopped to call 911 when the student defied her order to move after he sat down and hugged a female friend who had a bad day.

During the uncut video, the student asks the bus driver why he is not allowed to sit next to another student. She doesn’t answer.

Sometime after the incident, the bus driver was replaced, the YouTube user stated.

Proto made it clear that the offending student’s reaction was not acceptable.

But punishments are not effective, she said. Out-of-school suspension is the most severe and least effective form of punishment because “we pretend school is like Six Flags.”

For many students, staying at home is more like “Six Flags” because they get to sleep in, watch TV, and play video games, she said.

In-school suspension is better but still ineffective. Students remain in school, but they still get a vacation from sitting in the classroom and learning new material, and they eat lunch with their peers and socialize.

Detention is treated as the “weakest” form of school discipline even though it can be the most effective, Proto said.

She recommended more frequent use of after-school detention and a structured school day, meaning the offending student attends class but loses social privileges for the day and doesn’t eat breakfast or lunch with peers.

The restorative aspect would be a “character project” completed during detention. For example, if a student was in a physical fight, his project might be researching the law and the real-life consequences of assault.

Restorative discipline would be an additional tool for shaping student behavior, not a replacement for in-school and out-of-school suspensions, she said.

The school board is expected to discuss Proto’s findings early on in its next meeting June 27.

board for six years; and was elected to the District 5 seat on the Accomack board of supervisors for two four-year terms.

"I didn't really know Mr. Gray that well until he was elected to the board of supervisors," said Supervisor Grayson Chesser. "I knew him by reputation, which was good. I sat beside him for seven years. The only time I didn't sit beside him was the year he was chairman. I've never met a finer gentleman in my entire life. He was just a good man. They don't come any better than Jack Gray. Honest and honorable to a fault."

"Mr. Gray couldn't hear very well," Chesser continued. "I could hear just barely better than he could and he expected me to interpret what was being said. That was really the blind leading the blind," Chesser said, and laughed, and then added in a serious tone, "He was a pleasure to be with."

Mr. Gray's dream was to get local offi-

cial — those on the school board and on the board of supervisors — to renovate the former Accomack Primary School so it could be used for something instead of sitting there vacant as it has for years. That vision never happened. It is still owned by the school board and it is used for storage.

When Sheriff Todd Godwin attended Arcadia High School, Mr. Gray was his principal. "He cared about the students and he was all about Arcadia," Godwin said. "He's definitely going to be missed. When he got fired up, he could take that pen out of his pocket and it was like he was conducting an orchestra (or) like he had a magical wand. He was a good man."

"What a fine man," said Audrey Furness, a longtime member of the Accomack school board. She got to know him when he was principal at Arcadia and he would call her for help.

Mr. Gray had the perfect advice for a new principal who took over at Parkley High School after he left the post, Furness said. "You pretend every brick of this

building is your own," she said Mr. Gray counseled. "I understood because when something is our own we try to take care of it," she said. "When he died he had to have had a contented and peaceful mind regarding education because he did everything he could. He always talked about education. I didn't hear of negative comments about Jack Gray. He was into what he needed to do and he did it by the book."

Accomack County is blessed that Mr. Gray went into education, Furness said. "He loved his community. He was a great, great person." She said he encouraged students.

Harris Phillips, who succeeded Mr. Gray on the board of supervisors, immediately released a written statement last week just after Mr. Gray's death. "Today is a sad day for Accomack County with news of the passing of Mr. ... Gray. He was a great man and a great public servant for more years than many of us have been alive. He loved our county and our schools and his guidance improved both."

Phillips ran against Mr. Gray in the race for supervisor four years ago. He said Mr. Gray was his opponent and his friend. "Neither of us uttered an unkind word about the other and were gentlemen throughout the campaign. I wish there were more people like him, he was

one of the great ones. My prayers and condolences go out to Mrs. Gray and the rest of their family. Rest in peace, Mr. Gray."

Connie Burford, of Bloxom, wrote to the Eastern Shore Post about Gray, who was also her principal. She said he made an impression on her, she considered him her friend, and he encouraged her to run for school board. "He was an icon at Arcadia High School. As an administrator, he not only set the bar high, he raised it so high that most others after him have struggled to reach it. There will never be another like him who loved his school, the school system, and this county and its citizens as a whole. Mr. Gray was a devoted Christian who served as a deacon at Modest Town Baptist Church for 50 years. Furness said he was also the leader in getting baccalaureate services back at Arcadia.

"Jack Gray was committed to a life of service, especially to the northern end of Accomack County," said Rose B. Taylor, the current principal at Arcadia High. "Even after retiring, Mr. Gray worked tirelessly to support and promote the work being done at Arcadia High School. He was instrumental in bringing back our baccalaureate service and celebrating student success. He will certainly be missed."

Joe Ferebee was a teacher at Bad-

ger, the vocational school at Arcadia High. "He was a very good man," Ferebee said. "He was always the same. He had the children at heart. He wanted to make sure they did the best they could. I thought he always treated his teachers well. And he was a man, I would say, who started out as a lot of us on the Eastern Shore. He started out as a farmer and then got his degree and taught history."

"I'm not sure he volunteered but he liked it," Ferebee said of Mr. Gray coaching girls basketball at Parksley. Ferebee also

said Mr. Gray often went to ODU women's basketball games. "He was good church member. I would go with him to put the flags out in the cemetery for Veteran's Day and Memorial Day at Modest Town."

He married his wife, Barbara, a widow with five children, the youngest still in diapers, said Ferebee. "He did well by them. He cared for those children. They treated him as dad. He could always tell you a story... about them ... The only pride I could say in his heart and his mind was his wife and sons. I taught two of his sons."

Furness remembered how Mr. Gray took the new teachers under his wing. His wife was a bus driver. She would drive and he would be the spokesperson on a bus full of new teachers "from everywhere. That tells you how he loved his community. He'd show them points of interest ... He would feature the things that were important. It would last all morning. At the end of the tour they would end up at a luncheon," said Furness.

Accomack County supervisors observed a moment of silence at their Wednesday meeting to honor and remember Mr. Gray.

ONANCOCK MAN ADMITS HAVING PIPE BOMBS, DRUGS

Rashem Huhi Amun-Re, of Onancock, a violent felon, admitted Wednesday in Accomack Circuit Court to possessing cocaine, heroin, marijuana, guns, a bulletproof vest, more than \$2,000 in cash, and two pipe bombs, when he was arrested last August after police came to his house looking for a suspect in an unrelated hit-and-run crash.

His motives for having explosives, guns, and the vest were not mentioned during the trial. He told police he did not sell drugs, he used them.

Also known as Aman-Re, 40, he entered pleas via an agreement with As-

sistant Commonwealth's Attorney Randy Fultz. The defendant admitted to possessing the drugs, the bombs, being a felon and possessing guns, and possessing guns while possessing drugs, all felonies. Fultz did not prosecute a charge of possession of fentanyl, which couldn't be proved, and possession of a stolen gun because the original owner of the weapon could not be found.

Fultz also did not pursue drug distribution charges. He said although a search warrant was issued before the items were seized there could have been questions about the sweep police conducted after

smelling marijuana and being told no one was home by the accident suspect even though Amun-Re was inside. Fultz said the warrant did not list items the officers saw when they did the sweep.

Amun-Re had been free on an unspecified bond and was working at a local Royal Farms. Judge W. Revell Lewis III remanded him to jail to await sentencing set for Oct. 3. The defendant could be given up to 50 years in prison and fined up to \$15,000. Amun-Re legally changed his name from Terrell Stewart more than a decade ago. He was convicted of abduction and robbery that occurred in 1999.

Northampton Enrolls Almost 40% of County in Medicaid

Nearly 40% of Northampton residents receive Medicaid benefits since Medicaid expansion took effect in Virginia on Jan. 1, requiring Northampton County Social Services to commit 2.5 full-time employees to manage the enrollment increase.

"This is one of the best investments that we make," Spencer Murray, chairman of Northampton's board of supervisors said of the department of social services.

In 2018, the department provided more than \$41 million worth of assistance and services, about \$5 million more than the previous year, and that was with a slight drop in county funding.

Northampton contributed roughly 1.5% of what the department spent, or nearly \$752,000, about \$12,000 less than the previous year.

Nearly 82% of the local funds spent, or more than \$612,000, is reimbursable to the county, Mozella Francis, director of Northampton County Social Services said.

The department is funded with about 54% federal funding and nearly 44% state funding.

About one in three Northampton resi-

dents receive assistance from social services.

But from 2012 to 2018, there was an overall drop in the number of residents receiving social services benefits, from around 4,900 to 4,500.

The number of people receiving food stamps, officially named SNAP (Supplemental Nutrition Assistance Program), dropped from around 3,900 to about 2,900.

The number of people receiving welfare, officially named TANF (Temporary Assistance for Needy Families), dropped from 450 to about 200.

Supervisor David Fauber asked, "Are these numbers going down because they voluntarily are leaving and they're better off, they don't need to be on the programs, or is it something to do with the system that's ... getting them off this program?"

Francis said there are multiple reasons the numbers are down.

At one time, a family had to receive TANF to qualify to also receive SNAP, but that is no longer the case, Francis said.

But the number of people receiving Medicaid benefits increased from nearly 3,500 people to more than 3,900 people from 2012 to 2018, and it rose high-

er after Medicaid expansion.

Applications for Medicaid expansion were accepted beginning in November 2018. As of Jan. 1, 301 people had enrolled.

By May 17, 750 had enrolled, bringing the total number of Northampton residents enrolled in Medicaid to nearly 2,300.

But the number of people enrolled does not account for all household members served by the program. Medicaid now serves nearly 4,500 people in Northampton.

Murray said Francis and her team have done a "phenomenal job" of working through the influx of Medicaid applications.

He called social service workers the "frontline" responders who "sense and know the pulse of our community. They're the closest to what issues and challenges and problems that members of our community are having."

Accomack School Board Considers New Class Ranking System

Accomack high school graduations may no longer have valedictorian or salutatorian speeches as of 2022, because the two top-ranking students may no longer be acknowledged.

“We’ve had parents, students, counselors, administrators” ask that graduates no longer be ranked, Director of Secondary Education Karen Taylor said at the June 18 school board meeting.

Instead, each student with a GPA (grade point average) of 3.0 or higher would be recognized as an honor graduate.

An honor graduate with a GPA of 3.5 or higher would receive one of three Latin honor distinctions traditionally awarded to college graduates.

A student with a GPA between 3.5 and 3.75 would graduate cum laude or “with honor.” With a GPA between 3.76 and 3.99, a student would graduate magna cum laude or “with great honor.” A student with a GPA of 4.0 or higher would graduate summa cum laude or “with highest honor.”

Taylor indicated the title of valedictorian or salutatorian loses its significance when a tie for either of those

ranks must be broken by calculating each student’s GPA to one-hundredth or one-thousandth of a point.

“Why aren’t we honoring all the students?” she asked. “I mean, we should be encouraging excellence and the hard work they’re doing, the dual-enrollment classes they’re taking, but we only ... recognize number one and two.”

School board member George Waldenmaier pointed out that senior class rank and the Latin honor system are not “mutually exclusive” and both could be used.

He said class rank is “very important to kids in driving them for excellence – it’s who’s number one, who’s number two, who’s number three ...”

“... It’s more for the parents,” school board chairman Paul Bull interjected. “It’s kind of like Little League baseball.”

Taylor agreed that in some cases, parents are more concerned with class rank than students.

Another reason for using the Latin honor system is to acknowledge the academic achievements of students, such as those from military families, who transfer to an Accomack school during their se-

nior year and are not eligible for inclusion in the class ranking system, Taylor said.

School board member Audrey Furness asked if numerical grades are still used to determine class rank. Taylor said they are used only to break a tie that remains after two GPAs have been calculated to one-thousandth of a point.

But the fairness of that practice is questionable if a student’s grades in regular classes are compared to another student’s grades in advanced placement classes, Taylor added.

Any changes in the use of senior class rank or the Latin honor system

Victim Says Defendant in Kidnapping Case Is Innocent

The victim of an alleged abduction in Greenbackville says her boyfriend, who was arrested for the crime, did not kidnap her.

On Monday, Vermelle Tontrese Moore, 18, told Judge Gordon Vincent, of Accomack General District Court, that Jerry Antoine Satchell Jr., with whom she lives, did not force her into his vehicle. She was speaking at the judge's bench and was standing next to the defendant when she testified. It was impossible for spectators to hear all of the conversations.

A police report released last week stated the crime occurred at around 3 a.m. "Moore was a passenger in a vehicle traveling through the Captain's Cove subdivision in Greenbackville ... and was forcibly removed from the vehicle by Satchell," the report stated. "Satchell forced Moore into a dark green 1993 Ford F-150 pickup truck and fled the scene. As he was leaving the neighborhood, he intentionally backed into another vehicle and left the scene. No one in the vehicle that was struck by the pickup truck was injured in the crash."

It was the young woman's birthday and there was a party, she said in court. Moore implied Satchell came to her rescue as she was in a car with people who "were" her friends and had locked her in their car. "They wanted to take me to Berlin," Md., she said.

Commonwealth's Attorney Spencer Morgan told Vincent, "She has nowhere else to go. She was put out by her grandmother. (She is the) domestic partner with Satchell. Proceed very cautiously here. She's impressible. She's young."

"That is a lot of speculation," defense lawyer Paul Watson said of Morgan's comments. The abduction charge was initially filed in Accomack Juvenile and Domestic Relations Court but was transferred to Accomack General District Court on a formal request by Morgan.

Watson mentioned Moore could be seen in a video partying and dancing with Satchell. Special Agent Scott Wade, of the

state police and one of the investigators handling the case, said, "That was prior to 3 a.m. when he allegedly abducted her."

According to court records, Satchell, 21, lives in a camper west of ... Fleming Road in Hornstown. He was also charged with intentionally destroying property worth more than \$1,000 belonging to Doane Gayle and maliciously wounding Monae Odom.

Testimony Monday was that the car was damaged as the occupants were trying to stop Satchell.

Moore's disappearance was reported by state police as a Virginia Critically Missing Adult Alert at around noon June 12. Moore learned of this and contacted police at around 4 p.m. Satchell's pickup was also recovered that afternoon,

Officers continued to search for Satchell, who turned himself in the next day. He is being held in Accomack Jail. Vincent set two secured bonds. One was for \$15,000 and the other was for \$3,000. A preliminary hearing was scheduled for Aug. 12.

Two Charged With Violent Crimes

Two local men were charged with violent crimes, according to records filed in Accomack General District Court.

Anelso Perez-Martin, 33, of Maryland Avenue in Onley, was charged with attempting to maliciously stab, cut, or wound Ezekuiel Barrtolon with the intent to maim, disfigure, or kill. The incident occurred June 11. He was arrested the same day. Perez-Martin is being held without bond. Deputy J. Sharp, of the Accomack County Sheriff's Office, investigated.

Cesar Tecum-Ajanel, 25, of Big Road in Bloxom, was charged with strangulation in connection with a June 12 incident. The victim's name was not included in the court record. Tecum-Ajanel is being held without bond. Sharp investigated. A preliminary hearing was set for Aug. 12.

Sylvester Antwine Chaney, 35, of Rantz Street in New Church, was charged with making a false statement on a firearm transaction record. The crime occurred March 5. Chaney was arrested June 14. A secured bond was set at \$2,500. Trooper G. L. Gallimore investigated. A preliminary hearing was set for July.

Walter Pierre Thomas, 20, of Roxburn Place in Willingboro, N.J., was charged with eluding on June 16. A

\$2,500 secured bond was set. A preliminary hearing was scheduled for Aug. 19. Sgt. George Bennett, of the Onley Police Department, investigated.

Nickolas Ronald Barnes-Cromwell, 26, of Catherine Street in Parksley, is accused of felony hit-and-run in a crash that involved injury on June 6. Trooper Dan Wallace investigated. A secured bond was set at \$10,000. A preliminary hearing was scheduled for Aug. 12.

3 Charged With Felonies in Northampton

Three people were arrested last week and charged with felonies, according to records filed in Northampton Circuit Court.

William Trevaaygn Townsend, 25, of Banks Road near Cape Charles, was charged with grand larceny of a vehicle on March 2. He was arrested June 7. Townsend is being held without bond. Sgt. David Eder, of the Eastville Police Department, investigated.

Lauren Dean Weber, 18, of Gladstonebury Road in Winston Salem, N.C., is accused of possession of cocaine. She is free on a secured \$2,000 bond. Office Roland S. Kellam, of the Chesapeake Bay Bridge-Tunnel Police Department, investigated. The incident occurred June 14.

Katharyn Cynthia Shafer, 18, of Fox Lake Court in Winston Salem, N.C., was charged with distribution of a Schedule I or II drug, possession of a fictitious ID card, and possession of alcohol by an underage person. Secured bond was set at \$3,000. Kellam investigated.

Woman Charged With Sex Crime With Minor

A 20-year-old Exmore woman admitted Monday in Northampton Circuit Court to taking indecent liberties with a 14-year-old girl. In exchange for that plea, charges of attempted sodomy with an object by force and contributing to the delinquency of a minor will not be prosecuted.

Assistant Commonwealth's Attorney Jack Thornton called the incident nauseating and said he made the deal so that the victim would not have to testify in open court. Thornton said he could have proven all the charges. He summarized the events for Judge W. Revell Lewis III, saying the woman was a friend of the girl's sibling. Spates

brought marijuana to the girl's house where the two were left alone until a man arrived, who also had marijuana and was 41 years old. The three smoked the drug and then had sex. Later, there was another sex act with the two females, Thornton said.

Not long after the incidents occurred, Spates went to a member of the girl's family and told the story and the girl's mother called the police. The girl was later found to have a sexually transmitted disease.

Spates was allowed to remain free on a \$10,000 bond until sentencing, which was set for Oct. 7. A presentence report and a psychosexual evaluation were ordered for her. The man is awaiting sentencing.

In another case, Ja'Quan Rkese Jones, 19, of Franktown Road in Nassawadox, was convicted of threatening to burn his family's home on Jan. 31, 2019. A statement that summarized the incident explained that Jones assaulted both his 11-year-old brother and his mother. Jones turned on a burner on the kitchen stove and said he was going to burn down the house. He was also convicted of two counts of assault and battery of a family member. A presentence report and guidelines were ordered.

Jeffery Arthur McNeilan, 31, of Parsons Circle in Cape Charles, was convicted of unauthorized use of a vehicle in January. A presentence report was ordered. A charge of possession of meth was taken under advisement. Sentencing was set for Sept. 30.

Fatima Anderson, also known as Devin Dequanna Holder and Devin Dequanna Holden, 36, of Route 405 in Muncy, Pa., pleaded guilty to five counts of forging a public record, five counts of uttering, grand larceny, grand larceny with intent to sell, and providing a false ID to an officer. The offenses occurred in 2017. A mental evaluation was ordered.

Cape Charles Library in a Quandary Over Memorial Plaque

Cape Charles Memorial Library board members have thrown their hands up about what to do with what many consider a racist historical marker hanging just inside the library entrance, and they have turned to town officials and the state attorney general for help.

“In a lot of ways, this mirrors the controversy over the Confederate statues,” Linda Schultz said during the public comment period at the June 12 board meeting.

The Cape Charles library was founded in 1919, and at its dedication that same year, a plaque was presented bearing the names of all the men from the town who died in World War I, which ended in 1918.

The names on the plaque are segregated by race. Beneath the first seven names appears the word, “colored,” followed by 13 more names.

Hanging underneath the plaque is a small sign that reads, “This is the original plaque presented at the 1919 library dedication,” to provide some context for the memorial, but

it doesn’t tell the whole story, Schultz said.

“We have this wonderful, beautiful little upper-middle class haven here in Cape Charles. It wasn’t like that back in the day. It was segregated. African Americans were not even allowed to come into the library until, I think, the mid-’70s.”

Before the library moved to its current location on Mason Avenue, the plaque hung in the old library, a former church on Tazewell Avenue, which is now the Cape Charles Civic Center.

Library board members are questioning if the plaque is a war memorial as defined in section 15.2-1812 of the Virginia code. If so, it’s illegal to move the plaque and it could be considered stolen town property, Town Manager Larry DiRe said.

If the plaque is not a war memorial, then it’s like “another piece of furniture” and the library board can do whatever it wants with the plaque, DiRe said.

If the plaque is a memorial, then the question is whether it should be returned to its original location on Taze-

well Avenue or if it belongs in the library, wherever it is located.

Library board member Dianne Davis said the suggestion had been made to move the plaque into the library’s history room.

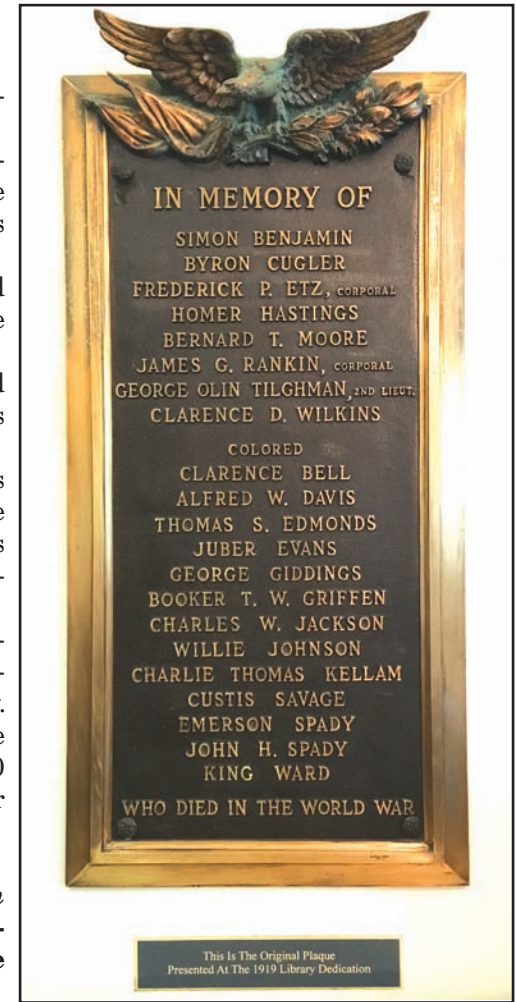
But board member Roger Moyer said historically, the board did not agree that the plaque should be moved at all.

Board member Chris Bannon called the plaque “special” for honoring blacks and whites together.

The next step is for the Cape Charles town attorney to send a letter to the state attorney general requesting his recommendation regarding the memorial plaque.

But the Cape Charles town council never appointed its legal consultant as the official town attorney. That action must be taken at the next town council meeting June 20 so the attorney can send the letter on the town’s behalf.

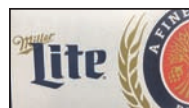

Final Pieces in Place for New Parksley Library To Begin Construction

“Yes, Eastern Shore, there will be a new library,” Vice Chairwoman Reneta Major announced Wednesday after the Accomack County Board of Supervisors approved a series of resolutions and votes paving the way for the Eastern Shore Library and Heritage Center to become a reality in Parksley.

The boards and committees associated with the project received applause and words of thanks. In the end, District 4 Supervisor Paul Muhly, who represents Parksley, gave credit to Supervisor Harris Phillips for realizing the old grocery store on Bennett Street could be rehabilitated.

Before Phillips and Muhly were elected four years ago, Phillips showed Muhly an article about what was done with the remains of a Texas grocery store. “I think Mr. Phillips deserves the credit about that,” Muhly said.

“I’m so happy the library issue is coming to an end,” said Phillips. “We can move forward. Thanks, everyone for the support.”

Members of library groups have been working for years to get a new facility.

The first action Wednesday was for the county to receive a deed of gift for the current library building from the library board of trustees. Accomack will lease it back to the trustees for \$1 until the new building is constructed. RH Contracting Inc., of Atlantic, which made the low bid of \$4,383,000, was awarded the contract. County Administrator Mike Mason was given the authority to enter into a contract on the county’s behalf but must wait until the library trustees receive a loan for \$750,000.

The supervisors also voted to secure \$2 million for the project at a rate of 3.173% for 20 years. They can pay the bonds off without penalty anytime after 2024. The cost per year was estimated at \$143,000. The entire project will cost \$5.1 million of which \$1.5 million is being funded by the state and \$850,000 was raised through donations.

Other formalities will include conducting a public hearing before amending the county budget to recognize approval of the project and the bond issuance and the final issuance of the bonds by the county economic development authority.

In other business, the supervisors directed staff to apply for a grant needed to install septic systems in the Makemie Park community. The area’s alternative sewer system serves 28 residences along Saxis Road. Officials said it is a private system, built with public funds, that could never handle an expanded capacity and was not maintained. The system is failing and poses a serious health threat. Grants of up to \$700,000 are available for conditions that alleviate serious and immediate health concerns.

While those monies would not be enough to install septic systems for all the houses, the plan is to install replacements in phases with the hope that the existing system will function properly when it is less stressed.

As the planning district commission does not have enough staff to pursue both the Makemie Park and Horntown projects, the latter would be delayed for a year or less.

Mason spoke about the state’s next phase for reducing nutrient and sediment entering the Chesapeake Bay. Localities were able to send comments to the Department of Environmental Quality. Mason said the word “expectations” was used throughout the draft. It was unclear what the repercussions would be if the best management practices are not fully implemented. The state plan also included a plan to increase the number of eligible counties in the poultry litter transport program from two to five and to increase the amount of litter transported annually from these counties to between 5,000 and 6,000 tons to 89,000 tons. In a submission, the county staff asked the DEQ what type of fertilizer will be recommended and how will the replacement affect water quality in the bay.

SUPERVISORS APPROVE NEW ACCOMACK AIRPORT REGULATIONS

Accomack supervisors revised rules, regulations, and minimum standards for the Accomack County Airport Wednesday for the first time in more than a decade and while a spokesperson for the local pilots' association said the final result was an improvement over the initial draft, not all the pilots are happy with the way things work at the local facility.

Airport Manager Barbara Haxter said the update was needed for compliance with federal agreements. "We appreciate the feedback from tenants," she said.

"After many changes, the final draft looks to be pretty good," said Randy Powell, of Wachapreague, the pilot group representative. "Greatly improved." He commended Haxter, County Administrator Mike Mason, and others for their "goodwill. We appreciate the cooperation very much."

But pilot Charles Simanski, of Onley, a 45-year pilot, was not so generous. "Our ability to function here is being diminished," he said, complaining electricity is not available at the newly desig-

nated airplane wash area so one can't vacuum or use other tools. For years, he said, the airport has had a self-service fuel pump but the county still pays someone to sit in the office and walk out when it is used. The prices are nearly \$1 above other places. "It's driving people away." He said maps are not available. "No pilots' shop ... No supplies. Nothing for kids even. You want to get a copy of the regulations, there's just nothing."

"Currently there are more aircraft than we have hangar space," said David Bright, a pilot from Wachapreague. He said despite the long list of local pilots waiting for a hangar, one was rented to an out-of-state resident with a plane that was not registered in Virginia. "We have aircraft owners who have been on the ramp for up to six years ... paying tie-down fees. And they were bypassed. I am on the waiting list. I am not next. ... Policies that are put out are not being followed."

"The airport has been neglected for a long time," said Jim Kaczmarek, a pilot from Parksley. He was happy to hear Mason's report about an Oceana aircraft maintenance group that volunteered to

paint the Navy A-4 jet displayed at the county airport and provide the paint with which to do the job. An initial estimate for the work was \$50,000. The county will only be responsible for the cost of housing for the workers for about a week. Mason said Haxter was the one who set up the solution. Kaczmarek said he talked to Haxter about getting a group to paint it three years ago with no luck. "Whoever made that happen on the board, I want to thank you."

Dwayne McCullough, of Onancock, a 10-year pilot, appreciates efforts to modify the rules and boasted about the pilots' association. "Those guys do a lot of good," he said mentioning aviation badges for Boy Scouts with 300 kids being flown at the expense of the pilots. "Some flew water to Tangier when its system was down ... It is a resource the county can use." McCullough said a group studying the possibility of oil spills contacted the association to see if the pilots would be able to spot any. "There are lots of other opportunities," he added.

In other action, the supervisors increased rates for the Central Accomack

Service Area by 4% to \$22.57 per one thousand gallons. The move was made after Onancock increased its rate to the county by the same amount.

The county received another \$10,000 grant for the demolition of the old Whispering Pines Motel, Mason said. The demolition will be completed by July 7, weather permitting.

The future home of the voter registrar's office and absentee polling site could be at Sawmill Park, Mason reported. A change is needed due to expanded absentee voter requirements. "The site has the preliminary approval of the registrar and electoral board chairman," he said.

The supervisors also approved a lease with the county's economic development authority for an unoccupied office at the county airport. The lease will begin Aug. 1 and will cost \$1 for the year.

County staff recommended awarding the construction project at the Emergency Operations Center fire training center, near Melfa, to Delmarva Veteran Builders, of Salisbury, Md., which was the low bidder. The project is an addition to the existing structure and will cost \$589,700.

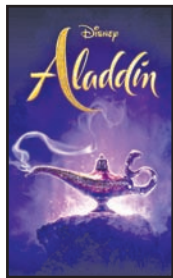

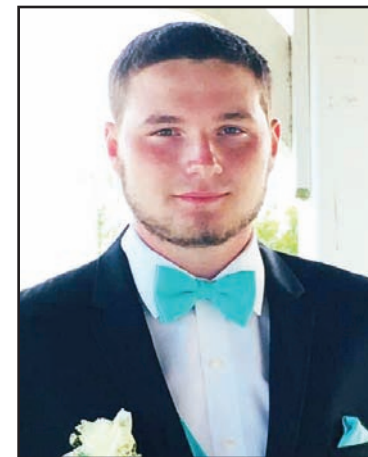

Fishing from the Shore

Cobia fishing has been red hot, at least as far as numbers are concerned. Some vessels have reported catches of over 20 fish and even a few catches exceeding 30 fish on a single trip! Of course, most of these fish are under the 40-inch minimum size limit, but there are enough keeper sized fish out there, if you are willing to put in your time. Still, there seems to be a lot of (justifiable) confusion among the recreational fishing community regarding the cobia regulations, the need for a permit just to target cobia, and the requirement to report every cobia fishing trip, even if you do not catch or keep a fish.

To keep a cobia in Virginia, the fish must measure at least 40 inches in total length. There is a bag limit of one fish per person, but no more than three fish can be kept on a single boat, no matter how many people are aboard. And to make things just a little more confusing for the weekend angler, only one fish per boat can measure in excess of 50 inches in length. In addition, all recreational anglers, captains, and guides must have a permit to fish for cobia. The permits are free and can be obtained from the Virginia Marine Resources Commission (VMRC) website. In addition, cobia permit holders are required to report all catches and cobia fishing activity to the VMRC, which can be done through the website.

Lower Shore – Chris Snook, at Chris' Bait & Tackle, said that the cobia action has been "great" with anglers catching lots of fish, though there are lots of undersized fish for every keeper. Spadefish are providing action around the fourth island of the Chesapeake Bay Bridge-Tunnel, though a lot of the fish are on the small side. Sea mullet (whiting) catches continue to come from the

waters just below Kiptopeke, while catches of croaker have been reported off the Concrete Ships. Flounder catches have come from out of Oyster and down by the Ditch when conditions have been favorable.

Jeb Brady, of Bailey's Bait & Tackle, reported that cobia fishing was excellent over the weekend for anglers who were able to get out, with action recorded from buoy 36A all the way down to Latimer Shoals. Some boats were reporting double-digit catches with most boats finding keepers. Spadefish action is picking up around Plantation Light and at the bridge-tunnel. Spanish Mackerel action is on the upswing, with a nice size class of fish in the mix. Action should only improve for these warm water fish as the temperatures rise. On June 22, the shop will celebrate its 50th anniversary from 2-6 p.m. Festivities include a fishing seminar from Nathan Richardson at 2 p.m., and Dalton Elliott will be performing until 6 p.m. There are lots of in-store specials and giveaways planned.

Wachapreague – A spokesperson from Trident Tackle reported that she had heard of action occurring in the offshore waters, but the inshore flounder fishing was off due to the wind and dirty water conditions.

Yellowfin tuna made their appearance in the Norfolk Canyon last weekend, with fish ranging from undersized "footballs" to 80-pound bruisers. Trollers also found good numbers of dolphin (mahi), as well as a few blue marlin, white marlin, and bigeye tuna. For those captains with good GPS numbers, deep water dropping

has been productive for both blueline and golden tilefish.

Chincoteague – Donna Rae Roeske, at Captain Bob's Marina, commented that the weather over the last weekend was a "tad" too windy to provide ideal flounder catching conditions. A few keeper flounder in the 19-22-inch class were pulled from the waters of the Chincoteague Channel. Assateague Channel provided more shelter from the winds and that provided easier fishing conditions, though the catching was not as good as the western side of the island. A few kingfish (whiting), croaker, and inshore sharks rounded out most of the recent catches. Roeske said that she expects action to take off out on Blackfish Banks around the submerged subway cars and boxcars with the warmer weather.

Upper Shore – Allan Ring, at the Sea Hawk Sports Center, said that anglers were still finding some flounder inside the inlets but it was rough fishing all of last weekend. Ring recommended Berkley Gulps, minnows, silversides, and Fish Bite's "Bob's Your Uncle" selections for baits. The cobia bite was described as "really, really good" for anglers employing menhaden cut baits behind buck-

ets of bunker chum. Rockfish have settled into their summertime pattern, with best action occurring in the creek mouths on the first of the ebb tide, early in the morning and around sunset. Casting lead jigheads with paddletail grubs has been an effective. Ring also added that spot and kingfish (whiting) have made their appearance in the sound with catches coming on small hooks baited with pieces of peeler crab, bloodworms, and Fish Bites.

Bill Hall was the first Eastern Shore resident to achieve Virginia Salt Water Master Angler Status. He has been named Virginia Saltwater Angler of the Year and Virginia Saltwater Release Angler of the Year. Bill is an I.G.F.A. International Committee Representative and a longtime member of the Virginia Saltwater Fishing Tournament Committee. He is the Virginia Recreation Fishing representative on the ASMFC Striped Bass Management Panel and is a past recipient of the CCA-VA Virginia Outdoor Writer Conservation Leadership Award.

Cooking with Connie

Welcome to another edition where I attempt a new recipe and make all the mistakes so you don't have to. And while mistakes were made, the good news is the cake was a big hit! If you make the cake, send us a photo to editor@easternshorepost.com I had seen recipes for key lime pound cake everywhere over the last year. I had been wanting to try it and my daughter's high school graduation party was the right occasion. I have reproduced the recipe exactly as I made it. The cake was dense. It would benefit from two teaspoons of baking powder. Pound cakes without leavening rely on beating air into the batter during the creaming of the butter and sugar and the addition of eggs. This recipe beats air into the butter and sugar, but not the eggs. Next time I make it, I will add the baking powder. I also increased the amount of vanilla and that is already reflected in the recipe. Finally, my cake stuck badly to the pan. I greased and floured the pan, but the recipe called only for greasing the pan. I also might have become impatient and tried to turn out the cake before it was ready.

The Icing

Ingredients:

- 8 ounces cream cheese, room temperature
- 3-4 tablespoons butter, room temperature
- 4 cups confectioners' sugar
- 1/4 cup freshly squeezed key lime juice (or lime juice)
- 2-3 teaspoons key lime zest (or lime zest)
- 1.5 teaspoons vanilla extract

Directions:

Using a hand mixer beat cream cheese and butter in a large bowl until well mixed.

Add confectioners' sugar and beat well until completely smooth and fluffy.

Add key lime juice, zest, and vanilla and mix until all ingredients are incorporated.

Ice cake.

Key Lime Pound Cake Takes the Cake

The Cake

Ingredients:

- 4 sticks butter (that's 1 pound, room temperature)
- 3 cups sugar
- 6 large eggs, room temperature
- 4 cups all-purpose flour
- 1/2 cup fresh key lime juice (or lime juice)
- 1/2 cup evaporated milk (I always keep a good number of those small, 5-ounce cans in my pantry.)
- 4 teaspoons key lime zest, minced (or lime zest)
- 2 teaspoons vanilla

Directions:

Preheat oven to 300°. Cover inside of 10-inch tube pan with non-stick spray. Set aside.

Beat the butter until light in color and fluffy. Add the sugar and again beat well for at least 3-5 minutes, depending on the kind of mixer you are using

(less for a paddle-type stand mixer, longer for a hand-held mixer). The mixture will be very light and fluffy.

One at a time add the eggs and beat only until the yellow disappears.

Stir juice, milk, zest, and vanilla together.

Now mixing by hand, gradually fold the flour and into the butter-egg mixture alternating with the key lime juice and milk mixture, beginning and ending with flour. Mix just enough to incorporate all ingredients. Mixing too much will force the air out of the batter.

Pour evenly into the tube pan and tap on the counter to loosen any air bubbles. Bake for 1 hour and 45 minutes or until cake tester comes out clean.

Cool on a cooling rack for 20-25 minutes in the pan then transfer from pan to cooling rack and allow to cool another hour or until completely cool. I made the icing according to the directions and it was too soft. So I tried adding more confectioners sugar and it was too sweet. So then I added another brick of cream cheese and some more lime juice and it was just right, although then I had way too much frosting. I think next time I will do things in this order: Cream together cream cheese and butter. Add half of the confectioners sugar. Add half of the key lime juice and all of the zest. then add more lime juice or sugar to balance out consistency and taste.

VDACS will review applications in the order they are submitted to the Beehive Distribution online application and registration system. When funding for the program has been exhausted, VDACS will suspend accepting applications. Applications will not carry forward from the previous fiscal year.

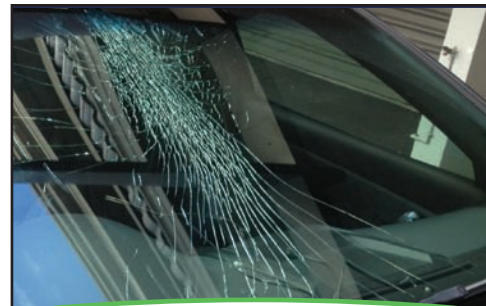



There are so many things to think about when cruising the roads of the Eastern Shore of Virginia. There are memories, wonderment, and scenes that make me visualize what may have been many years ago. Yippee!

At Bennett's Crossing, on Route 13 in Painter, for example, there used to be a putt-putt golf business that Clark Gladden operated in the summer just across the road from the railroad stop. There was also a vineyard/winery near the crossing. It was owned by a local lawyer and her husband and was the first of its kind on the Shore. The wine was pretty good and I got a little French lesson when I wrote a story about it in the 1980s.

I love the old worn buildings that are deteriorating. There is one between Pungoteague and Cedarview that used to be a theater. The roof has caved in but that doesn't stop me from seeing

a big screen and a filled house when I ride by.

Those old landmarks are not always an eyesore to me. Instead, they are what aids to navigation and what I use to give others directions. When the landmarks all disappear, I will have to learn the names of all the roads that were given titles while I was away from the area trying to make my fortune. That will not be pleasant.

I fondly remember the tree line that used to be behind 4 Corner Plaza. I also remember when the only business in the shopping center was Acme Market. It stood alone and proud.

Thankfully the new fire station in Tasley is going up and I will have a new landmark to take the place of the old Whispering Pines Motel. Sometimes I just say the intersection near WESR radio and people know what I am talking about.

I can scarcely remember what the entrance to Onancock used to look like when I was in school. Back then, Forks Grill, a restaurant, was smack dab in the middle of the road where one can turn to go to Tasley.

I've accepted the circle intersection at Tasley but I can still conjure in my mind the way it used to look. I can also remember what St. Peter's Church, in Onley, looked like before it had pews inside in 1968. I'm like an elephant that way.

The original Moose Lodge was on the highway in Belle Haven and is now the Rev. David Sabatino's church. It pains me to see the Idle Hour Theater in Belle Haven all closed down. It's been a while since I noticed a new message on the marquee. Near that is a beauty salon in what I consider a modern architecture building. That was once a doctor's office and the legal aid office. There is a house around that corner that was once on the market for \$37,000. I still notice it on the way from the cemetery and wonder how different my life would have been if I had bought it.

Exmore's town park always amazes me. There used to be a Chevrolet dealership there. I can see it every time I pass by. My stepfather, Jack Justus, had the auto body shop right beside it. The area looks nice

now. But it wasn't bad when lines of Chevys were in the lot either.

My brother and I were recently talking about the former Record Shop, in downtown Exmore, across from the old bank. A couple of doors down in the building with the blue bricks was the Silco store where I got my first job.

I visited the emergency room of the original hospital, in Nassawadox, one summer after accidentally breaking out the window of the back door of my house. I had a wrench in my hand and was going inside to tell on my brother. When I pushed it open and the glass broke, a big shard of glass cut into my bicep and I was stitched up at the first NAM (Northampton-Accomack Memorial) hospital on Rogers Drive. I can also recollect Assateague Beach when marsh grasses were planted along the sand dune and one would have to wait for an hour in the line to get to the sand. It wasn't too long ago that one had to cross the original bridge to Chincoteague to get there. The remains now serve as a pier.

How fast we get used to the new scenery. Thanks for the memories. Yippee!
