## SEAHAWK RESTORED, REPAINTED AT MELFA AIRPORT

The Navy A-4 Skyhawk that is displayed next to the Accomack County Airport terminal in Melfa was given a new paint job this week.

The initial estimate for the work

was \$50,000. Maintenance is required by the Navy as part of the loan contract with the National Naval Museum in Pensacola, Fla. But the county was only responsible for housing a handful of Oceana aircraft maintenance team

members for about five days, instead of paying thousands of dollars to get the plane painted.

At the start of the project Monday, Petty Officer Robert McClure, the team

# Catholic Priest in Pocomoke Removed From Office and Suspended

The Rev. William J. Porter was removed from his post at Holy Name of Jesus Church, in Pocomoke, Md., last week and was suspended from “exercising priestly ministries” after a Delaware State Police investigation of alleged sexual misconduct was halted because the statute of limitations had expired.

The accuser was a teenager when the offense is alleged to have occurred at Our Lady of Fatima Parish in New Castle, Del., 38 years ago. The Catholic diocese was made aware of the allegation March 1. Now, another investigation, this one by the Wilmington Police Department is being conducted regarding a similar incident there.

In response to the allegation, the diocese said in a statement, it notified the state police and the state attorney general’s office. On July 19, 2019, church officials said they were notified the state police “investigation was complete because the conduct occurred outside of the statute

of limitations.”

Porter is currently under investigation by the Wilmington Police Department for alleged similar conduct. The Diocese of Wilmington stated it encourages those who have been sexually abused by a member of the clergy or anyone else to immediately notify authorities.

Porter was ordained in 1975. He has served as pastor at the Pocomoke church since 2003. He was the pastor at St. Luke/St. Andrew in Ocean City, Md., from 1991 to 2003; was a faculty member at St. Elizabeth High School in Wilmington from 1982 to 1991; and served on the faculty at Saint Mark’s High School

in Wilmington from 1979 to 1982. Additionally, Porter was an associate pastor at St. Catherine of Siena, Wilmington, from 1978 to 1979. He was also an assistant principal at St. Elizabeth High School from 1977-1978 and an associate pastor at St. Elizabeth Parish, in Wilmington, from 1975 to 1977.

“The Diocese of Wilmington is committed to protecting children and to providing support to survivors of sexual abuse,” an announcement stated. “We recognize the courage of those survivors who come forward to tell their stories after so many years. In acknowledging the pain suffered by survivors of abuse, Bish-

op W. Francis Malooly requests the faithful of the Diocese to join him in praying for the healing of all who have been harmed by abuse, for the countless lives affected by such actions, and for the many priests of the Diocese of Wilmington who have been faithful to their vocation and the people they serve.”

A spokesperson for the Delaware police referred a reporter to the diocese’s statements. Questions were referred to a public relations officer at the Wilmington Police Department but the phone was not answered. Parishioners were told about Porter’s leaving the Pocomoke church last Saturday night when Mass began.

# Rocket Lab Ready To Build at Wallops Research Park

The kinks have been worked out of Rocket Lab's site plans for the Wallops Research Park, approval has been obtained for all but the lighting, and construction is expected to begin in a month or two, Accomack County officials said this week.

The New Zealand-based company wants to send small rockets from Wallops Island and build a local facility at the park. The company is known in the aeronautics world for delivering "small satellites to low earth orbit at an unprecedented frequency."

Rocket Lab will be the first to occupy space in the \$8 million WRP, which is about a decade old.

District 2 Supervisor Ron Wolff, an avid supporter of NASA and space programs, said Tuesday that construction restrictions were too stringent in the initial 2009 covenants at the park, which is likely what keeps tenants away. Wolff was recently elected chairman of the WRP Council.

The council voted unanimously last

week to approve the final site plan as presented by VA Space / Rocket Lab. The vote was based on the recommendation from the Site Plan Review Committee, which was composed of council members.

The detailed plans provided to the county were marked "not for public release" and were not made available to the Eastern Shore Post. But according to the council meeting minutes, which were provided, requirements were waived for design, delivery, loading doors and docks, and dumpster enclosures. Security fencing and designs and plans for storage tank systems were approved.

"I'm glad to see that things are starting to move forward in a more positive way," said Wolff. "We've been a long time without too much activity. This is a good thing," he added. "Building materials have changed" in 10 years. "We need to update those."

There was a lot of give and take," Wolff continued. "In the process, there was a lot of looking back at the cove-

nants." Since Rocket Lab announced its intentions, there has been more interest in the park, Wolff said.

According to the minutes, the building will be all metal. The covenant called for a maximum of 20% metal roofing or siding. Also, more than 5% listed in the covenant will be permitted for a corporate identity or accent color.

A waiver was also made in regard to the pavement in all parking, delivery, and loading areas. In the covenants, no

truck entrance doors, loading areas, bays or docks were allowed along a street frontage. Since the Rocket Lab lot is on a corner, the areas would be allowed to face the side road and would be partially screened instead of totally screened.

Security fencing was also approved. A lighting plan will be required before a building permit will be granted. In addition, a fuel tank will be permitted behind the building and the dumpster enclosure will be permitted to be constructed of something other than metal.

## Accomack Airport Receives Federal Grant

Accomack County Airport in Melfa was among eight Virginia airports to share more than \$13 million in federal funds, Senator John Warner and Tim Kaine announced Friday.

The Accomack facility's grant of \$94,500 is earmarked to rehabilitate an apron where aircraft are parked, unloaded or loaded, refueled, or boarded.

The money will come from the "FAA's Airport Improvement Program, which provides grants for the planning and development of public-use airports that are significant to national air transportation," according to the announcement. Also sharing the funds are airports in Charlottesville, Culpeper, Danville, Farmville, Mattaponi, Quinton, and Roanoke.

leader, said the plane was in good condition and didn't need the usual scrub down. So, members got right to putting on protective gear and sanding the Skyhawk.

The Naval team doing the work is Ambush Fighter Squadron Composite VFC-12. A squadron by the same name flew the aircraft in the 1950s. As a lightweight, single-seat, single-engine attack aircraft, it had outstanding low-speed control and stability during both takeoff and landing that made it ideal for carrier operations, a brochure, available at the airport, states.

"Pound for pound, she is easily one of the most effective and versatile light attack planes ever produced ... her dry weight of 10,465 pounds earned her the nickname 'Heinemann's Hot Rod' after Douglas Aircraft Company's chief design engineer Ed Heinemann," the pamphlet continued. "Between 1956 and 2003, McDonnell Douglas pro-

duced 2,960 units of various models of aircraft. All models had two internally mounted 20mm cannons and were capable of delivering both conventional and nuclear weapons day or night."

Airport Manager Barbara Haxter gave Jim Metcalf, of Virginia Beach, a frequent visitor at the local airport, credit for finding the team and "mak-

ing this possible." She had discussed the need with him and that the airport was actively looking for experts to do the job.

"Suddenly one day in April of this year, he came in and said, 'I have a squadron ready to come over,'" Haxter reported. Metcalf, a retired US Navy captain, reached out to the VFC-12's skipper, Commander Roy-

al Gordon, who in turn assigned the crew to paint the A4-F. Metcalf flew the A4 during his military career, Haxter said.

The aircraft was transported in three sections from Naval Air Station Oceana in March 1995. The initial plan was for the plane to be displayed at the entrance to the industrial park.

"The annual sales tax holiday makes many important items more affordable for Virginians as they get ready for the new school year or stock up on basic supplies," said Gov. Ralph Northam. "I encourage families in every part of the Commonwealth to mark their calendars so

they can take advantage of the savings this weekend, while also supporting the Virginia businesses in their communities."

**School supplies, clothing, and footwear:** Qualified school supplies – \$20 or less per item, and qualified clothing and footwear – \$100 or less per item. School supplies include items like notebooks, pencils, lunch boxes and reference books.

**Hurricane and emergency preparedness products:** Portable generators – \$1,000 or less per item; gas-powered chainsaws – \$350

or less per item, chainsaw accessories – \$60 or less per item, and other specified hurricane preparedness products – \$60 or less per item.

**Energy Star and WaterSense products:** Qualifying Energy Star or WaterSense products purchased for non-commercial home or personal use – \$2,500 or less per item.

# Exmore To Host Fourth Annual National Night Out Celebration

Exmore will join neighborhoods across the state and throughout the nation in celebrating National Night Out the evening of Tuesday, Aug. 6, from 6 p.m. to 9 p.m. National Night Out is a family-friendly event focused on strengthening the bonds between local police teams and the communities they serve. Hosted by Chief Angelo DiMartino and the Exmore Police Department, Exmore's National Night Out (NNO) is the only registered NNO on Virginia's Eastern Shore and is open to everyone in Northampton and Accomack counties. It's free, and it's shaping up to be a fun-filled evening with something of interest for all ages.

Now in its fourth year, Exmore's NNO, a "Party in the Park," is full of activities and entertainment for the entire family, with music, food trucks, bounce houses, cornhole competitions and more, including the park's spacious, lighted playground for the kids.

"While the goal is to have a good time, the underlying serious intent of the evening is never lost," said Chief DiMartino.

no. "Everyone has a role to play in keeping our communities safe. By partnering and working together cooperatively, we can achieve the best results."

To that end, there are educational exhibits and demonstrations from dozens of community groups and civic organizations who will be on-site providing educational information. The Northampton County Sheriff's Department is returning for the fourth consecutive year to offer free IDENT-A-KID fingerprinting, and the Exmore Police Department will be handing out firearm safety information and gun locks. There will be games, giveaways, and other surprises.

National Night Out has been held annually on the first Tuesday in August since 1984. Sponsored by the National Association of Town Watch in the United States, the event began with neighbors turning on their porch lights and sitting in front of their homes to demonstrate solidarity against crime. This simple gesture communicated a powerful message to lawbreakers: our police officers are supported by extra eyes and

## Melfa Man Killed in Norfolk Was Shot in the Head

A Melfa man, who was killed in a shooting last week, in Norfolk, Va., died from a gunshot wound to the head, according to the state Medical Examiner's Office.

Markee Turner, 29, of Seaside Road, died at the scene of the shooting in the 6500 block of North Military Highway. The death was ruled a homicide. The incident occurred Thursday July 25.

Tamian Davis, 23, of Clover Hill Drive in Portsmouth, Va., was also injured in the shooting. He was taken to a hospital in Norfolk, where he later died from his injuries.

Dispatchers received a report of "a gunshot disturbance" at about 7:50 p.m. When police arrived, they located the two victims inside a parked car.

A motive or circumstances surrounding the deaths have not been disclosed.

## Atlantic Man Sentenced

An Atlantic man was sentenced last week to 10 years in prison for breaking into a home and stealing money

Ray Ellis Townsend, 62, of Townsend Lane, was given five years each for burglarizing George Brothers' house at night and stealing \$500 or more on Nov. 28, 2018. The terms were set to run consecutively with all but four years and nine months suspended.

In another case, Martinis Drummond, 38, of Doe Crossing Lane in Melfa, pleaded guilty to three counts of burglary, three counts of grand larceny, possession of burglary tools, and receiving stolen property. Presentence reports were ordered. Sentencing was set for Sept. 12.

Rodney Battle, 49, of Church Road in Accomack, pleaded guilty to credit card larceny, grand larceny, and credit card fraud in connection with incidents that occurred Sept. 2017. A January 2020 sentencing was scheduled.

Kendall Darrell Bibbins, no age available, of Accomack, was sentenced

to three years each for failure to register as a violent sex offender and giving false information as a sex offender. The offenses occurred in May 2015. All but time served was suspended.

Kenesha La Starr Scarborough, 33, of Bradley Court in Pocomoke City, Md., was sentenced to three years in prison with all but seven months suspended for assault and battery of a state trooper and resisting arrest in March 2018. She was fined \$500 for DWI and ordered to serve 30 days with 25 days suspended. Scarborough's driver's license was suspended for a year.

Corbin Kenji Drummond, 39, of Smith Road in Atlantic, was sentenced to five years each for extortion by communicating a threat in writing to kill or do bodily harm to Yoshika Jones and making a threat to bomb, burn, or destroy a building. All but time served was suspended. The incidents occurred Jan. 29.

## 106 Acres Added to Magothy Bay Preserve

### Submitted Article

In the first six months of 2019, the Virginia Department of Conservation and Recreation (DCR) acquired and added more than 1,045 acres to six DCR properties. This acreage expands existing state parks and adds land to future state parks. It will also protect and enhance habitat for rare species in the Natural Area Preserve system.

Additions include:

**Magothy Bay Natural Area Preserve:** 106 acres to be restored to provide migratory bird habitat. Funding was provided by the Virginia Coastal Zone Management Program, administered by the Virginia Department of Environmental Quality, and the Virginia Land Conservation Foundation.

**Clinch River State Park** (under development): 1 acre, to provide river access for canoes and kayaks. This parcel was donated by The Nature Conservancy.

**Clinch River State Park** (under development): 232 acres, the first anchor property in the "string of pearls" that will make up Clinch River State Park.

**Mount Joy Pond Natural Area Preserve:** 85 acres to protect rare species habitat and provide a smoke buffer for prescribed burn activities at the preserve. The acquisition was made possible by the Virginia Native Plant Society, which orig-

inally bought the property using a grant from the DuPont Natural Resource Damage Assessment and Restoration Settlement. It was then donated to DCR.

**Hungry Mother State Park:** 9 acres to provide a buffer at the entrance to the park and improve the visitor experience.

**York River State Park:** 401 acres made possible by funding from the Trust for Public Land and the Navy Readiness and Environmental Protection Integration Program.

**Mayo River State Park** (under development): 214 acres bought by the Piedmont Land Conservancy using Duke Energy Coal Ash Spill Settlement funds to buy this parcel, which the conservancy then donated to DCR.

"Virginia State Parks is pleased to work with numerous partners to ensure that significant additions are made for recreational and conservation efforts across the state. These acquisitions will help to provide outdoor experiences for current and future generations," said Virginia State Parks Director Craig Seaver. "Organizations such as the Trust for Public Land, Navy Readiness and Environmental Protection Integration Program, Piedmont Land Conservancy, Nature Conservancy and others are instrumental in making these acquisitions happen."

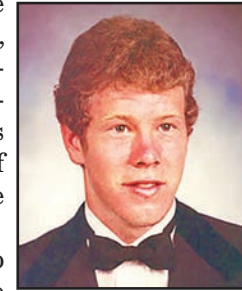

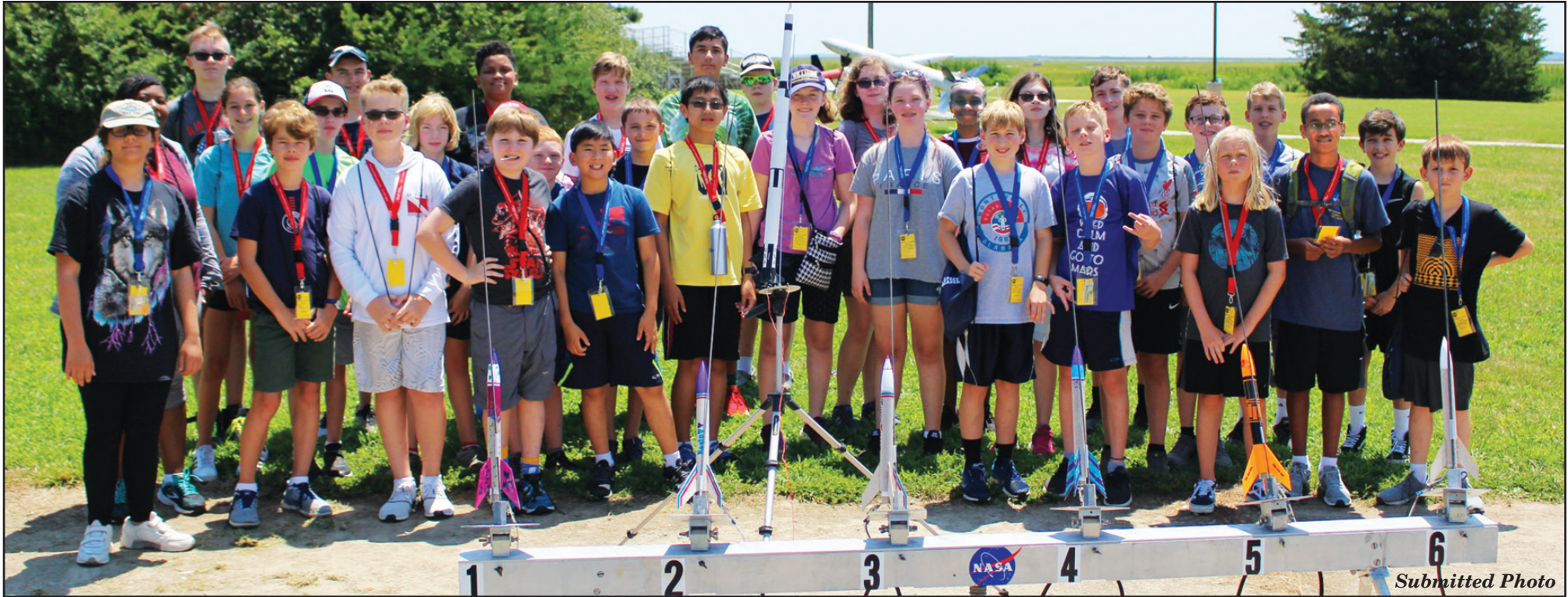

# Report: Assateague Island National Seashore Supported 1,192 jobs in 2018

A new National Park Service (NPS) report shows that 2,136,889 visitors to Assateague Island National Seashore in 2018 spent \$94,476,000 in communities near the park. That spending supported 1,192 jobs in the local area and had a cumulative benefit to the local economy of \$105,594,000.

“Assateague Island National Seashore welcomes visitors from across the country and around the world,” said Superintendent Debbie Darden. “We are delighted to share the story of this place and the experiences it provides. We also feature the park as a way to introduce our visitors to this part of the country and all that it offers. National park tourism is a significant driver in the national economy, returning \$10 for every \$1 invested in the National Park Service, and it’s a big factor in our local economy as well. We appreciate the partnership and support of our neighbors and are glad to be able to give back by helping to sustain local communities.”

The peer-reviewed visitor spending analysis was conducted by economists Catherine Cullinane Thomas and Egan Cornachione of the U.S. Geological Survey

and Lynne Koontz of the National Park Service. The report shows \$20.2 billion of direct spending by more than 318 million park visitors in communities within 60 miles of a national park. This spending supported 329,000 jobs nationally; 268,000 of those jobs are found in these gateway communities. The cumulative benefit to the U.S. economy was \$40.1 billion.

Lodging expenses account for the largest share of visitor spending, about \$6.8 billion in 2018. Food expenses are the second largest spending area and visitors spent \$4 billion in restaurants and bars and another \$1.4 billion at grocery and convenience stores.

Visitor spending on lodging supported more than 58,000 jobs and more than 61,000 jobs in restaurants. Visitor spending in the recreation industries supported more than 28,000 jobs, and spending in retail supported more than 20,000 jobs.

Report authors also produce an interactive tool that enables users to explore visitor spending, jobs, labor income, value added, and output effects by sector for national, state, and local economies. Users can also view year-by-year trend data. The interactive tool and report

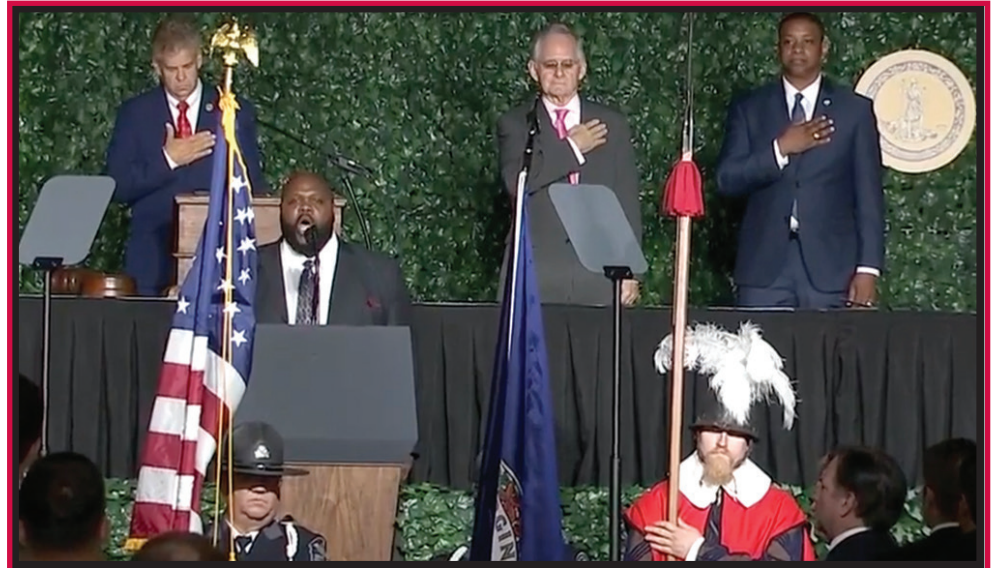

# Health Matters **Extreme Heat and Heat-Related Illnesses**

**S**ummer temperatures in Virginia normally climb into the upper 90s and even reach over 100 degrees at times. The hot temperatures and high heat indexes can cause ill health effects.

The body normally cools itself by sweating, but under some conditions, sweating just isn't enough. Prolonged exposure to heat can cause cramping, heat exhaustion, heat stroke, and even death. It is important to stay hydrated and seek cool temperature environments until the heat subsides.

Here are some tips to avoid heat-related illness during the summer:

**Drink water.** When the temperature rises, it is important to drink plenty of water. Drinks that contain caffeine, large amounts of sugar, or alcohol should be avoided because they can cause dehydration.

**Keep cool indoors.** On hot days, prevent illness by keeping cool indoors. If a home is not air-conditioned, try to spend the hottest hours of the day in a cool public place such as a library, movie theater, or store.

**Dress for the heat.** Wear lightweight, light-colored clothing. Light colors will re-

flect away some of the sun's energy. It is also a good idea to wear hats or to use an umbrella. Always apply sunscreen to exposed skin.

**Limit physical activity.** Avoid excessive physical exertion in hot temperatures, especially in the middle of the day. If one must work outdoors, stay hydrated by drinking two to four glasses of water each hour and take frequent breaks in a cool place. Even a few hours in an air-conditioned environment reduces the danger of heat-related illness.

**Do not keep children or pets in cars.** Temperatures inside a car with windows up can reach over 150 degrees quickly, resulting in heat stroke and death.

**Check on the neighbors.** Although anyone can suffer heat-related illness, some people are at greater risk than others. People aged 65 or older are particularly susceptible to heat-related illnesses and complications that can result during periods of high temperatures and humidity.

**Heat-Related Weather Terms:** Understanding heat-related weather terminology can help one prepare for hot weather.

**Heat Index:** is a measure of how hot it feels when relative humidity is added to

the air temperature.

**Excessive Heat Outlooks:** Issued when the potential exists for an excessive heat event in the next 3-7 days.

**Excessive Heat Watches:** Issued when conditions are favorable for an excessive heat in the next 24 to 72 hours.

**Excessive Heat Warning/Advisories:** Issued when an excessive heat is expected in the next 36 hours.

## Signs and Symptoms of Heat-Related Illness:

Several heat-related health conditions can cause serious health problems. When temperatures are on the rise, watch for the following symptoms:

**Dehydration** — Dehydration is caused by the excessive loss of water and salts from the body due to illness or from prolonged exposure to heat. Severe dehydration can become a life-threatening condition if not treated.

**Heat Cramps** — Heat cramps are painful, involuntary muscle spasms that usually occur during heavy physical activity in

hot environments. Muscles most often affected include those of the calves, arms, abdominal wall, and back. If someone is suffering from heat cramps, they should rest for several hours and drink clear juice or an electrolyte-containing sports drink.

**Heat Exhaustion** — Heat exhaustion occurs when the body loses too much water and salt from sweating during hot temperatures. The elderly, people who work outside, and people with high blood pressure are most at risk of heat exhaustion. Continued exposure may lead to heat stroke, which is life-threatening.

**Heat Stroke** — Heat stroke is caused by prolonged exposure to high temperatures or by doing physical activity in hot weather. Sweating has usually stopped and your body temperature becomes too high; body temperatures can reach as high as 106 degrees in 15 minutes. Heat stroke is a life-threatening condition and you should seek immediate medical attention if you or someone you know is suffering from heat stroke.

Twenty years from now Coleby Burford, above, hopes the first thing her former students will remember “is that I made an enjoyable experience for them but also that they felt loved and welcomed.”

Burford will begin her teaching career in a kindergarten classroom at Chincoteague Elementary School in the upcoming term. But in reality, she has been teaching since she was in kindergarten. She wants to create the atmosphere Lou Ann Burkhead provided when Burford was in kindergarten at Kegotank Elementary School. The other kindergarten teacher at Chincoteague, Amber Giddings, has been doing just that for 14 years. Giddings was also taught by Burkhead.

Burkhead “has been my inspiration to be a kindergarten teacher since I was in kindergarten,” said Giddings. “I think so many kids will tell you that it’s impossible to forget that first teacher. I remember that she loved us and made learning fun. And those are two of my most important goals in the classroom. I think it is special to teach in the same county as

your previous teachers. It gives you momentum and encouragement and in my case, it has always given me the opportunity to have another set of eyes and ears when needed.”

“That Coleby always had a light in her eyes,” said Burkhead. “Always a twinkle. I can see it now.” Burford “was very particular. Always wanted whatever she did to be just right. Very much a perfectionist. Very hard on herself. She helped others back then. She was teaching back then. It’s weird how things come back around. It’s really neat. She is so excited and just can’t wait and that’s so good to see.”

They’re a lot alike, those two,” she said of Giddings and Burford. “I can close my eyes and remember exactly. Loved life, loved school. Couldn’t wait to come back to school. Loved the holidays ... So many good memories. This will be year 31 years for me.”

Surprisingly, Burkhead never went to kindergarten. “My Dad was in the service in the Air Force. I was born in Japan. I guess kindergarten just wasn’t a thing back then.”

Burkhead said having taught both

women is “really neat to me. They are the luckiest kids in the world to walk into their two rooms. If I had a kid going into kindergarten I would want either one of them to teach them. That’s the best compliment you can give.”

Burford did her student teaching in a third-grade classroom. “I enjoyed it,” said Burford. “I loved the third graders. But I missed my little ones. I wanted the youngest kids. They’re so much fun and so creative.”

Both of the younger teachers know kindergarten is their calling. Giddings has now seen her first class graduate from high school. “It was so amazing to watch them graduate on the stage and know I had started them off so many years ago,” she said. “I think I had 13 or 14 in that class. Very sweet moment!”

Mrs. Burkhead and I have shared a few students over the years and it is a wonderful resource to have her experience and knowledge to call on,” said Giddings. “She has always been nothing but encouraging to me and helped me realize that while being in education is a constant learning experience, it was my calling and one I am so blessed that I

followed.”

Burford is expecting 18 to 20 this year. She’s been compiling a library of 500 books and counting. They were mostly donated by her college roommate’s mother who taught in Charlottesville. Other books will come from her mother’s friend in Washington, D.C., and from local friends. She was sorting the books into reading levels while she was talking.

“Every student should be able to look through my library and find a book that they like,” she said.

Burford is going to focus on the future. The kids will help her establish classroom rules so they will be less likely to break them. She also wants to get recycling started in her classroom and at the school.

“I was a newer teacher in the county when Lou Ann won for teacher of the year at KES,” said Giddings. “I was given the pleasure of writing one of her letters of recommendation for that. It was a huge honor and one I will not soon forget. I am very excited to teach alongside Coleby and know she is going to be an outstanding asset in kindergarten and at CES.”

# The Pony Auction Gallops to a New High

“A new record-setting auction” brought \$271,700 for 50 colts and fillies sold at the annual Chincoteague Volunteer Fire Company’s Pony Penning, according to spokesperson Denise Bowden.

The average price was \$4,700 with the high being \$17,000 and the low being \$2,000. It took half a dozen Saltwater Cowboys to control the first pony to be paraded out in front of a crowd of thousands. It sold for \$3,900.

Also early in the auction a “buyback” pony — one that is bought by a bidder and then given back to the fire company to stay with the herd and be raised on Assateague — was sold for \$16,000. The proceeds went to the local United Way. The winning bidder got naming rights and a certificate to take home.

The ponies swam the nar-

row Assateague Channel last Wednesday to Chincoteague. They were then herded down the streets to the Fireman’s Carnival where they were auctioned the next day. Those that weren’t auctioned swam back to Assateague last Friday.

The tradition of Pony Penning started in 1925. The event was made famous by Illinois author Marguerite Henry when she wrote about Misty, the palomino pinto with markings resembling a map of the United States on her side. Henry paid \$150 for Misty at the auction in 1946.

A popular pony that was sold this year, Elvis, went for \$6,000. He was Bowden’s favorite and will call Ohio his new home.

In 1982, 50 ponies were auctioned and brought a total of \$15,400. The top bid that year was \$600. Others were sold as low as \$175. The auctioneer insisted one filly was a Misty look-alike. In spite of his sales pitch, the pony sold for less than the \$308 average.

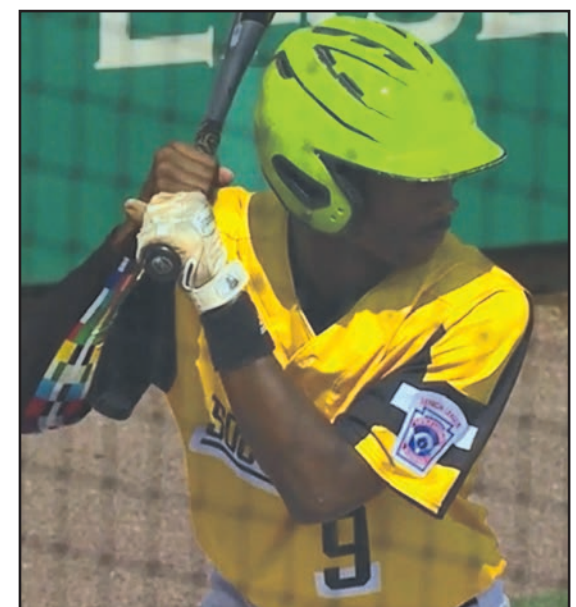

The vessel Miss Molly took Top Boat honors in the 2019 edition of the Eastern Shore Marlin Club's Annual Billfish Release Tournament with three marlin releases. Second Place went to the White Bite, which also had three billfish releases but lost out to the Miss Molly on a tiebreaker based on the third fish's time of catch. The Heat Wave finished in third place with two releases. Angler Brian Pruitt, aboard the No Limits, had the tournament's largest dolphin, which weighed 25.5 pounds. Captain Lindsay Paul aboard the Donzi took the largest tuna award. The 10-4 Joker with angler Gary Garvey released the first billfish in the tournament, a blue marlin. The tourney attracted a field of 16 vessels and a total of 17 billfish were caught and released.

**Wachapreague** – Stephen Sawyer, at Trident Tackle, reported that almost every boat fishing in the tournament over the weekend had catches of mahi and marlin encounters. The shop had registered citations for blue and white marlin releases, as well as a couple of sheepshead catches. Amanda Manzel-la, at the Wachapreague Inn, reported that lots of mahi, golden tilefish, and marlin releases were recorded over the weekend. The wrecks were producing spadefish, at least one cobia and even some mahi. Inside the inlet, limits of flounder were still being made by anglers willing to put in some time.

**Chincoteague** – Pete Vasiliou, of Captain Steve's Bait & Tackle, reported that anglers are having the best late July/early August keeper flounder action inside the Chincoteague Bay in the last six to seven years. Schools of bluefish have also been making sporadic appearances inside the bay as well as along the surf at Assateague. The shop has weighed in a couple of nice sheepshead that were caught inside the bay. Vasiliou said there are plenty of big sharks around, both inside and outside the inlet. The inshore wrecks are still holding flounder, triggerfish, and spadefish, while a large class of mahi is

being caught in the blue water.

Donna Rae Roeske, at Captain Bob's Marina, reports flounder are being caught on both sides of the Queen Sound bridge, while the waters inside of Chincoteague Channel are holding large schools of pinhead croaker. Inside the canal, small gray trout have been taken, some barely meeting the minimum legal size. The whiting/kingfish run continues between buoys 15 and 11. Sharks of all sizes and several species are spread from buoy 10 all the way out to Turner's Lump. On Blackfish Banks, Roeske said the rail cars are holding flounder, triggers, black sea bass, and spadefish, with cobia, dolphin and yellowfin tuna being caught farther offshore. The Parking Lot wreck continues to hold large sea bass, she added.

**Lower Shore** – Chris Snook, of Chris' Bait & Tackle, reported cobia fishing had rebounded "pretty good after slacking off" during the couple days of cooler weather last week. Lots of sharks are showing up in the cobia fishery and more red drum are showing up in the mix. A few puppy drum are starting to show up on the lower seaside. Spadefish continue to linger around the fourth island of the bridge-tunnel, while flounder are hanging along the bottom at the fourth island as well as beside the bases of the bridge pilings. Speckled trout are beginning to hit inside the lower bayside creeks. Croaker catches are still coming from out of Oyster and near Marker 262. Spot numbers are on the rise.

Jeb Brady, at Bailey's Bait & Tackle, reported that cobia fishing had slowed during last weekend, with a few keepers caught, but undersized fish and sharks were more abundant. Spanish mackerel were being caught down near the bridge-tunnel and up near buoy 36A. Brady said that the spadefish fishery remains productive both at the bridge-tunnel and around Plantation Light. Recent catches at the Cape Charles Pier include keeper-sized flounder, speckled trout, and gray trout.

**Upper Shore** – A few speckled trout are starting to show up in the upper bayside shallows, where small rockfish are still the most dominant species. Gil "Sevie" Pruitt recently landed a 23-inch speck while fishing inside Pomco Creek. Bottom fishing over the deeper water rocks is producing a mixture of bluefish, whiting (sand mullet),

spot and small croakers, with an occasional flounder. A few cobia are still being seen cruising the surface. Cow-nosed rays, locally called "bullfish," are a problem in both the shallow and deep

water. In the barrier island surf, spot and small whiting are hitting blood-worm and Fish Bite baits, while bluefish and a variety of sharks and rays are being caught on fresh cut bait.

## Cape Charles Camp Has Kids Sailing Through Summer

If you happened to pilot a vessel through Kings Creek in Cape Charles this week or last and encountered an

overturned Sunfish sailboat with its young occupants in the water, you probably learned quickly that no one was in distress. It was part of a new

day camp to teach children about sailing, and the first water lesson is how to right oneself if the boat tips.

Cape Charles Sailing Camp is the

brainchild of business partners and co-founders, Mia Guinan, who operates food and technology businesses, and applied kinesiology Ph.D. student and vet-

eran sailor and instructor Hannah Twiddy. Guinan said she wanted her kids to learn to sail, and “There were a lot of other moms who wanted to get in on that.”

Twiddy and Guinan are joined by instructor Emma Corbitt, who was a member of a club sailing team at Virginia Tech, and she has competed in regattas all up and down the East Coast.

Twiddy, having taught sailing for more than 10 years at local sailing centers and private lessons, is fulfilling a dream to start a local, grassroots sailing program, like the one she was in as a child growing up in Elizabeth City, N.C.

“They are learning really fast,” said Twiddy of this week’s students. “A lot of kids don’t know each other, but they are learning to work together.”

Teamwork is just one of the camp objectives. Sailing students learn about tides, wind, navigation, rigging, and knot tying. Some learned enough in the first week to come back and help out with the second week of campers.

At the end of the camp, the sailors-in-training take their parents out on the water. “They’re so proud,” Twiddy said of the parents. “They are excit-

ed and surprised by what their kids learned in a week of half days.”

Twiddy and Guinan targeted local allies: the Oyster Farm, which allows use of the docks for the sailing school, mayor and harbormaster Smitty Dize, the Studio Center, a digital marketing and media company, and the Cape Charles Yacht Club. The Jackspot sponsored an event to raise the funds for the first two weeklong camp sessions.

The pair was able to purchase a couple of small Sunfish sailboats; others were donated or are on loan for use by the 16 students during each weeklong morning camp. Only two weeks of camp were offered this summer during the camp’s inaugural year, but Twiddy and Guinan have big plans.

“We see it being a full-blown camp for the summer,” said Guinan, “and being a real amenity to Cape Charles.” She also hopes to offer private adult and group lessons.

According to Sports and Fitness Industry Association, more than 3.9 million people engaged in the sport of sailing in 2015, with just under a third of those

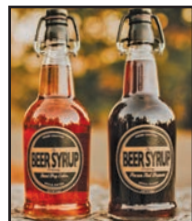
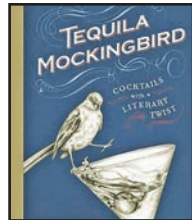

# SHAVE ICE SHACK SHAKES THE HEAT ONE SERVING AT THE TIME

Tucked away on Peach Street downtown Cape Charles is a bright yellow building with a teal-colored door, and the flavors inside the Peach Beach Shave Ice Shack are every bit as colorful as the building.

The 24 hand-mixed syrup flavors are made using pure cane sugar and purified water, says co-owner Jackie Jones, who added that there are also a few sugar-free options. Unlike snow cones, which are made from ice that has been ground into chips, shave ice is made by shaving a solid block of ice “so finely that it produces soft snow,” said Jones.

The soft texture of the ice keeps the syrup from going right to the bottom, as is the case with snow

cones. Instead, the flavors soak into the snow, which allows tasters to have up to three separate flavors in the same serving.

The technique is from Hawaii. The owners bought authentic equipment and kept the authentic name, “shave ice” rather than “shaved ice.” It is “the authentic Hawaiian way to say it,” Jones said.

Jones and partner Erin Harvey opened the business just over a year ago in a building that was a garage. The seasonal treat vendor is open from 11 a.m. until 9 p.m., seven days a week from Memorial Day to Labor Day.

When they aren’t at the Shave Ice Shack, Jones works as an educational consultant, and Harvey works as a documentary cinematographer.

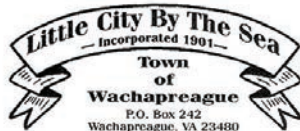

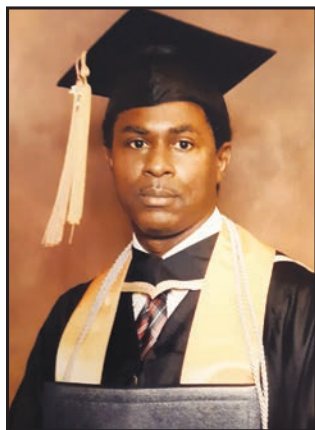

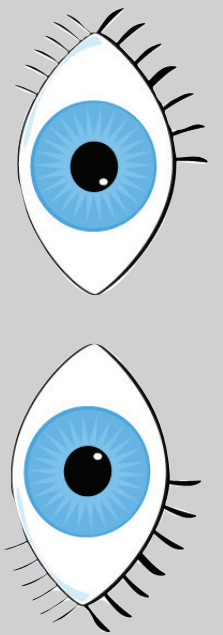
