Justice for George Floyd Protesters March in Exmore

Protesters observe eight minutes and 46 seconds of silence to mark the time a Minneapolis police officer pressed his knee into the neck of George Floyd, who died in police custody

A crowd of protesters who gathered in Exmore Town Park last Saturday evening stood silently for eight minutes and 46 seconds, the length of time that three Minneapolis police officers allowed a fourth to hold his knee on the neck of George Floyd, who died in police custody May 25.

"Justice for George Floyd" was organized by Kaliyah Diamond Weatherly, whose family lives in Exmore. Her goal was to protest "peacefully as we march and chant and show out for our black brothers and sisters against police brutality."

Another protest was held earlier in the day in Accomac, where hundreds marched from the courthouse green to the library.

Northampton County Sheriff David Doughty and Exmore Police Chief Angelo DiMartino addressed the crowd and thanked everyone for coming out.

"Mr. Floyd should have never had that happen to him. It should never happen again to anyone, ever. No one should ever feel in danger or at risk of danger while in the custody of the police," DiMartino said.

"Those officers – they don't represent us. They don't represent any of the of-

ficers that are here on the Eastern Shore that are here with you tonight. And we stand here with you all to give this message out, that it needs to stop, and it needs to stop now," he said.

Following the extended moment of silence, the group set out on its march through town.

Chants including "No justice – no peace!" were heard in the streets as the procession made its way up Main Street and turned onto Westfield Avenue.

Protesters shouted and raised signs bearing slogans such as "Black Lives Matter" and "Make America Love Again" as they walked around the block, down Broad Street, and turned onto Bright Street before arriving back at the park.

Following the walk, speeches were given by minister Quintavon Washington, of Accomac, Dr. Arthur Carter, of Nassawadox, and the Rev. Kelvin Jones, also of Nassawadox and the pastor of First Baptist Church in Capeville.

Carter offered up nine words for the

listeners' reflection, one for each of the nearly nine minutes George Floyd lay on the ground with a police officer's knee on his neck: truth, peace, justice, mercy, forgiveness; and organize, strategize, mobilize, and activate.

The first five words represented shared values of those protesting against racism, and the last four were actions that activists should continue.

"What I saw today was the embodiment of righteousness, of justice. Restorative justice policing," Carter said. "I saw public safety officers right here, among us and with us, speaking to the horror" of racism and Floyd's death.

"Even those who have done horrible things, let us provide mercy for them and to them, because all people, if they choose to, can transform," Carter said.

He spoke in support of restorative justice in both law enforcement and education and noted that minorities are disproportionately sent into the "school-to-prison pipeline" and education

Onley Mayor Responds to Censure Resolution

Mayor says allegations in censure resolution are false and May 19 special meeting was held illegally

Onley Mayor Matt Hart responded to a resolution censuring him passed by the Onley town council at the June 1 meeting.

The resolution was approved with four yes votes and two abstentions.

The item was not on the meeting agenda but was added that night, Hart said.

In a message to Onley residents posted on Facebook, Hart defended his actions and said a May 19 special meeting where the resolution apparently was discussed in executive session was held illegally.

"I assure you with 100% confidence that the allegations in the censure resolution by the Onley town council are false," he wrote in part, adding, "... I love this town and I am committed to serving the people of this town to the best of my God-given ability."

The resolution included the allegation that Hart created a hostile work environment for town employees and contractors, among other allegations.

Hart's attorney, David W. Rowan, in a letter included in the post, said he has requested audiovisual files from the May and June council meetings and said the special meeting "ap-

is withheld from kids who are perceived as misbehaving.

“Let’s hold our school boards accountable. And if they aren’t doing, instituting restorative justice education, let’s get them out of office,” Carter said.

Jones made a case for citizens seeking change by voting. “When you vote, you can elect people who see the hearts and needs of their constituents and not the color of their skin. Elect people who genuinely love God, because if they love God, they will love the people that they’ve been elected to serve,” the pastor said.

“Elect people who will not be silent, will not be complicit but will shout it out that injustice anywhere is a threat to justice everywhere. Shout it that darkness can never drive out darkness, only light can do that,” he said.

“We’ll continue to work together, we’ll continue to pray together, we will continue to struggle together, but more importantly, we will continue to stand up against racism together and tell the world that enough is enough.”

pears to have been improperly called” in violation of the Virginia Freedom of Information Act.

Hart in a telephone interview Wednesday said he intends to take the matter to court.

“No one is above the law, especially the town council,” he said.

He had his attorney send a letter to the council before the May 19 meeting, advising it could be illegal, he said, adding, “I refused to go.”

“They met anyway; they met for an hour and 45 minutes, in closed session mind you, and during a time that we are only supposed to be meeting virtually, they decided to meet in person,” he said.

The censure came after a May 2 incident in which an Onley police officer was injured in an altercation with a suspect and required emergency medical attention. The patrol car, which was damaged, was left sitting along Route 13 for several hours afterward, according to Hart.

Hart said he was concerned about the officer and went to take a look af-

ter a resident contacted him at 7:26 p.m. after seeing the damaged vehicle along the highway.

Hart then sent an email about the incident to the town manager and council members.

He also sent a text message to the town manager.

After receiving another phone call later about the police car still sitting on the highway, he sent out another email later that night.

At the May 4 council meeting, the Onley police chief said Hart had not followed the chain of command in the incident, according to Hart.

“I was concerned about the officer’s life and made a phone call to him and followed what I thought needed to be done,” Hart said.

In another incident Hart cited in the interview, he said a shed at his residence, next to a lot owned by the town, was damaged when a town contractor was mowing grass.

Hart in a written response to the censure admitted he was upset and said both he and the contractor raised their voices during a phone call about

the incident.

Hart, who is in his first term as mayor and previously served on town council, and Henry E. “Ned” Finney have filed as candidates for mayor in the upcoming election, according to the Accomack County Voter Registrar.

The deadline to file was Tuesday.

Seven people have filed as candidates for the six town council seats: Brian A. Corbin; Rose M. Pierson; William R. “Bill” Ferguson; Susan M. Rillo; Wood W. Zember; Billye D. Custis; and Claudia Carpenter Harmon.

Gov. Northam Outlines Phased Reopening of Virginia Schools

Plan includes students spaced six feet apart, daily health screenings of students and staff, and face covering guidelines while in school.

Virginia schools will begin reopening in phases, with social distancing guidelines and continued online learning opportunities in place to keep students and school staff safe, Gov. Ralph Northam announced June 9.

“To be clear, all Virginia schools will open for students next year, but the school experience will look very different,” he said.

When schools reopen their doors this fall, desks will be six feet apart and teachers and school staff will be wearing face coverings when they cannot maintain social distance.

Students will be encouraged to wear face coverings, but they will not be required.

All students and staff will undergo

daily health screenings.

Since social distancing will mean fewer students may occupy a classroom together, class schedules must be staggered, or schools must offer a combination of in-person instruction and remote learning to accommodate everyone, Northam said.

Remote learning and teleworking options must be provided to students and staff who have high-risk health conditions.

School cafeterias must stagger meal times or remain closed, meaning some students may have to be served breakfast and lunch in the classroom.

No matter when schools decide to open their doors or what classrooms look like in the future, all schools in the state will be required to deliver new instruction to students this fall, Virginia Superintendent of Schools James Lane said.

After the governor closed schools for the rest of the academic year March 23, schools began offering online learning and handing out homework packets along with free meals at distribution sites, but those lessons were re-

view and were not graded.

“I believe that these closures have helped mitigate the spread of COVID-19 in our communities over the last few months,” Northam said.

All Virginia schools currently are in Phase One of reopening, in which childcare is available to working families and students with disabilities may receive in-person instruction.

Most schools will be able to enter Phase Two immediately, which allows in-person instruction for students with disabilities, English learners, and students in pre-K through third grade.

“We wanted to focus on getting education to our earliest learners because of the challenges that they were facing in the remote learning environment while also making sure that we can keep them safe,” Lane clarified.

School-based summer camps may also operate with restrictions in Phase Two.

Phase Three will allow in-person instruction for all students, with social distancing and remote learning options also in place.

Before entering Phase Two or Phase Three of reopening, schools must give the Virginia Department of Education plans outlining how they will comply with health and safety guidelines.

A school must wait at least two weeks before transitioning from Phase Two to Phase Three, Northam said.

The guidelines are flexible to allow schools to reopen buildings at their own pace. There is no mandate to open for summer school.

“This approach to reopening our schools protects and prioritizes the health and social, emotional, and physical well-being of students and staff as public health conditions evolve,” Northam said.

Lane also commented on public education in Virginia as related to recent concerns about racism and his pledge “to ensure that the color of a student’s skin doesn’t dictate the education opportunity that they have access to.”

“We’re going to have to do a better job of putting culturally responsive teaching practices into trainings for our teachers, into the standards and the

way that we approach them and building cultural competence for our educators to make sure that every child sees themselves in every classroom,” he said.

“We have phenomenal educators in Virginia that are doing this work already and we’ll continue to build upon that,” Lane said.

“I am committed to eradicating racism from our schools and communities.”

COVID-19

As of June 9, there were 487 new cases of COVID-19 identified in Virginia, for a total of 51,738 cases. There were 19 more deaths related to COVID-19 reported, bringing Virginia’s coronavirus death toll to 1,496.

Northam said the number of positive COVID-19 tests has trended downward over the last 14 days. About 10% of COVID-19 tests were positive. There have been fewer hospitalizations, and hospital bed capacity and supplies of personal protective equipment are sufficient.

Hiring contact tracers continues. There are more than 870 contact tracers, with a goal of reaching 1,200 by July, or 15 contact tracers for every 100,000 people in the state.

New Website Provides Week-by-Week Data for COVID-19 in Nursing Homes

A new requirement to submit data on COVID-19 cases in nursing homes has resulted in publication of weekly numbers by the federal agency charged with oversight of nursing homes.

Still, the numbers for Eastern Shore facilities so far don't appear to match up with Virginia Department of Health statistics.

That is true of other localities as well, according to media reports.

The Centers for Medicare and Medicaid Services (CMS) announced June 4 it was posting the first set of COVID-19 nursing home data, after announcing in April a requirement for nursing homes to inform residents and their families of COVID-19 cases in their facilities and to report cases to the Centers for Disease Control and Prevention.

CMS is responsible for ensuring health and safety of nursing home residents by enforcing standards.

It has been difficult to get information about COVID-19 outbreaks in Virginia nursing homes because of a state law that defines corporations as people, giving facilities a right to privacy regarding health information.

That has left it up to the facilities themselves whether to voluntarily share information about outbreaks with the public.

The CMS database sheds some light on how COVID-19 is affecting nursing homes.

Shore Health and Rehab Center in Parksley reported for residents the week of May 31 it had one confirmed COVID-19 case; four total suspected cases; no COVID-19 deaths; and 102 out of 136 available beds occupied, according to the database.

Additionally, the facility reported nine confirmed COVID-19 cases and six suspected cases among staff as of May 31.

Heritage Hall in Nassawadox reported for the week of May 24 one resident was admitted with COVID-19

that week; six residents were suspected to have COVID-19; zero deaths; no confirmed or suspected cases among staff; and 93 of 143 beds occupied, according to the database.

Those figures were low in contrast to reports of an earlier, large outbreak there.

Facilities that have submitted erroneous data have an "N" displayed in a column titled "Passed Quality Assurance Check," which the database showed for Heritage Hall as of June 9.

A health department official told county officials in May around 94 of 220 people the National Guard tested at Heritage Hall in late April were positive for the virus.

A spokesperson for the facility said in a May 5 email the test results included 46 employees and 43 residents who tested positive.

No data from Commonwealth Senior Living at the Eastern Shore in Onancock was found in the database as of June 9.

There were no cases there as of early May, Kristie Annis, spokesperson for the facility, said then.

Health department statistics show the Eastern Shore has had outbreaks in four long-term care facilities, which include group homes and other settings in addition to nursing homes.

The Shore also has had six outbreaks in congregate settings, which include the poultry plants or other workplaces, among other settings.

An outbreak is defined as two or more linked cases outside a household setting.

As of June 11, 821 cases on the Shore, and 70 among healthcare workers, were associated with outbreaks.

The number of hospitalizations and deaths due to outbreaks in a locality is not reported on the state health department website.

Accomack County has had 984 cases, 55 hospitalizations, and 13 deaths to date, according to the Virginia Department of Health. Northampton County has had 259 cases, 34 hospitalizations, and 27 deaths.

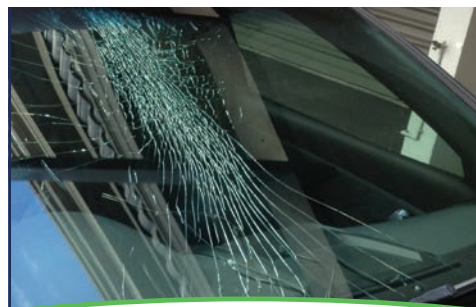

cases and 273 people tested.

Parksley, where Shore Health and Rehabilitation is located, has had 174 cases and 722 people tested.

Onancock, where Commonwealth Senior Living is located, has had 84 cases and 254 tested.

The figures include cases and test numbers from among all residents of the ZIP code.

The preliminary data released by CMS has “several limitations,” according to a note on the website.

For one thing, facilities can opt whether or not to report cumulative data back to Jan. 1, meaning some will report higher total numbers of cases and deaths than others in the beginning.

Testing availability also could im-

pact the number of confirmed cases a facility reports.

Additionally, “as with any new reporting program, some facilities will struggle with their first submissions, and therefore, some of the data from their early submissions may be inaccurate,” the note said. That could be corrected in subsequent weeks.

The data shows that as of May 31 about 13,600 nursing homes, or around 88%, had reported the required information.

Facilities around the United States reported more than 95,000 COVID-19 cases and almost 32,000 deaths, according to a press release.

The agency plans to update the data weekly.

VOTERS REQUEST MORE ABSENTEE BALLOTS APPROACHING JUNE 23 REPUBLICAN PRIMARY

More Eastern Shore voters who want to cast a ballot in the June 23 Republican primary are asking for absentee ballots than in the last similar primary, according to an analysis by the nonprofit Virginia Public Access Project.

Requests for mail-in ballots stand at 53 in Accomack County, compared to just 18 in the 2018 primary — that’s nearly three times more.

In Northampton, 46 voters have requested mail-in ballots, compared to 11 in 2018, more than four times more.

The coronavirus pandemic has been a significant factor in expanding voting by mail numbers across Virginia.

“Preliminary numbers show Republicans seeking to participate in a June 23 statewide primary to select a U.S. Senate nominee are taking advantage of the mail option in far greater numbers than they did in a similar election held two years ago,” according to VPAP.

To date, 29,285 Virginia voters requested absentee ballots for the primary, and 10,610 have returned their ballots.

That compares to the 2018 primary, when just 4,214 voters returned absentee ballots in the primary.

The deadline to request an absentee ballot to be mailed to a registered voter is Tuesday, June 16. The request must be received by the registrar by 5 p.m.

The deadline to register to vote in the primary has passed.

The Northampton Voter Registrar’s office will be open for in-person absentee voting on June 20, the last day to vote absentee in the election.

The Accomack County Voter Registrar’s office is open for in-person absentee voting Monday through Friday, between 8:30 a.m. and 5 p.m., but is closed daily between 12:30 and 1 p.m.

For those voting in person, the polls are open Tuesday, June 23, from 6 a.m. to 7 p.m. Social distancing protocol will be followed.

Vying to represent the Republican Party on the ballot in November for the U.S. Senate are Daniel M. Gade, Thomas A. Speciale II, and Alissa A. Baldwin.

Running for the party’s slot for the House of Representatives 2nd District seat are Ben Loyola Jr., Scott W. Taylor, and Jarome Bell.

Since Virginia does not register voters by party, any registered voter can choose to vote in the primary.

All voters can use the 2A code for their reason to vote absentee.

Coast Guard Gives Final Approval to Anchorage Near Cape Charles

For years, ships have anchored outside of Cape Charles, and the U.S. Coast Guard did not have the authority to ensure their safety and security, but last month, its fifth district commander, Rear Adm. Keith Smith, signed a final rule and made it official.

“The Coast Guard facilitates \$5.4 trillion in commerce through the Maritime Transportation System (MTS) annually,” Smith said in a May 28 press release.

“Formally establishing this anchorage, where ships already anchor ... helps ensure the safety of the MTS. It also protects the Chesapeake Bay by reducing potential pollution threats through regulation of the area.”

The new anchorage was named Anchorage R, and an anchorage for quarantined ships, Anchorage Q, was moved farther south.

Plans to formally establish an anchorage near Cape Charles began in 2016. The Coast Guard solicited public input through several channels, including three public meetings and a

Notice of Proposed Rule-Making that received 84 written comments.

Comments raised concerns about potential risks associated with the anchorage, including vessels dragging anchor, oil spills, sewage pollution, and negative impacts on fisheries.

Chairman John Joeckel, of the Eastern Shore of Virginia Regional Navigable Waterways Committee, reviewed the final rule and noted that it added two requirements that would help mitigate oil spills and the risk of vessels dragging anchor.

First, no vessel may transfer oil or chemicals in bulk to another vessel without permission from the COTP (captain of the port), enabling the COTP to control the conditions of the transfer.

Second, a non-self-propelled vessel, such as a barge, must be tended by a towing vessel unless otherwise permitted by the COTP, reducing the risk of such a vessel breaking away and dragging anchor.

The Coast Guard believed that the additional restrictions on anchored vessels, combined with existing laws and regu-

lations, were sufficient to prevent an oil spill, and it made no additions addressing local oil spill response capability.

Several citizens were concerned that some ships may not be properly treating their sewage before discharging it into the Chesapeake Bay or that nutrient levels in properly treated sewage may be harmful.

Citizens called for the creation of a no-discharge zone in the Chesapeake Bay as a solution.

The final rule did not add any more requirements for sewage discharge, considering existing laws and regulations on ships and sewage.

Joeckel noted that the creation of a no-discharge zone is beyond the scope of the rule-making; however, a letter was sent to the Virginia Department of Environmental Quality in November 2019 informing it that citizens had requested the creation of a no-discharge zone.

The U.S. Environmental Protection Agency may establish a no-discharge zone when requested by a state.

Neither did the Coast Guard change the proposed rule regarding discharge

of ballast water or impact to fisheries. It asserted that establishing the anchorage would have no adverse effect, and the risks anchored vessels pose pre-exist the designation of the anchorage.

Concerns were also raised about possible congestion at the anchorage, and citizens made suggestions about how long vessels should stay; the Coast Guard concluded the 30-day limit that was previously set would be sufficient.

Capt. Kevin Carroll, commander of Coast Guard Sector Virginia, explained in an email last month that the new anchorage was born out of an ongoing need of commercial vessels that were using the Lynnhaven naval anchorages near Virginia Beach, Va., until they became unavailable due to increased military use.

Carroll said, “It is my sincere belief that as this process completes, the southern Chesapeake Bay will have a designated deep draft anchorage that will allow for a safer place for ships to anchor while promoting the health and safety of other vessel traffic, the environment, and nearby residents.”

Cape Charles Beach Reopening Comes with \$56K Price Tag

Cape Charles Beach is open and welcoming visitors after a 10-week closure due to COVID-19, but while Northampton County's only public beach is free to visitors, the reopening comes at a hefty price for the town.

It will cost \$56,000 to implement the 17 beach reopening requirements outlined in Gov. Ralph Northam's executive order 65, according to the Cape Charles Beach Re-Opening Plan dated June 5.

That is the price of the "return to a sense of normalcy" Town Manager John Hozey referenced in a public notice released last Friday.

The \$56,000 will cover implementation of the beach plan through Labor Day, Sept. 7, or for about 13 weeks.

The cost included hiring three beach attendants; one on duty each weekday and two on duty each weekend, from 9 a.m. to 6 p.m. daily.

Beach attendant duties include patrolling the beach every hour on weekdays and ensuring that social distancing guidelines and town codes are followed.

Beachgoers must stay 6 feet apart and may not gather in groups of more than 50. No group sporting event or entertainment is permitted. If a problem arises, police may enforce the rules.

The town has hired an additional police officer who will work each Saturday and Sunday, from 10 a.m. to 4 p.m.,

assisting the regular-duty police officer and the beach attendants as needed.

The beach attendants and police officer conduct alternating beach patrols every half hour on weekends.

Equipment provided to the attendants includes a shade tent, high-visibility shirts, a cooler for dispensing ice and water, and radios for communicating with each other and police. They may also have access to a public works UTV (utility task vehicle) for completing patrols.

Other expenses include signs notifying the public of beach rules and guidelines.

A contractor has been hired to clean and sanitize the public beach restroom and high-touch areas such as the gazebo, LOVE sign, and dolphin sculpture. (The gazebo is closed but may be permitted to reopen when Virginia enters Phase 3 of its reopening, possibly later this summer.) Cleaning duties are performed every two hours from 9 a.m. to 6 p.m. daily.

Northam's executive order 55 closed all beaches from March 30 to June 10 due to COVID-19, Hozey noted in a May 29 public notice.

"So, it is important to keep in mind that the whole reason for closing the beaches was because they were considered unsafe. Nobody wanted to hurt our economy," he wrote.

Virginia Beach was able to reopen for Memorial Day weekend because it spent "several weeks of coordination"

on a reopening plan.

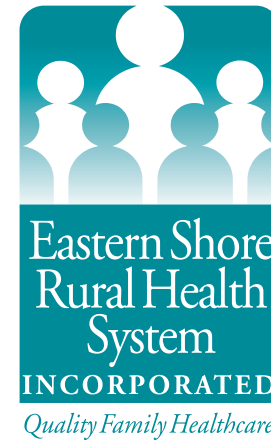
When the governor announced Virginia Beach had been granted an exception to the statewide beach closure, “many people misunderstood and thought that all Virginia beaches had been reopened,” Hozey said.

Cape Charles was working on a comparable plan when “the governor took us by surprise” and announced May 28 that all beaches could open as early as May 29 if they implemented a long list of safety measures.

But it was “impossible” for Cape Charles to meet the guidelines with “one day’s notice,” Hozey said.

However, the town was able to finalize its beach reopening plan in time to welcome visitors back to the beach one week later, an announcement Hozey made in a June 5 public notice.

“Trying to balance economic concerns against public health concerns has been a real challenge, and we again want to thank you for your understanding and patience as we continue to seek this balance.”

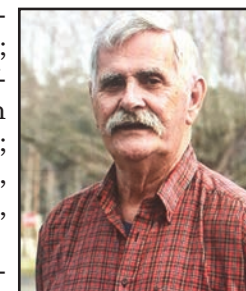

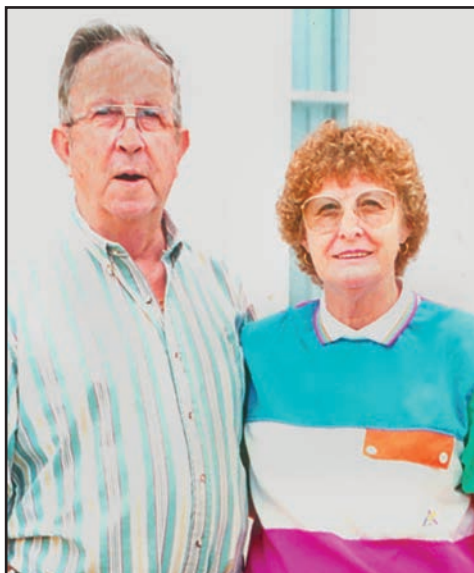

A FATHER FINDS WHEN KIDS TRADE VIDEO GAMES FOR BASKETBALL HOOPS, IT'S CONTAGIOUS

They started coming as early as 9 a.m. on a picture-perfect Sunday morning. Kids as young as 3, all the way up to teenagers, to the parking lot at Arcadia High School. What started as one parent's attempt to steer his kids from video games and into exercising, has quickly swelled into a successful endeavor to teach and inspire a group of kids, and to bridge away from a difficult period of distancing.

The blacktop gym is the brainchild of Deverick Henderson, father of two. Henderson credits his children, Jayden and Jordan, as the impetus behind his actions. Of his kids, Henderson was candid and sincere.

"I love them, my two inspired me to do this," said Henderson.

That first week it was just Henderson and his kids, but word traveled as the weather began to improve on the Shore and parents sought an outlet for the tireless energy of youth.

"I came out just to work out with my kids, then people started hitting me up on my inbox; the first day was two, then 19, and 36, last Sunday was 47," said Henderson.

This past Sunday the number increased to 49.

An effort this large is not accomplished without help, and Henderson was quick to praise Tyrone Branch, Marquell Washington, Kevin Cropper, and Charles Baines. Many of these individuals, Henderson included, have continued to work 12-hour days throughout the pandemic and yet show no letup in staging these pop-up sessions during the week.

"I couldn't have done it without them," Henderson said.

The crew shows up hours before the kids, setting up orange cones and portable basketball hoops. The scene is orderly. Safety is without question. These men are here for the kids, their eyes fixed to the progression of both skill and attitude.

Like Henderson, Charles Baines grew up a stone's throw from this school. Baines' drive has culminated in a successful career in professional basketball overseas, to spots such as Spain, the Philippines, and Australia, to name a few. The pandemic stopped basketball worldwide, and Baines has taken his abbreviated time off from the game to lend an encouraging voice.

"For me, it's been about hard work. Nothing is given; whatever kids want to do is possible. This is what it's about: What are you going to do for the next generation? The kids are the future, they look up to us," said Baines.

Sometimes the first step is breaking kids free from habits, particularly ones exacerbated by the situation of quarantine.

"Moms say, 'You've got to get them off those games and out of the fridge,'" Henderson said.

The results relayed to Henderson have been extraordinary.

"Some moms say it's the most they've ever been outside; I say, anything to get them off that Fortnite. We didn't have that stuff as kids. They'll remember this," said Henderson.

It's hard to disagree. Kids continued to join the ranks as the morning rolled along. As diverse as the ages are, so are

the locations from which kids come, with some traveling south from Pocomoke City and Salisbury to take part.

"They travel to be here, one girl brought her kids from across the bridge," Henderson said.

As I'm standing by his side, Henderson pointed to the growing crowds.

"Look, kids are still coming here," he said.

The reasons they come are many, with exercise and companionship only part of the story. Some are just so determined to grow.

Jakiyah Trader is a poised ninth grader from Pocomoke City. Last year was her first year playing basketball, and though her young team struggled through some growing pains, it has shown the will to persevere. The coach pointed team members to Henderson's undertaking.

"My coach told me about this, she signed us up, and we started coming. I like the coaches here; from the beginning until now, we see a big difference," said Trader.

Though basketball is not all that is taught, it's apparent many of these kids are looking to hone their skills in this game.

"A lot of kids didn't know anything about basketball until this; these kids are going to be ready for church

league," Henderson said.

Henderson referenced leagues established by the Rev. Gary Miller from St. John Methodist Church as the place many of these kids will transition to competing. Miller has been active in maintaining both summer and fall leagues for kids, going as far as building a gym on the church's property.

"He keeps his stuff going," Henderson said of Miller.

A lot of these kids also play Amateur Athletic Union basketball out of state, which for the time being has been shelved. These sessions help keep the experienced players from losing their step.

There is much variety in what is being taught.

"We do all kinds of drills, stretching, running, during the work we do a lot of conditioning then Sundays are fun days," Henderson said.

The kids have already learned that Sundays are indeed extra special. This particular Sunday they were geared up for a barbecue, with a father of several participants, Kevin Cropper, safely tending the grill with careful attention to sanitary precautions. With charcoal smoke wafting, Cropper intently turns burgers and hot dogs. All supplies are through donations. From the Gatorades that await water breaks, to

the jerseys sending a message of unity, all is possible through parents and cash apps set up by Marquell Washington and Henderson. Washington's app is \$mjwx2, while Henderson's is \$Deve1203.

The whole scene is positive and encouraging, and it's leaving a strong impression on the kids.

"For them to teach us, it encourages me more," said Trader.

The elder Cropper's sons, Jordan and Kevin, are present, with open smiles, eager to voice their own opinions.

Kevin was a standout on Arcadia's junior varsity basketball team this past winter and shows promise to play a significant role on the varsity Firebirds when school resumes. For Kevin, the experience to train with someone like Baines is invaluable.

"I like playing with everybody, the drills, running; it's nice they're doing this," said Cropper.

His younger brother, Jordan, sees things similarly, particularly in light of the situation kids have been asked

to endure.

"I like just getting to have fun again," said Jordan.

In this parking lot off Route 13 in Oak Hall a lot is made whole again, particularly the basics of youth and summer.

The endeavor is only in its infancy, but it is working, with results measured by smiles and respectful attitudes. Even as Henderson transitions to a more set schedule at work, he is determined to keep things going with help from his friends.

"I'm going to keep doing it no matter what, definitely every Sunday, the days I can't do it Tyrone Branch does it in Pocomoke, he carries my kids there," said Henderson.

The scale of the operation is something to behold, and Henderson shows no intention to turn kids away as the group grows.

Henderson's dedication has impressed the most important of observers as well, his own mother.

"My mom said, 'this is your calling.'"

Geocaching Is a Year-Round Fun-Filled Treasure Hunt

Navy Yeoman Veronica Vance first turned to geocaching to explore the countryside around Bristol, Tenn., when she was assigned a few years ago.

When the puzzle-like search for a hidden container ended, Vance and her children found themselves with another adventure. They began to explore a large, wooded park.

“The first cache led us to an amazing place, and after that, we were hooked,” she said.

The children loved the hunt. They could operate the software on their phones, coach each other, compete with each other, and share the thrill of reaching a shared goal.

In other words, geocaching benefited everyone in different ways.

After reaching their required minimum of 20 found caches, the family also found a new benefit: A sense of public service.

“We were finding, but we weren’t giving back,” she said.

So they began hiding their own

geocaches, creating what has grown to a nine-cache series that she titled, “Bring Me to Chincoteague Island.” The series highlights her favorite entertainment and historical spots, especially often overlooked gems such as the Captain Timothy Hill House, Chincoteague’s oldest surviving residence.

Today, her family also gives back by toting supplies, such as plastic ties and small bags, and repairing geocaches they find in need.

For Jim and Christy Betz, of Machipongo, geocaching grew from scavenger hunts they used to prepare for their children.

Initially, they found themselves with their children, Summer, 8, and Parker, 6, at the Food Lion at Exmore. By chance they checked the geocaching app, which showed a cache hidden in the store’s parking lot. Although located in a pedestrian place, the cache became an adrenaline-filled marathon to find.

“The minute you find it, you get a rush,” he said, “This is our scavenger hunt now.”

As parents, they also enjoy geocaching as an easy way to lure their children outside to play.

A recent geocache hidden by the Betzes leads geocachers to a marsh overlook from a Nature Conservancy platform.

They chose the location thinking about the many visitors who drive Route 13 without ever discovering such treasures.

“It’s four minutes off Route 13 to have this view,” Jim Betz said.

Christy hopes to create a much expanded series of geocaches that will blend her avocation with her vocation: tourism planning.

As assistant executive director of the Eastern Shore of Virginia Tourism Commission, she wants to geocache her way through the list of attractions in the commission’s 2020 activity guide.

Among the most accomplished of the Eastern Shore’s geocache authors are Steve and Kim Hubbell, who have found more than 14,143 geocaches since 2011. Their most notable geocache hunts have included breaking ice with kayaks and climbing railroad abutments in Richmond.

Difficult terrain can be an attraction for geocachers, but the couple

quickly caution, “not every cache is for everyone.”

Discretion can be the better part of geocaching and attention should be paid to the terrain and difficulty rankings in the geocaching app.

The Virginia Beach, Va., couple hid caches at the southern tip of the peninsula and leading to Arlington and Custis Family Tomb. Originally, they felt drawn to place caches in an area with far fewer caches than their hometown of Virginia Beach.

Hiding caches allows them to share historical research about areas, because the geocaching app enables them to add text and links to their sources.

Tips for Geocachers

Basic geocaching is a free and engaging way to explore the outdoors. With over 3 million geocaches around the globe, they are everywhere, including the Eastern Shore of Virginia.

To start, download the official geocaching app onto a cell phone using the appropriate app store. Beginners don’t need the premium subscription, which displays extra geocaches. Then, follow the directions.

Here are some tips to make the hunt more pleasant.

- Start with caches that have difficulty ratings of two or less on the five-point scale. A difficulty of 1 means that the geocache can be found by someone in a wheelchair; a rating of 1.5 would mean that someone could roll nearby, but would have to get out of the wheelchair to actually find the geocache, said geocacher Veronica Vance.
- Bring snacks. The thrill of the hunt can become addictive and time can fly.
- Put the app on all available phones. Children especially may want to read the map and clues individually.
- Pay attention to the difficulty and terrain rankings. Top-rated fives can be very hard to find or very hard to reach.
- In case of frustration, remember that geocaches can’t be buried. However, they can be very cleverly hidden or require the geocacher to reach somewhere blindly.
- And always, be safe, appropriately clothed, and, yes, socially distanced.



*Fishing from
the Shore*

A week of sunny skies and lighter winds resulted in increased fishing access and some outstanding angling action. The big news of the week was the huge influx of cobia into the waters of the southern Chesapeake Bay. Look for these hard fighting fish to rapidly expand their range northward. It's time for bluefin and yellowfin tuna in our offshore waters from the 21-Mile Hill, east to the Norfolk and Washington canyons.

Lower Shore – Jeb Brady, at Bailey's Bait & Tackle in Cape Charles, reported that cobia fishing has taken off with fish being caught on the bottom with cut bunker as well as by sight casting with live eels. Sharks can be an unwelcome bycatch at times while chumming and using cut bait. The shop weighed in a 62.8-pound cobia over the weekend for Nick Lewis. Flounder action has shown improvement with catches made out of Oyster and down in the "Ditch." Red drum action is still consistent along the breakers of Fisherman's Island. Small gray trout and large sea mullet (whiting) are biting near the concrete ships off Kiptopeke.

Wachapreague – Captain Lindsay Paul, at Trident Tackle, said that the flounder fishing is "pretty decent" with some anglers catching their limits. Captain Paul specifically mentioned Bullshead, Green and Drawing Channels, and Burton's Bay as productive flounder fishing locations. Berkley Gulp in white, chartreuse, or pink colors, fished with a minnow, was the top bait combination. He said that a few black drum are still coming from the surf, with back sea bass on the offshore wrecks and blue-line tilefish being caught deep-dropping in the canyons.

Amanda Manzella, at the Wachapreague Inn, reported good fishing over the weekend, with the best action

occurring approximately an hour after high tide. Nita Large was the winner in the 4th Annual Shore Girls Flounder Tournament. Her fish measured 21 3/8 inches. Kim Miller finished second (21 1/4 inches), and Kallie Brock took third with a fish measuring 21 inches.

Chincoteague – Donna Rae Roeske, at Captain Bob's Marina, described the fishing as "hot right now." She said that the north side of the Queen Sound Bridge is producing nice-sized flounder as well as sharks. The town pier has produced the first croaker of the season. The waters around the inlet are producing catches of kingfish (whiting). Coastal sharks are just outside the Assateague Island breakers. Surf fishermen are finding a mixed bag of black drum, striped bass, sea mullet, perch, and bluefish.

Upper Shore – Captain Matt Abell, at Sea Hawk Sports Center, described the flounder fishing on the seaside as "okay," with the best action occurring Friday. Speckled trout fishing has been good on the Chesapeake Bay side, with catches of red and black drum improving over the weekend. Speckled trout catches were coming on bass assassins fished under popping corks, according to Captain Abell.

Onancock – If you were ever curious about participating in the kayak fishing craze, a kayak-guided fishing service is now available out of Onancock Wharf. Burnham Guides Paddling Adventures is offering a kayak fishing tour on the protected and scenic waters of Onancock Creek. Kayakers can fish with an experienced local guide for a variety of gamefish, such as speckled trout and striped bass. Each trip is three hours and includes instructions, a fully outfitted fishing kayak rental, rod, bait, and guide service for \$125 per angler. 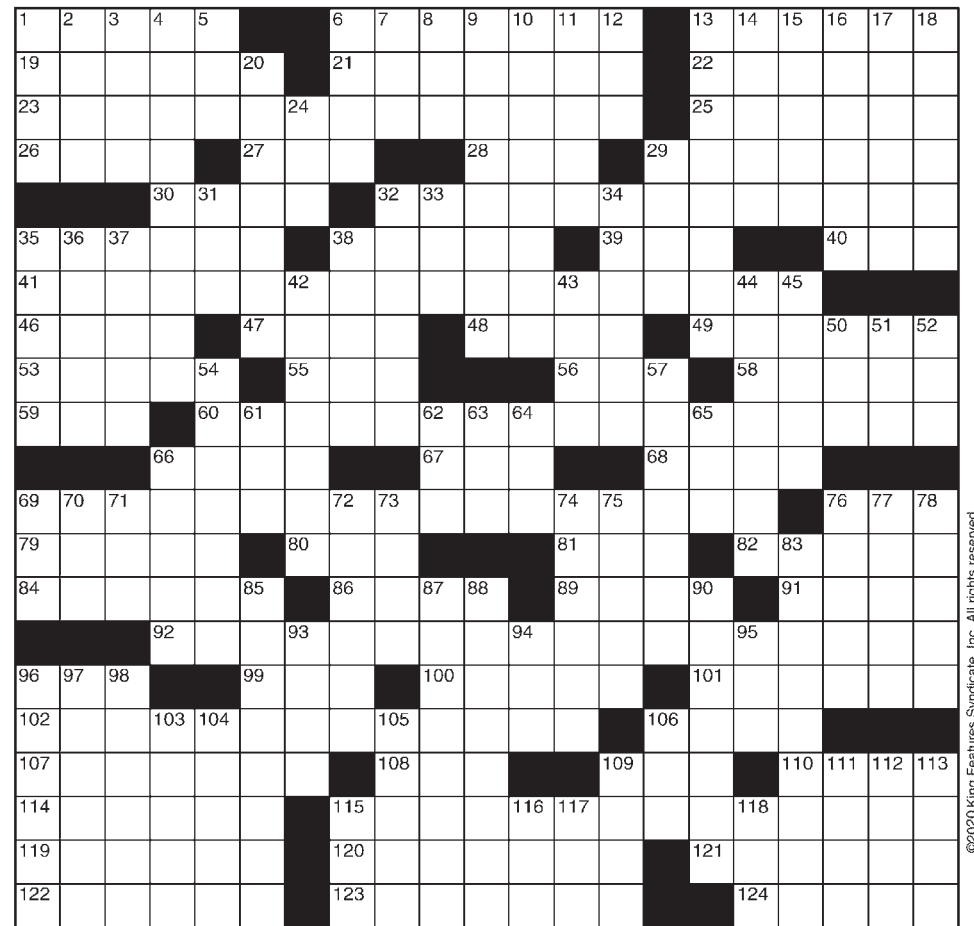

Things You Didn't Need To Know

When we opened our internet tubes for cleaning this week, we found a chocolate bar!

For most of its 3,000-plus-year relationship with humans, chocolate has been consumed as an unsweetened liquid, starting with Olmec Indians who passed their knowledge of cacao beans to the Mayans, who used chocolate at all levels of their civilization, to the Aztecs, who considered chocolate a gift from the gods. Their last leader, Montezuma II, drank a gallon or more of chocolate each day.

In the 1500s, chocolate came to Eu-

rope via the Spanish conquerors of South America and soon Europeans were making fancy chocolate drinks by adding sugar, cinnamon, and other spices. Not until the 1800s was chocolate widely enjoyed as a solid when bars were made from chocolate liquor, cocoa butter, and sugar. Dried milk powder was added to make milk chocolate. By the turn of the 20th century, with machines that aerated chocolate to make it more palatable, the modern chocolate bar was in business.

In World War II, the government commissioned a specially designed Hershey chocolate bar that wouldn't melt easily or be so tasty that soldiers would eat it in

nonemergency situations. The D ration bar was a 4-ounce chunk mixed with oat flour and was so successfully not tasty that some soldiers tossed it.

After the war, Russia blockaded the people of West Berlin and, to save them from starving, the U.S. and Britain undertook the Berlin Airlift, eventually flying in 2.3 million tons of food, medicine, coal, and other supplies.

One American flyer, 1st Lt. Gail Halvorsen, met some hungry German kids and was impressed they weren't begging for chocolate as most refugee kids did during the war. He promised them that next time he flew over, he'd drop some candy. He told them to watch for the

plane that wiggled its wings.

He used his chocolate ration and that donated by some of his friends, fashioned small parachutes out of handkerchiefs and old shirts, and began making candy drops to crowds of children that grew day by day. He became known as "Onkel Wackelflugel" or Uncle Wiggly Wings. Soon other American pilots were dropping chocolate by parachutes, newspaper articles were written, and Halvorsen became known in West Germany as "Der Schokoladen Flieger," the Chocolate Flyer. By the end of the airlift, 23 tons of chocolate and other candy had been dropped by 250,000 parachutes.

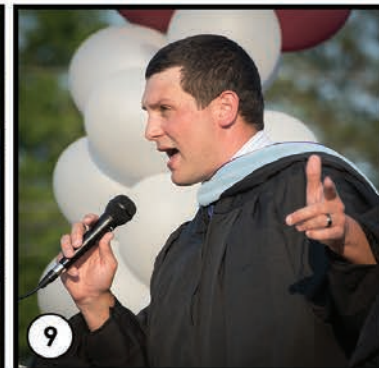
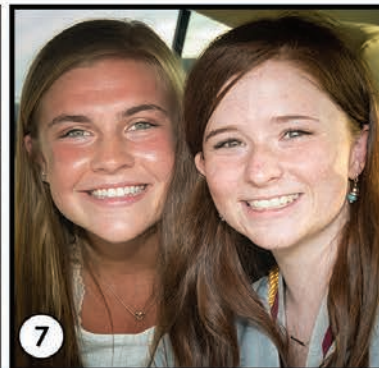

VA Resumes In-Person Compensation and Pension Exams at Select Locations: The U.S. Department of Veterans Affairs (VA) announced it would

resume in-person Compensation and Pension (C&P) exams in select locations across the country.

VA Veterans Benefits Administration's (VBA) contracted medical examination providers will immediately begin contacting veterans in select locations with claims pending C&P exams to schedule exam appointments.

"Resuming C&P exams allow the VA to continue delivering the benefits our veterans have earned," said VA Secretary Robert Wilkie. "We're keeping the safety of veterans and our medical providers as our highest priority and have put a robust set of measures in place to ensure medical providers can safely conduct these examinations."

Safety measures include COVID-19 screening for veterans and employees, physical distancing, and appropriate personal protective equipment to include face coverings and gloves. The VA is working closely with its medical providers to ensure the safety of veterans and providers remain a top priority.

The VA expects to start conducting in-person exams within the next few weeks based on the availability of veterans in the following approved locations: White River Junction, Vt., Syracuse, N.Y., Erie, Pa., Huntington, W.Va., Danville, Va., Charleston, S.C., West Palm Beach, Fla., Johnson City, Tenn., Cleveland, Ohio, Tomah, Wis., Shorewood Hills, Wis., Kansas City, Mo., Little Rock, Ark., San Antonio, Texas, Fort Harrison, Mont., Seattle, Wash., Boise, Idaho, Las Vegas, Nev., Tucson, Ariz., and Fargo, N.D.

Veterans outside of these areas will continue to be served through telehealth appointments or the acceptable clinical evidence process, which includes a review of existing medical records to provide the information

needed to complete the claim, whenever possible.

Veterans within resumed service areas who do not yet feel comfortable receiving in-person exams may opt to schedule their exams for a later date without an impact on their disability claim. No final action will be taken on a claim while a required in-person exam is pending.

The VA expects to expand the list of available locations as conditions allow, with guidance from various agencies driving decision making.

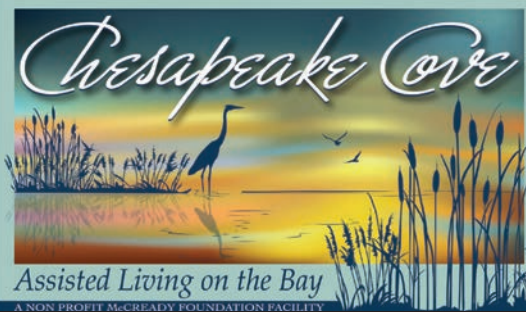

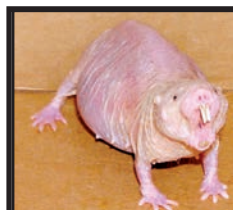

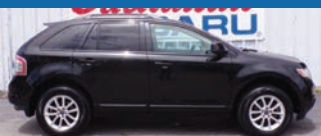
