



Local COVID-19 Cases Spike in Accomack Going Into Holiday Season

COVID-19 cases on the Eastern Shore are increasing.

"Over the past two weeks we have definitely seen an increase in our number of cases," said Jon Richardson, chief operating officer at the Eastern Shore Health District, in a Nov. 23 email.

Richardson said the health department is keeping a close eye on the situation.

"It is concerning," he said.

Accomack County reported eight new cases Monday and now has a seven-day average of seven daily new cases, or a seven-day average rate of 22 new daily cases reported per 100,000 population.

One new hospitalization and no new deaths were reported Monday in Accomack County.

Accomack County has had 1,308 cases, 105 hospitalizations, and 21 deaths since the pandemic began.

Northampton County reported two new cases Monday and now has a seven-day average of one new daily case, or a seven-day average rate of 8.5 new daily cases per 100,000 population.

Northampton County had zero new hospitalizations and zero new deaths reported Monday.

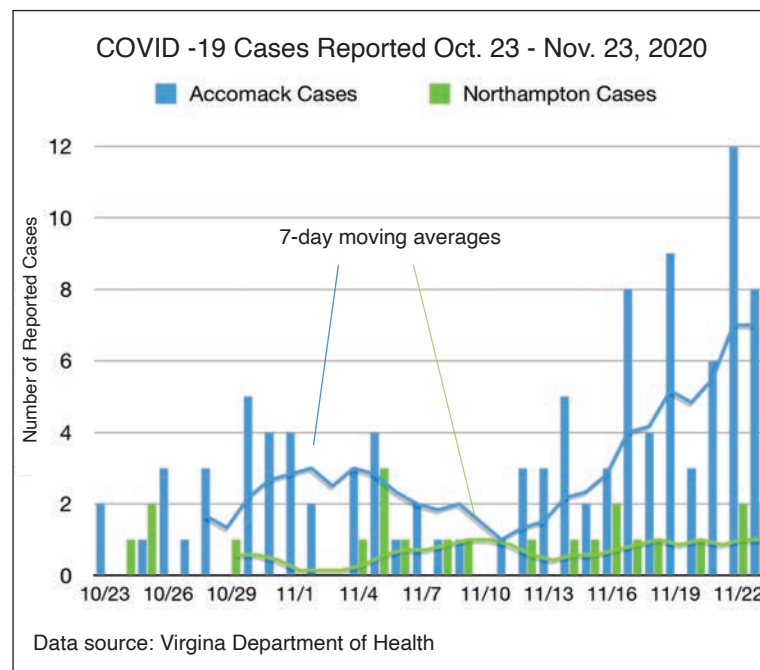
Northampton County has had 339 cases, 49 hospitalizations, and 31 deaths since the pandemic began.

The Eastern Shore has had 17 outbreaks since the pandemic began, with 891 associated cases: four in long-term care facilities; 10 in congregate settings; one in a correctional facility; one in a healthcare setting; and one in a K-12 school.

There have been 149 cases among healthcare workers associated with outbreaks.

There have been 18,214 PCR tests administered in the Eastern Shore Health District and the current seven-day test positivity rate was 5.7% as of Monday.

"(I)t's important for the community to know that as current community transmission trends are



on the rise, there is more risk of outbreaks. While things have remained fairly calm in the poultry plants and schools, there is no guarantee for that to continue as case counts continue to rise," Richardson said.

The current increase is not attributable to any one facility or gathering, according to Richardson.

"Many of these cases resulted from close contact with other positive cases," he said of recently reported cases.

Last spring, many local coronavirus cases were traced to either nursing homes or Accomack County's two poultry processing facilities.

Richardson said nursing homes are testing staff and patients regularly, based on federal guidelines.

"This has helped to quickly catch positive cases to isolate them from others," he said, adding the health department has seen "very few cases" in long-term care facilities over the past several months.

Similarly, the health department has seen very

few cases among poultry workers over the past several months, according to Richardson.

After local schools resumed in-person classes, one outbreak has been reported in a school. That was a total of two cases at Nandua High School.

"We have seen other cases amongst staff and students at different schools but they have not resulted in outbreaks," Richardson said, adding that the health department is not seeing transmission within

the schools.

“For the most part, we have identified students and staff who have tested positive were exposed outside the school setting,” he said.

The health department anticipates case numbers could climb over the next couple of months as people gather to celebrate the holidays.

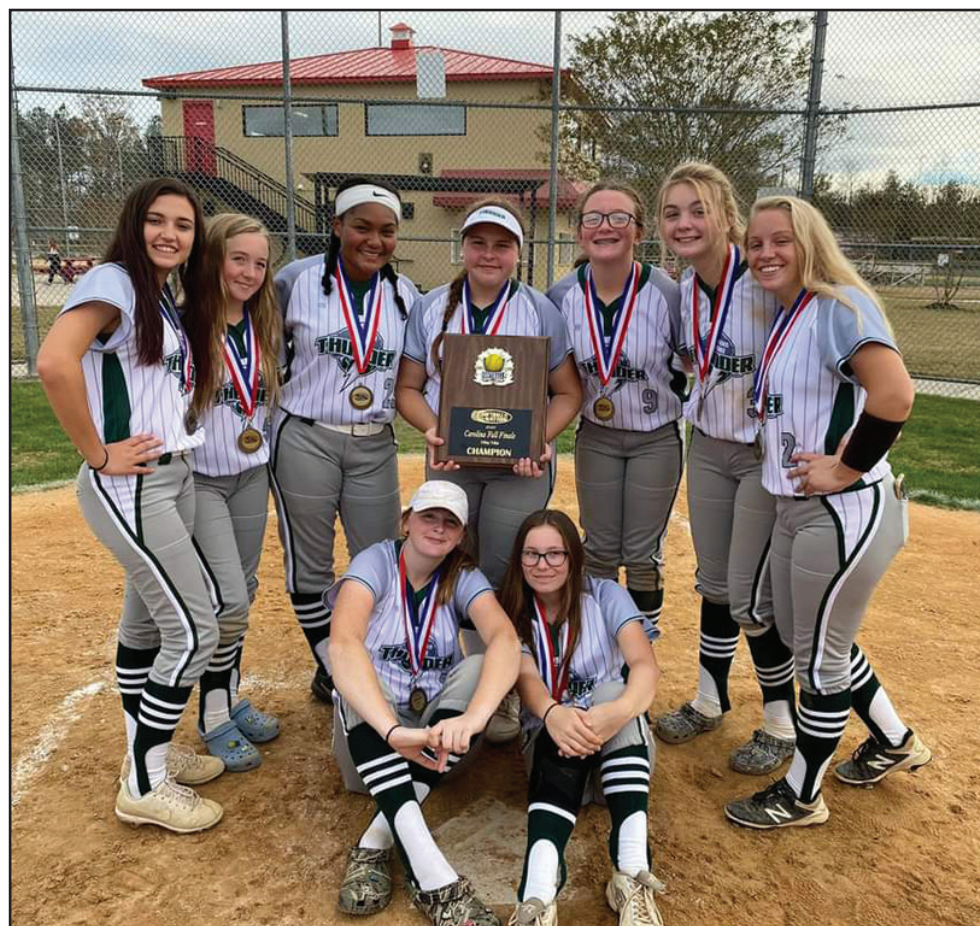
“Masks, social distancing, and frequent handwashing continue to be our best prevention methods,” Richardson said.

The health department follows up on all complaints related to Gov. Ralph Northam’s executive orders related to the pandemic.

Northam last week during a press conference said the Virginia Health Department will continue to enforce safety measures outlined in the orders.

“So far, educational efforts have resulted in compliance with the executive orders, so we have not had to take any enforcement action,” Richardson said.

“We need to continue to do our best with our prevention methods. Wash your hands frequently, wear a mask in public, and maintain social distancing between yourselves and those outside of your household,” Richardson said, adding, “Continuing these practices will absolutely help keep case counts down. The science supporting that is undeniable. We will get through this by looking out for each other as a community.”

Gov. Northam Signs Revised 'Very Progressive' State Budget

Gov. Ralph Northam announced at a press conference last Wednesday he had signed the revised biennial state budget sent him by the general assembly — calling the budget “very progressive.”

The budget includes provisions to protect Virginians from evictions and utility shutoffs, Northam said.

“This budget gives us the tools we need to contend with the challenges brought on by the ongoing pandemic,” Northam said in a press release, adding, “I am grateful to our partners in the General Assembly (for) their work in crafting a revised spending plan that protects the most vulnerable Virginians, stays true to our shared values, and puts the Commonwealth in a strong position to weather this public health crisis.”

The signed budget finalizes previously announced funding allocations that Virginia received under the federal CARES Act, including:

• **Vaccination Program:** \$22 million for the Virginia Department of Health’s vaccination preparation and planning through the end of 2020

• **K-12 Schools:** \$220 million for COVID-19 preparedness and response efforts in K-12 public schools, with all 132 school districts receiving at least \$100,000.

• **Higher Education:** \$116 million to support ongoing COVID-19 response at public colleges, universities, and medical schools and \$22 million for the State Council of Higher Education for Virginia to provide payments to private institutions of higher education.

• **Child Care:** \$65.8 million to increase access to child care and continue child care incentive grant program established in April.

• **Small Business Assistance:** \$70 million to establish the Rebuild VA economic recovery fund providing grants to small businesses and non-profit organizations impacted by the pandemic and \$30 million in additional funds to continue the program.

• **Broadband Accessibility:** \$30 million to fast-track broadband projects in underserved localities.

• **Home Health Workers:** \$73 million to provide hazard pay to home health personal attendants who served high-risk populations during the early months of the pandemic.

• **Workforce Training for Unemployed Virginians:** \$30 million to establish the Re-Employing Virginians initiative providing scholarships to individuals who enroll in programs in high-demand fields.

• **Rent and Mortgage Relief:** \$12 million to expand the Virginia Rent and Mortgage Relief Program launched in June.

• **Food Banks:** \$7 million to help Virginia food banks meet increased demand for food assistance.

• **Medicaid Day Support Providers:** \$25 million to fund monthly retainer payments for day support programs that provide services for Virginians with developmental disabilities.

• **Free Clinics:** \$3 million to reimburse members of the Virginia Association of Free and Charitable Clinics for COVID-19 expenses.

It also includes \$100 million in coronavirus relief funds to support utility shutoff protection for customers facing financial hardship, as well as prohibiting evictions for rent non-payment through Dec. 31, 2020.

After Jan. 1, 2021, the budget requires landlords and tenants to work together to access rent assistance, including through the Virginia Rent and Mortgage Relief Program, before proceeding with an eviction.

Northam said commonwealth officials continue to take actions “to support our frontline workers and protect taxpayer dollars.”

He has asked the federal government to extend Title 32 status for the National Guard through next year — which would mean the federal government would continue to pay for the Guard’s assistance.

Federal authority over Nation-

al Guard members falls under Title 32 of the U.S. Code. This is considered federal active duty for specific state missions and full-time Guard positions.

“Throughout this pandemic, our Virginia National Guard has been a critical partner, helping move supplies and especially helping provide manpower and logistics for testing events,” Northam said.

Northam said Virginia’s small businesses continue to face difficulties.

“I’ve said many times, we have both a health crisis and an economic crisis — and we are focused on both of them,” he said.

Northam said the commonwealth is working to give support to businesses through the Rebuild Virginia Plan.

A few weeks ago, eligibility was expanded for the grant program and additional money was put into it.

Northam said nearly 15,000 applications for grants have been received. To date, more than \$55 million in grants have been approved,

with almost 39% of the amount going to businesses in low-income communities.

“But I know that everyone from

laid-off workers to businesses continues to struggle,” he said, adding, “We are encouraging Congress to pass another stimulus package.”

“Now that the election is behind us...Congress needs to come together to get this done — and they need to get it done now,” Northam said.

Those measurements will aid in selecting the proper size cover to fit your boat.

Boaters wrapping their boats or installing boat covers may find desiccant dehydrator kits useful. These are very

reasonably priced and effective.

Do-it-yourself winterizing kits are also a useful suggestion for preparing vessel power units and potable water tanks for the winter season. Or simply purchase a bottle of gasoline preservative to add to your fuel tank.

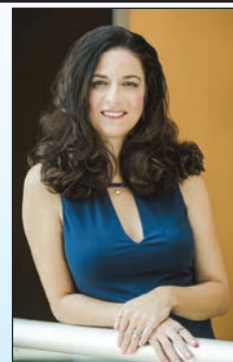

Chincoteague's Island Community House Ready To Shine at Open House

The Island Community House on Chincoteague will hold an open house Saturday, Dec. 5, from 10 a.m. to 6 p.m., to formally introduce the facility and its offerings to the public.

The house, formerly known as the Selby House, has been renovated and converted into a community gathering place. It is at 6246 Mumford St., behind the movie theater.

The Chincoteague Chamber of Commerce will hold an outdoor ribbon-cutting ceremony at 11 a.m.

The open house is an all-day event to allow for small groups and social distancing.

Local artisans and holiday treats will be at the event, as well as information about upcoming ICH activities. Team Brianna Town Park fundraiser items also will be available to purchase.

The community house got its start when David Landsberger purchased the house, which needed renovations, with the intent to turn it into a place where Chincoteague's senior citizens, children,

and others could gather for activities.

"He decided he was going to renovate it. ... They made it into a beautiful, open floor plan. ... There are so many possibilities for this place," said Cindy Faith, who recently took on the job of ICH coordinator.

There had been discussions over the years about Chincoteague's senior citizens in particular needing a place to gather, after senior services formerly provided at what is now the Chincoteague Cultural Alliance building ceased.

"There just really hasn't been anything to replace it," Faith said.

The community house opened a little over a year ago and was just gaining momentum when the COVID-19 pandemic hit, forcing it to shut down.

The goal of the open house is to create awareness of the facility and explain its offerings — including senior and youth activities; community events; guest speakers; yoga, art, and other classes; satellite classes from Eastern Shore Community College; a commercial kitchen; and rental space

for private gatherings.

Not all of those activities are happening right now due to pandemic restrictions, but Faith said, "We want it to be a place for the community. I want them to feel like it's their house."

The building "couldn't be in a better location," right downtown, Faith said, not-

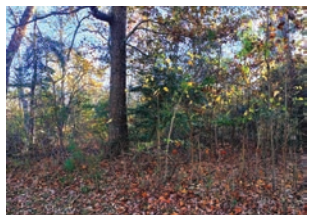
ing there is ample parking nearby and the trolley stops right across the street.

heading up the fundraiser.

Land for the park, which is on Smith Street, was purchased by Landsberger and donated to the town, with the request that it be used for a playground and an athletic field.

Faith credited Landsberger with supporting “almost every nonprofit on this island this year and (helping) them survive this year, quietly.”

Money raised will go to create a sensory playground named in honor of Brianna Merritt, who died last year at age 11 after battling cancer for three years.

“Her upbeat attitude and request that everyone ‘Be Kind’ has spurred a real movement in the island and beyond. It’s really an incredible thing to see,” said Faith.

Teams around Chincoteague are planning creative fundraisers for the playground, such as Capt. Steve’s 2020 Annual Surf Fishing Tournament, held recently to benefit the project.

“We are reaching out to the community and beyond to help support the finances of this park,” Leonard said.

A sensory playground is one that con-

tains accessible playground equipment and activities that stimulate children’s senses — touch, movement, smell, taste, sight, hearing, and balance.

That could include items such as outdoor musical instruments, among other equipment.

While sensory playgrounds are geared somewhat toward children with special needs, all children can enjoy them, according to Leonard.

A presentation from a professional playground designer from the company Third Little Pig will be made at the Dec. 8 meeting of the town recreation and community enhancement committee, at 5 p.m., Leonard said.

“Brianna’s wish was for everybody to be kind — to do something kind for somebody every day,” Leonard said, adding, “So we are carrying that wish throughout the playground. It might be just little quotes here and there; it might be a pile of seashells that are decorated with ‘Be Kind’ quotes; it might be rocks that people paint; it might be signs.”

The park in addition to the playground will include a multiuse athletic

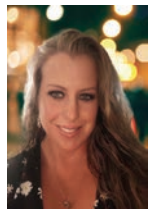

Chincoteague Approves Staff Raises, Additional EMS Staffing

Chincoteague Town Council members voted to give town employees a raise that had been delayed in July due to budgetary concerns related to the COVID-19 pandemic.

The council voted unanimously at the Thursday, Nov. 19, meeting to give the raise starting with pay period 10, deferring until May a decision on an option to make the raise retroactive to the start of the fiscal year.

The annual cost of the raise is \$59,285.

Chincoteague Town Manager Mike Tolbert updated the council about distribution of federal CARES Act funds, saying the town has awarded 99 grants to small businesses and watermen, totaling \$398,000.

The council voted to spend part of the remaining nearly \$60,000 allocated to the town on a new dispatch system for the police department.

The cloud-based system involves minimal equipment and will cost around \$20,000 for equipment and in-

stallation, plus a maintenance fee.

The \$1,000 per month fee matches the amount the town charges the U.S. Fish and Wildlife Service, starting last year, for dispatch service, according to Tolbert.

Other suggested expenditures for the remaining federal funds include remote message display boards, personal protective equipment, and cleaning supplies, among other items.

Emergency Management Coordinator Bryan Rush updated the council on the COVID-19 pandemic state of emergency.

Chincoteague has had a total of 40 cases, including two additional cases since Monday, he said.

He spoke about a point of distribution plan for a vaccine to be administered, when available, to active EMS volunteers and town employees in the first phase of vaccinations.

"Today, I have been informed that the CDC and the Virginia Department of Health are projecting a phase 1 roll-out of vaccinations by mid- to late De-

ember," Rush said, adding, "Our front-line healthcare providers are going to be first in line."

The council approved an EMS staffing proposal Rush presented to help better meet response demands.

He noted the department has been short two full-time employees for some time due to a surgery and an injury on the job.

The department normally has eight full-time employees besides Rush, as well as 11 part-time employees.

Minimum staffing of two people per shift is happening between 40% and 55% of the time at present, meaning there is no local response for a second ambulance call during those times.

"We're looking at a 12- to 25-minute mutual aid response" from an ambulance off the island to handle a second call, Rush said.

The budget and personnel commit-

tee in consultation with the Chincoteague Vol. Fire Company recommended hiring more part-time employees to fill the gaps.

Rush said he plans to go from 11 to 15 part-time staff, which will cost around \$102,000 for the rest of the fiscal year.

Still, \$55,220 remains in the current budget and the department is \$31,000 under total projected expenses for the year to date, so the additional amount needed is around \$17,000.

The council voted unanimously to approve the plan.

The council in other action approved a conditional use permit for David Landsberger to allow use of a separate building at his residence as a bedroom. The building formerly housed his office, which he since moved into a former bedroom in his house.

No one spoke at the public hearing.

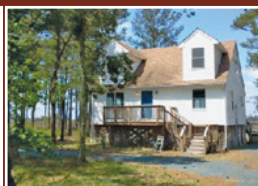

Nurse Goes Beyond Cosmetic To Help Clients Feel Confident

A registered nurse who recently opened a medical spa in Cape Charles is looking for new opportunities to give back.

“Women want to feel good and confident when they go out,” said Stephanie Holvick, owner of R.N. Faces.

Women who are older or disabled are no exception, and working with these clients is Holvick’s specialty.

One of the services she offers is micropigmentation, or permanent makeup. She provides this service free to women who are blind, and she is seeking referrals for new clients.

It’s difficult for a woman to apply her makeup when she literally can’t see what she’s doing, and for 27 years Holvick has been providing permanent makeup services for free to the visually impaired.

She also offers areola repigmentation at no cost to breast cancer survivors who have undergone breast reconstruction.

Holvick also is a breast cancer survivor. She had a lumpectomy in 2008 and radiation. She opted to remove the tattoos doctors had placed on her body as targets for her radiation treatments.

“Some women choose to leave the marks there as a badge of honor – and that’s their choice,” she said via her website, www.rnfaces.com

“I chose to rid myself of the constant reminder of cancer every time I looked in the mirror. I wanted to take back control of my body, and that was my choice.”

Micropigmentation is done by tattooing. Holvick has three different tattoo machines and prefers her traditional coil tattoo machine but also owns a smaller, quieter one preferred by some clients, particularly those who get the permanent makeup.

A full face of permanent makeup includes eyebrows, eye liner, and lip liner, and gives the client the “first line of defense” against aging, Holvick said.

Permanent makeup is a solution for older women who have lost color in their faces with age, particularly as their hair thins out, including eyebrows and eyelashes. Permanent makeup al-

so eliminates the difficulties of applying makeup on older skin that has less elasticity, with hands that may be less steady than they once were.

The permanent makeup design is drawn onto the client’s face so she can wear the look home and show her family before deciding whether or not she wants to commit to the procedure.

The permanent makeup will begin to fade with time, despite its name, and should be touched up every two years, Holvick said.

Her specialty in mature skin also includes the removal of minor skin imperfections.

People over 50 tend to accumulate skin tags and brown spots, and people of color are susceptible to developing a skin condition called dermatosis papulosa nigra, in which small, dark moles or “Morgan Freeman spots” form on the face, Holvick noted.

These imperfections can be removed by non-laser treatment with a machine called the Skin Classic, which uses direct high frequency.

Other available skin procedures include microdermabrasion and microneedling.

Microdermabrasion breaks up and

removes dead skin cells, resurfacing and polishing the skin.

Microneedling makes tiny punctures in the skin, and new collagen is formed as the micro-wounds heal, rejuvenating the skin and reducing the appearance of fine lines and uneven skin tone.

Holvick said she prefers the Skin Classic because laser treatments are more expensive and less effective.

The high frequency typically is effective in one session and can be done in minutes. For example, one client had a skin tag under each eye, and his treatment took about three minutes on each side, Holvick said.

Her husband, Michael Holvick, is a retired chiropractor who went back to school in 2005 to learn skin procedures. He works alongside her with the Skin Classic, which they have owned since 2007. They also teach other clinicians how to use the machine.

Stephanie Holvick has been a registered nurse since 1982. She was introduced to aesthetic nursing while she was working in the field of plastic surgery.

Holvick received her first training in micropigmentation about 10 years into her nursing career, and she was

hooked on the concept. She has been providing permanent makeup for free for the blind since 1993.

She also has had rewarding experiences helping burn victims and clients with alopecia, multiple sclerosis, or Parkinson's disease.

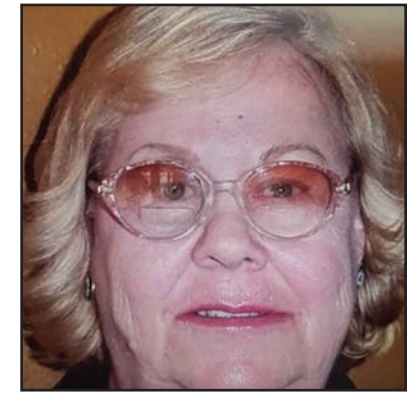
The Holvicks have traveled all around the country, working and training other clinicians on the Skin Classic.

They were in Southern Shores, a town in North Carolina's Outer Banks, when Hurricane Sandy hit in 2012.

During the aftermath of the storm, curiosity drove them to visit Cape Charles for the first time to see if the town had sustained any damage.

Like many couples before and after them, the Holvicks "fell in love" with Cape Charles and decided to make it their home.

Both are retired from their previous

careers and have been enjoying their "last hurrah" in Cape Charles since last August.

Stephanie Holvick decided that after Breezes Day Spa closed, it was the right time to open her own business. A spring opening was not possible due to COVID-19, but R.N. Faces is now open and accepting clients.

The Holvicks no longer travel to train clinicians on the Skin Classic; now Stephanie Holvick holds trainings every Monday at her office in

Cape Charles.

She also plans to offer Botox and fillers at the clinic by Dr. Frances Williams, who is associated with Riverside Shore Memorial Hospital in Onley.

Mary Jordan Heil

Mrs. Mary Jordan Heil, a retired Accomack County school teacher known for her light-up-the-room smile and for inspiring generations of Eastern Shore students, died Friday, Nov. 20, 2020, after a battle with cancer. She was 80 and lived in Poplar Cove.

Heil is survived by her brother, Joseph Jordan, of Toledo, Ohio, and sister, Kathleen Diller, of Medford, N.J. She leaves behind her daughters, Martha Riordon Heil, of Los Alamos, N.M., and Emily Heil, of Washington, D.C.; her son, William Coston, of Hackensack, N.J.; and granddaughters, Mary May and Nicole Jean Riordon Heil, of Los Alamos.

When Heil arrived in Onancock more than 40 years ago, little had prepared her for life on the Eastern Shore — a life that she would come to love. Growing up in Toledo, she wore a starchy Catholic school uniform; later, as a young secretary in Washington, D.C., she donned heels and gloves to attend fancy cocktail parties in Georgetown. But after she and her husband, Nicholas Heil (deceased), settled in Poplar Cove, she often found herself in jeans and a flannel shirt, tending to a flock of 40,000 chickens on the family's property. The unlikely country girl never complained about the pungent, ramshackle chicken houses, the broken-down tractor, or anything else, really. No matter what it was, she saw the good within it.

Heil was born in Buffalo, N.Y., in 1940. She earned a bachelor's degree from Marquette University and a master's degree from Old Dominion University. She taught in the Accomack County school system for more than 30 years, where she was

known as an uncommonly kind and empathetic educator.

As a fifth grade teacher and later an instructor in the talented-and-gifted program, Heil filled her classrooms with fun. Children would paint flowers on the windows and pull wild costumes from the dress-up box of cast-off clothing that she collected. Though many people find middle-schoolers unbearable, she loved being around them and seeing their identities take shape. She loved to teach reading, helping many adults master language in her free time.

Heil was happiest when her home was filled with laughter. When her daughters were little, she threw birthday parties with candy-stuffed pinatas and cakes in the shape of cats. On Halloween, she hand stitched bumblebee and mosquito costumes. Later, she led troops of girls to the Dream roller rink and served tacos for endless slumber parties. In recent years, she delighted in making cupcakes — topped with pink frosting, always — with her beloved granddaughters.

For decades, Heil engaged in near-constant banter with her husband, Nicholas, the love of her life. They met on Capitol Hill in the mid-1960s. At the time, she was working for the House Judiciary Committee, and he was a lawyer for Congressman William Cahill. They married in 1970 and moved to the Eastern Shore eight years later, trading the intensity of politics for the peace of the marshes. Year after year, they strolled the beaches of Chincoteague and lovingly matched wits over the Sunday newspapers.

Heil welcomed hundreds of guests to Poplar Cove, inviting them to sit down at the round oak table in her kitchen. It was the hub of family life, where she served dinner every night and coffee so strong, people said it could stand up without a cup. She made visitors feel at home and took in all kinds of strays, from friends of friends to political volunteers to foreign exchange students. Always a good listener, she would grip people's arms tightly as they spoke, making them feel that every word was important. During the holidays, she made sure everyone left with a heavy tin of homemade cookies.

Everyone will remember Heil's signature laugh, warm and heartfelt. Her children joked that they could locate

her at the grocery store just by listening for it — surely, she had found a friend in one of the aisles. Her laugh expressed her boundless optimism, her appreciation for the good and the goofy in each moment, in each person she shared it with.

The Heil family will hold a private service at their home in late November. They plan to invite extended family and friends to a celebration of Mary's life next summer, or as soon as it is safe to gather.

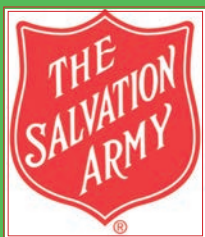

Kiptopeke Students Help Select New Historical Markers

A Kiptopeke Elementary School educator and two of her former students participated in an online event with Gov. Ralph Northam Oct. 29 as he announced 10 new historical highway markers that will honor Black Americans who made history in Virginia.

These signs can be seen on Virginia roadsides and are easily recognized by their distinctive shape, silver background, black lettering, and the official state seal.

Shavonne Ruffin, Kiptopeke Elementary's sixth grade special education case manager, also participated and described how she had attend-

ed a conference where she met Katherine Johnson, an African American mathematician who worked for NASA and helped make the Apollo 11's moon landing in 1969 a success.

The story of Johnson and two other African American women who were NASA computers was told in the 2016 film, "Hidden Figures," which the KES sixth-grade team showed in the classroom.

After seeing the movie, the sixth graders decided to nominate Johnson for the Black history contest.

Two of those students participated in the October online event: Maliyah Jones, who is now a Northampton Middle School student, and Kaela Joyner, who currently attends Great Neck Middle School in Virginia Beach.

Kaela described how the story of Katherine Johnson inspired her to become a mathematician, and Maliyah introduced Virginia's first lady, Pamela

Northam.

Other participants in the virtual program included Laurel Ridge Elementary School student Javier Rodriguez-Aragon, Virginia Secretary of Education Atif Qarni, and Virginia Secretary of Natural Resources Matt Strickler.

Maura Keaney, a technology coach for Fairfax County Public Schools, discussed how her students discovered this inequity while they were learning Virginia history.

Every year, Keaney sends fourth grade Virginia Studies students, dubbed the History Hunters, on a history scavenger hunt.

Part of the project is finding Virginia historical markers, either in person or online. A student gets one point for finding a marker, 10 points for writing a summary of the information provided, and bonus points for taking a selfie with the historical marker.

Last year, Virginia history students were impressed by the story

of 16-year-old Barbara Johns, who led her peers on a strike in 1951 for equal education at their high school in Farmville.

The fourth graders were “shocked, sad, and even angry” that there was no historical marker recognizing Johns’ contributions to the civil rights movement.

They learned there were also few or no historical markers in Fairfax County recognizing the history of Native Americans or women.

Keaney researched how to get a new historical marker installed by the Virginia Department of Historic Resources, but it would cost nearly \$2,000 and would need to be approved by Farmville officials.

That led to a classroom discussion about “how money and power influence whose story gets told,” Keaney said.

She later learned about the Virginia Black history contest, and her students nominated Johns, who was selected to be featured on one of the new highway markers.

The 10 Black Virginians whose stories will be told on the new historical markers, and the future location of each marker, are:

The Vikings Season Comes to an End

The Vikings wrapped up postseason play last week, advancing to the semifinals of the Metro Conference tournament. Broadwater was a fourth seed after a tie for third place turned in favor of Atlantic Shores Christian. The Vikings received home court advantage in the first round where they squared off against Denbigh Baptist Christian Nov. 16. After defeating the Minutemen, Broadwater traveled to Chesapeake to take on the StoneBridge Cavaliers.

For the first time this season, the Metro Conference convened and elected to allow a small number of spectators in to watch the playoffs. Home teams were admitted 13 fans and the traveling team was allowed 12.

The Vikings had already defeated the Minutemen twice in the regular season. Both times Emily Nordwall was on the court and head coach Benji Rew was on the sideline. On this evening both were absent as Broadwater

played sophomore Molly Brown, and assistant coach Heather Hall took the reins. "Proud of the girls. They worked together when they needed to," said Hall.

Sophomore Hope Parrish has been the focal point of attack for the Minutemen. She's been used in a variety of ways, racking up 38 kills in the two prior games, mainly from the middle back row and as an outside hitter. Slowing her down was critical to victory as Suzanna Long took the task personally, often jumping at the net as the lead blocker and finding great success on the night. As she jumped at the net the back row stepped up behind filling the gap as the ball was either deflected or rolled off fingertips of blockers. The young Vikings have struggled with recognizing when to move up or stay back in those situations in past games but were near perfect last Monday night.

Communication was key and the Vikings used it, calling out tips and diving for digs fluidly. Gaps in commu-

nication weren't a common occurrence but happened occasionally especially in set three when the Minutemen overcame the Vikings, putting them in grasp of a comeback after falling behind in the first two sets.

Taylor Leland had another strong performance doing several things for the Vikings that go unmarked in the stat sheet. She assisted on nearly all of the plays but being vocal in where she sent the ball was critical to the team's success as the Vikings defeated the Minutemen, halting their comeback. The Vikings' versatility was on display once again with several players delivering hits that allowed them to defeat the Minutemen in four sets (25-21, 25-13, 19-25, 17-25).

The Vikings were led in attacking by Chloe Hall with eight kills. Molly Brown led in serves, recording five aces. Suzanna Long led in blocking with seven. Seniors Hannah Davis and Sammi Yeung contributed three kills apiece.

After defeating the Minutemen, the

Vikings found themselves once again facing off against Metro Conference goliath StoneBridge. The Cavaliers are favored to win the entire tournament as they're undefeated in the conference and haven't dropped a set to any opponents all year. Freshman Amelia Matson is a force to be reckoned with, leading her team in kills with 173 on the season. Matson and company made quick work of the young Vikings, defeating them in three straight sets (25-13, 25-5, 25-14).

The loss ended the Vikings season but the team "overall accomplished a lot. Some games we were behind and were able to overcome. This group of girls meshed well together and everyone felt like part of the team," said Hall on the season. The Vikings will lose seniors Sammi Yeung and Hannah Davis and will need some players to step up to be successful next year. Hall admitted that the team will lack height next year and will need to establish a middle blocker and libero.

Former Broadwater Student Athlete Set to Play for Barton College

Jordan Yarrell is a 6-foot-4-inch guard who averaged 11.6 points, 6.7 rebounds, 3.8 assists, and 1.6 steals in three seasons for the John Paul II Catholic Saints. Before moving to Greenville, N.C., the Delaware-born Yarrell lived in Melfa and starred on the Broadwater Vikings squad. Yarrell started on the Vikings JV team as a seventh-grader before bumping up to the varsity squad for his eighth- and ninth-grade seasons. He averaged 14 points, 3.6 assists, and 5.7 rebounds in two seasons for the Vikings before transferring to John Paul II Catholic to play for head coach Greg Mullins.

Yarrell's all-around game helped the Saints make the playoffs where he was the team's MVP for three seasons. The versatile guard racked up over 1,000 points in his high school career, landing on the all-conference team three times, including a freshman appearance. Playing primarily as a shooting guard, Yarrell saw some action in the wing position and played power forward occasionally, becoming the team's defensive player of the year leading the team in steals.

COVID-19 travel restrictions limited

Yarrell's recruiting but he drew interest from Highpoint University, University of North Carolina Greensboro, Christopher Newport, and Averett University. He ultimately chose Barton college because of the program's rich history of success and it being close to home. Barton College is a Division II school that competes in the Conference Carolinas where Barton won the NCAA National Championship in 2007.

Yarrell will be competing for a shooting guard position for the Bulldogs, which finished last year's season with a 11-9 record in their conference. Along with the 40-minute commute from home, Yarrell chose Barton because of the relaxed coaching style Ron Lievense uses. "He's a player's coach. He allows you to play your game and adjusts as needed," said Yarrell.

The young guard credits his success on the court to a quick release and his ability to deliver the ball to teammates. With gyms being closed for the majority of the year, he's been working out at home trying to improve his footwork and ability to catch and shoot. He'll be pursuing a degree in sports management as he tries to crack into the senior lead Bulldogs starting five.

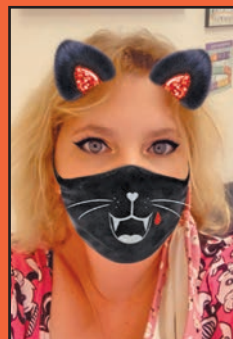

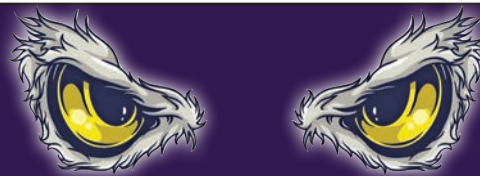

Random Facts About ... Turkeys, Wild and Domesticated

It's no surprise that on Thanksgiving week, our internet tubes were full of random facts about turkeys.

You have to think of turkeys in two distinct categories: wild and domesticated. Turkeys bred and raised for our Thanksgiving tables are large-breasted, overweight, and not too bright. In some cases, these domesticated turkeys become so big that they can hardly stand upright. The heaviest one ever raised was 86 pounds. Domesticated turkeys are artificially

inseminated, the males being too fat to breed naturally. The story of domesticated turkeys being so stupid that they keep looking up at the rain until they drown is not, however, true. These turkeys are unaccustomed to life outside the cage or poultry barn and have been known to panic in the rain, running into fences and piling up on each other with the ones underneath being crushed or suffocated.

Compare this to the wild turkey: an agile, intelligent creature who has been living by its wits for 10 million

years. In short bursts, they can fly 50 mph and can run 20 mph. They are highly social animals, have intimate knowledge of their territory, and will curiously investigate new or novel items in their environment. Male turkeys are called toms or gobblers. Only the males gobble; the females cluck or chirp. The males also grow beards, which are specialized bristle-like feathers that grow out of the males' breast feathers. Only about 15% of females grow beards. By the time a gobbler is three years old, its beard can be a foot long and a few rare toms grow a second beard. Beards are prized trophies among turkey hunters with the record beard being 22.6 inches long. No one seems to know what purpose the turkey's beard serves. Maybe it helps attract females, the hens.

Toms do a lot to attract females. Several will surround a female and dance, puff up, spread their feathers, and gobble excitedly. Only one will get to breed. The featherless head of the turkey will change colors depending on the turkey's mood. Males that are

excited about breeding or fighting will turn bright red.

One explanation for how they got their name is that turkeys brought from the Americas starting in the 1500s came on ships that stopped first in Turkey and then sailed on to Europe. Arriving from Turkey, the birds were called turkeys. The English especially were fond of attributing food from the Americas to Turkey and originally called pumpkins "Turkish cucumbers."

The turkeys imported to Europe in the 1500s had been domesticated by the native peoples of South America and then brought to America by early European settlers. Of course, wild turkeys were already in North America when the settlers got here. There are stories of early pioneers, having heard that a large bird with a featherless head was delicious eating, shooting the turkey vulture by mistake and then trying to serve that carrion-eater for dinner. It is apparently inedible.

But the turkey-turkey is delicious, which is why we eat more than 46 million of them on Thanksgiving.

Extensive Outdoor Holiday Display Is Family Project to Spread Cheer

For anyone mourning the cancellation of Cape Charles' signature holiday events – the Grand Illumination, lighted golf cart parade, Festive Fridays, and Crab Pot Drop – there is yet a little bit of good Yuletide news.

Landon Heath, 12, and his grandfather, Buck Gaskill, have lit up their front yard with a roughly 70-piece show several weeks early this year.

“My wife was reading about all the stress with COVID and how if something makes you feel good, put it up

early. So, we put it up,” said Gaskill.

It's no mean feat putting up 33 inflatable pieces, 12 hard plastic illuminated molds, and innumerable wire frame pieces.

“We've put in three solid days, at least,” unpacking, positioning, assembling, and wiring the pieces in a web of guy wires to anchor the pieces in place.

Some of the pieces date back more than 20 years to the early days of Gaskill's marriage to his wife, Mammy.

However, the project mushroomed when Landon, then living with his oth-

er grandparents, Billy and Cynthia Heath, of Townsend, became fascinated with the displays and began receiving them as gifts.

One of the first was a large Snoopy that is still on display and still much taller than Landon, who today is a lanky seventh grader at Northampton Middle School.

“We try to add one each year, but usually it winds up more than that,” said Gaskill.

For the last five years, the growing display has been a fixture on Gaskill's

front lawn at 20190 Seaside Road, north of Oyster but technically within the Cape Charles ZIP code.

New this year and prominently displayed are a large inflatable turkey and Santa.

“We've had people stop when we're setting up and say, ‘we look forward to seeing it every year,’” said Gaskill.

The costs in term of time and higher electrical bills isn't much of a concern to Gaskill.

“It's fun for us and fun for Landon,” he said.

Volunteers, Staffers Brave Pandemic to Welcome Visitors to the Eastern Shore

In an age when health risks make workers question their jobs, six volunteers are greeting strangers and helping staff the Eastern Shore of Virginia Welcome Center for free.

Since the center reopened from quarantine in July, the six have greeted and counseled visitors, donating a combined 147 hours of time.

“We need our volunteers. They’re essential to the success of the welcome center,” said Christy Betz, assistant executive director of tourism for the Eastern Shore of Virginia Tourism Commission.

The volunteers are Chris Bannon, Randy Childs, Leslie McInnes, Terry and Mike Strub, and Valerie Travis, all of Cape Charles.

The volunteers usually work with a paid staff member, who opens and disinfects the center, then wipes the center down again at closing, said Betz.

During what is typically a two- to four-hour, midday shift, volunteers help during with busy times and allow paid staff members to tend other work and eat meals.

Feeling needed and confident that health protocols will prevent infection is key to motivating volunteers.

“It gives you a good feeling always, no matter how bad things are, that you can help people,” said Paul Tiffany, of Cape Charles, a former volunteer turned paid staffer.

Not only do volunteers work behind plexiglass panes, but the number of people allowed in the center is limited to five.

Also, a table of sanitizers and signs greets visitors at the door.

Even before arriving at the table, visitors pass racks of brochures outside.

The racks, previously placed outside only when the center was closed, now stay outside when it’s open.

And to shorten the time that volunteers have to spend with visitors, pre-filled bags of brochures are at hand.

But perhaps the best defense is empowering the volunteers to enforce the rules.

“I have no trouble saying, ‘I’ll get you a mask,’” on the infrequent occasions that visitors arrive without one, said Tiffany.

The control given volunteers and staff to enforce the protocols and regulate the health risks is total.

Administrators don’t pressure volunteers to work if they don’t feel safe, and the same policy applies to staff.

“We’re volunteering to work, because we don’t have to come in,” said Tiffany.

Four additional volunteers have chosen to pause their service un-

til COVID-19 restrictions end, said Betz.

The spread of COVID-19 across America has altered the types of visitors coming to the center.

Largely gone are overseas travelers and their interesting accents, who were some of the most appealing to talk to.

In their place have come more visitors from the Midwest or who reside within an hour of the Eastern Shore.

The former seem to want to escape the growing contagion of their hometowns.

The latter often want to escape their homes. Many have never seen the Eastern Shore.

For both groups, the outdoors ac-

tivities and spacious vistas of the Eastern Shore offer safety and relaxation.

“The Eastern Shore has been socially distancing since the early 1600s,” said Robie Marsh, executive director of the Eastern Shore of Virginia Tourism Commission.

Despite the COVID-19 restrictions, however, the work day for volunteers remains fundamentally as it was before.

“It’s almost impossible not to engage with people,” Tiffany said.

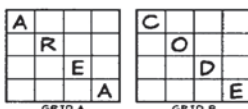

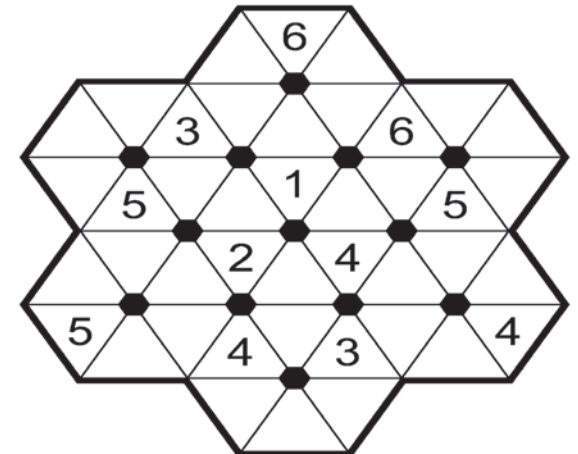

A Better Monument Solution

Dear Editor:

The closing paragraph in the letter from Bill Payne in the Nov. 20 Post conveys the message that the Confederate monument should be removed. There is a far superior alternative, but it will take time to plan and money to execute. That plan is to erect a statue of a Union soldier of recognizably African descent at the same site. Patience is required to allow that planning to be done.

We have a teaching opportunity here which, in its focus and its potential scope, is very likely without parallel elsewhere. Of those men from here who volunteered for the Union forces, nearly all had African ancestry. Of those men who volunteered for the Confederacy, nearly none had African ancestry.

These Union soldiers later formed on the Shore a remarkable six posts of the Grand Army of the Republic (GAR), the Union veterans organization.

The existing statue is not an aggrandizement of a Confederate general, it is just an individual soldier.

The statue was erected during the Jim Crow period, and this new statue might be thought of as reflecting the progress toward equality made since then. We

can memorialize and name the individuals who served on both sides, but this is an opportunity to honor in particular those men who until now have had no public recognition of the part they played in the fight for our founding precept that all men are created equal.

Every person with whom I've so far spoken about this concept recognizes its excellence and that it's a novel, positive approach. These include, in addition to several local persons, the former curator of the Abraham Lincoln Collection at the Lincoln presidential library in Springfield, Ill.; the head of the GAR Museum and Library in Philadelphia; and a historian specializing in the U.S. Colored Troops.

My own experience may be an example of how one spark of knowledge prevented from extinction can create interest in further learning. I became aware of this whole subject because a deification image of Lincoln was discarded, by someone who was ignorant of its significance, into the old green box just by the Gaskins Chapel Church, from where it found its way to our home. Had the image gone to the landfill, I'd have remained ignorant. Today its story, including its connection to the history of the Shore, can continue to be told. Gaskins Chapel Church was also the site of one of those six GAR posts.

The new main library building in Parksley will contain the Heritage Center, where collected papers of local people from that era will reside – including many documents still with the descendants, but which will need a home eventually. These also are part of the fabric of local history which must be saved and studied.

The graves of these Union veterans remain largely unmarked as to their service, while many veterans elsewhere have GAR grave medallions. It may have made sense during Jim Crow not to provide targets, but that omission can be rectified now.

Teaching and learning of history (and

much history-related tourism, even without a battlefield) can flow from this project as its center, with both statues in place at Eastville alongside other relics there of the history of slavery. Much of great value will have been needlessly squandered if the Confederate statue is removed.

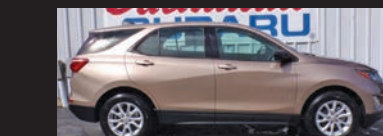
