‘The hugest success stories in aquaculture’ VIMS to dedicate massive \$17M Wachapreague project Saturday

A world-famous Eastern Shore aquacultural laboratory is getting even bigger and better with a campus upgrade.

Officials will dedicate six new buildings on the Virginia Institute of Marine Science’s Eastern Shore Lab campus in Wachapreague during a by-invitation ceremony Saturday for people involved in the \$17 million project.

Construction is still ongoing at the campus, which is part of the College of William & Mary. An open house and tours for the public will be held when construction is complete.

Research performed at the lab under Mike Castagna, its first director, resulted in development of the highly successful Virginia hard clam aquaculture industry, which last year had production of \$58 million, nearly all from the Eastern Shore.

“Even though this is a very small, humble place, this is one of the hugest success stories in aquaculture ever,” said Richard Snyder, the lab’s director.

“If you go anywhere in the world and you talk to people who know about aquaculture, they know Mike Castagna’s name and they know Wachapreague,” he said. “This place is world-famous because of that aquaculture success story.”

Two lawsuits allege town violated law

Mayor says municipal business has stopped, per lawyer’s advice

Two members of the Parksley Town Council have filed lawsuits against its mayor, several council members, and the town itself, alleging they misused closed meeting laws to illegally hide town business and “silence open discussion.”

The council members, Daniel and Carol Matthews, who are married, in separate petitions for writs of mandamus (a court order to properly perform a duty), allege town officials have held illegal executive sessions. Another meeting, they say, was not properly advertised.

State law allows governmental bodies to enter sessions closed to the public to discuss a limited number of topics, including employee performance or prospective land acquisition.

The Matthewses are petitioning the court to compel the town and its officials to comply with Virginia’s Freedom of Information Act, or FOIA, according to the lawsuits. They are representing themselves.

The lawsuits apparently have ground town business to a halt. Mayor Frank Russell said Tuesday the town’s Oct. 10 meeting was canceled on advice of the town’s attorney.

“It’s going to cause the town business to stop until our lawyer tells us differently,” he

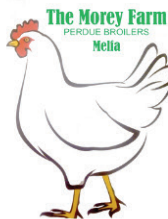

said.

Russell said he plans to make a video to post on social media to explain the situation to residents.

Russell said that during his involvement with the Town Council, "we have never had a citizen or a council person bring legal action against our town to the best of my knowledge."

Daniel Matthews is running for re-election in the Nov. 8 town election. His wife is not on the ballot this year.

Carol Matthews filed a petition for a writ of mandamus Sept. 19, naming Russell and the town as defendants.

Daniel Matthews filed a petition Sept. 21, naming as defendants Russell; three council members — Sam Welch, Jan Welch, and Ricky Taylor; and the town.

Carol Matthews alleges Russell, "select members of the Parksley Town Council," and the town's FOIA officer denied her rights under the act "by knowingly and willfully violating (Virginia) FOIA as it pertains to closed meeting laws," according to the complaint.

She alleges the defendants have gone into closed sessions illegally and used those sessions "to discuss non-exempt topics, intimidate the plaintiff and other individuals, as well as silence open discussion that should be shared with the public," according to the petition.

The lawsuit cites four different in-

stances between March and July when Carol Matthews alleges the Parksley Town Council went into executive session improperly, as well as detailing a dispute over the contents of meeting minutes.

Carol Matthews asks the court to order the mayor, council members, and the town clerk to comply with FOIA, and to order the clerk to include Matthews' statement of concern and point of order about an executive session at the July Town Council meeting in the meeting minutes.

Daniel Matthews' complaint alleges Russell, three council members, and the town's police officer met improperly Sept. 4 to discuss town business (hiring another police officer) and interviewed a candidate for the job, without other council members or the public being properly notified.

Russell called it all "a very sad situation."

"The majority of our council ... donates our salary back to the town so that it can be used for more important things. Most of our council works very hard for the citizens of the town of Parksley and it makes me extremely sad that this legal action has been brought against the town of Parksley," Russell said.

"The majority of our council has been working hard to move our town forward in a positive direction and I don't understand why any elected official would want to portray our town in a negative light."

Russell said he has been involved with the Town Council "bordering on 20 years now."

The lab serves as a field station and coastal seawater laboratory for marine science and aquaculture research, marine science education, outreach, and advisory service to the commonwealth of Virginia, in particular about marine resources on the Eastern Shore.

The lab also attracts scientists from around the world — recent visitors came from New Zealand, Wales, Africa, and the Virgin Islands — to conduct research in aquaculture and coastal ecology.

The construction project includes more than 22,000 square feet and replacement of several structures, including the original administration building, which dated to 1961, and the Castagna Shellfish Research Hatchery.

A residence hall and maintenance and storage facilities also were replaced.

Additionally, a new education center, designed to expand research capabilities, was added behind Seaside Hall.

The center, on Riverview Avenue, includes a molecular biology lab, an algae culture lab, microbiology labs, offices, and a classroom.

The new Castagna Research Hatchery, on the waterfront, is designed to

withstand tidal flooding and is built for its purpose, instead of being retrofitted, as the former hatchery was.

The facility previously added two other buildings, the Seawater Lab and Seaside Hall, in 2012.

The initiative to renovate and add to the campus was supported in the General Assembly by local legislators Del. Rob Bloxom and Sen. Lynwood Lewis, along with the aquaculture industry and friends of the lab.

In addition to new facilities, three new positions are being added: a faculty member; a marine technician, who will also coordinate outreach and education activities; and a facilities maintenance employee.

The lab currently has nine employees.

The Eastern Shore Lab was established as a field laboratory of VIMS in 1959, but there previously was a small research facility in Wachapreague during World War II, according to Snyder.

Researchers during the war worked under a contract with the DuPont Corporation to study methods of culturing marsh mussels, which at the time were in demand as a source of vitamin D.

Research being done today at the facility includes, among other topics, seaside bay scallop restoration and aquaculture and the potential commercial viability of growing kelp and algae on the Shore.

Local walk raises \$40K

The Alzheimer's Association's Southeastern Virginia chapter held its 2022 Walk to End Alzheimer's at Eastern Shore Community College on Oct. 8, with local teams raising more than \$40,000 to help fund research to develop treatments for the progressive brain disease.

"As the prevalence of this disease grows, the cost of care will escalate into the hundreds of billions of dollars. Alzheimer's is destroying our families, our finances, and our future, and it's time to end it," said Katie McDonough, executive director of the Alzheimer's Association chapter.

Last week, results of a phase-three clinical trial of a drug called Lecanemab showed a 27% reduction of cognitive decline in people living with early Alzheimer's disease, McDonough said.

"This is the moment when we will

look back years from now and say, 'This is when it all started. This is our beginning,'" said Executive Director Katie McDonough.

The number of Virginians age 65 or older with Alzheimer's was 150,000 in 2020 and is expected to rise to 190,000 in 2025, an increase of nearly 27%.

The growing number of Alzheimer's patients burdens health care providers and family members.

Medicaid alone spent \$1 billion on care for Alzheimer's patients in Virginia in 2020.

Last year, 351,000 family members and friends provided Alzheimer's patients in Virginia 524 million hours of unpaid care valued at more than \$8.5 billion.

Alzheimer's is a serious disease that does more than cause memory problems: more than 2,600 Virginians died from the disease in 2019.

The Alzheimer's Association is contributing to the cause of finding a cure

by investing more than \$310 million in 950 projects in 48 countries worldwide.

The 2022 Walk to End Alzheimer's on the Shore had 14 teams and a total of 230 participants who raised money and walked the half-mile loop at the community college.

The Alzheimer's Association chapter is 80% of the way to its \$50,000 fundraising goal, which it may complete by the end of the calendar year.

The Virginia Federation of Humane Societies (VFHS), the Humane Society of the United States, and the Friends of Eastern Shore Animal Control are hosting a discussion on animal protection issues, what people can do to help, and how to work with state and local officials.

“VFHS has a long history of providing grant funding to animal welfare organizations on the Eastern Shore, including Northern Accomack Community Cats, Chincoteague Island Community Cats, and to the animal shelter in

Melfa. We are deeply committed to helping citizens and pets there,” said Debra Griggs, of the VFHS board of directors.

The Virginia and national humane societies are hosting eight similar events across the state to hear from Virginia residents “and it is important to us to include the Eastern Shore,” Griggs said, adding, “We are eager to talk to folks on the Shore and hear from them about animal welfare issues from their perspective.”

The event is open to everyone.

“We expect the most interest will be from folks actively involved in serving dogs and cats on the Shore — rescue groups, TNR (trap, neuter, release) practitioners, and citizens who care about the welfare of animals and want to learn more about how they can help,” Griggs said.

Northampton wants more info on nonprofit's tax request

Northampton supervisors want more information before they entertain the idea of granting local tax exempt status to a Christian nonprofit.

"I want to know more about what the benefit is to our community," said Supervisor John Coker on Oct 11.

The Youth With a Mission Bridge Network of the Eastern Shore is applying for a real estate tax exemption for property it is purchasing in Nassawadox.

According to documents submitted by the nonprofit, the property is on

Rogers Drive, was previously owned by the Northampton Accomack Memorial Hospital, and includes a building that once was a nursing school.

The property consists of about 20 acres with improvements and is valued at more than \$4.2 million.

But Youth With a Mission has not yet identified its local target audience or described the programs and activities it is planning.

"They talk about the kids, they talk about the elderly, they talk about everything, but there's no description of what they're going to do," Coker said.

He also wanted to see evidence that the local community supports Youth

With a Mission.

Furthermore, the project is only in the beginning stages and there's no way to predict when or if the nonprofit will ever begin operations in its new location.

"We don't want another empty building in Nassawadox that's not paying taxes," Coker said.

He was concerned about the precedent that would be set by giving local tax exempt status to an organization that isn't a church or a school but "something else."

There are likely 100 or more such 501(c)(3) nonprofits in Northampton County and "the line's going to be out the door" for tax exempt status, he said.

Chair Betsy Mapp agreed that more information is needed before supervisors can make a decision.

Supervisor Dixon Leatherbury said that Youth With a Mission is a nationwide organization that does "good work" but acknowledged that its intention for the Nassawadox location is "just simply not spelled out."

The supervisors agreed not to advance the matter to a public hearing until Youth With a Mission has the opportunity to present more information on its project on Nov. 7.

Coker said the presentation must be "miraculous" to convince supervisors to grant the nonprofit's request.

from FACES likely will share information about that organization as well.

"VFHS is deeply committed to the people and pets of the Eastern Shore," Griggs said.

The organization for the last three years has secured grant funding to sup-

port TNR activities of three community cat groups on the Shore and also has provided funding to the Eastern Shore Regional Animal Control Facility in the form of vouchers to reduce the cost of adoption of sheltered dogs and cats.

ACCOMACK

Man makes plea in sex crime

A Newport News man originally charged with rape pleaded guilty to carnal knowledge of a 13-year-old girl in a plea agreement with the Accomack County prosecutor.

Victor Antonio Coll, 25, was originally set for a jury trial. He is allowed to remain on bond until his sentencing in February but is prohibited from coming to the Eastern Shore except for court meetings.

Coll was visiting his father and family for Christmas in 2020. He admitted going into the girl's bedroom and having sex with her.

Commonwealth's Attorney Spencer Morgan said he entered into the agreement with Coll to spare the victim, who did not want to testify and because there was no forensic evidence.

The girl did not tell her mother what happened until almost a year later.

According to the terms of the agreement, Judge W. Revell Lewis III ordered that a presentence report and a psycho-sexual evaluation be prepared and that Coll's active jail time be limited to the midpoint of the sentencing guidelines.

He also told Coll he is not to come to the Eastern Shore of Virginia for any reason other than court-ordered meetings.

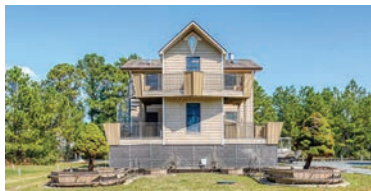

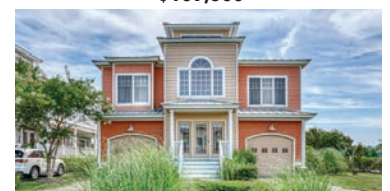

Casting a global net for our teachers

The United States cannot produce enough teachers to fill its own teaching positions. That's jarring.

On the Eastern Shore teacher recruitment is especially difficult. So it was interesting to see Accomack County Public Schools extend its recruiting efforts overseas as it looks for educators.

The result, according to a Sept. 30 article in this paper, is striking. Nearly a dozen new teachers who were hired by Accomack County in the past two years are from Jamaica, Columbia, and the Philippines.

They are well-regarded by their peers and meet work requirements like having two years of teaching experience.

Why the shortage? Teachers nationwide are leaving the profession and fewer college graduates are entering it.

Another article in the Sept. 30 edition of this paper reported on an anonymous exit survey Accomack County gave to its departing teachers.

Only 40% of the 60 teachers who left Accomack schools responded to the survey — a small rate of participation after what seems like a pretty large departure.

The top reason for taking a teaching position elsewhere was higher pay. The second reason was fuel prices and teachers looking for a shorter commute.

We'd like to know what reasons would have been given by the other 60% who decided to leave the school system but didn't respond to the survey. The insight would help officials understand — and fix — the exodus.

And we'd like to welcome our new teachers from abroad. We're fortunate they've come to the Eastern Shore to make an investment in our most precious resource: our children.

She's been the chief clerk for the Accomack County General District Court since July 1, 2006.

In Northampton County, Karen Merritt has been the chief general district court clerk since 2001. In all, she has been full time in the office for 33 years,

and for three years before that on a part-time bases.

It is fun to talk to people like Chisum and Merritt who work hard behind the scenes. They seek no fanfare and ask for no credit.

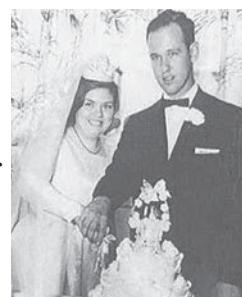

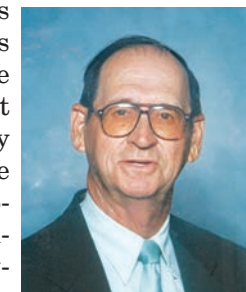

If you were to ask others about David, most everyone would say he was a character. He loved people and he had the gift of gab to the point you would wonder if he was ever going to stop talking. As long as you were willing to listen, he was willing to talk. JoAnne was well aware of his "gift" and always expected him to come home at least one to two hours past the time he told her. Sometimes he would stop on his way home and picked some flowers for JoAnne. It was a running joke that when he worked for Salyer Funeral Home on occasion, that he would come home with flowers for her and she teased him on whether he bought them, picked them, or just happened to "find" them after the funeral services.

David did not graduate from high school as many young teens did not back in those days. Instead, he went to work for Gene Taylor at Wallops Island Supply Company when he was 16 years old. David was always grateful for the years spent with Gene as he unselfishly took David under his wing, mentoring him and successfully teaching him the plumbing trade to the point that David earned master plumber status. Eventually, David owned and operated Snead Plumbing Inc., which he ran for almost 50 years. He loved the business mainly because he loved people. And he took his "gift" right to

the worksite, often coming back to the work van finding his helper asleep because they were done waiting for him to finish up his conversations. And this was part of the personality that so many loved about David because for him, it wasn't all about the money but the relationships formed. He never expected anyone to pay more than what they were getting and also made sure that widows were well taken care of. David also partnered with David Ross, operating Ross & Snead Inc. which began in the late '70s. Together they built and sold several spec homes on the island and eventually partnered with Jack and Glenn Hirose, forming Boulevard Plaza, from which they built the Dollar General Store. They also built Fiddler Bay Townhomes. David was the initiator along with his son-in-law, Tom, to open the Watson House Bed and Breakfast, which became so successful that he, Joanne, Tom, and Jacque opened the Inn at Poplar Corner with the concept drawing done on a napkin based on a home that he once saw in Suffolk, Va. They operated the B&Bs along with several rental homes for 14 years. David also spent his time volunteering in the bingo stand at the annual firemen's carnival and was so dedicated to the task that they made him an honorary member, of which he was extremely proud. He also lent his time to the Kiwanis Club over the years as work would allow. While a member of the Kiwanis, David oversaw the making of the brick sign that stands in front of the Chincoteague High School with the help of the CHS Key Club. He also began carving decoys in his late teens and was known

for his painting styles on the birds so much so that other carvers would send their decoys to him to paint, which earned him supplemental income. He became involved in the local jail ministry years ago with other members such as Roy Jones, Curtis Allen, Tommy Daisey, and with his father, Paul. He loved ministering to the incarcerated and telling them about Jesus. He was a member of Union Baptist Church and served as an usher for many years. Later, he started to attend the church by the beach – Church of God. He gave his heart to the Lord in the mid '70s and often told others of his love for the Lord and even while suffering with dementia, his love for the Lord never left him. He also dearly loved his family and friends.

There will also be musical performances by John Gordon, Corn Funk Review, The Hookz, and Mosquito Cabaret.

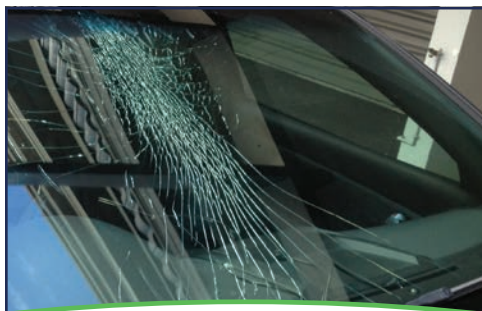

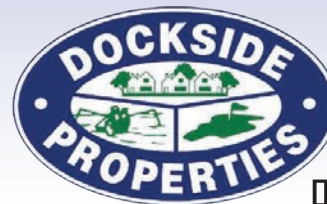

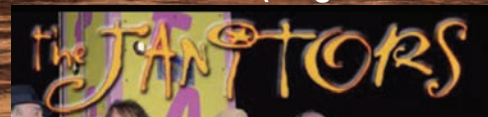

Local disc golf group is a real ace

It's been almost six years since Exmore resident Will Smith became involved with disc golf. Smith has accomplished a lot since he fell in love with the sport.

He has earned one win at a Professional Disc Golf Association sanctioned event and in 2019, he took over management operations for the Eastern Shore of Virginia Disc Golf Club.

One aspect of disc golf that Smith enjoys is that indi-

viduals can choose their own level of involvement.

"You can play three times a day or three times a year," he said. "There are also a variety of competitive events you can choose to participate in."

The origins of disc golf date back to the 1970s. The rules of the game are similar to golf, but instead of using a ball and a club, players throw a flying disc at an elevated metal basket.

ESVADGC matches are held all over the Shore. Every third Sunday, the club hosts a monthly tournament in Indiantown Park at 10 a.m. Every first Saturday, the club hosts a monthly event at the Historic Onancock School. Smith also has a private course in Exmore named the Lynwood Forrest Disc Golf Club.

Smith helped grow public interest in disc golf by creating a social media presence for the club online. The ESVADGC also offers prizes to winners and has a ranking system that recognizes players of all skill levels.

The club has 40 members and each event averages 25 to 35 players. Currently, the club doesn't offer clinics

or open houses to those interested in learning how to play disc golf, but plans to offer them are in the works.

Playing disc golf has several benefits. It can serve as a full body exercise and stimulates the mind. It is also an inclusive sport.

"I've played rounds with people from all walks of life," Smith said. "You can really develop a sense of community through disc golf. I've made friends over the last five years that I will have for the rest of my life."

Chesapeake Bay striped bass season opens

While most of the state was busy tracking the movements of a storm named Ian, the 2022 Virginia Chesapeake Bay striped season quietly opened Oct. 4 and will remain open through the end of the calendar year.

Anglers are allowed only one fish per day, and that fish must measure in the 20-inch to 36-inch slot limit.

In addition, anglers targeting striped bass using live or dead natural baits must use only “non-offset corrod-

ible, non-stainless steel circle hooks.”

The 2022 coastal (seaside) striped bass season opened May 16 and also will remain open through the rest of the calendar year.

The bag limit is one fish per angler and the fish must fit into the 28-inch to 36-inch slot. The same hook regulation applies when targeting striped bass with bait.

Upper Shore

Most anglers I spoke to have told me that fishing (or catching) action has not returned to the pre-storm level.

Anglers working the shallows on the Chesapeake Bay side are finding some small striped bass and a few speckled trout.

The sudden dip in nighttime temperatures appears to have given the shallow water fish a case of lockjaw but I think we will see an uptake in the action by the weekend.

On the seaside, the surf action has produced a variety of fish, but no large numbers of any species. Anglers have reported catches of bluefish, whiting, spot, trout, and a few slot-sized puppy drum.

Flounder catches are still coming from inside the seaside bays for anglers using live minnows and Berkley Gulp.

Wachapreague

The charter vessel, Heat Wave, with Captain Dale Dirks and angler Alex Jerasa boated a potential state leading 275-pound bigeye tuna while fishing in the Washington Canyon on Monday. The fish was weighed in at Trident Tackle.

Once the paperwork has been finalized, the behemoth tuna should best the current Virginia Saltwater Fishing Tournament leader, a 253-pound, 7-ounce bigeye tuna caught by Carter Andrew Smith in the Norfolk Canyon.

Both Captain Lindsay Paul, of Trident Tackle, and Amanda Manzella, of the Wachapreague Inn, said there are still some flounder and speckled trout being caught inside the inlet. A few red drum have been caught in the surf on the flood tide.

Lower Shore

Dez Louie, at Oceans East – Eastern Shore, said the anglers fishing around the pound nets off Kiptopeke have been catching lots of speckled trout, mixed sizes of red drum, flounder, and schoolie-sized striped bass.

Natural colored patterns and white artificials have been successful when the waters have been clear, while chartreuse and pink-colored baits have been more productive when the waters have been stained.

Recommended soft plastic lures include Berkley Gulp and Z-Man Minnowz with Pro-Cure gel scents. Hard bait recommendations include Mirrolures and Rapala Skitterwalk top-water baits.

I spoke with Jeb Brady, of Bailey’s Bait & Tackle in Cape Charles, while he was out fishing for speckled trout Monday.

He took the time between casts to tell me of his optimism with the improvement of the bite since the passing of the storm and the drop in water temperatures.

Trout catches were being made in the bayside creeks as well as on the seaside out of Oyster, primarily on artificial baits.

Brady and his staff have had success recently using the Down South Lures soft plastic baits.

Puppy drum schools are still patrolling the shallows on the lower bay-side and anglers targeting them have enjoyed success using baits fished under popping corks.

Best action on the early season striped bass has occurred after sunset while casting artificials under and around lights.

Late season sheepshead catches are still coming from around the Chesapeake Bay Bridge-Tunnel pilings and over the Cherrystone Reef. Catches from the lower bayside piers have consisted mostly of spot and small trout.
