PARKSLEY: THE SHORE'S LITTLE TOWN THAT COULD

Parksley, the little town that could, has been gaining momentum in its quest to return to its former life as a thriving metropolis.

With bragging rights of being the future home of Eastern Shore Public Library and Heritage Center, having the best bridal boutique in Virginia, combining art into the scene, erecting a war memorial, revitalizing its look, opening a DMV office, housing the county's public works department, and planning a fall festival to commemorate its 30-year-old railroad museum, things are moving and shaking there. It's all part of the plan to bring more people to Parksley to visit, shop, and live.

The town's history goes back to the mid-1880s and the beginnings of the railroad on the Eastern Shore. Parksley was the second planned town, coming after Cape Charles, and was laid out in 1885 under the management of the Parksley Land Improvement Company.

In 1898, there was an attempt to relocate the county seat from Accomac to Parksley. That feat was not successful, but in modern days the push to move the library from the aging building in Accomac to a renovated structure in Parksley made the cut. A former grocery store will be used as a shell and made larger for a new facility that will also include a meeting hall and more computer access for the public. The fruition is more than a year away.

Parksley was incorporated in 1904.

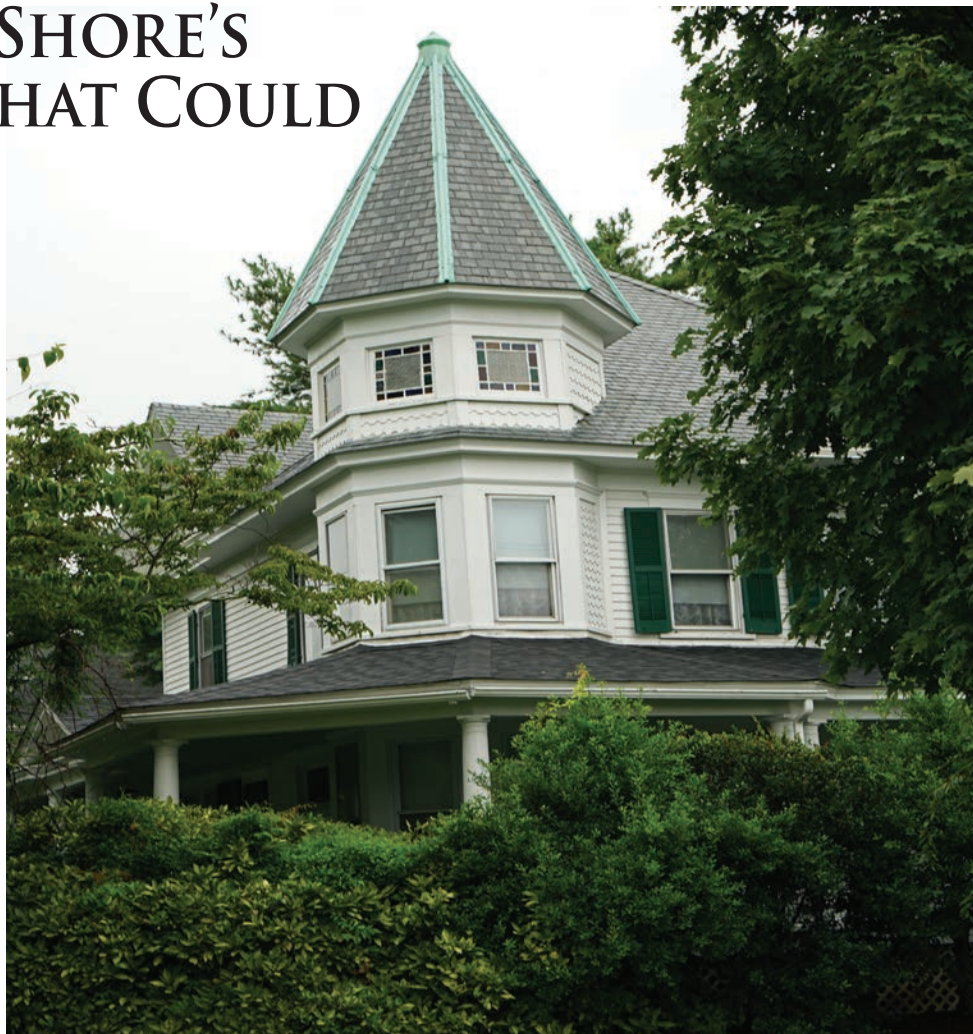

At one point it was a significant shipping point for seafood and produce harvested in the area. These days, a seafood store is among the newer shops and a farmers market is in the center of town.

During World War II, Parksley was

the site of the Shore National Guard Armory and its airfield was used by the Civil Air Patrol. It was also home to the Parksley Spuds, a team that played in the Eastern Shore Baseball League.

Parksley was flourishing 35 years ago. "We had two grocery markets, two banks, the shirt factory was open, and the Lunch Box (restaurant) was open," said Deborah Russell, who owns Russell's Formal

Guilty Plea From Woman Who Neglected, Caged Her Children

Malista Ann Ness-Hopkins pleaded guilty Thursday in Accomack Circuit Court to neglecting five of her children "in a manner so gross, wanton and culpable as to show a reckless disregard for human life."

She could be sentenced to a maximum of 25 years in prison and fined \$12,500.

After a complaint was filed with the county's department of social services last summer, a worker went to the defendant's Mearsville home and found the residence was filthy, it smelled of urine and feces, the children had lice and flea bites, and two of them were held in makeshift crib cages, Assistant Commonwealth's Attorney Elizabeth Wolff told the court.

Three of the children were under three years old. All were younger than 18. One growled and hissed "like a caged animal," Wolff said.

Judge W. Revell Lewis III allowed Ness-Hopkins, 39, formerly of Gladding Road, who is now living in Accomac with a friend, to remain free on \$10,000 bond until sentencing, which is scheduled for December.

The children are in the custody of their grandmother and foster care.

In late 2016, Wolff said, another of the defendant's nine children was living with her. The daughter stated Ness-

Tourism Director Ruffles Some Feathers at Economic Development Workshop

When Chairman Robert Crockett of the Accomack Board of Supervisors attended an invitation-only economic workshop recently in Onancock, he said he became "alarmed" by the large note posted on the wall behind the session's speakers, which included Gov. Ralph Northam.

"Outlaw Industrial Chicken Farming," Accomack's biggest industry, was the message staring at Crockett on a 5-inch by 7-inch, or larger, yellow paper. "Comments were posted on the wall and everyone was facing that wall," Crockett said Tuesday. "It was clear from where I was sitting what it said. When you got closer you could see that her name was affixed on that comment."

Crockett was speaking of Kerry Allison, executive director of the Eastern Shore of Virginia Tourism Commission.

"I believe the tourism commission, they need to address the comment that was made," Crockett continued. "The position that their executive director took to the governor, I can't, I don't, understand why she would make a comment like that. Because I can't see how it (chicken farming) is going to harm tourism at all. The stronger our economy is, the better all parts of our economy are," Crockett said.

Allison is on a two-week vacation to Ireland, a phone call to her office confirmed. An email to her was immediately returned and stated, "I am out of the office until Monday, Aug. 13."

Crockett said since Allison attended the session and was there representing the commission, he figured she was conveying the feelings of the tourism board. The poultry industry in Accomack involves more than 4,000 jobs.

"I see it as a very serious issue with a person with her position. ... Is that their position?" he said of the commission. "If not, they need to come out and say it's not their position."

Crockett would not say if the board of supervisors would publicly discuss or take action on the issue.

"I think it's a mountain out of a molehill," said Steve Potts, chairman of the tourism commission. "We are the fastest growing industry," he said of tourism. "I don't know if that's newsworthy. I'd have to talk to the powers that be who were there. If someone

sent me a survey, would I tell them what they wanted to hear? ... Seems kind of crazy that someone from the A-NPDC (Accomack-Northampton Planning District Commission) would want to damage someone. I don't know what's going on."

Potts said he was going to investigate the situation. He didn't get back to the Eastern Shore Post by press time. Supervisor Laura Belle Gordy, who serves on the tourism commission, said the panel has never discussed the poultry industry.

A-NPDC Planning Director Curt Smith said when comments were solicited, "It was made clear that all ideas would be shared with others." He said a summary report that will go to state agencies would be ready in about seven to 10 days. "We gave everybody a chance to submit a project idea." They got five words that were printed and posted with their names attached to them. There were 50 to 60 ideas. "I treated it like every other comment that came in. It was posted like every other idea."

Smith said Allison's comment did not come up during the meeting.

The Virginia Housing Development Authority, Virginia Department of Housing and Community Development, and the Virginia Tourism Corporation were among the state agencies that attended. Smith was asked to facilitate the session. "I set it up to put the state agencies to task," he said.

Supervisor Grayson Chesser was not pleased with Allison's comment. "It is pretty disturbing when the rep of one industry here attacks another industry here. We're all supposed to be working for the better of the two counties. Whether you like poultry or not, it is by far the largest industry here, for Northampton too, as one in 10 from there works in the plants ... She could have said lessen impacts or friction between industrial poultry and the tourist industry. I wouldn't agree with that. I think we've already done it. You have to remember not everybody likes tourism ... Not everybody is in love with tourism but it is part of our economy. Agriculture and the poultry industry dwarfs tourism and that's not to put down tourism either."

18-Year-Old 'Remorseless Killer' Gets 48-Year Sentence

Referred to as "a remorseless killer" by the prosecutor and certified as an adult by the court although he was 17 when he committed murder, robbery, and related gun offenses over a \$20 drug deal gone wrong, 18-year-old Zachary Isaiah Townsend was sentenced Thursday in Accomack Circuit Court to nearly five decades in prison.

Judge W. Revell Lewis III gave Townsend, formerly of Greta Road in

Atlantic, 40 years with 10 suspended for second-degree murder of Nathaniel (Nate) Adam Ayres, 19, Deer Drive in Nelsonia, 20 years with 10 suspended for robbery, three years for one count of using a firearm in a felony, and five years for the second firearm charge.

The jury that convicted Townsend was not tasked with recommending sentences for him because of his age.

Townsend did not make a state-

ment when he was asked by Lewis if he had anything to say about the crimes. He never talked to police either.

Commonwealth's Attorney Spencer Morgan said Townsend has shown no remorse. "Coldblooded acts from a remorseless killer and I ask the judge to sentence accordingly," he said.

Morgan had three reasons for asking for the stiff sentence: Townsend's previous record of shoplifting and burglary, "the impact this horrible act had on his (Ayres') family and friends," and that the crimes were "for nothing more than \$20."

Defense lawyer Paul Watson had his three reasons for asking for a more lenient term. He suggested about 20 years for the crimes because Townsend was a juvenile; he was intoxicated on pills, marijuana, and alcohol; and he had a difficult upbringing filled with physical and substance abuse.

Testimony showed Ayres was shot, in front of two other youths, six times at close range with a revolver that was never recovered. One bullet entered the Ayres' right temple and went through his scalp and face, lodging in his sinus,

a medical examiner told the court. Another hit behind the right ear passing to the carotid artery and voice box. Ayres was also struck with gunfire in the back of the head and neck. Another bullet entered the front of his left shoulder and down into the ribs and back. A blunt force laceration, found on the side of the victim's head, was not consistent with a fall. Townsend died of gunshot wounds to the head, neck, and torso.

Lewis said after Townsend was caught committing the previous crimes, treatment was recommended. "Unfortunately, his father was not involved in his life. His mother opposed treatment. That is incredible that a mother would oppose treatment calculated to help her son ... when negative things happened that aren't properly dealt with, unhealthy ideas develop. "In this case, Townsend had absolutely no respect for human life."

Ayres' grandmother wrote to the court about the defendant, "You did not just take his life. You took mine (and) the innocence of those who witnessed" the crimes.

"She has a perfect right to her own opinion," Chesser continued. "But you don't have a right to your own opinion when you are representing an agency ... These are my friends and neighbors. She's saying their jobs should be outlawed."

"The ball's in the tourism commission's court," the supervisor said. "I'm pretty sure all of them know about it." So what does he want to happen? "That's not for me to say, we don't have any say over who they hire, I don't

think. If that is the official possession of the tourism commission, I will not look too favorably on the tourism commission. I certainly hope it's not and I don't think it is. This is people's lives you're dealing with, their livelihood. You don't do that flippantly."

"This is the one industry where people can raise a family, get food health insurance, retirement, have a car, put kids through college, and move up" in the company, Chesser said.

Accomack included \$86,500 in its budget for the tourism commission this year. Northampton gave \$144,000.

As most of your readers know, from 2012-2015 there was an attempt by a small band of opportunists-complicit with the members of the former Board of Supervisors - to rezone Northampton County into something it was never intended to be....Virginia Beach or Ocean City. & Bridal with her family.

The bridal shop was named among of "Best of 2018" in the state by Virginia Living magazine. "Elegant dresses line the walls of this 34-year-old shop, including gowns from Justin Alexander, known for classic silhouettes and clean lines, the Beloved collection by Casablanca, with its airy and bohemian feel, and the Rebecca Ingram collection by Maggie Sottero, with its trademark lace and timeless romantic aesthetic," the publication stated.

Russell talked about the decline of the town with optimism for what it can be again.

"It all started to crumble when the shirt factory closed, then Parksley Drug sold to CVS, then Shore Bank and PNC closed branches, and finally the grocery stores went," she said. "We managed to survive all the closings and worked very hard to keep Parksley alive."

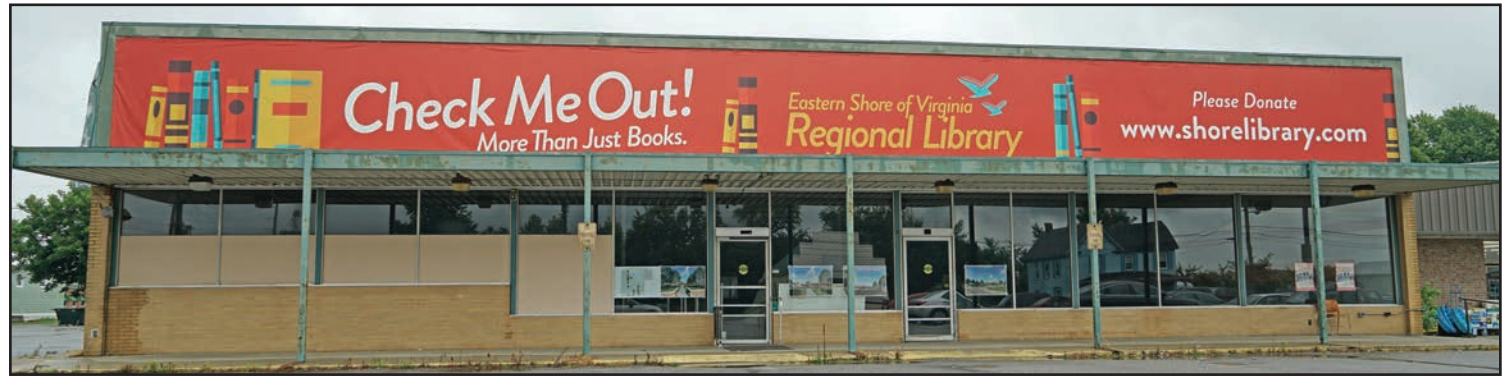

Russell's husband Frank also owns an auto repair business in Parksley with his brother, Fred. Frank Russell serves on the town council and is fondly known as "Mr. Parksley."

"Our plan for the future is to keep on doing business as usual," Deborah Russell said. "Frank and I have seen a lot of small businesses come and go, but we have high hopes for the future."

Richard Lewis lives outside of Parks-

ley now, but he's from the town and is a big supporter. "I've always been a Parksley boy and I love Parksley," he said. His business, Associated Grain, is just outside the limits. "We are putting in additional grain space and a new grain bin," he said. Lewis is "starting up a small trucking company and hiring a couple more workers."

"The big thing is the improvements to the residential areas. Landlords and

homeowners are putting back Victorian homes," Lewis said. "The Lunch Box is open" again. He mentioned how wonderful the veterans memorial is. "The railway museum went through renovation last year. It is infectious when one person" makes improvements. He said the town is "enforcing ordinances and getting things cleaned up. The biggest thing is the library and the Heritage Center. That is going to be a game changer for Parksley."

The town is the only place on the Eastern Shore where residents can go and still have their gas pumped for them, choose between undertakers, use playground equipment, view a vast array of architecture, and climb aboard a rail car. County Supervisor Paul Muhly of Parksley is hoping to get the now-defunct Eastern Shore Railroad in Cape Charles to donate a locomotive to the railway museum.

Another new-to-the-scene-go-getter is Councilwoman Julie Nash. Described by Lewis as "a firecracker," Nash is a professor of psychology at the Eastern Shore Community College and a painter. She is opening an art gallery in the former drugstore/bank just in time for the town festival she is organizing, which is set for Saturday, Oct. 6. See story on Page 7.

Nash also formed a new art organi-

Strongman Contest Part of October Festival

The "Strongest Man on the Eastern Shore of Virginia" will be identified in October in a John Henry-like contest set to be held during the 30th anniversary festival of the Eastern Shore Railway Museum in Parksley.

The title will be given to the best steel-driving man tasked with hammering a stake into railroad ties near the museum.

"We're going to crown him the strongest man," said Julie Nash, a local businesswoman and member of the town council. Along with the title, the powerful guy will get a trophy, \$100, a golden spike, his picture in the Eastern Shore Post, and his photo posted in the town hall during his reign. "We want people to sign up as soon as possible," Nash said. Applications are available in the town office.

The festival will be held on Saturday, Oct. 6, from 10 a.m. to 6 p.m. There will be no charge for admission, and free popcorn, cotton candy, and snow cones will be distributed.

What do the local women get to do?

"They get to watch," Nash laughed, referring to the strong man competition. It should be great entertainment for all.

Hopkins would punish the children by locking them in their room or crib and withholding food. The defendant's mother was also aware of her locking them in their cribs. Wolff said Ness-Hopkins had promised not to do that again.

It was later realized the youngest child was seven months behind in getting vaccinations. Another child was diagnosed with reactive detachment disorder caused by severe neglect. A third child was diagnosed with post-traumatic stress disorder and another unspecified disorder. All visitation with Ness-Hopkins "was ceased" for the third child, the prosecutor said.

"The defendant found herself overwhelmed in the situation she was in," defense lawyer Tucker Watson said. "She was residing in a home that was dilapidated" and she had no income. She planned to move to Whitestone, Va. "When social services entered the house, they did observe boxes."

Watson said Ness-Hopkins' boyfriend died in May 2016. "It was a devastating point in her life. Depression and grief and the overwhelming nature of taking care of five small children triggered the neglect. She was suffering from depression and post-traumatic stress disorder from her own childhood ... she is heartbroken for many reasons. It saddens her that she and her children had to live in that situation ... the two young boys had experienced climbing out of the cribs ... and it is a well-documented risk."

Watson said there are numerous gadgets on the market that keep children from climbing out of their cribs. "The defendant obviously didn't have the money to buy those." He said his client locked them in the cribs when they were sleeping and she was doing the same.

"She would deny that she ever disciplined the children in a dangerous manner." There was "no evidence of abuse, no injuries. Only neglect. She had been attending doctors visits for all her children and there are records of that."

Lewis said he would consider a detention and retention program as requested by Watson.

Six Years for Embezzling

After being sentenced to six years in prison last Thursday in Accomack Circuit Court, Jennifer Brook Hill Stapleton left the courtroom in handcuffs and tears while a woman identified as her mother made threats and was also escorted away.

All but 40 days of the terms handed down for embezzling from the Kegotank Elementary School's PTA were suspended for Stapleton, 37, of Pond Road in Temperanceville. The outspoken former president of the group was taken across the street to Accomack Jail to serve her time.

Stapleton pleaded guilty to two charges and embezzling \$6,000. She didn't answer when Judge H. Thomas Padrick Jr. repeatedly asked her why she committed the crimes. Padrick sentenced her to three years each for each charge to run concurrently.

Meanwhile, her husband, Brandon Stapleton, continues to make posts on Facebook contending her innocence. "I want this community to know that the support for my family has been overwhelming but welcoming," he wrote. "Many of our close friends know the evidence I have can prove she couldn't have done what was accused. We made an unselfish decision months ago, in the interest of all families involved, to avoid a bench trial and minimal hassle for everyone, especially all the kids involved even if (it) meant we had to take a small hit. We've never been in a court or had a lawyer and that unselfish decision, obviously in retrospect, was the wrong decision ... we didn't know any better. We were never warned what happened today was even a possibility on the table."

Brandon Stapleton claims the case was fixed. "She had no answer because there was no answer," he wrote. "She stood on her morals through all the tears, and took responsibility but never admitted to stealing anything for any reason. That's what you're supposed to do as a Christian, especially in court, tell the truth. Jennifer could tell me to my face that she did what she is being accused of and I still wouldn't believe her. I've looked much too hard into every date, our accounts, and every possible angle to see it could not have happened. The doubt I had in her when I was doing that is something I'm ashamed of but it verified everything I should've never

doubted in the first place. I want this community to know that I tried two years ago, as soon as the first investigator showed up, and many times since, to make that PTA financially whole, every bit of it, without even looking into it. I figured, at that point, being fulfilled monetarily, the PTA board could hash out the cause for discrepancy and then address it. That would have avoided all this for everyone impacted. That request was denied by that PTA over and over. So it was never about the money, the PTA, or the KES kids. It was total animus. So I retained a lawyer. I still paid in full as soon as my lawyer allowed me to."

Brandon Stapleton later wrote to thank his friends for the hundreds of texts of concern. "We are doing well. Jennifer is able to call us at will, though it rips me up to watch those conversations between her and my daughters ... my family deeply appreciates the outpouring of support and willingness to do literally anything to help us through this. It is very humbling."

She could have been sentenced to 40 years in prison. Prior to the trial, she denied committing the crimes. Her lawyer, Thomas Northam, offered no evidence and she did not testify.

Commonwealth's Attorney Spencer Morgan gave a summary of the evidence when she entered her pleas. While he said the case was circumstantial, she was the only one who handled the money, guarded it from the other PTA officers, and was "resistant to assistance."

Court records show a debit card Stapleton used in connection with the PTA was used for gas, fast food, gymnastic training where her children took classes, and groceries including dog food and breakfast cereal.

In August 2015, money was embezzled from receipts collected at a bingo event held at the Parksley Volunteer Fire Department, the document stated. Witnesses would have testified at a contested trial that more than \$2,000 was collected at this event. But the bank deposit was for \$1,561.

There was also "embezzled money from receipts from an event where Krispy Kreme donuts were sold by the PTA in September of 2015," court records stated. "The treasurer's report for September 2015, bank deposit slips and the executive register from the 2015-16 school year all indicated that there was \$3,323 collected from the event. PTA and bank records also indicated that the cost of the sale was \$2,821.50. However, the summary of Kegotank PTA receipts through February 16, 2016, indicated \$4,624."

"The record should have reflected more than \$5,000," the court record said. "This is a projected figure that does not include the more than 70 dozens of glazed donuts comped to the PTA by Krispy Kreme."

The event "Fall Grams" held in October 2015 shows \$730 in receipts though actual bank deposits show only \$595, according to the documents. Stapleton was also accused of embezzling \$356 for a movie shown on two nights in November 2015. "Based on movie night rosters, the total amount collected should have been more than \$500. Each child was charged \$5 with a total of 104 students. There is no record of any deposits made for that event." Morgan said witnesses would also have testified Stapleton "had at times expressed financial pressure that she and her family were feeling" at that time.

In another case, Ali Rashawn Savage Jr., 23, of Savagetown Road in Belle Haven, was sentenced to three years in prison with all but seven months suspended for failing to register as a violent sex offender on March 31, 2017.

A graveside service was conducted at the Burger home on Wareham Farm on Aug. 1, 2018, with the Rev. C. Berkeley Ford officiating.

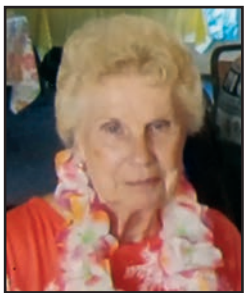

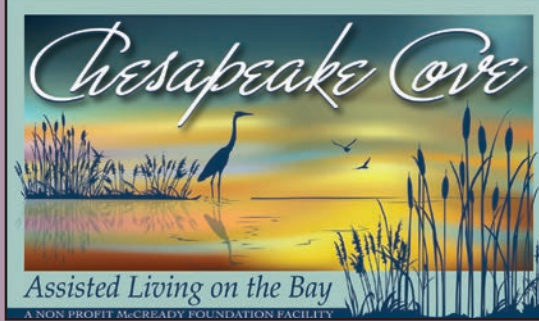

Northampton Has Room To Improve Resistance to Coastal Flooding

With an initial score of 61 out of 100 on the brand-new coastal resilience scorecard prepared by the Resilience Adaptation Feasibility Tool (RAFT) team, Northampton is at a moderate level of preparedness for flooding and other storm hazards with plenty of opportunity for improvement.

It took 18 months for the coastal resilience scorecard to be developed by the team of collaborators from Old Dominion University, the University of Virginia, and William & Mary Law School.

The RAFT team is dedicated “to help Virginia’s coastal localities improve resilience to flooding and other coastal storm hazards while remaining economically and socially viable.”

It was created in light of data suggesting Northampton’s flood risk is continually increasing. About 30 years ago, tides at Kiptopeke rose 1 foot above high tide less than 50 hours per year. A decade later, tides were staying 1 foot above high tide nearly 100 hours per year. At present, tides are rising to 1 foot above high tide between 200 and 250 hours per year.

The RAFT team scored Northampton in five categories of coastal resiliency, including county policies and leadership, risk assessment and emergency management, infrastructure, planning, and community health and well-being and engagement.

Each of 25 items within the five scoring categories was worth 4 points, with 100 total points possible. Northampton received a perfect score of 4/4 on five items: leadership and planning, hazard mitigation, critical transportation infrastructure, funding including state and federal assistance, and providing coastal resilience information to the public.

Northampton received a 0/4 on two items: water supply and wastewater management and participation in the Community Rating System. To correct these weaknesses, the RAFT team recommended the county update its water supply plan to address dangers posed by coastal hazards to drinking water and to participate in the Community Rating System.

The Federal Emergency Management Agency (FEMA) provides information on the Community Rating System, which rewards floodplain management activities with flood insurance

rate reductions up to 45 percent.

According to FEMA, floodplain management increases public safety, lessens human suffering, reduces damage to private property and public infrastructure, avoids economic losses, and protects the environment.

The RAFT team made additional recommendations for Northampton’s best opportunities to improve coastal resilience:

- The county should perform a flood exposure and vulnerability assessment including maps cataloging flood sources from rain and tide-driven events.
- Northampton should create a green infrastructure plan for using natural means of enhancing coastal resilience and identifying ecological assets that are vulnerable to coastal storm activity.
- The county should strive to exceed state requirements for stormwater management and provide incentives to the public to participate in stormwater management. Public demonstrations should be conducted on best practices homeowners can do such as creating rainwater gardens.
- Northampton should create programs for helping small businesses prepare for emergencies and manage their businesses while communicating directly with the county during emergencies.

Board of Supervisors Chairman Spencer Murray discussed the county’s need to strike a balance between coastal resilience and economic development. He decried the unfairness of Northampton being burdened with regulations while heavy development across the Chesapeake Bay seems to go unchecked.

“If I go across that bridge over there in Lynnhaven ... I can reach out and touch apartment buildings that are being built on the beach – on the beach!” Murray emphasized. “Where is the Department of Environmental Quality over there?”

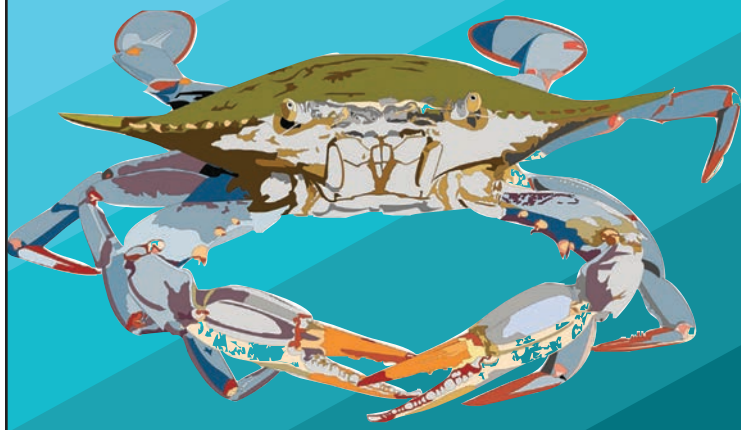
“We’re on the same page,” RAFT team member Tanya Cobb, of the University of Virginia, answered, and she said the team was willing to help Northampton in any way possible.

Last summer, the RAFT team conducted a coastal resilience workshop exclusively for the town of Cape Charles.

Citizens Propose Their Own Solution To Food Lion Intersection Near Cape Charles

Some Northampton citizens disagree with the Virginia Department of Transportation's plans to improve safety on Route 13 near Cape Charles as presented at a July 24 public hearing and have signed an informal document approving what former supervisor Granville Hogg terms the "citizens' proposal," a costlier solution involving the closing of a busy intersection and construction of a new public access road to the Food Lion shopping center.

VDOT's proposed safety improvements presented July 24 include widening and lengthening eight turn lanes, tapering roadway edges, and installing lighting and road signs along less than a half mile of Route 13 by the shopping center.

But citizens pointed out the plans proposed no changes to the dangerous intersection of Route 13 and south Country Place, which crosses the highway from Union Bank & Trust to McDonald's at the lower end of the shopping center.

Some suggested installing a traffic light at the intersection, but VDOT representatives said that could actually

make the intersection more dangerous.

Others mentioned converting the crossing into a J-turn intersection. It would allow drivers to exit the highway either right or left but would prevent a vehicle from driving straight across all four lanes of the heavily trafficked area.

Still others recommended closing the intersection. Hogg's proposal includes both closing the intersection and constructing a new access road to the shopping center allowing users to avoid the highway.

The access road would extend from north Country Place (next to Dollar General) and bear left onto Bayside Road, aka Business Route 13, leading to Cheriton. It would be about 1,000 feet long, or less than .2 miles. Alternatively, the access road could extend from north Country Place straight to Morris Court, which currently bears left onto Bayside Road. It would be about 1,200 feet long, or less than .25 miles.

The project would involve reconstructing a previously existing Route 13 connecting road on state-owned land.

The idea for the access road dates

back at least eight years. An April 19, 2010, letter from former County Administrator Katie Nunez to former VDOT Accomac Residency Administrator Bobby Isdell noted the receipt of "numerous comments about the safety and congestion" and the need to "examine other alternatives to access this high-volume shopping area and travel zone, particularly a secondary ingress/egress point that does not originate from Route 13."

VDOT previously estimated the project would cost \$4.5 million. In a July 31, 2017, letter to Virginia Secretary of Transportation Aubrey Layne Jr., written by Hogg when he was still a county supervisor, Hogg called the \$4.5 million

estimate "ludicrous" because it included about \$2.5 million in land acquisition costs that Hogg deemed unnecessary since "most of the land was owned by VDOT since 1950."

Cutting those costs could decrease the total project cost to \$2 million. Hogg proposed additional savings by using a material other than macadam to pave the road.

VDOT's proposed safety improvements, to be implemented under its Smart Scale program, will cost \$1.7 million.

VDOT representatives indicated none of its proposed improvements would be removed from the plan, but small additions could be made.

Clarification

A story in last week's edition of the Eastern Shore Post stated that closing the intersection of Route 13 and the Country Place entrance to the Food Lion shopping center near Cape Charles would mean southbound drivers traveling to Food Lion would have to continue several hundred feet and make a U-turn to reach

their destination.

This statement referred to drivers approaching the shopping center at its southern entrance, next to McDonald's.

Drivers traveling southbound on Route 13 will still be able to make left turns to the shopping center using the northern entrance, also named Country Place, next to Dollar General.

granted bond last week in Northampton Circuit Court.

Tavarus Jewel Stratton, 33, was released on a secured \$20,000 bond with the condition that he has no contact with the victim “directly or indirectly.” The bond was granted on July 23, by Judge W. Revell Lewis III.

Stratton was charged with rape by force or intimidation in connection with a Jan. 14, 2017, incident. A direct indictment was brought by the grand jury in May. He was arrested June 6, 2018.

In another case, Fred William Munford III, 23, of Lee Street in Belle Haven, was sentenced to five years in prison with all but a year suspended for possession of a gun by a nonviolent felon on April 15, 2017. He was put on supervised probation for three years.

Kendon Anthony Ruthven Ferguson, 29, of Virginia Beach, was convicted of child neglect in connection with an incident that occurred Nov. 26, 2018. A presentence report was ordered. Sentencing was scheduled in late October. Sheriff David Doughty said the inci-

dent occurred in the Eastville area. Investigator Terry Thomas of the Northampton County Sheriff’s Office handled the case. The trial is set for Sept. 17.

Shooting Charges Not Prosecuted

A young Mappsville man will not be prosecuted for shooting at an occupied vehicle last April and causing more than \$1,000 worth of damage, according to records filed this week in Accomack General District Court.

Jaylon Kellam, also known as Jaylon Harmon, 19, of Beartown Road, was charged with committing the April 22 offense thereby putting the life of the occupant in peril and destruction of property belonging to Tahah Berryville of Onancock. Both are felonies. It was unclear from the record why the decision not to prosecute the case was made. In some instances, charges are taken directly to the grand jury. That panel is scheduled to meet Aug. 6.

In another case, Latisha Annette Pepper, 32, of Linhaven Circle near Painter, was charged with possession of a firearm by a nonviolent felon on July 8. She was arrested July 27. A preliminary hearing was set for Sept. 10.

Tierro Laprix Williams, 32, of Federalburg, Md., was charged with a third offense in five years of driving while intoxicated. The incident occurred July 28. He was arrested for the felony offense on the same day and is being held in Accomack Jail.

Corey Smith, 30, of Starboard Road in Chesapeake, was charged with a third offense of driving on a revoked license, which is a felony. The incident occurred July 30.

Erik Castillo, 22, of Joynes Neck Road in Accomack, was charged with eluding police on July 17. He was arrested the next day. A preliminary hearing will be held later this month.

Charges Go to Grand Jury

Probable cause was found in Accomack Juvenile and Domestic Relations Court recently to certify charges against a Parksley man to a county grand jury

scheduled to meet Aug. 6.

Two counts of threatening to bomb, burn, or destroy a home and a count of unauthorized use of a vehicle were certified against Edwin Colon Matias, 32, of Dreamland Circle. The offenses occurred May 22.

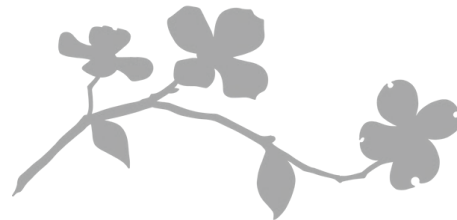
“Subject stated to multiple family members that he was going to burn down the trailers in which they resided,” Trooper A.J. Rohnke wrote in court records. “He made these statements to his mother and his brother, after his mother told him she wanted him to leave her property based on their testimony and statements.”

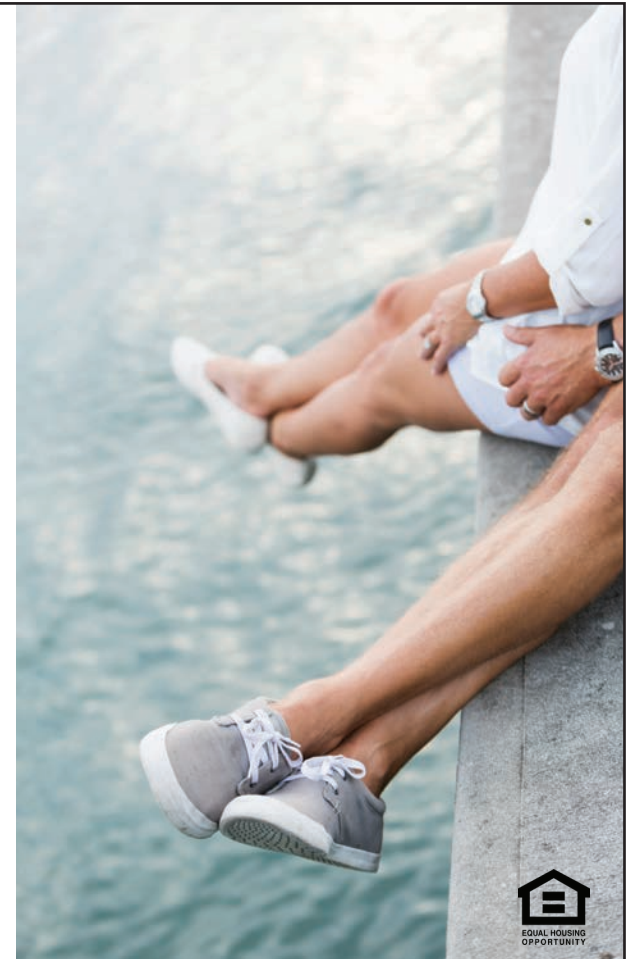

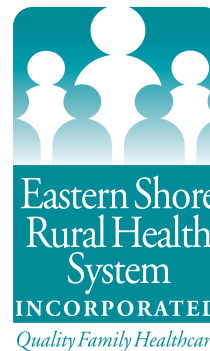

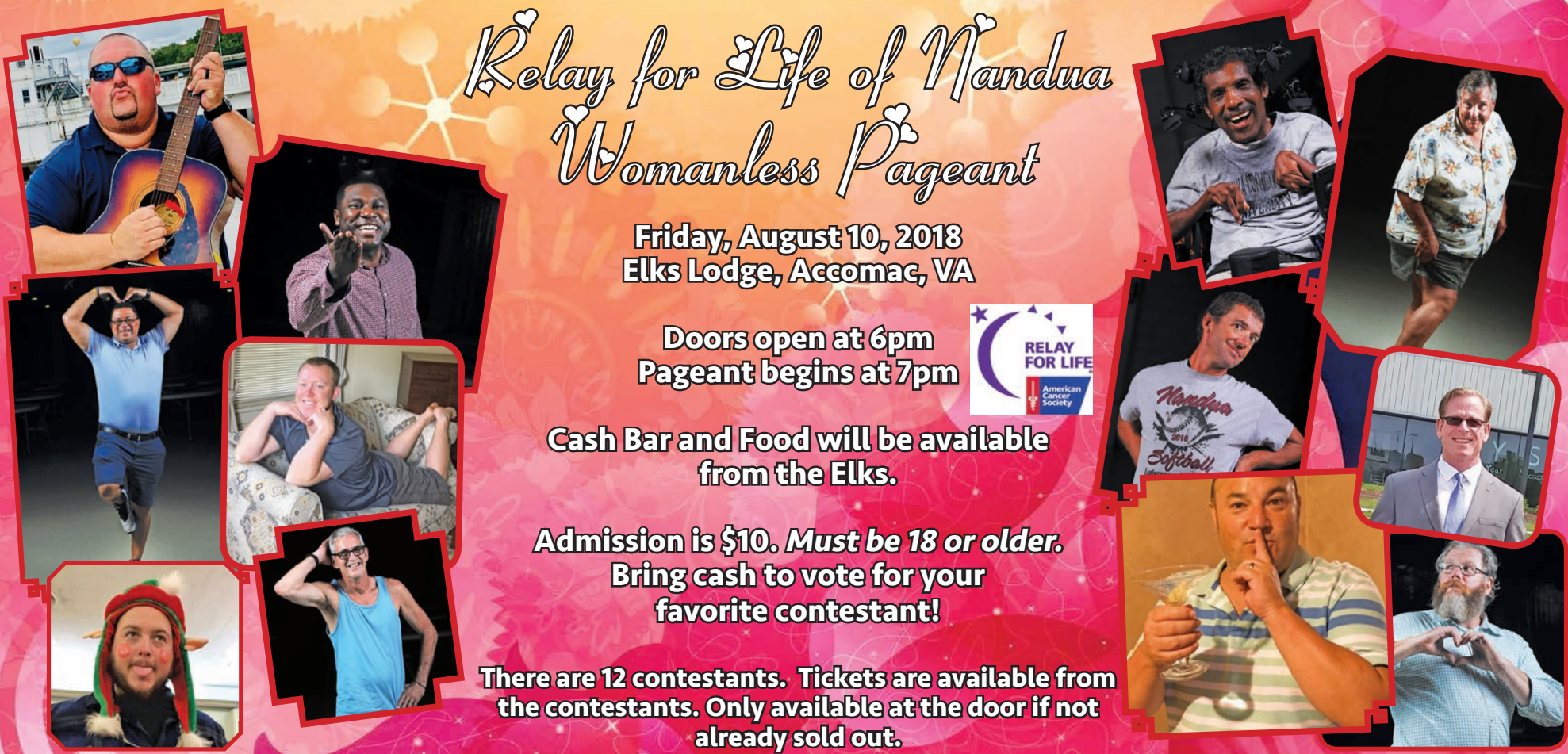

Fishing from the Shore

The Miss Molly was the big winner in last weekend's 2018 Eastern Shore Marlin Club Billfish Release Tournament. In addition to being the overall winner with two billfish releases, the vessel also took home awards for the first billfish release in the tournament, Top Boat-First Day, Top Boat-Third Day, and the largest dolphin (mahi), a 55-pound, 8-ounce bull! Second Place went to the vessel It's All Good with a billfish release. The Byte Me earned the largest tuna award with a yellowfin weighing 46 pounds, 8 ounces, and the Strike Zone took top wahoo honors with a 21-pounder.

Overall, most anglers I spoke with described the offshore fishing as slow, despite typically productive conditions such as ideal surface water temperatures, the presence of "pretty" water, and the abundance of sea life such as dolphin and whales.

Cobia, red drum, and flounder continue to provide action in the lower Chesapeake Bay, but the upper bay's action remains worrisome and slow with only a few spot, sand mullet, and a smattering of croakers in the deeper water and small stripers and bluefish in the shallows.

Lower Shore – Mark Snook, of Chris' Bait & Tackle, reported that there is still "decent" cobia action along Chesapeake Bay Bridge-Tunnel and up at Buoy 16. The shop had received a good report on flounder catches coming from along the bridge pilings. Catches of snapper blues were being made off Kiptopeke, where sea mullet were also reported. Sea mullet (whiting) catches were also being made over Lattimore Shoals. Large red drum releases were being made over the shoals during the late afternoons and evenings.

Jeb Brady, of Bailey's Bait & Tackle, said that the cobia bite was good last weekend with reports of a lot of 40-to 45-inch fish mixed in with a lots of "shorts." One local captain reported the sea mullet and spot fishing was good in the deep water off Buoy 36-A. The shop weighed in a 5-pound, 2-ounce flounder on Sunday, but overall, the flounder fishing was slow.

Wachapreague – The big fishing news out of Wachapreague was last weekend's Eastern Shore Marlin Club's Annual Billfish Release Tournament. As reported earlier, the crew of the Miss Molly cleaned up on the awards, releasing two of the event's three billfish and landing a monster mahi which should take the lead in the Virginia

Saltwater Fishing Tournament. Congratulations goes out to Jazmine Evans, who was awarded the Marlin Club's Bob Fate Service Award.

Captain Lindsay Paul, at Trident Tackle, also reported that a few flounder had been caught inside of the inlet, including some caught while jigging in the inlet.

Chincoteague – Donna Rae, at Captain Bob's Marina, reported that the weather has been playing havoc with the fishing. A few flounder were still being caught in Chincoteague Channel between Beebe Road and the American Legion Hall. Some kingfish/whiting were caught in the inlet, but croakers have been scarce. The only consistent action has been with sharks in the inlet and between buoy 10 and 2TL (Turner's Lump).

Jimmy Vasilou, of Captain Steve's Bait & Tackle, reported that the shop weighed in a citation 36-pound dolphin (mahi), caught aboard the Aquaholic. Captain John returned with limits of flounder and seabass from the offshore wrecks as well as a pair of yellowfin caught while chunking. Vasilou said that a few flounder had been caught inside Chincoteague Bay, while some croaker catches have come from off Memorial Park, buoy 10, and in Queen Sound. Spot catches have come from the surf, especially during the early mornings, and one angler landed a nice 1-pound, 3-ounce pompano from the beach. The shop is hosting a youth

croaker/flounder tournament through Aug. 15, with a portion of the proceeds being donated to the Chincoteague Elementary School.

Upper Shore – Captain Matt Abell, at the Sea Hawk Sports Center, reported that there are still a lot of small cobia in the lower bay with a few keepers mixed in. Inshore flounder fishing remained poor, primarily due to dirty water conditions from all the recent rain. A crew fishing with Kyle Krabill reported that flounder action on the rail cars was slow on Sunday, but they quickly limited out by 10:30 a.m. on some of the deeper wrecks. Tuna fishing has been slow locally, but reports of yellowfin coming on the chunk were received by vessels fishing out of Ocean City. A party with Captain Walt, of Light Tackle Charters out of Crisfield, landed some small rock and bluefish in the upper Pocomoke Sound.

Bill Hall was the first Eastern Shore resident to achieve Virginia Salt Water Master Angler Status. He has been named Virginia Saltwater Angler of the Year and Virginia Saltwater Release Angler of the Year. Bill is an I.G.F.A. International Committee Representative and a longtime member of the Virginia Saltwater Fishing Tournament Committee. He is the Virginia Recreation Fishing representative on the ASMFC Striped Bass Management Panel and is a past recipient of the CCA-VA Virginia Outdoor Writer Conservation Leadership Award.

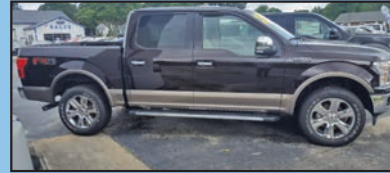

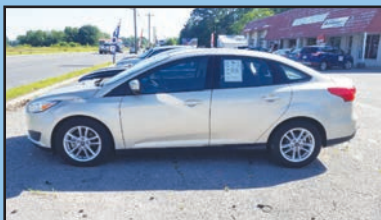

PONY AUCTION GALLOPS TO NEW RECORD

First, there were the sounds of delight. The "oohs" and "aahs." Those usual reactions people have when a cute little baby appears.

In this case, the crowd was fixed on Number 5, a little white pinto from the herd of famous Assateague ponies. She was about to be auctioned to the highest bidder during the 93rd Annual Chincoteague Fire Company's Pony Penning.

The filly was carried out to the auction yard by a hulking saltwater cowboy. The man's T-shirt identified him as a member of the Atlantic Fire Company, who had come to pitch in for the cause.

The foal favored the famous Misty of Chincoteague from the book by that name. Finally, the cowboy put her down and let her walk a bit, making the audience squeal some more. The bidding was fast and high. Little Misty seemed unimpressed with the commotion. Fire company spokesperson Denise Bowden, also a member of the town council, said the pony will stay on the islands until October when she will make her way to Washington State to her new home.

A Pennsylvania family bought the first pony to appear that day. This young filly, a chestnut foal, awed Julie Ecker of Cheswick, who stepped up with a smile to pay \$1,000. Trailing behind was Lyla, 2, and Eliza, 4. The girls had been "saving for a pony," according to their hot pink T-shirts.

Jennifer Merrill, of Cheyenne, Wyo., gladly paid \$1,900 for her brown colt with blaze. She showed off her bill of sale and heritage certificate when be-

ing photographed with her family.

Chincoteague Mayor Arthur Leonard held up a saddle and blanket that were auctioned to benefit the fire company. The mayor was wearing shorts, and spectators could see the tattoo of a pony that adorned his calf.

Fifty-three ponies were sold for a record-breaking \$228,400. On average the ponies went for \$4,309. The lowest winning bids were \$1,000. The highest was \$20,000. Other donated items, saddles and gear, brought another \$13,000.

In 2016, 57 ponies sold for an average of \$2,659 with the high bid being \$11,000 and the low bid being \$550. Sales that year totaled \$151,550.

The day wasn't without tragedy. A mare named "Butterfly Kisses" was being chased by a stallion and slipped in the mud, crashing into a fence and breaking her neck. She was euthanized and taken back to Assateague Island for burial.

Calling it "cruel," the People for the Ethical Treatment of Animals (PETA) called for the fire company to stop conducting its Pony Penning events. Bowden refuted the allegation on Facebook and defended both the practice and the company's care of animals. In turn, people overwhelmingly responded to Bowden in support.

"It disgusts me that the CVFD has to continuously defend itself against ignorant people who don't know the facts," wrote Mary Ester Raw Leonard. "We love our fire department and appreciate all the hard work and efforts you all give to this community as a whole!"

Wading, Saving, and Searching For a Chincoteague Pony

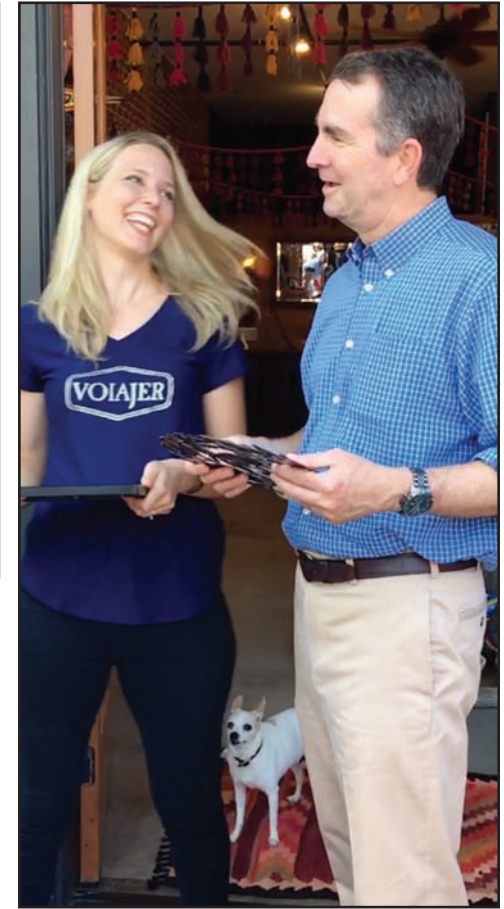

Gov. Northam Celebrates 14 New Businesses in Cape Charles

Eastern Shore native, Gov. Ralph Northam, jumped on the Cape Charles bandwagon – or rather, the golf cart tour – on July 27 when he performed ribbon cuttings at 14 new businesses that have opened in town within the past year.

Northam said, “We’re a little bit biased, being from the Eastern Shore, but this is truly God’s country, and it is so great to see Cape Charles and the Eastern Shore are thriving.”

About \$80 million was spent in Northampton County in 2016, Northam said.

But “all this did not happen overnight,” Cape Charles Mayor Smitty Dize said. “Over the past 20 years” there were “a lot of people investing in the vision of Cape Charles,” which he called “a pretty beautiful thing.”

Dize reflected on the town’s early days during its original boom. It was a railroad town and a link for steamships, and later, ferries, crossing the Chesapeake Bay.

Cape Charles declined, or as Dize put it, “putted along,” after the Chesapeake Bay Bridge-Tunnel opened in 1964.

Beginning in the late 1990s, Dize said, “many took a huge risk, invested time, energy, and resources in our town.” He mentioned several older Mason Avenue businesses that paved the way for Cape Charles’ recent economic developments.

During the recession that hit in 2008, Cape Charles “held ground,” and it was in 2012 that the town “took it to the next level.”

On the 14 ribbon cuttings performed, Northam, a pediatric neurologist, joked, “I haven’t cut that many things since I’ve been in the operating room.”

Blood Drive at Riverside Shore Memorial Hospital

Blood donation requirements include a minimum weight of 110 pounds and minimum age of 17. A 16-year-old may donate blood with written parental consent. There is no upper age limit for donating blood.

Many health conditions and medications do not prevent someone from donating blood. People taking insulin, blood pressure, thyroid, and cholesterol medications, aspirin, antidepressants, and hormone replacement can give blood.

Donors are encouraged to eat a meal prior to giving blood and drink plenty of water.

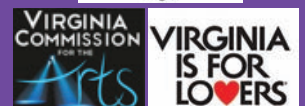

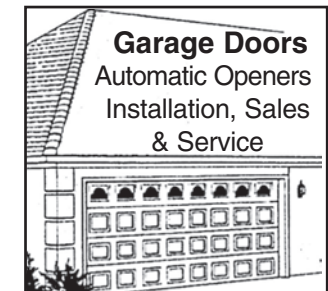

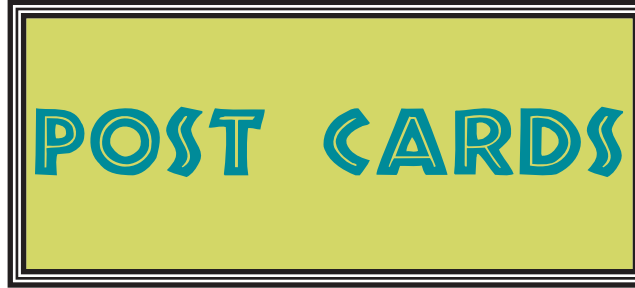
