## COUNCIL URGES CITIZENS TO COMMENT ON BEACH PLAN

Chincoteague officials say plans for a new public beach and parking at Assateague could compromise the economy of the town, make access cumbersome, and cause erosion that would eventually adversely affect Chincoteague.

At Tuesday's town council meeting they urged residents and other concerned citizens to submit their thoughts by the Sept. 13 deadline. Comments may be submitted via email to NorthChincoteagueBeach@dot.gov or by regular mail to Chincoteague National Wildlife Refuge, Attention: North Chincoteague Beach, P. O. Box 62, Chincoteague, VA 23336.

The beach is slated to move 1.5 miles north and was identified in the Final Comprehensive Conservation Plan and Environmental Impact Statement (CCP/EIS) for Chincoteague and Wallops Island national wildlife refuges and approved in November 2015.

"People have grown weary of public comment it has taken so long," islander Donna Leonard told the council. It was once reported the refuge's Beach Road would be removed when the new beach is established, she said. "I don't see any ... plans to demolish that road." But to ensure it, she asked people to write in.

"I've already sent in my comment," said Councilwoman Denise Bowden. "I don't think what they have come up with is beneficial to our visitors ... or residents. On a high tide, you might have a little beach. This is not going to give us the beach access we have enjoyed for 50 years," she continued. "I get it that we go through storms. The amount of money that they are talking about (to build the new facilities) for 18 to 20 years would get us what we need right now. There's got to be a better way than what they have pushed on us right here."

"You already have to jump in your car and drive over," said Councilman Matthew Reed. It makes it "even more difficult with kids to have to walk that far," he said of the distance from the proposed parking to the beach. "If they want to spend the money, (the federal government) should put jetties in." The current beach, "That's our lifesaver for the southern end of Chincoteague," he continued. "They are going to let it run its course. We've got to fight them tooth and nail. I would say write them a letter," Reed said.

Mayor Arthur Leonard reminded the others that the initial proposal was aimed at eliminating parking and using a shuttle

bus. "Luckily, the public was heard and the shuttle idea was done away with," he said. "I've been to all the meetings. No shuttle service is proposed." He agreed that the southern area must be protected from wash over.

Historically, walking a distance was the way to enjoy the beach, the mayor continued. "When they used the beach in the 20s and 30s, they would walk from the Coast Guard station to the ocean. Unfortunately, we've been spoiled. I daresay we have the easiest public access to the beach on the East Coast. How far do you walk on the hot sand in Ocean City?" He rhetorically asked. "We're kind of spoiled. You also pay the piper when Mother Nature rages. It's hard to make plans to maintain something when you're that close to the water. It may be convenient but when it's gone. It's gone," he said describing North Carolina.

"You get nothing done when you fight," the mayor continued. "It's not good ... instead of fighting with the federal government, we need to work with the federal government. In the end, it's theirs." Still, he urged people to make comments. "They hear them all. If you don't plan for something, you're planning for disaster."

"With all due respect, I have to disagree with you," Bowden said. "You have to fight ... I never felt the Town of Chincoteague (residents) were a group of people that just roll over ... I think even though we may not win the war, I think there are some battles that need to be fought."

In other business, council voted unanimously to allow installation of digital signs at both Chincoteague schools. The school division requested the change so cancellations and other school and town announcements could be easily made. The signs have already been erected at Accomack County's other nine schools.

Planning Commission Chairman Ray Rosenberger noted the change could be considered spot zoning.

"As long as it is announcing a town or school function," the mayor said, it should be allowable.

"We're part of the county," said Bowden. "Our schools are part of the county. I think it would be unwise if we didn't allow this for our schools. ... I don't see how we can be wrong with that."

In July, the owner of a derelict house on Cleveland Street was given another 60 days to take action to fix the structure. He did not take action so the council unanimously voted to demolish it.

# Tourism Director at Center of Poultry Conflict To Retire Jan. 1

Kerry Allison, executive director of the Eastern Shore of Virginia Tourism Commission, who was criticized last month by the Accomack Board of Supervisors for her suggestion to “Outlaw Industrial Chicken Farming,” is retiring effective Jan. 1.

The decision was announced in a letter she emailed Tuesday to the Eastern Shore Post. It was signed by the commission’s chairman, Steven Potts, and addressed to Eastern Shore of Virginia tourism partners. It was sent to the newspaper via Allison’s email address.

“This impending vacancy and the development of a plan of action to fulfill this position” is scheduled to be discussed at the commission’s next meeting on Sept. 26, Potts wrote.

Allison’s suggestion regarding the poultry industry was among opinions received from a survey conducted by the Accomack-Northampton Planning District Commission and posted on the wall at an economic summit the agen-

cy hosted in July. The meeting was attended by Gov. Ralph Northam and other state leaders.

Last month, Accomack supervisors said the poultry industry is vital to Accomack. The leaders were unhappy the commission did not act to reprimand Allison and discussed the possibility of giving funds to the local chambers of commerce instead of the tourism commission. About \$86,500 was provided to the commission by Accomack County in the current budget.

Supervisor Grayson Chesser was the most incensed and continued to be so when reached for comment Tuesday. “She wants to stay and help get her replacement straight,” he said of Allison regarding her retirement. “I’ve still not heard an apology for what she wrote. I would have thought that would have been the place to start. But that is up to her. She doesn’t need to apologize to me, she needs to say she is sorry to all the citizens on the Eastern Shore who work in the poultry industry.”

Chairman Robert Crockett of the Accomack supervisors was also appalled. “Poultry is our anchor tenant,” he said at the session in August. “That would be devastating for us.” He feared the issue would be harmful. “Now back in Richmond, you know they are talking about this,” he said.

Crockett made the motion for county staff to explore a new approach of promoting tourism in Accomack by teaming up with local chambers “and to assist Chincoteague for the first time.”

Tuesday, Crockett declined to comment about Allison’s retirement. “But I will say, the county administrator will continue to explore options for promoting tourism on the Eastern Shore of Virginia,”

Potts wrote, “Under the guidance and expertise of Ms. Allison, the tourism industry on Virginia’s Eastern Shore has continued to grow and thrive, and was recognized as the fastest-growing tourism region during two of her four years in this position. Kerry leveraged her skill set to

help launch our regional industry into the digital age through the development of rich content and a strong digital platform from which to market the many assets of Virginia’s Eastern Shore, including a new website scheduled to launch in October.”

“The annual tourism summits continue to unite our partners and provide opportunities for the exchange of ideas with and among our tourism entrepreneurs and to meet the needs of growing markets,” Potts wrote. “Kerry has strengthened the Tourism Commission’s staff, bringing in a higher level of efficiency to keep our region on top of the growing market trends. During her tenure, the southern gateway welcome center has welcomed close to 500,000 visitors to this region and its travel ambassadors have guided those visitors off Route 13 and into many communities and businesses throughout the Eastern Shore. Please join the commission as we wish Kerry all the best in her future endeavors.”

# WITH SCHOOL EXPENDITURE ON HORIZON, NORTHAMPTON SUPERVISORS WEIGHING EXPENSES

Since Northampton supervisors made the commitment earlier this summer either to renovate or rebuild Northampton High School, which will cost millions of dollars no matter what option county and public school officials agree upon, supervisors have been keeping an extra close eye on every dollar of taxpayer money being spent.

When Finance Director John Chandler requested a budget amendment of \$20,500 on Aug. 14, he billed it as “good news” because the amount of the request had been reduced from \$27,500.

The funds were requested to help pay for a brand-new emergency response vehicle valued at about \$60,000, which would replace a 2007 Dodge Durango that has been driven more than 170,000 miles. Supervisor David Fauber said the county was getting a “good deal” and Supervisor John Coker concurred.

But not every supervisor agreed. Supervisor Robert Duer took issue with the fact that only \$12,000 had been set aside for the vehicle in the budget approved shortly

before fiscal year 2019 began July 1.

The county had applied for funds to help pay for the vehicle, expecting to receive an 80/20 grant, meaning the county would pay 20 percent of the vehicle’s cost. A 50/50 grant was received, therefore Chandler requested the additional \$20,500 needed to bring the county’s contribution to 50 percent of the vehicle’s cost, or \$32,500.

Based on the assumption that the county already has three such vehicles, Duer questioned whether the replacement quick response vehicle was needed and asked, “How many staff at either time need a quick response vehicle?” and “Is there a cheaper vehicle than \$60,000 because we’re spending someone else’s money.”

The grant received “might have been 80/20 on a \$45,000 vehicle, but guess what? We buy a \$60,000 one, it’s all of a sudden 50/50,” he said.

Duer also wanted to know if construction of the new EMS garage in Machipongo was staying on budget. “We’re spending money like it’s water.”

County Administrator Charlie Kolakowski relayed the information from Director of Public Works Chris Thomas, who is overseeing the project, that it is on budget.

But Duer was not satisfied. “We’ve got to stop bleeding (money). We’ve got a school to build, we’ve got everything else to build, we keep right on spending. Just spend, spend, spend. No!” he said to the funding request.

The budget amendment passed 3-2, with Duer and Supervisor Oliver Bennett dissenting.

The spending issue resurfaced on Aug. 27 when Chandler presented supervisors with an inventory of all county-owned vehicles, including ambulances and police cruisers, and other items such as trailers and construction equipment.

Duer questioned why supervisors had not been made aware that the county purchased brand-new equipment including a boom lift (cherry picker), a scissor lift, and a mini excavator.

Deputy to the County Administrator Janice Williams explained that as

long as the cost of each item was less than \$30,000, the purchases did not require supervisors’ approval.

“We sit here and OK \$25,000 cars,” Duer countered. He recalled approving the new snow blower listed, which only cost about \$1,500.

Duer, who is also Exmore’s town manager, said, “I’m spending someone else’s money, I don’t fly under the radar like that, I’m sorry.”

Bennett, a Northampton teacher and member of the high school revitalization committee, commented, “As we look at going ahead in good faith using citizens’ money to build, remodel, whatever we do, we may want to look now at being a little more reasonable” about the county’s practices purchasing new vehicles and equipment.

“We’re looking to spend some large amounts of money, and some of that money could possibly come from better spending,” he said.

Chandler agreed to get supervisors information on the costs and uses of the two lifts and mini excavator as Duer requested.

# Northampton To Conduct Formal Structural Review of High School

The first month of work by Northampton's High School Revitalization Committee has culminated in a request for proposals (RFP) from professional architectural and engineering firms to conduct a formal structural investigation at Northampton High School.

Speight, Marshall & Francis, the structural engineering firm that inspects the building annually, previously determined the poor condition of the original 1954 structure, but the new RFP will allow the opportunity for county supervisors to get a second opinion.

The firm chosen will be tasked with examining every structure on the school grounds, a range that includes the 1954 building and 1978 addition to the bleachers and athletic field building.

All issues identified will be grouped into categories such as immediate safety risks, potential future safety risks, and maintenance and operational efficiency needs.

Within each category, each issue will be ranked by priority. Projects will also be ranked by cost.

The committee members agreed that student safety is their No. 1 concern.

At the Sept. 5 meeting, the school division was represented by Superintendent Eddie Lawrence, Chief Financial Officer Brook Thomas, School Board Chairman William Oakley, and school board members Paul Bibbins and Maxine Rasmussen.

Northampton county officials present were County Administrator Charlie Kolakowski, Director of Finance John Chandler, and supervisors Oliver Bennett and John Coker.

The RFP will be advertised locally from Sept. 7 to Sept. 17, and proposals will be due Oct. 29. Interviews will be conducted on Nov. 27 and Nov. 28, and the selected applicant will be notified Dec. 12.

The next committee meeting is at the high school on Wednesday, Sept. 12, at 4 p.m., when Northamp-

ton Schools Director of Operations Chris Truckner will conduct a walk-through of the building and grounds. The overview of known structural issues at the high school will help committee members prepare questions for the architectural engineer.

The committee has yet to decide how much money will be spent on the high school revitalization project.

The county received the third round of funding scenarios from Davenport & Company in mid-August.

The first of three scenarios determined how much additional debt the county could take on while maintaining its current debt service, or the amount it pays annually on its debt, \$3.1 million. By taking on new debt only as old debt is paid off, the county could borrow about \$42 million.

The second scenario calculated the amount of new debt Northampton could take on by raising its tax rate 2 cents and increasing its annual debt service to \$3.4 million. It could borrow about \$47 million.

The third scenario determined

that if the county raised its tax rate 4 cents, it could increase its annual debt service to \$3.8 million and borrow nearly \$52 million.

In all three scenarios, additional debts issued would be paid over 20-year periods, with payments on principal and interest beginning in the years the debts are issued.

The committee also has not yet discussed factors in the cost of a new or renovated school such as the number of students it will serve or the square footage needed per student.

It is currently considering four options for the high school revitalization project: renovate the existing building and continue its use as a combined middle and high school, renovate the high school and renovate and re-open the old middle school in Machipongo, renovate the existing building and construct an addition to create a high school and middle school complex at the current location, or construct an all-new high school and middle school complex at the current location or a new location.

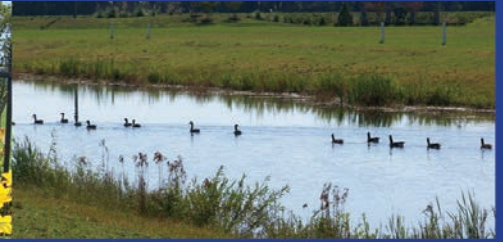

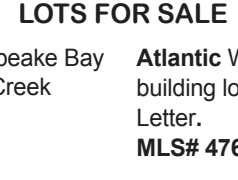

### Farm Worker Threatens Another With Homemade Spear

A native of Cuba, who had been working on an Eastern Shore farm for the last two months, was accused last weekend of threatening to injure another laborer with a makeshift spear, according to court records.

Omar Roman, 53, of 7th Avenue in Miami, Fla., is being held in Accomack Jail without bond.

He was charged with attempting to rob Miguel Morale on Aug. 31, "By means of violence, assault, putting the victim in fear of serious bodily harm, threats or by presenting a firearm or other deadly weapon."

Roman was also charged with the misdemeanor being intoxicated in public. A preliminary hearing was set for Sept. 19. Sgt. Bobby Taylor of the Accomack County Sheriff's Office (ACSO) investigated.

Taylor wrote on a criminal complaint that he and "Deputy Sharp were dispatched to the intersection of Coardtown Road and Chincoteague Road" in reference to a fight. When the officers arrived, Morale said Roman "tried to rob him for his beer and money." Morale also said, "Roman had a blue stick with a large knife tied to the end of it."

The victim said he went to Ray's Shanty, a local restaurant, for help. "Roman chased him with the knife yelling, 'Give me your beer or money, I kill you!'" Roman "had a strong odor of alcohol on his breath, his speech was slurred and his eyes were watery, blood-shot and glassy."

An application for bond stated Roman told authorities that he has a mental health diagnosis and health issues. The suspect was "argumentative" with an officer.

In another case, Joseph Samuel Davila, 30, with addresses on Trailer Circle and Cobb Station, in Cape Charles, was charged with strangling and injuring Margarita Cruz-Morales. Deputy N. Kugler of ACSO investigated. Davila is being held without bail. The incident occurred Aug. 28.

### Two Charged With Felonies in Northampton

Two men were charged with felonies in the last week in Northampton, according to records filed in the county general district court.

Kenneth Jackson Bowen Jr., of Exmore, was charged with a third offense of petty larceny, which is a felony, in connection with an Aug. 31 crime. Chief A. P. DiMartino of the Exmore Police Department investigated. A preliminary hearing was set for October.

Lorenzo Jermelle Stith Jr., of Cape Charles, was accused of providing false information on a consent form on March 16, 2017. He was arrested Aug. 30.

Both men are being held in the Eastern Shore Regional Jail in Eastville.

### Exmore Man Pleads Guilty To Drug Charges

An Exmore man pleaded guilty Tuesday in Northampton Circuit Court to selling cocaine and possessing a gun while selling the drug.

Joseph Didier West, 29, of Belle Haven Road in Exmore, was convicted of both charges. West is being held in the Eastern Shore Regional Jail pending sentencing. The incidents occurred July 2, 2017.

Counts of carrying a concealed weapon and possession with intent to distribute between a half-ounce and five pounds of marijuana were not prosecuted.

In another case, Antwine Tazewell, 37, of Cheriton, was sentenced to seven years in prison with 5.5 years suspended for possession with intent to distribute cocaine in October 2016. He was arrested in July 2017. Tazewell was ordered to be on probation for three years. His driver's license was suspended for six months.

# Accomack School Board Debates Behavior Intervention Program for High Schools

A presentation on Accomack schools' success implementing Positive Behavioral Interventions and Supports (PBIS) in its elementary and middle schools escalated into a debate over whether the school division should continue with plans to implement the program at the high school level.

Coordinator of Student Services Chester Hall informed the audience at Tuesday night's school board meeting that according to Virginia code, "positive behavioral interventions, strategies, and supports" must be considered when children's behavior impedes learning.

PBIS is not a pre-packaged program but a framework used to customize behavioral interventions for each school based on its individual needs, Hall said.

It is part of the Virginia Tiered Systems of Supports (VTSS), providing behavioral support at multiple levels. Tier 1 interventions are effective for 80 percent of students. Tier 2 interventions target the next 15 percent of children and include the "check in, check out" method of student behavior self-monitoring and peer mentoring. Tier

3 interventions reach the remaining 5 percent of students.

"It's not stickers and lollipops," Hall said.

PBIS programs are monitored by three software systems and five teams of coaches at the state, division, and school levels.

Forty-seven states, plus Washington, D.C., use PBIS. In Virginia, 41 percent of schools participate.

Nationwide, schools using PBIS experienced a 33 percent reduction of both referrals and out-of-school suspensions last year.

(A referral is a form filled out by a teacher and sent to an administrator reporting student misconduct and referring the student for disciplinary action such as in-school or out-of-school suspension.)

Metompkin Elementary Principal Belinda Rippon reported the number of referrals given at the school dropped from 482 during the 2016-2017 school year to 311 during the 2017-2018 school year, a 35 percent decrease.

Pungoteague Elementary Principal Brian Patterson reported similar results. Between the 2016-2017 and 2017-

2018 school years, the number of referrals dropped from 389 to 250, a 36 percent decrease. The number of out-of-school suspensions was reduced by more than half, from 96 to 42.

Accawmacke Elementary Principal Javan Thompson demonstrated the unique way his school implements PBIS: Each student receives a "membership card" that is hole-punched every time the student is observed exhibiting a positive behavior. As students collect hole punches, they work their way up to silver, gold, or platinum membership status.

Arcadia Middle School Principal Brian Tupper also attested to the effectiveness of PBIS. The school's positive behavior intervention program is represented by the acronym PRIDE: personal responsibility, respect, integrity, determination, and excellence. It was built on the school's motto, Panther Pride Runs Deep.

"If a child can't read, we teach them how to read. If a child can't add and subtract, we teach them how to add and subtract. But if a child can't behave, our typical response is to punish. Many of these children don't know how to behave in the public school setting, and so we need to take the time to teach them how to behave," Rippon concluded.

But school board member George Waldenmaier cautioned his peers that, in his experience, positive behavior interventions are ineffective with high school students.

"A six-year-old is a very different kind of person than a 16-year-old, and an out-of-control six-year-old is a very different thing from an out-of-control 16-year-old," he said.

High school students tend to "game the system," which "stops any discipline from advancing any farther" and leads to "poor faculty morale," Waldenmaier added.

He cited Nandua High School as evidence of his point. After the school abandoned a previous effort to implement PBIS and instead adopted a code of conduct, it won a VTSS award for the highest reduction of referrals in the state, he said.

Waldenmaier recommended reducing the number of referrals by providing intense professional development for the teachers who write the majority of referrals.

He was against "lowering write-ups by preventing people from writing up" due to complicated disciplinary procedures or "pressure coming from the top on building principals: 'You best not be suspending anybody because we're watching you.'"

Superintendent Chris Holland responded, "Be very aware of what I'm saying. ... We're going to still suspend children if they're disrupting, if they're disrespecting my teachers, my administrators. They're going to go home. ... The high schools need to understand that some stuff we will not tolerate, and that's what it's going to be because I'm going to give the directive."

Waldenmaier said principals should have the choice to "opt in or out" of PBIS.

School Board Chairman Ronnie Holden answered, "A principal is a part of a team, and that principal has got to be a team player, or else we need another principal."

Waldenmaier did approve of one aspect of PBIS: "Working on school culture pays giant dividends" and leads to "happy teachers ... less bullying ... higher achievement and ... few discipline problems."

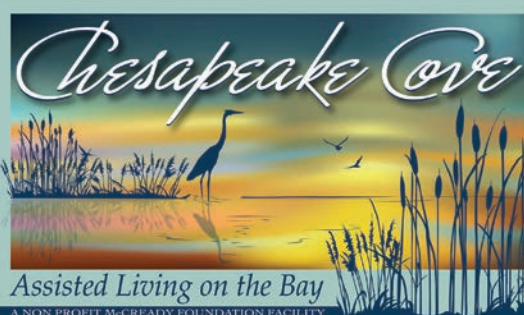

Accomack schools officially announced the accreditation ratings of its 11 schools on Tuesday. All schools earned the rating of “accredited” except one, Metompkin Elementary, which earned “accredited with conditions.”

Director of Accountability and Curriculum Sandy Drummond shared Accomack’s SOL (standards of learning) passing rates as calculated at the state level, used to determine school accreditation ratings. They appear in the accompanying table.

The data published in the Aug. 21 edition of the Eastern Shore Post was accurate according to federal calculation methods but does not reflect on school accreditation ratings.

The 2018-2019 school year marks the first year the Every Student Succeeds Act, which replaces No Child Left Behind, is fully implemented in schools across the country.

It is also the first year in which the Virginia Department of Education has implemented changes in the accreditation rating system. Previously, there were 12 accreditation ratings, includ-

ing “fully accredited,” the highest rating, “partially accredited,” and “accreditation denied.”

The accreditation rating system has been simplified to three ratings. “Fully accredited” has been shortened to simply, “accredited.” The other two possible ratings are “accredited with conditions” and “accreditation denied.”

Accreditation ratings are determined based on six or eight school-quality indicators, depending on whether the school has a graduating class. The six universal indicators are: overall school performance in English, overall school performance in math, overall school performance in science, English performance by gap groups, math performance by gap groups, and attendance.

(There are seven gap groups: English learners, students with disabilities, economically disadvantaged students, Asian students, Hispanic students, black students, and white students.)

A high school, or any school with a graduating class, is also judged on school quality by two additional indicators, the graduation and completion index and

the dropout rate.

School achievement within each quality indicator is ranked from Level 1 to 3, with Level 1 as the highest and Level 3 as the lowest.

A school must reach Level 1 or 2 in every quality indicator to be accredited. A school at Level 3 in one or more quality indicators is accredited with conditions. Schools that fail to adopt and implement required corrective action plans are rated accreditation denied.

The required passing rates are 75 percent in English and 70 percent in math and science. The history SOL is no longer required and is not included in the table.

The scores of students who do not pass but show significant improvement contribute to their school’s achievement levels.

Metompkin Elementary did not attain accreditation because of Level 3 performance in two English gap groups. It also was not “grandfathered in” by achieving accreditation in the previous three years.

However, Metompkin made “tremendous” growth, particularly with a 20 percent increase in science performance, Drummond said.

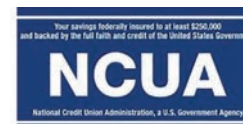

# NASA Asks Feds To Pay for New Wells

NASA requested \$11 million in federal monies to reimburse Chincoteague for new wells for town drinking water, Town Manager Jim West said Tuesday during a town council meeting.

"Language to allow reimbursement has been submitted to Congressman (Scott) Taylor by NASA to allow them

to use their appropriations to reimburse the town for new wells and the purchase of property," he said was learned last week.

Last year, the town's wells, which are at the NASA Wallops Flight Facility property on Wallops Island, were contaminated from firefighting foam used at a fire training area.

Use of those wells was discontinued and safe drinking water has been available from other wells there.

Meanwhile, Chincoteague officials are moving forward with establishing new wells for a more permanent solution. Town leaders recently spent

\$300,000 for 30 acres on the mainland so wells could be drilled there for drinking water. Testing at the new site showed no PFAS, no arsenic, and no other contaminants. The water now being used from NASA also passed all testing.

# Fishing from the Shore

Look for an upcoming transition from the summer to the autumn fishery, but enjoy the next couple of weeks of cobia and Spanish mackerel fishing while it lasts. We have already seen a decline in the number of larger-sized spadefish for the season. As the traditional summertime species begin to depart, look for an increase in the numbers of speckled trout and puppy drum, as well as some large yellow-bellied spot.

**Lower Shore** – Jeb Brady, of Bailey's Bait & Tackle, reported that the Spanish mackerel bite was still "really good." The shop weighed in two citation Spanish over the weekend, the largest weighing over five pounds. The larger fish were caught on trolled spoons. Big red drum continue to hit in the evenings for anglers soaking cut baits. Reports of nice-sized croakers have come in from the Cabbage Patch, while the waters off Cherrystone Creek are producing catches of spot.

Mark Snook, of Chris' Bait & Tackle, reported that the Kiptopeke State Park Pier was producing catches of spot and blowtoads, as well as its share of crabs. Sight casters in the lower bay were still finding cobia travelling with rays and sea turtles. Small spadefish were around Plantation Light as well as portions of the bridge. Red drum were still being released over the shoals along Fisherman's Island and off the 12-mile marker. Spanish mackerel, as well as 14- 18-inch bluefish, were being caught by trolling from the Chesapeake Bay Bridge-Tunnel north into the bay. Snook said that the Spanish size trend has been that a smaller class of fish were to the south, from buoy 18 to the CBBT, while the larger fish seem to be concentrated from the waters off Cape Charles and north. Snook has heard rumors of speckled trout and puppy drum catches from the Magothy Bay area.

**Chincoteague** – Donna Rae, at Captain Bob's Marina, reports that flounder up to 4 pounds have been pulled out of the southern reaches of Chincoteague Channel, with some of the best action oc-

curing out in front of the marina. Pink has been the hot color of late for flounder. Good kingfish/whiting fishing has come from the waters near buoys 13 and 14, with the best action occurring on live bloodworms, bloodworm scented squid strips, and bloodworm-scented Fish Bites. Croaker action has slowed over the weekend, but anglers were still finding a few pompano near the inlet. Action in Assateague Channel has been almost nonexistent over the last week. Both sides of Queen Sound Bridge, as well as Cockle Creek, are holding sharks.

Depending on your feelings, this can be a nuisance, unless you are targeting the toothy critters. Almost of the sharks are either too small or illegal to possess, so snapping a quick picture while they are boatside (in the water) and releasing them is the safe way to go. Shark action is still occurring from just outside of the inlet out to Turner's Lump. Rae claims that the flounder action on the structures on Blackfish Banks is still strong up to 26 inches in length. Triggerfish still remain above the structure. Offshore, a wahoo, a few cobia and some mahi have come from the Big Finger. Yellowfin tuna are still out at the Washington Canyon.

Jimmy Vasilou, at Captain Steve's Bait & Tackle, reported that Captain John, aboard the Huntress, had a big trip offshore, bringing back a nice mixed catch of mahi, tilefish, flounder, and seabass. The shop weighed in a 45-pound citation wahoo over the weekend. The crew also had a nice catch of dolphin. Vasilou said that triggerfish, spadefish, and a sheepshead was caught on the Little Wreck.

**Wachapreague** – Captain Lindsay Paul, of Trident Tackle, reported that there had been some dolphin action in 20 fathoms as well as a few dolphin and some false albacore a little closer inside over the Hills. The flounder bite on the wrecks has come to a halt, which is typical for this time of year. Paul expects action to resume hot and heavy in a few

weeks. Spadefish and a few triggerfish over the wrecks at #10. Inside the inlet, catches consisted of croaker and few spot. The shop did weigh in some citations over the weekend for tilefish up to 12 pounds, 12 ounces, as well as a 12-pound, 10-ounce sheepshead, which was caught on the bayside.

**Upper Shore** – Captain Matt Abell of the Sea Hawk Sports Center reported that the Parking Lot has produced catches of dolphin. Closer inshore, the flounder fishing over the wrecks has slowed, with just a couple of keepers reported. Abell said that the numbers of big red drum had slowed a little in the southern bay, but the shop did weigh a big cobia caught off Nassawadox Creek. Farther up the bay, Matt said that small (undersized) speckled trout were "everywhere." The

northern portion of Tangier Sound was producing plenty of rockfish, but few of keeper size.

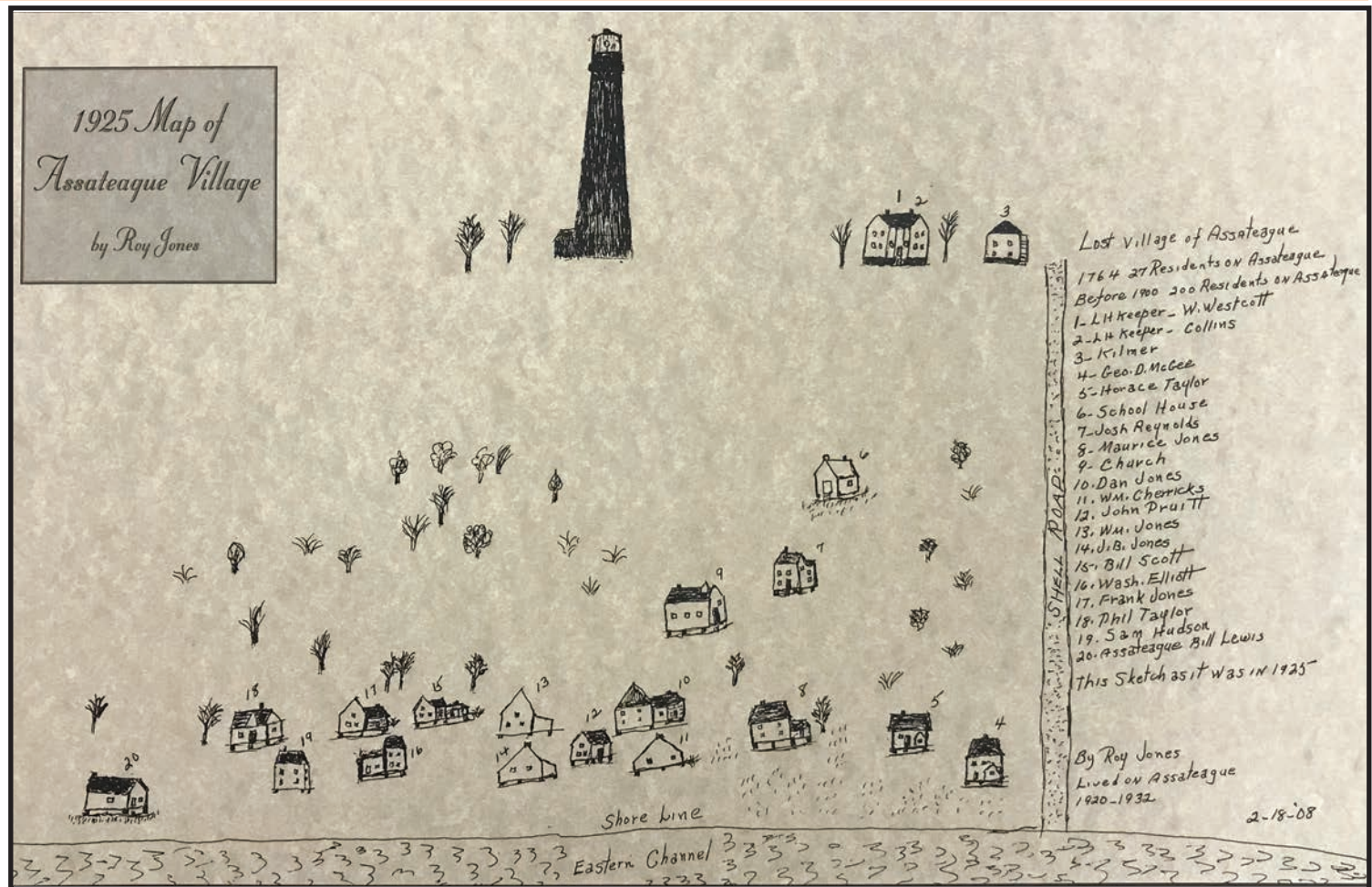
## Ashes to Ashes, Sand to Sand: The Lost Village Of Assateague

One million visitors make the trek each year to Chincoteague National Wildlife Refuge, and many of them stop to see the lighthouse. From that vantage point, the only trace of the community that used to be — Assateague Village — is the lighthouse itself and the assistant lighthouse keeper's residence, which is now used by the U.S. Fish and Wildlife Service as a seasonal staff residence. But before the area was a national treasure, it was the humble home of a handful of homesteaders.

Below the bluff, just above the channel are remnants of a village, established in 1794, that once was home to as many as 35 families, according to Chincoteague resident Roy Jones, the last living former resident of Assateague. An interview with Jones was recorded by the Museum of Chincoteague and can be viewed online or purchased from the museum on a video "When Assateague Was Home: Remembering the Lost Village." The video also has interviews with others who remember the village.

"At that time, life on Assateague and life on Chincoteague was very similar, Jones said, but there were some notable differences. "Chincoteague had running water and

electricity."

Old photographs, which appear to have been taken from the lighthouse, depict tidy two-story homes with fenced yards and tilled garden plots.

The livelihood of island folk was based around seafood: in the fall and winter, watermen tonged for Chincoteague oysters. In spring and summer, they harvested clams and scallops; and the summer months, they caught the plentiful crabs. What wasn't eaten

was sold on Chincoteague Island.

Later, in the early 1900s, there were two fish oil factories at Tom's Cove. At their peak, they employed 50 people on the day shift, and 25 on the night shift.

An annual roundup of the once-abundant island sheep yielded wool that the village women cleaned, carded, and spun.

A one-room schoolhouse, which also served as the town's social center, edu-

cated children through "sixth readers."

"They didn't go by grades like we do. They went by readers," said Jones. "It went up to the sixth readers. That was equivalent to the elementary school.

"When we finished the sixth reader, we had to go to Chincoteague school," he said. At that point students would go across in a boat and walk the distance to school, getting passed by the school bus that was

just for Chincoteague children.

A smallpox outbreak in 1903 found the island playing host to victims of the disease who were banished to a "pesthouse" there. People from Chincoteague were prohibited from going to Assateague. Those who died were buried in a small cemetery, known as "Smallpox Hill," on the east (left) side of the Beach Access Road approaching the refuge entrance from Chincoteague.

#### Village Villain

The beginning of the end came when Dr. Samuel B. Fields, of Baltimore, purchased most of the land on the Virginia side of Assateague in the early 1900s. He erected a fence that prevented the villagers from getting to Tom's Cove, and posted an overseer to enforce the refusal of passage.

With their means of livelihood cut off, village residents began to leave in 1922, a few at a time, floating their homes across the channel to re-establish them on Chincoteague.

In his book "Once Upon An Island," Kirk Mariner says the last village resident left in 1932, but Jones'

family left in 1933, and the museum's video gives the date of the last withdrawal as 1943, which coincides with the year Field's family sold the land to the federal government for the national wildlife refuge.

A trail (now closed to the public) weaves along the locations of the former homes, and other buildings, now just slight rises in the surrounding marshy landscape. On a slight rise, cement posts mark the corners of the church cemetery.

The U.S. Fish and Wildlife Service located human remains using ground-penetrating radar. A metal plaque reading "Human Remains interred in Assateague Village before 1933" was installed in 2010 to mark the location. 

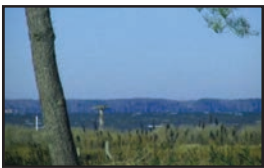

# Health Matters National Preparedness Month

National Preparedness Month (NPM), recognized each September, reminds everyone to prepare their families now and throughout the year. This NPM will focus on planning, with an overarching theme: Disasters Happen. Prepare

Now. Learn How.

Take time to learn lifesaving skills – such as CPR and first aid, check insurance policies and coverage for the hazards that may be faced, such as flood, earthquakes, and tornados. Make sure to consider the costs associated with disasters and save for an emergency. Also, know how to take practical safety steps like shutting off water and gas.

The devastating hurricanes and wildfires of 2017 reminded the nation of the importance of preparing for disasters.

## Make A Plan

Make a plan today. Know how to contact one another and reconnect if separated. Establish a family meeting place that's familiar and easy to find.

**Step 1:** Put together a plan by discussing these four questions with family, friends, or household to start your emergency plan.

- How will I receive emergency

alerts and warnings?

- What is my shelter plan?
- What is my evacuation route?
- What is my family/household communication plan?

**Step 2:** Consider specific needs in your household.

Tailor plans and supplies to fit specific daily living needs and responsibilities. Discuss needs and responsibilities and how people in the network can assist each other with communication, care of children, business, pets, or specific needs like the operation of durable medical equipment. Create a personal network for specific areas where assistance is needed. Keep in mind some these factors when developing a plan:

- Different ages of members within the household
- Responsibilities for assisting others
- Locations frequented
- Dietary needs
- Medical needs including prescriptions and equipment
- Disabilities or access and functional needs including devices and equipment
- Languages spoken
- Cultural and religious considerations

- Pets or service animals
- Households with school-aged children

**Step 3:** Fill out a family emergency plan

- Download and fill out a family emergency plan or use them as a guide to create your own.

•Create an emergency plan for parents

**Step 4:** Practice the plan with family in the household

## Emergency Preparedness Kit Recommended by VDOH

A supply kit for the home should include: water – one gallon of water per person per day for at least three days, for drinking and sanitation; food – a three-day supply of non-perishable food; first aid supplies and medications; clothing and bedding; tools and emergency supplies; and important family documents.

Store your emergency kit in an area that is easily accessible. Put contents in a large, watertight container (e.g. a large plastic garbage can with a lid and wheels) that can move easily. Make sure everyone in the family knows where to find the emergency kit.

A supply kit for a vehicle should include: blankets, first aid kit, booster cables, cell phone/charger, tool kit, water, canned or dried foods and a can opener, flashlight and extra batteries.

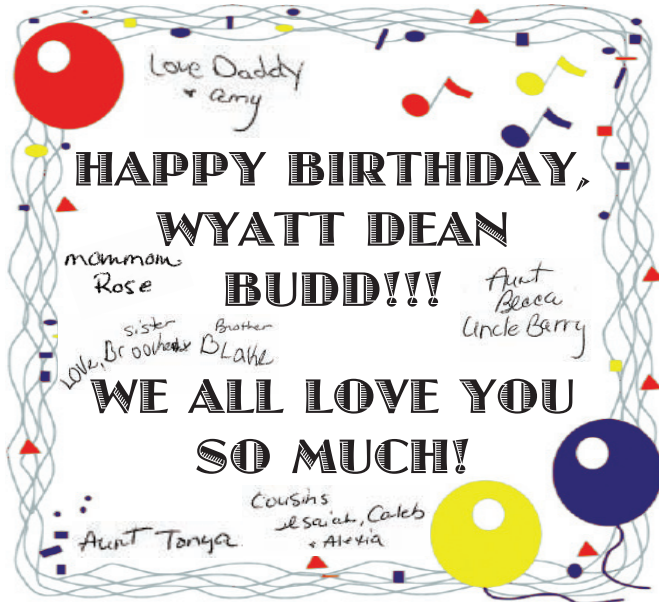

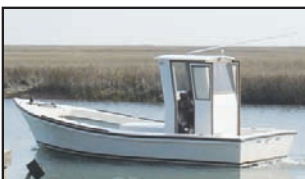



# Advertising Adversity

We are all constantly bombarded by advertising on TV, by email, in old-fashioned mail, etc. Because it is easy to become glazed over by it all, it is easy to turn off your critical-thinking skill and miss the things.

For example, we've all seen or heard the ad from a certain company offering to find you low-cost term life insurance." We found Dotty, 38, a \$500,000 policy for under \$30 a month." Then it mentions it is a 10-year term policy, meaning it is over after 10 years. Then if Dotty wants another one at age 48, the cost will really jump. What the ad does not mention is that it would be far cheaper over the 20-year period for Dotty to have bought a 20-year term policy at age 38 rather than a 10-year at 38 and another one at 48. The two succes-

sive policies at age 38 and then again at 48 work out to much more premium dollars for the insurance company.

We've all seen the clever ads about insurance that pay cash while you are in the hospital. They are branded with a funny bird. The problem here is that it is both government and insurance industry policy to push people out of the hospital as quickly as possible. Therefore, the consumer who buys this product is buying something that runs counter to both public and private policy. Is that a smart use of consumer dollars?

We are now seeing a multiplicity of ads referring to "final expense" insurance. If you believe that an ad that only tells half the story is deceptive, then these are deceptive. Some say the cost can be as little as \$9.95 a month without ever saying exactly what that \$9.95 gets

you. Others say the cost is \$9.95 a "unit" without ever defining what a "unit" is. Put on your critical thinking hat and ask yourself why the ad is so incomplete? Bait and switch perhaps?

Automobile ads are equally misleading. Watch the next few that you see. You will probably see lines and lines of microscopic type flash on the screen for only a second or two. Impossible to read. Ask yourself a basic question or two. Why can't a company make a straightforward offer with its right hand, so to speak, without then taking much of it back (all the fine print) with its left hand? The answer is simple: They want to get you into the showroom.

Automobile ads that refer to leasing often use the phrase "low mileage lease" in connection with what seems to be a good monthly price. This mileage limitation, above which you pay highly for excess mileage usage, is often 10,000 or even just 8,000 miles a year. 10,000 is

less than 200 miles a week, a pittance especially in a rural area like the Eastern Shore where things are spread out. Don't be taken in by the price, drill down and think critically.

Cosmetic ads are a trip. They use terms for chemical compounds and contents that sound invented. Check them out. Ads for over-the-counter products often have a small print disclaimer saying that the product being advertised has not been evaluated by the Food and Drug Administration. That is equivalent to saying "use at your own risk," a phrase that would not make a product very marketable.

There are many more examples, but time and space rule. Once again, do your own critical thinking when it comes to your money.

## It's Time for Rep. Scott Taylor To Oppose Seismic Blasting

There are few places I would rather be kayaking than the coastal waterways of Virginia's Eastern Shore. Paddling through vast salt marshes or following the bend of an unexplored barrier island are experiences I have spent my life trying to preserve and share with others. I've built a lifestyle as well as my business, SouthEast Expeditions, around the Eastern Shore's natural resources. With Atlantic offshore drilling activities impending, these experiences may disappear. If Virginia's coastline is touched by oil, I'll be out of a job. Plain and simple.

It's not just the livelihood of one avid kayaker that offshore drilling could make obsolete. All along the Eastern Shore, local businesses depend on abundant marine ecosystems and clean salty waters. Virginia's healthy ocean resources support over 86,000 jobs and generate roughly \$4.8 billion each year, mainly through tourism, aquaculture, fishing, and recreation. If we remain good stewards of our marshlands and waterways, Virginia can continue to reap the benefits of this consistent economic driver, year after year.

I have spent the last 20 years as an active member of our growing ecotourism industry here on the Eastern Shore. With picturesque tidal creeks, bays, and marshes, it's a natural fit. But if the oil industry encroaches on our seaside, that could quickly change.

U.S. Rep. Scott Taylor opposes drilling off the state of Virginia. We applaud that, but we need his opposition to seismic airgun blasting, too. Dangerous seismic airgun blasting is the precursor to full-blown drilling. And only focusing on these activities in Virginia's waters isn't enough. Representative Taylor should be vocal against drilling anywhere in

the Atlantic. Oil spills know no boundaries. If there's a blowout in North Carolina, Virginia could still feel the effects. Slicks could easily spread to our sandy shores and get trapped in eastern Virginia's maze of barrier islands. It could get transported up current and reach the innermost waterways of the Chesapeake Bay. The Deepwater Horizon rig was located offshore Louisiana when tragedy struck in 2010, but the flood of oil spared no neighboring states.

Like oil, noise doesn't respect state lines. Seismic airgun blasting, the disruptive process used to search for oil beneath the seafloor, sends explosions of noise that can be heard thousands of miles away. It's been shown to harm marine mammals, displace commercial fish populations, and kill tiny organisms that form the base of the ocean food chain. But damaging noise is not the only threat.

By taking a soft stance on seismic testing, Rep. Taylor is as good as pro-drilling. Part of the exploration process requires drilling exploratory wells to see if there's actually any viable oil or gas where companies think it is. Such exploratory wells have all the downsides of commercial drilling, particularly in deepwater, frontier basins like the Atlantic. When BP's Deepwater Horizon rig exploded and gushed more than 200 million gallons of oil into the Gulf of Mexico, it was tapping an exploratory well. We know how that played out for local communities, coastal economies, and the Gulf environment. Tourism plummeted in the Gulf region, with an estimated 10 million lost user-days of beach, fishing, and boating activity. The economic impact is still being felt today. The cost of closures and oil exposure on Gulf fisheries

could total \$8.7 billion by 2020. I shudder to think of the outcome for Virginia's tourism and fisheries – let alone my own business – if another such exploratory drilling blunder happened off our shores.

Business leaders throughout coastal Virginia stand united in opposition to drilling and exploration in the Atlantic. It's in our best interest to preserve the character of the Eastern Shore, not jeopardize it with coastal industrialization or the perils of an inevitable spill. Experienced business owners, we know a savvy business decision when we see it – developing offshore oil and gas in the Atlantic is not one. 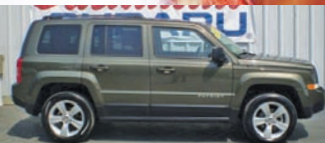
