WASHOUT! Rains Rip Roads, Strand Residents

Even after the rain ended and residents emerged to survey the damage, parts of Northampton County remained under a flood warning Monday after more than 10 inches of rain fell in less than 24 hours near the Accomack/Northampton county line, causing Hillsborough Drive — the only access to the Hillsborough neighborhood in southern Accomack County — to wash out, stranding the cluster of homes west of Belle Haven.

Wardtown, Saltworks, and Cemetery roads in Northampton County were also closed near Ocohanock Neck Road after flooding washed out those roads, along with Happy Union Drive in Exmore. Saltworks has been repaired and reopened, and VDOT expected to have Happy Union open to traffic by the end of the day Tuesday.

Tonya Cuff and her son, Jacob, 16, spent Sunday afternoon and evening watching the pond fill behind the house on Still Pond Lane in the Hillsborough neighborhood that they share with her father and mother, Robert and Cindy Gray. The well-known fishing spot's water level fluctuated regularly, and this was the highest they had seen it.

The rain started Sunday afternoon and continued into the evening, getting stronger around 6:30 or 7 p.m. "It just poured," said another Hillsborough resident, Jamie Davis. "We kept checking the radar and it said it would move out,

Shore Errs on the Side of Caution

The week started with Eastern Shore residents rushing to get supplies and trying to figure out where low-lying folks would stay during the impending arrival of monster Hurricane Florence following Gov. Ralph Northam's mandatory evacuation order for Zone A, which is much of the coast of both sides of the Shore.

With more and more people in recent years building along the intracoastal waterway to the east and Chesapeake Bay inlets to the west, many in Accomack and

Northampton counties are living in Zone A.

There was the normal anxiety, or in some cases thrill, that goes with it. The forecast was ever changing. Tuesday was much the same.

But Wednesday things brightened here a bit as it appeared the Shore could avoid the most severe weather as predicted by the National Hurricane Center Track Forecast Cone. The hurricane was expected to move a bit farther south.

Governor Northam scheduled a press conference about the weather for shortly

after press time — too late to be included in this edition — and his office would not share details ahead of time.

"I think we're all doing better," C. Ray Pruitt, Accomack's director of public safety, said Wednesday. "I feel sorry for the people who are not doing better."

Even so, "We're erring on the side of caution," Pruitt said. The shelters were still opened at 5 p.m. Wednesday and officials continued to monitor the storm. "I'm fine with it," Pruitt said. Updates were

Woman's Act of Caring for Stray Kitten Turns Into Rabies Ordeal

Cara Burton, of Parksley, is a cat lover who couldn't resist helping a kitten that she discovered in a rock crevice at Guard Shore's beach near Bloxom recently.

The director of the Eastern Shore Public Library took the ailing animal to the vet as it appeared to have been thrown where she found it and was suffering.

Unfortunately, Burton's kindness was rewarded with a series of shots. "Yep, it was rabid," she announced on Facebook last week. The cat was infected and had bitten her. So Burton wound up in the local emergency room.

"Four shots in arm and thighs" for the first round, she said, adding the treatment wasn't painful but it was expensive. "Have to get three more over next two weeks."

The cat "was euthanized because of back trauma," Burton continued. Paralyzed and blind in one eye, it had a lot of pain. "I was blessed to be able to end its misery. Thankfully the vet saw her ASAP. She was a sweet kitten and seemed genuinely grateful that I pulled her out ... kept her warm, and sought medical help."

A report from the Eastern Shore Health District reminded residents to be aware of rabies and to get pets vaccinated. The female grey tabby with tricolor stripes, which was found on Aug. 31, was tested for rabies at the state laboratory.

"Given the remote location this cat was found and its poor condition, it is possible that this cat may have been transported there by someone from another location," according to the announcement. "If you, your family member or your pets had any potential contact with this cat in any location, please contact the Accomack County Health Department immediately at 757-787-5886."

Rabies is a fatal disease caused by a virus in the saliva of infected mammals. It is spread when the virus enters a fresh open wound, or through exposure of a mucous membrane of the nose, eye, or mouth. Rabies is endemic in our raccoon population with spillover into other species. High-risk species also include foxes, skunks, bats, and unvaccinated cats.

"This incident is another reminder that residents of the Eastern Shore

must keep a heightened sense of awareness of this deadly disease and always be wary of wild, stray, and unvaccinated animals," the health department reported. "To protect yourselves, your families, and your own pets ... make sure all of your own pets and valuable livestock are up to date on rabies vaccinations. Keep your pets confined to your own property. Avoid contact with wild, stray, or unknown cats, dogs, and wildlife. If you do get bitten or scratched, wash the wound thoroughly with soap and plenty of water and notify your doctor as soon as possible."

Always report all animal bites to the Accomack County Health Department at 757-787-5880, the Accomack County Sheriff's Office at 757-787-1131, the Northampton County Health Department 757-442-6228, or the Northampton

Sheriff's Office 757-678-0458.

"If people would spay/neuter their pets and get them vaccinated for rabies, the spread of this deadly disease on the Shore would be greatly reduced," said Burton. "It is a simple way to protect you and your family and prevent much misery for animals."

Following Heavy Rains, Exmore Talks About Trash in Roadside Ditches

At Exmore's council meeting Monday night, one day after heavy rains that caused flooding in several parts of town, the first public comment heard was from Brenda Bailey, who spoke out about ditches being full of trash and not draining properly.

She said she was frustrated because it's an ongoing problem and no one ever does anything about it.

Council members said the town is limited in what it could do about ditch maintenance, and so is Northampton County.

"What can we do to pull together?" Bailey asked.

Town Manager Robert Duer asked Bailey to wait until around October 31 or mid-November to allow time to survey the ditches, particularly on the seaside. He suspected the ditches were full of improperly disposed tires.

Council members also discussed how to reduce the cost of the town's trash collection service, which is operating at a loss. They agreed that land-

fill tipping fees, which had only risen 5 percent, were not to blame. The majority of the expense of trash pickup is in labor and equipment. The type of garbage truck used also makes a difference in labor costs. A regular garbage truck requires three workers, but an automated side loader – the type of garbage truck with equipment that automatically grabs waste containers at the curb and dumps trash directly into the truck – can be fully operated by one person.

Contracting out the trash collection service was suggested. Duer said that option had been researched previously and would likely result in a "push" – neither a loss nor a profit – but it could be reconsidered.

Recycling was mentioned, but Duer said, "Recycling is dead," because it is so difficult to find a company willing to pick up recyclables. There also remains the question of who would sort the items, Duer added.

Other services provided by the town, such as the police force, admin-

istration, public works, and water supply, generate enough income to cover losses in sewer and sanitation services and still net an overall profit.

A financial report on Exmore's profits and losses from December 2013 to July 2018 showed that during Duer's 4.5 years thus far as town manager, the town has gained a net profit of \$1.8 million.

As of June 30, 2013, the town's checking and savings balances, totaling more than half a million dollars, had more than doubled since the previous year.

In 2014, those balances began to approach the \$1 million mark, which was surpassed the following year. Fiscal years 2015, 2016, and 2017 ended with Exmore having about \$1.4 million, \$1.7 million, and \$2.1 million, respectively, in the bank.

As of June 30, 2018, Exmore has more than \$2.6 million in cash on hand and continues to maintain a balance between its assets and liabilities and equity.

Duer did not take all the credit. Rather, he commended the whole staff for working together to manage the town.

Earlier this year, Exmore residents complained about the overpopulation of stray cats in town. Duer reported that with some charitable assistance from local organizations, 40 cats were either spayed or neutered recently.

"Everybody's happy, except the cats," Duer joked.

Upcoming special events at Exmore Town Park include the second annual Shakespeare in the Park, featuring a performance of "As You Like It" on Friday, Sept. 21, at 7:30 p.m.

The first annual Artisans Festival follows on Saturday, Sept. 22, where creators of arts, crafts, food, and more will showcase and sell their work.

Two weeks later, the first annual Eastern Shore Music & Soul Food Festival will also make its premiere, on Friday, Oct. 5, and Saturday, Oct. 6.

but it never moved," he said.

About 4 a.m. Cuff heard an "awful landslide, loud rumbling, vibrating-type noise," and the "pop, pop, pop" of trees snapping. "And then we lost power," she said. Jacob came running in. "You can hear the water rushing," he told her. "He ran out back and he said 'The water is rushing out of the pond. There are trees missing where the road should be.'"

Jay Diem, spokesperson for A&N Electric Cooperative (ANEC), said the first power outage calls started coming in around 4:30 a.m.

Cuff and Davis were two of about 36 homes left without power when the washout took not only the road, but the power line that ran underneath. The road ran along the top of the pond's dam. A "big tube" ran under the road, along with a culvert that distributed water from the pond into the creek below. "That was repaired last year," Cuff said.

By now it was 4:45 a.m., and Cuff's father, Robert Gray, proposed they drive down and have a look at the damage. When they arrived, a neighbor was already there. In the darkness, he had

managed to stop another neighbor from driving into the washout. As they stood together, light just beginning to creep over the horizon, they began to see the enormity of the devastation.

"It was amazing," said Cuff. "We were watching the pond water merging with the creek water and scores of fish being deposited along the shore." The differences in salinity and water temperature caused high fish mortality. "The fish were suffocating, basically. It was sad. My son was raised on this pond. For him, it was torture," she said

Cuff said after pausing to call VDOT and ANEC, she called the neighbors on the Shields Bridge Road side of the gap to ask them to intercept unsuspecting cars, but before anyone could get out there, a newspaper delivery vehicle had made the turn onto Hillsborough Drive. The gathered neighbors frantically tried to signal the driver with their cell phones. "We were jumping up and down ... trying to get his attention," she said. He paused long enough to see the trees were down. "Then he saw the road was gone," she said.

Cuff began posting photos to Facebook to alert others to the danger.

Davis woke again around 6:30 a.m. and saw Cuff's photos. He and other residents made their way down to the washout. "All the residents of Hillsborough were on one side (of the washout) and VDOT was on the other side," he said.

"VDOT crews are assessing damage and working with county public safety" officials to assist residents, said VDOT spokeswoman Nina Napolitano. VDOT crews were alerted around 5 a.m. Monday. "They have placed signs and barricades on both sides to keep people away." The agency is exploring options for temporary access for residents, while it works on permanent repairs to Hillsborough Road.

In the meantime, property owners bordering the development have granted temporary access across their land. One route was described by Cuff as a forestry road. "It's very hard to get through, very tight. Not a lot of vehicles can get through," she said. Another route goes along a farm field. "That is the route VDOT and A&N used. Some people with bigger vehicles passed through there."

Data from the National Oceanic and Atmospheric Administration showed

more than 10 inches of rain fell in an area roughly bounded by Belle Haven, Nassawadox, Jamesville, and Craddockville, ringed by areas of 6 to 10 inches

of rain. Both Davis and Cuff have neighbors who speculated up to 16 inches fell: one by means of a 5-gallon bucket that was filled by the storm and one by a

backyard rain gauge.

Davis picked up limbs from his yard during the forced downtime. He had gone out to get groceries Saturday night, so he is prepared for Hurricane Florence. A neighbor who works at the hospital had been ferried across the creek in a boat, to be picked up and taken to work. People are figuring things out and making the best of the situation.

"In a way we were lucky," Davis said, that the disruption happened before the hurricane impacts the area later this week and VDOT and ANEC resources are spread thin. Davis said his power was back around 2 p.m. Diem said power was fully restored to the area by 2:30 p.m. Monday.

"It's an amazing, unbelievable sight to see," said Cuff. "It's a testament: Don't underestimate the power of water, especially with this hurricane coming. People don't think about how much force is behind it. You can't even begin to judge."

She had high praise for VDOT, ANEC, Marshall's Tree Service, and Accomack County Department of Public Safety. "They were outstanding. They were right on top of it. They did the best they could to help us," she said.

Bond Denied For Murder-For-Hire Defendant

Bond was denied last week in Accomack Circuit Court for a Painter man alleged to have been hired to kill an Eastern Shore Drug Task Force police informant in October 2017.

Aaron Jamaricus Bowens, also known as Easy and BOBO, 22, of Big Pine Road, was later paid \$1,000 for injuring the informant, according to the confession of a co-defendant who ordered the hit. But authorities do not believe Bowens was the one who actually shot the victim and his girlfriend last Halloween night. He is charged with capital murder for hire, capital murder for a prisoner, and felony obstruction of justice.

Defense lawyer Afshin Farashahi, of Virginia Beach, Va., argued that there was no solid evidence against Bowens. Farashahi said his client has "strong ties to the community," is not a flight risk, and deserves the "presumption of innocence."

"There is a copious amount of evidence that shows this defendant was in it up to his neck," said Commonwealth's Attorney Spencer Morgan. "He actually accepted payment ... he is a threat to witnesses and the public."

Judge W. Revell Lewis III denied Farashahi's motion and noted Bowens is unemployed. After calendars were studied, Lewis set the trial for Feb. 5, 6, and 7, 2019. Pre-trial motions were scheduled in December.

Nathaniel Johnson, 31, has testified he was shot in the back and buttocks. Dezarae Smith, 19, was hit in the foot. The two were visiting in the Linhaven area near Painter and were walking to Johnson's car, which was parked at his grandmother's nearby home, when they were shot.

Both victims identified the gunman as Roquan Lee'teq (Cake) Rogers, 19, of Benjamin Banneker Street in Exmore. Last month, a jury was deadlocked in finding some verdicts for Rogers. The 12-member panel convicted Rogers of three counts of conspiracy but could

not agree on nine other counts including attempted capital murder of Johnson and Smith. The foreperson said the jury recommended a total of 17 years in prison for conspiracy to commit capital murder for hire, conspiracy to commit capital murder involving a prisoner, and conspiracy to commit obstruction of justice. When the members were polled, one juror said he disagreed with the sentence.

Bowens has been publicly accused of committing murder in Northampton County, although he was never charged with the crime. His home was searched after Johnson and Smith were shot, and street gang-related notes were confiscated.

There was a \$3,000 contract for killing Johnson, according to court records. Morgan said Bowens was paid less because Johnson survived.

In another case, Lewis denied bond for Sonny James Kelly Sr., 46, of Savannah Road in Hallwood. Kelly was free on bond after being accused of making a bomb threat when he was charged with receiving stolen property. Lewis said Kelly has been convicted of crimes 13 times and his release would be a threat to public safety.

Billy Brandice Kilmon, 34, of Sunny Court in Cape Charles, pleaded guilty to possession of cocaine. A presentence report was ordered. The incident occurred in December 2017.

Harvey Lee Pettit Jr., 40, of Accomack Manor in Parksley, was sentenced to 20 years with half suspended for cocaine distribution. It was his third offense selling illegal drugs. The offense occurred in April 2017.

Gabrielle Lynn Kromer, 27, of Rice's Lane in Onley, was sentenced to three years each on counts of burglary, grand larceny, and child endangerment. All but 15 days each was suspended to run consecutively. The incidents occurred in May 2017.

Steven Joseph Ramsey, 27, of Onancock, was given a three-year suspended sentence for grand larceny of property from Walmart that occurred in October 2017. Ramsey was sentenced to 12 months for petty larceny.

Matthew Edward Grimes, also known as Joshua Charles Grimes, 48, of Luff Court in Greenbackville, was sentenced to three years in prison with two years suspended for forging a public document in July 2017.

VDOT is working to provide temporary access for people living in the Hillsborough neighborhood. Contract crews are clearing downed trees, and VDOT has placed signs and barricades on both sides of the damaged area for safety.

Northampton County

Cape Charles Council Gets Up to Speed on Annexation Agreement

With three new Cape Charles council members learning their roles, the council was briefed last week on the November 1991 annexation order made on behalf of the town and construction company Brown & Root. The annexation increased the town's area by approximately three square miles, founded the unfulfilled expectation of extensive commercial and residential development – including nearly 3,000 homes that were never built – and remains a source of contention for some residents almost 30 years later.

Michael Sterling, managing partner of the Norfolk-based law firm Vandeventer Black, made the Sept. 6 presentation that was open to the public.

Sterling taught a brief history lesson on Cape Charles' relationship with Brown & Root and the company's successors.

The Brown & Root story can be traced back to 1977, when the construction company requested farm land it purchased to be rezoned for industrial use — specifically, to build

an offshore drilling platform — and Northampton County complied.

But the offshore drilling concept failed. A new concept surfaced in the early 1990s: a resort and retirement community called Accawmacke Plantation. Over the course of 20 years, 3,000 homes were to be built, along with a golf course, marina, hotel, and retail outlets.

Part of the land Brown & Root purchased already belonged to the town of Cape Charles. The remainder belonged to Northampton County.

The original agreement made between Cape Charles and Brown & Root in March 1990 committed the construction company to develop the land on the condition that the portion belonging to Northampton County would be annexed into Cape Charles and the town would extend its utilities to the area.

Northampton filed a lawsuit opposing the annexation agreement but later settled.

In a court document filed in October 1991, former Northampton County Attorney Bruce Jones explained why

the petition for the annexation should have been dismissed.

“Whether Accawmacke Plantation will ever become a reality or, if so, what form it will take, no matter what decision this Court makes, is a matter of rank speculation ... depending on social and economic considerations and Brown & Root's fancy,” the document stated.

One specific reason for the county's opposition to the annexation was, “The Supreme Court has not ruled on the power of annexation courts to order non-financial terms and conditions not specifically contemplated by the specific enumerated powers of this section.”

In other words, demands in the annexation agreement for anything other than money could not be enforced. For example, Cape Charles could not be required to hire a full-time town planner. Brown & Root could not be required to hire local construction workers. Neither the town nor the construction company could be required to build a road, and the county could not be required to change its zoning ordinance.

The annexation agreement was amended in November 1991 and was signed by former Northampton County Board of Supervisors Chairman Charles Bell, former Cape Charles Mayor Edward “Alex” Parry, and former Brown & Root Vice President Joel Bates.

The golf resort and community was built on the land purchased by Brown & Root and was renamed Bay Creek. The land also contains the subdivisions of Marina Village East, Kings Bay, and The Colony, as well as other properties such as Kings Creek Marina.

Among the key points of the annexation agreement Sterling highlighted was Brown & Root's responsibility to pay the costs of planning the development, including consultants, engineers, architects, and other experts.

Sterling addressed the belief of some Cape Charles residents that Brown & Root was responsible to pay for the town's new wastewater treatment plant, which cost about \$19.2 million.

A Virginia Water Quality Improvement Fund grant and an American Recovery and Reinvestment Act grant covered about \$14 million, or around 73 percent of the cost. The remainder was covered by the town with a 20-year, no-interest loan from the state.

Sterling pointed out language in the original annexation agreement that confirmed “Brown & Root agrees to pay the cost of the physical expansion of the town's sewer and water treatment systems,” but only “to accommodate the additional treatment demands of the Brown & Root property beyond the limits of the town's current permitted capacities.”

But the Brown & Root development was never completed. It would have required a wastewater treatment capacity of more than 1 million gallons per day. The new wastewater treatment plant, which was built to meet current state regulations for nutrient removal, has the same permitted capacity as the old plant, 250,000 gallons per day. It uses about 150,000 gallons of water per day.

Members of the public who attended the town council work session were permitted to ask questions.

Eyre Baldwin asked if Brown & Root has any obligation for expansion of the wastewater treatment plant. Sterling responded, “I won't answer that.”

The Virginia Department of Transportation recently completed road improvements on Old Cape Charles Road (Route 642), which leads past Bay Creek and provides access to Cape Charles Harbor. The \$10 million project (including engineering, right of way, and construction) opened to traffic this summer.

Old Cape Charles Road connects to Stone Road, the main road leading from Route 13 to the town of Cape Charles.

Wayne Creed said Brown and Root should have paid for a new connector road as stated by the annexation agreement.

But the agreement indicated road construction should begin when average annual peak hour traffic entering and leaving south Accawmacke Plantation, now Bay Creek, exceeds 400 and average annual peak hour traffic on Old Cape Charles Road exceeds 250.

Because the area was never built up enough, the traffic studies were never done, Sterling said.

If Brown & Root had finished building the 3,000 new homes as proposed and those homes were occupied, Cape Charles would have had five times as many residents and the total county population would have increased 50 percent.

To determine which zone you are in, visit ACDPS.net and click on the Emergency Management section. In Northampton, go to northampton-ems.org Chincoteague residents can visit chincoteague-va.org

Schools in both counties were closed for the rest of the week. And disaster declarations were made. Those in Zone A included Cape Charles, Chincoteague, Deep Creek, Greenbackville, Quinby, Oyster, Wachapreague, Hacks Neck, and Harborton and many other areas. Saxis and Sanford were listed as being in Zone B but usually get hit with flooding. Bay Creek near Cape Charles was also in Zone B.

Arcadia and Nandua high schools were set up as shelters for Accomack. Nandua Middle was established as a shelter for Northampton residents seeking higher ground. Those opened at 5 p.m., Wednesday. Bus services were offered late Wednesday afternoon from Northampton.

It was noted that mobile homes, recreational vehicles, and other campers may be vulnerable to high wind damage.

Price gouging was outlawed by the state attorney general and late book fees were waived in advance for the Eastern Shore Public Library. The libraries announced closures for Thursday and Friday, Sept. 13 and 14.

Esther Evans, who works at the Exmore Hampton Inn and Suites in Exmore, said reservations had been coming in steadily but picked up after the evacuation order. "Monday evening into early Tuesday morning we sold out," she said.

As of Wednesday morning, when Florence appeared to be taking a more southern track, Holiday Inn Express in Exmore still had rooms available.

Chincoteague

On Chincoteague, residents and visitors were told the area could receive impacts starting late Wednesday or early Thursday with "high winds, heavy rainfall and dangerous coastal flooding," according to a report issued by E. Bryan Rush, director of the town's emergency

services. A mandatory evacuation for all visitors began Wednesday morning.

Councilwoman Denise Bowden told it like it was to those looking for her guidance. "I do not know if we will have major flooding or hurricane force winds. No one knows this. If your gut instinct tells you to evacuate, then go. There is no shame in being scared. I cannot tell you where to park your vehicles. If you wish to put them on higher ground then seek out friends who have higher ground. If you choose to stay, then prepare accordingly in case we have worst case scenarios. Food, water, candles, meds, pet food, etc."

Concerns for the welfare of the herd of famous wild ponies poured in on Facebook to what appeared to be all Chincoteague-related pages. "The ponies are fine," Bowden reported. "They have the natural instinct to seek higher ground. They are much safer out on Assateague than they would be corralled at the carnival grounds."

"Don't be an ass and leave your dog outside tied up or in a pen," she also commented. "This is just wrong on so many levels," she continued. Also, "Keep an eye out for the elderly and those that don't have family to turn to. Be smart and keep your patience. Nerves can get on edge. Being hot-headed will not do you any good. Don't chastise those that evacuate. For some, this is their first major storm, they are nervous and on edge. Leave them alone and don't make them feel worse than they already do."

"There are more that will never leave than those who will leave," Bowden told the Post.

"A Teaguer will dig down in the marsh mud and stay put and will only leave when they have absolutely exhausted their resources ... If you are not a resident, you have to leave. I could not tell you how many people that may impact. It would be hard to gather numbers when you also have vacation homes to account for."

Cape Charles

In Cape Charles, Mayor Smitty Dize said much of the old town area is in Zone A. "Town staff is workin to prepare public streets and facilities for the impending storm. Residents can help by removing objects from porches, decks and yards that can be moved and blown area by strong storm winds. These blowing objects pose a danger to people and property. Please take care to remove trash cans from the street and curb."

The public works crew has moved the

LOVE sign as a precaution and warned residents to stay off the beach and fishing pier during the storm. Bay Creek is making its golf course parking lot available for city residents. "Residents should stop at the Bay Creek Gatehouse and obtain a Guest Pass to be placed on the rearview mirror," reads an advisory from town officials Wednesday morning. The town will be posting updates on www.capecharles.org

"There are many homes in Cape Charles that have part-time residents... it would be prudent ... to pay attention to your neighbors' homes as well as your own," Dize said.

Tangier

On Tangier Island, Mayor James "Ooker" Eskridge said 279 of 400 residents were staying. "They were monitoring the weather stations. They continue to monitor. A lot of the folks who are staying have their own boats and would leave and take their families to a safer harbor, maybe Crisfield," Md., the mayor said. "They're getting their (crab) pots up as a precaution. They're preparing."

"We don't have so much trouble with a storm surge," he continued. "We can get one in the bay, but usually ocean beaches and bays" and "the Western Shore" of the Chesapeake have more of a concern. Still, high tides in the last few days on Tangier were marked as high as they were with Hurricane Isabel, he continued. "People are concerned because we already have this much water."

It had been recommended during a

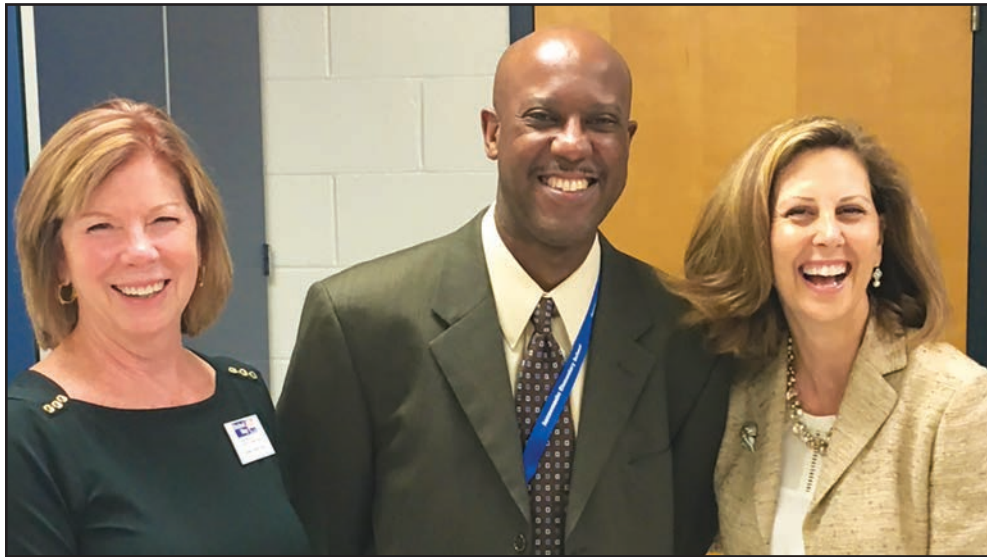
Tangier town meeting that those with medical issues and the elderly go to the mainland. Phone service on the western side of the island goes in and out with the tide, a Tangier woman said. A list of those staying was compiled by town officials so everyone could be accounted for.

A notice from emergency coordinators in both counties warned, "Although the exact track of Hurricane Florence is unknown at this time, we will be feeling impacts from this storm. Flooding, high winds, heavy rainfall will impact the area."

"Regardless of your evacuation zone, emergency management officials are advising all residents to prepare for high winds. Residents should continually monitor local media outlets for information regarding the track of Hurricane Florence. Storm movement is subject to change."

Just before press time Wednesday, Northampton officials announced its Emergency Operations Center would open Thursday, Sept. 13, at 9 a.m., when county operations were scheduled to cease at the offices of county administrator, finance, information technology, commissioner of the revenue, treasurer, planning, permitting and enforcement and the voter registration. Northampton's landfill and all six solid waste collection sites will be open Thursday, Sept. 13, until noon. The clerk of the court's office will be open Thursday. A decision about Friday hours will be decided Thursday. Normal county operations will resume as soon as it is safe to do so, an announcement said.

The Arcadia Firebirds downed the Nandua Warriors last Friday night in Onley, 42-31, in the first district match up of the season.

Joe Teasley got things rolling with a touchdown to put the Warriors on the board first. The 2-point conversion was good, placing the Warriors in the lead after the first quarter, 8-0.

Jaheim Bailey notched another six for Nandua with a 12-yard touchdown in the second, and with a completed pass to Xzaviyor Snead to get the extra points, the Warriors were up, 16-0.

A 16-yard run by Lethan Williams would put the Firebirds on the board, and with the kick good, they narrowed the gap, 16-7. Another Firebird touchdown and extra point would inch Arcadia closer to rest the

halftime score at 16-14.

Journey of Marshall Cropper Took A Strange Twist

As a boy growing up in Wattsville in northern Accomack County, Marshall Cropper would have thought it outrageously absurd to think he one day would be a member of the Eastern Shore Golf Hall of Fame.

"There was no golf being played on the playgrounds where I lived," said Cropper with a hearty laugh, adding, "In fact, there were no playgrounds. We played in the fields, and it was mostly baseball and football."

Cropper, now 74, went on to become a two-sport star at Mary N. Smith, 22 miles from home and the only black high school in the county during days of segregation.

"I got home many nights after practice by using my thumb," recalled Cropper. "Or John Parsons would take a bunch of us home. He must have worn out three cars carrying all his players home."

Cropper was good enough in baseball that the Cincinnati Reds wanted to sign him to a contract. But he wanted an education and thought a better

path to the pros was in football.

When colleges came calling, he chose Maryland State College, today the University of Maryland Eastern Shore in Princess Anne, Md.

"I remember going there with a church group as a teenager in the 1950s and just falling in love with the place. And that was before they had all the facilities they have today," Cropper added.

The UMES campus, a short drive from Route 13 in Princess Anne, today boasts outstanding facilities and is a popular choice for students from Virginia's Eastern Shore, including Isaac Taylor of Wachapreague, a former Nandua High School basketball star who is expected to play a big role for the Hawks this season. One of Taylor's assistant coaches is Ace Custis, former Northampton standout whose number is retired at Virginia Tech.

The women's bowling team has won the NCAA National Championship three times in the past 10 years.

Maryland State Once a Pipeline to the Pros

Although no football is played on the campus today, there was a time Maryland State College was a pipeline to the pros.

"I played with 11 guys in my career who went on to the NFL. There were more than 40 from Maryland State overall who got there," said Cropper recently, standing below a wall of photos of Maryland State greats, including his former teammate and today one of his best friends, eight-time Pro Bowler Art Shell, the second African-American coach ever in the NFL and a member of its Hall of Fame.

Another Maryland State griddy who shared the field with Cropper was Emerson Boozer, a star in the Jets' Super Bowl III win over Baltimore that hastened the merger of the NFL and the AFL.

Cropper also played with Charlie Stukes, a Baltimore Colt great, and preceding Cropper's time at Maryland

State were Roger Brown and Johnny Sample, another Eastern Shore of Virginia native who played prominent

roles in both that Super Bowl III and the 1958 NFL championship game that saw the Colts defeat the New York Giants in overtime, often called “The Greatest Game Ever Played.”

“All those players coming out of Maryland State and going to the pros paved the way for the rest of us. Scouts kept coming back to the campus to look at us because they knew we could play ball with the best,” said Cropper.

Another one of Cropper’s Maryland State teammates had his NFL hopes cut short by an horrific car accident. But, fortunately, Clarence Clemons also had a love for music and had a fabled career as a saxophonist in Bruce Springsteen’s E-Street Band from 1972 until his death in 2011.

“He was good enough to play ball,” said Cropper, reflecting on Clemons. “I know that. I think we all got pleasure out of seeing him successful.”

Cropper Gets a Golf Tip from The King

Cropper was a good-hitting, left-handed first baseman at Maryland State and an All-CIAA tight end in 1966. He signed with the Pittsburgh Steelers after graduating from Maryland State in 1967.

The Steelers trained at Latrobe, Pa., the hometown of Arnold Palmer, and after practice, some of the players would hit golf balls at the nearby driving range.

“I was hitting the ball a country mile, but it would usually veer right or left. Arnold Palmer came up and told me I should try swinging right-handed because I might have more control.

He was right, too. I have played that way ever since,” said Cropper, getting one of his first golf tips from the man known as “The King.”

Cropper played for the Steelers before they were among the NFL elite, catching 14 passes for 181 yards in three seasons and leaving just prior to the arrival of Chuck Noll, who eventually coached Pittsburgh to four Super Bowl wins.

But then he signed on with the Washington Redskins for two seasons, including 1969, the only season there for famed NFL coach Vince Lombardi.

“Coach Lombardi had a way of instilling his expectations on you and getting

more out of you than maybe you thought you had to give,” recalled Cropper.

Lombardi took the Redskins from a 5-9 record the year before he arrived to a 7-5-2 mark and then died of cancer before the next season.

“I think Coach knew he was sick that season,” said Cropper, “but he never stopped coaching us.”

Cropper Returns to Alma Mater After D.C. Career

After two years with the Redskins, Cropper stayed in the D.C. area to work for the city’s Department of Environmental Services and then the D.C. Department of Recreation.

He earned his master’s degree in 1975 from National Graduate University and was inducted into the University of Maryland Eastern Shore Hall of Fame in 1984.

If Cropper deserved inclusion in the school’s hall of fame in 1984, then today there should be a separate room just for him.

In 2004 Cropper started a golf academy at the school. And four years later, he founded with the support of the school’s president the first PGA golf management program at any historically black college in the country. It remains the only such program and is just one of 20 programs anywhere, with most located at major universities.

The educational program is accredited by the PGA of America and includes extensive classroom studies, internship experience and player development, providing students the opportunity to acquire knowledge and skills necessary to have success in the golf industry.

Cropper also serves as the men’s coach of the golf team. The Hawks have upcoming matches in North Carolina, Georgia and Florida, as well as the Virginia State Trojan Fall Classic, a tournament they won two years ago.

“We are Division 1 and hold our own with some big schools. But I tell the coaches at those schools, ‘You are giving out trophies. I am providing my guys careers.’”

Cropper said numerous UMES graduates are now making their livelihood in professional golf in a number of capacities.

The golf program has an indoor hitting

ting area with a simulator that includes 30 courses, an outdoor driving range and a practice green. Students in the golf management program take all the prerequisite courses other students must complete.

Cropper said the university's golf management program isn't just about golf. "Even if you don't make a career in golf, being able to play at a competent level helps you in business dealings. Our program also includes hotel and restaurant management skills," added Cropper, who has coordinated numerous fundraiser activities, including the Eastern Shore Art Shell Celebrity Golf Tournament held at area courses for many years.

Cropper's Passion Has Been Working with Youth

In 1995, Cropper was presented the National Association for Equal Opportunity in Higher Education Award. One force that has driven Cropper's entire life is giving back. "I had a lot of mentors in my life. First there were my parents (James and Lurine Cropper). But John Parsons and his wife, Florence, were

major influences on me. She might have taught me more baseball than Coach Parsons. She really knew the game," said Cropper, who also mentioned Floyd Nedab Sr., another one of his coaches.

"One reason I came to Maryland State was it was close to home, where I could help kids become successful where I grew up."

Cropper lives in the family home in Wattsville and still attends the church where he grew up. "I look around the church and can see in my mind's eye where my parents used to sit, where my uncles, aunts and cousins used to sit. There are lots of memories there," said Cropper, sitting under a sign that reads, "I started my life with nothing, and I am proud to say I've got most of it left."

Cropper's wife of 36 years, Sarah, a Berlin, Md. native he met at Maryland State, died of cancer in 2008. They had two children, a son, Vashnile, and a daughter, Vashti, and today Cropper has three grandchildren.

Earlier this year, Cropper became the first African-American to be inducted into the Eastern Shore Golf Hall of Fame, a program started by Eastern Shore Golf Magazine in 2011.

Cropper plays golf today mainly at fundraising and celebrity events, saying his handicap "is anything I want it to be, depending on who I am playing," but golf for him is mostly a tool for teaching life skills and raising funds for those programs dear to him.

"I was shocked and humbled when I was told I was being inducted into the Eastern Shore Golf Hall of Fame. Who would have thought a poor kid like me from Wattsville would be in a hall of fame for golf?"

The answer is that few have done as much for others with simply a game.

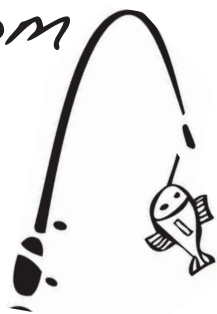

Fishing from the Shore

Recent weather conditions have severely impacted local fishing activities, preventing anglers from safely accessing inshore and offshore waters, as well as forcing the postponement and cancellation of area fishing tournaments. As I sit at my computer and write this, the Weather Channel and social media are inundating us with reports, predictions, and scenarios. Regardless of Hurricane Florence's final path, anglers are encouraged to be smart when it comes to venturing out in less than ideal conditions. No fish is worth losing your vessel and possibly your life.

Look for cobia, spadefish, and triggerfish to continue to exit the lower Chesapeake Bay, while the big red drum and Spanish mackerel run should last a little while longer. Bluefish numbers should also be on the rise as the Spanish population dwindles. Smaller red drum (aka puppy drum) should increase in numbers as the water temperatures begin to cool. Expect speckled trout numbers to also increase, hopefully a little larger size class than the little "dinks" that are currently in the creek mouths.

Lower Shore – Chris Snook, of Chris' Bait & Tackle, used one word to describe the recent fishing conditions in the lower bay, "windy!" She said that anglers that were able to get out last weekend managed to still find some cobia around the pilings of the Chesapeake Bay Bridge-Tunnel. The most recent weather system should hasten the cobia migration to the ocean waters and south for the winter. Trollers and casters were still catching Spanish mackerel as of last weekend, but more bluefish were becoming a larger part of the bycatch. Anglers soaking cut bait late in the day were catching and releasing big red drum. Snook had not heard much on croaker catches lately and commented that all the other fisheries had "slacked off."

Chincoteague – Donna Rae, at Captain Bob's Marina, reported a tale of two fisheries. Prior to last Saturday, she said that flounder were being caught in the southern part of the Chincoteague Channel and in the Canal from buoy #17 down beyond buoy #14. Spanish mackerel, sharks, kingfish, croaker, and pompano were landed from buoy #15 out to the inlet. In the ocean waters, Blackfish Banks was producing flounder and triggerfish, while black sea bass catches were coming from a little farther east. Since Saturday, it has been a whole different story, as she blames the recent strong winds for tearing up the sea bottom. Always the optimist, Rae thinks that once the weather stabilizes, the fish will return with the warm water temperatures, and she predicts a productive autumn fishery.

good." Keeper flounder have been landed from the North Main Street Pier. A 12.5-inch black sea bass was caught off Inlet View. The Memorial Park Pier was producing catches of croaker. Anglers are catching an assortment of sharks and rays off the rocks at the base of the Queen Sound Bridge.

Upper Shore – Captain Matt Abell, at the Sea Hawk Sports Center, reports that red drum catches have come from the waters off Pungoteague Creek, while small speckled trout can be found in the shallows. Matt said that there were some cobia still around. The shop weighed in a 13-pound sheepshead, which was caught in Tangier Sound. A customer aboard the Crisfield charter boat Barbara Ann hooked and boated a large black drum while targeting spot. Customer Josh Harrison released a blue marlin in the Washington Canyon, where lots of dolphin (mahi) are being caught. Spanish mackerel were being caught off Chincoteague, but flounder fishing over the sunken railcars has gone flat.

Bill Hall was the first Eastern Shore resident to achieve Virginia Salt Water Master Angler Status. He has been named Virginia Saltwater Angler of the Year and Virginia Saltwater Release Angler of the Year. Bill is an I.G.F.A. International Committee Representative and a longtime member of the Virginia Saltwater Fishing Tournament Committee. He is the Virginia Recreation Fishing representative on the ASMFC Striped Bass Management Panel and is a past recipient of the CCA-VA Virginia Outdoor Writer Conservation Leadership Award.

Jimmy Vasilou, at Captain Steve's Bait & Tackle, reported that the first big red drum of the fall was caught last Thursday by an angler targeting sharks in the surf of Assateague Island. Pete Vasilou enjoyed a nice catch of dolphin in the Washington Canyon, where white marlin continue to be encountered, and described the inshore croaker fishing as "pretty

Fresh, Local Produce Perfect for Fall Gatherings

Summer may be coming to an end, but fresh, Virginia-grown produce is still available.

Apples, Asian pears, beets, berries, squash, peaches, peppers, sweet corn, tomatoes and watermelon are still ripe and ready for the picking—and eating. These yummy foods are perfect for picnics and back-to-school events.

“Summer is winding down, and soon we’ll have plenty of local fall produce, like sweet potatoes, winter squash, pumpkins and cole crops,” said Tony Banks, commodity marketing specialist for Virginia Farm Bureau Federation. “But there’s still plenty of fresh produce to put on your dinner tables or use for picnics and grilling.”

Many fresh foods are available well into the end of September and even October, and the Virginia Fruit and Vegetable Availability Calendar shows when your favorite local crops are available in Virginia.

Jim Saunders of Saunders Brothers Farm and Farm Market in Nelson County reported having a wide variety of fresh, late-season fruit available including apples, Asian pears, nectarines and peaches. Saunders Brothers grows a type of peach and a variety of Asian pears that ripen at the end of September, and their apple varieties can be picked all the way through November.

When describing his Gala apples, Saunders said, “We’ve had an abundance of rain this year, so the size is very good, and they’re very juicy.”

Blake, a variety of peach that Saunders and his family have been growing on the farm for 70 years, is a yellow-flesh, freestone peach. “The beauty of the Blake peach is that it’s red around the seed, which is very unusual,” Saunders noted. “And people who like to freeze peaches like that; it’s really good-tasting.”

He said the farm’s white nectarines also are good this season. “They’re very sweet and come away from the seed. It’s just a peach with no fuzz,” he added.

The farm grows several varieties of Asian pears. The first variety to ripen—Shinseiki—is particularly juicy, Saunders said. “If you take a bite out of it, the juice will run down your chin.”

Overall, he said, “we’ve had a great season here. We have had a lot of rain. We have a really good crop.”

Public Encouraged to Comment on ‘Dairy Imitation’ Labeling

The U.S. Food and Drug Administration is asking for the public’s input on labeling non-dairy foods as milk.

The FDA hasn’t been enforcing regulations that govern how dairy and non-dairy imitation products, like almond “milk,” are labeled. But they plan to change that.

“This mis-labeling is cutting into dairy farmers’ bottom lines and is confusing for consumers,” said American Farm Bureau Federation economist Michael Nepveux. “Americans are very familiar with milk as a healthy source of protein and nutrients, and a big reason for this awareness comes from education and marketing efforts by the American dairy industry.

“These other products are taking advantage of that consumer trust to market their non-dairy products as milk and trade on the dairy industry’s good name.”

Because consumers often make food choices based on labeling, the FDA has decided to study labeling the wide variety of plant-based foods that are being positioned in the marketplace as substitutes for standardized dairy products.

Consumers can comment through Oct. 11 at regulations.gov/document?D=FDA-2018-N-2381-0317 and click on the “comment now” button.

FDA Commissioner Scott Gottlieb said consumers are more interested than ever in learning about the food they eat and using that information to make healthful choices. At the



same time, the market is rapidly responding to new consumer expectations and trends.

“FDA’s review of dairy product labeling is long overdue,” said Tony Banks, commodity marketing specialist for Virginia Farm Bureau Federation. “Marketing claims aside, mislabeling can create food allergen and safety issues by confusing consumers over product contents.

“Federal law is clear on dairy terms; the FDA just hasn’t been enforcing it,” Banks explained. “What’s needed now are identity standards for plant-based products.”

Many plant-based food products bear traditional dairy terms such as milk, yogurt and cheese. Those products, however, are not the food that has been standardized under the 1938 Food, Drug and Cosmetic Act with the name “milk,” Gottlieb said.

Some of the products’ nutritional content varies widely compared to traditional milk and can have the potential for public health consequences. For example, cases have been reported of young children drinking rice-based beverages and then contracting a disease called kwashiorkor, a form of severe protein malnutrition. There also has been a case of a toddler who was diagnosed with rickets, caused by vitamin D deficiency, after parents used a soy-based alternative to cow’s milk.

Public health concerns are one reason the FDA is prioritizing efforts to closely look at the identity standards for dairy products. It’s part of an overall process for modernizing identity standards to help give consumers proper dietary information.

USDA To Measure Small Grain Production

During the first two weeks of September, growers of small grains

around the country will receive survey forms from the U.S. Department of Agriculture’s National Agricultural Statistics Service (NASS). The agency is taking a comprehensive look into the 2018 production and supply of small grains, which include wheat, barley and rye for Virginia.

“We will contact over 1,000 producers in Virginia to accurately measure 2018 acreage, yield, and production for small grains,” said Herman Ellison, Virginia state statistician. “The data collected from this survey will also help set small grain acreage and production estimates at the county level.”

NASS will contact Virginia survey participants to gather information on their 2018 production and the quantities of corn, soybeans, winter wheat and barley stored on-farm.

“The county yield estimates we establish from this survey are used by other USDA agencies, such as Farm Service and Risk Management Agencies,” Ellison said. “FSA’s Agricultural Risk Coverage (ARC) and other program calculations all integrate the data from this survey. RMA uses the information for its Area Risk Protection Insurance Plan and establishment of transitional yields. Particularly when severe weather, drought or flooding impact crop production, these data are crucial to the agriculture industry.”

As an alternative to mailing the survey back and to help save both time and money, growers will have the option to respond to the survey securely online. Farmers who have not responded by Aug. 30, may receive a phone call from a NASS representative who will help them fill out the survey form.

NASS safeguards the privacy of all respondents and publishes only aggregate data, ensuring that no individual operation or producer can be identified.

Survey results will be published in several reports, including the annual Small Grains Summary and the quarterly Grain Stocks report, both to be released on September 28. 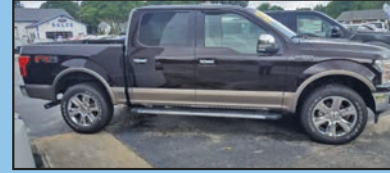

CCA Offers Fall Classes in a Wide Array of Arts

The Chincoteague Cultural Alliance is offering a large variety of classes this fall including painting, fly tying, wine and cheese pairing, and holiday ornament making.

The first is a two-day class on Sept. 15 and 16 taught by Stephanie Hale. A vendor at CCA's Second Saturday Artful Flea, Hale sells honey and other products derived from her beekeeping, along with beautiful creations combining glass, shells, and poured resin. Her class will walk students through the steps of making their own poured resin framed art.

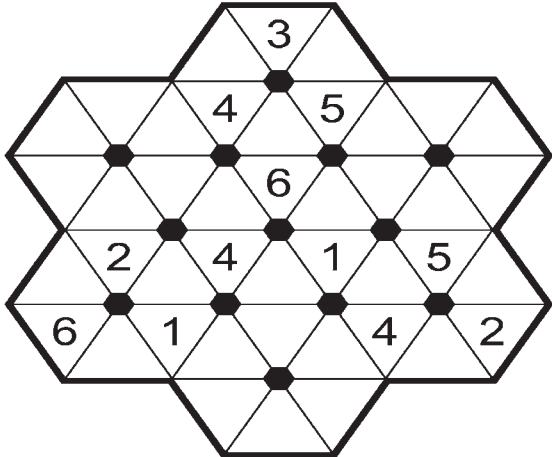

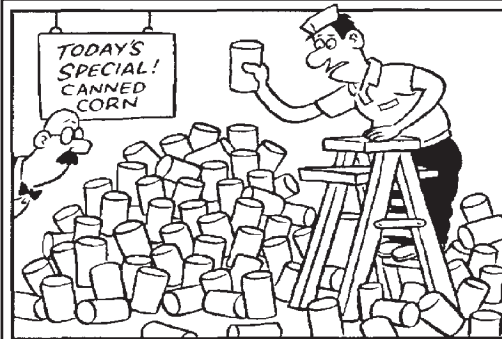

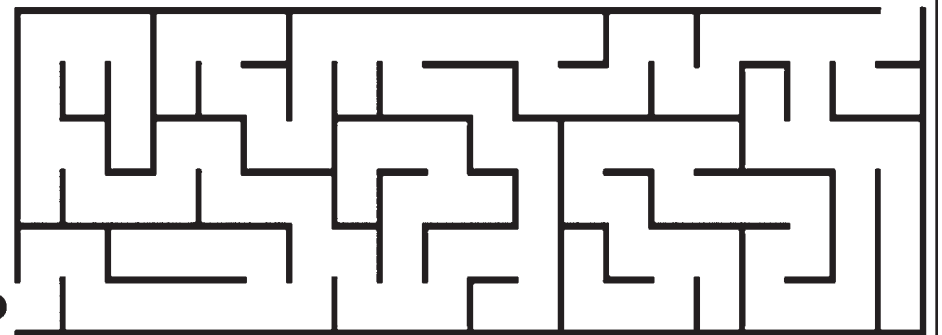

Mars Parachute Test Launches from Wallops

A parachute test for a future mission to Mars was successfully launched on a NASA Black Brant IX suborbital sounding rocket at 9:30 a.m., Friday, Sept. 7, from the agency's Wallops Flight Facility.

The rocket carried the Advanced Supersonic Parachute Inflation Research Experiment (ASPIRE) from NASA's Jet Propulsion Laboratory in Pasadena, Calif.

The payload descended by parachute and splashed down in the Atlantic Ocean 28 miles from Wallops Island. The parachute was successfully recovered and returned to Wallops for data retrieval and inspection.

The payload is a bullet-nosed, cylindrical structure holding a supersonic parachute, the parachute's deployment mechanism, and the test's high-definition instrumentation — including cameras — to record data.

ASPIRE is managed by the Jet Propulsion Laboratory, for NASA's Science Mission Directorate, with support from NASA's Langley Research Center in Hampton, Va., and NASA's Ames Research Center in Mountain View, Calif. NASA's Sounding Rocket Program is based at the

agency's Wallops Flight Facility. NASA's Heliophysics Division manages the sounding-rocket program for the agency.

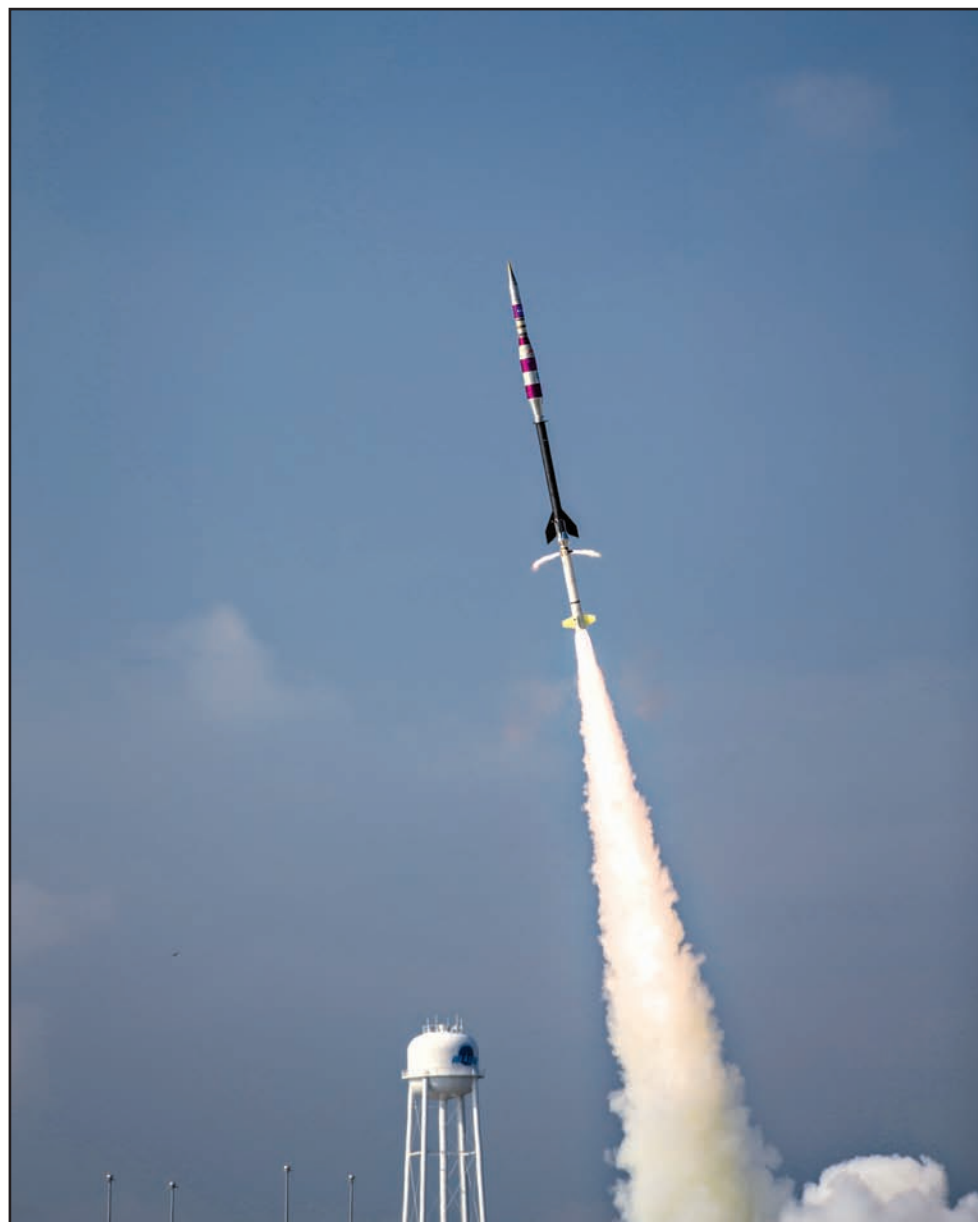



Veteran Legislation

Last month, President Donald Trump signed into law the John S. McCain National Defense Authorization Act for Fiscal Year 2019, named in honor of the late Senate Armed Services Committee Chairman John McCain. There are a lot facets to this piece of legislation, but there are two pieces that veterans need be aware. Commencing in January 2020, service-connected disabled veterans and their caregivers will be eligible to use base commissary stores and Morale, Welfare and Recreation facilities. This is a giant step for veterans: purchasing things online from the base exchange. This new

legislation allows veterans with a service-connected disability to shop on base.

The second piece of legislation is the Disabled Veterans Access to Space-A Travel Act. This provides service-connected veterans with a permanent disability rating of 100 percent the ability to fly at no cost within the continental United States operated by Air Mobility Command. Space-A flying allows all service members and retired military to hop on any scheduled or unscheduled military flights at no cost. It's important to note that a person flying Space-A may be bumped by a mission critical assignment or by military traveling on orders.

Last month the Department of Veter-

ans Affairs (VA) announced that thousands of low-income veteran families will continue to receive benefits under the Supportive Services for Veteran Families (SSVF) program. Veterans who are permanently housed or transitioning to permanent housing, will continue to have access to crucial services with the funding of approximately \$326 million in grants.

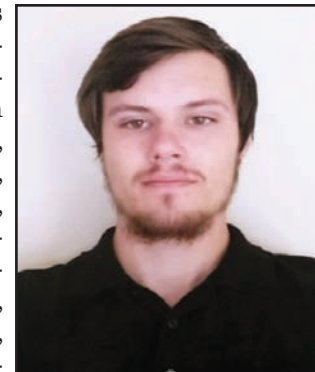
SSVF funding that supports outreach, case management, and other flexible assistance rapidly to re-house homeless veterans, or those at risk, will be awarded to 252 nonprofit organizations in all 50 states and the District of Columbia, Guam, Puerto Rico, and the U.S. Virgin Islands.
